(57) **CLAIM**

The design of the shoulder strap ring hardware, substantially as shown.

DESCRIPTION

FIG. 1 is a top plan view of a shoulder strap ring hardware showing my new design.

FIG. 2 is a front end view.

FIG. 3 is an end view.

FIG. 4 is a top plan view shown with the coating removed for ease of illustration.

FIG. 5 is a front view of the ring of FIG. 4.

FIG. 6 is a side view of FIG. 4.

FIG. 7 is an exterior view of one end of the coating, removed from the buckle for ease of illustration.

FIG. 8 is an exterior view of the other end of the coating, removed from the buckle for ease of illustration.

FIG. 9 is an interior view, which is indicative of either end of the coating, removed from the buckle for ease of illustration.

FIG. 10 is an end view of the coating of FIG. 9.

FIG. 11 is the other end view of the coating of FIG. 9; and,

FIG. 12 is an isometric view of the ring of FIGS. 1-3.

The broken line showing of a strap in FIG. 12 is included for the purpose of illustrating environment and forms no part of the claimed design.

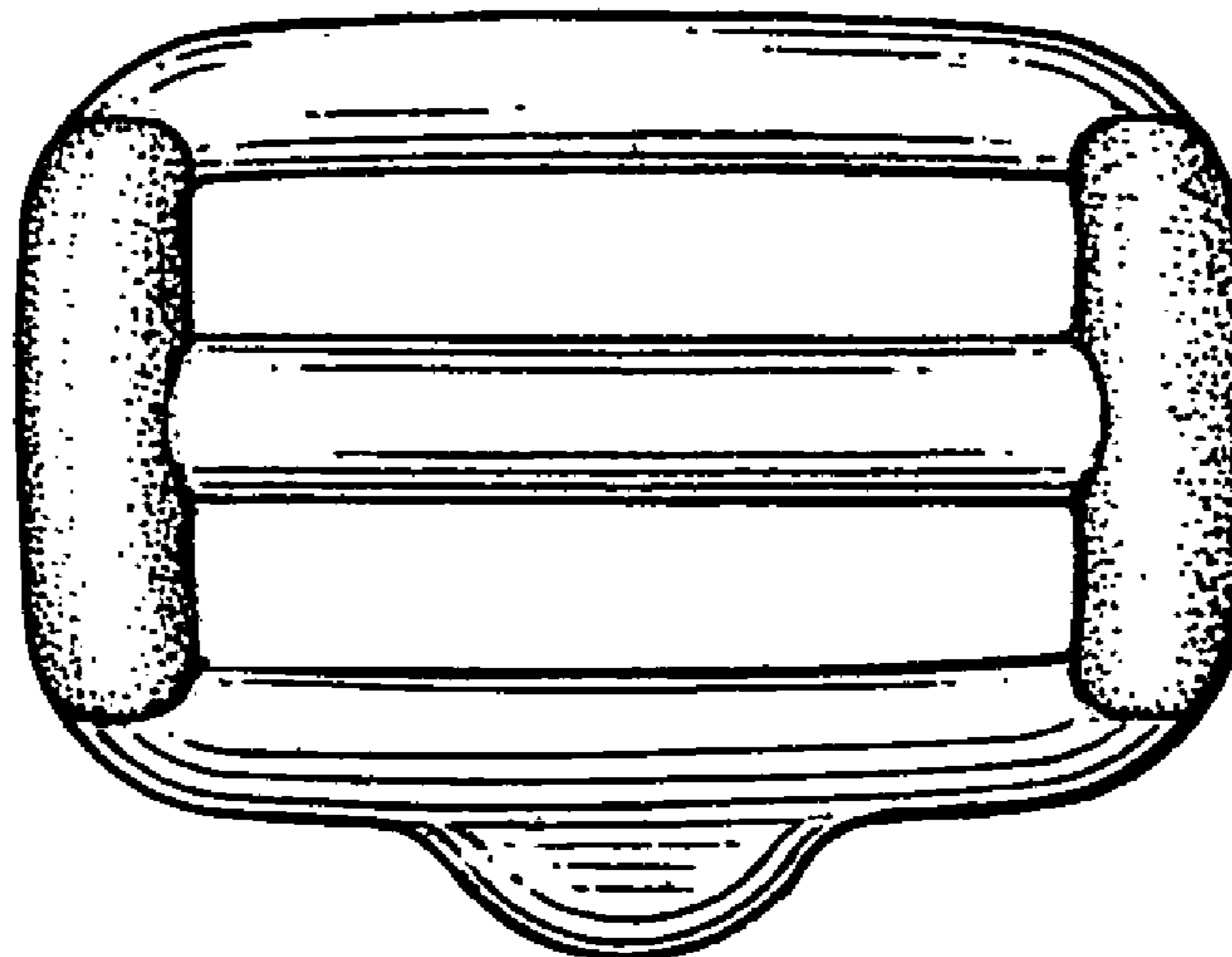

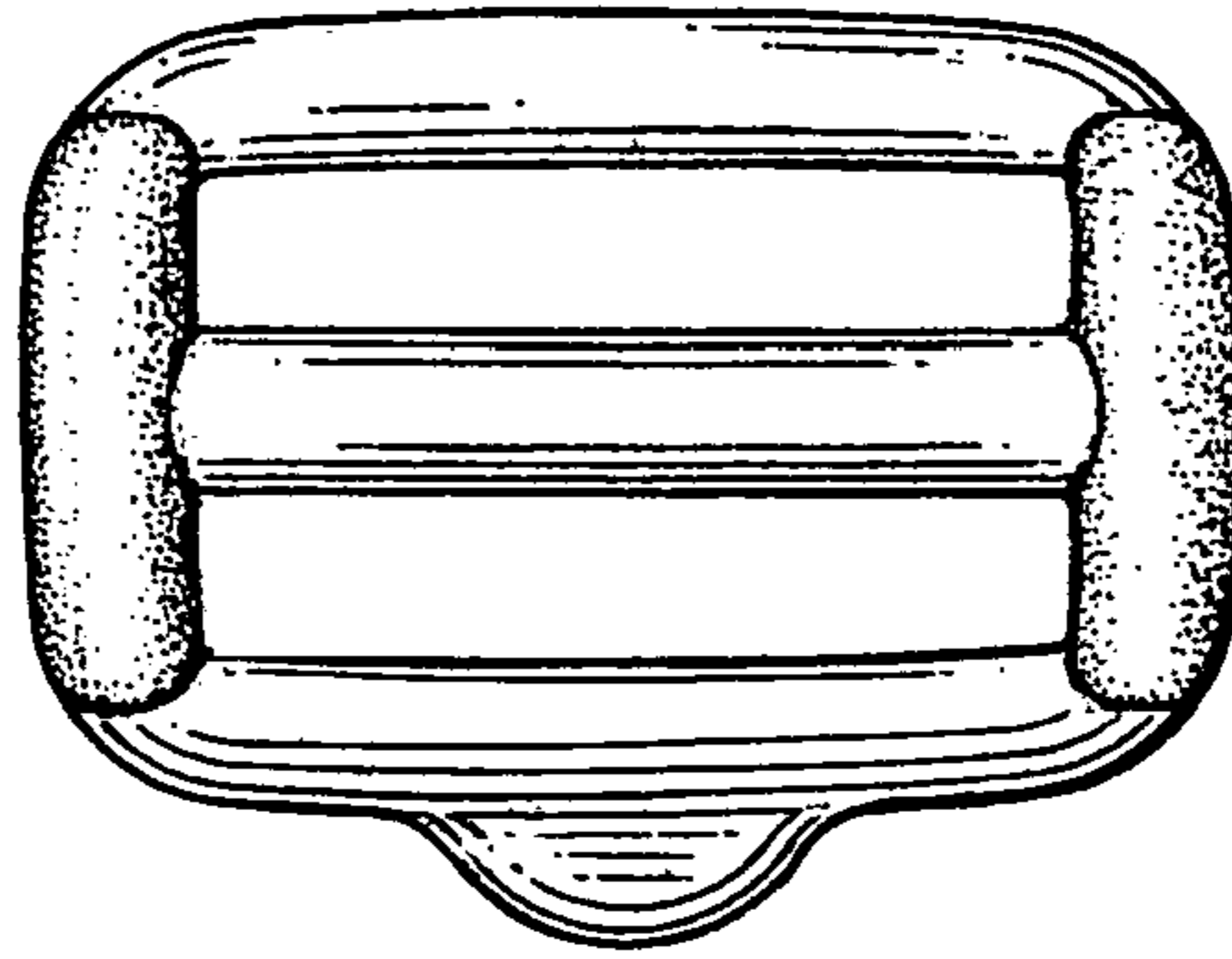

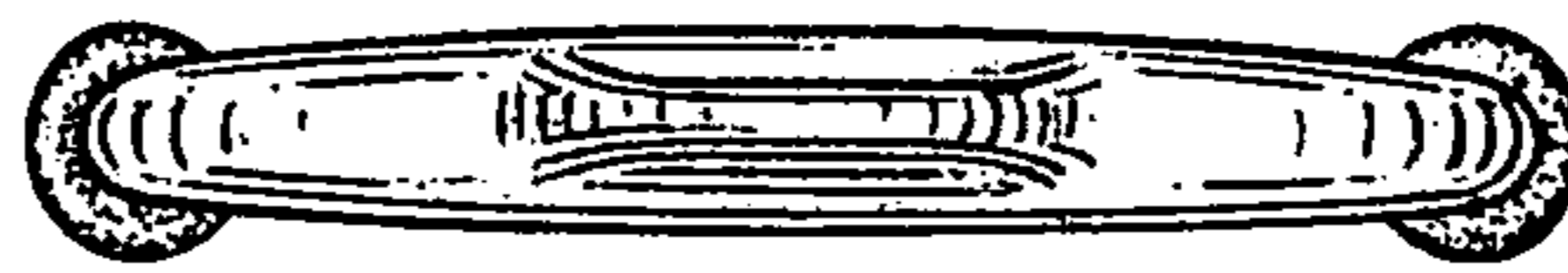

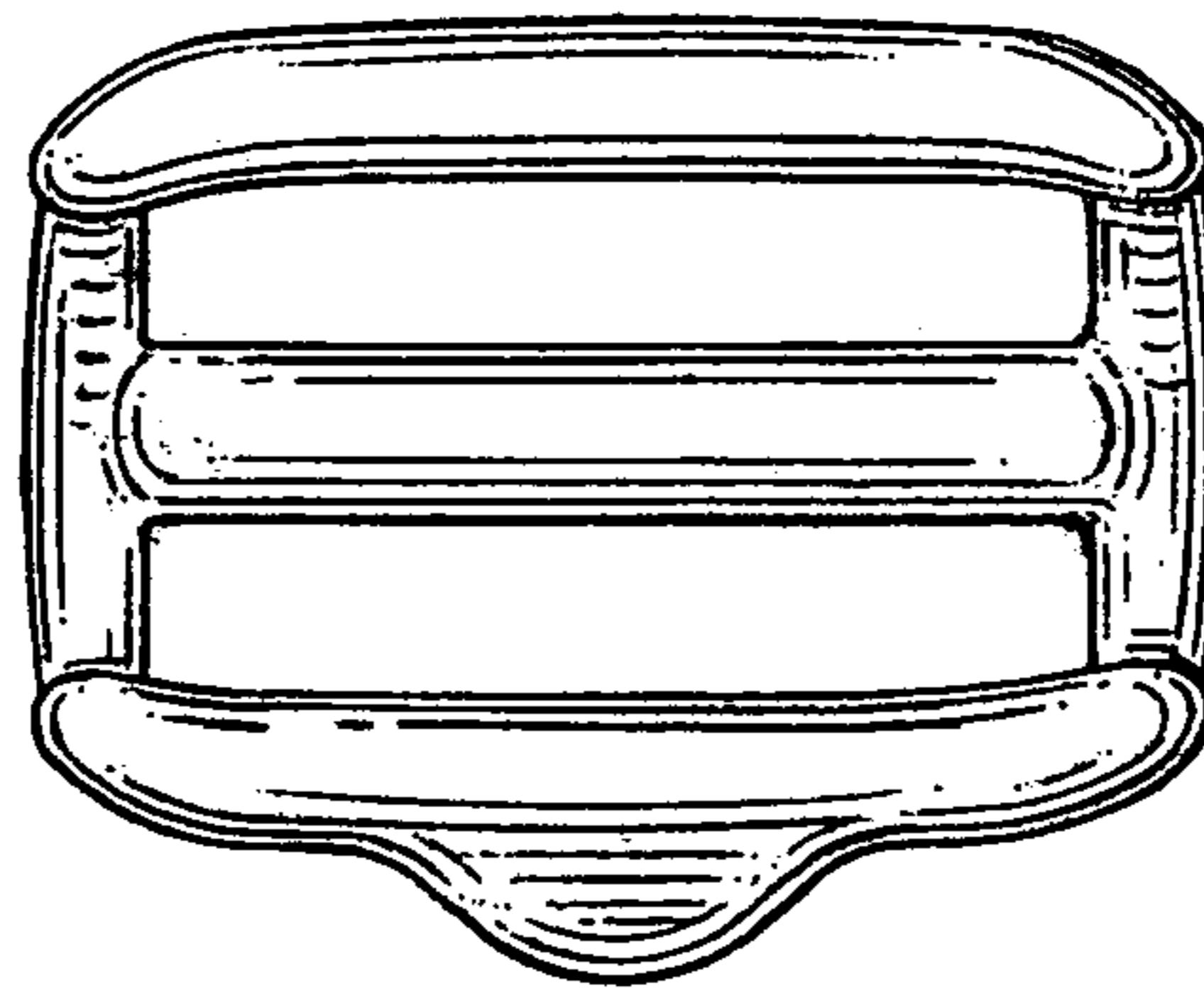

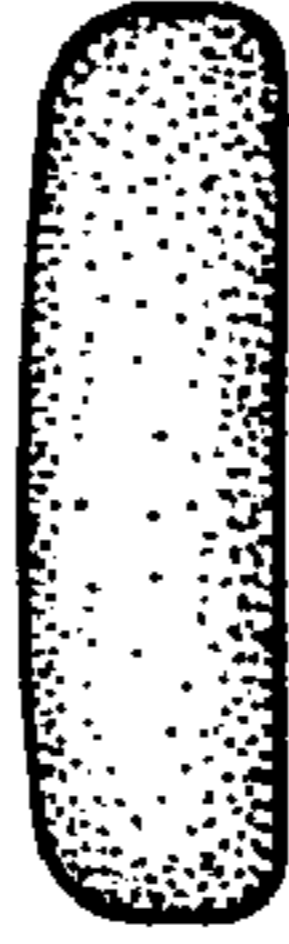

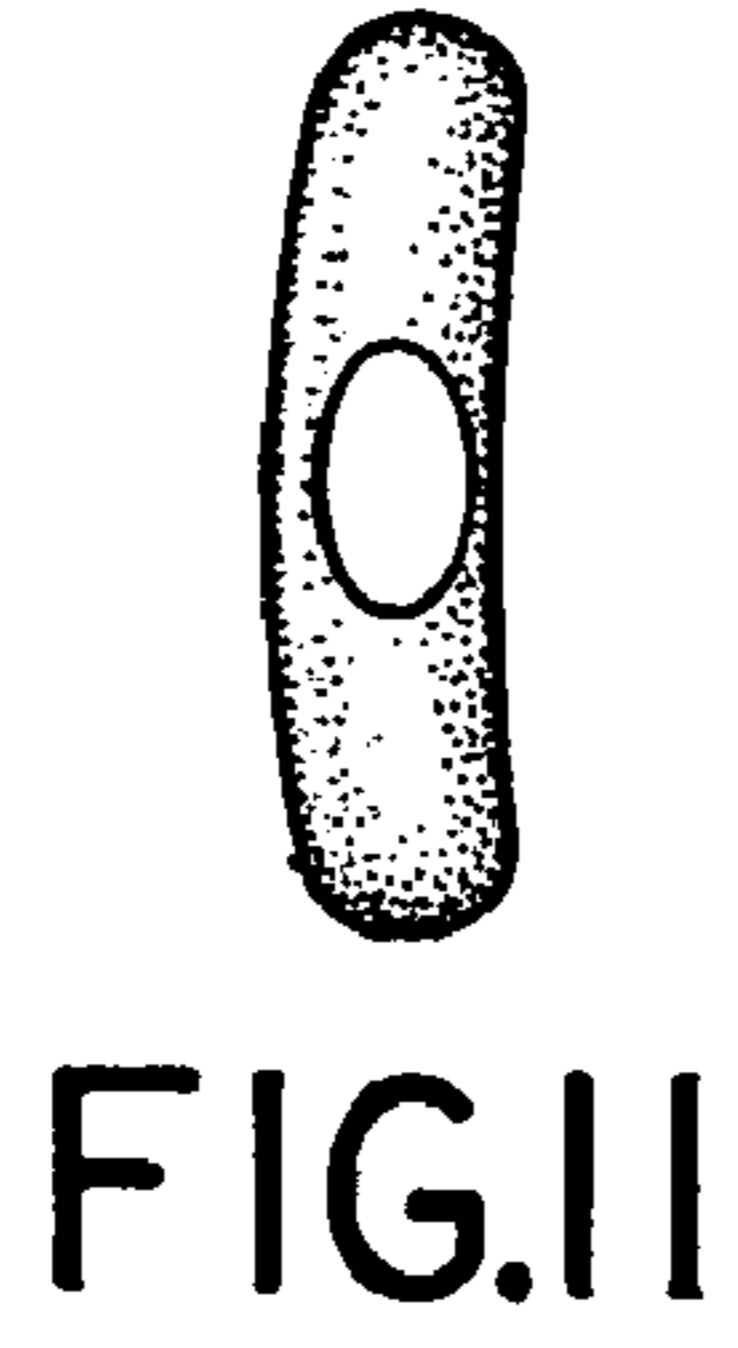

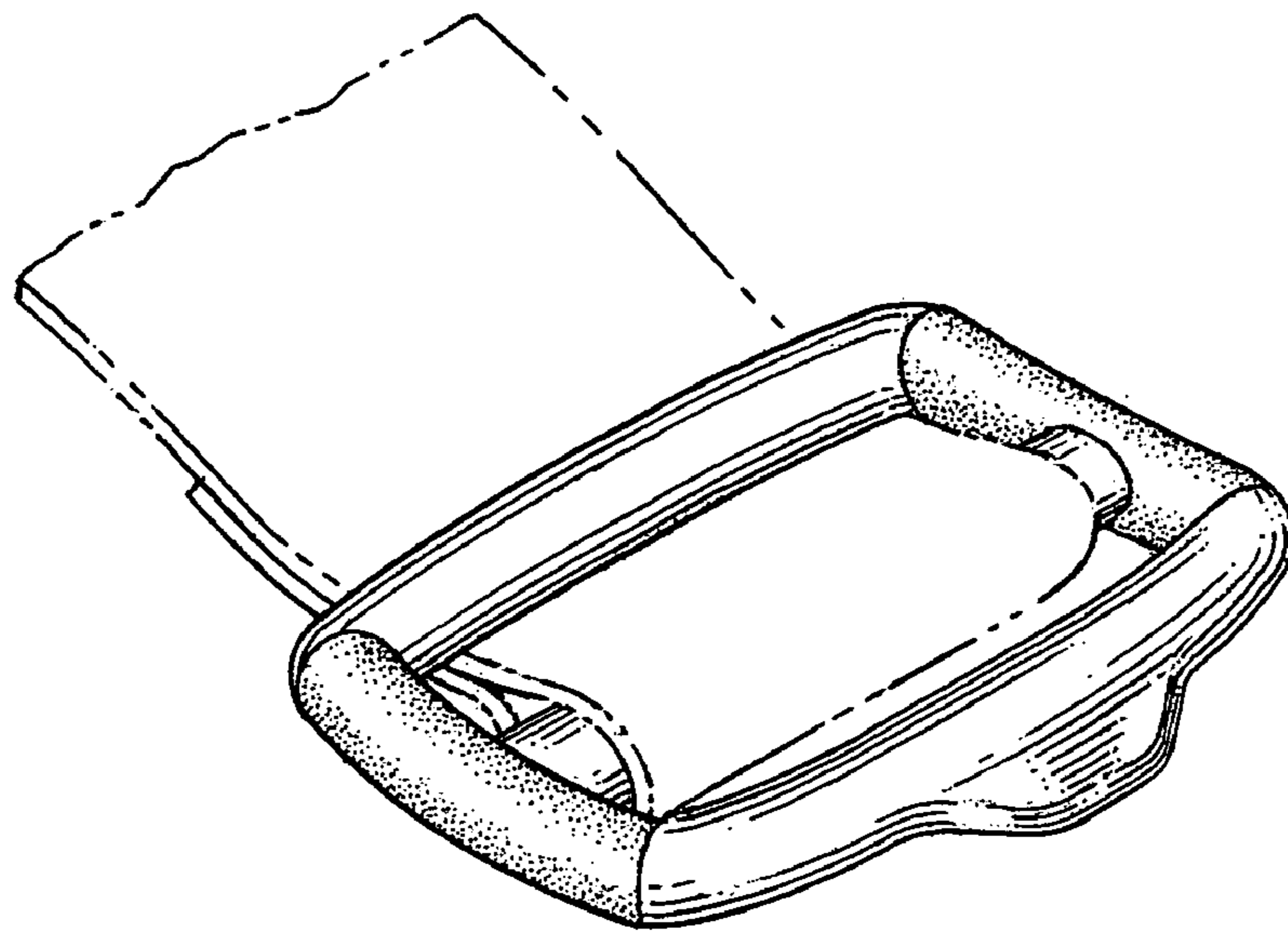
