DESCRIPTION

FIG. 3 is a rear elevational view of the truck bumper of FIG. 1;

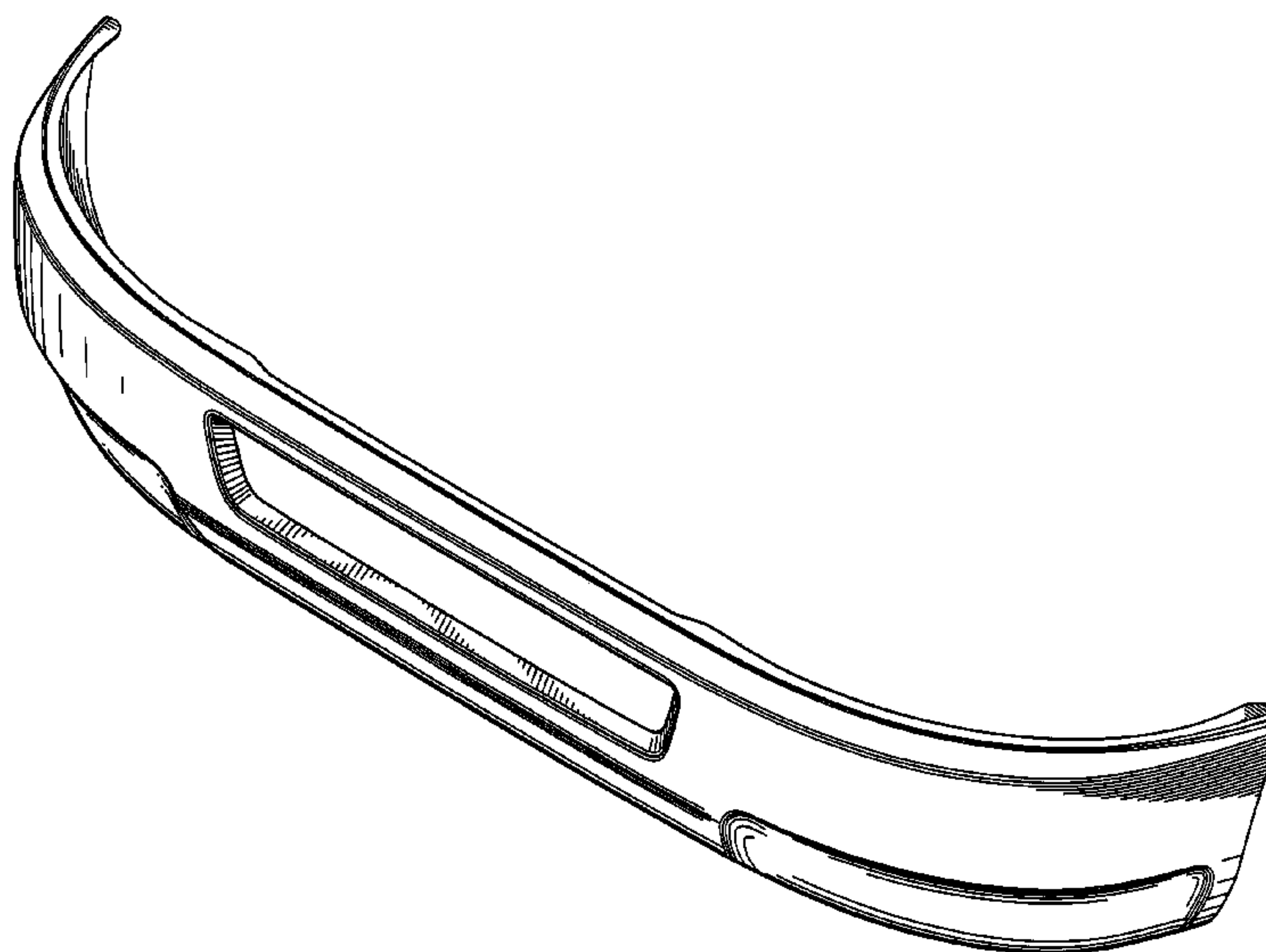
FIG. 4 is a top plan view of the truck bumper of FIG. 1;

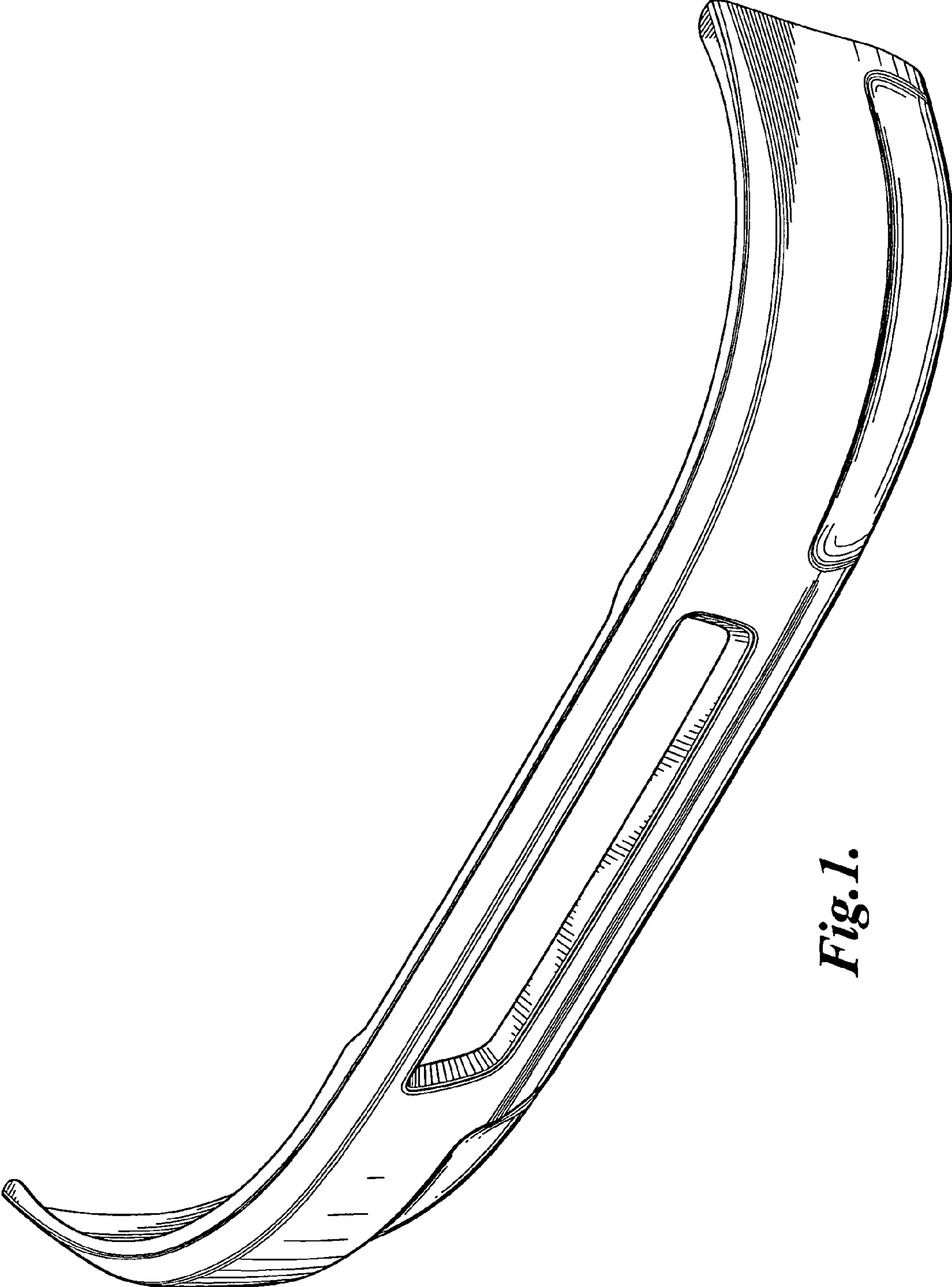

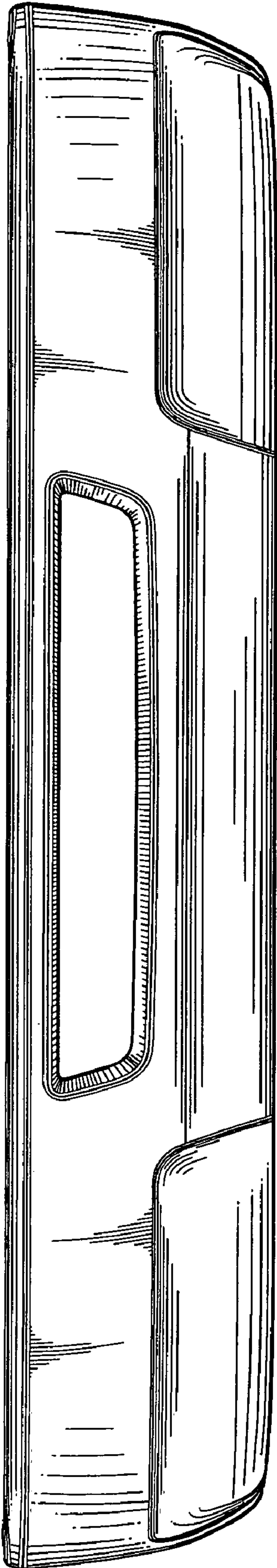

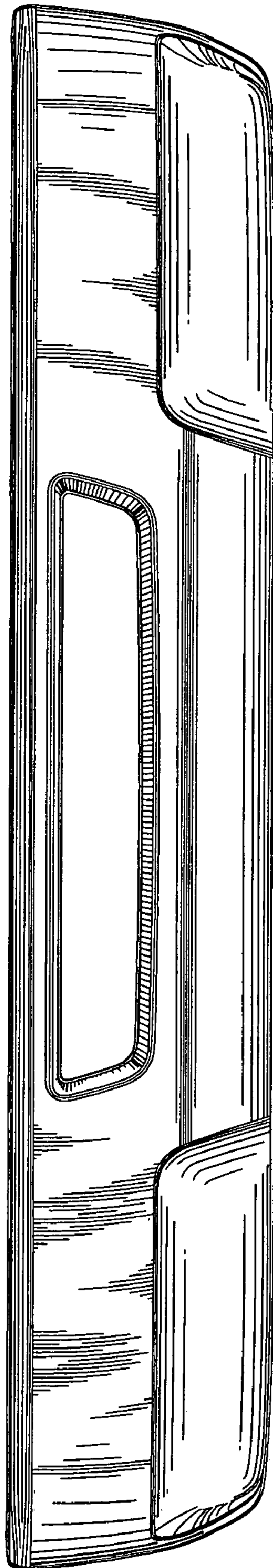

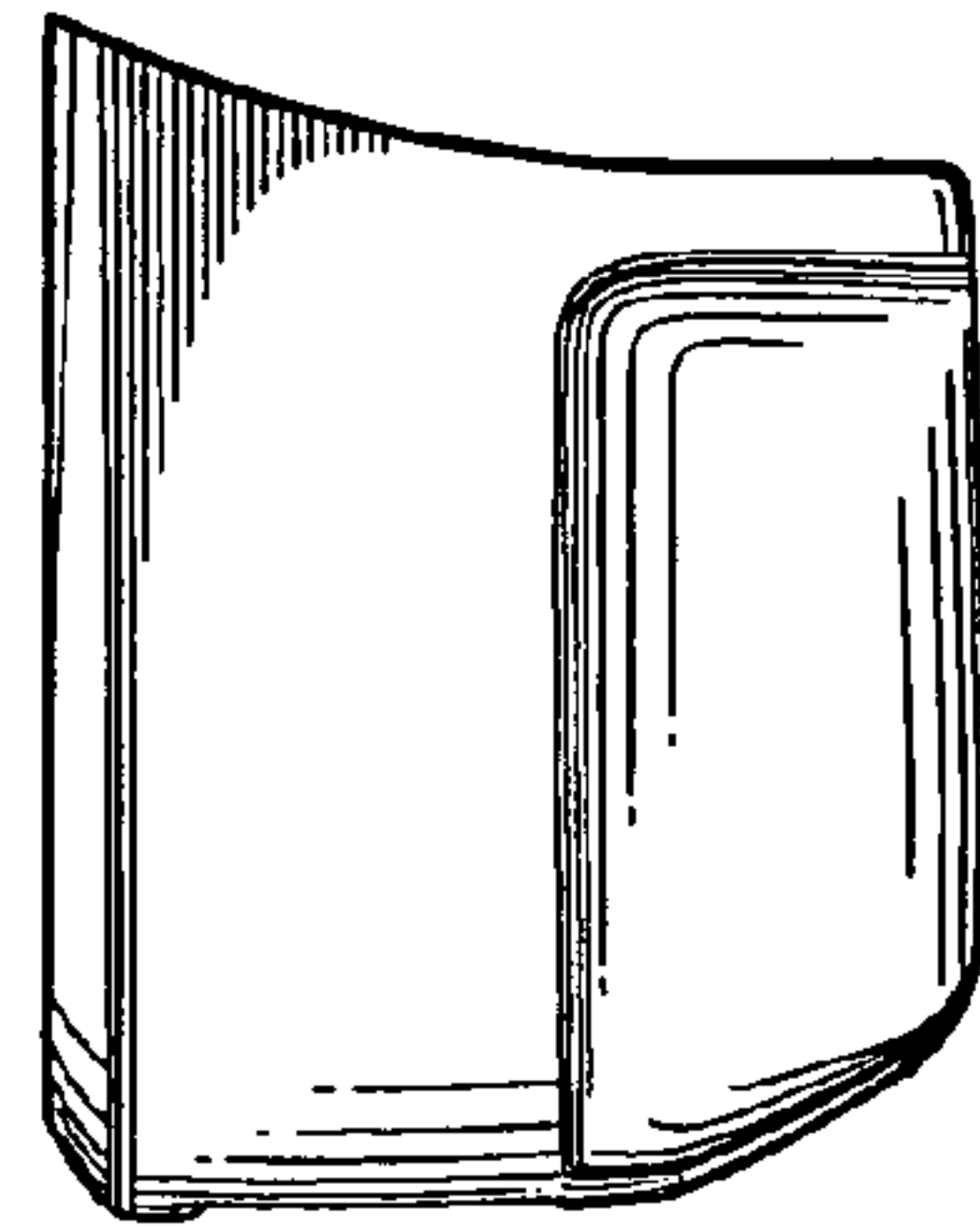
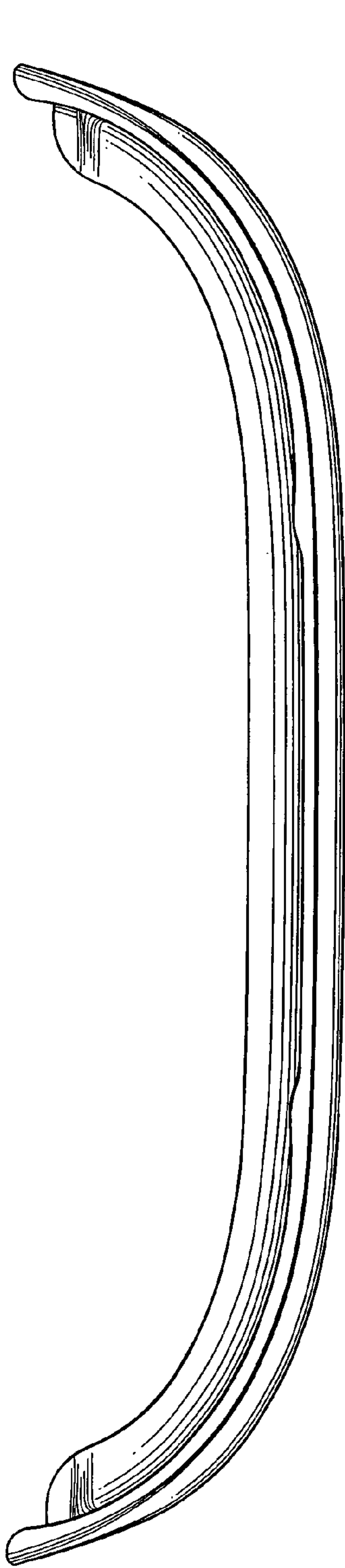

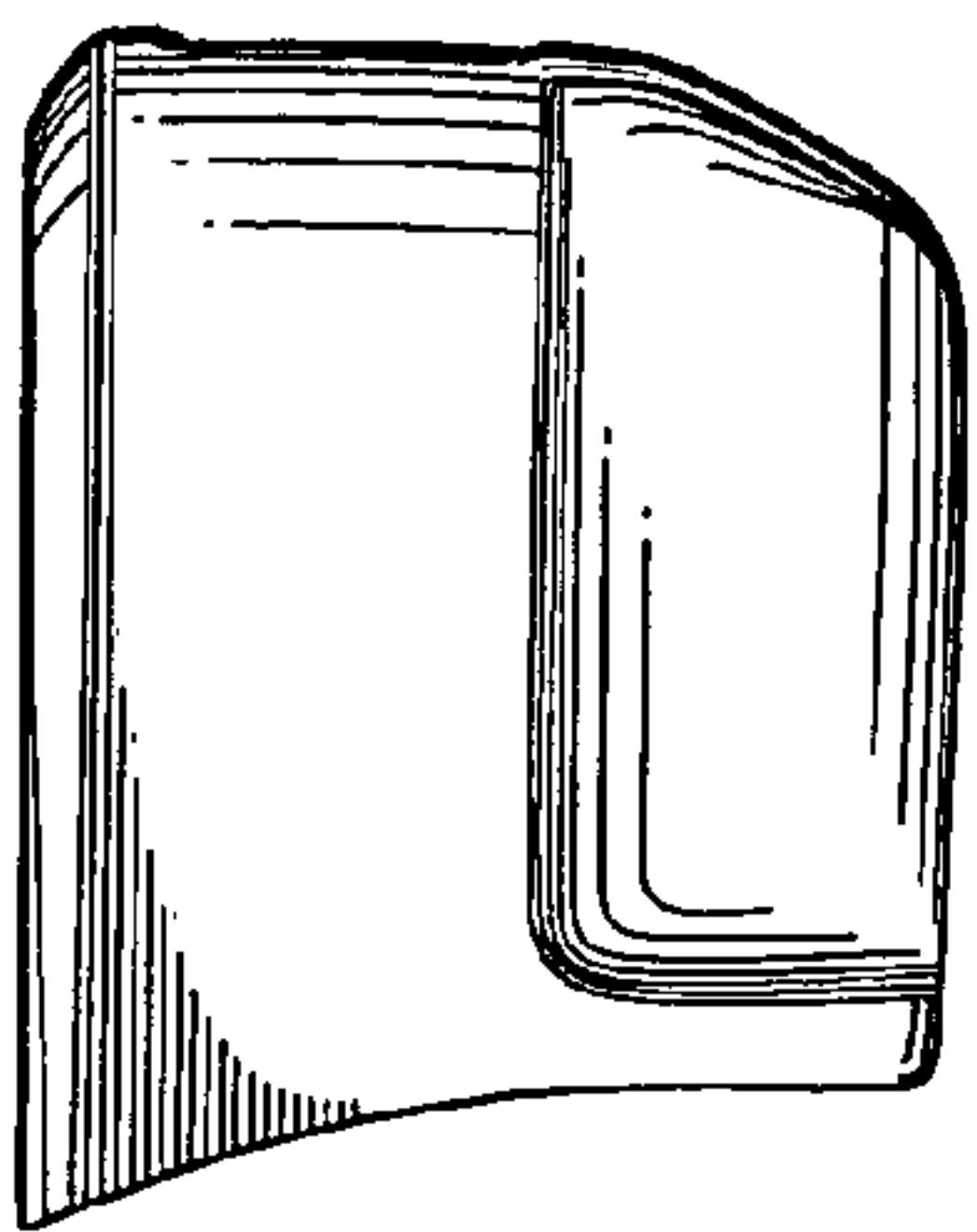

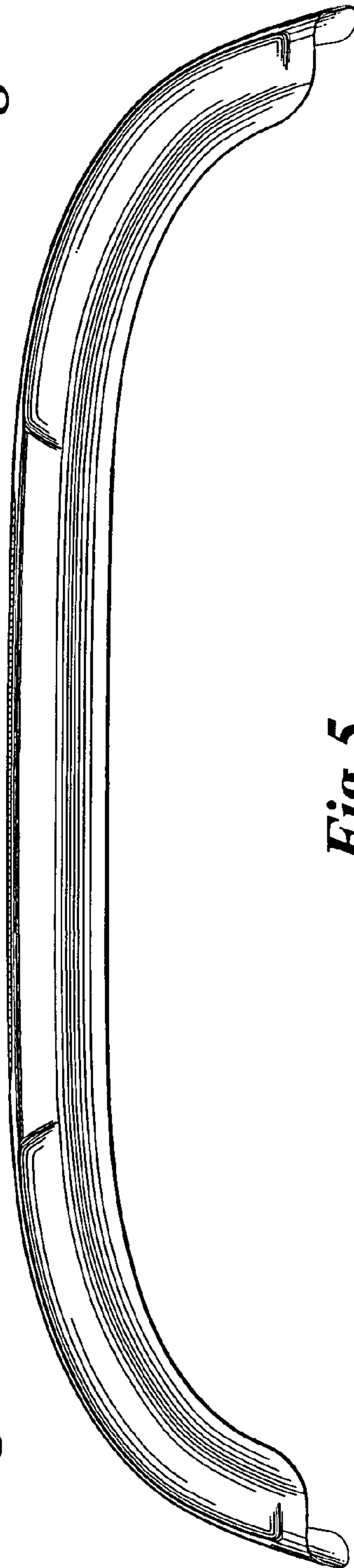
