FIG. 4 is a front elevational view of the truck hood unit of FIG. 1;

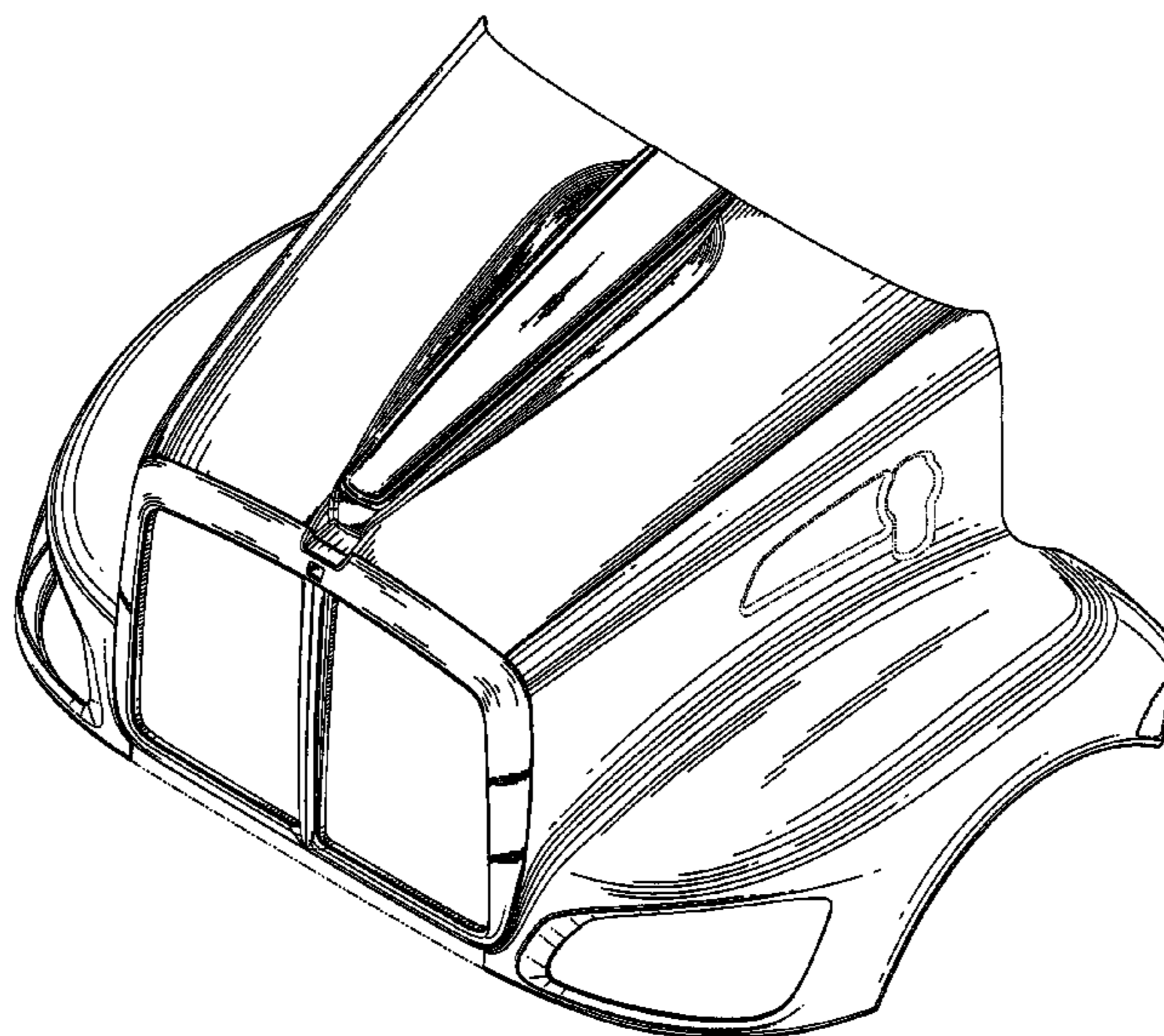
FIG. 5 is a rear elevational view of the truck hood unit of FIG. 1;

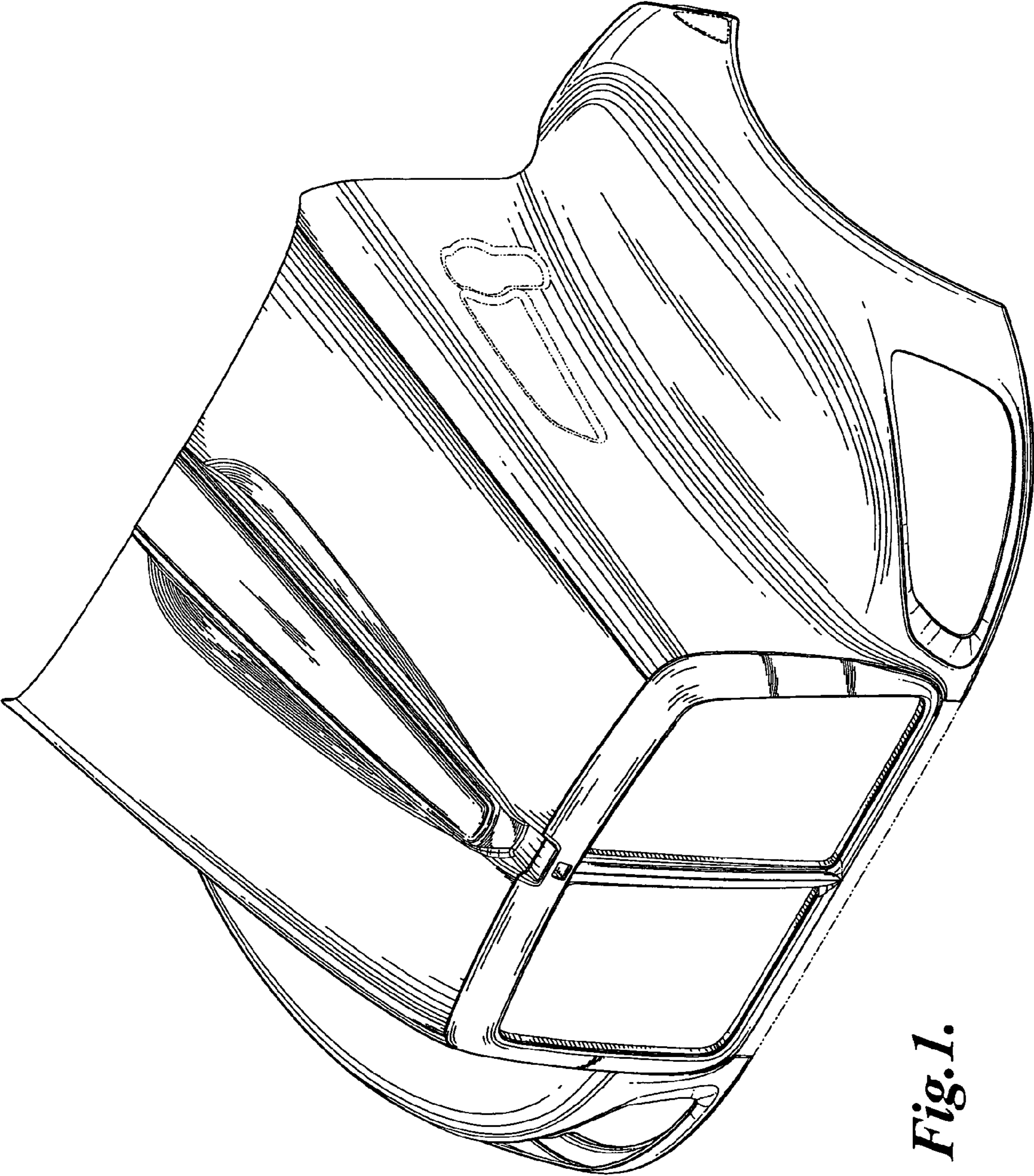

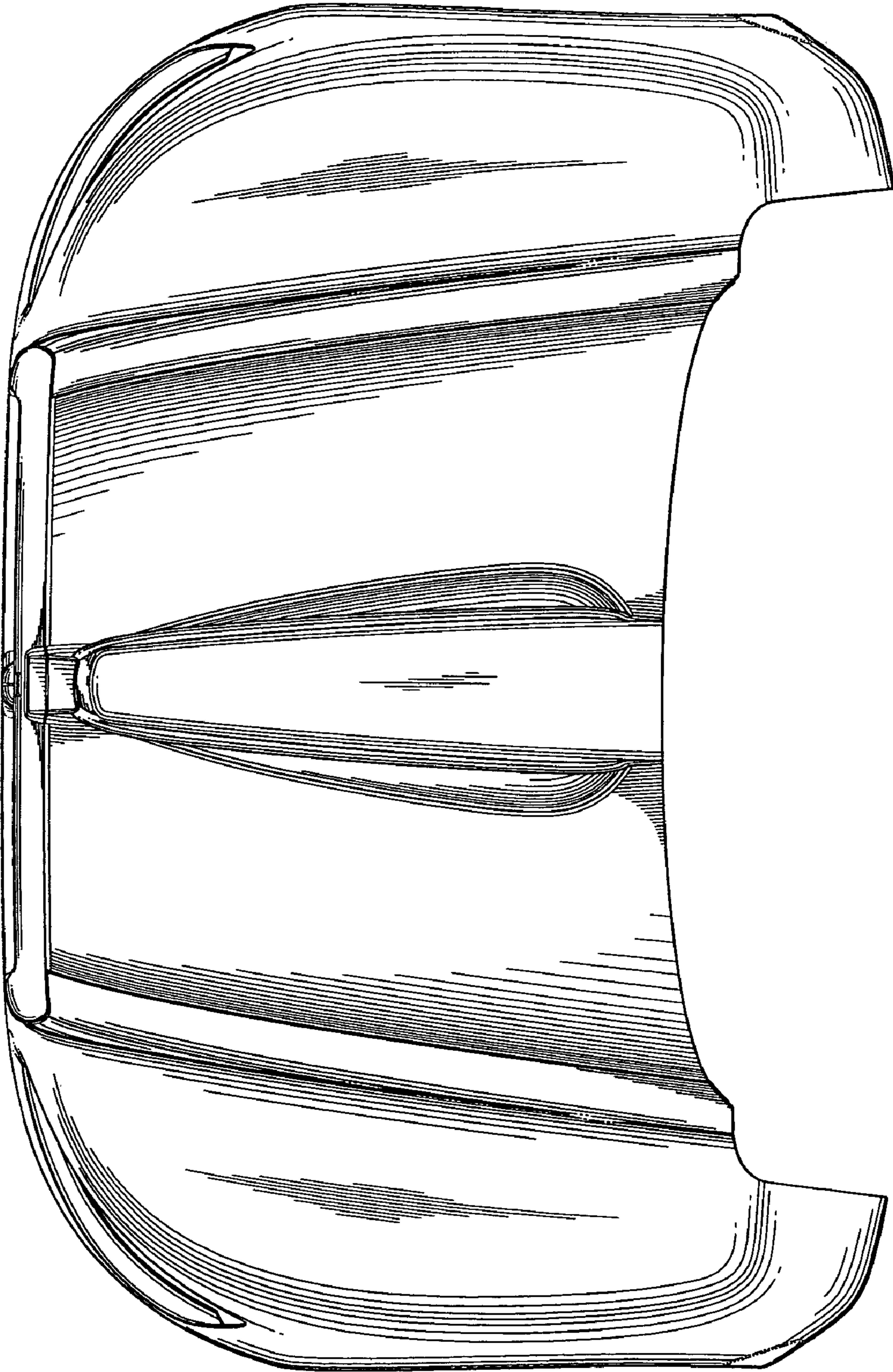

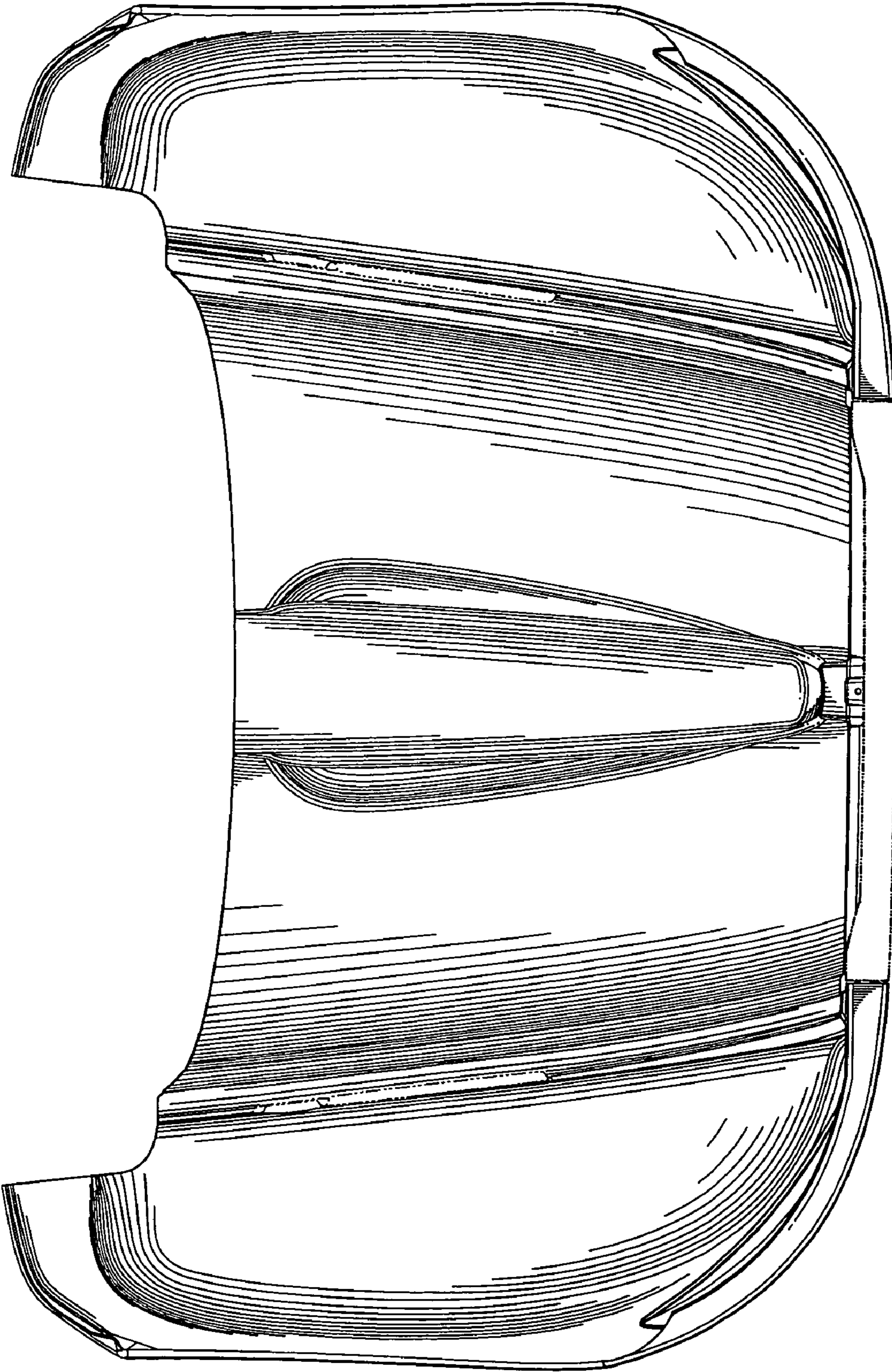

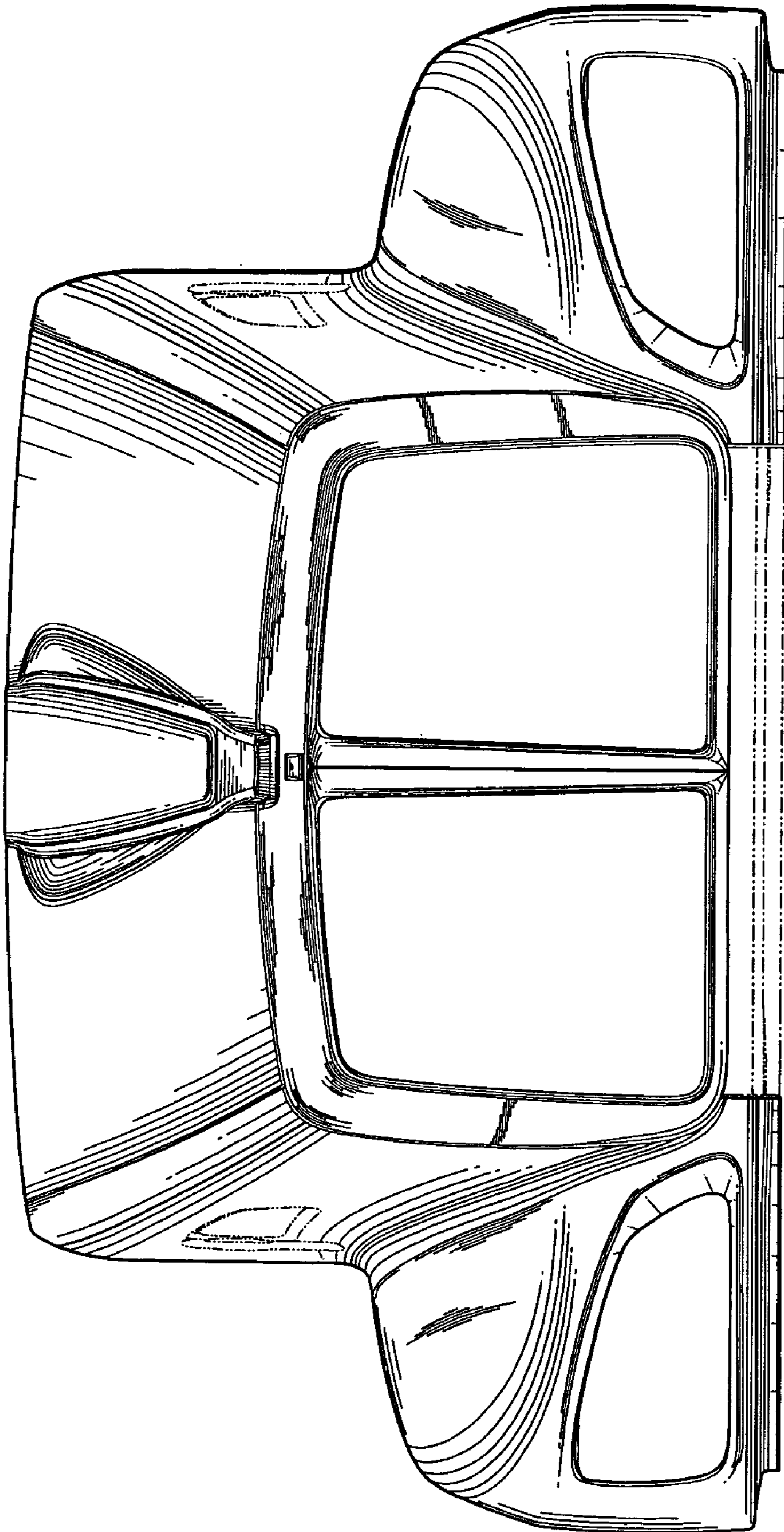

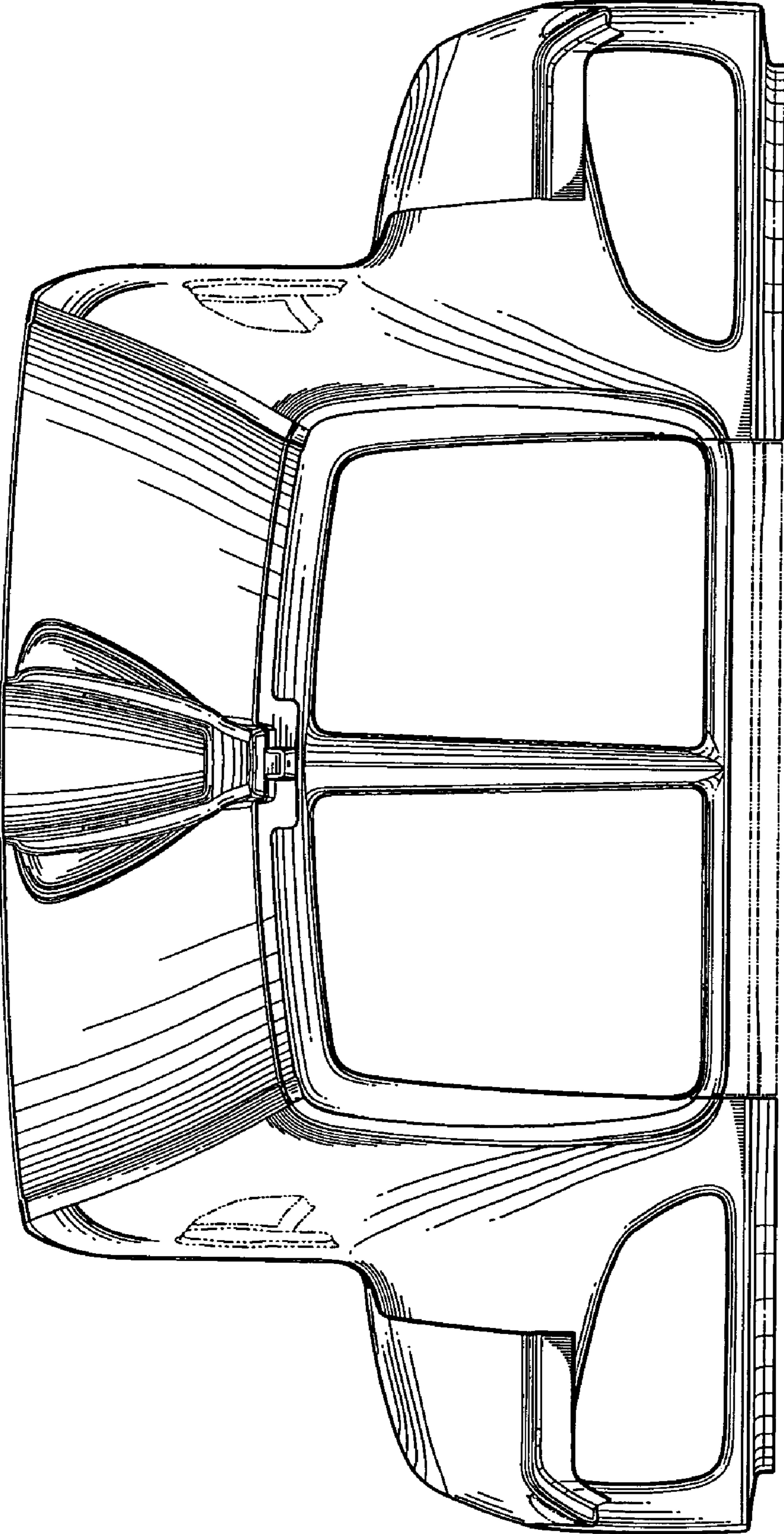

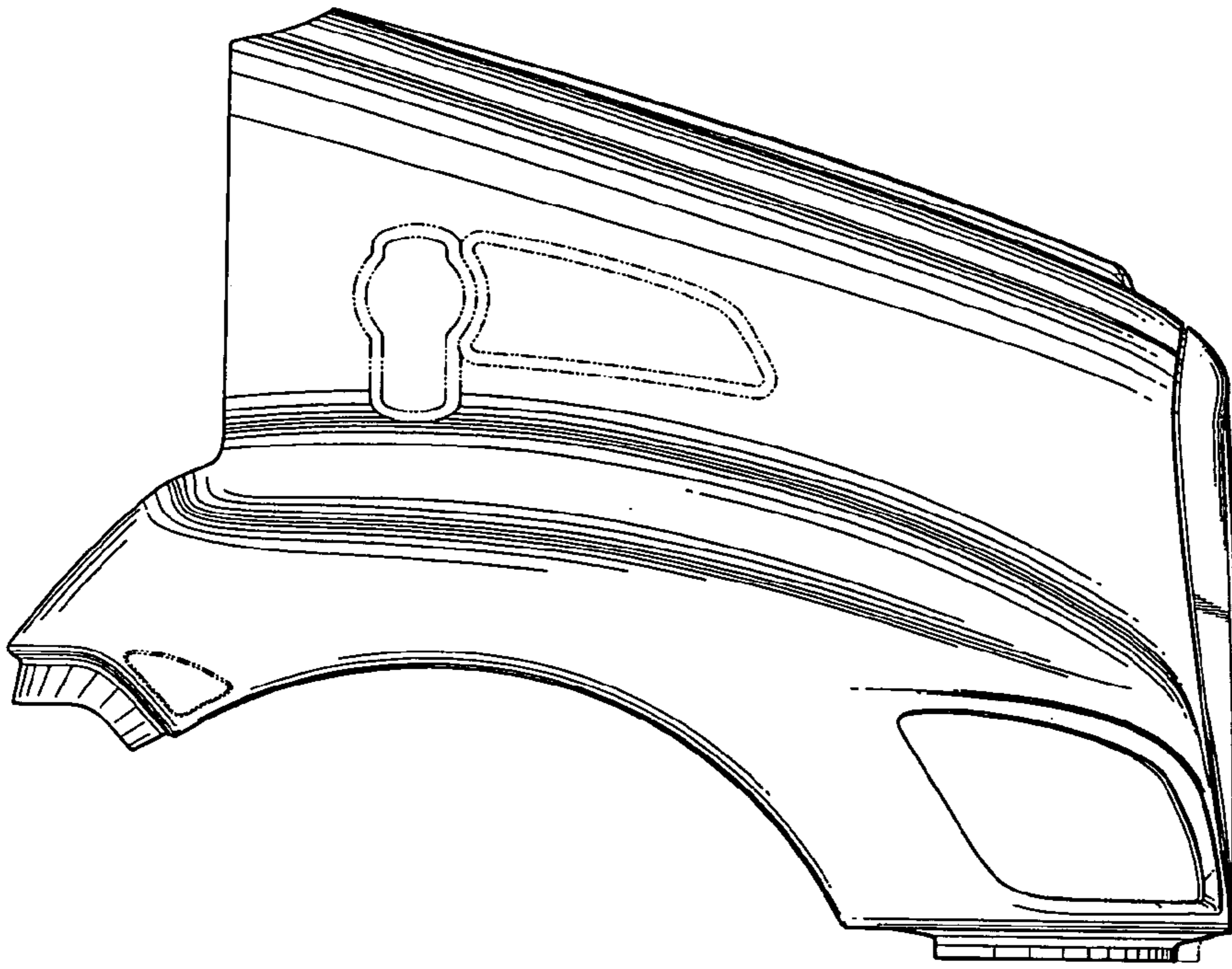

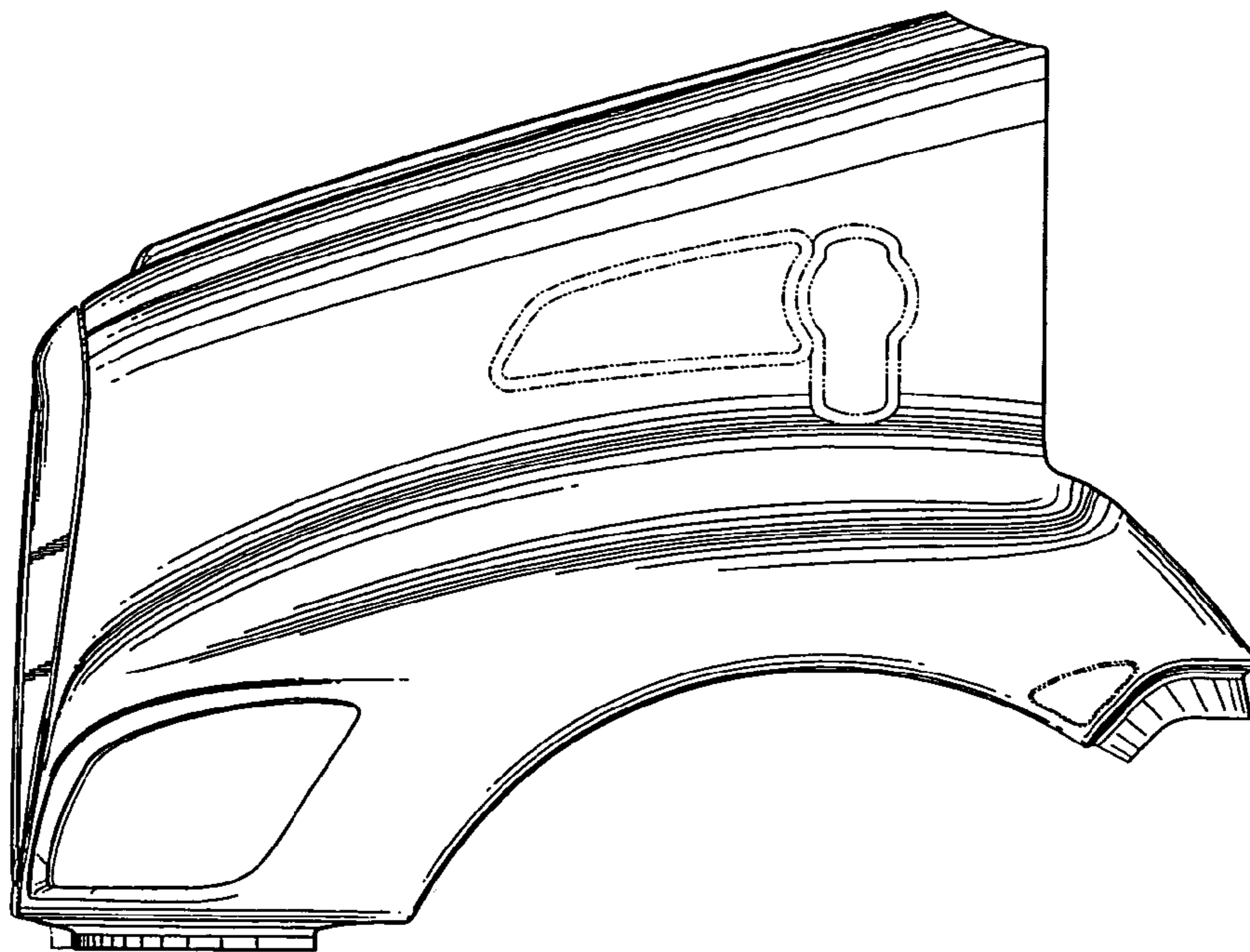
