**DESCRIPTION**

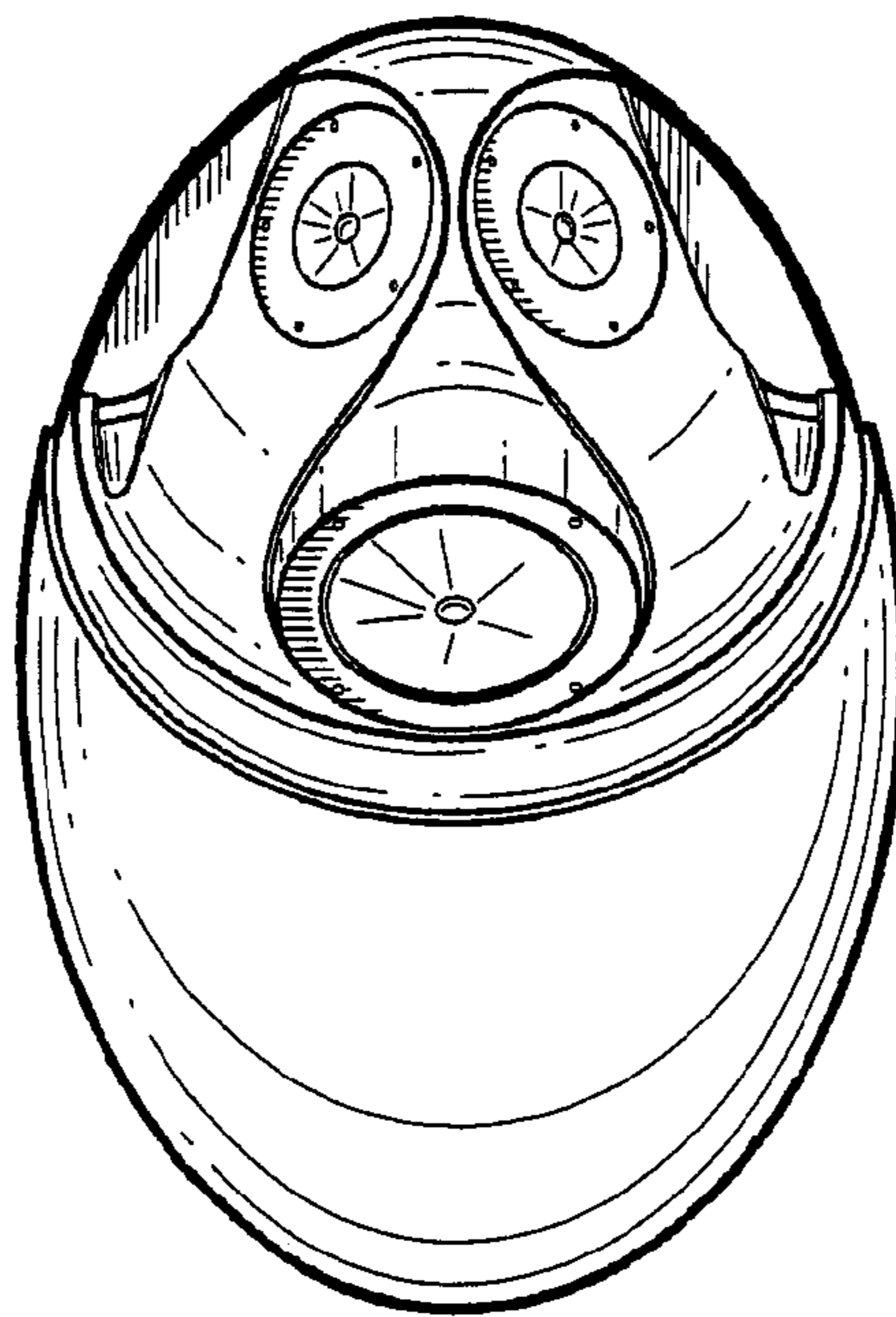

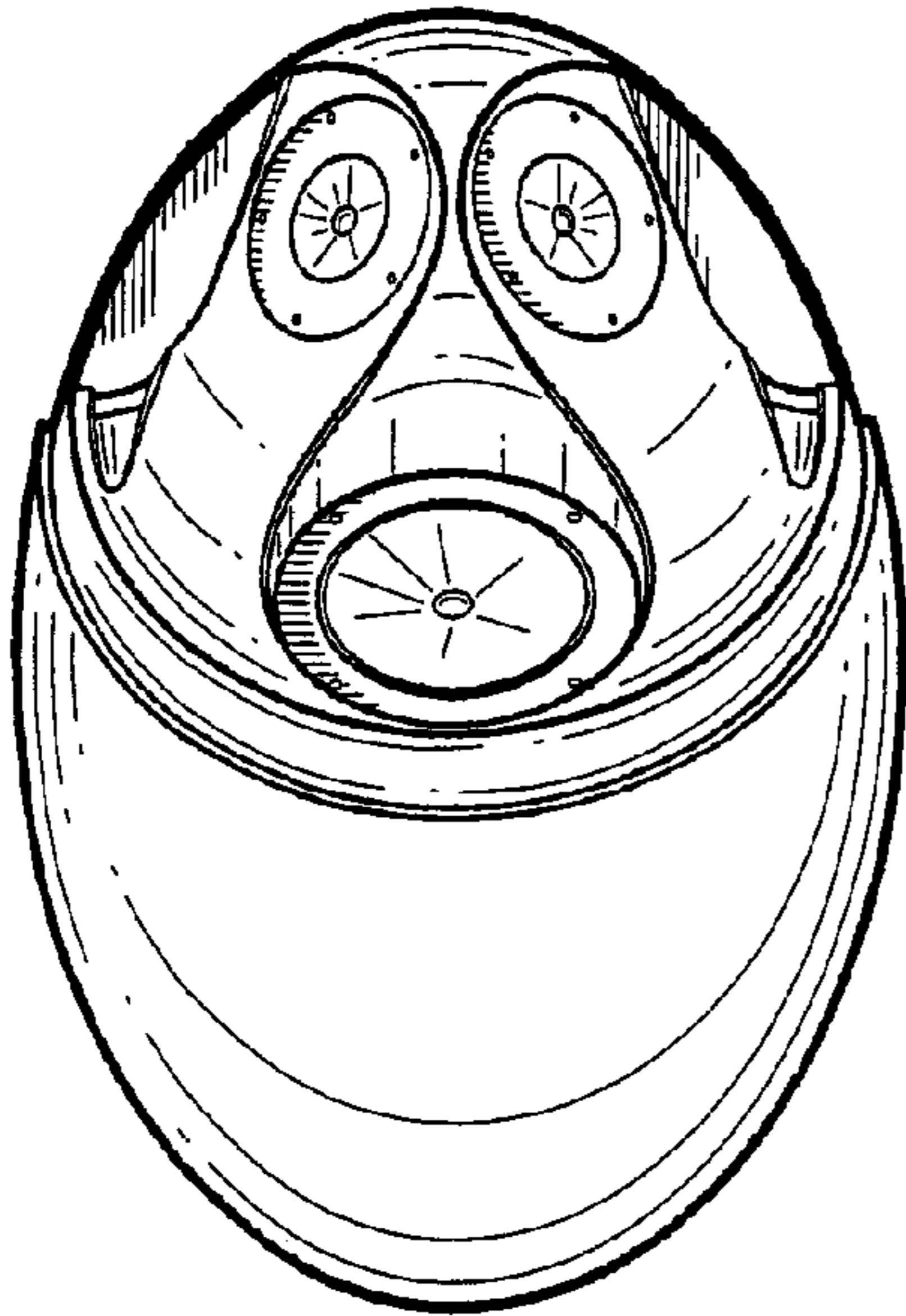

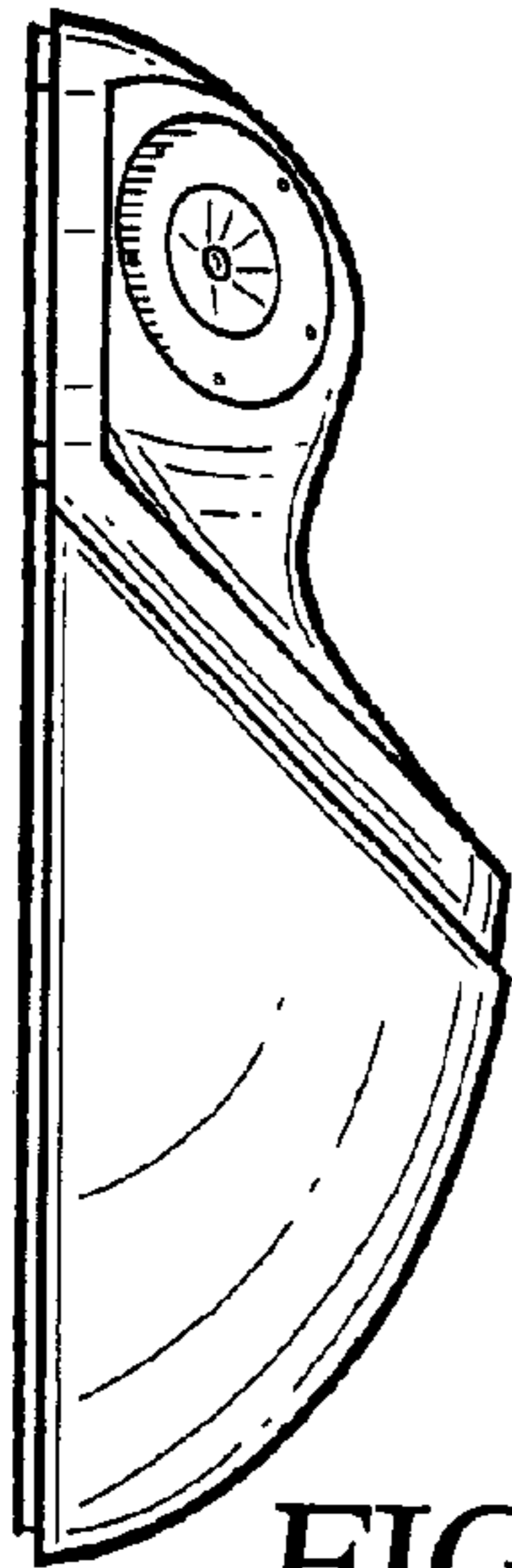
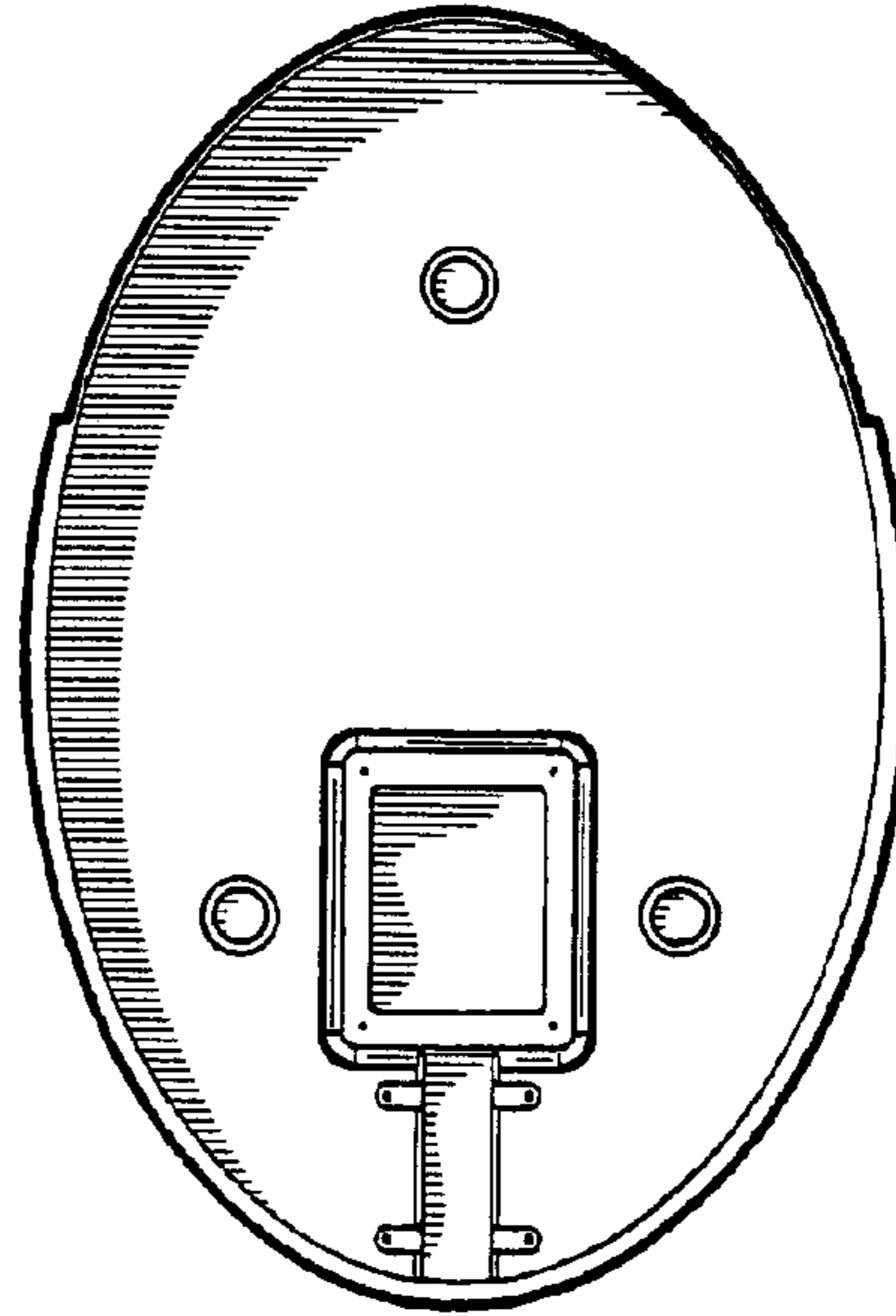

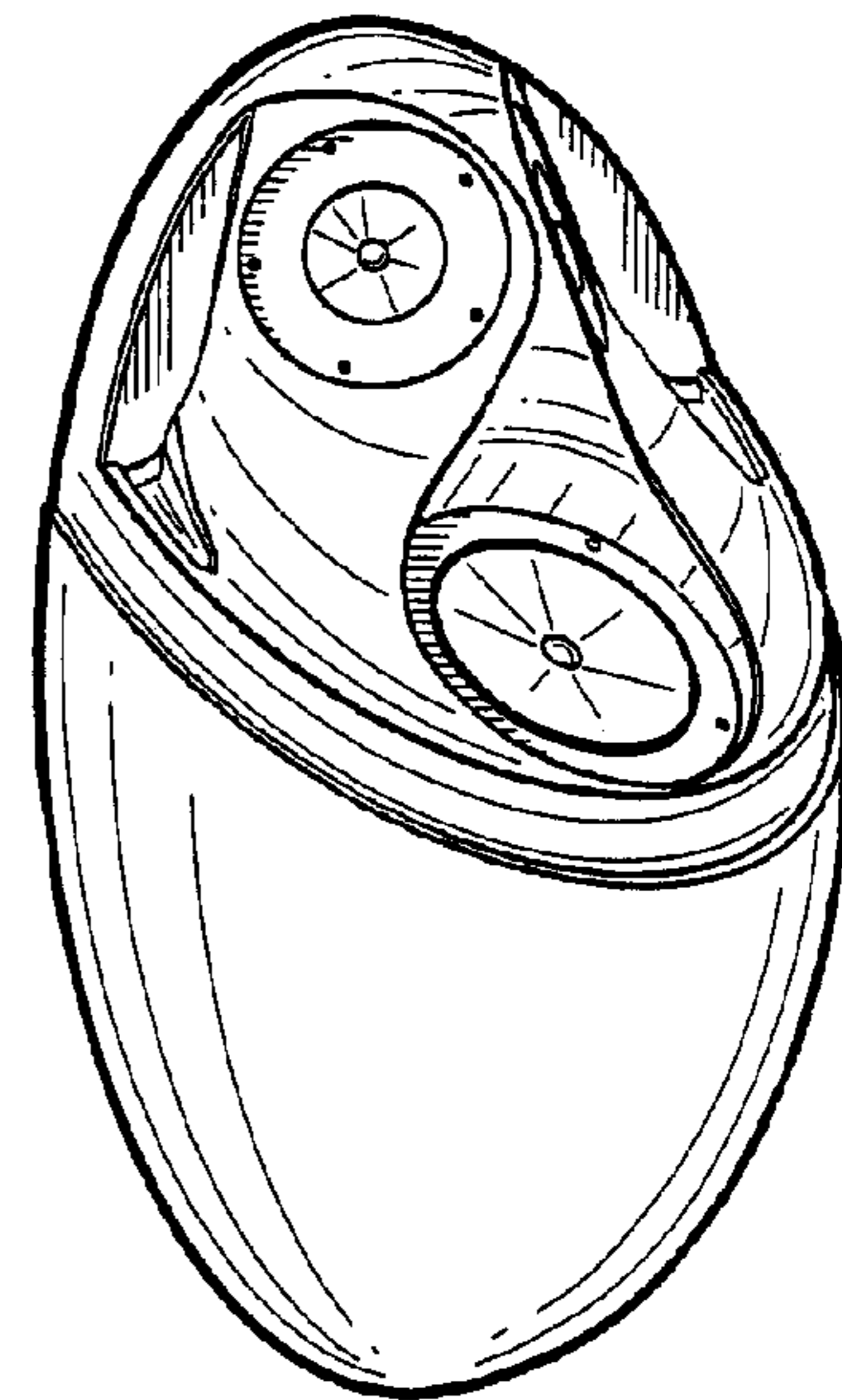
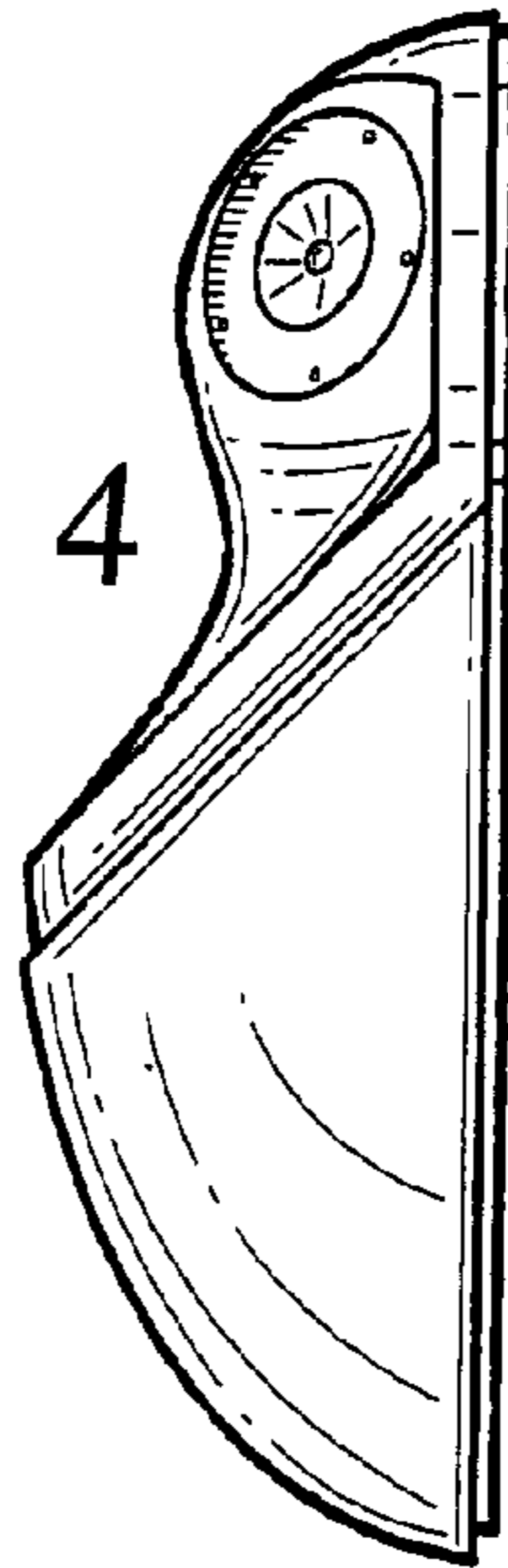

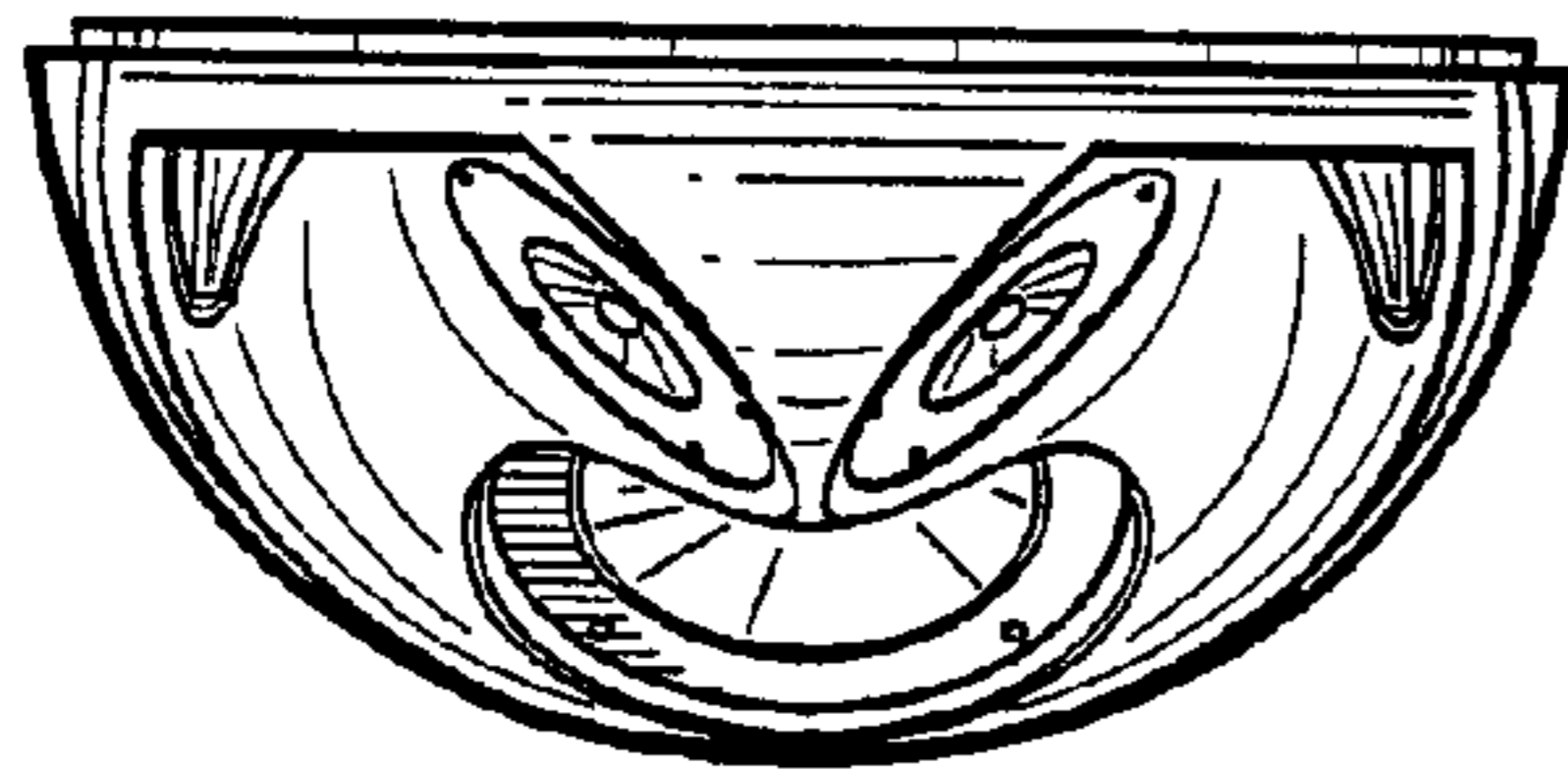

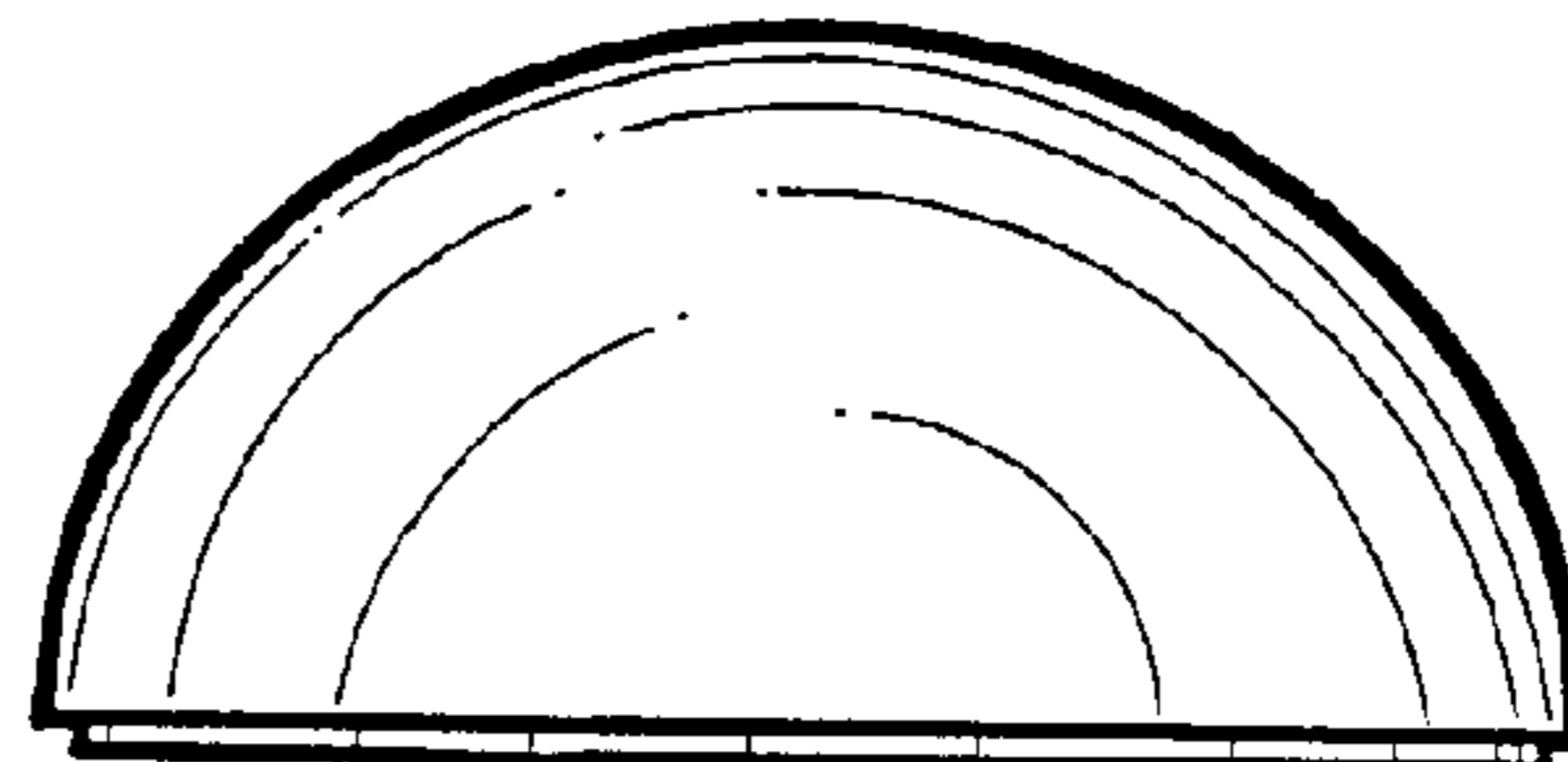

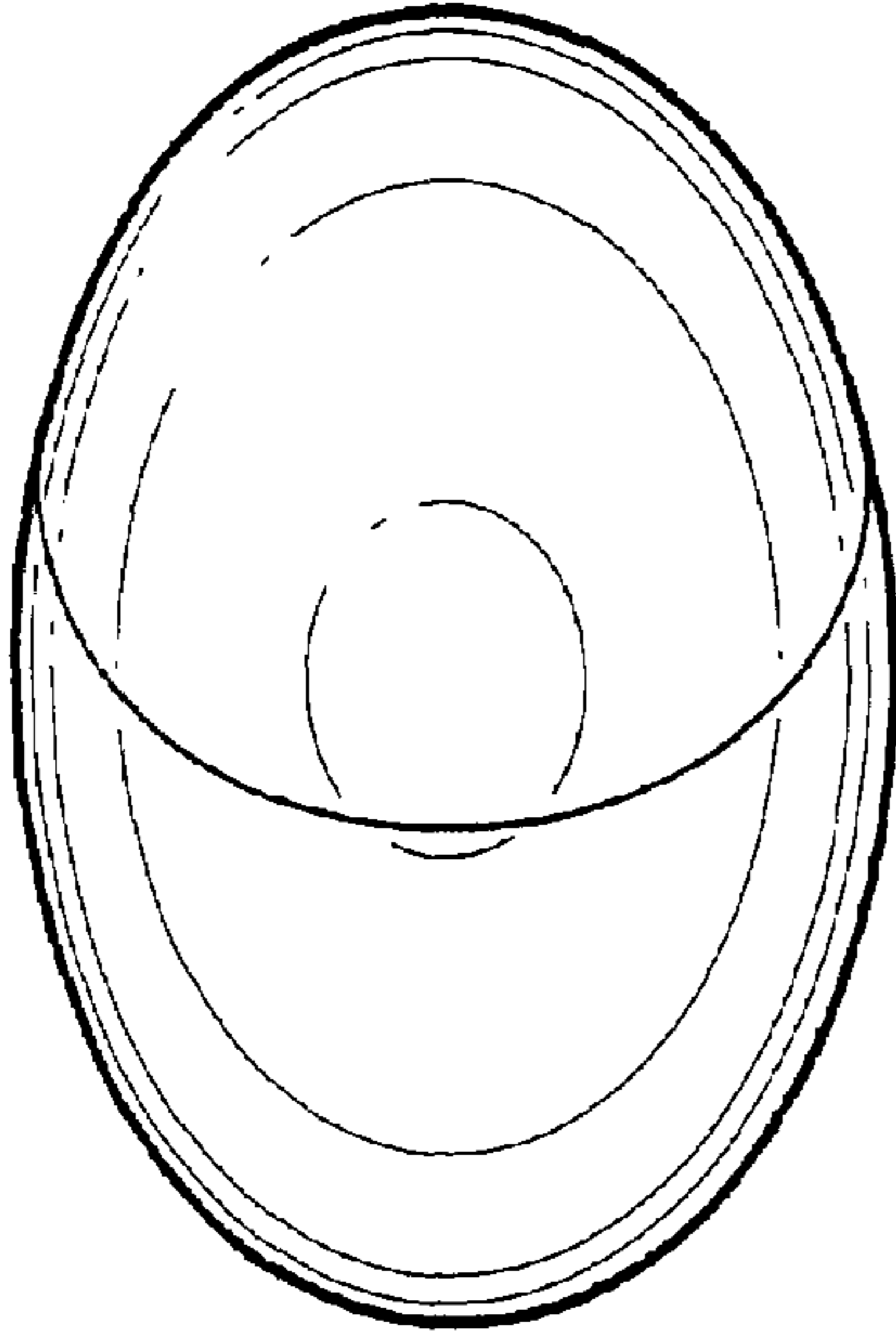

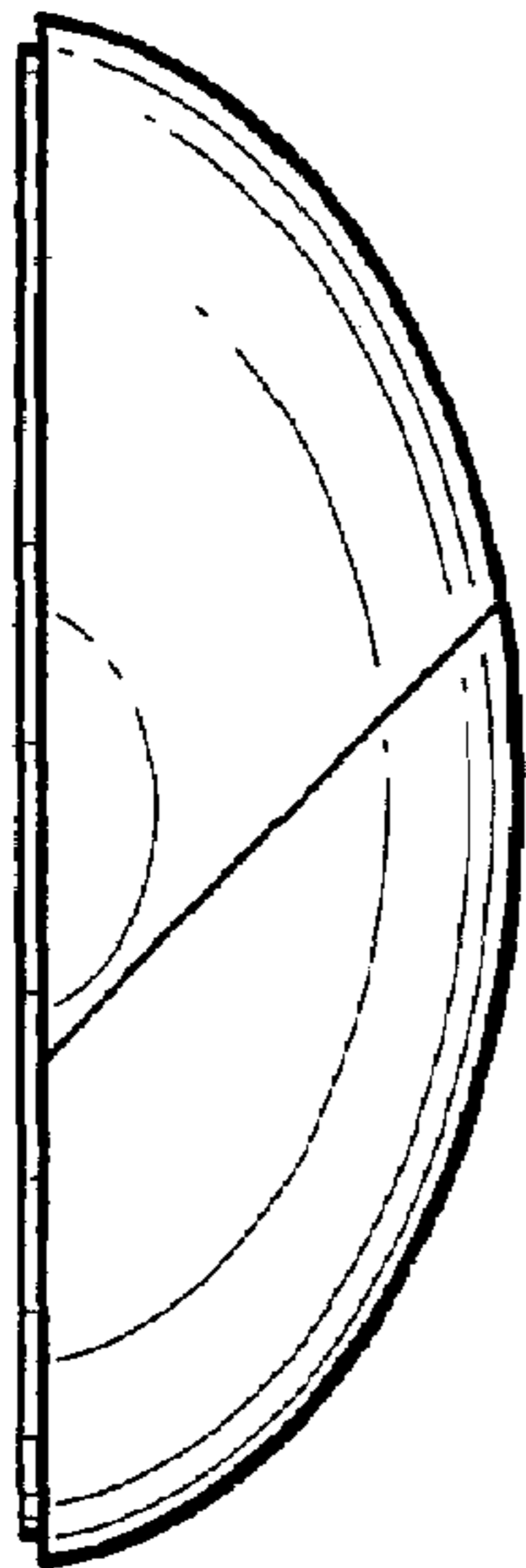
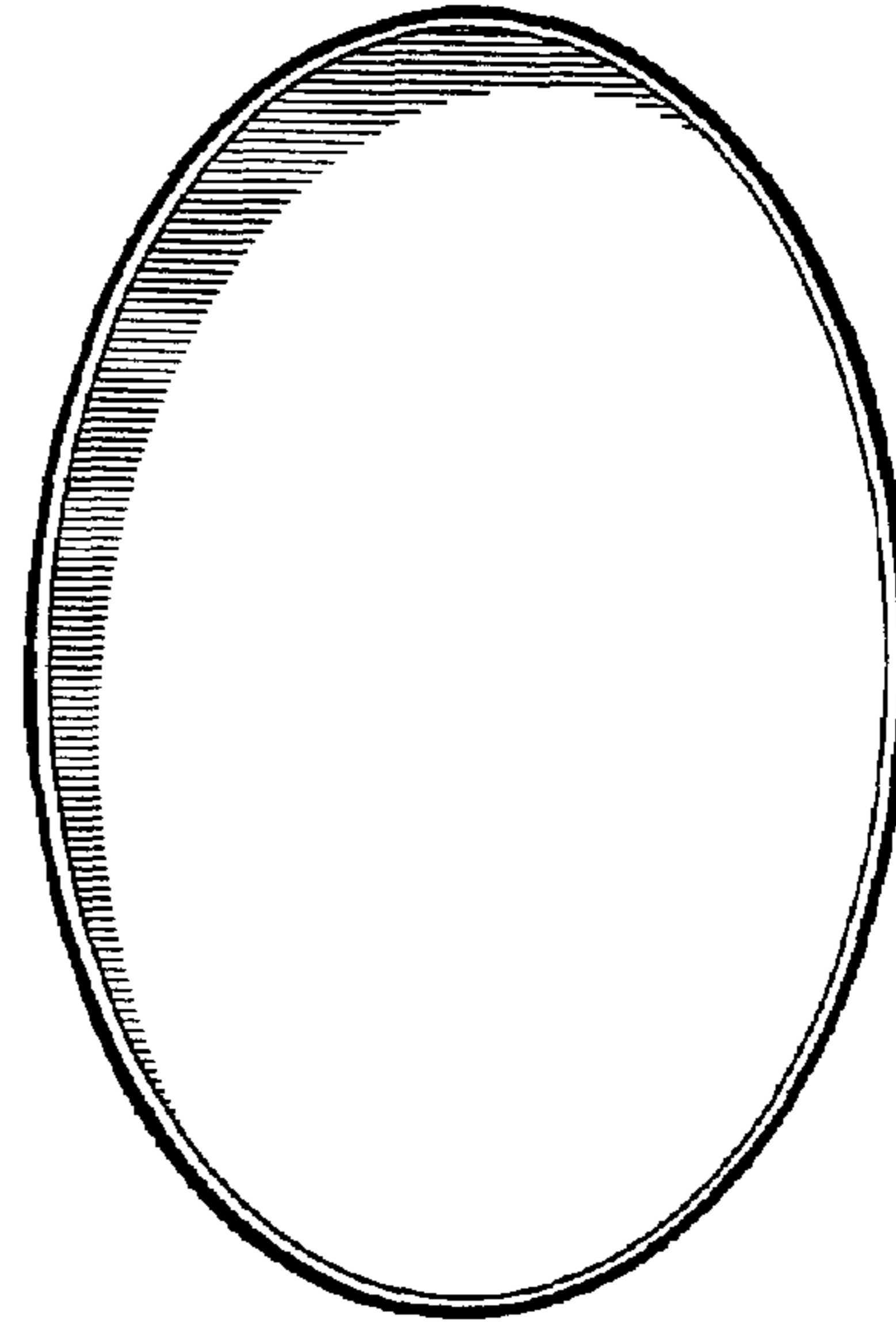

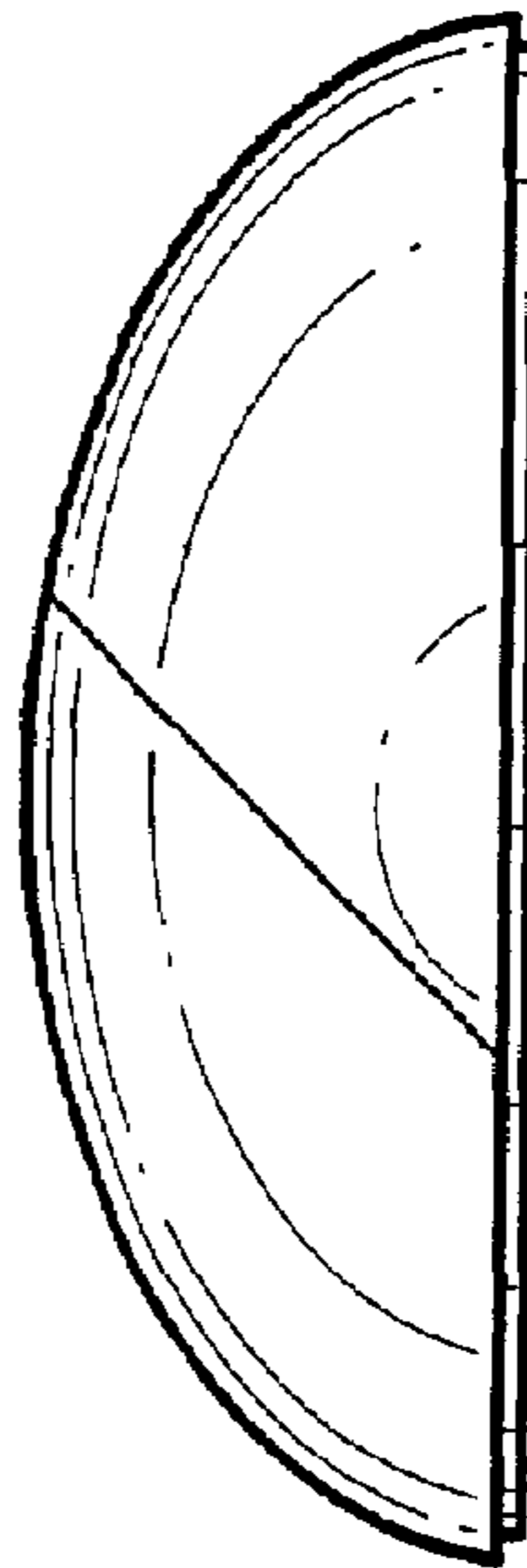

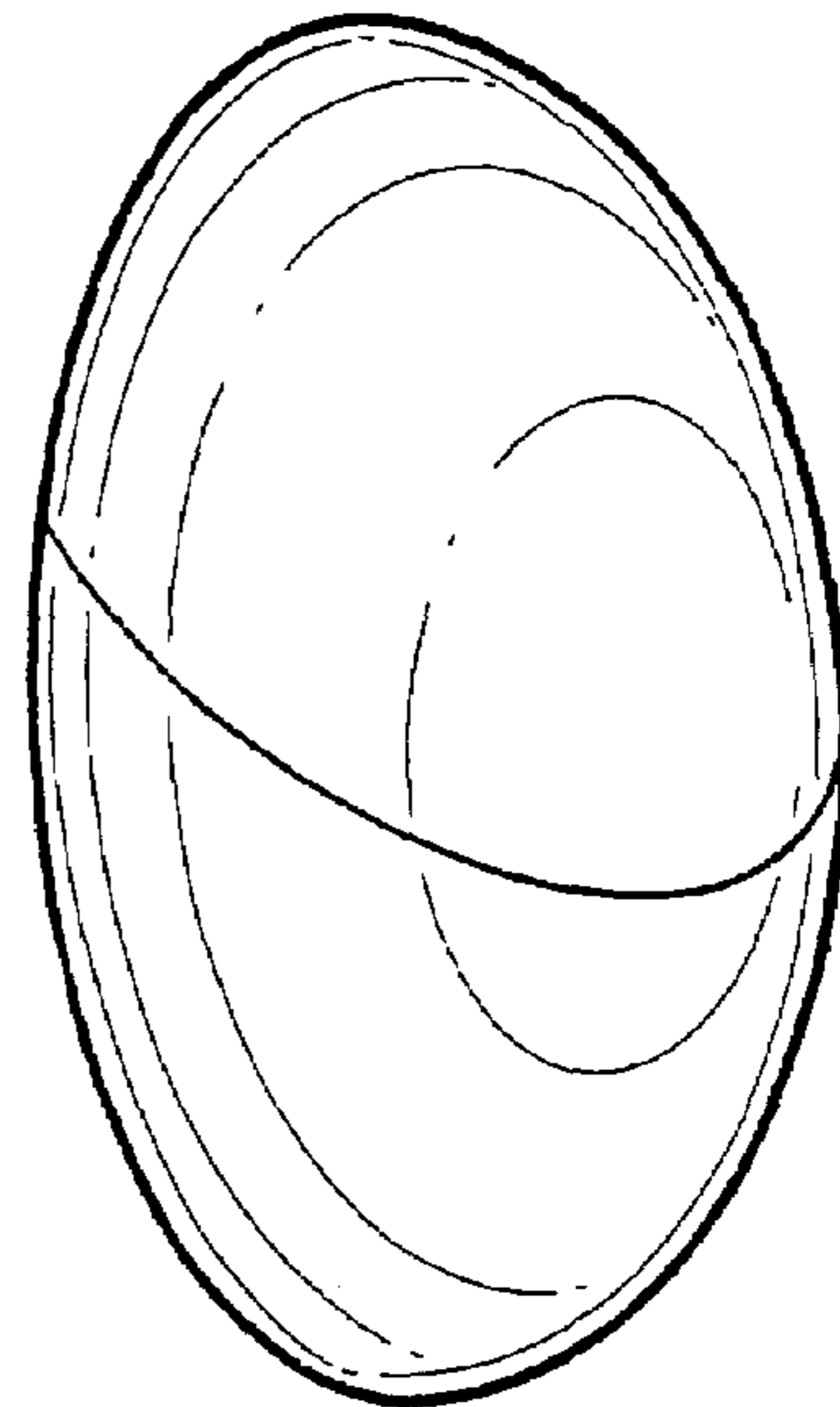

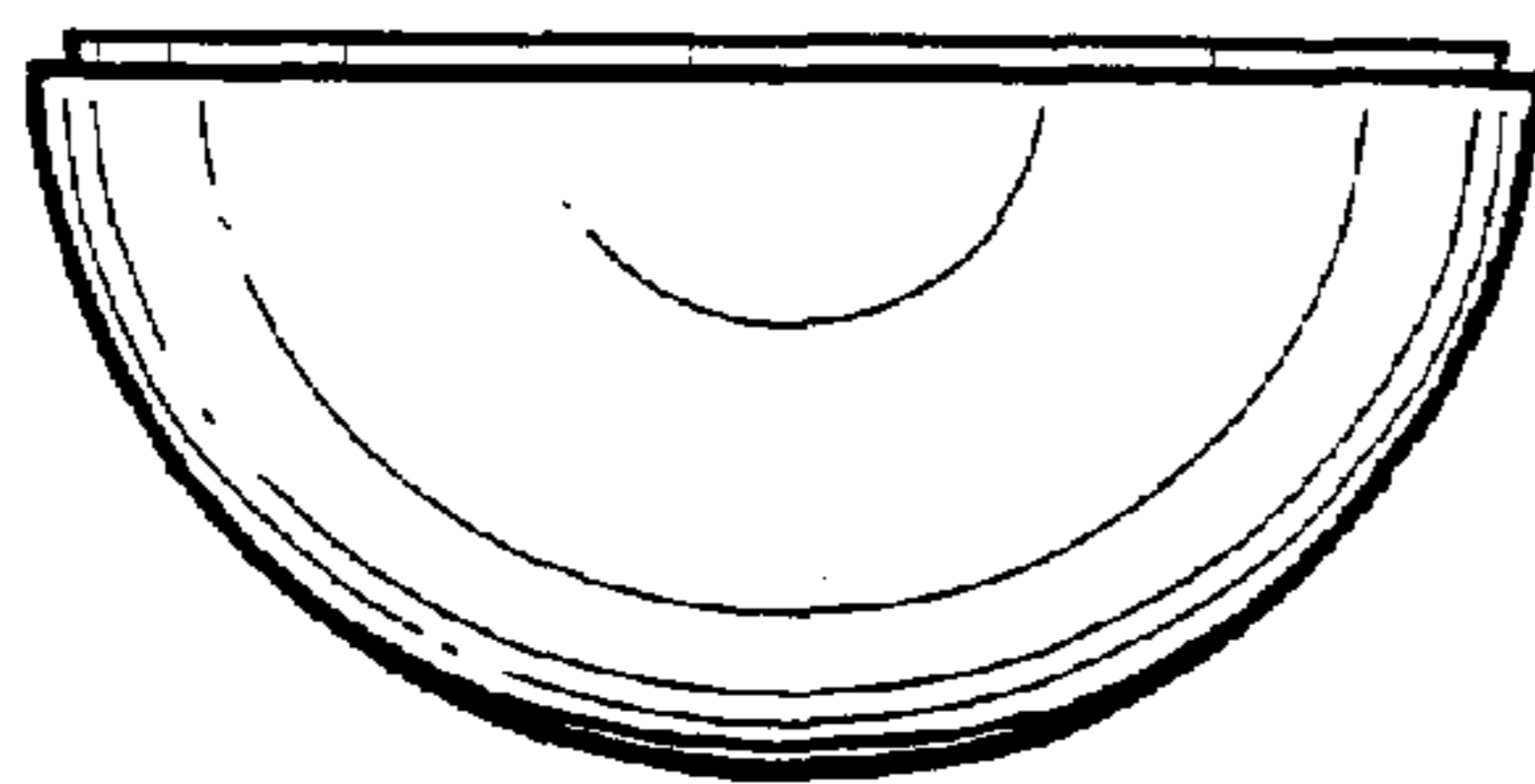
