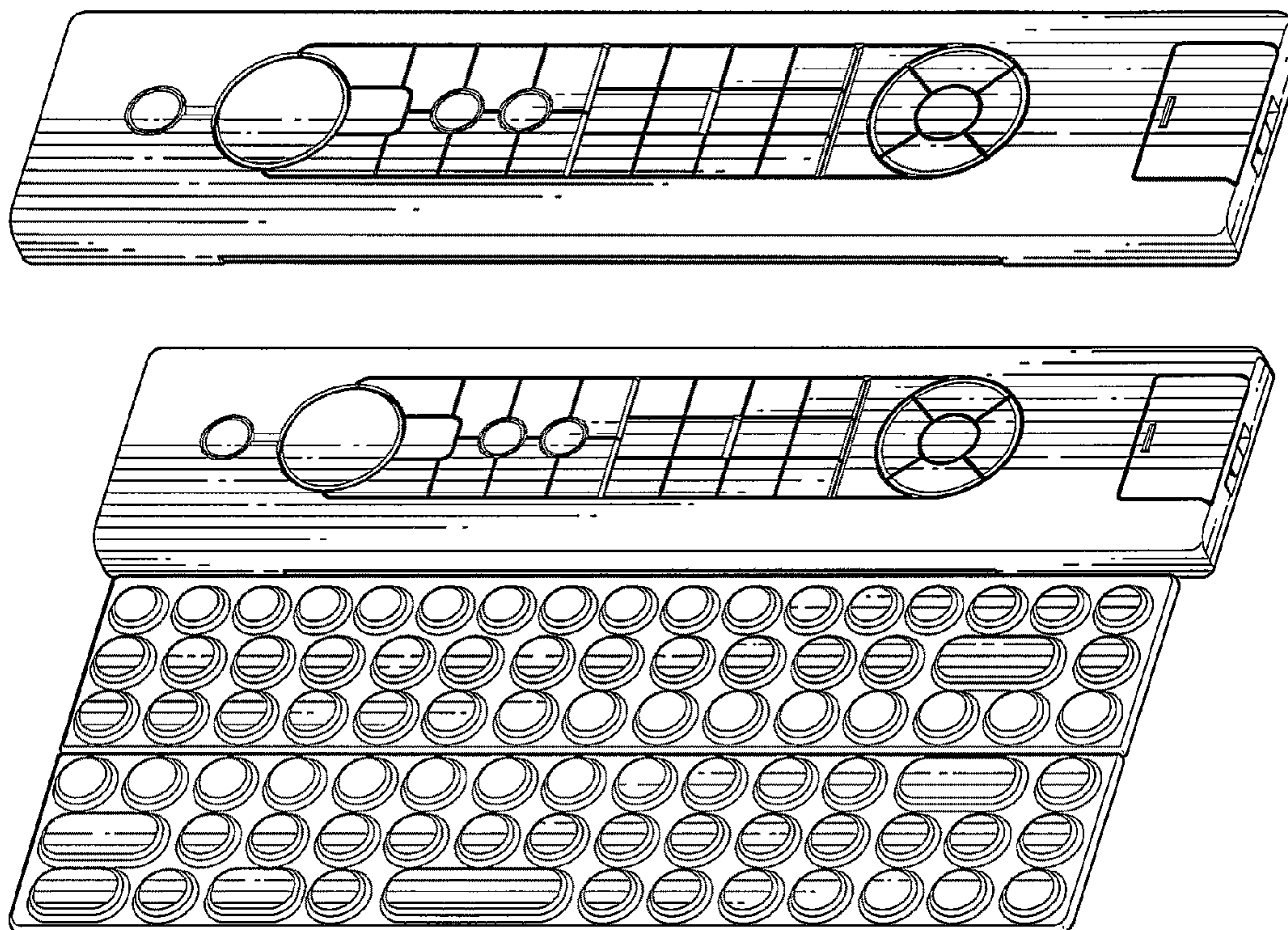
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a remote keyboard showing my new design in a folded position;

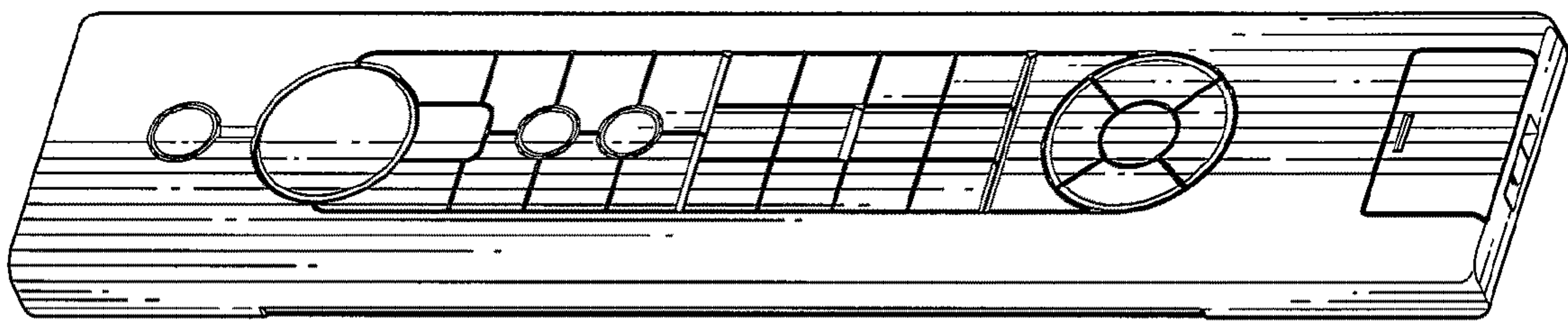

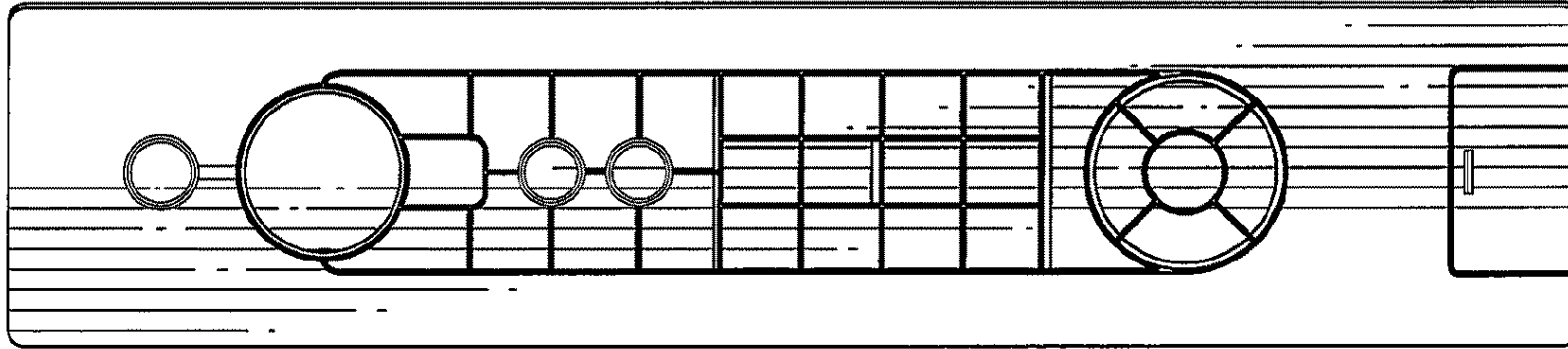

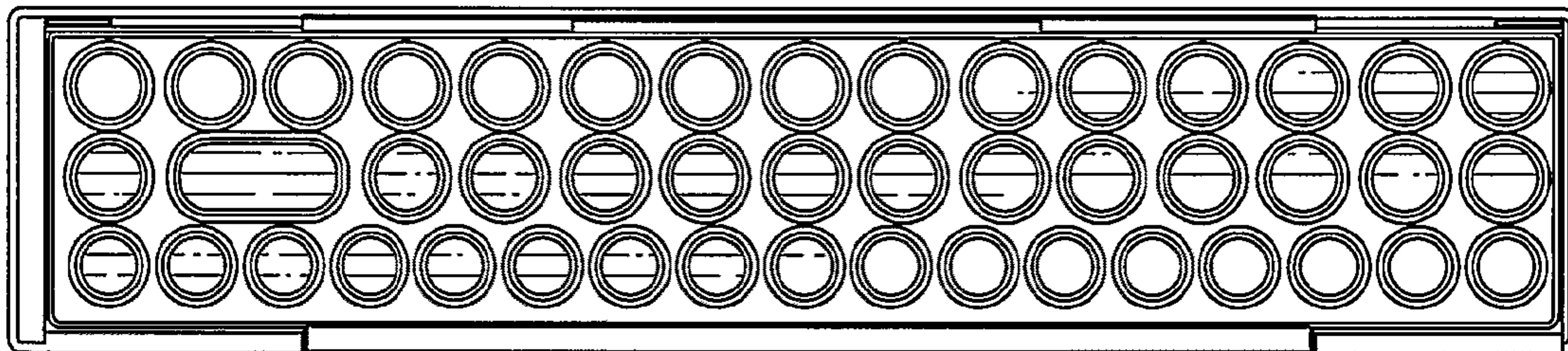

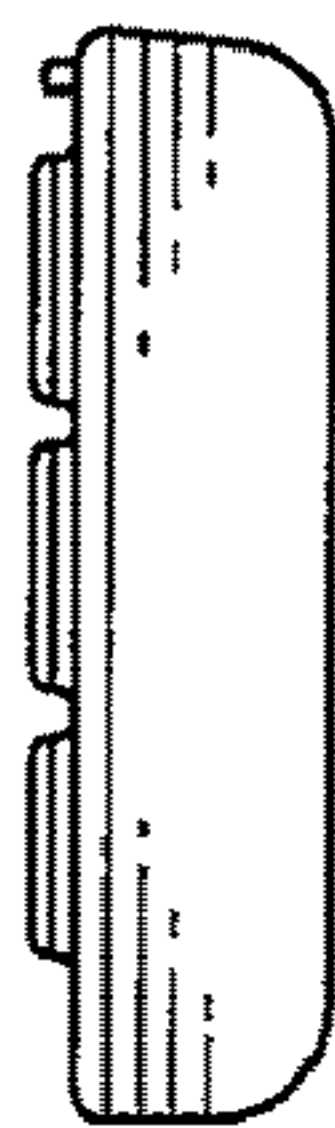

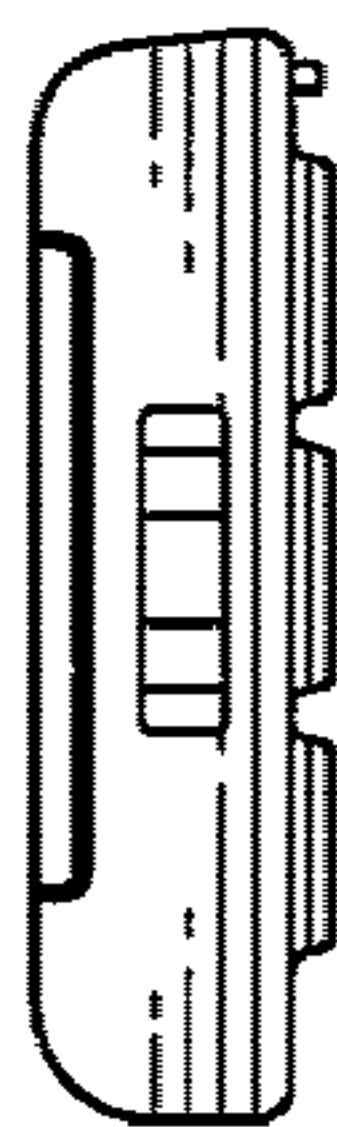

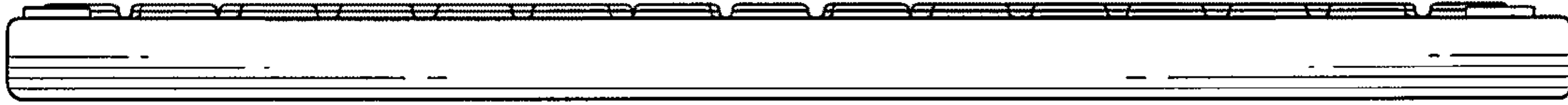

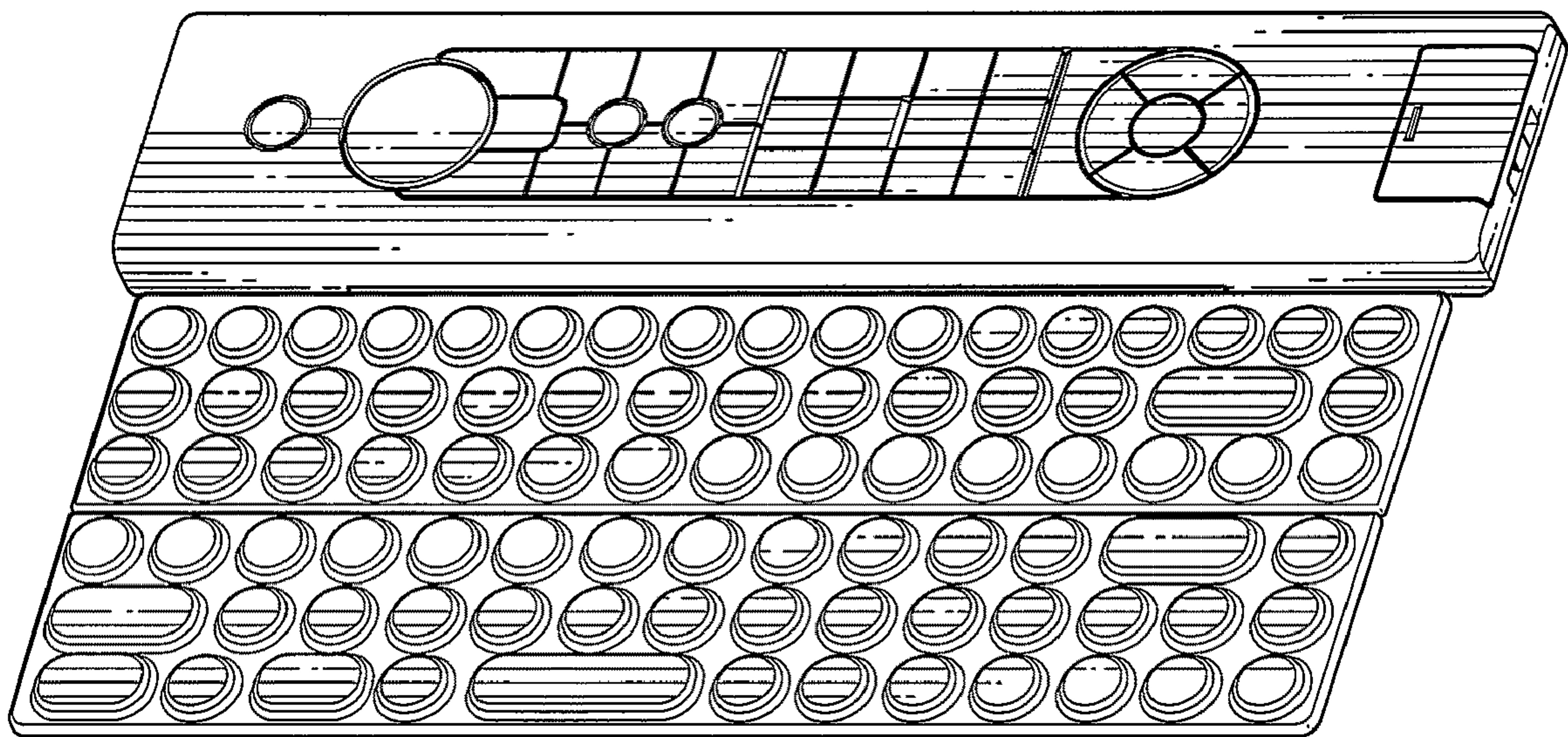
