(57) **CLAIM**

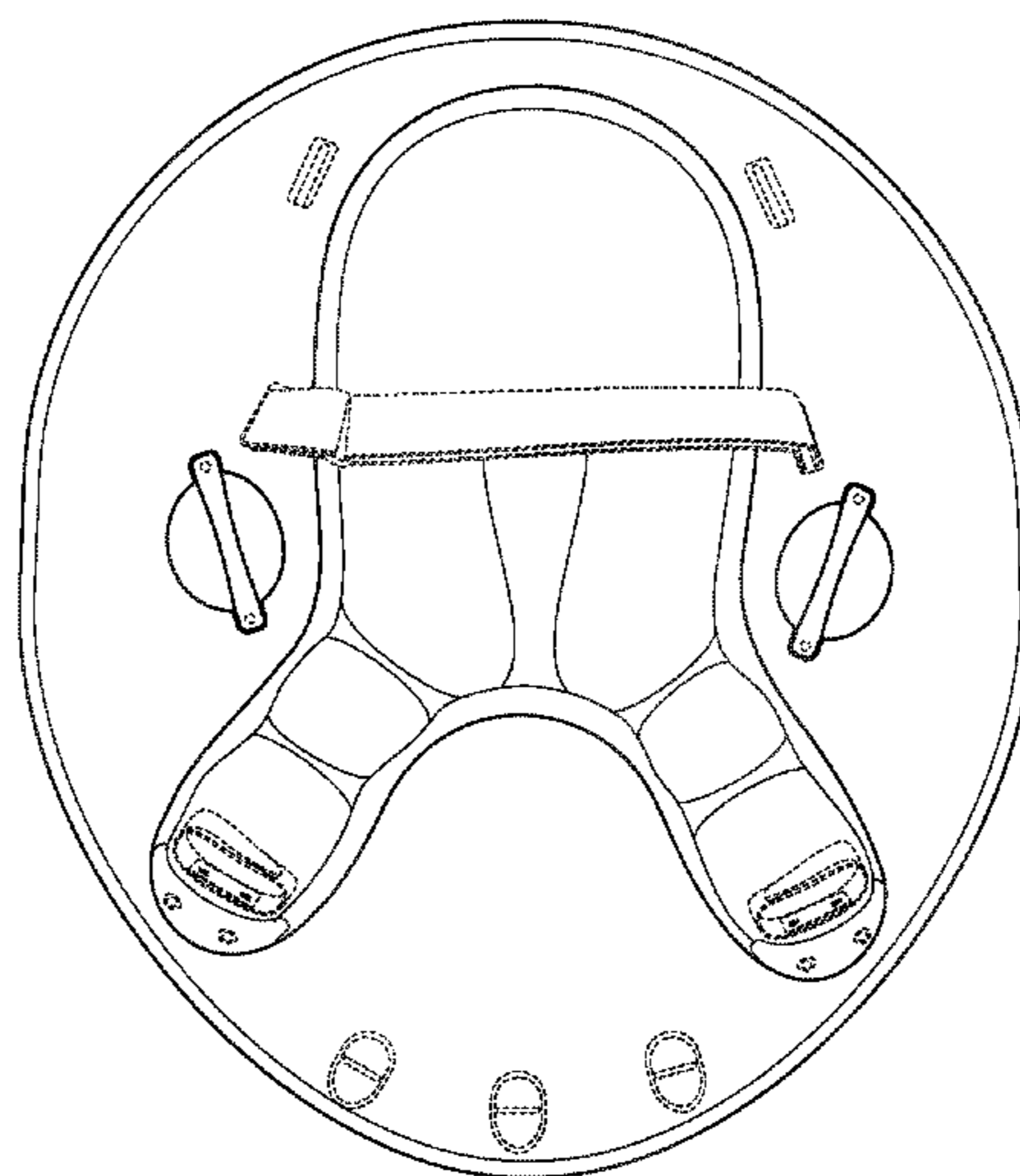
The ornamental design for a water sport board, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the water sport board;

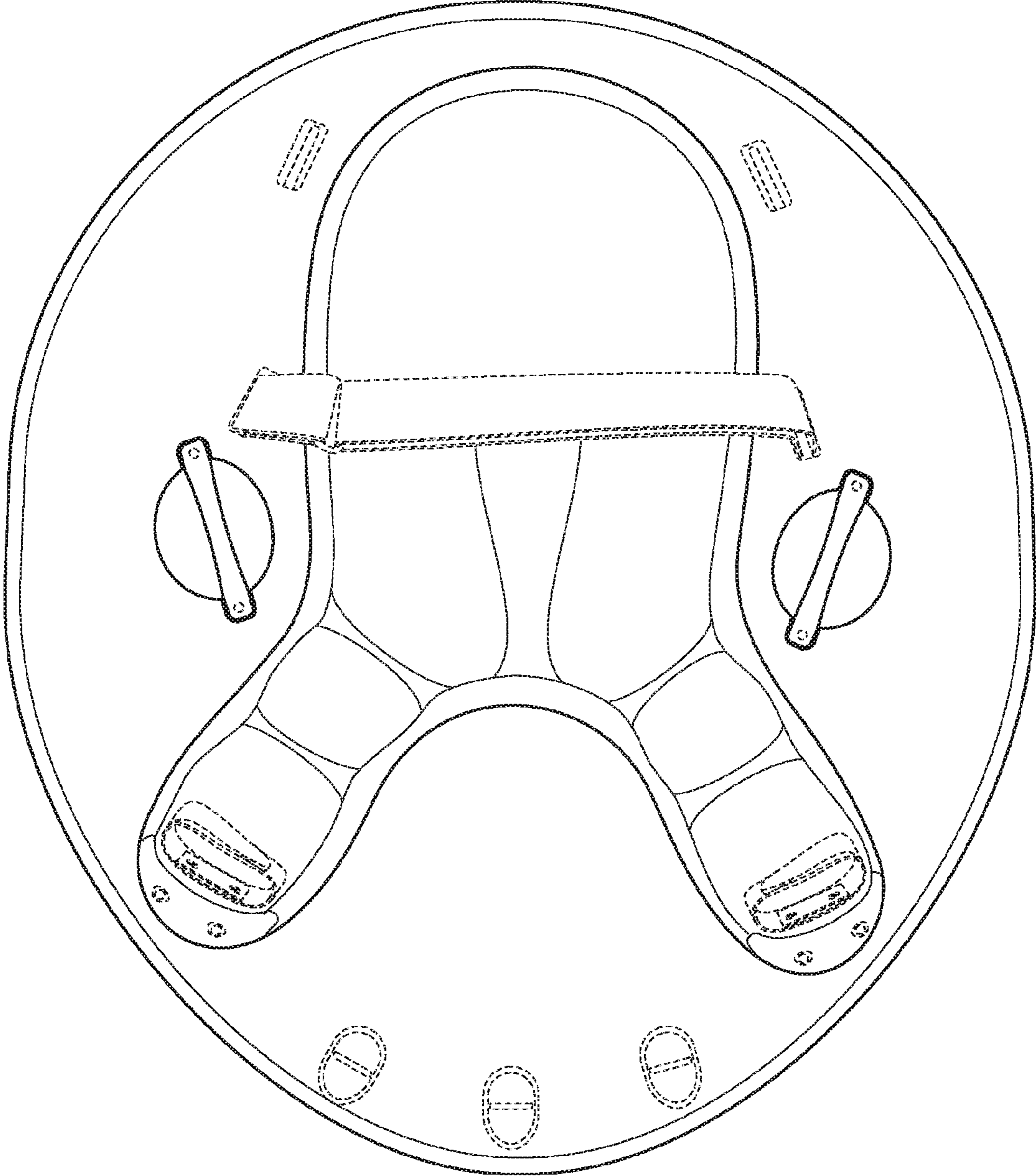

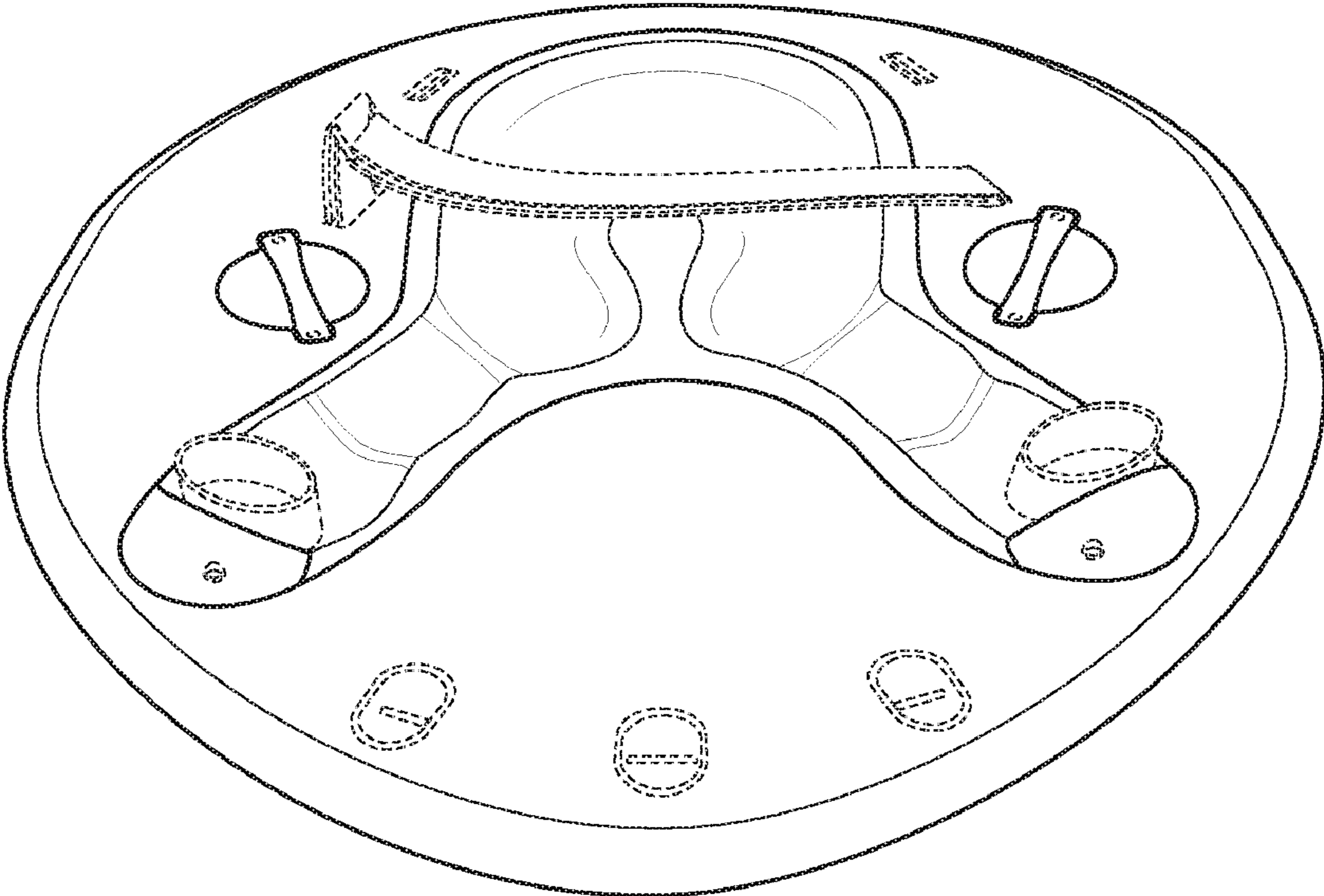

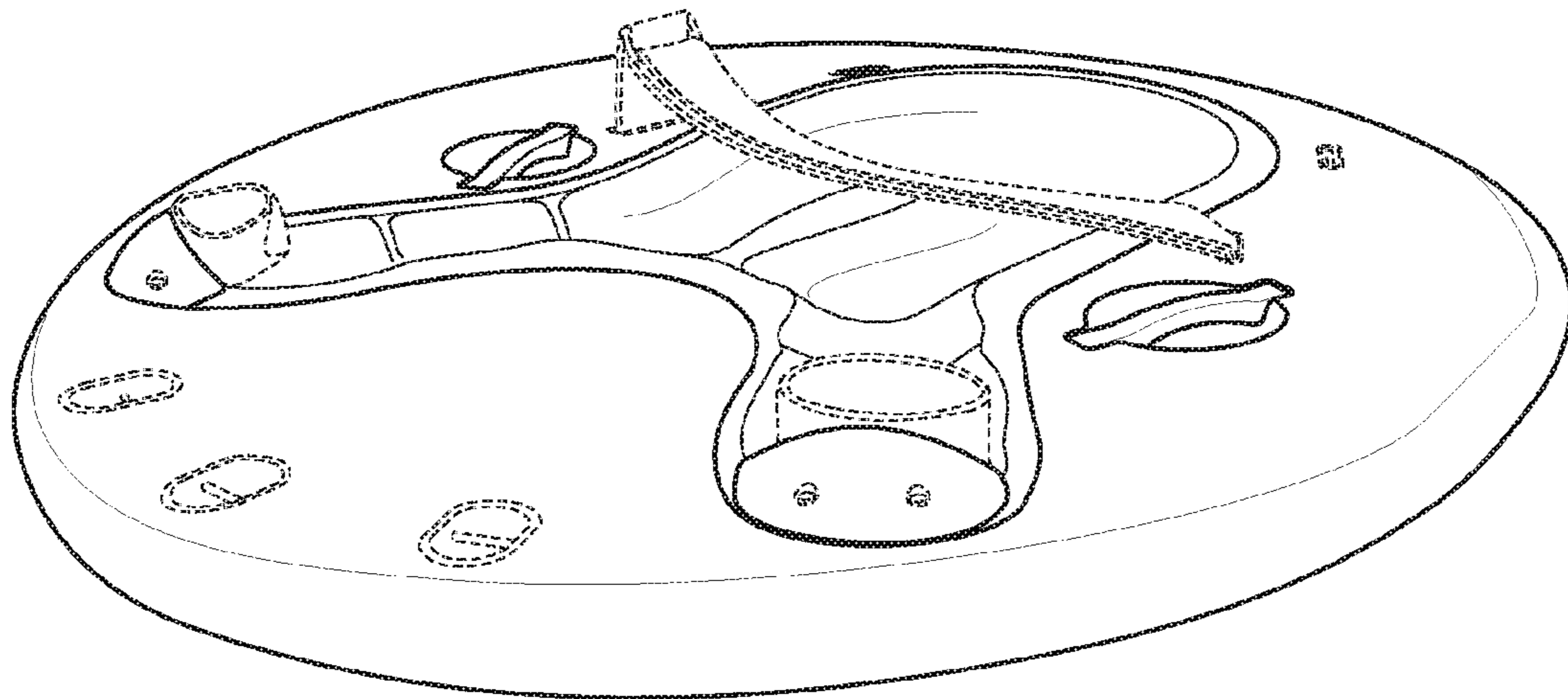

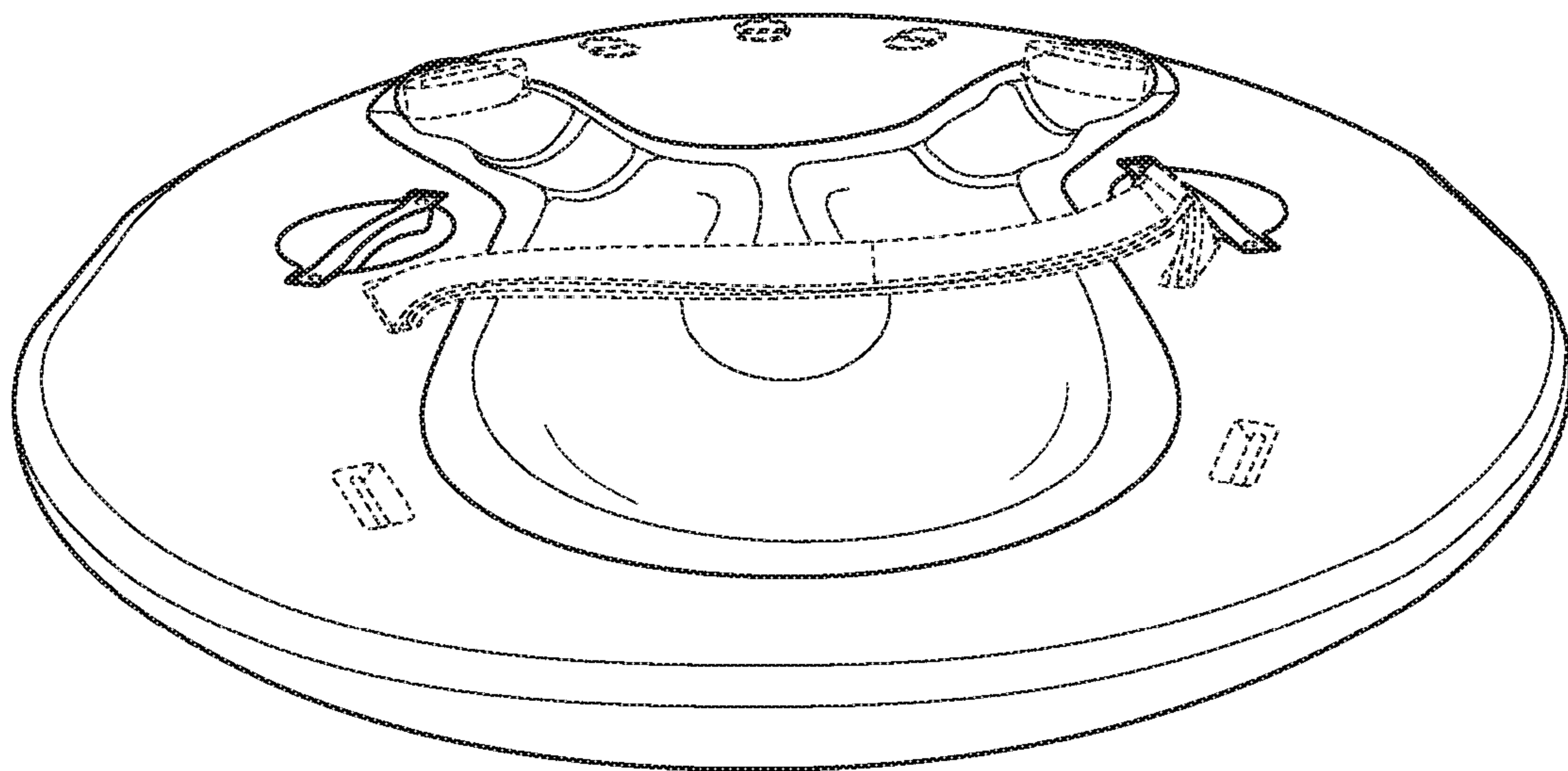

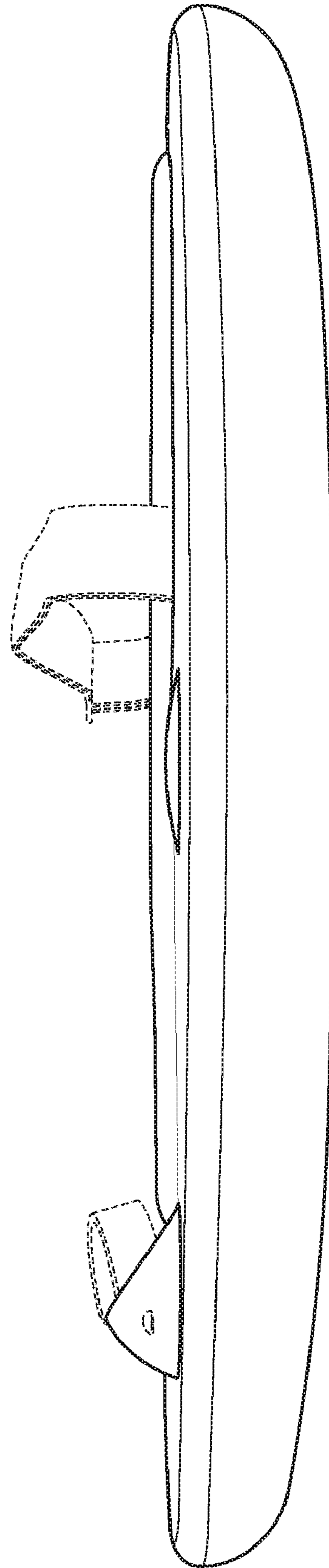

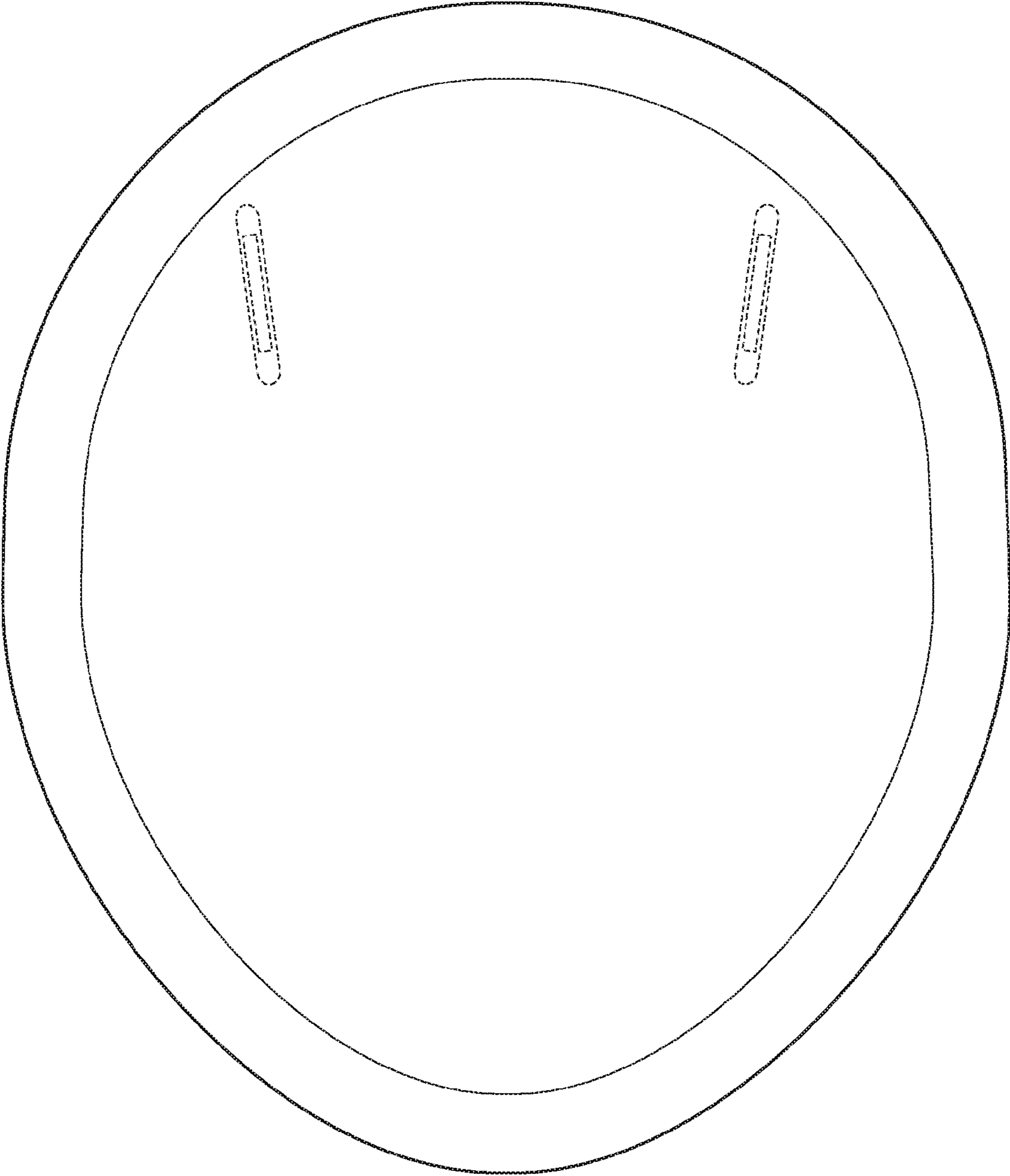
