FIG. 3 is a left side elevational view of the invention.

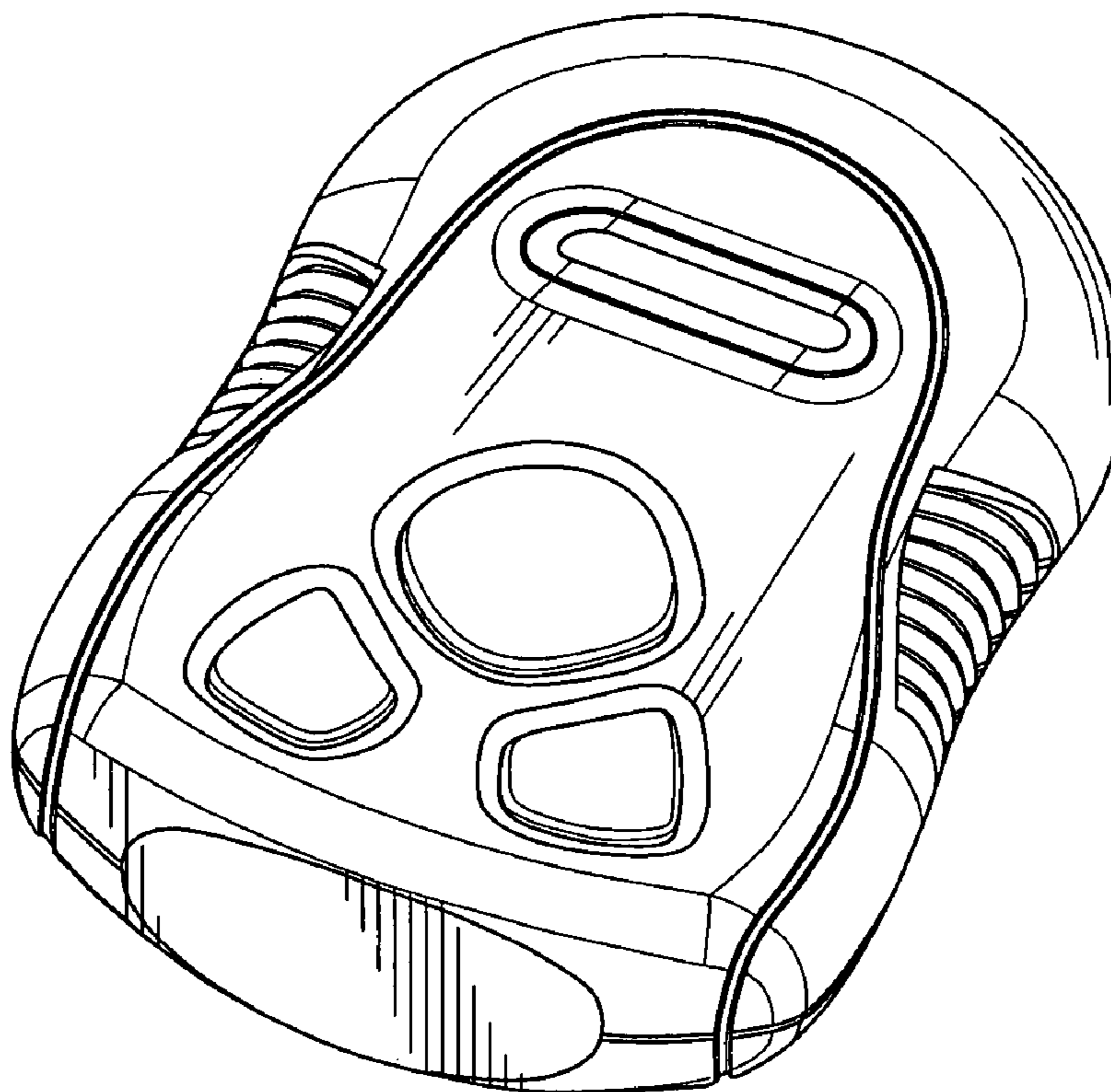
FIG. 4 is a front elevational view of the invention.

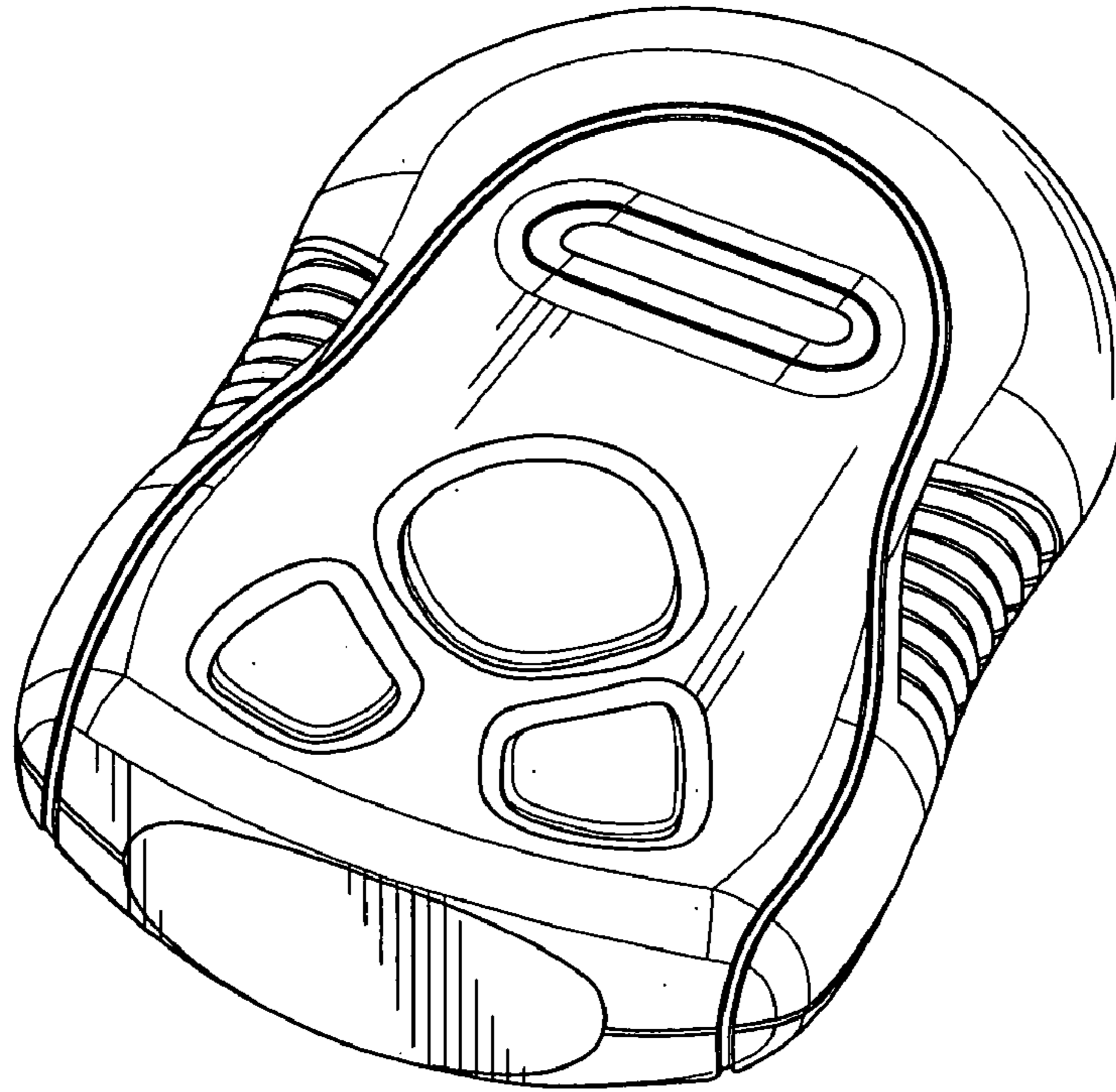

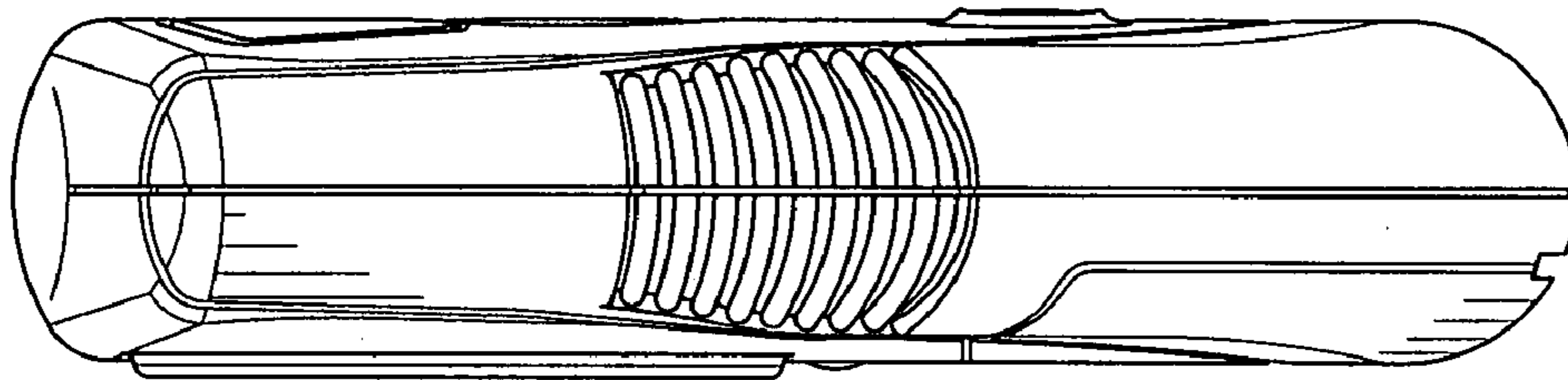

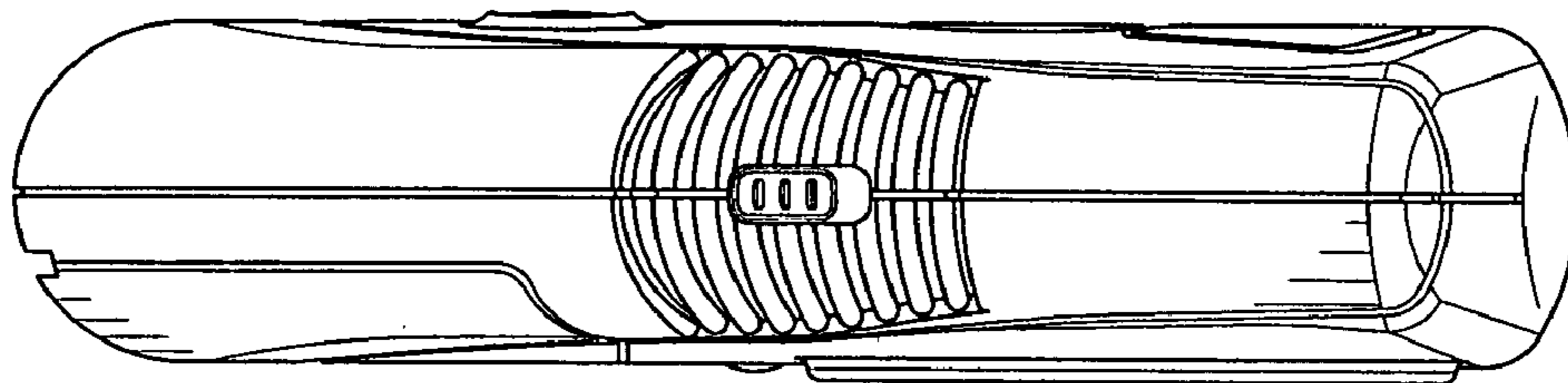

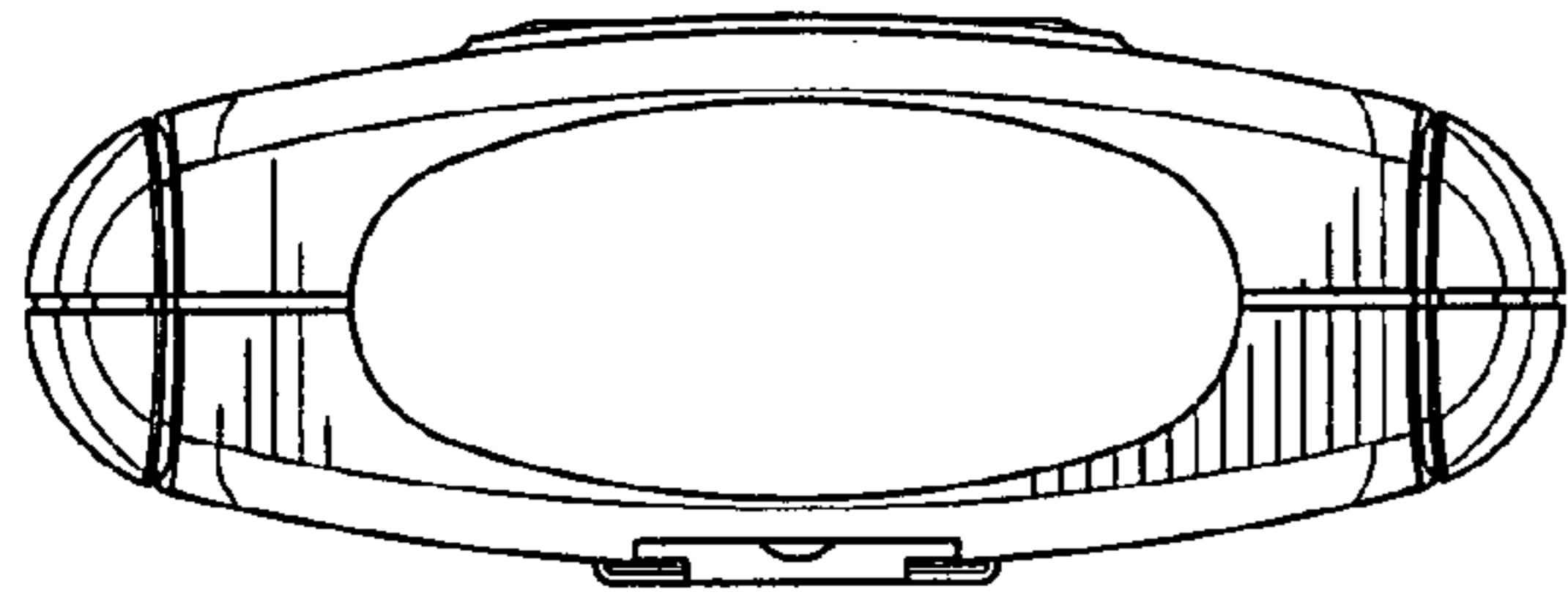

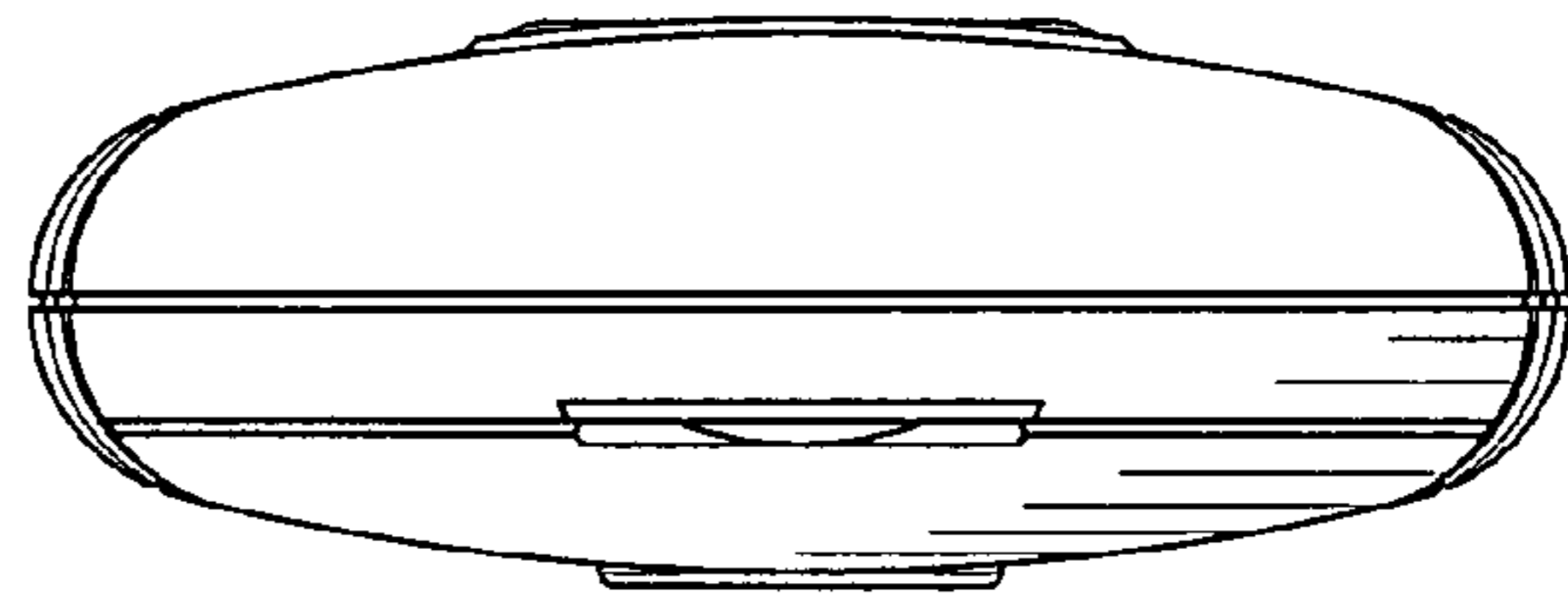

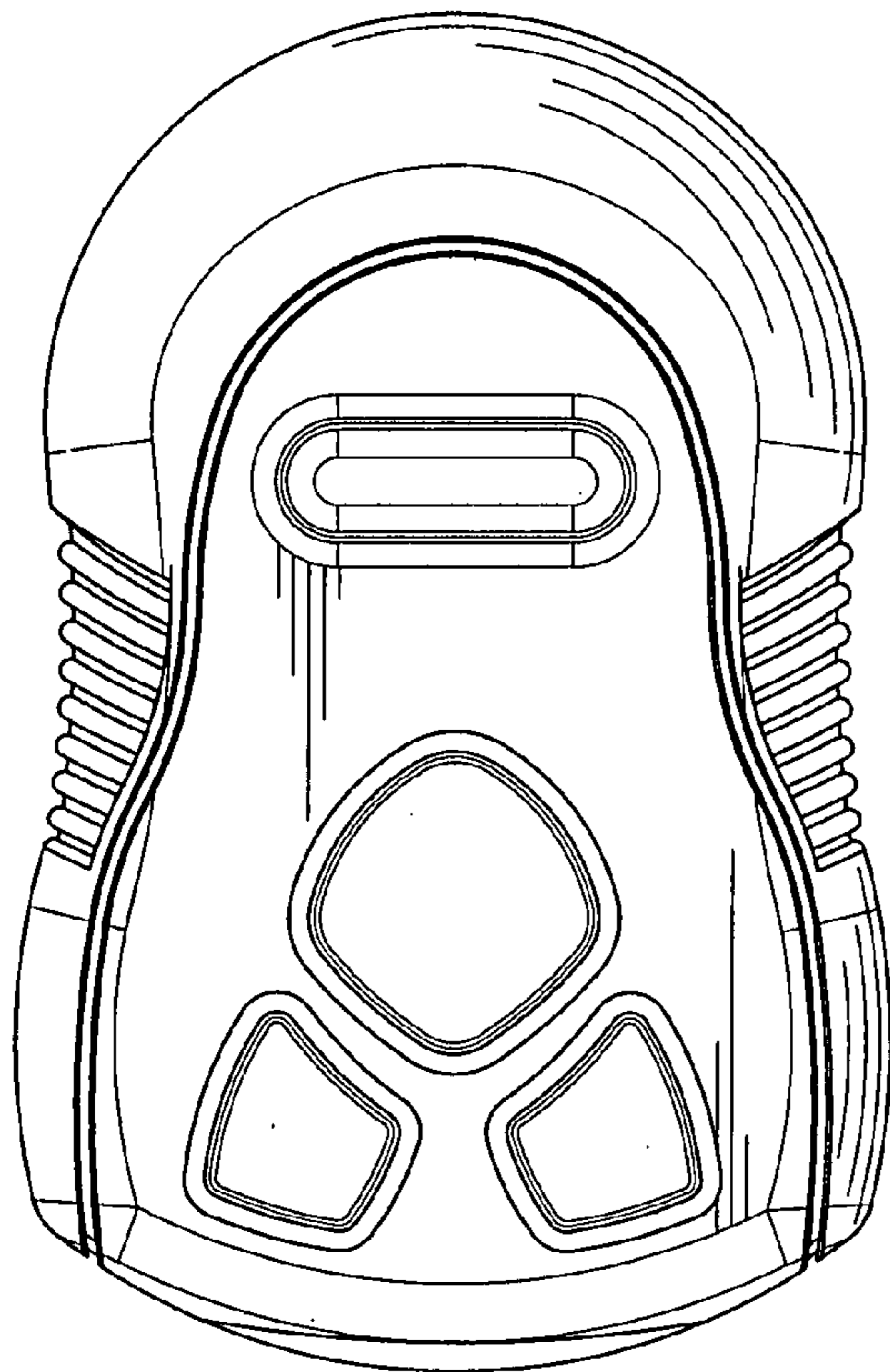

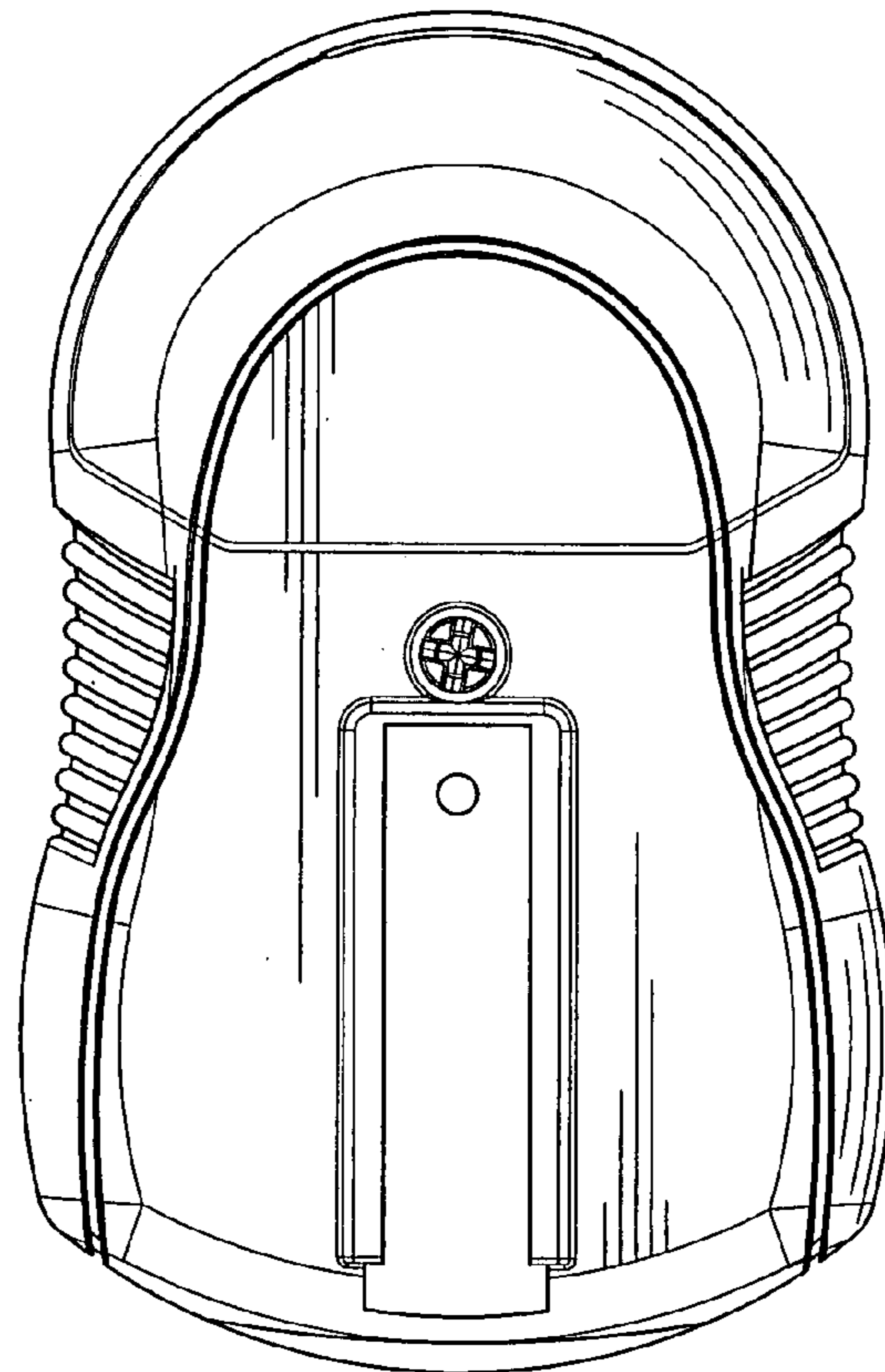
