(57) **CLAIM**

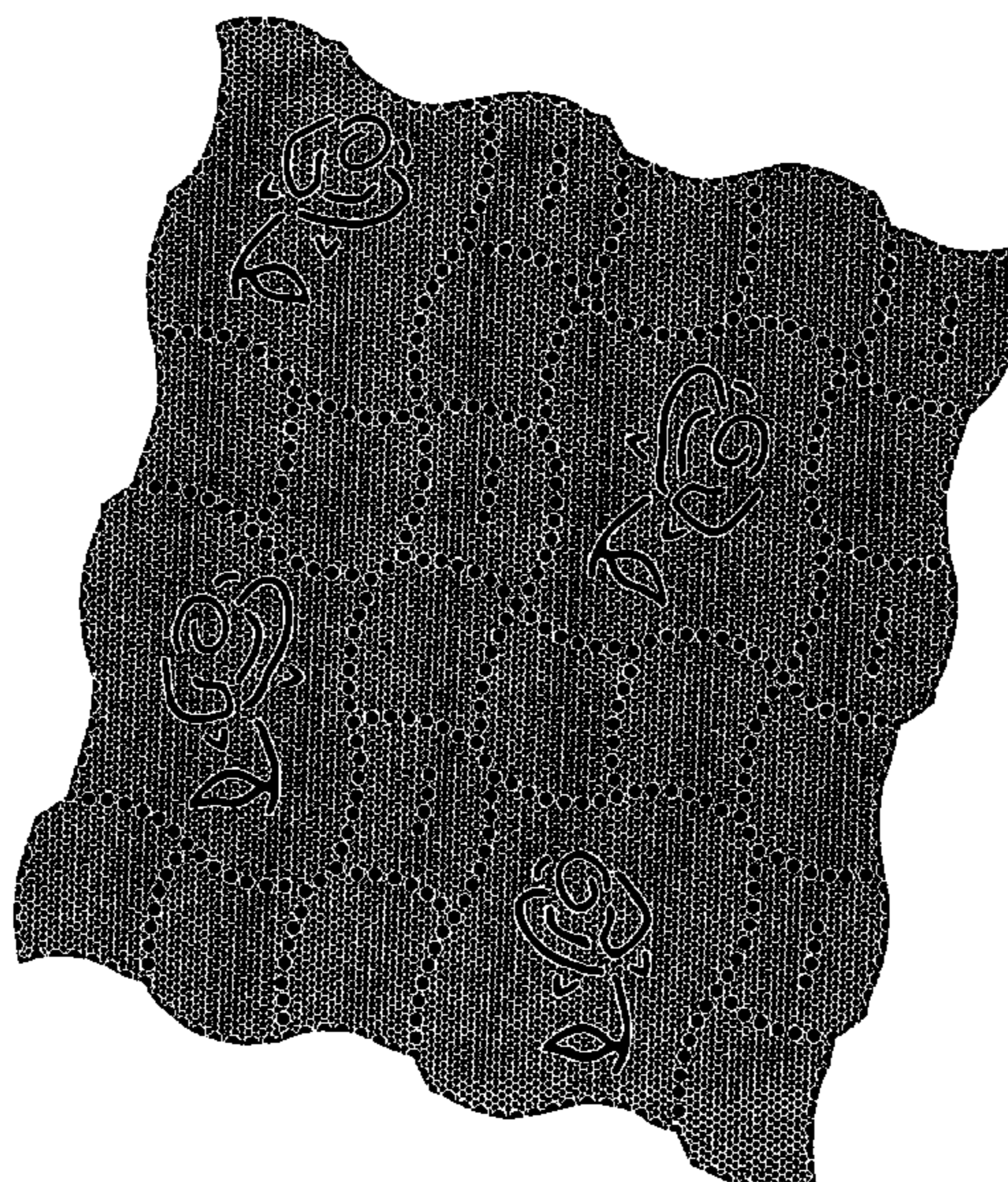
The ornamental design for a papermaking belt and product produced therefor, as shown and described.
