FIG. 7 is a bottom view of the crib according to an embodiment of the present invention.

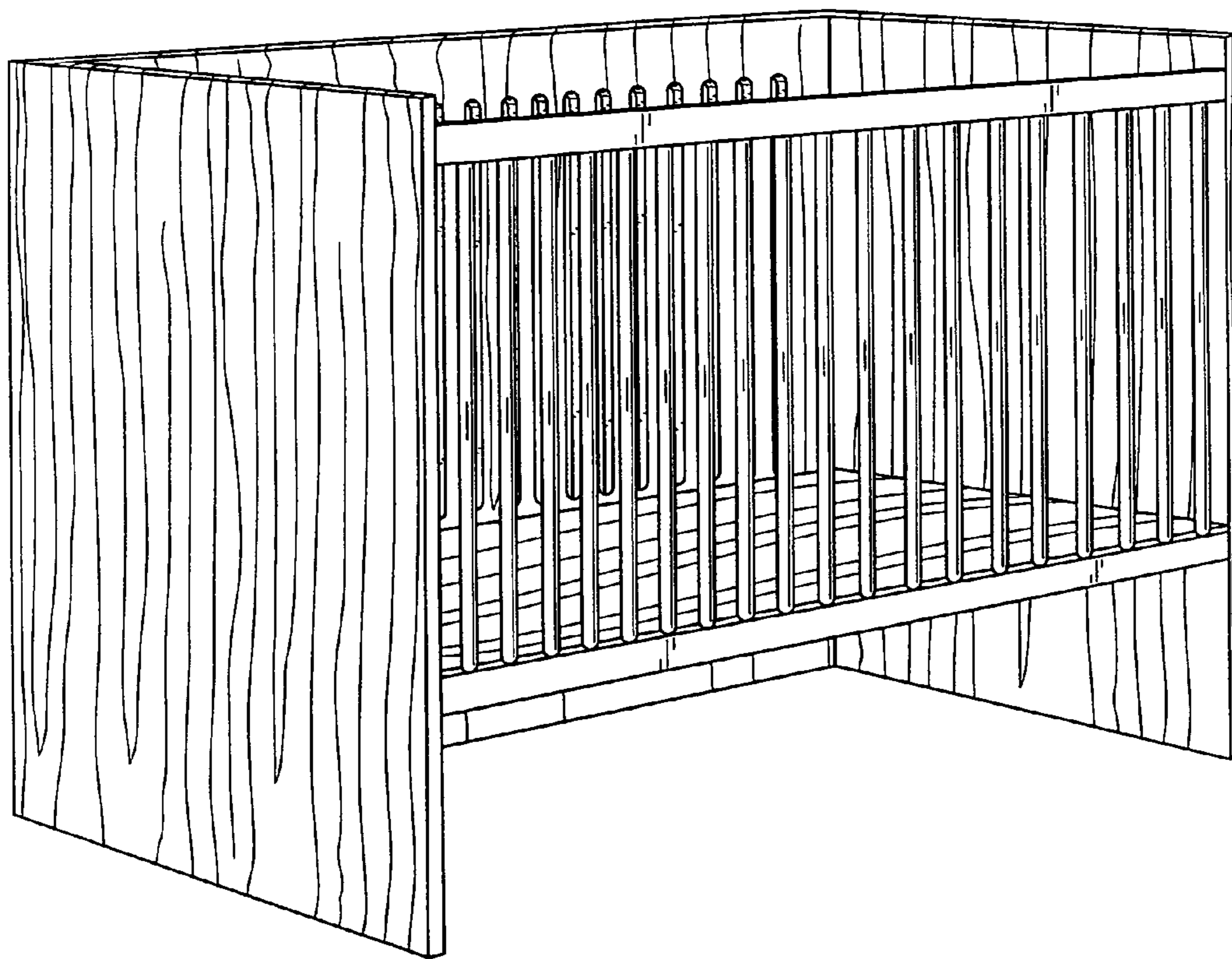

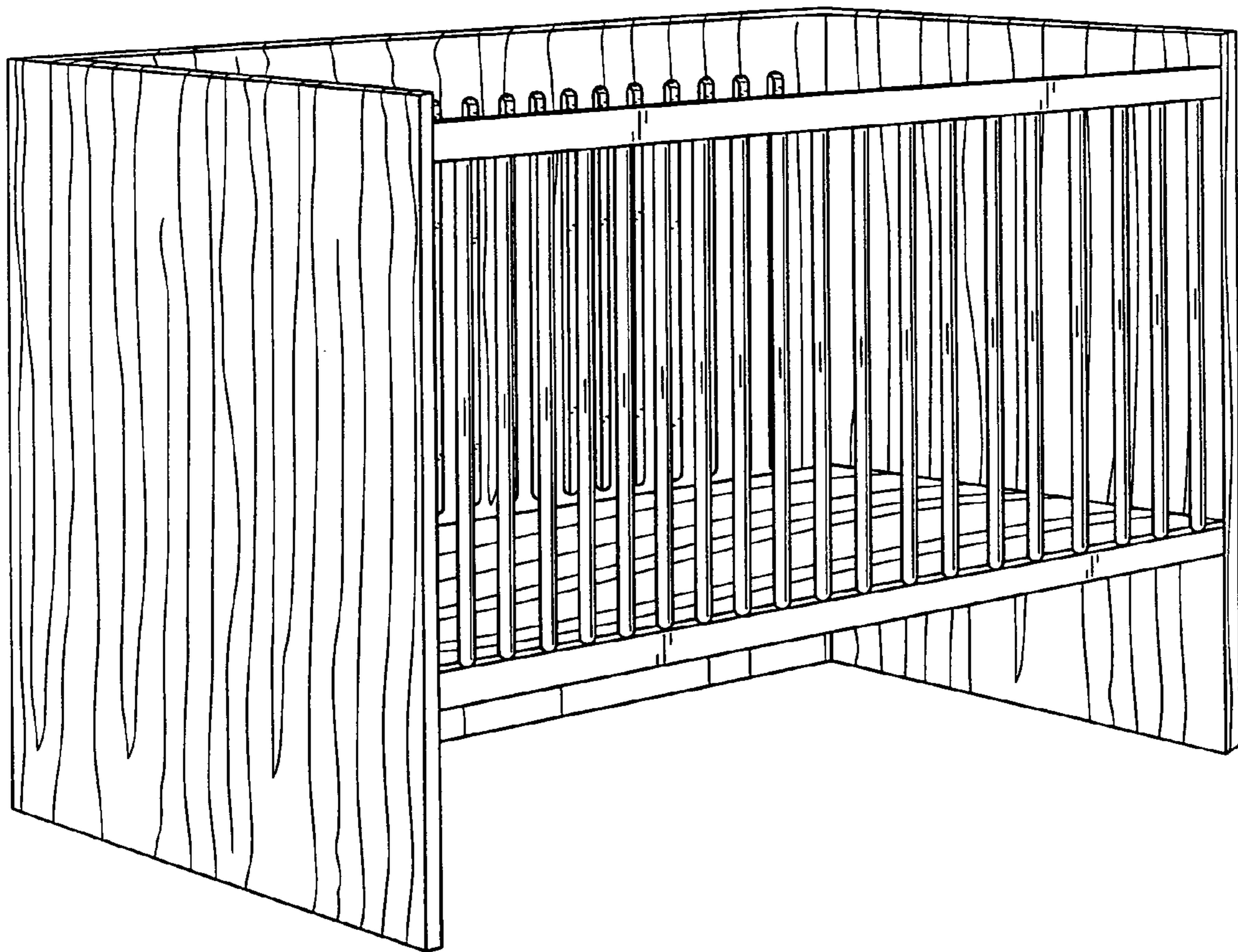

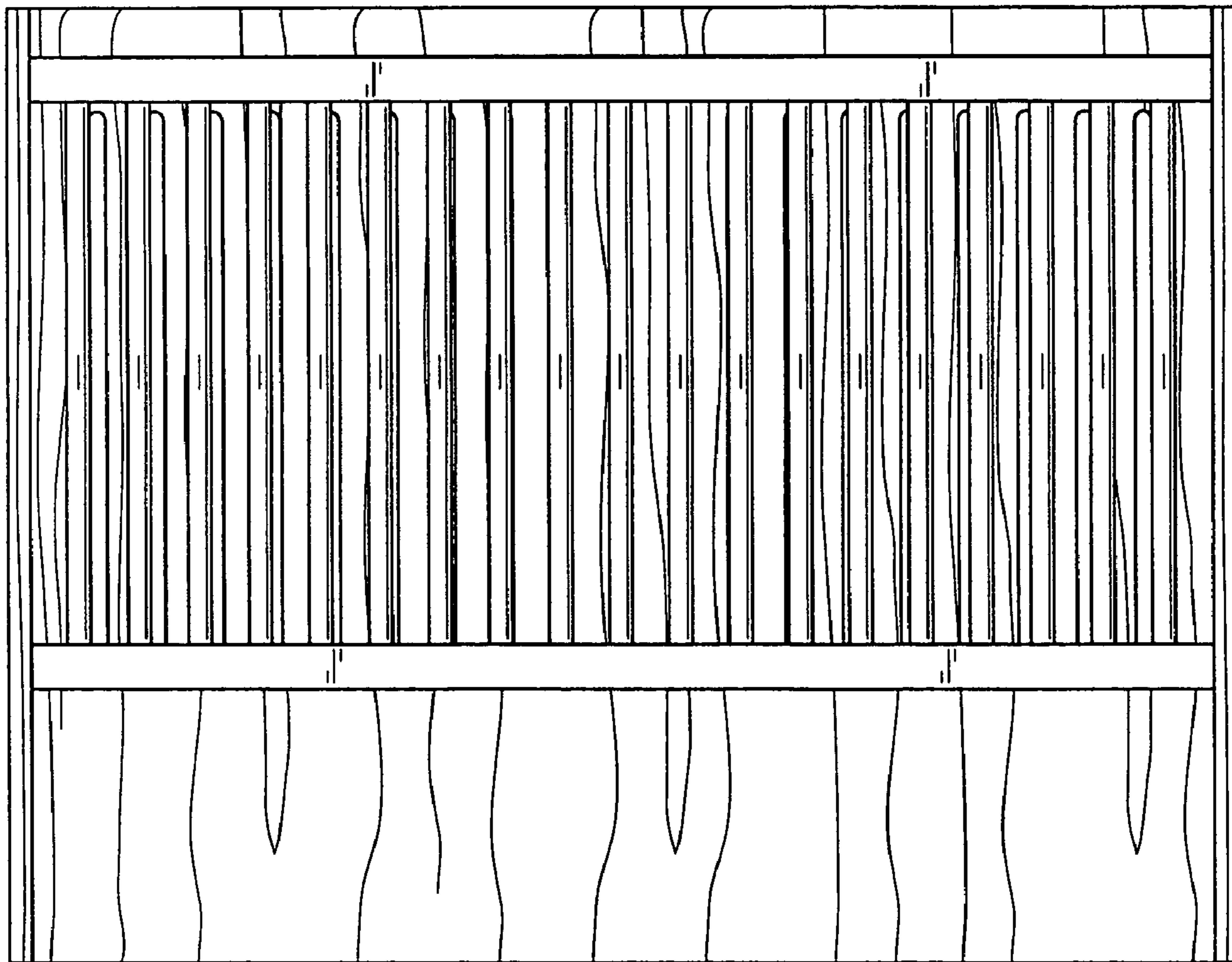

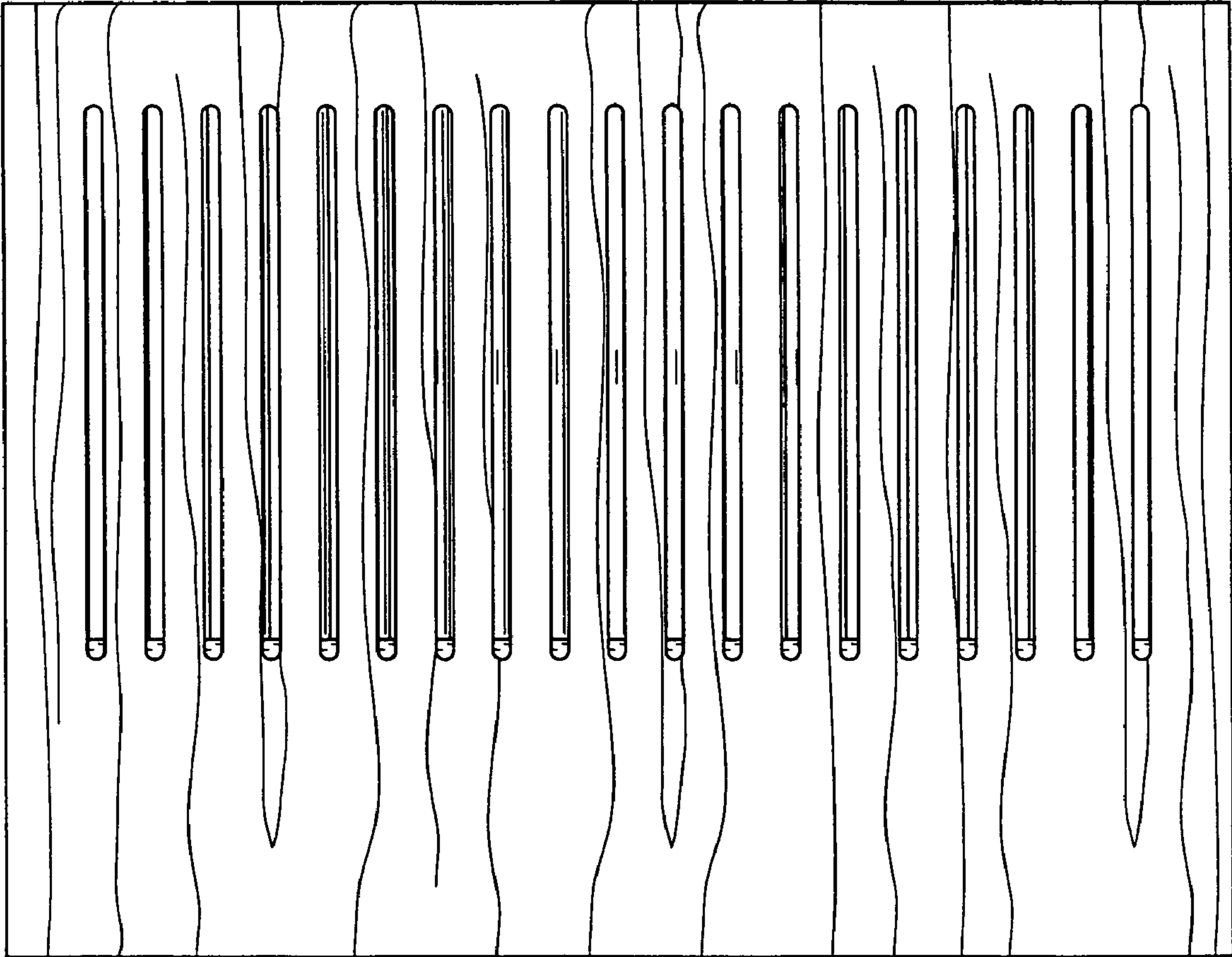

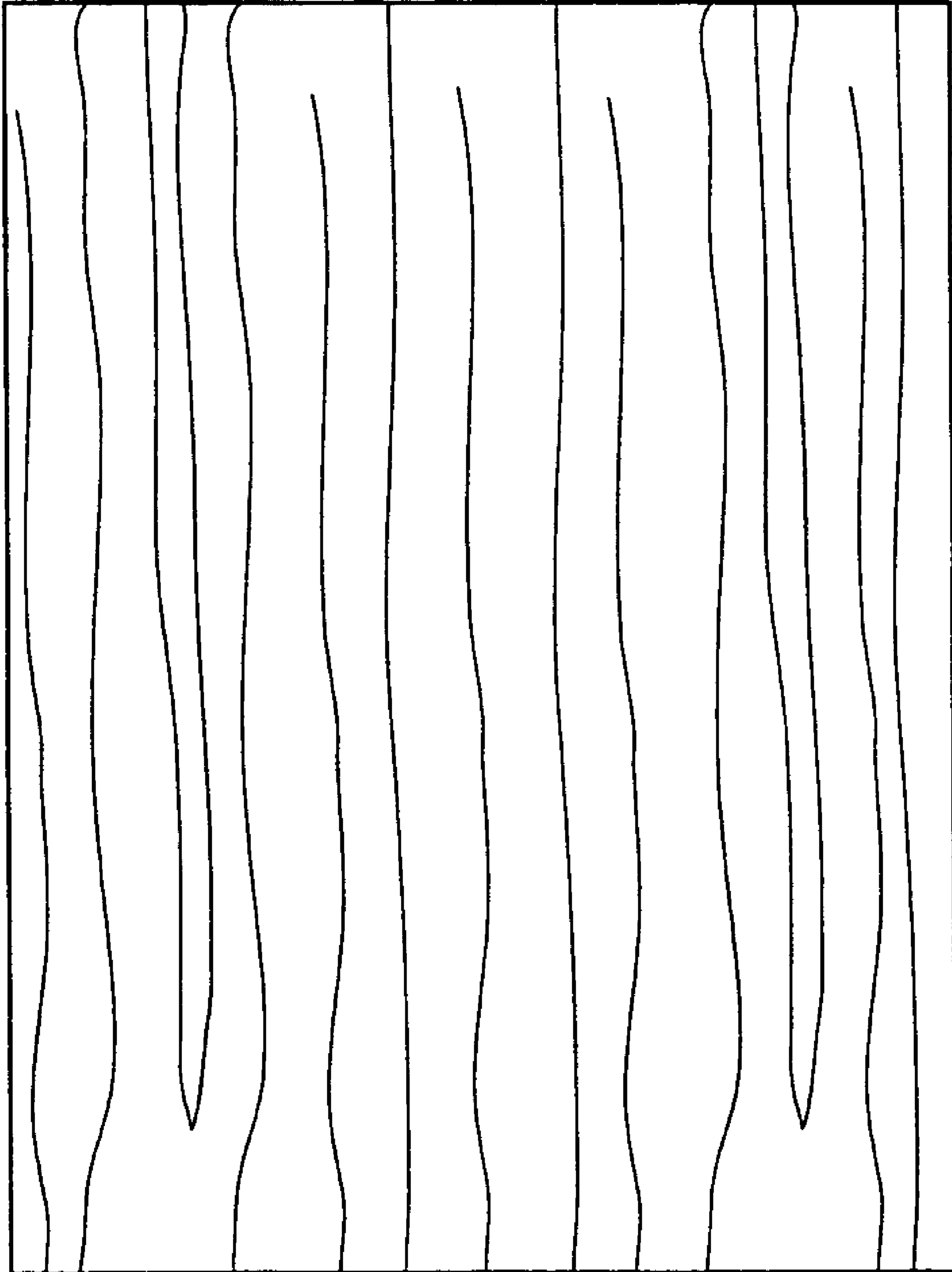

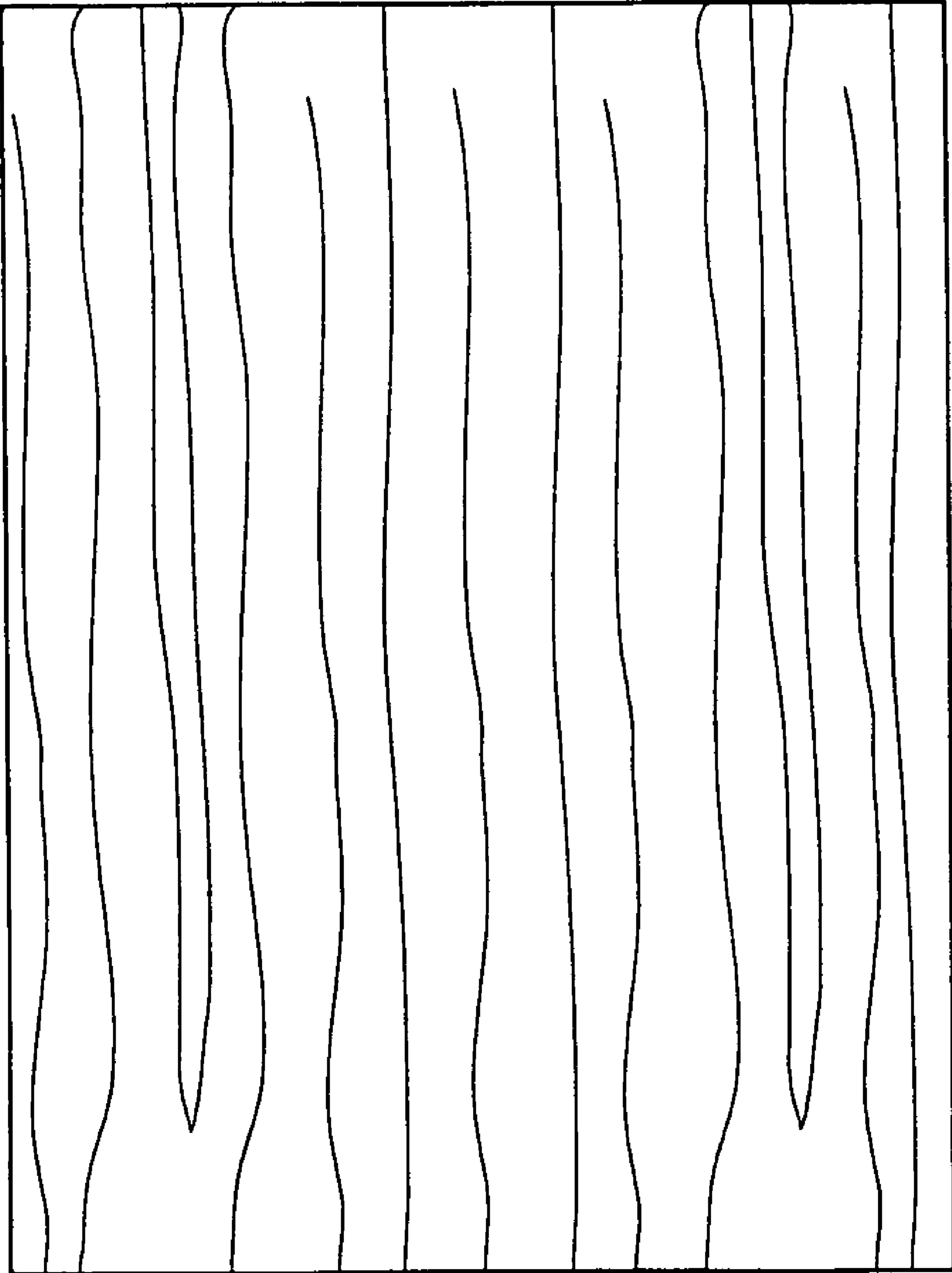

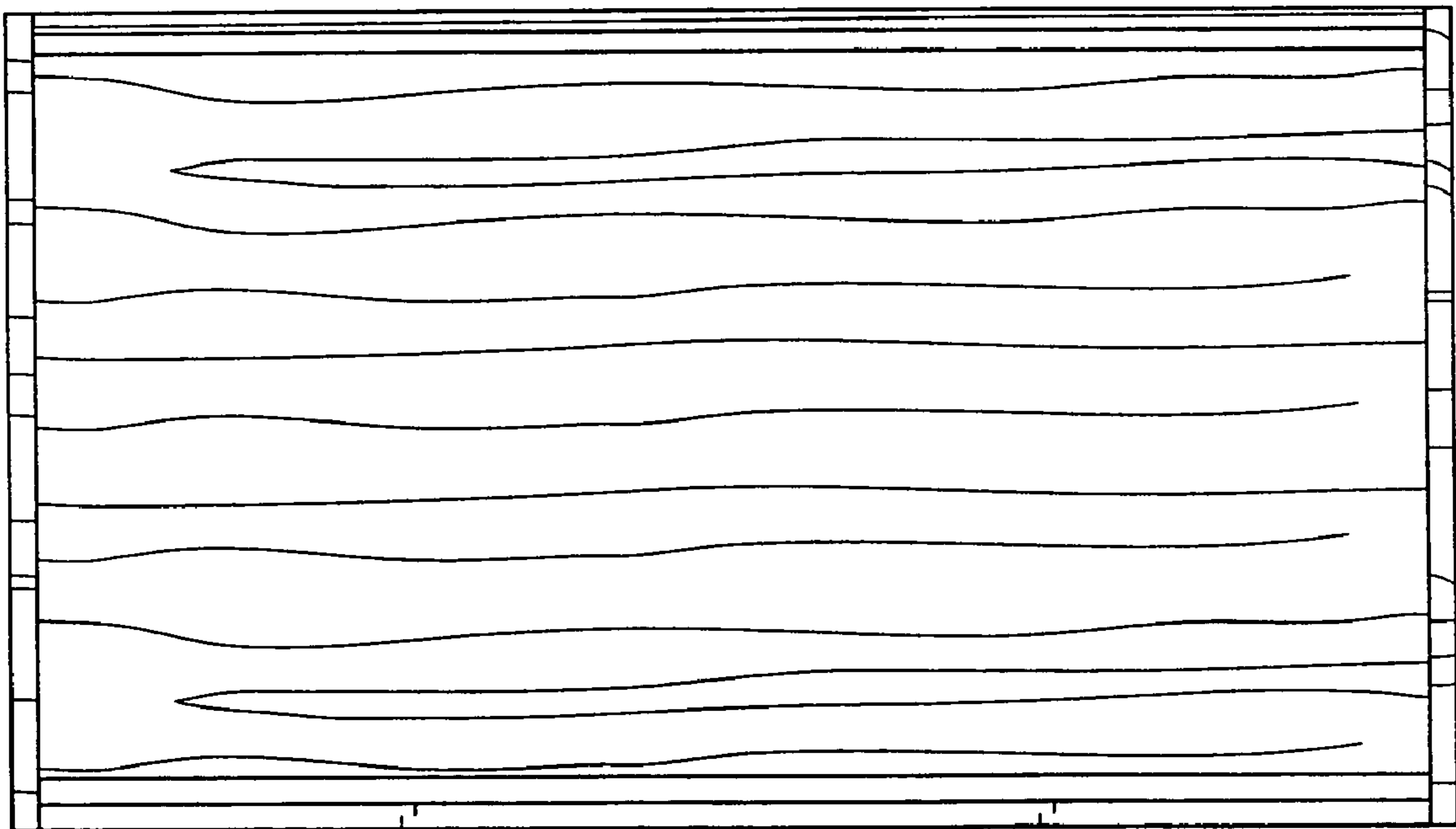

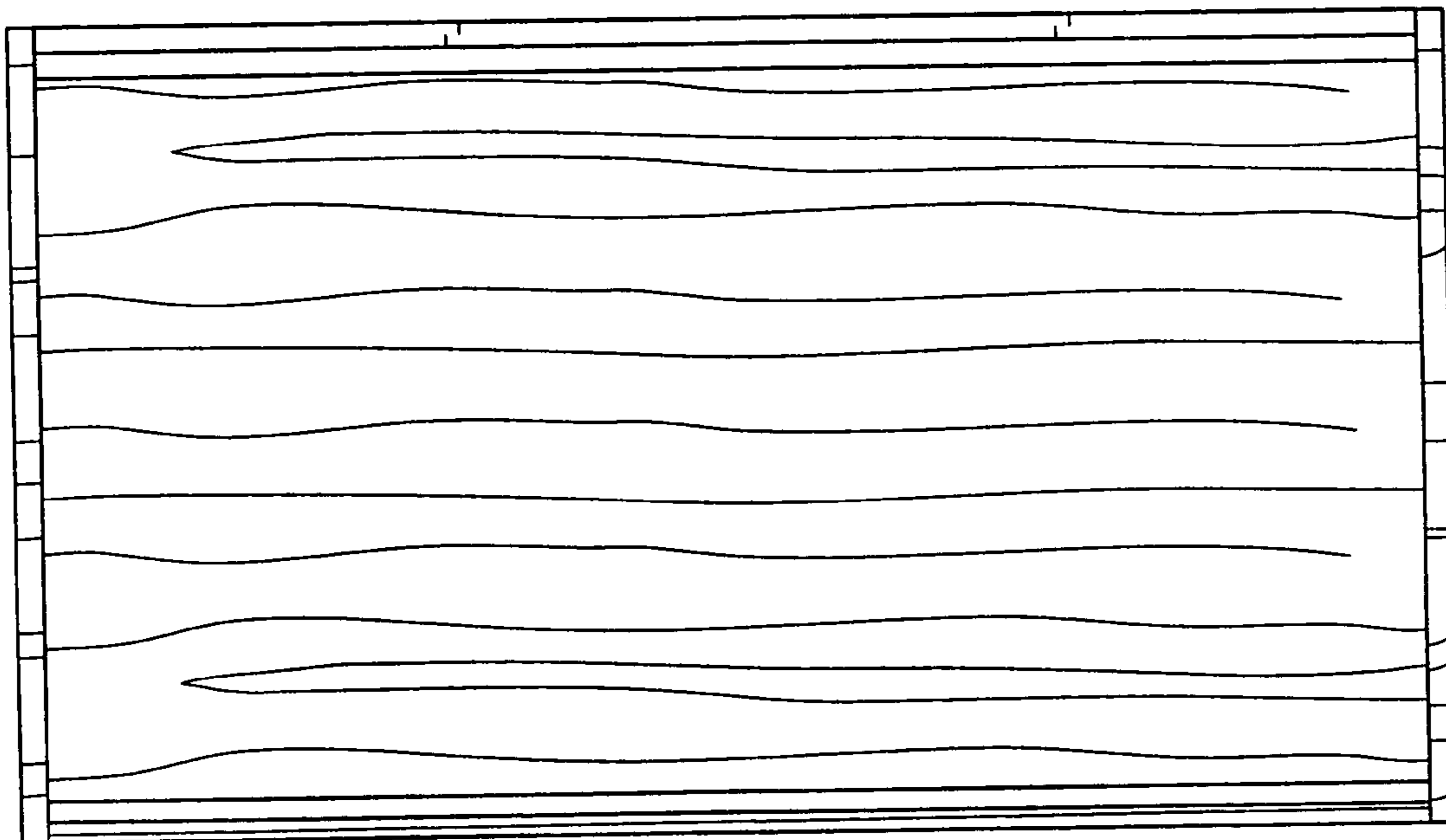
