The ornamental design for a threaded storage container lid, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the threaded storage container lid;

FIG. 2 is front view of the threaded storage container lid;

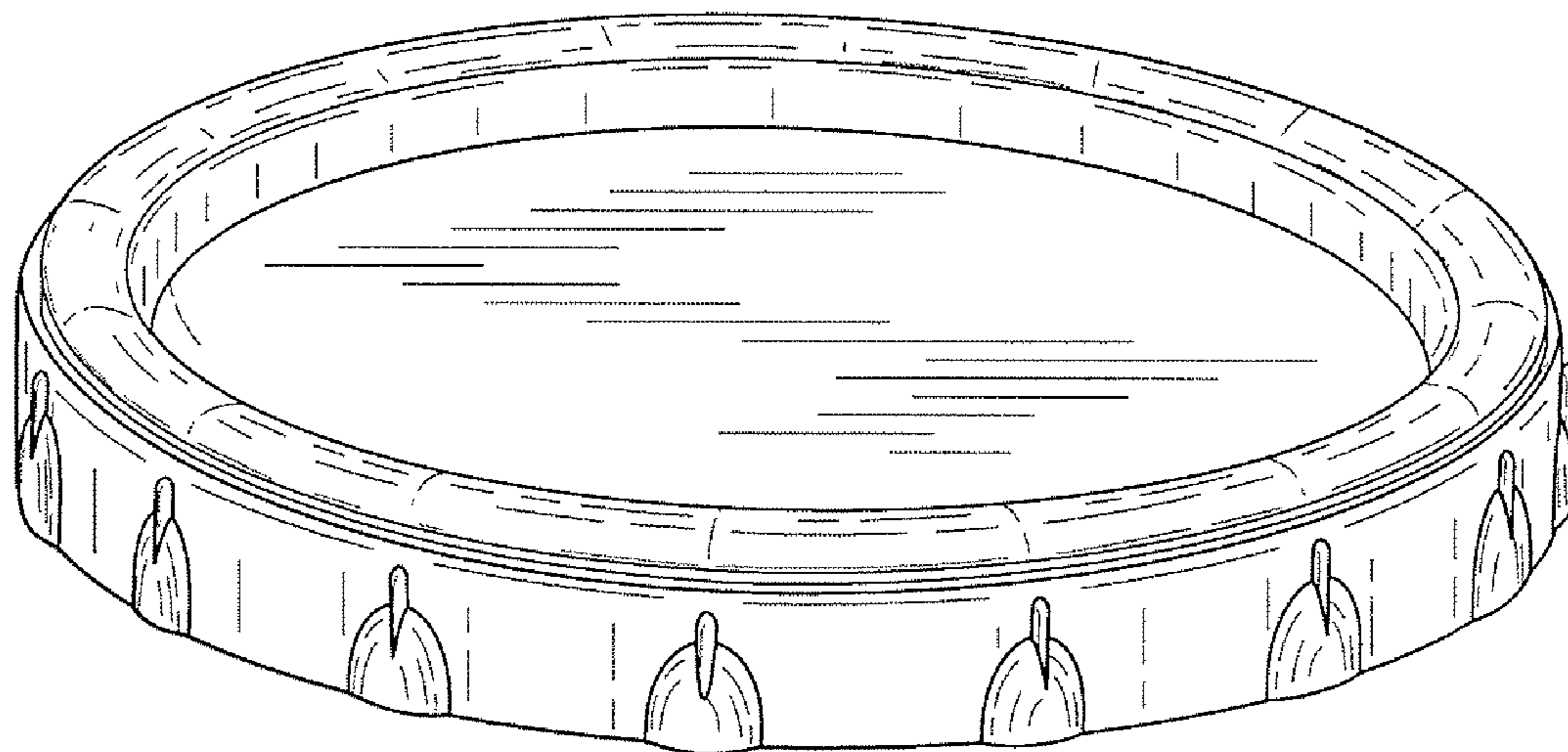
FIG. 3 is a top view of the threaded storage container lid; and,

FIG. 4 is a bottom view of the threaded storage container lid.

The rear of the Container lid and both the right and left sides of the container lid are identical to the front of the container lid depicted in FIG. 2.

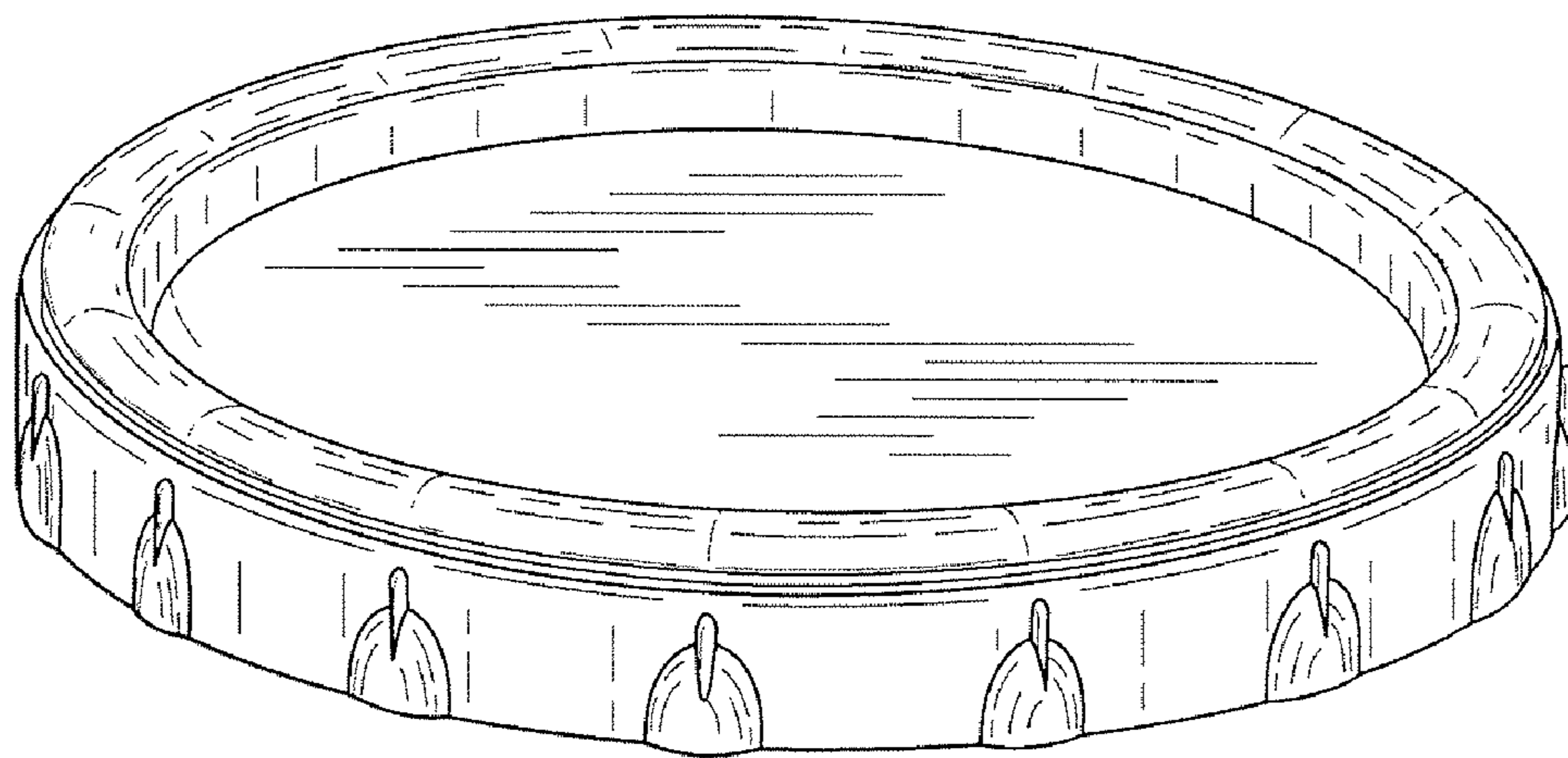

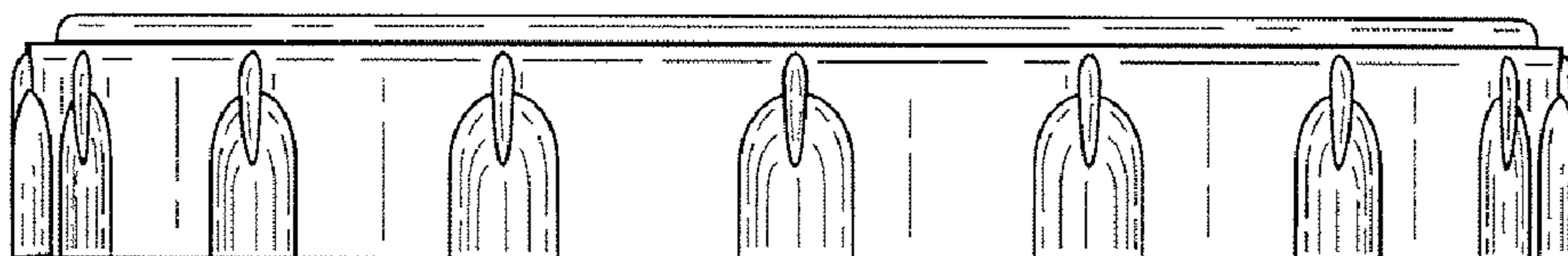

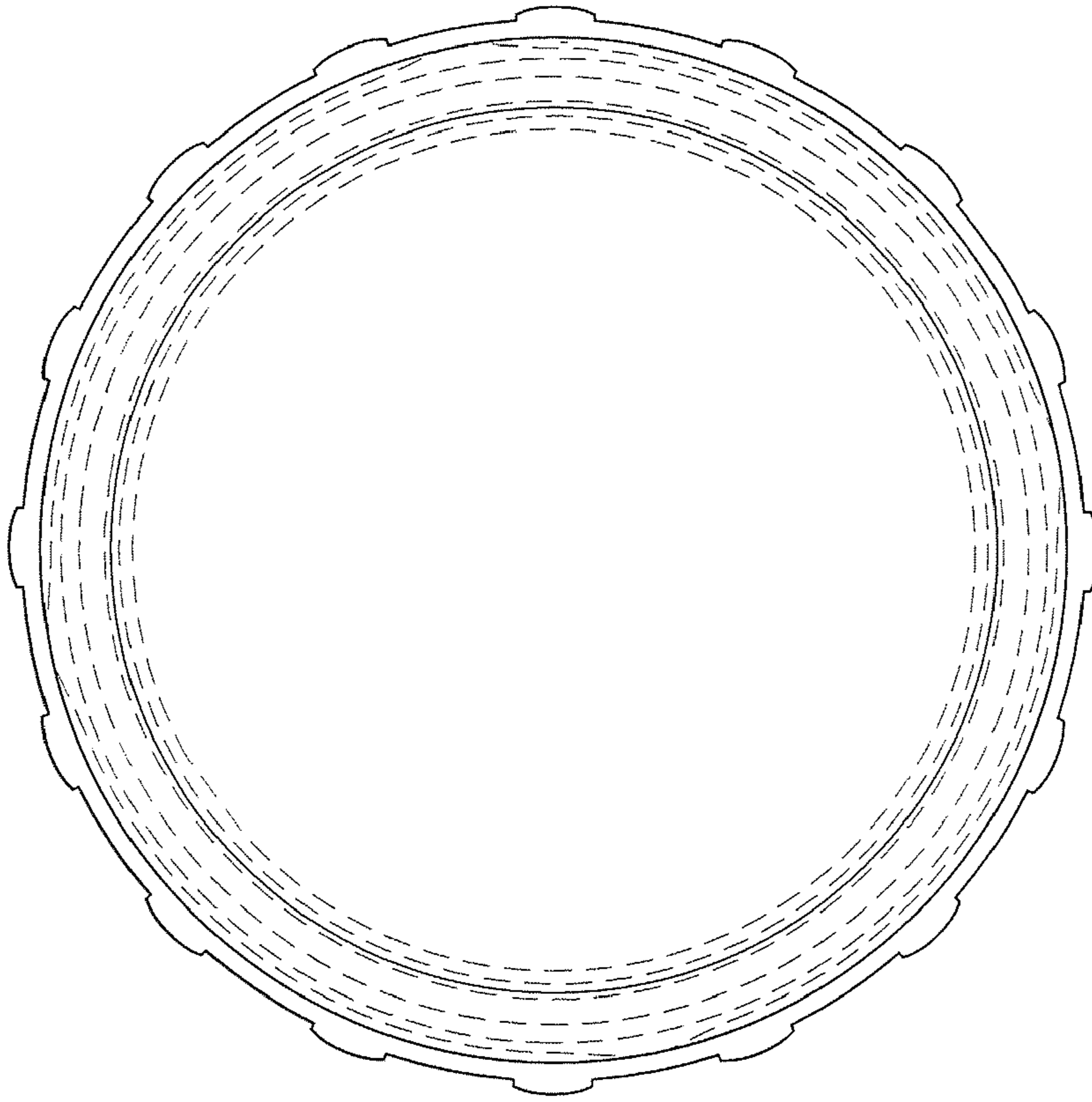

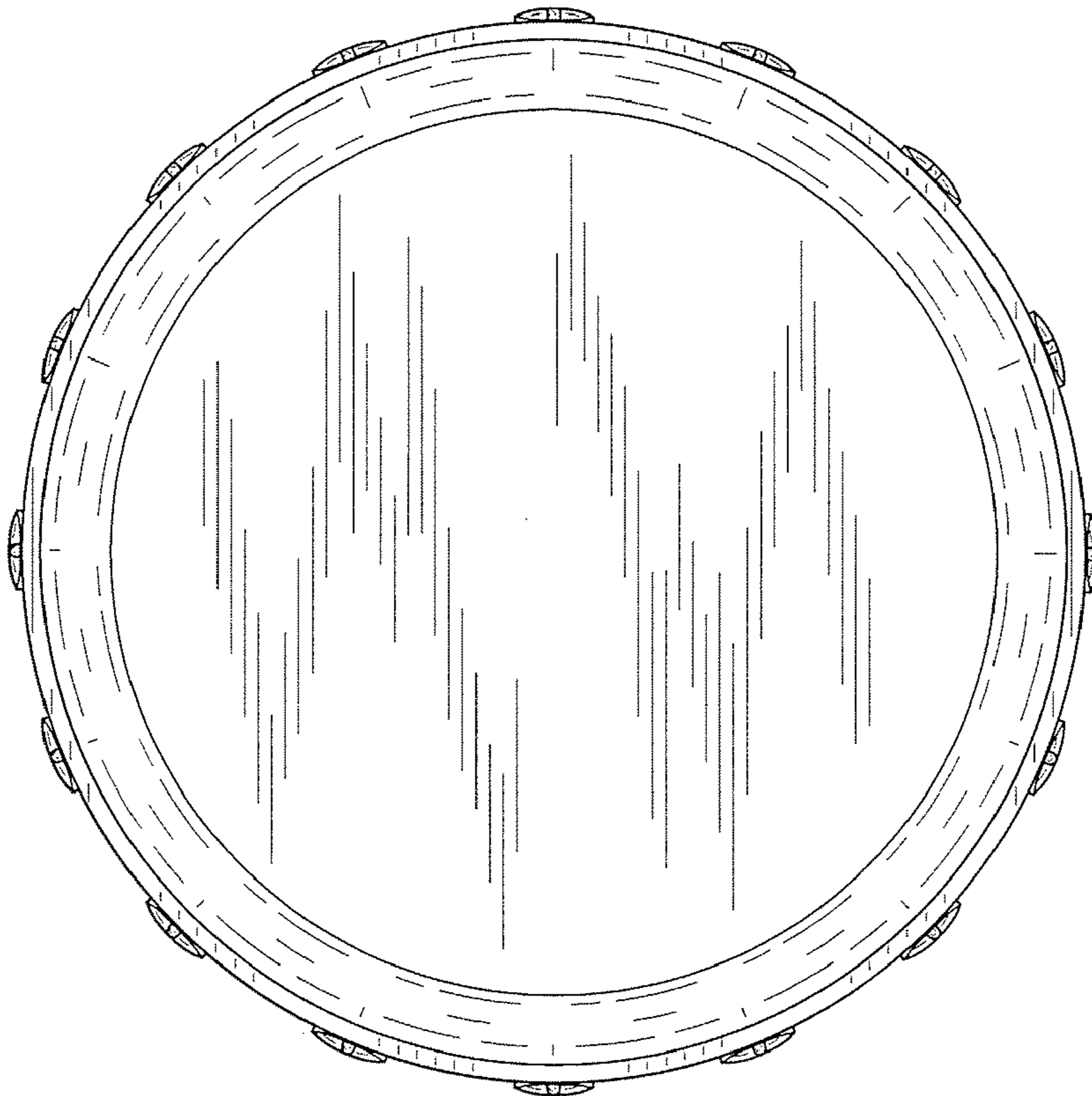
