(57) **CLAIM**

The ornamental design for a handle for utensil, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the handle for utensil of my design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a bottom view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a left side view thereof;

FIG. 7 is a top perspective view thereof;

FIG. 8 is a top perspective view of the handle of FIG. 1 in an environment showing a peeler;

FIG. 9 is a top perspective view of the handle of FIG. 1 in an environment showing a bottle opener;

FIG. 10 is a top perspective view of the handle of FIG. 1 in an environment showing a lemon scraper;

FIG. 11 is a top perspective view of the handle of FIG. 1 in an environment showing a spoon; and,

FIG. 12 is a top perspective view of the handle of FIG. 1 in an environment showing a core remover.

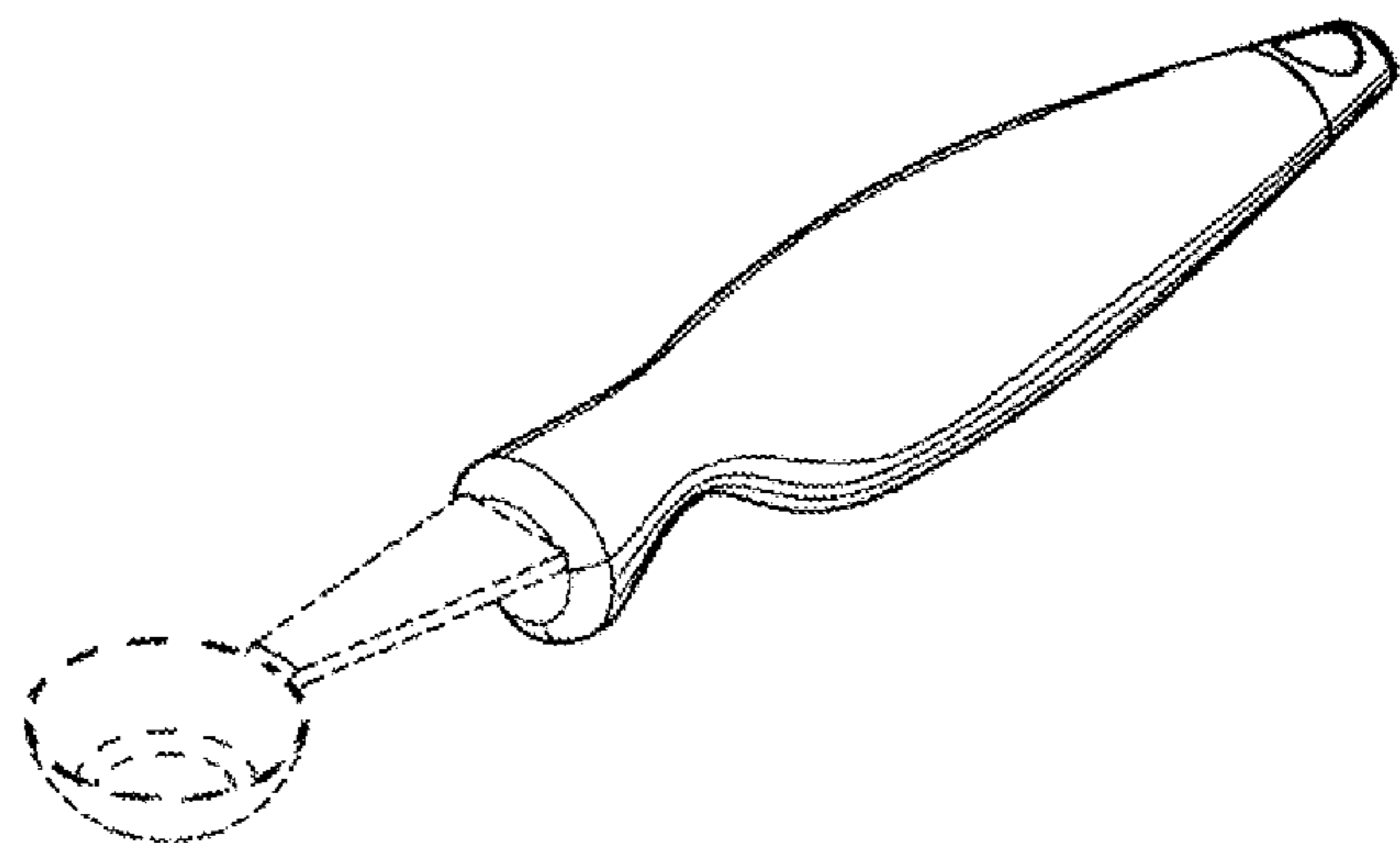
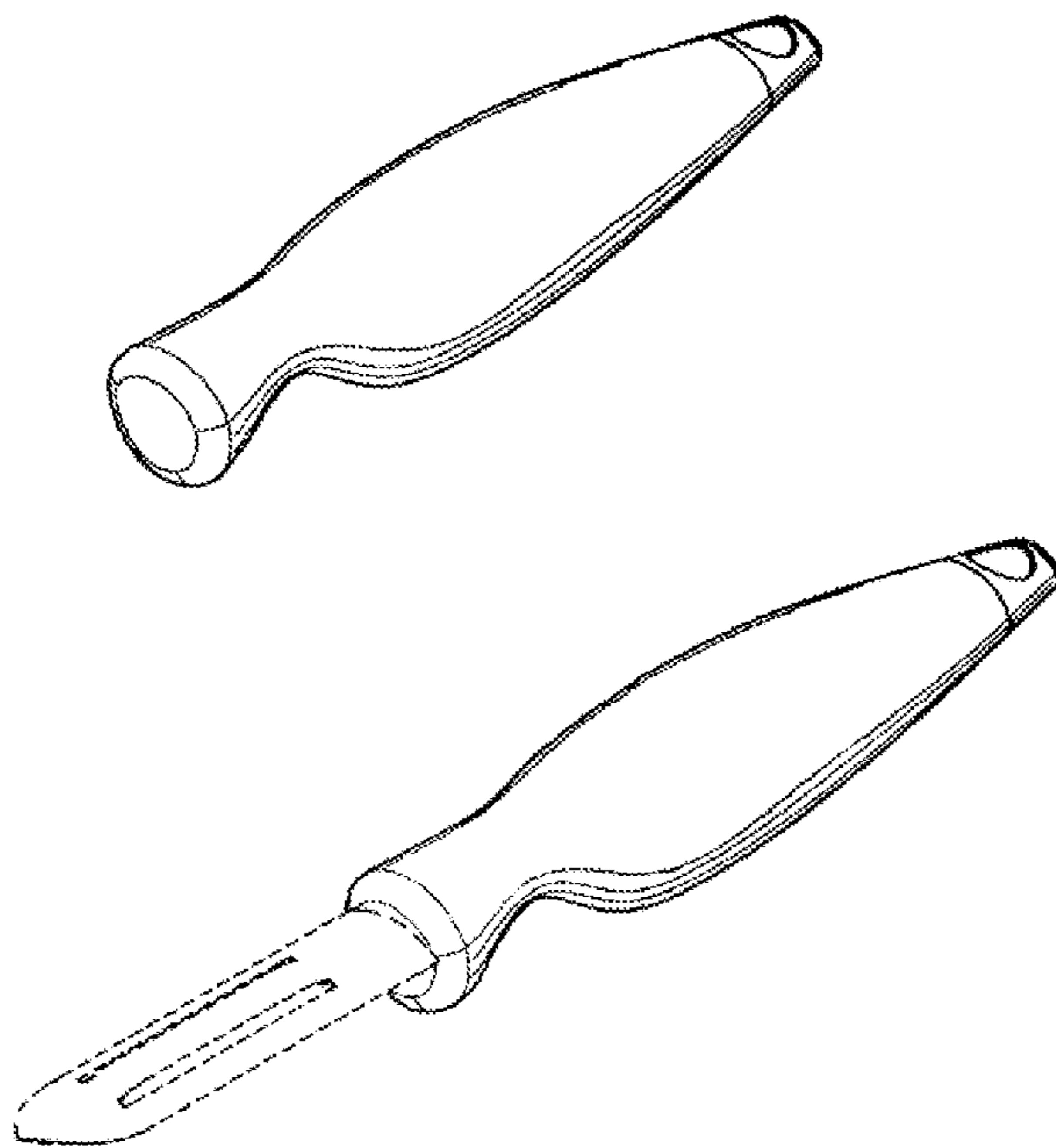

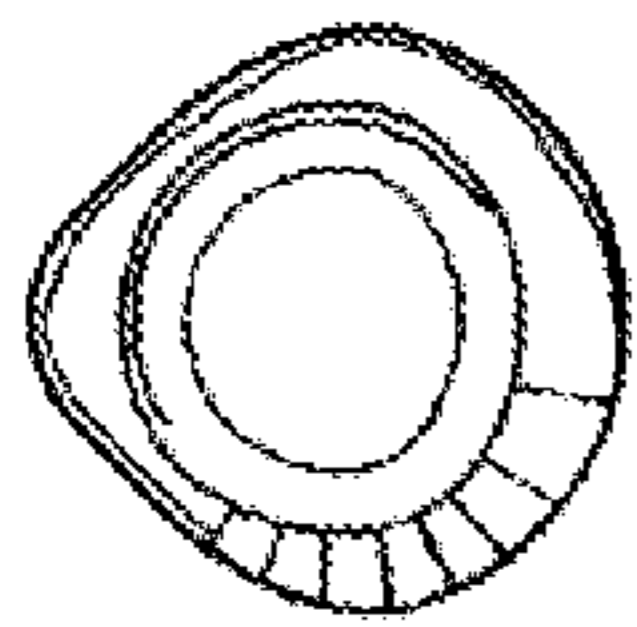

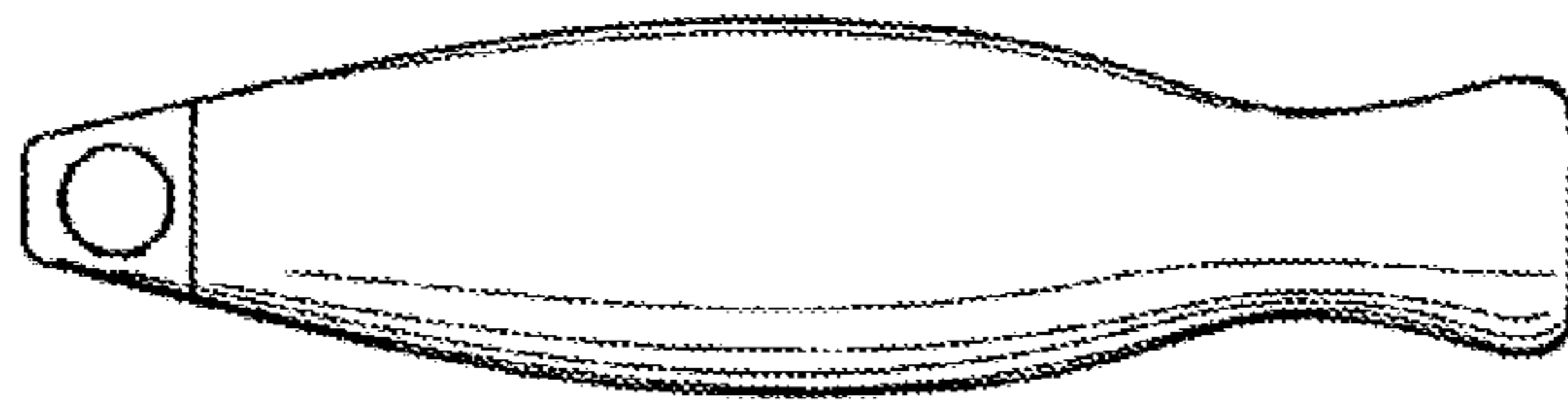

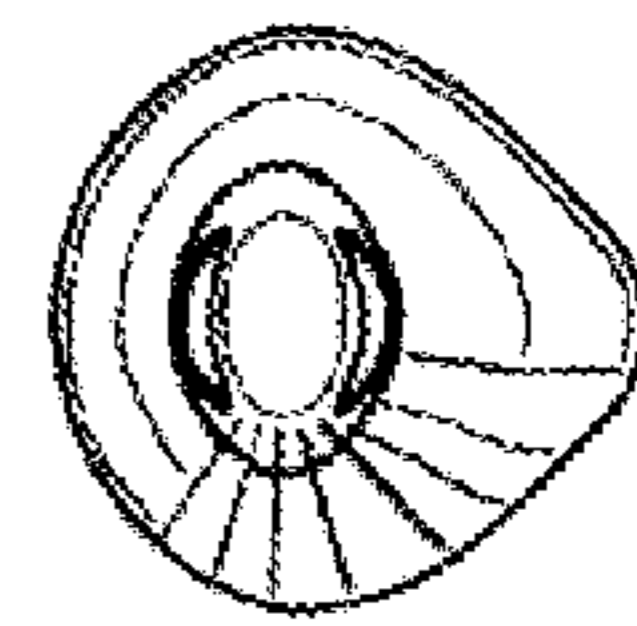

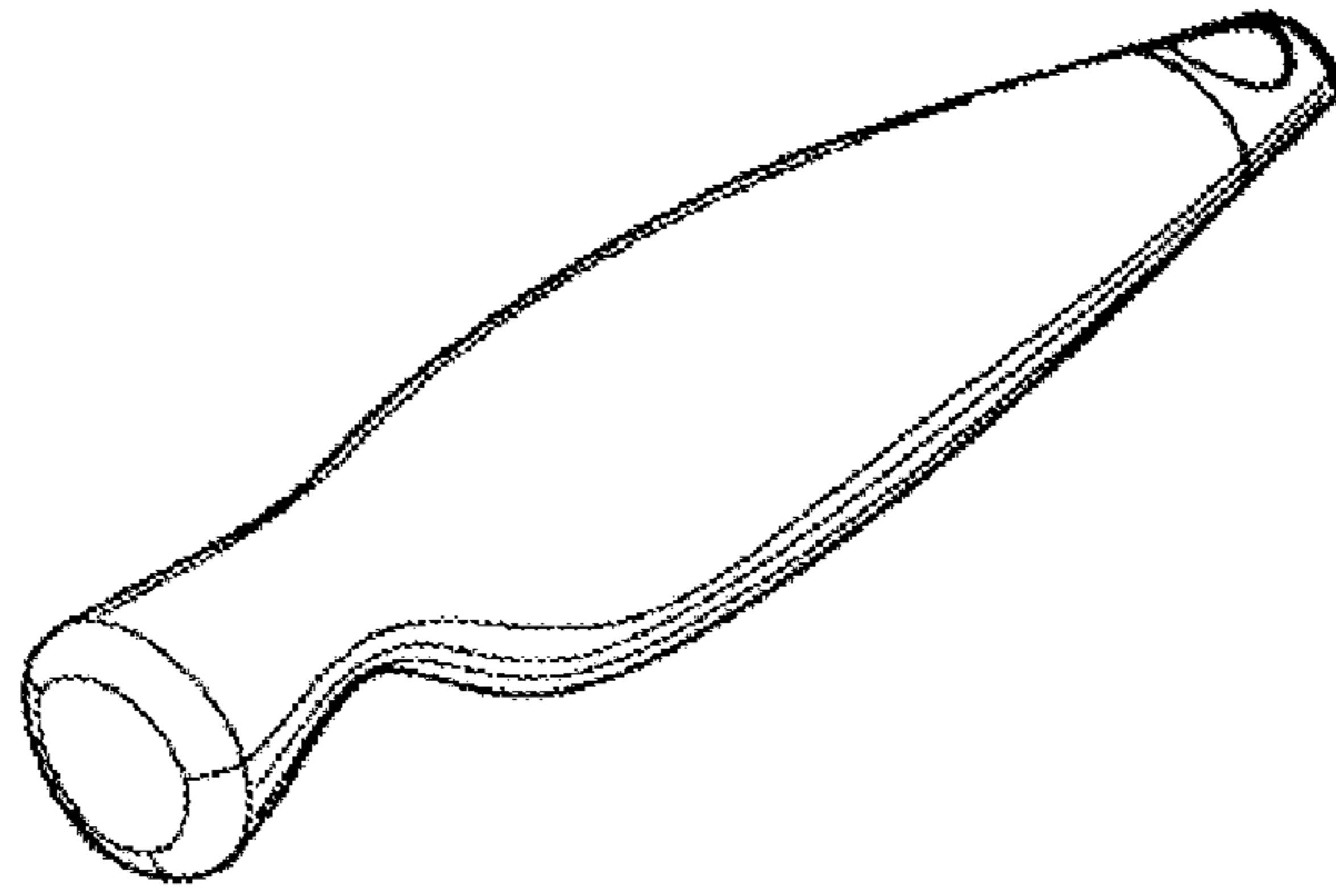

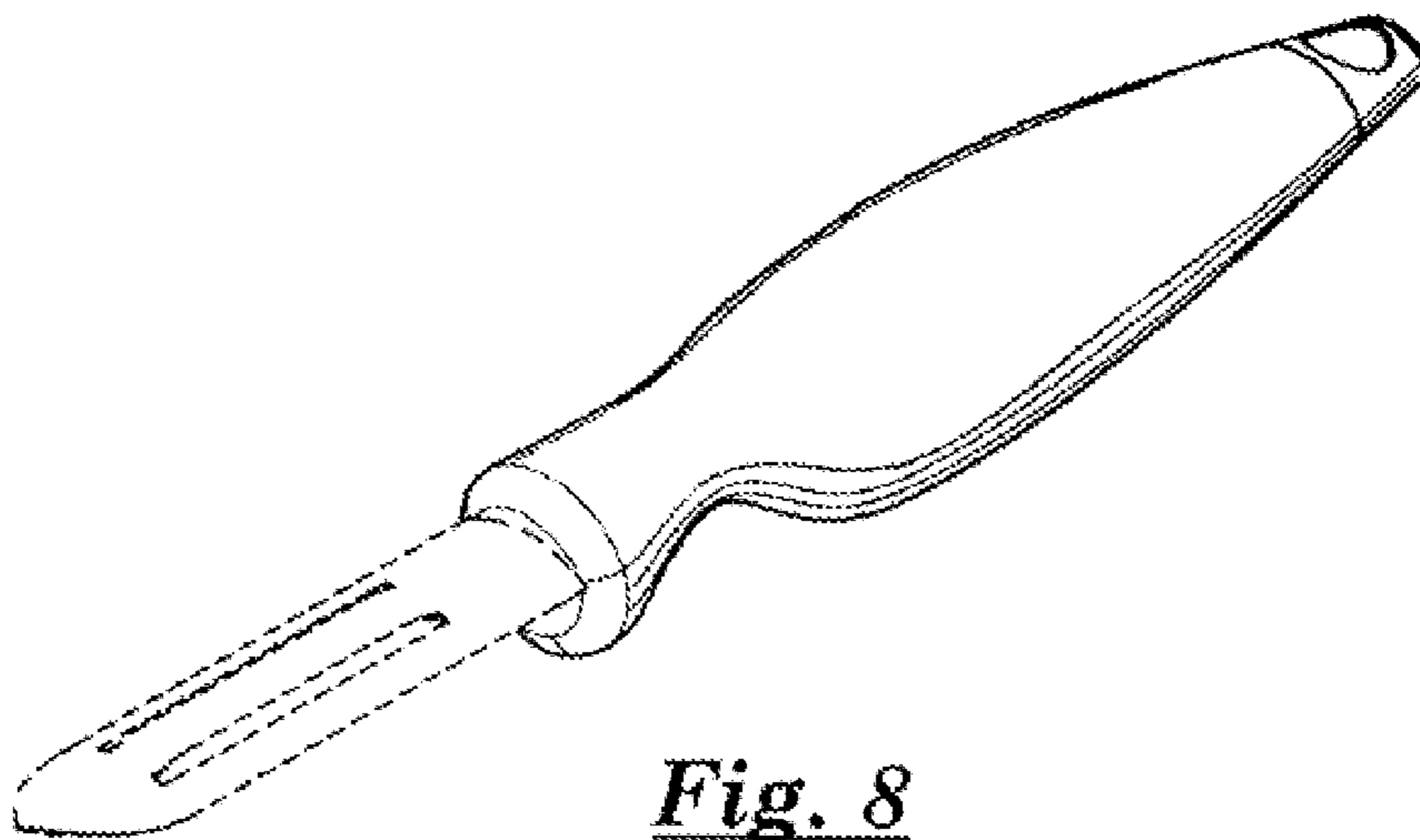

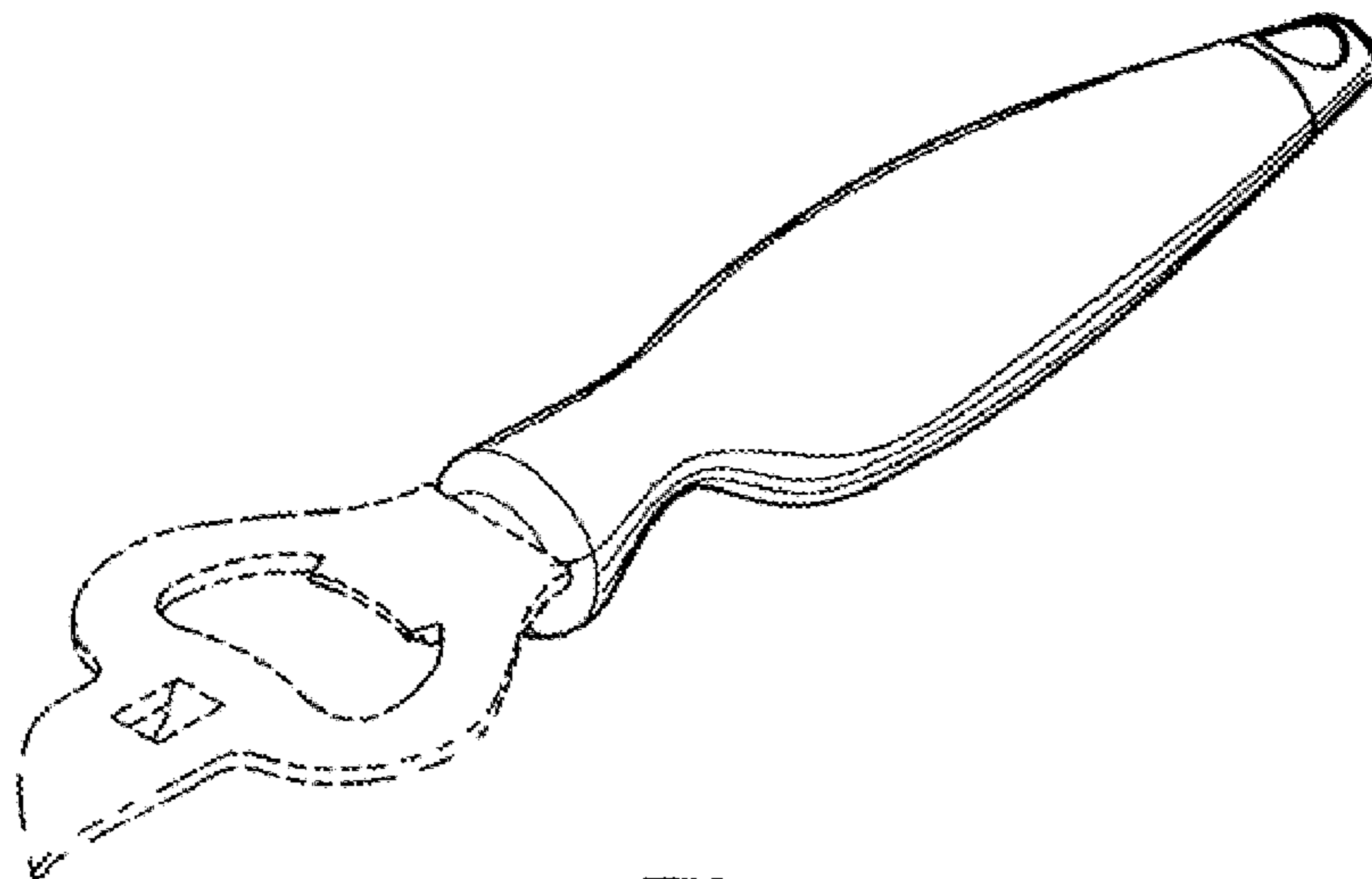

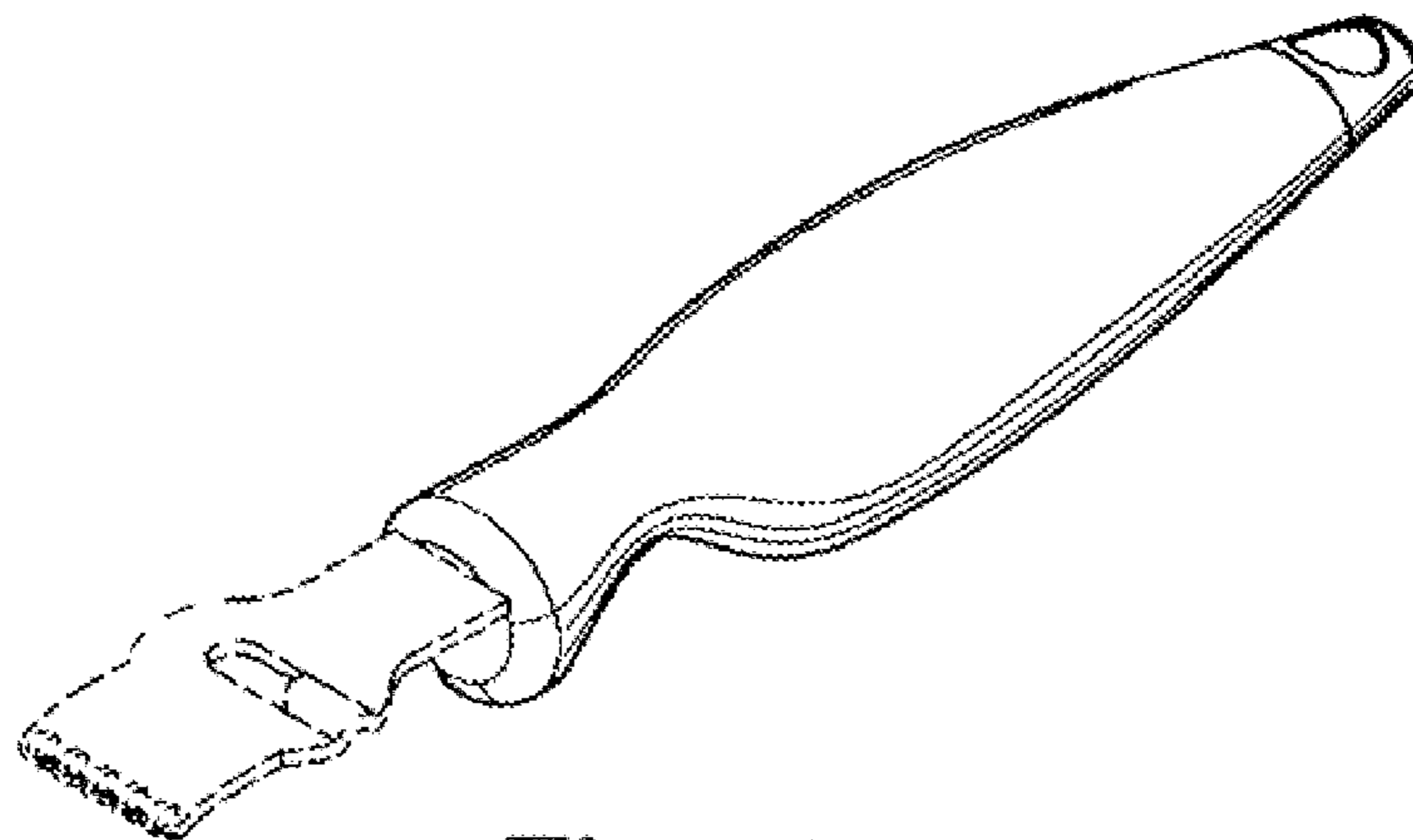

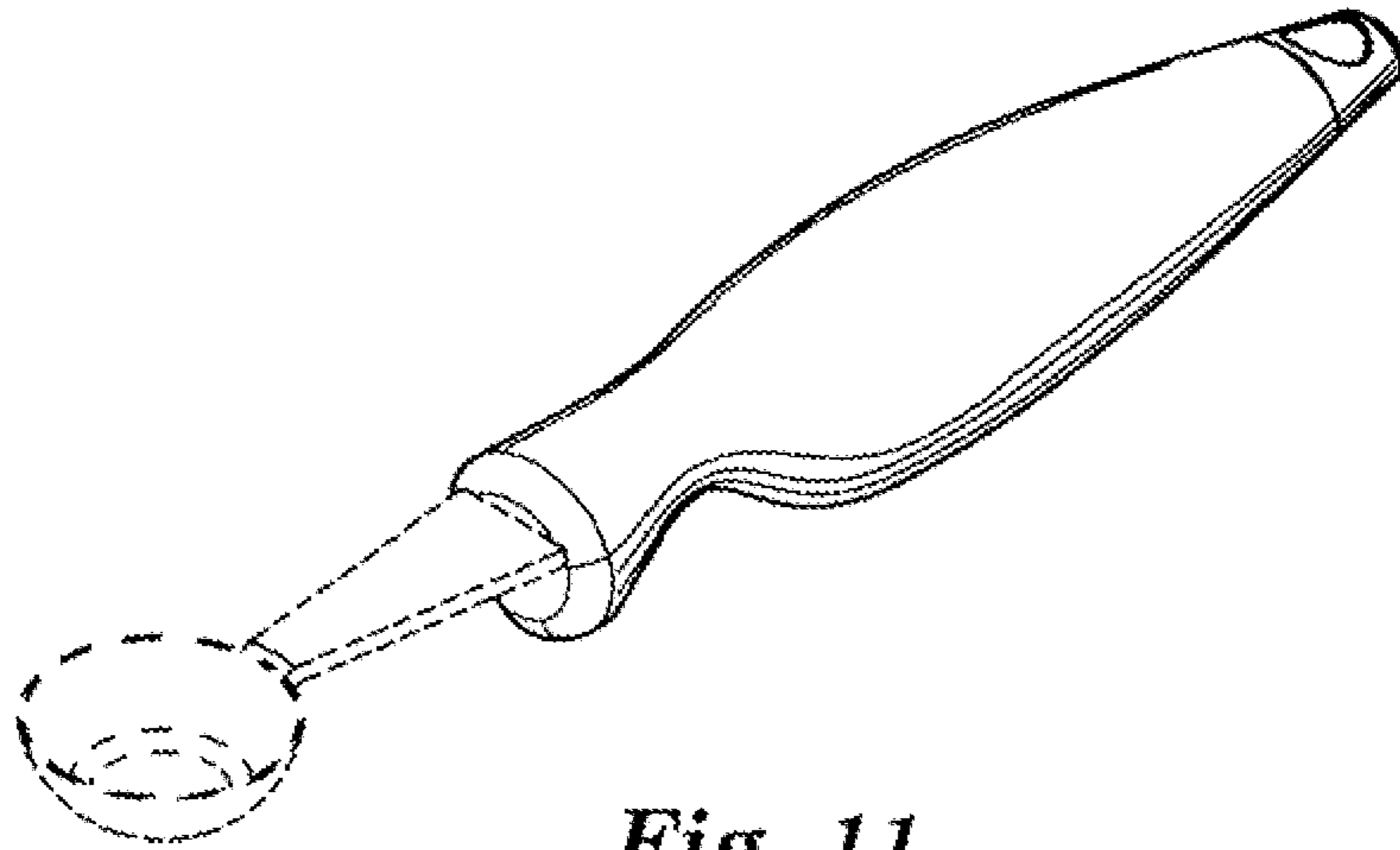

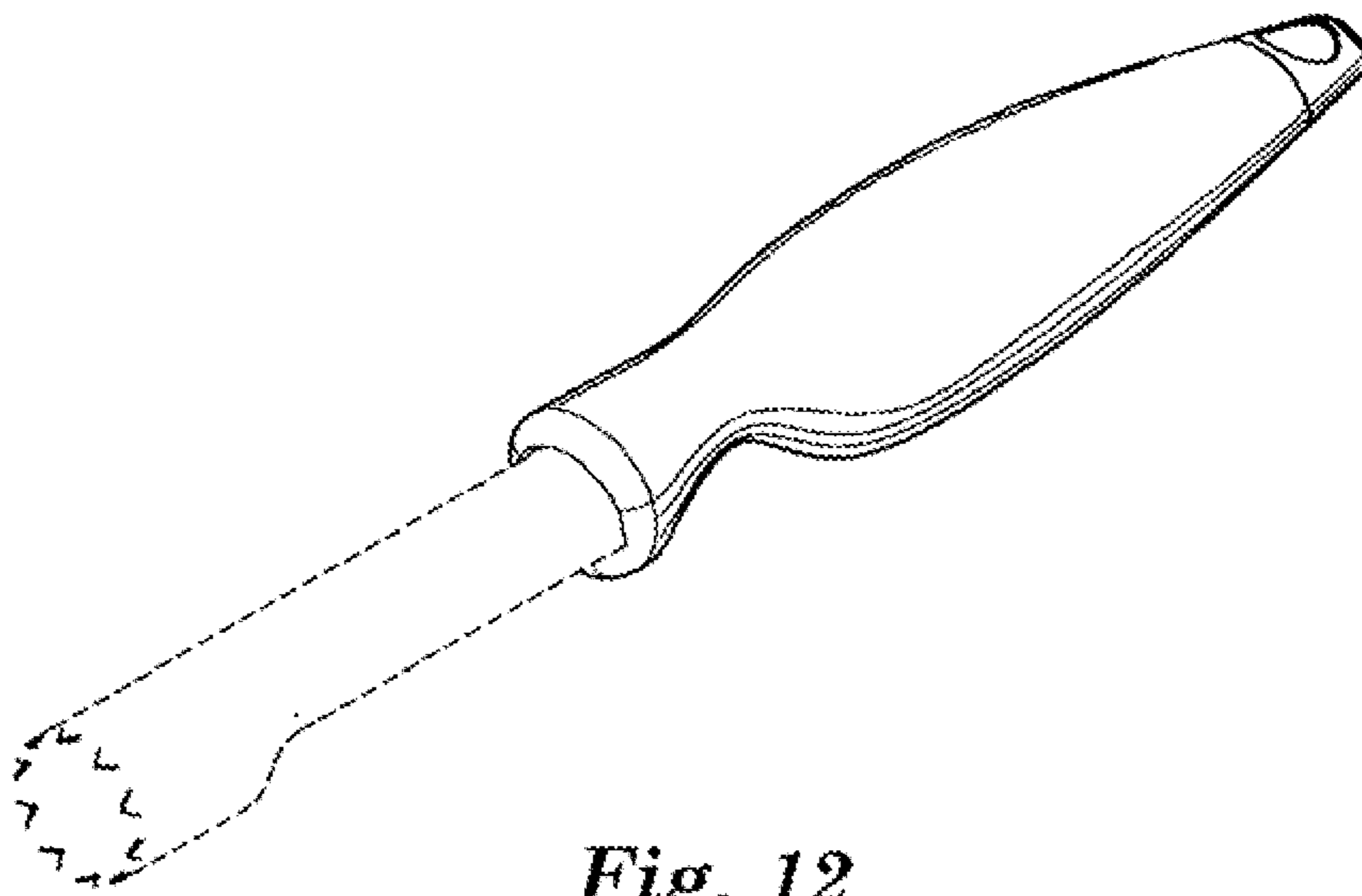
