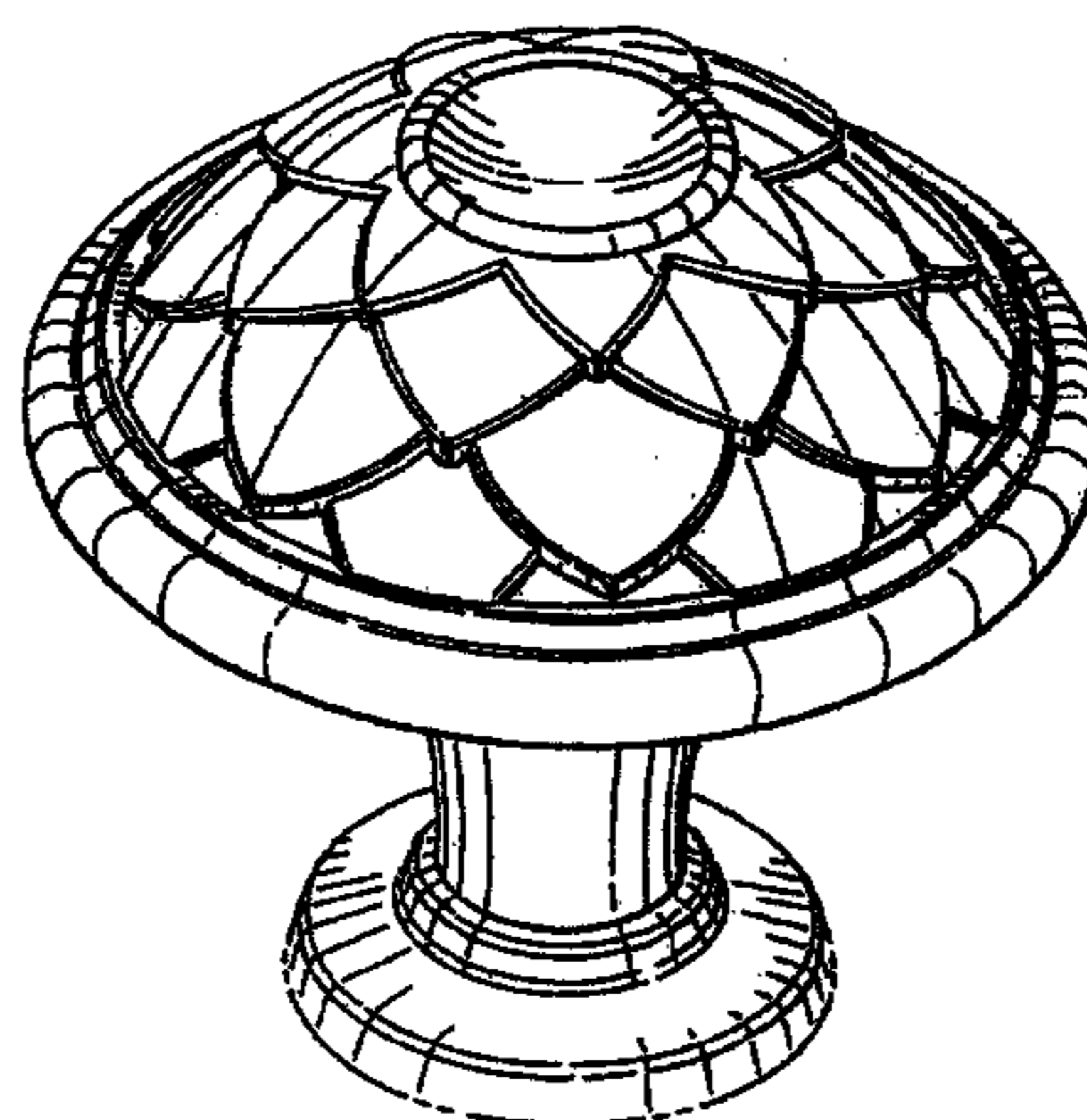
(57) **CLAIM**

We claim the ornamental design for a knob, as shown and described.

DESCRIPTION

FIG. 1 is an elevated perspective view of the knob of the present claimed invention;
FIG. 2 is a top view of the knob of FIG. 1;
FIG. 3 is a bottom view of the knob of FIG. 1;
FIG. 4 is front view of the knob of FIG. 1;
FIG. 5 is a third side view of the knob of FIG. 1, a third side view being mirror image thereto; and,
FIG. 6 is a rear view of the knob of FIG. 1.
The broken lines are included for the purpose of illustration and form no part of the claimed design.

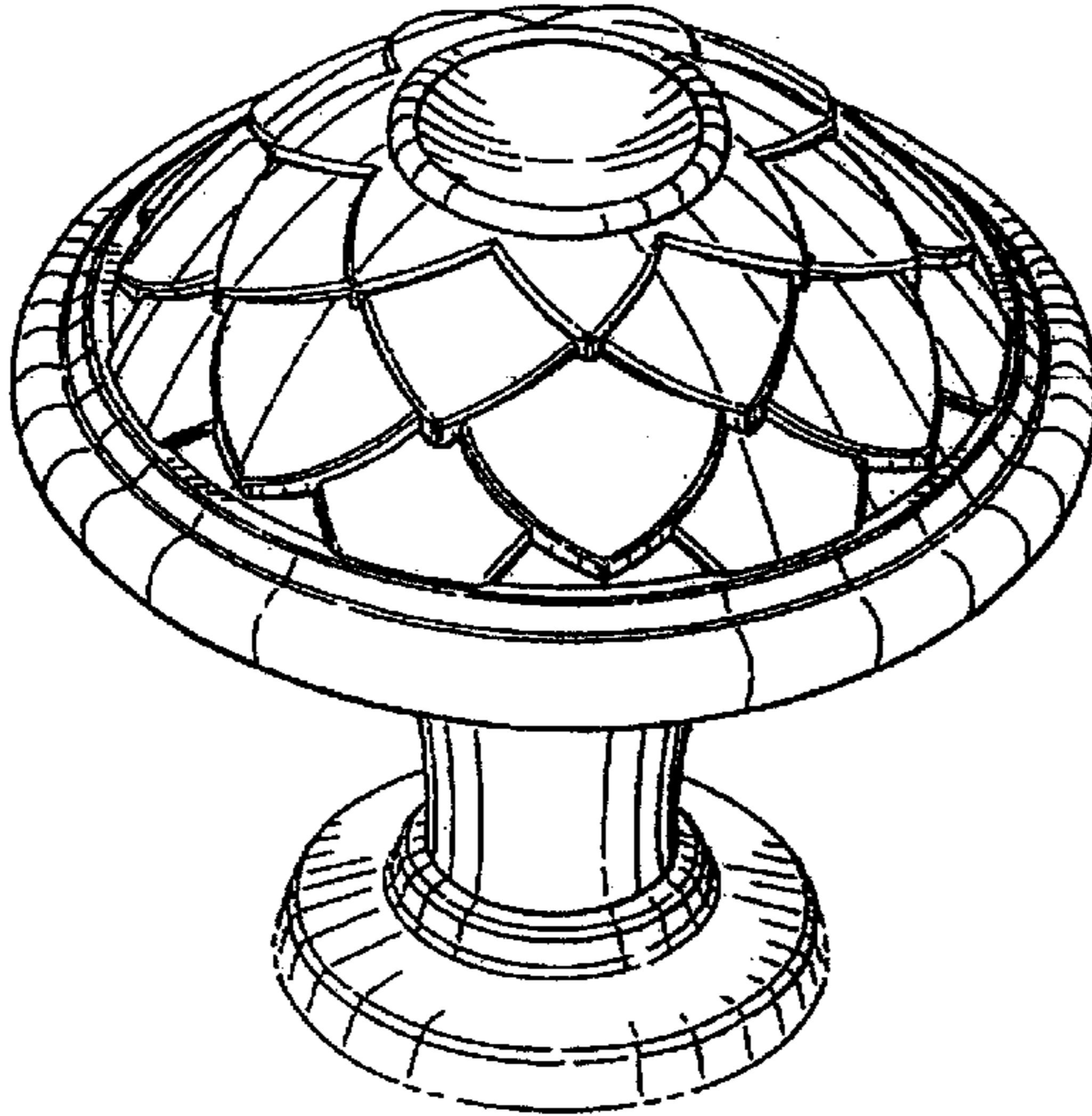

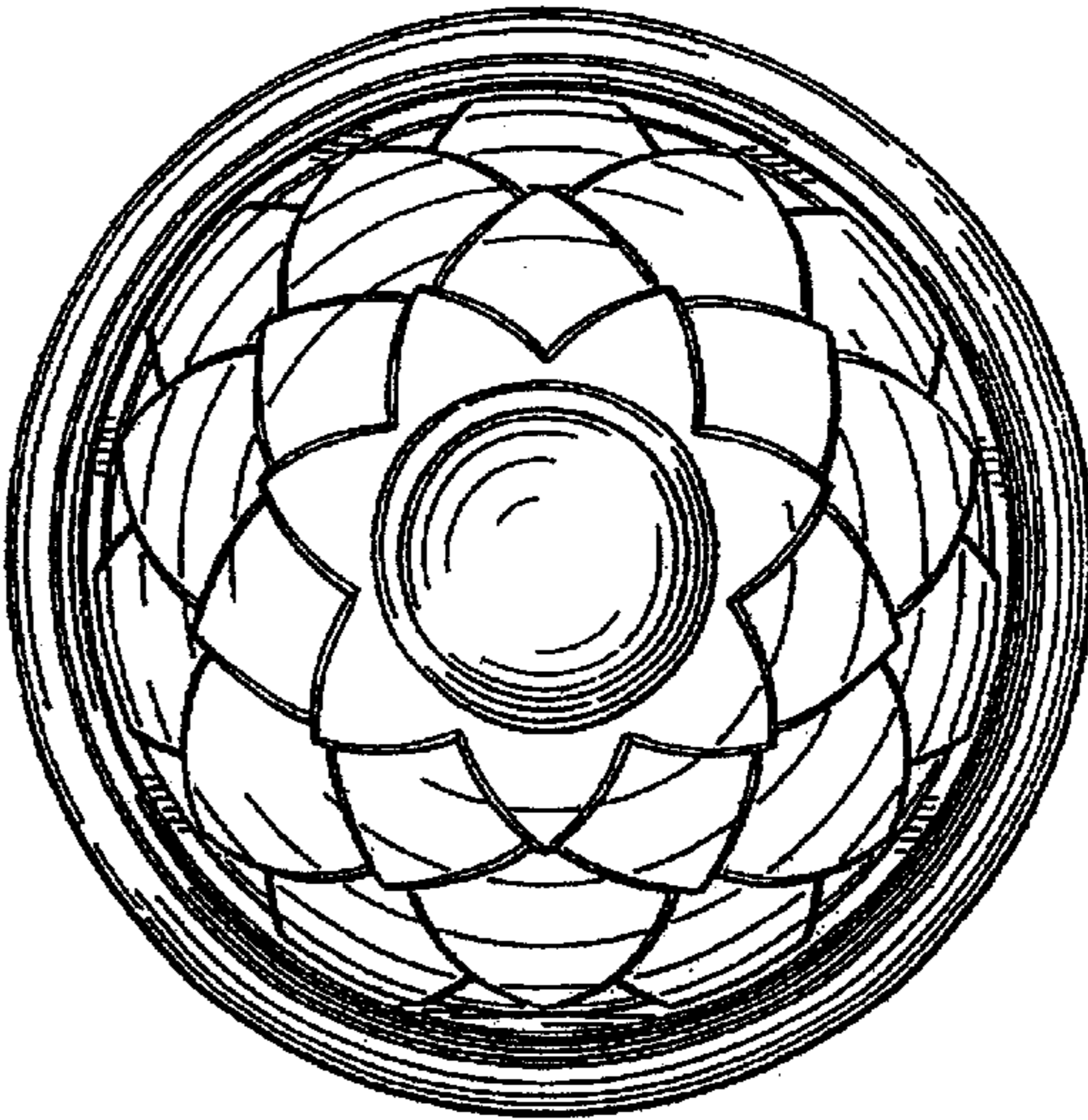

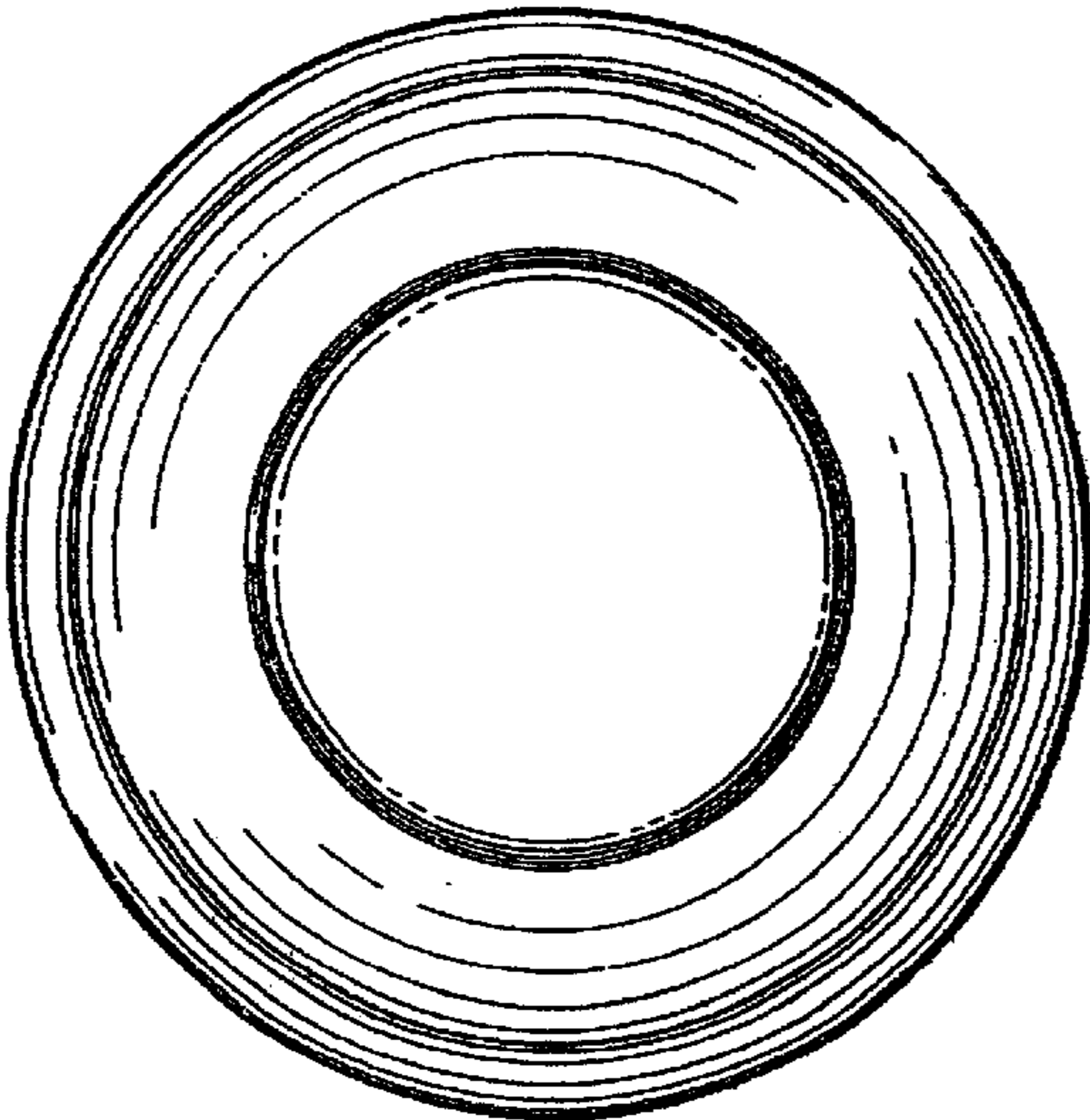

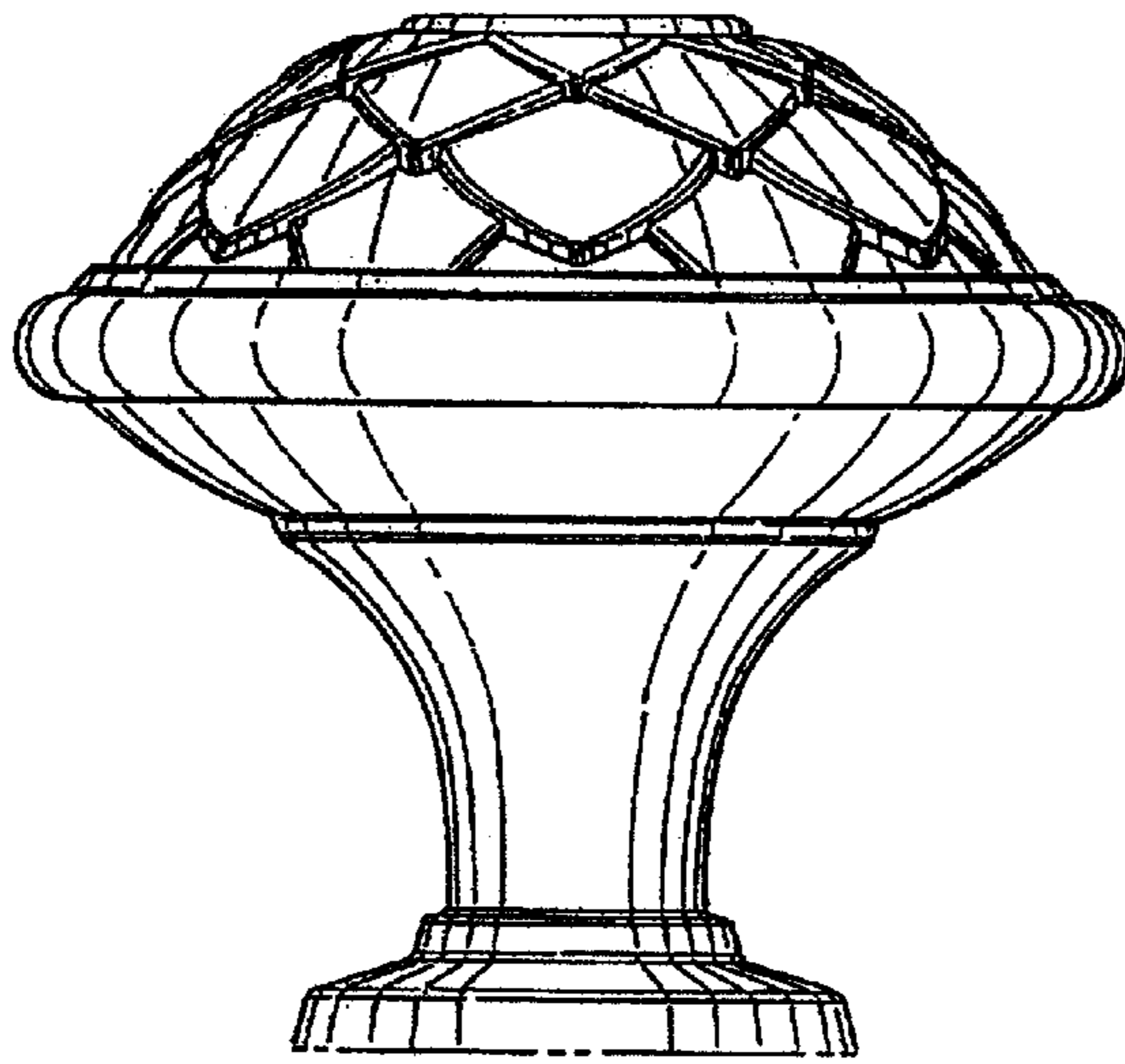

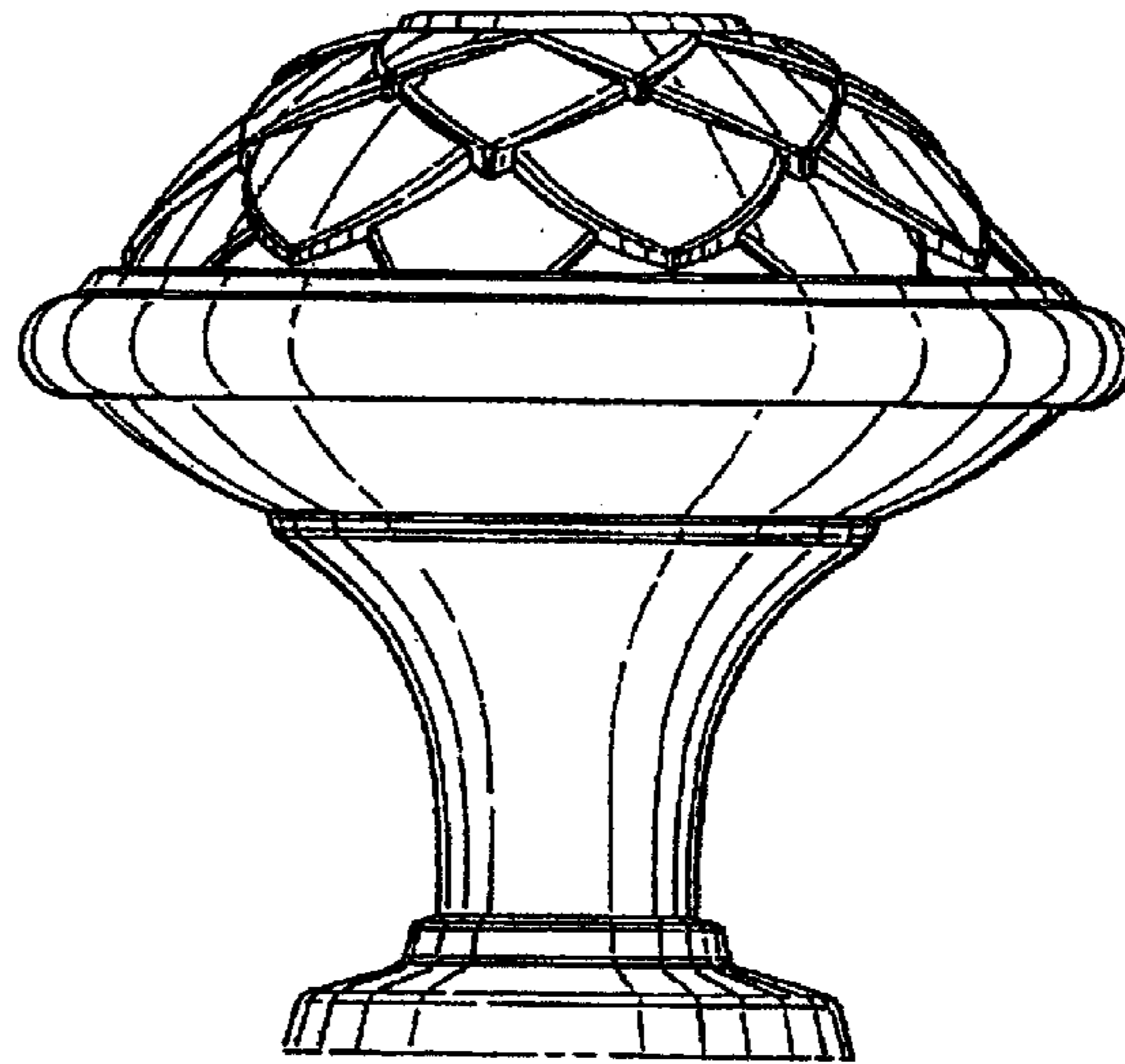

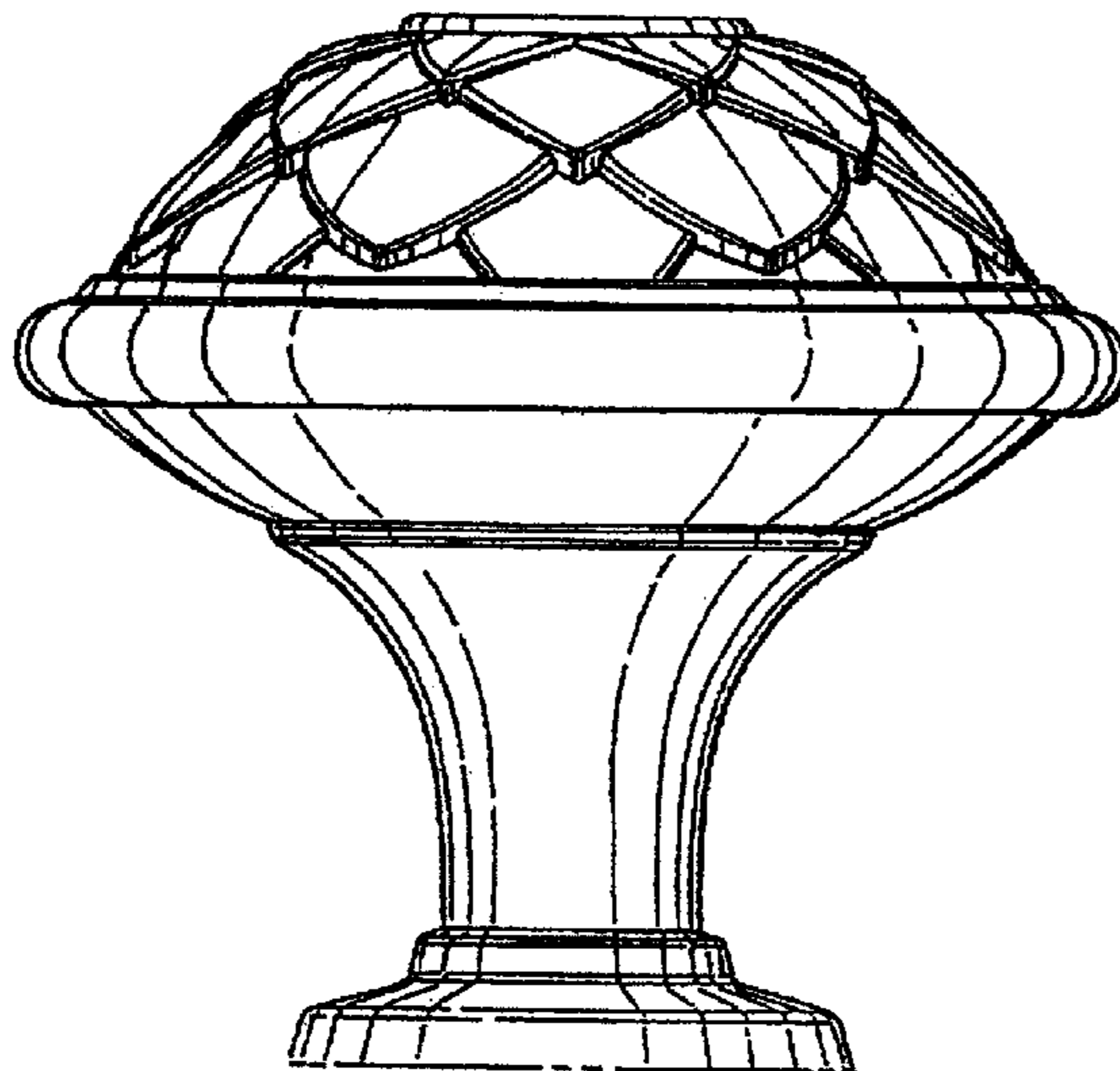
