FIG. 3 is a left side rear elevational view thereof;

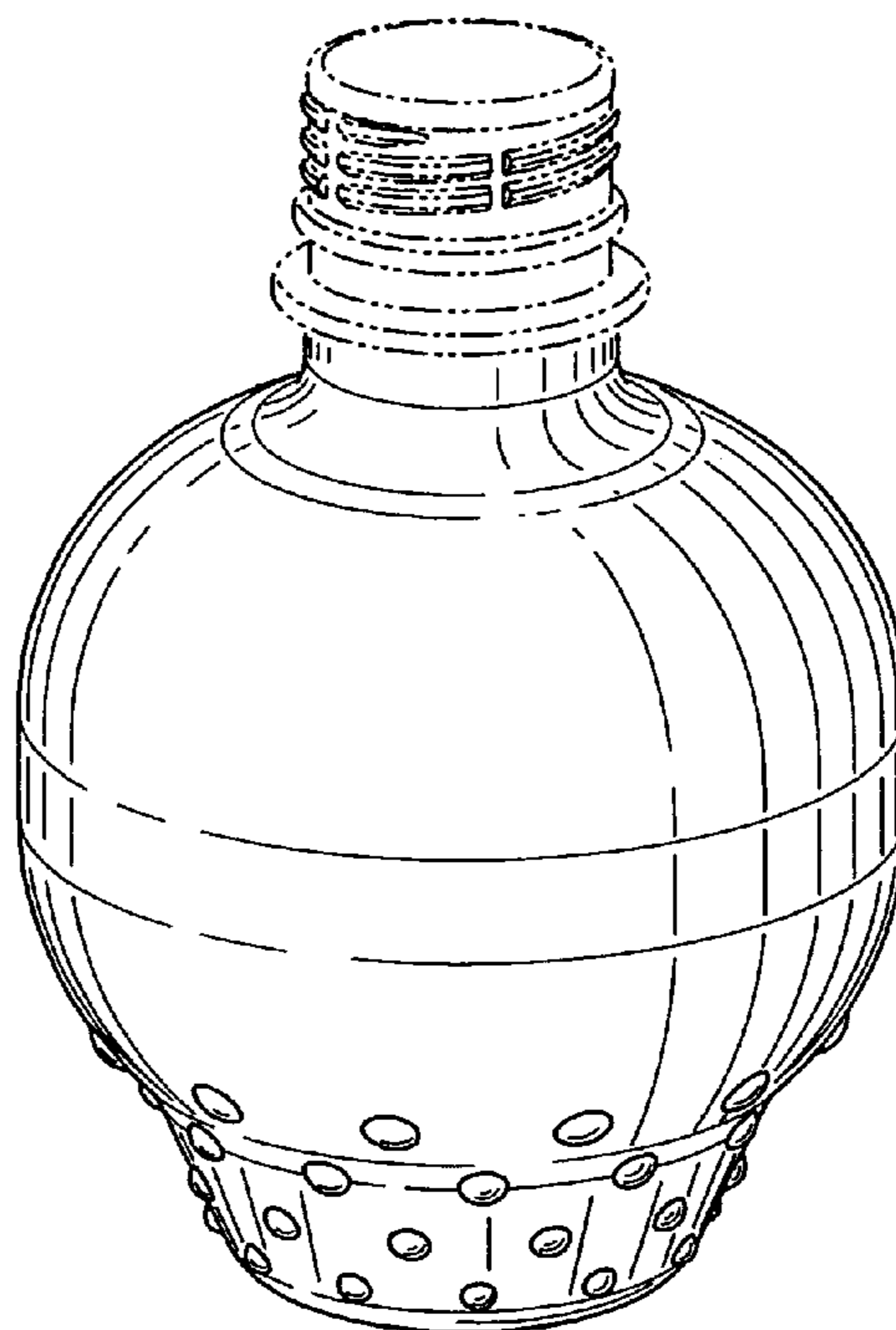
FIG. 4 is a front elevational view thereof;

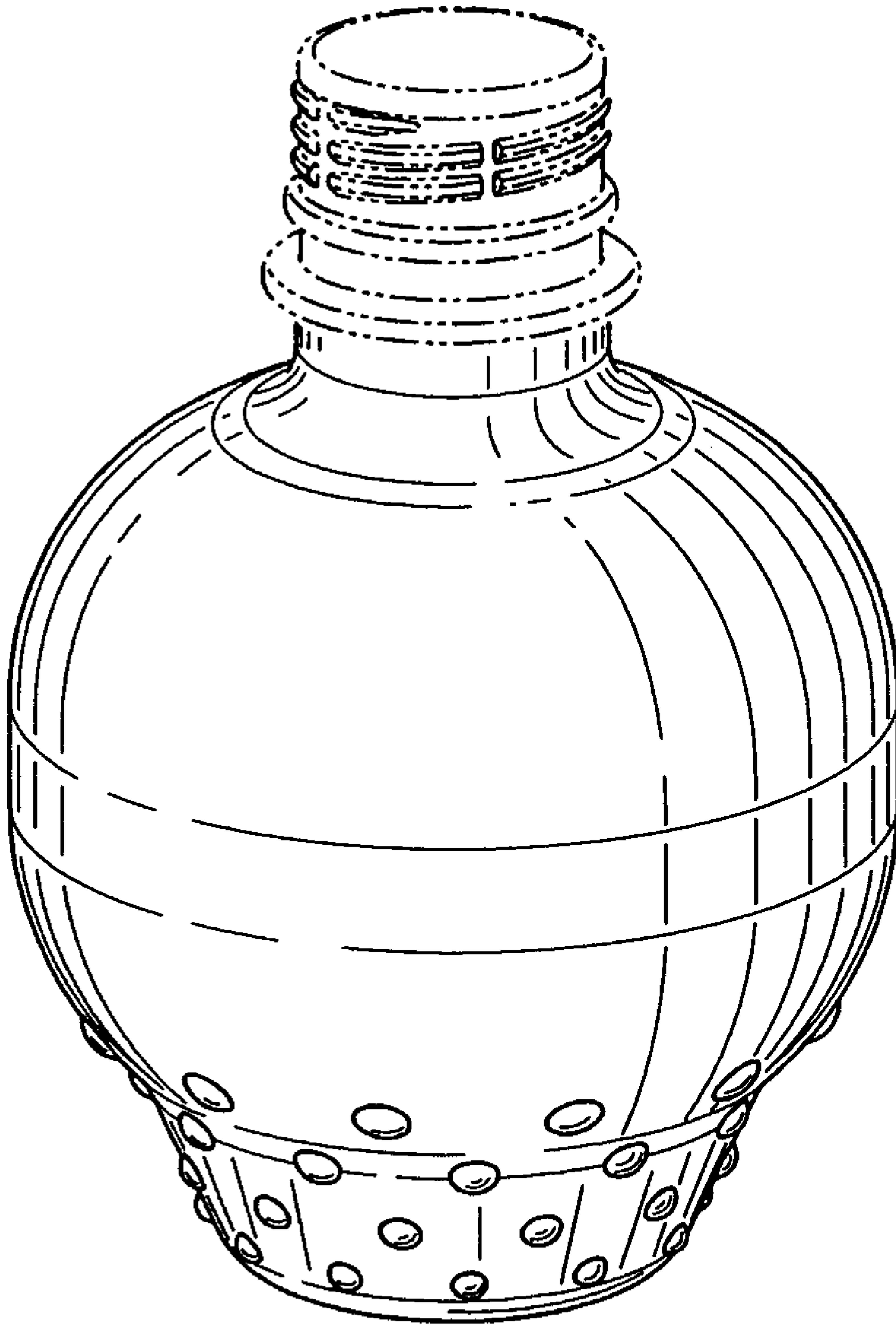
FIG. 5 is a back elevational view thereof; and,

FIG. 6 is a top plan view thereof.

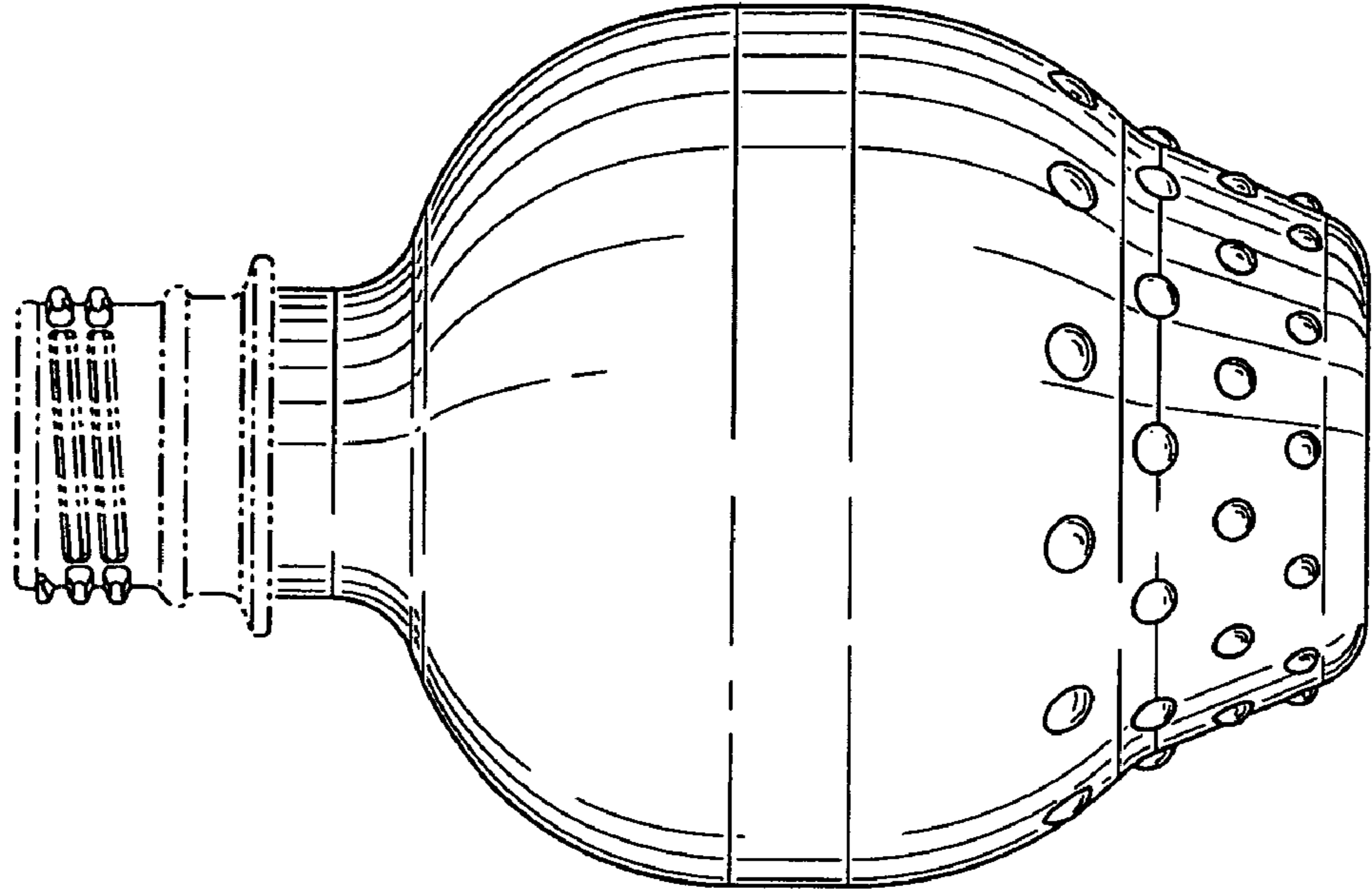

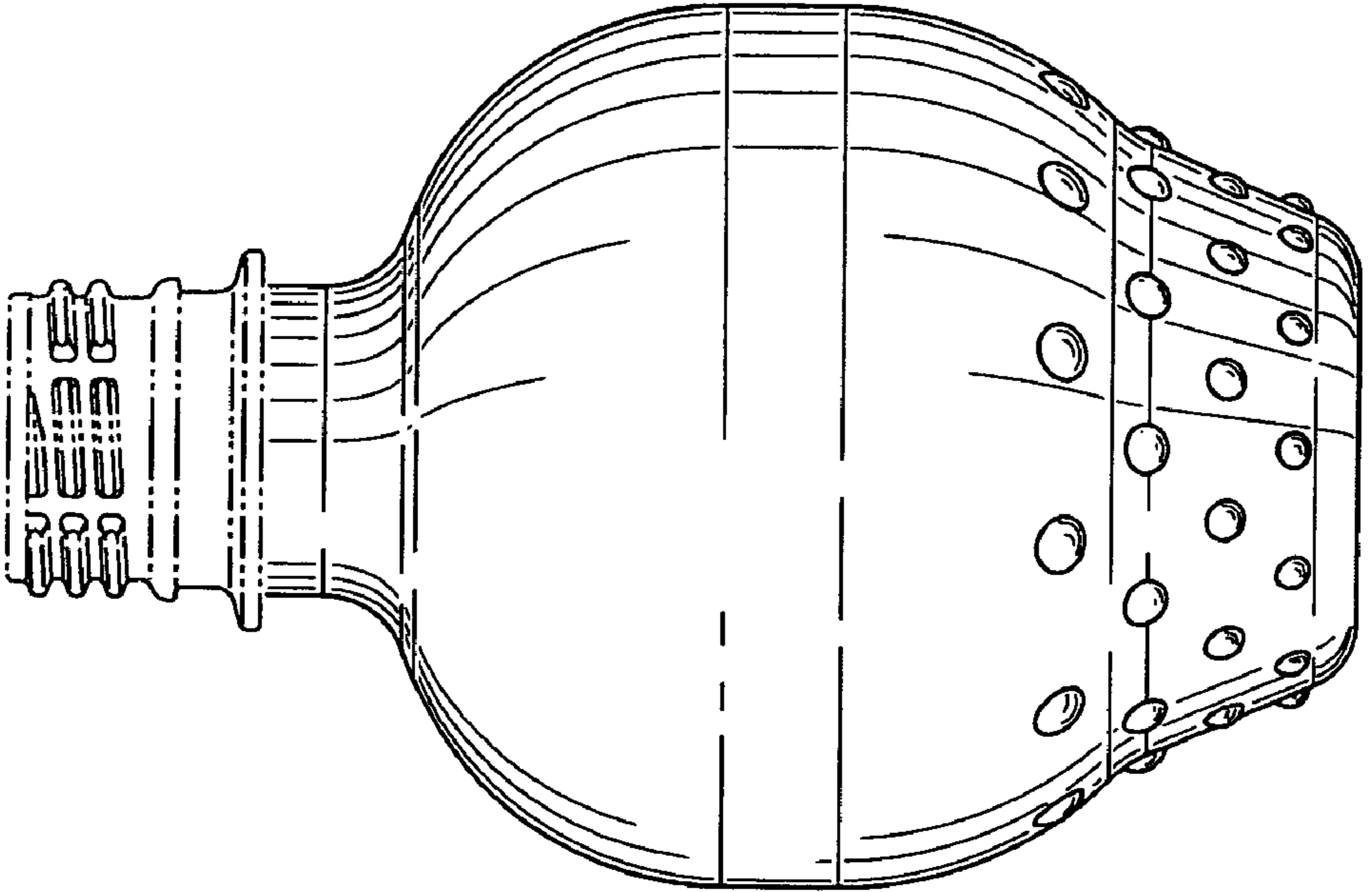




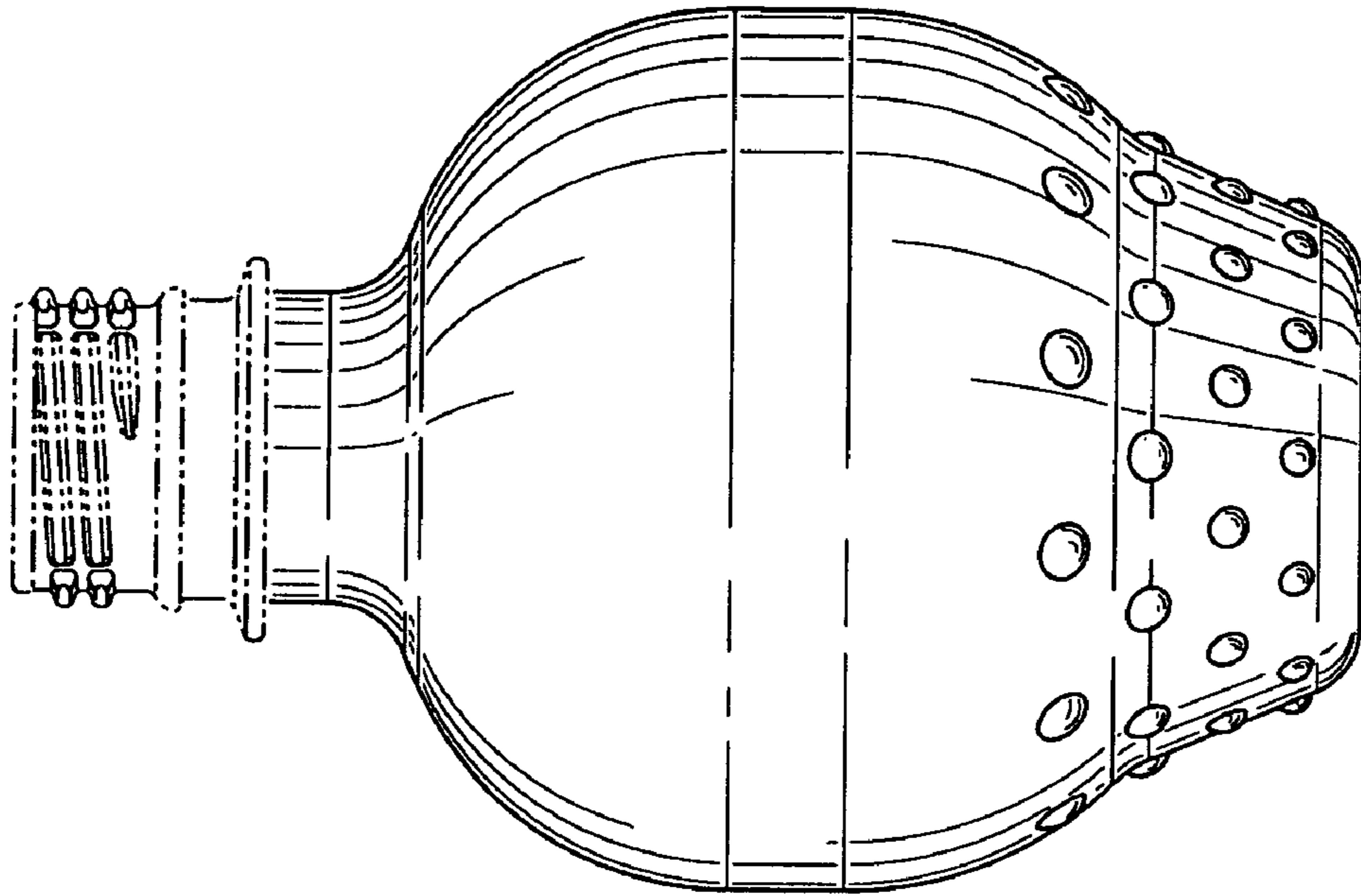

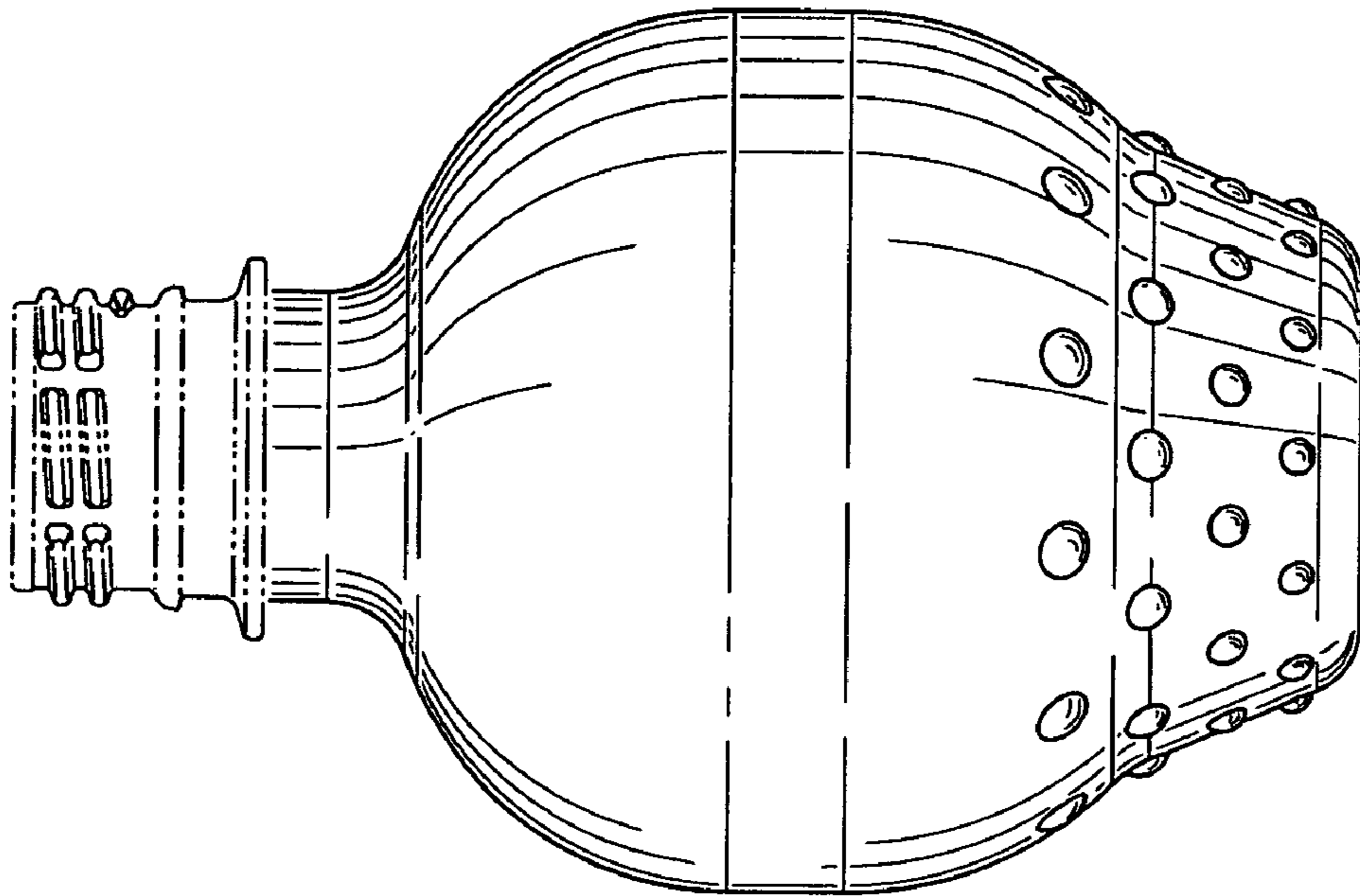

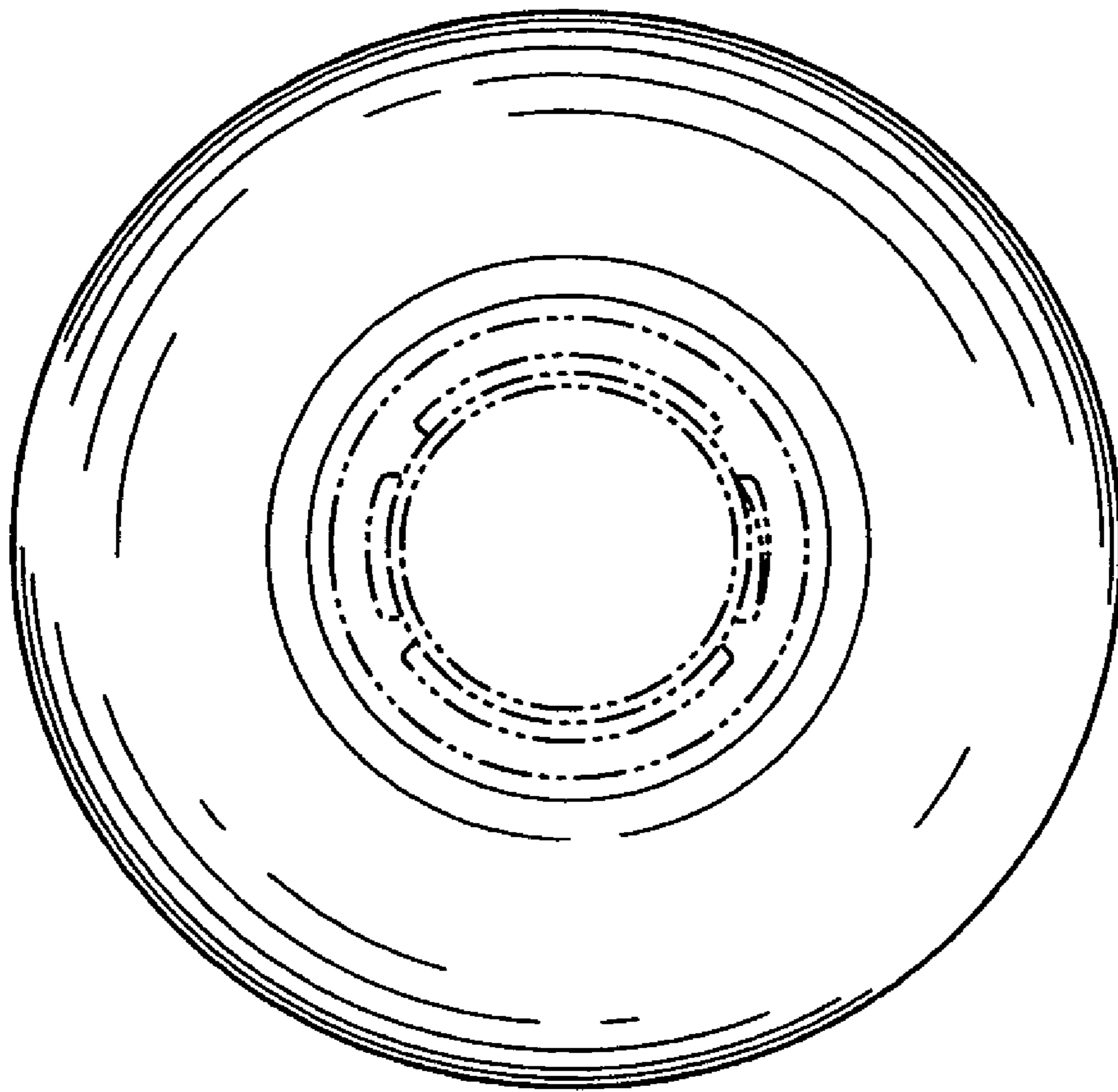
