**DESCRIPTION**

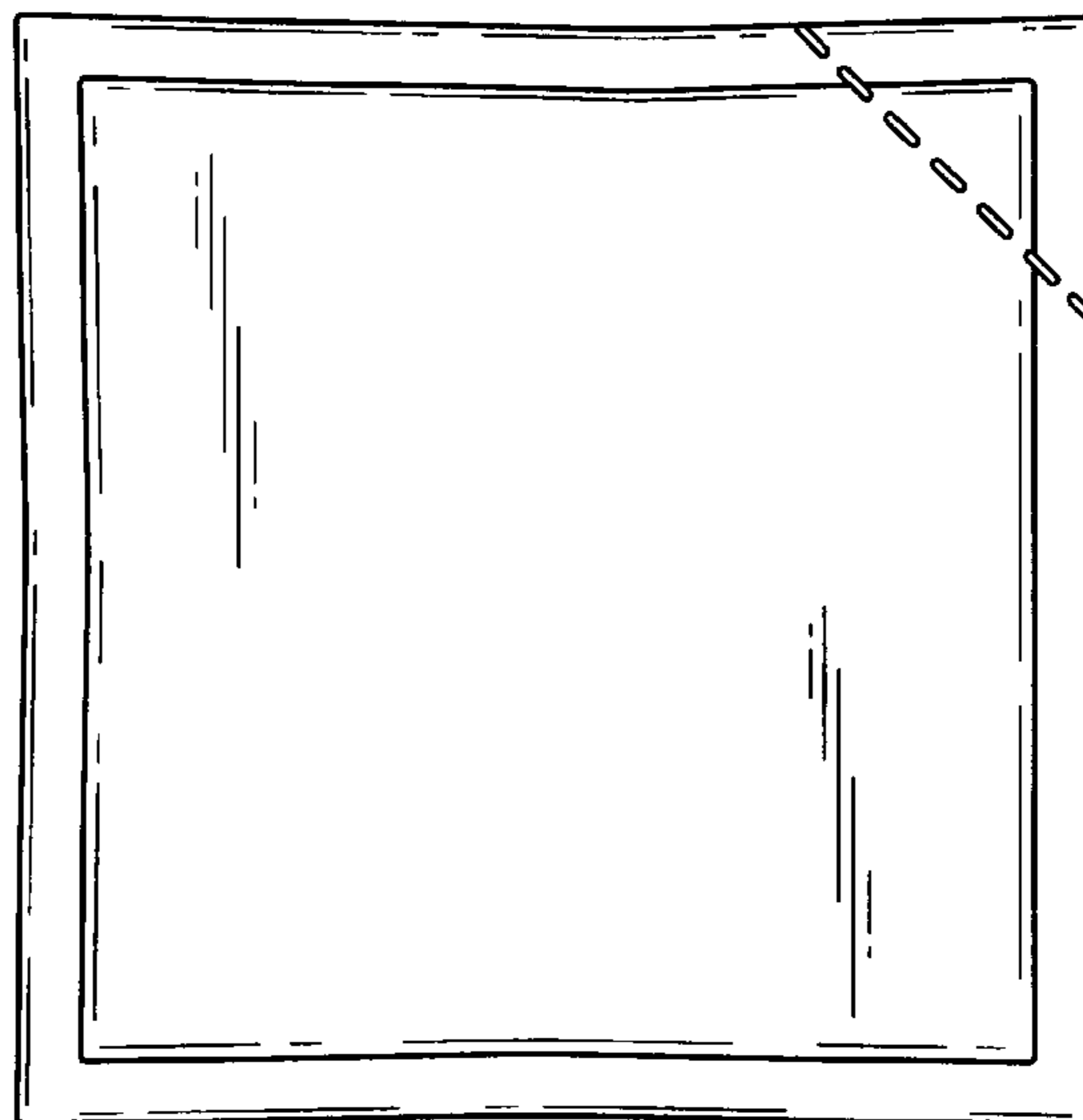
FIG. 1 is a front elevational view of the pouch for alcoholic beverages.

FIG. 2 is a rear elevational view thereof.

FIG. 3 is a left side elevational view thereof, the right side view being a mirror image of the left side view; and,

FIG. 4 is a top plan view thereof, the bottom plan view being a mirror image of the top plan view.

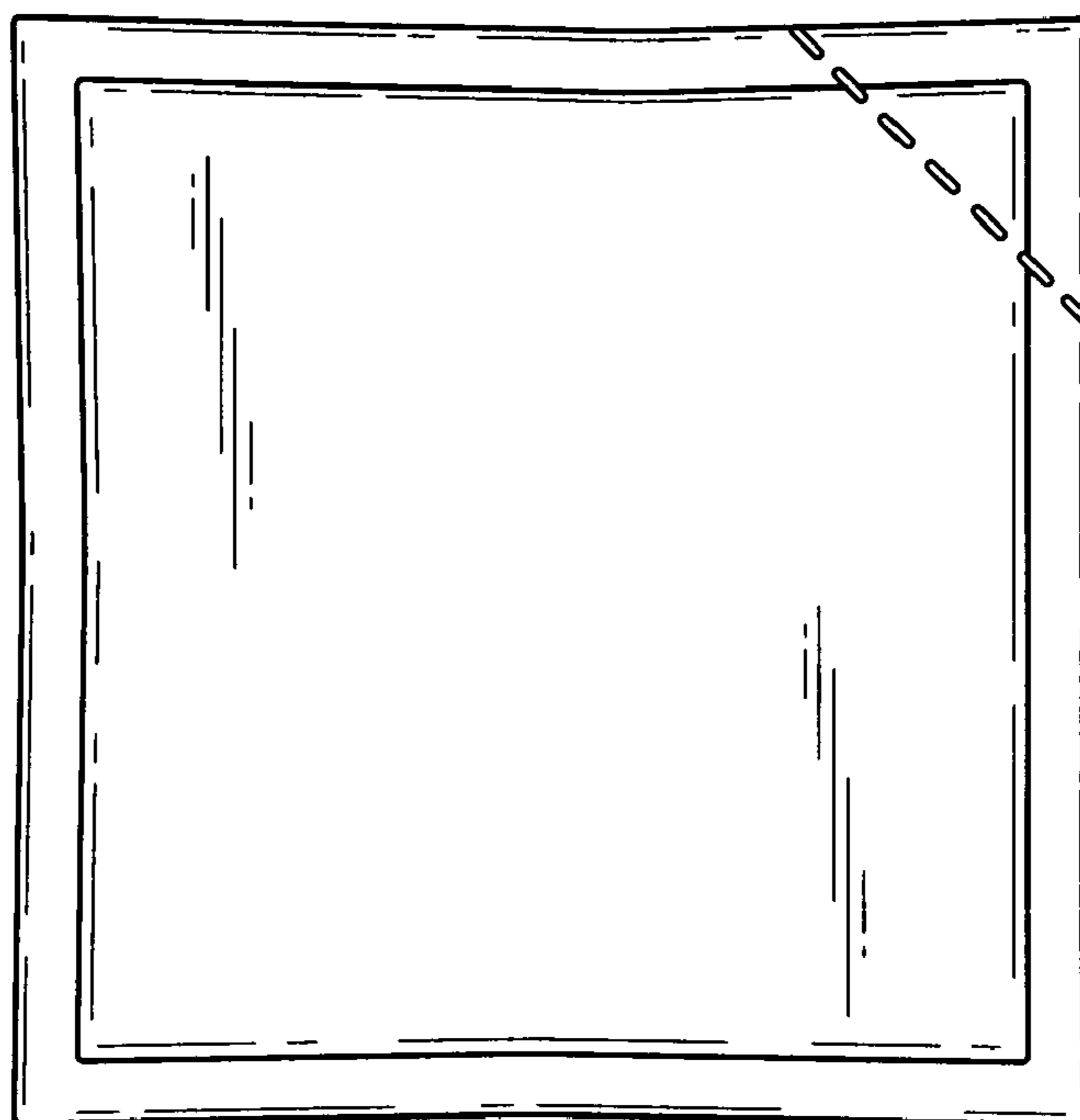

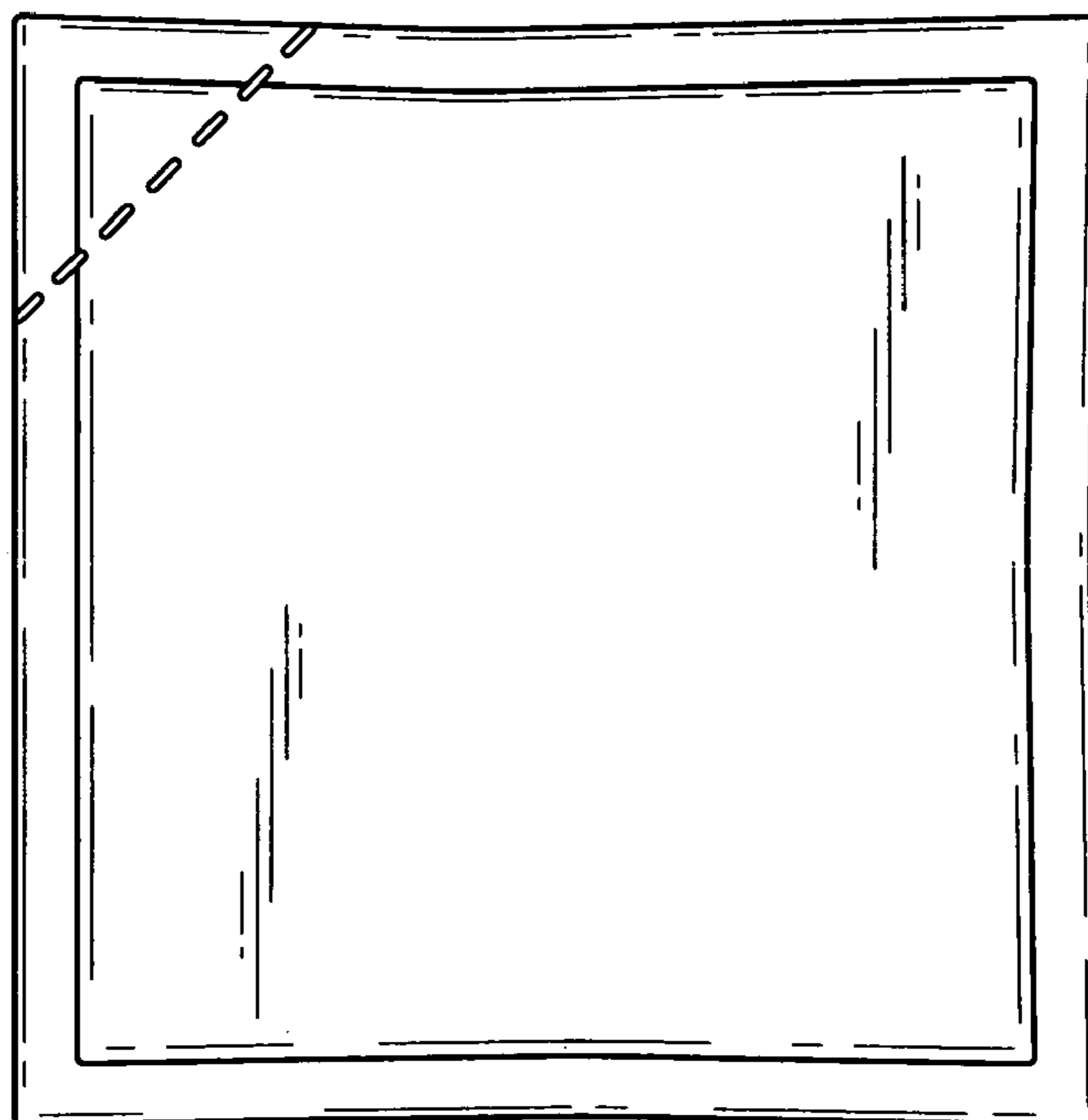
