FIG. 2 is a top view.

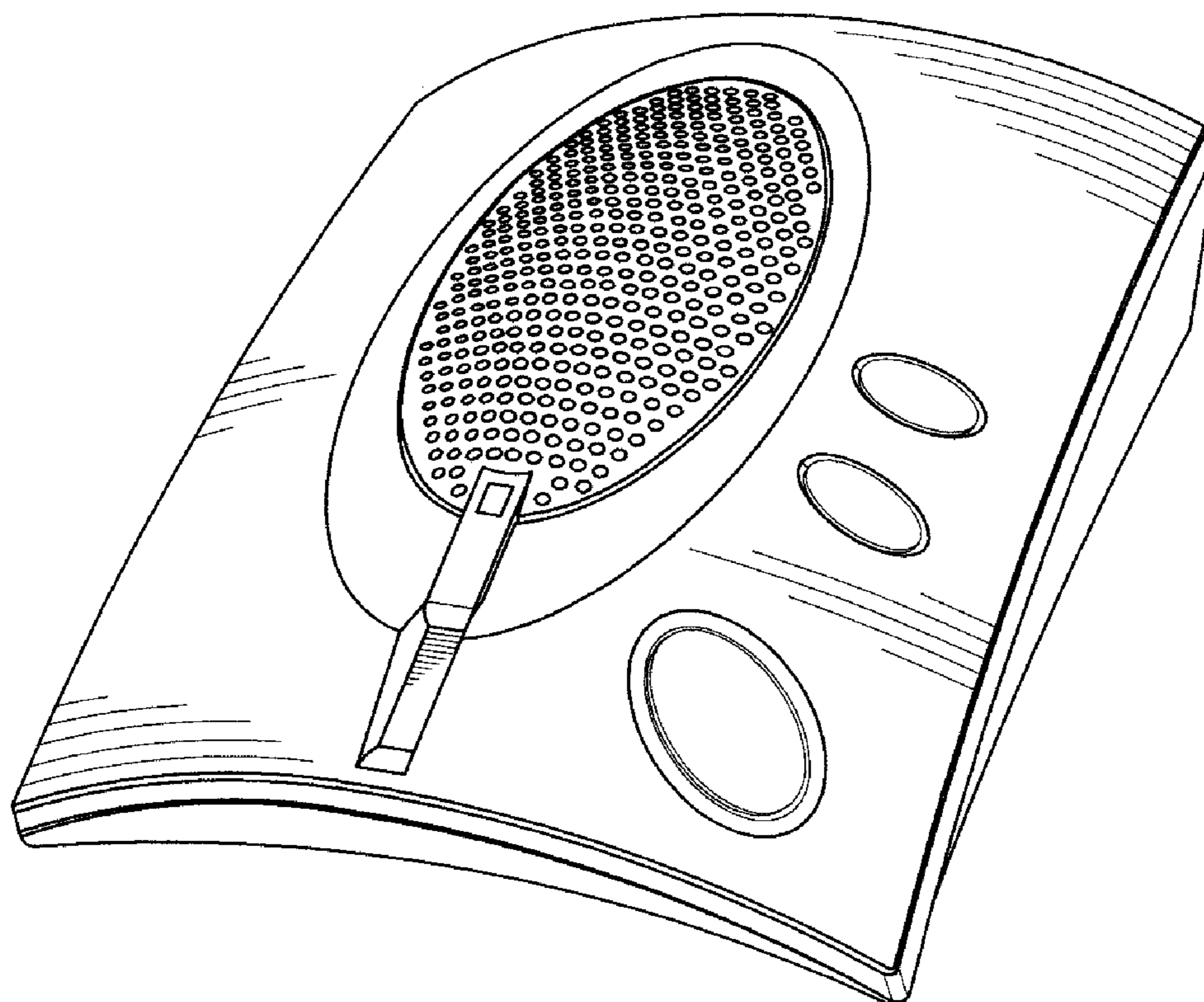
FIG. 3 is a front view.

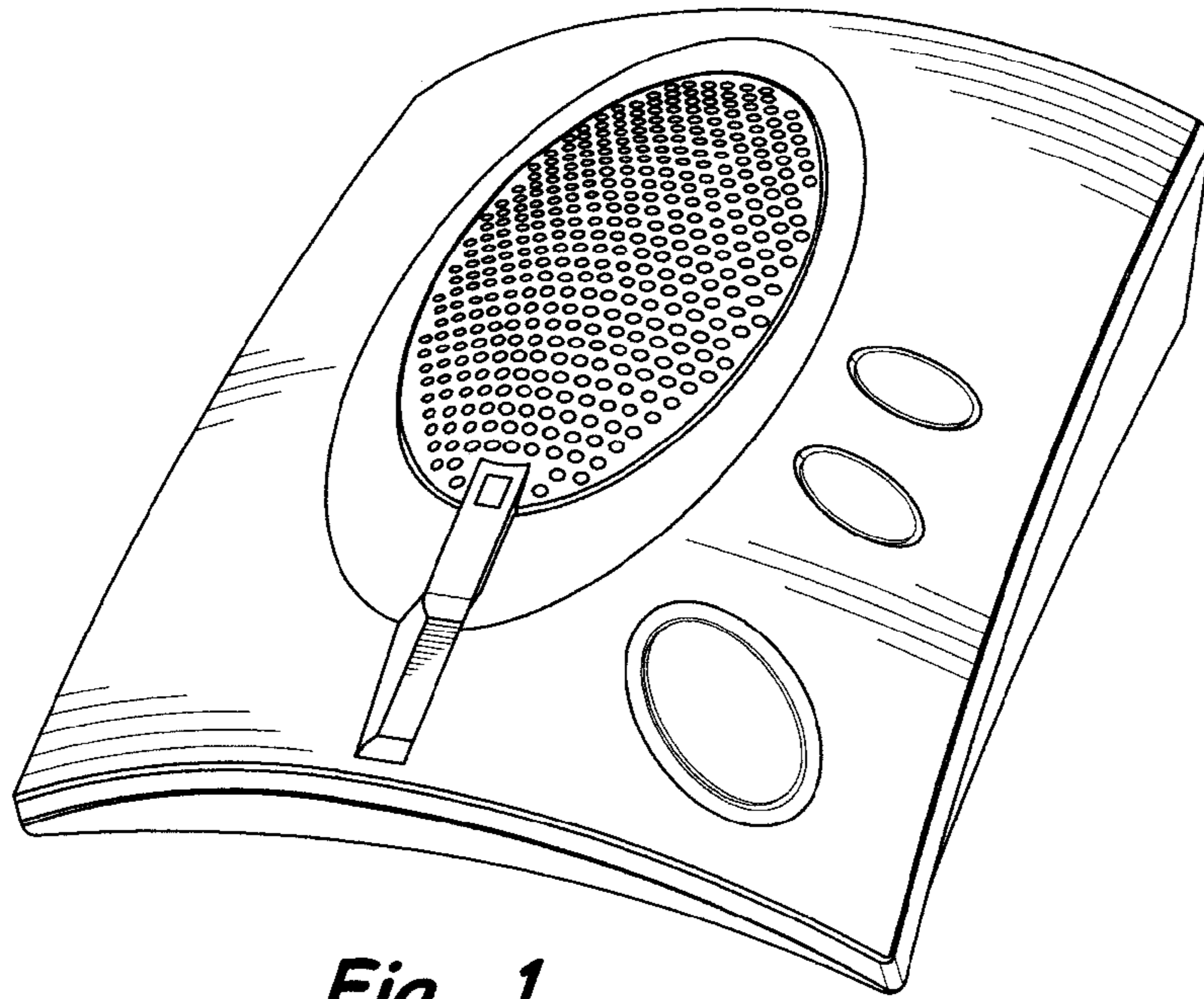

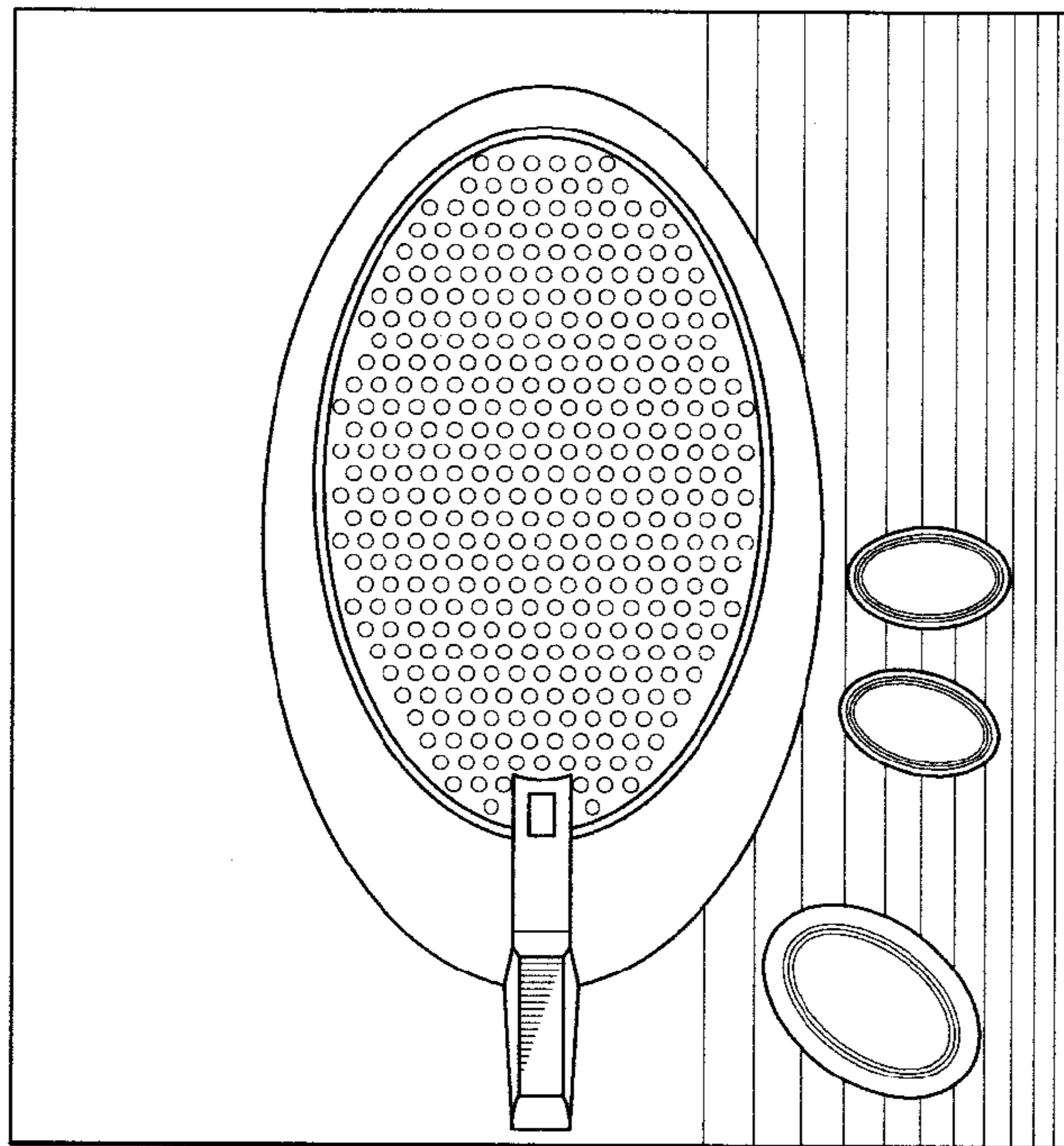

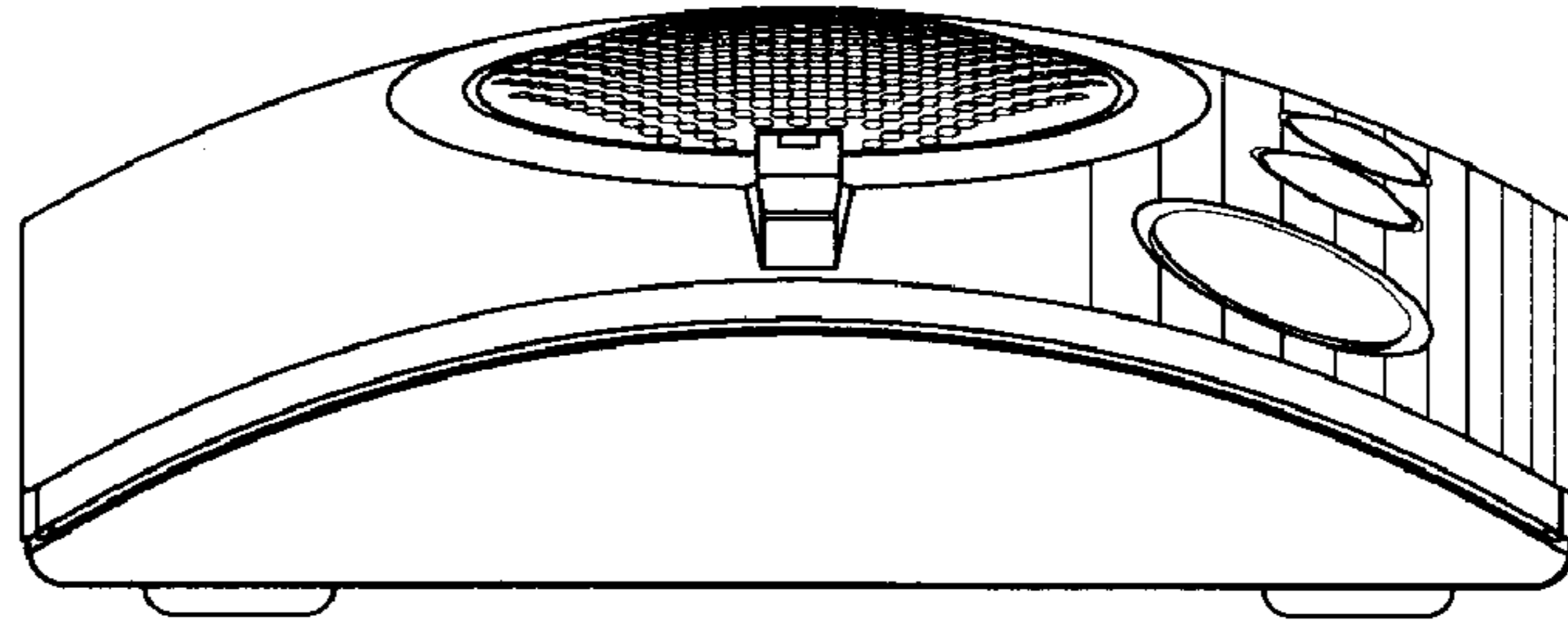

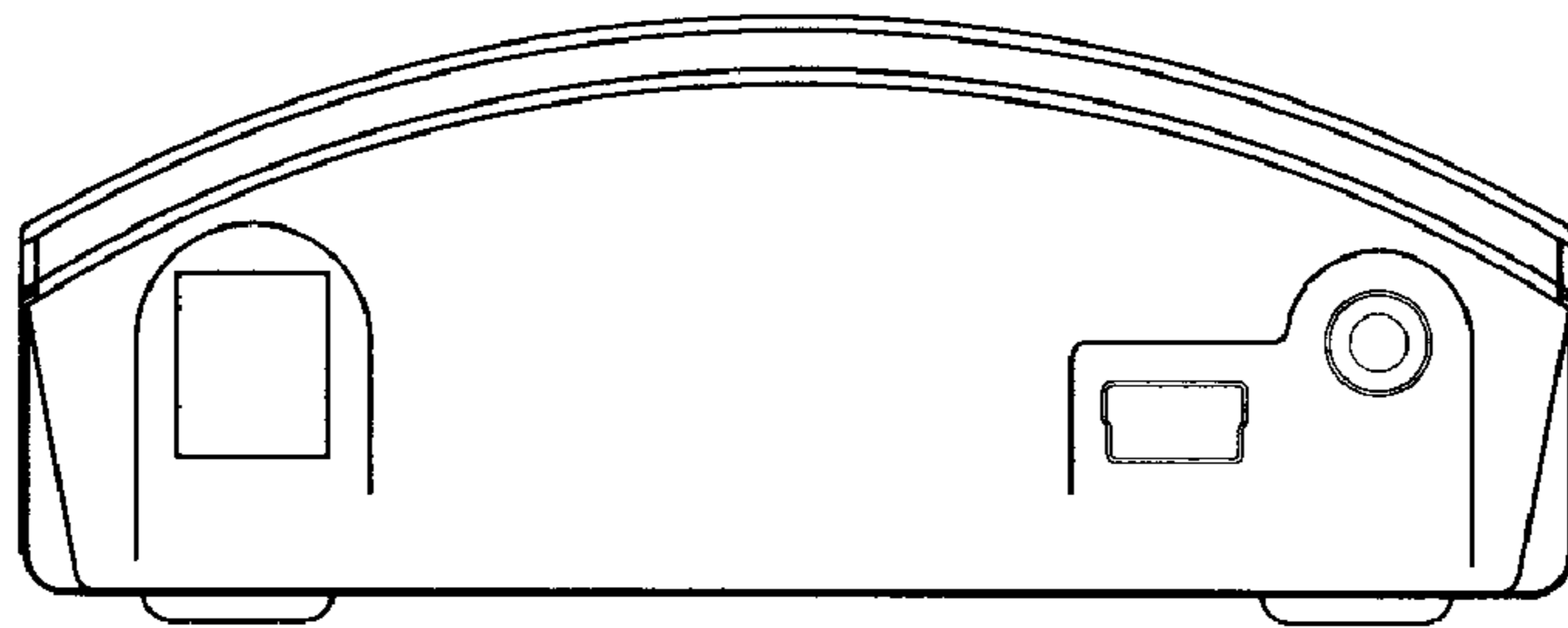

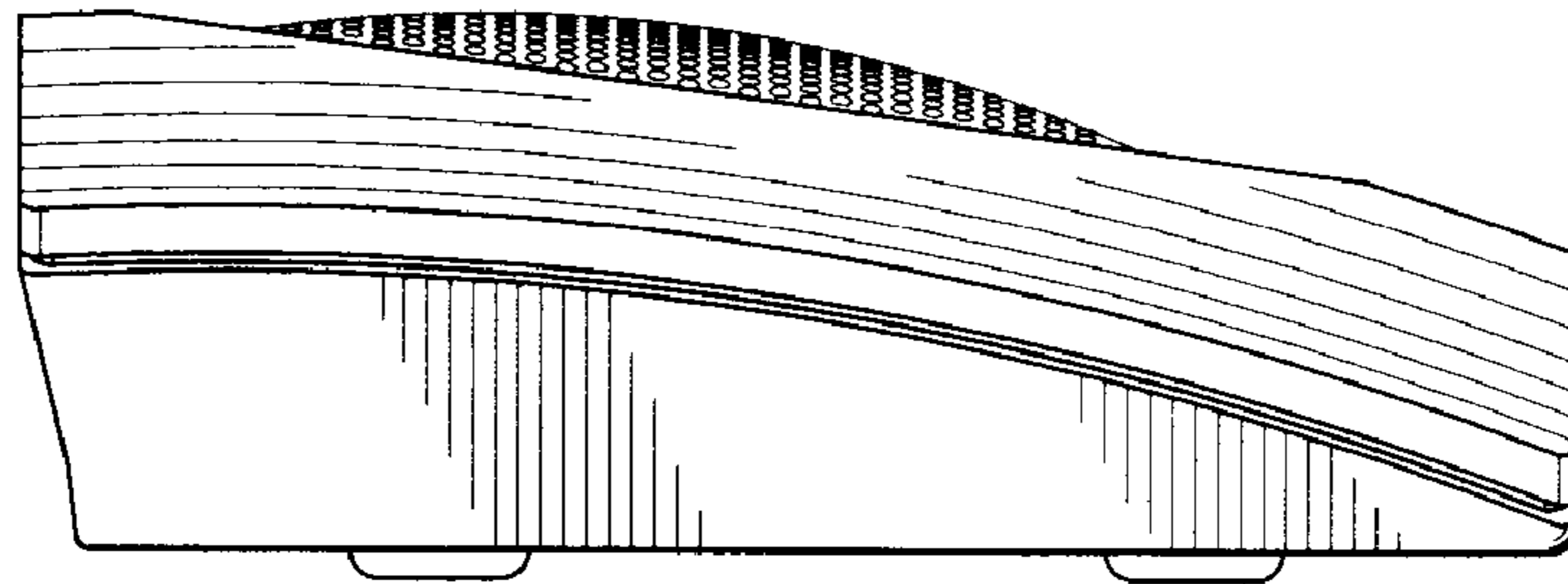

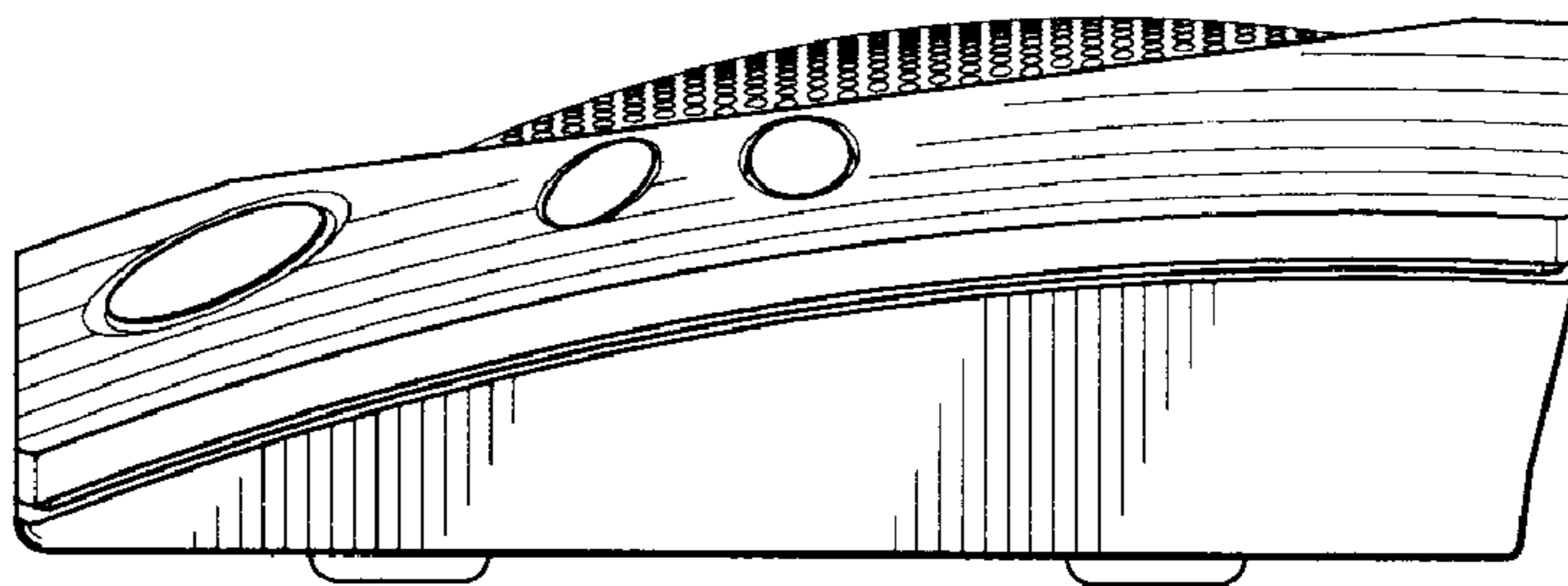
