FIG. 4 shows a front view of the second embodiment thereof;

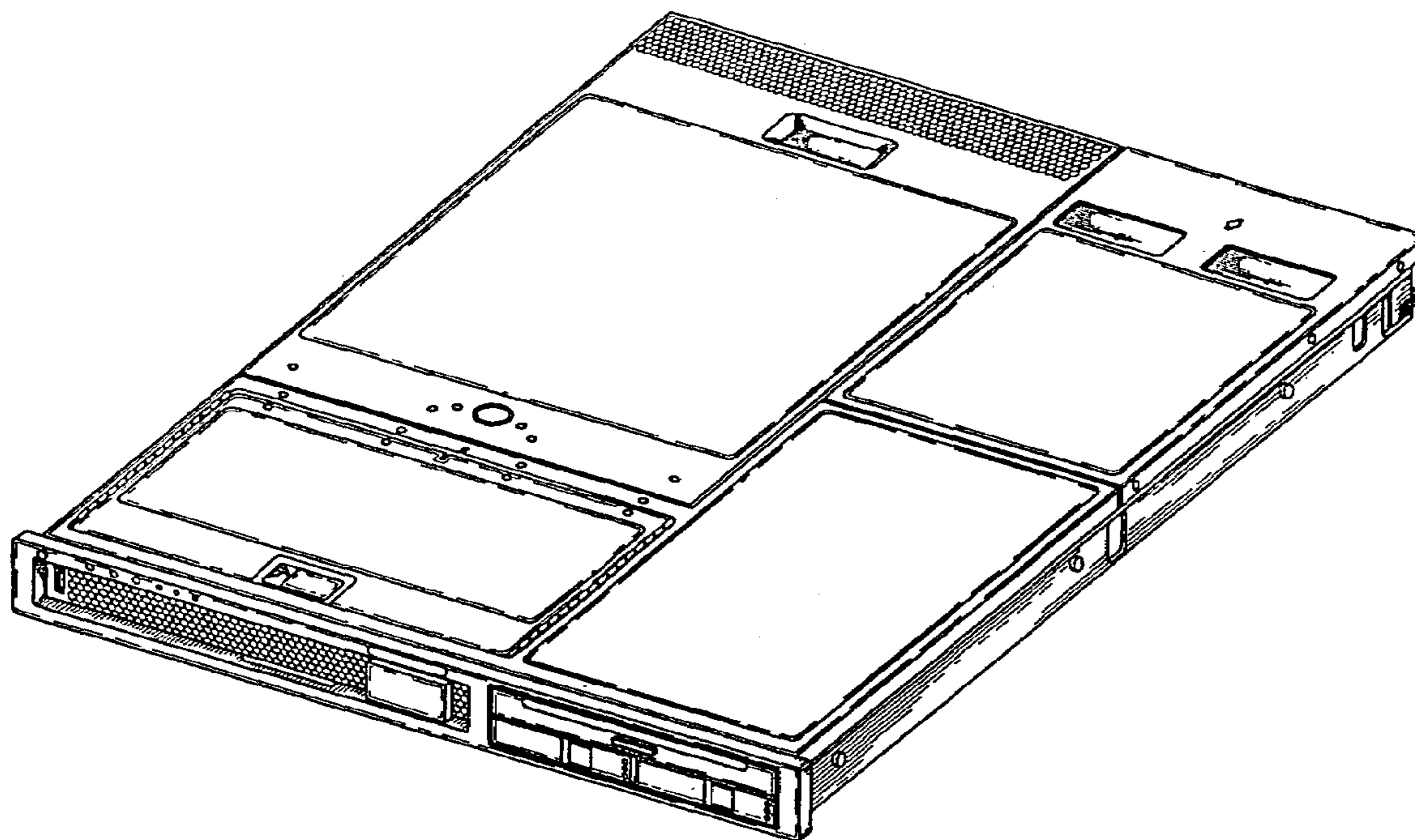
FIG. 5 shows a rear view of the first embodiment thereof;

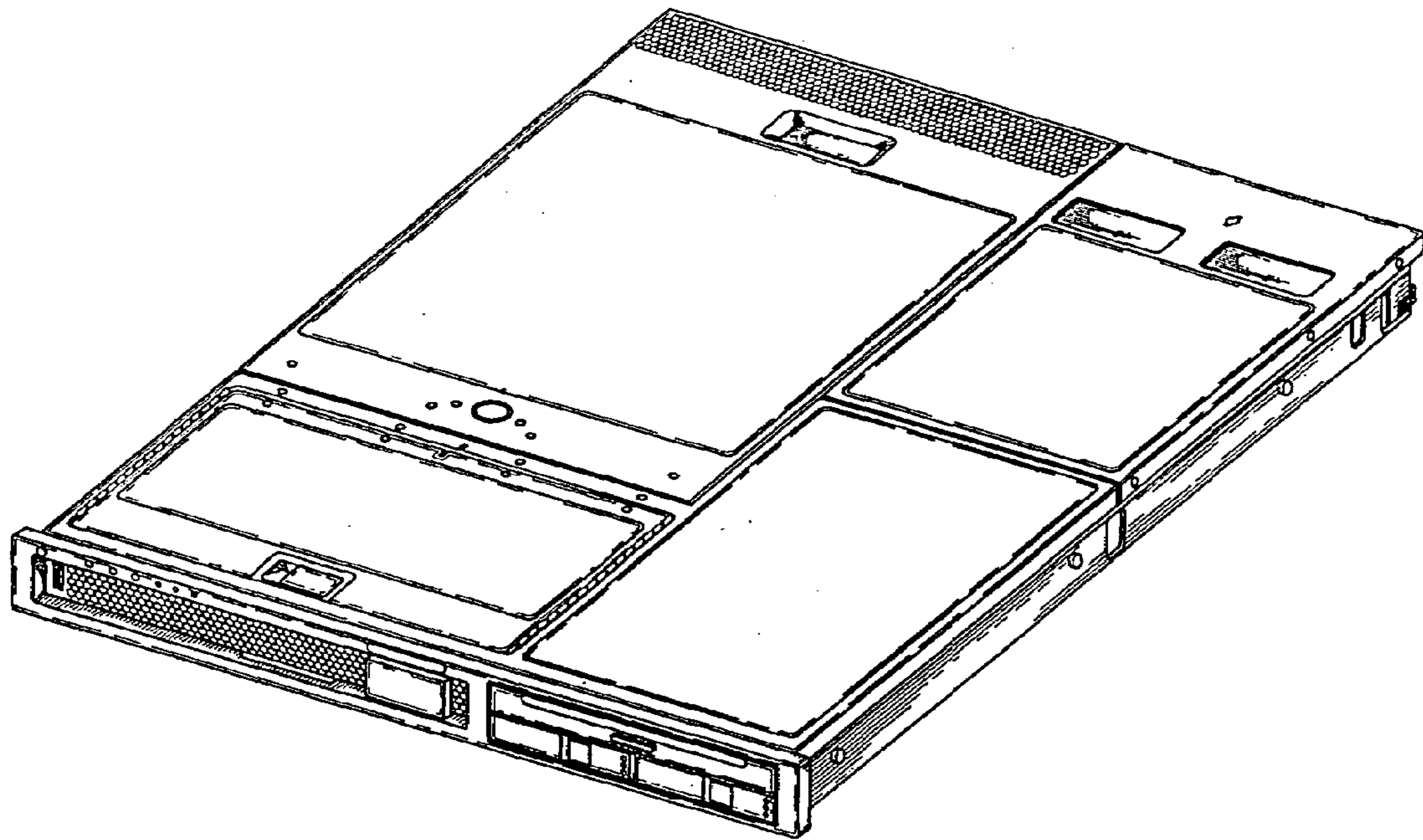

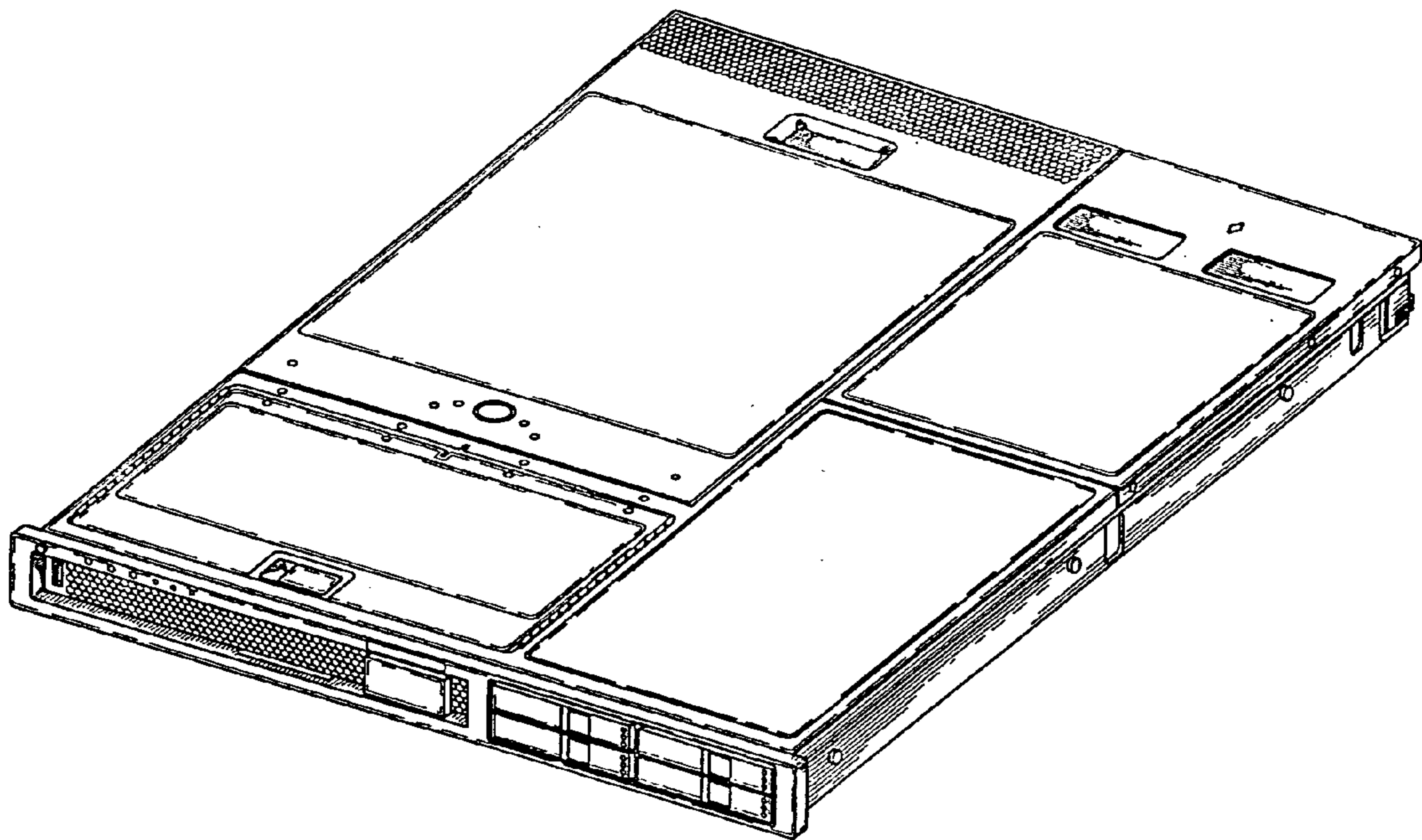

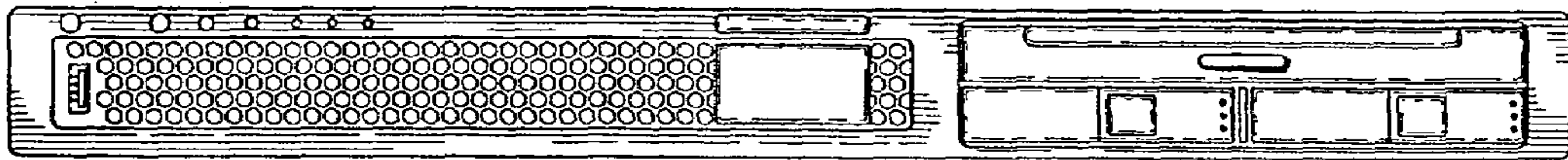

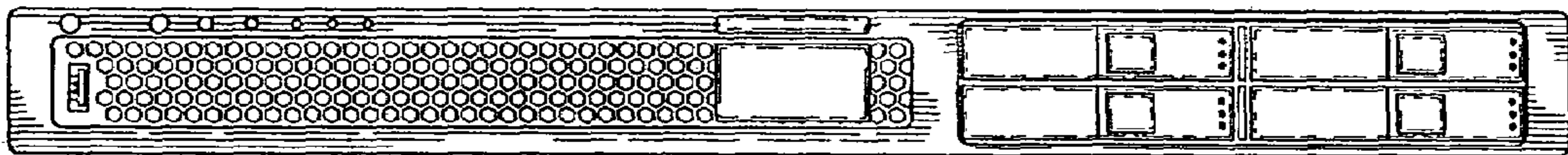

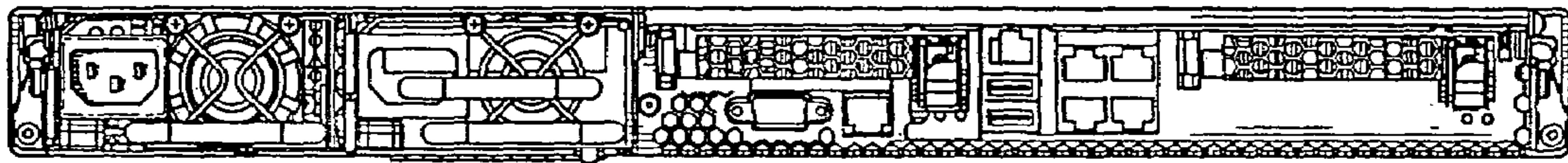

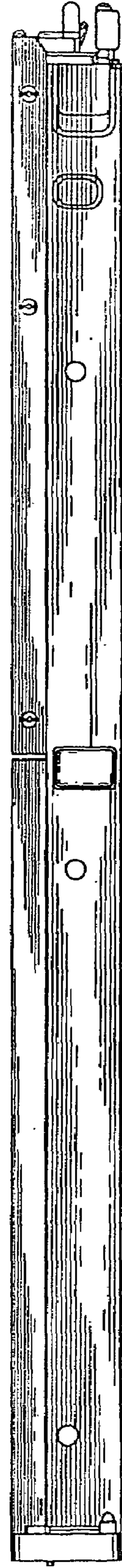

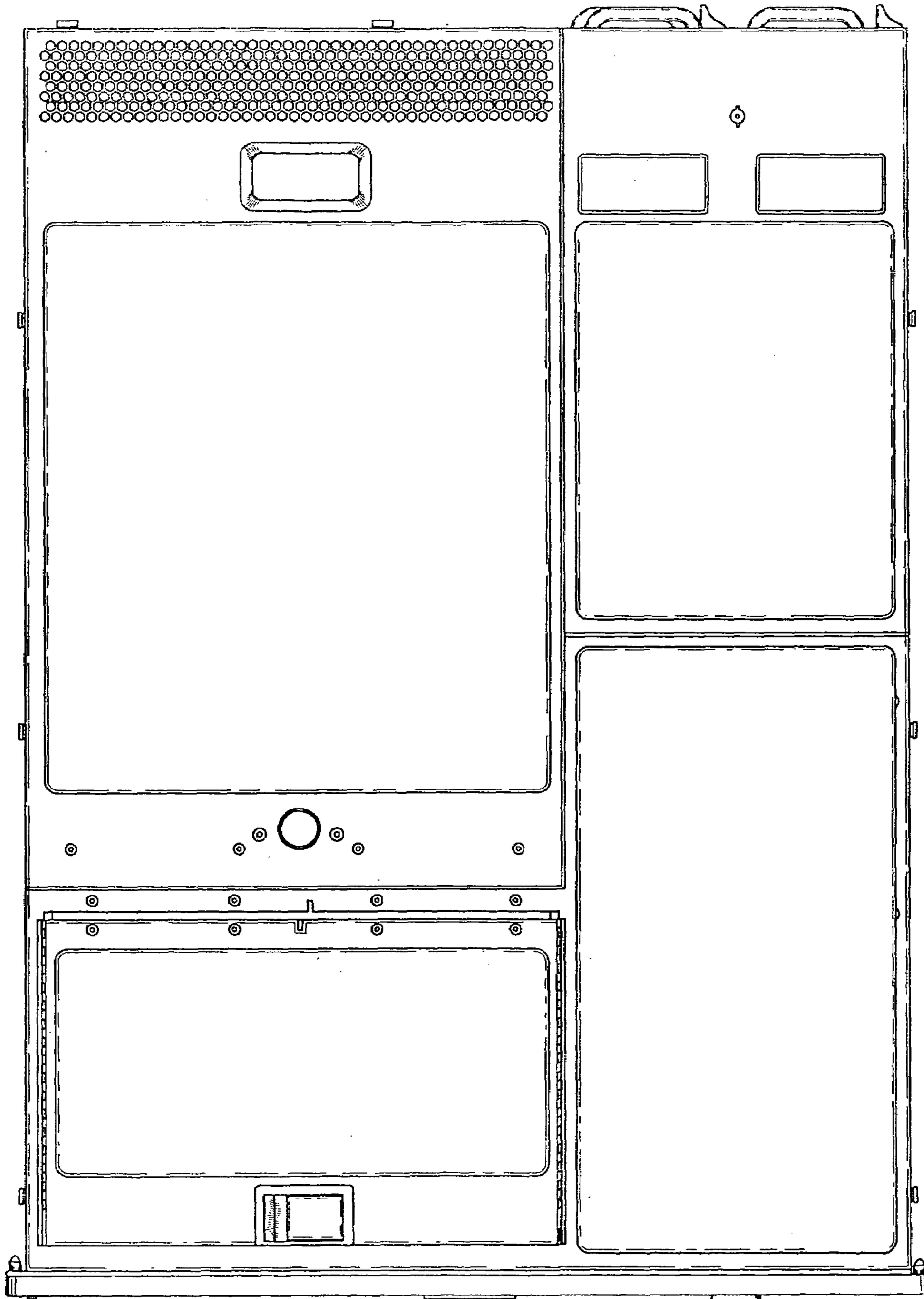
