FIG. 4 is an enlarged view of the region in FIG. 3.

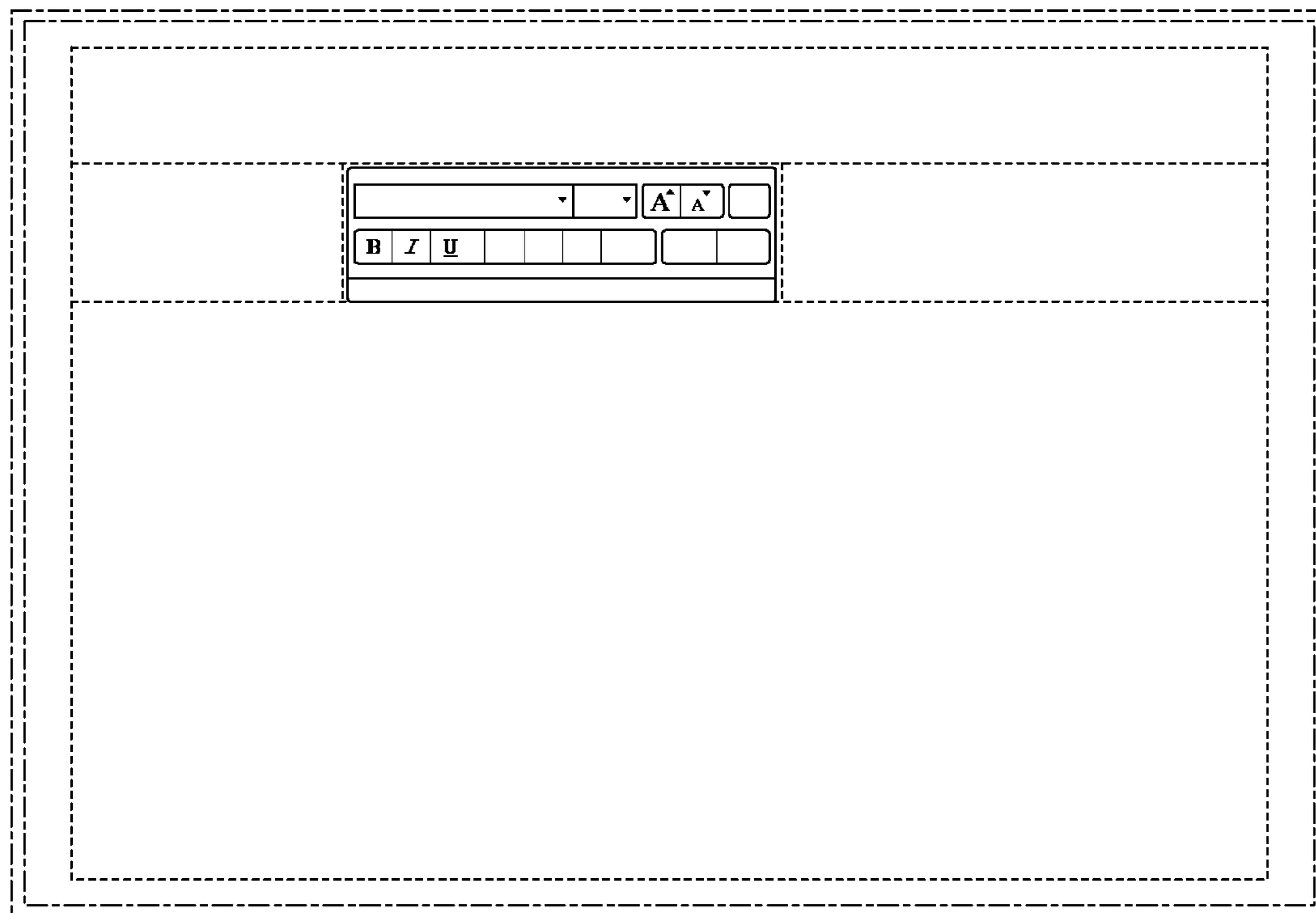

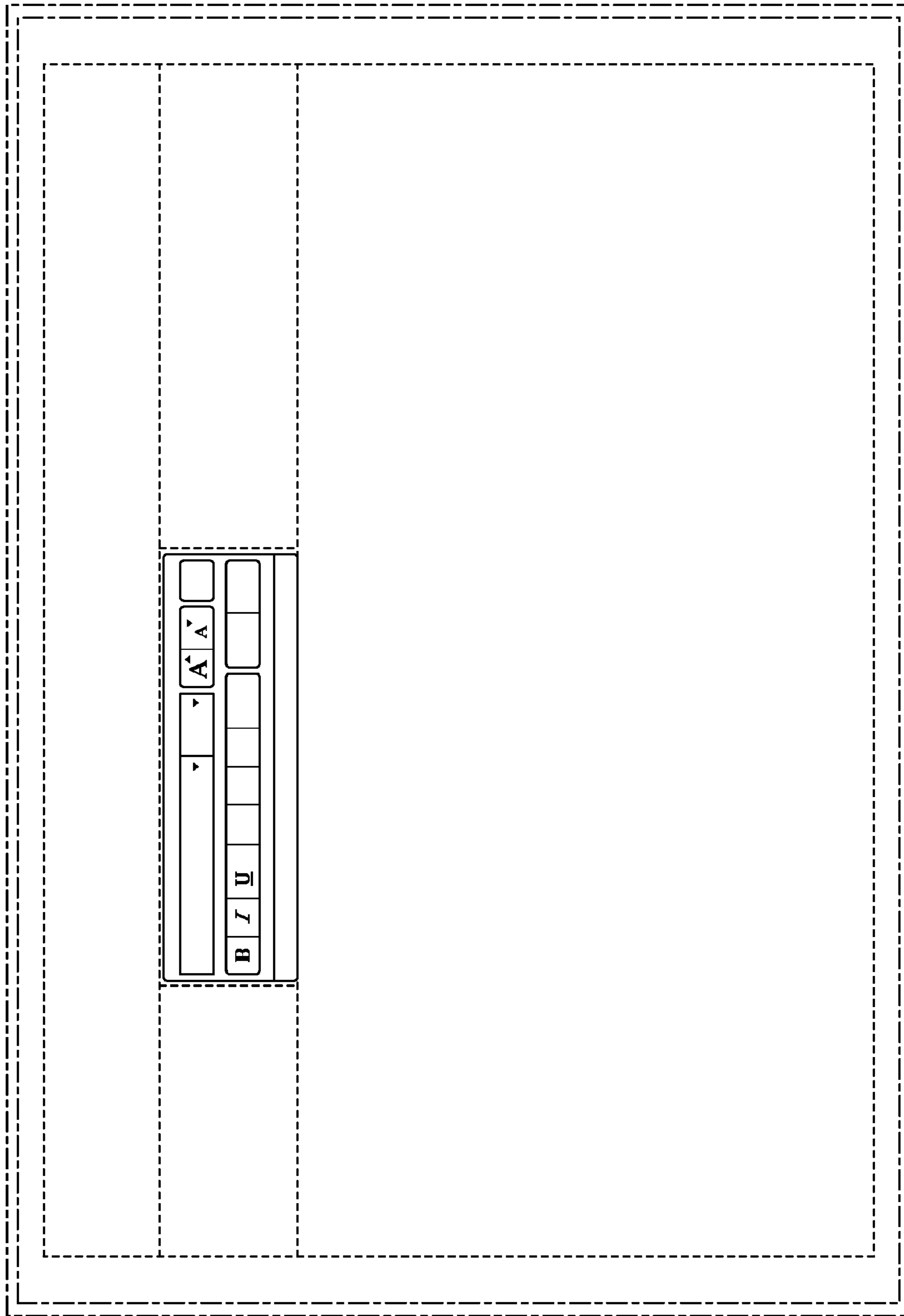

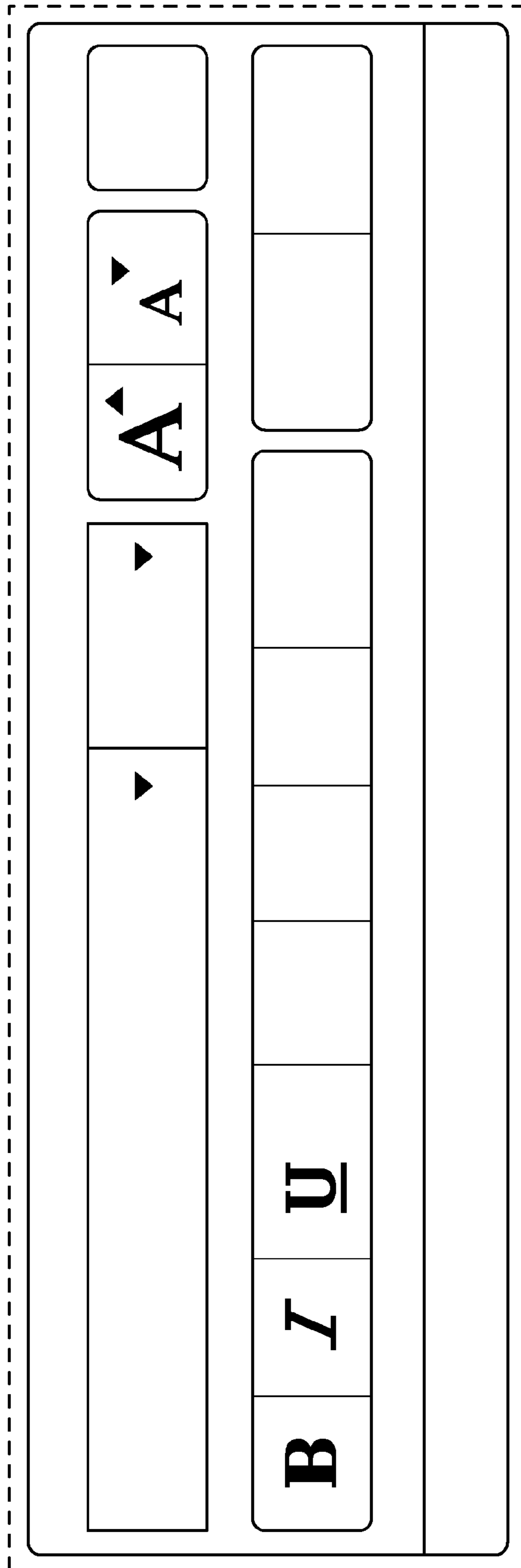

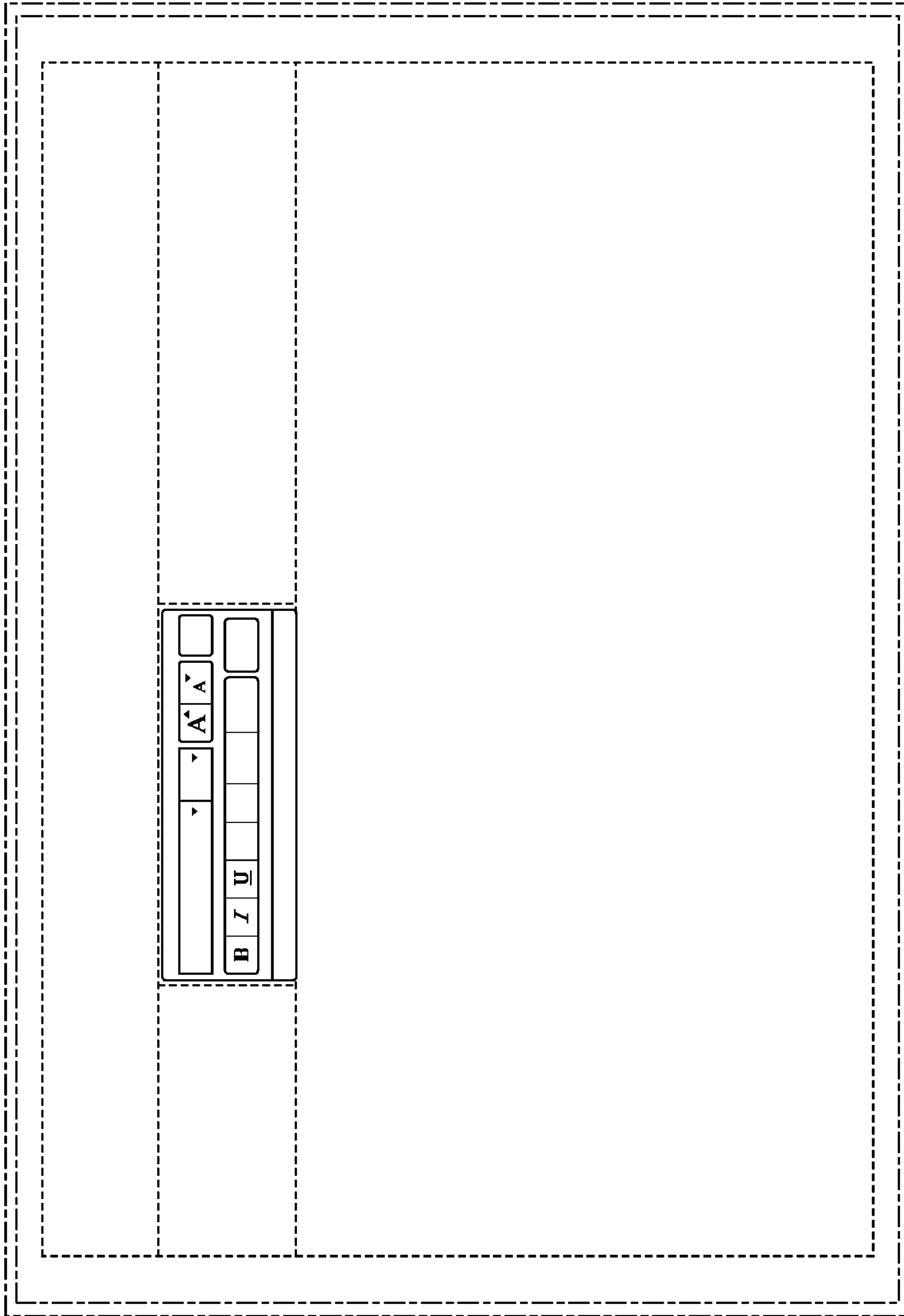

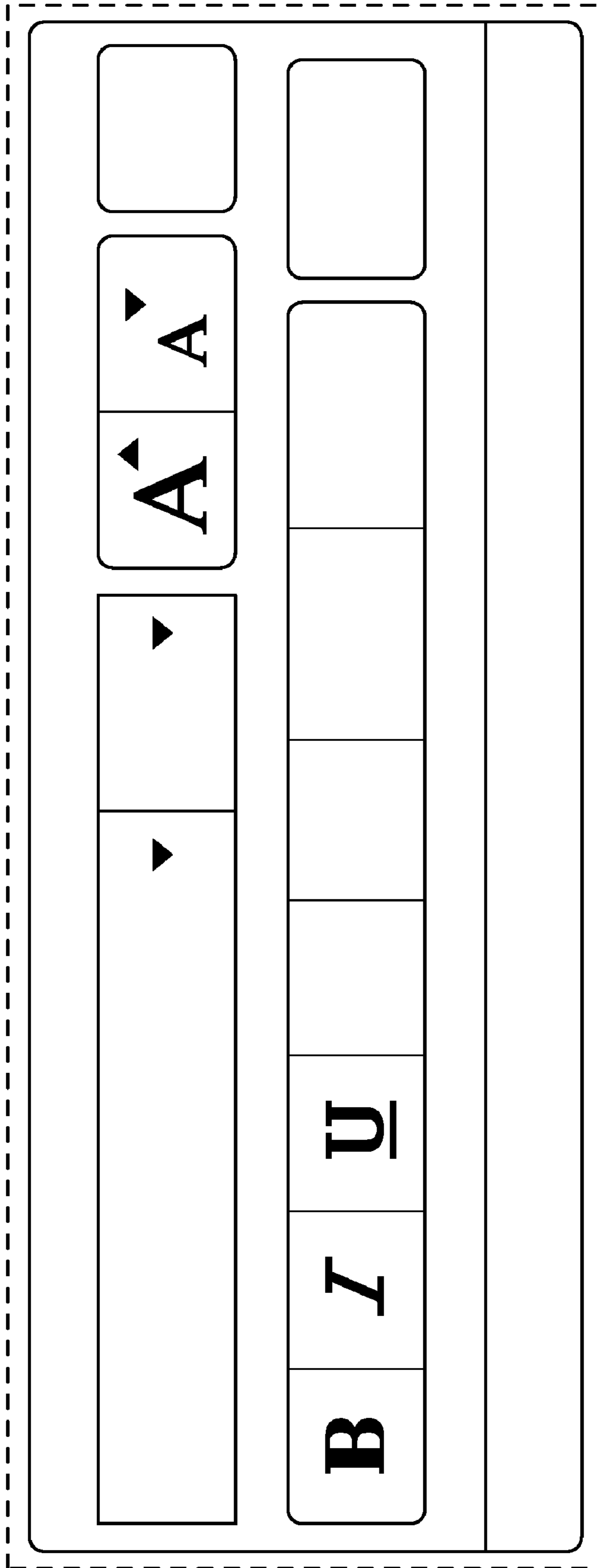
