DESCRIPTION

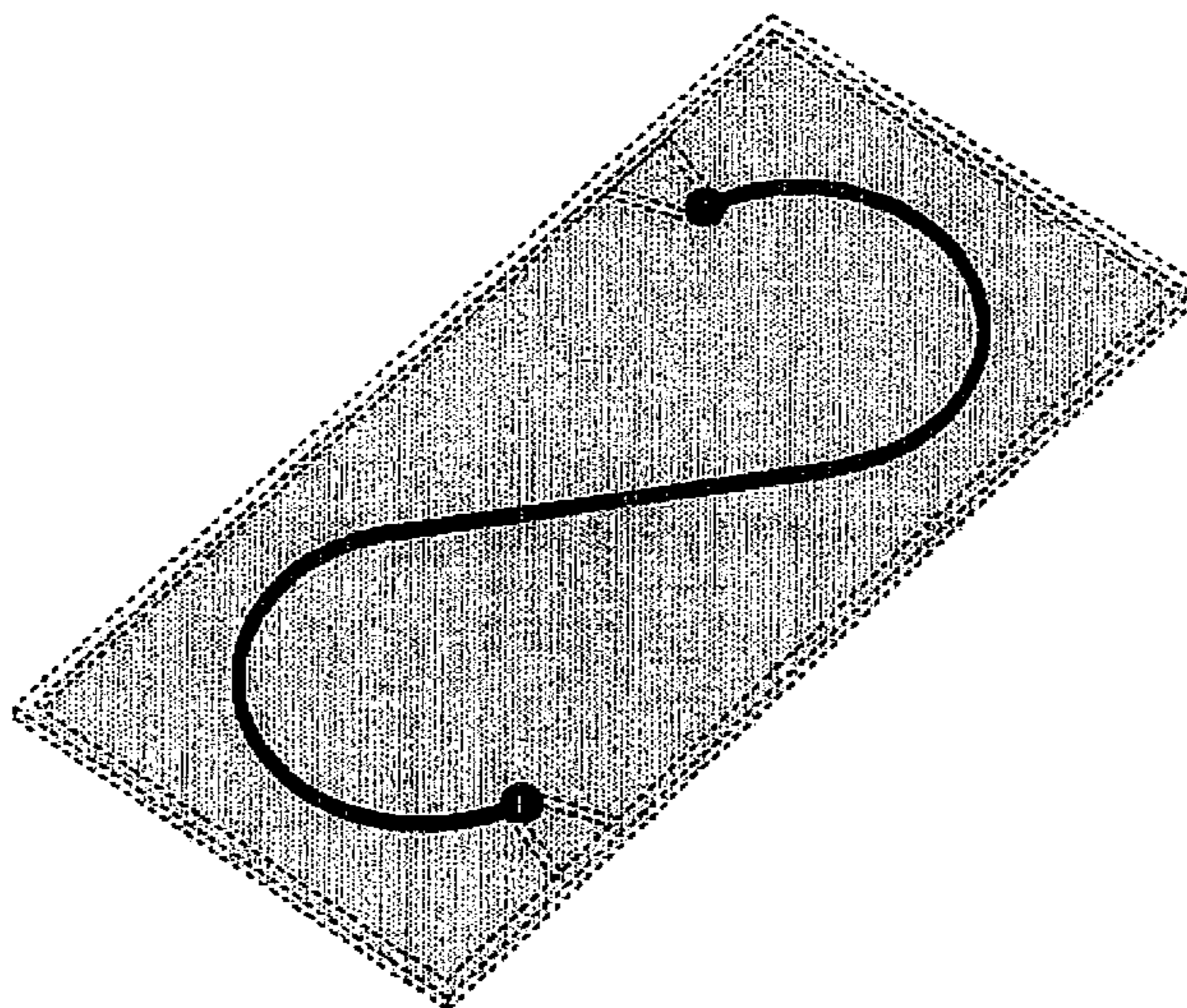
FIG. 1 is a top, perspective view of a resonator showing our new design;

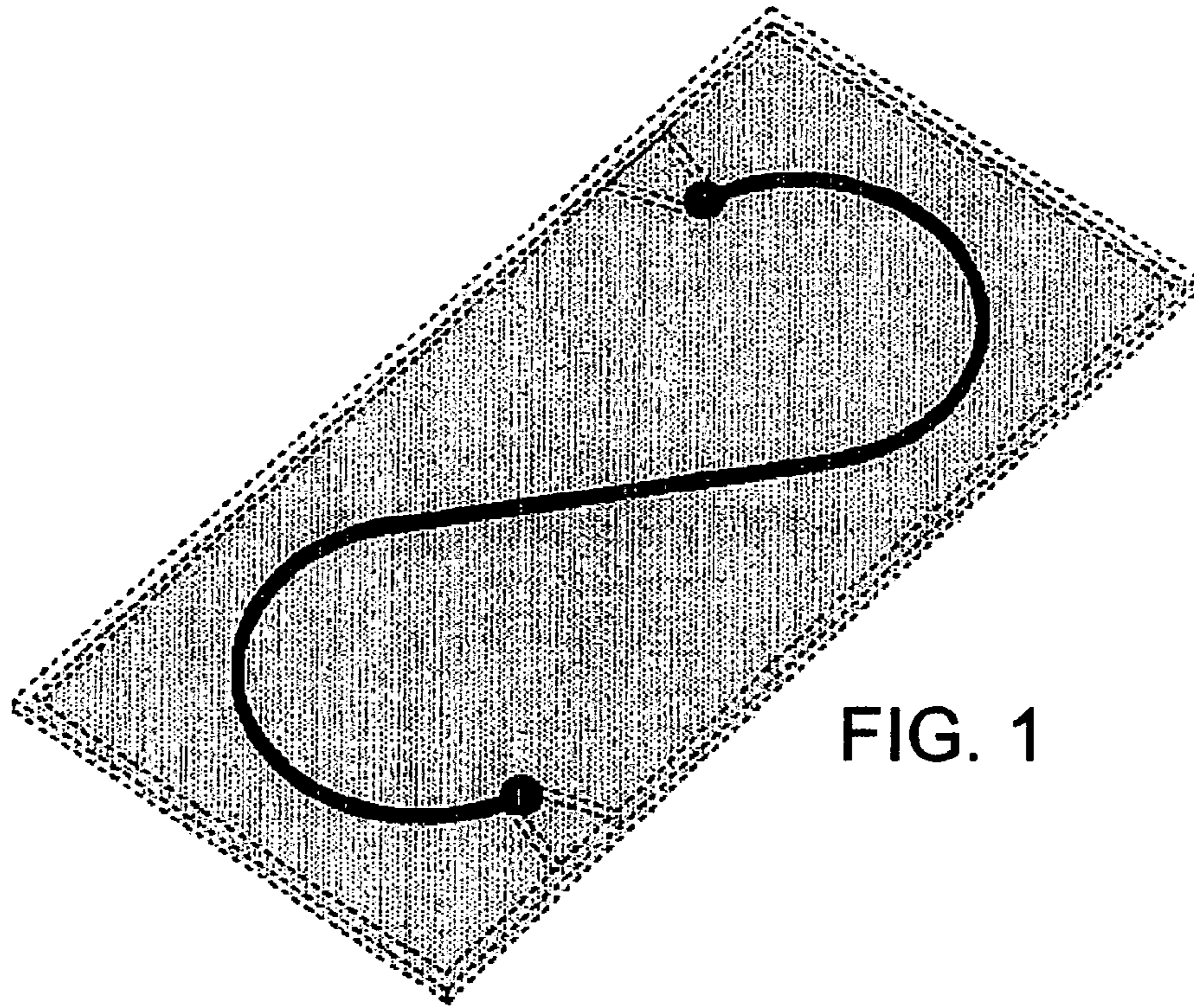

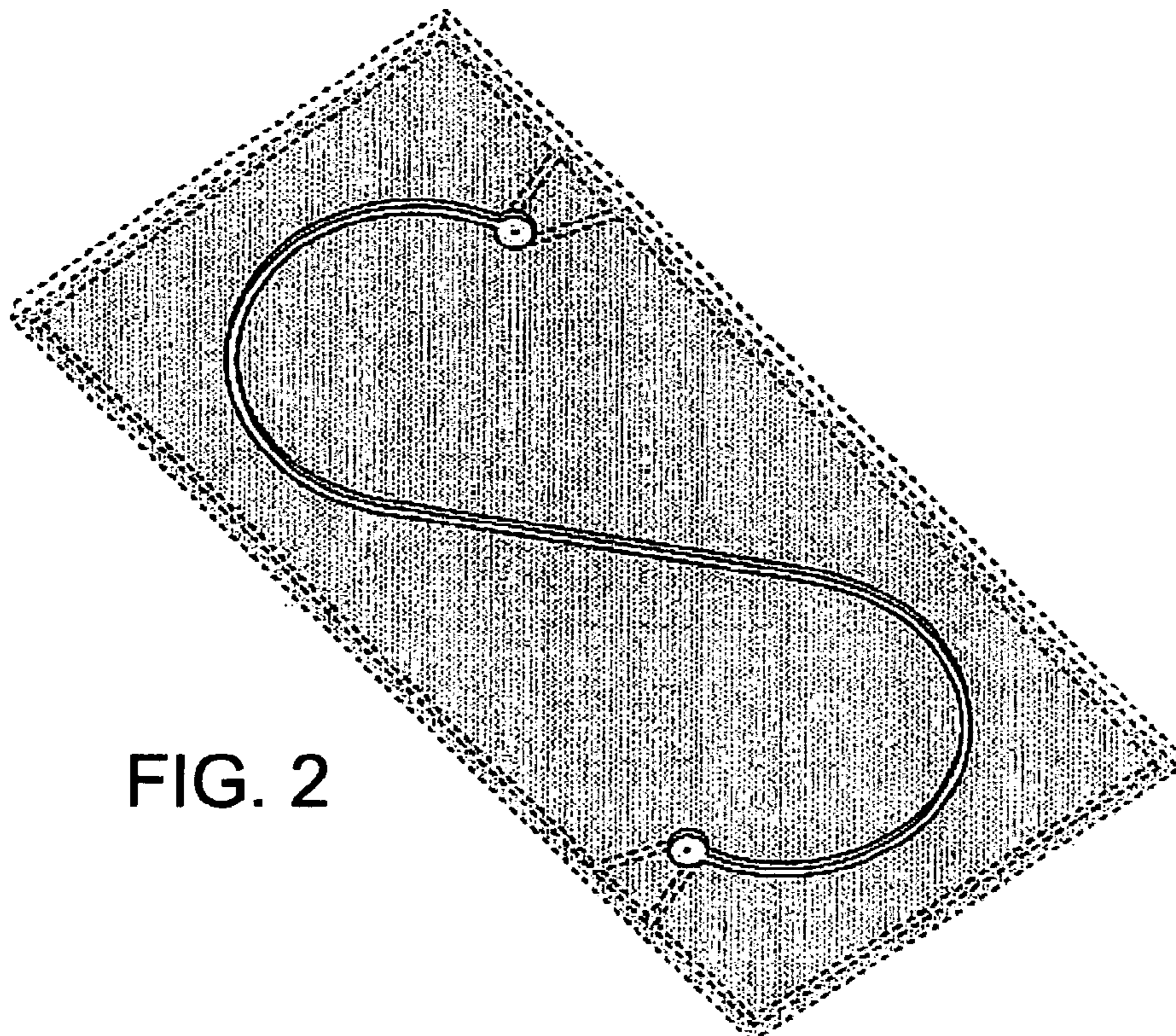

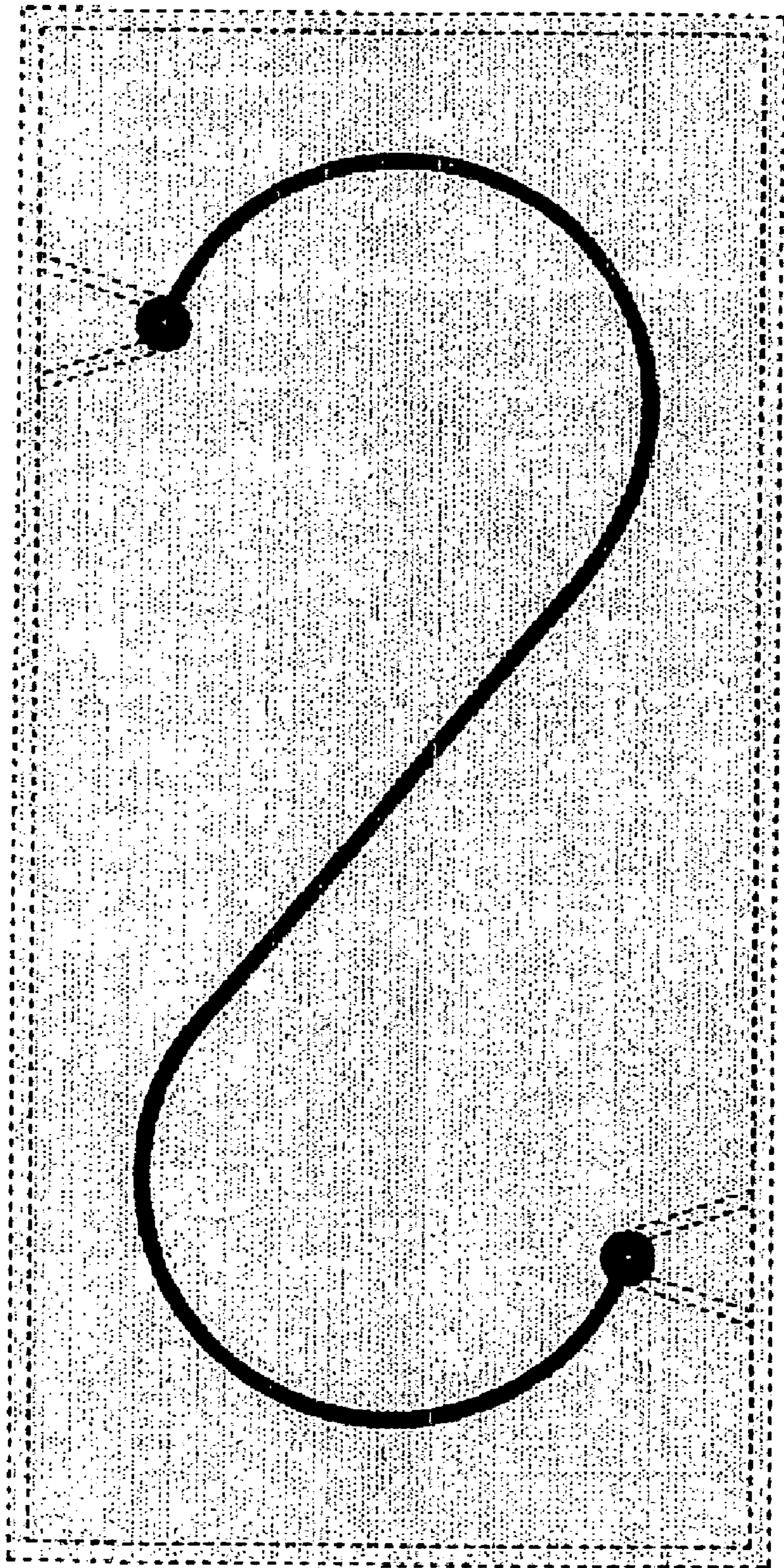
