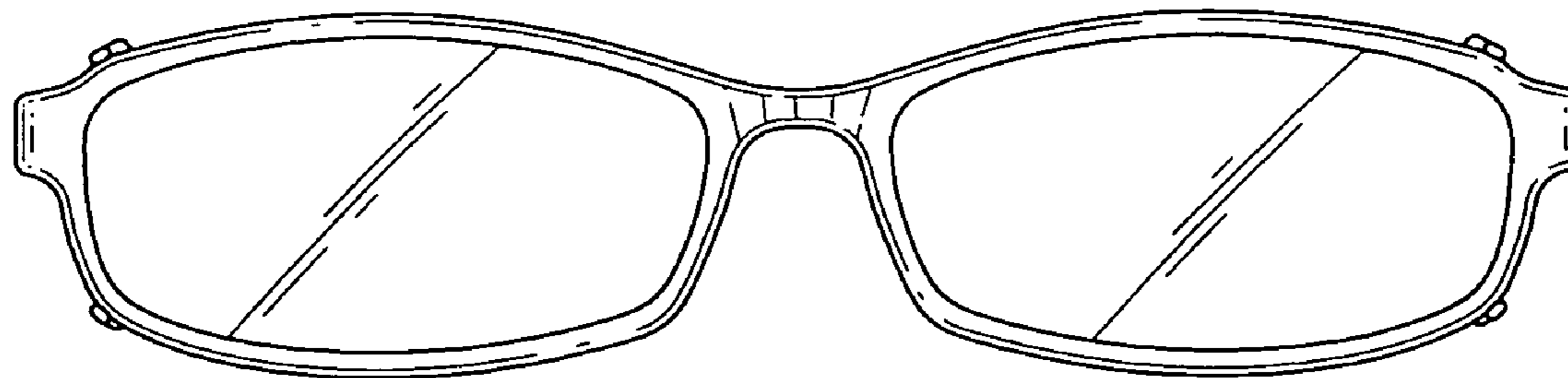
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of an embodiment of eyewear showing my new design;

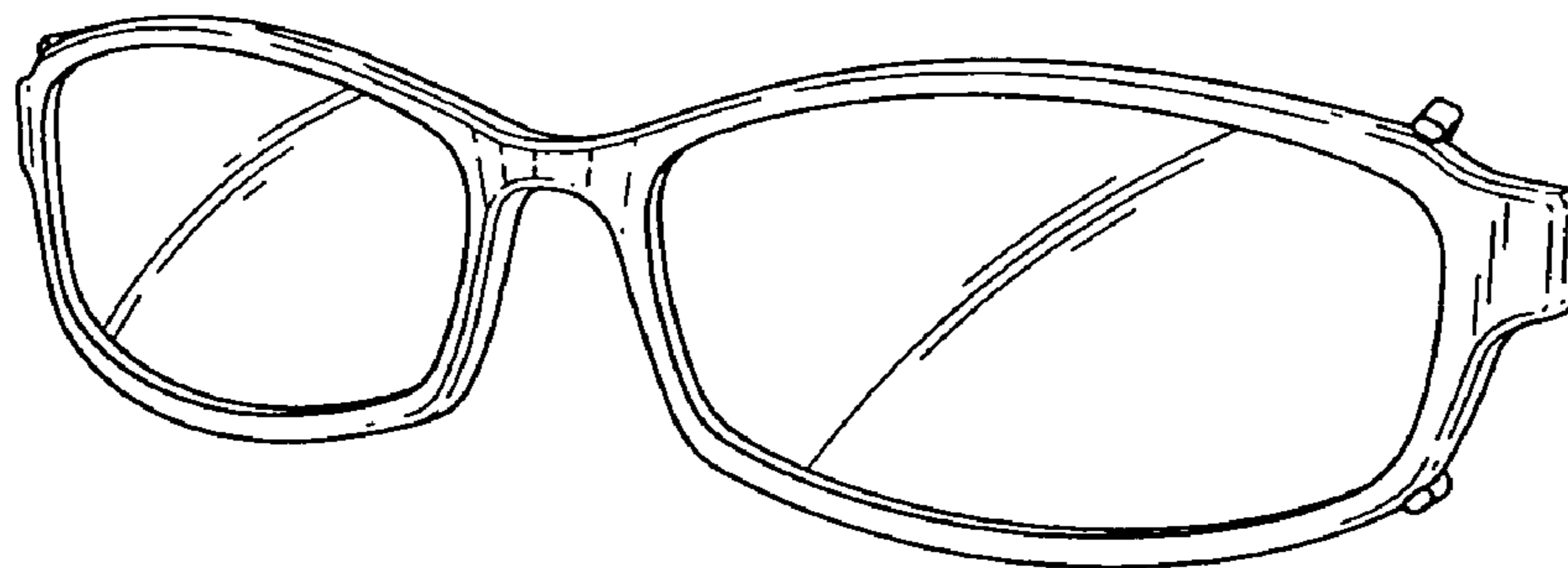

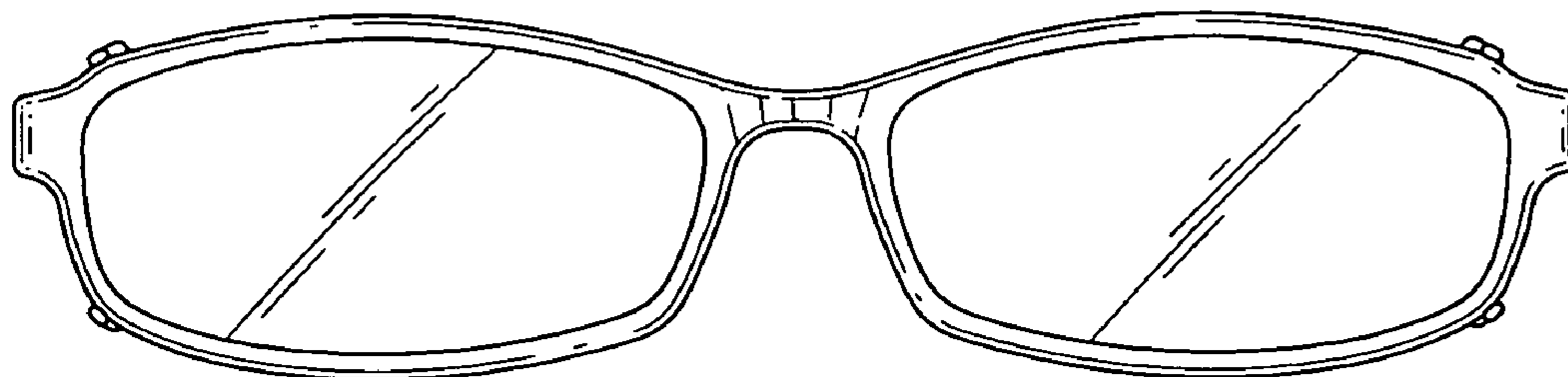

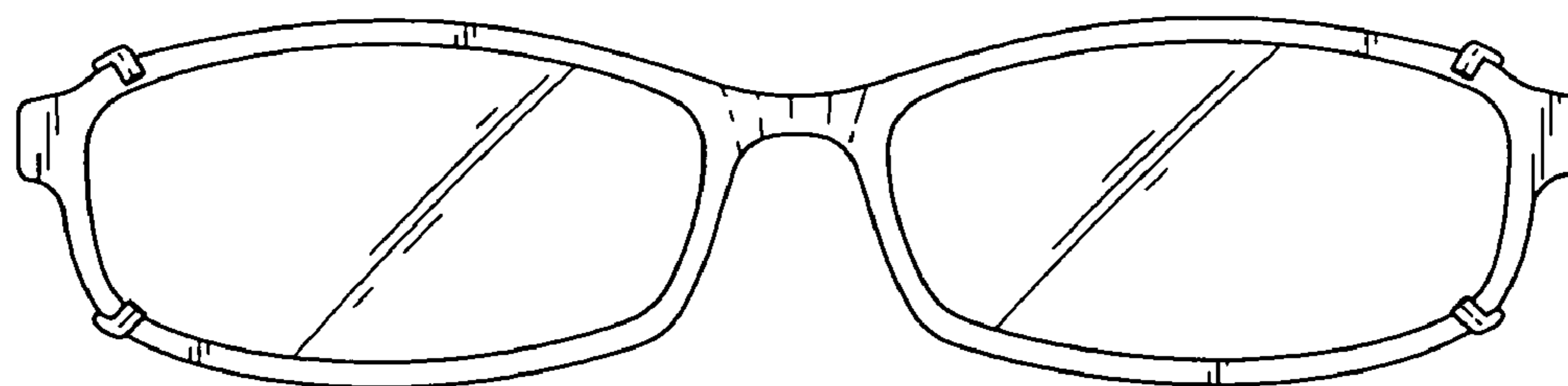
