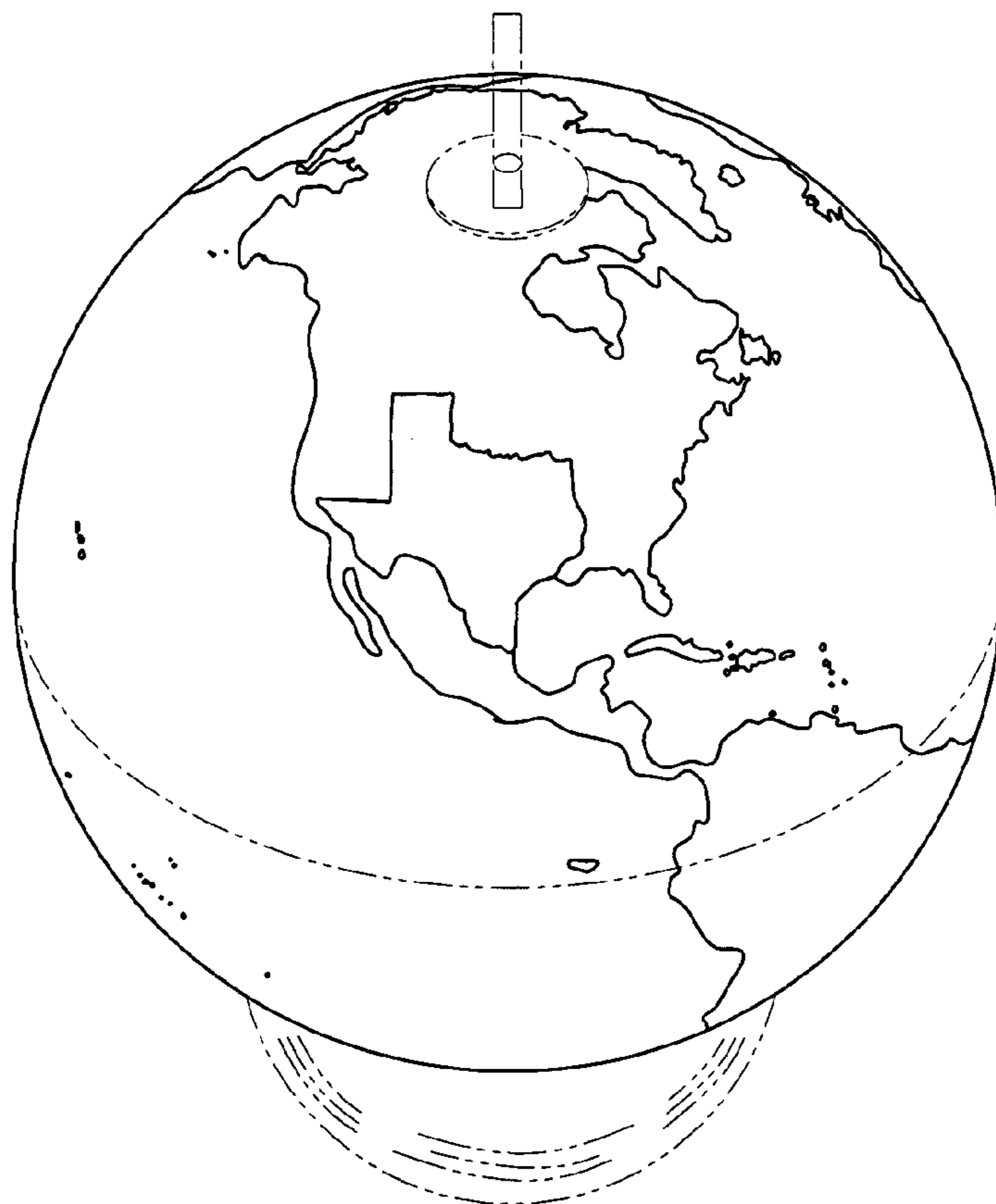
FIG. 5 is a right side-facing view thereof;

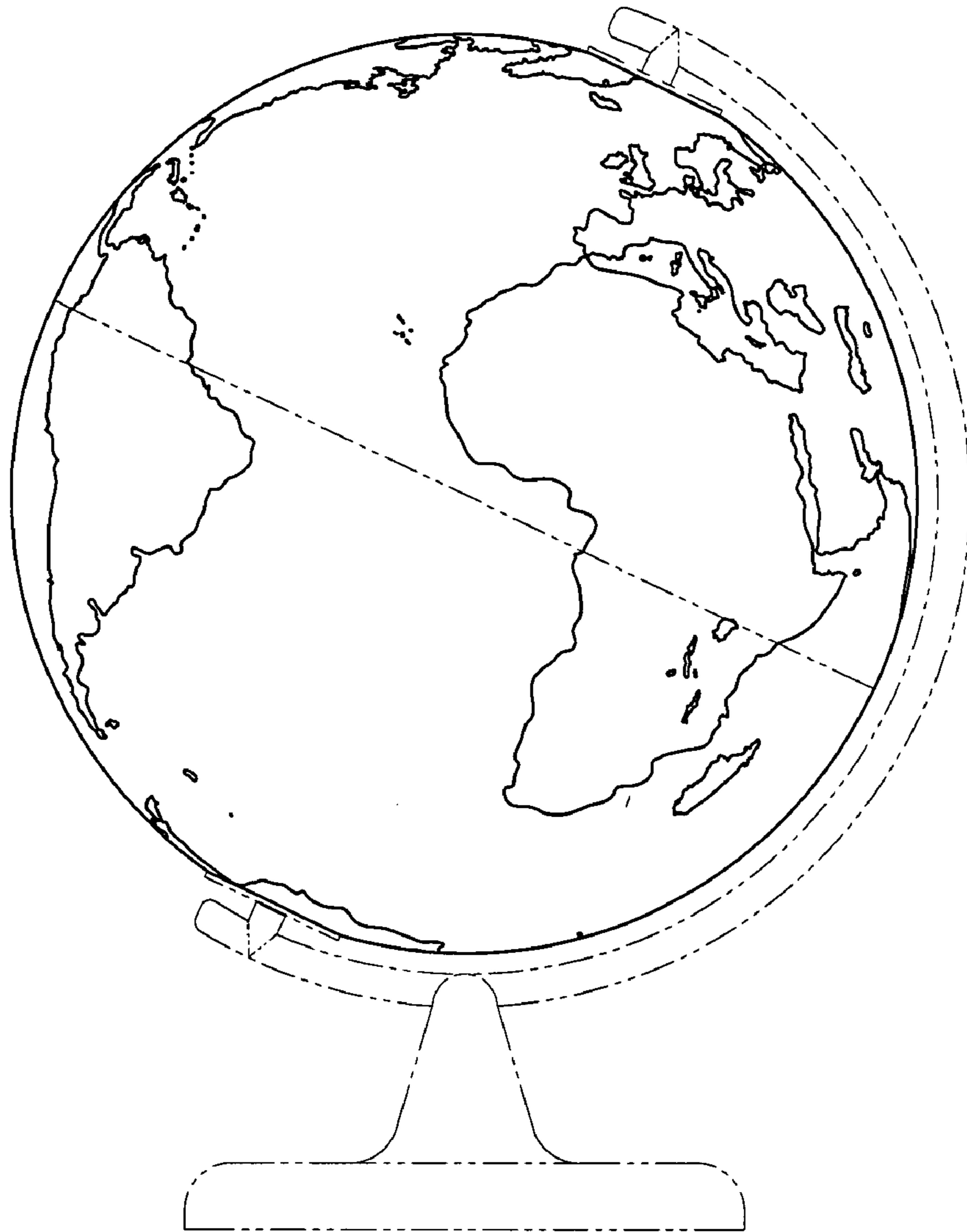

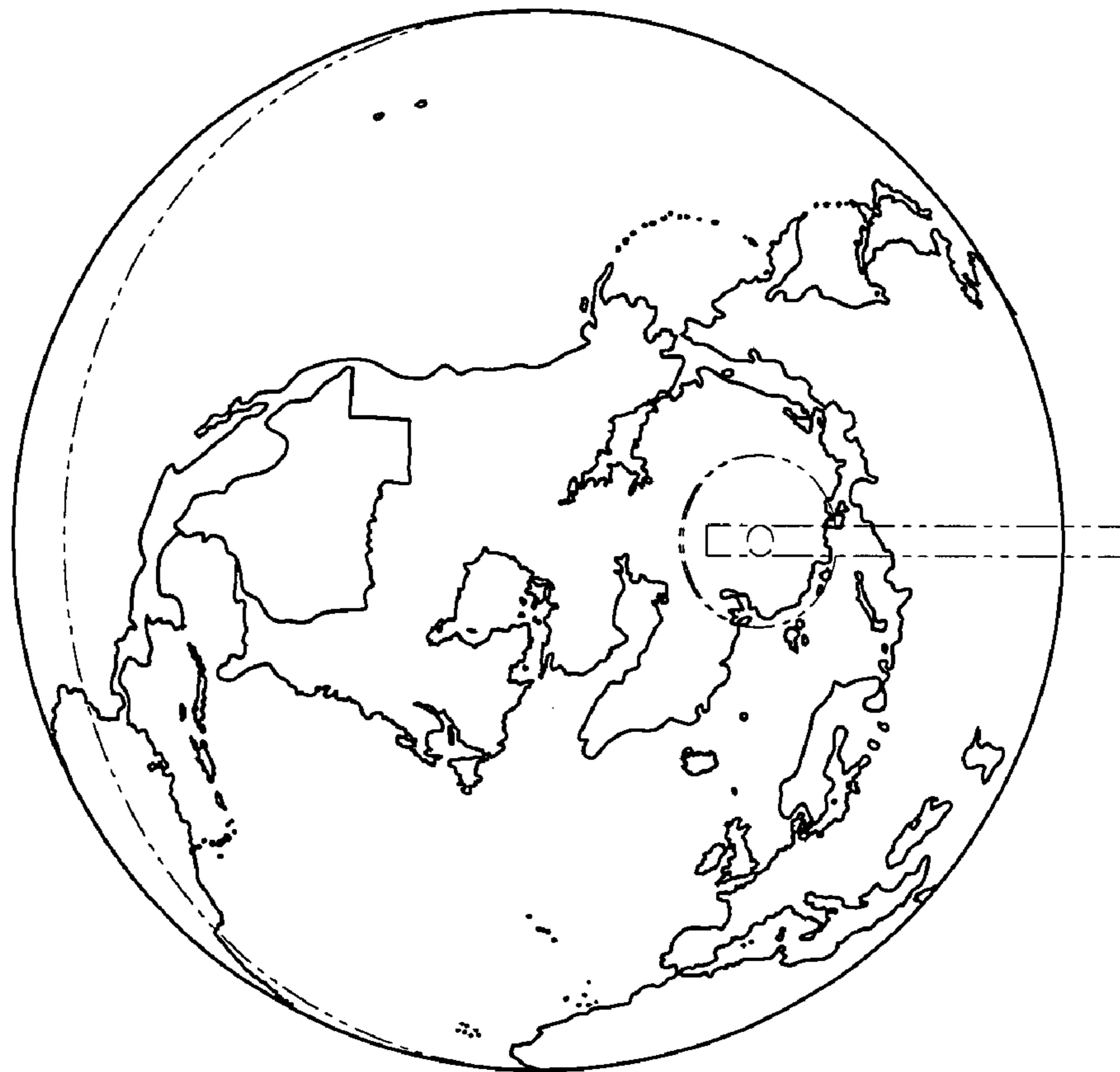

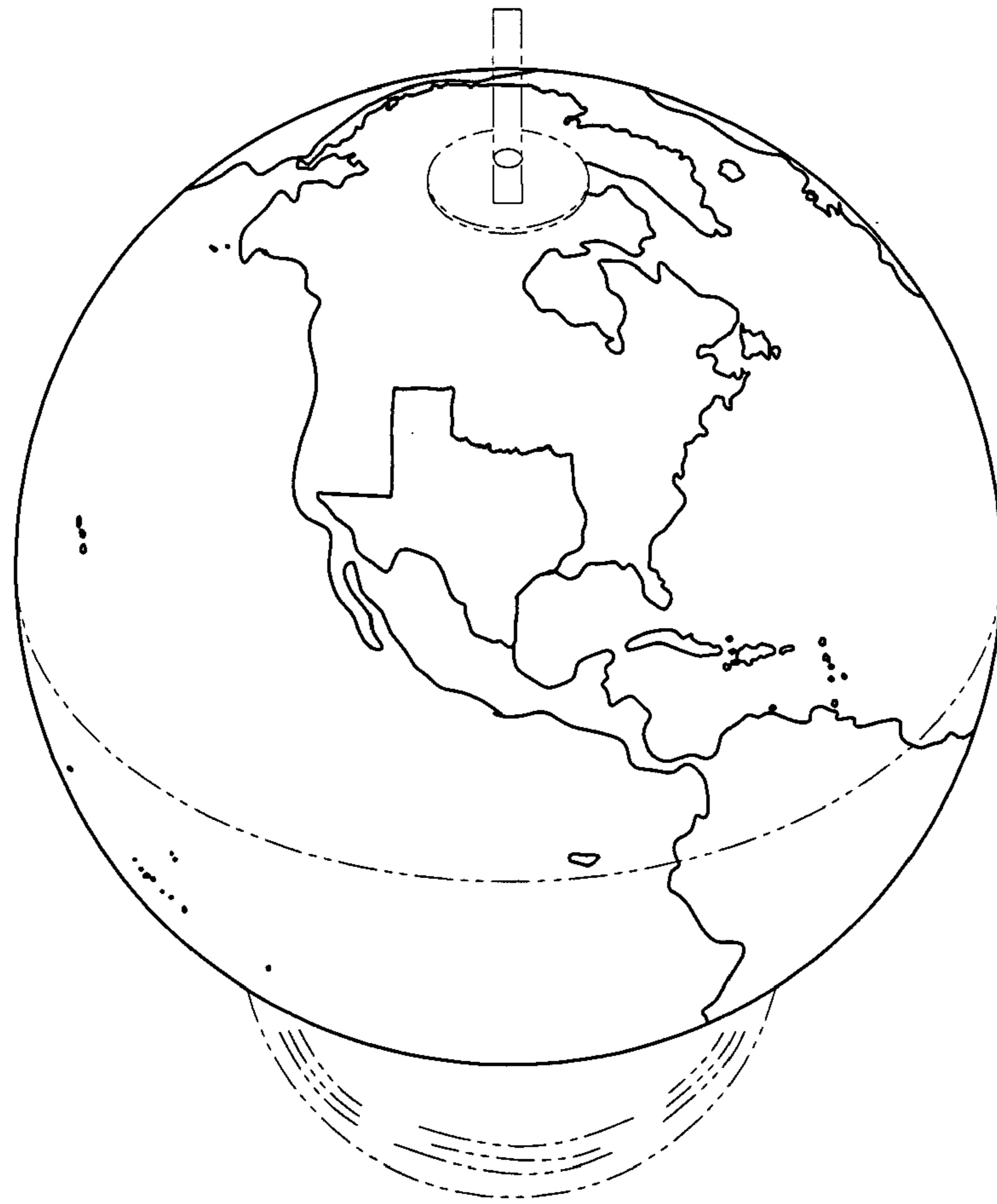

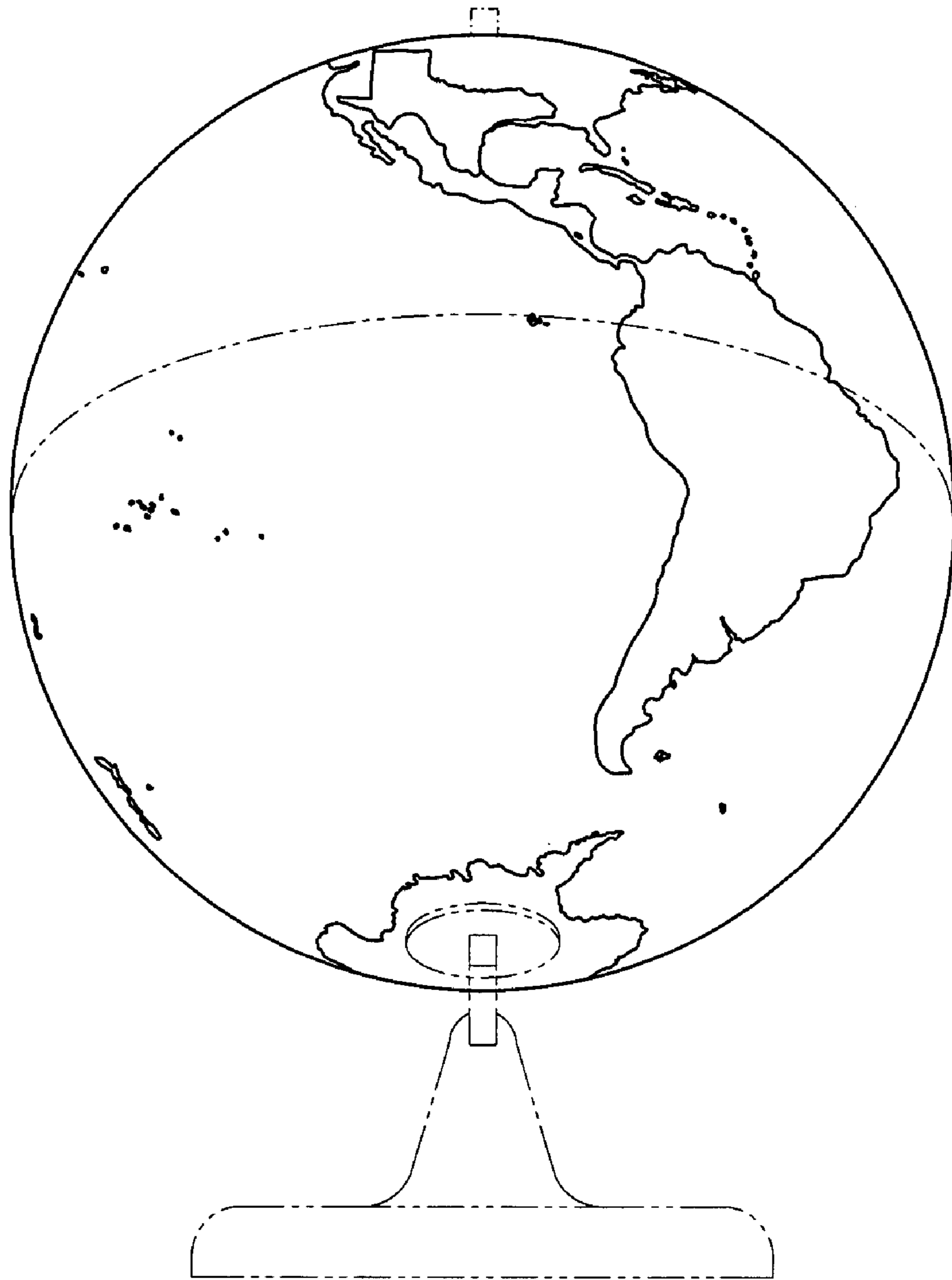

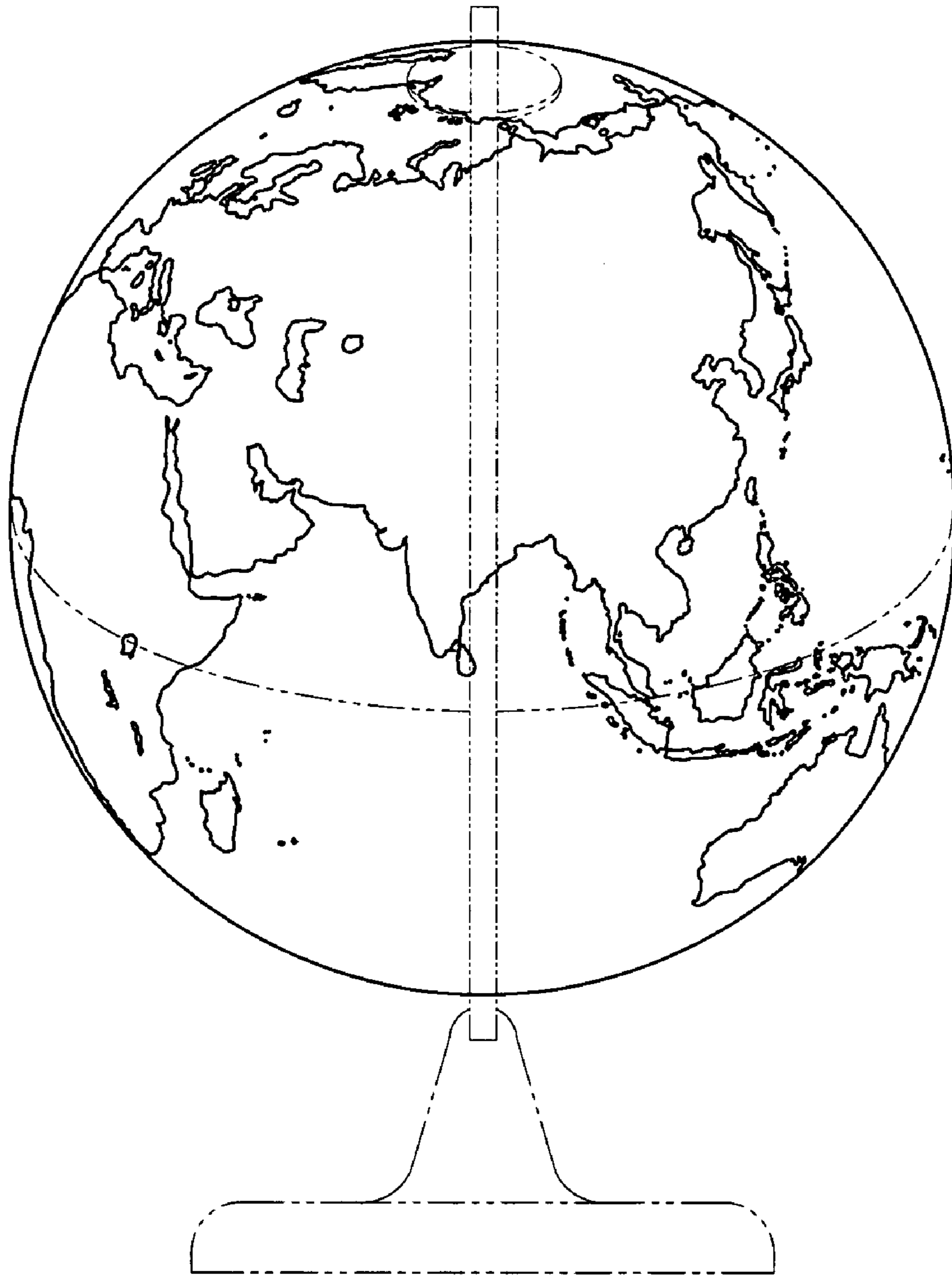

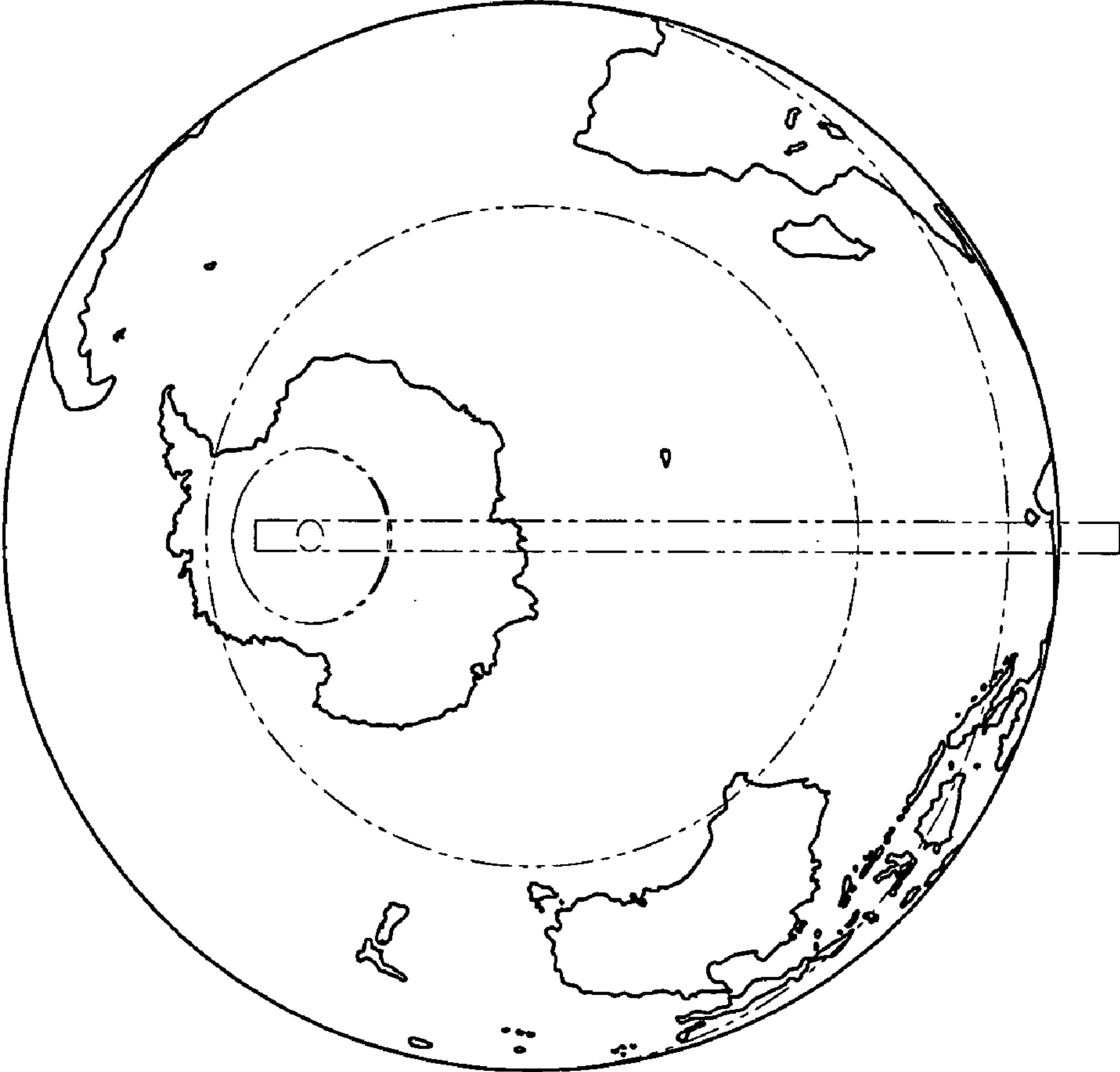

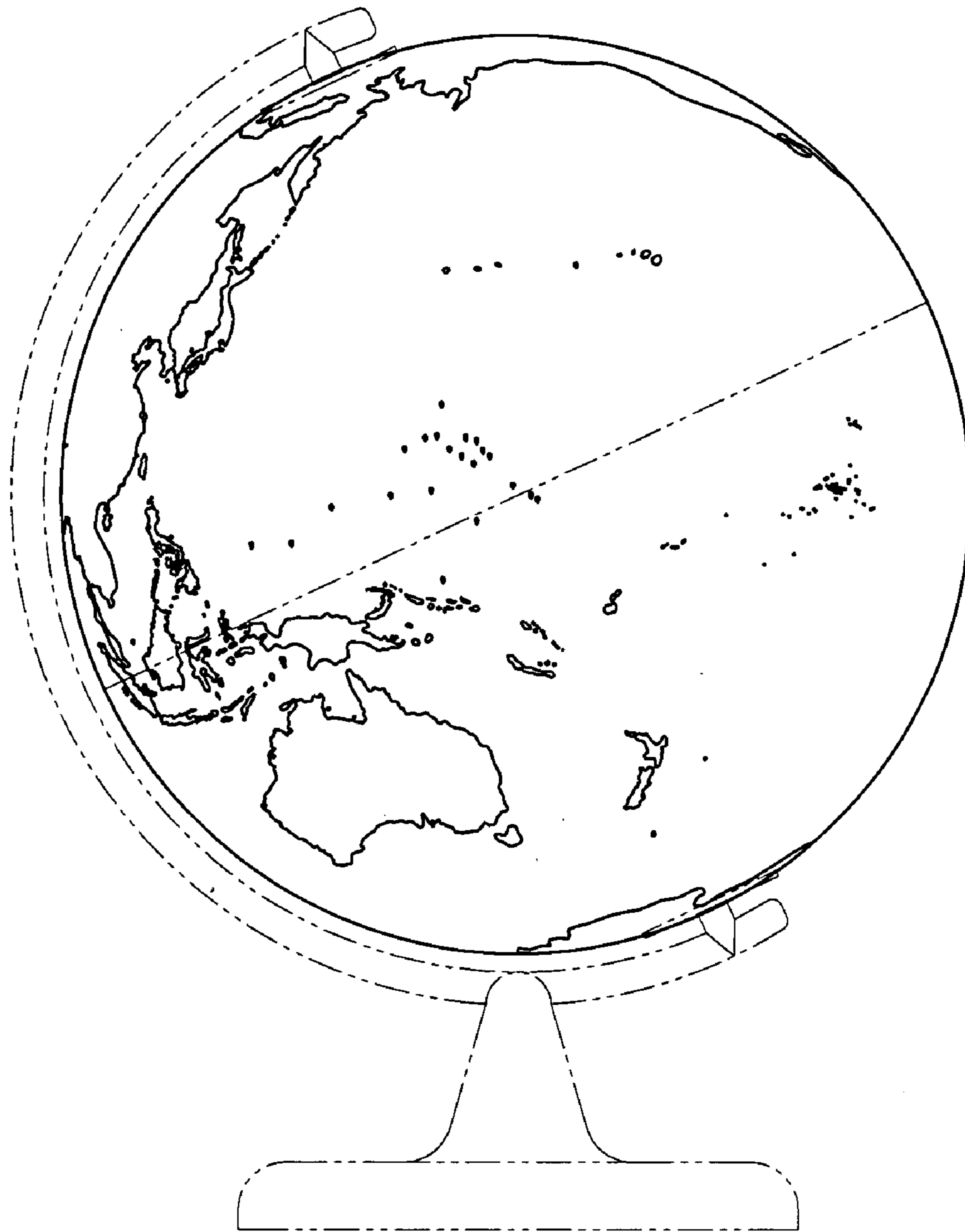
