(57) **CLAIM**

I claim, the ornamental design for an LED open sign with a neon appearance, as shown and described.

DESCRIPTION

This invention is intended for use as an "open sign" and can be used in both outdoor and indoor applications.

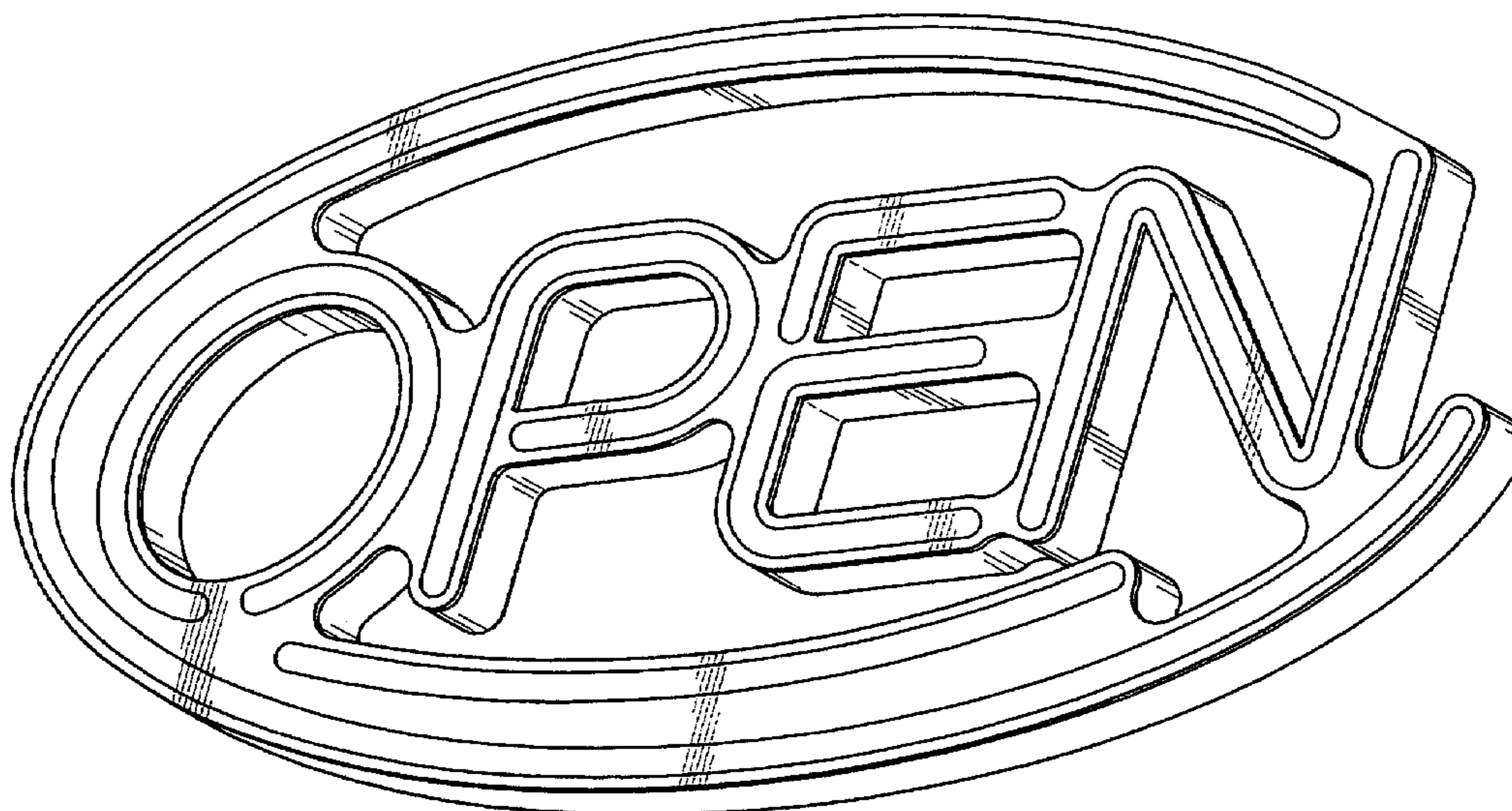
FIG. 1 is a perspective view of a LED open sign with a neon appearance.

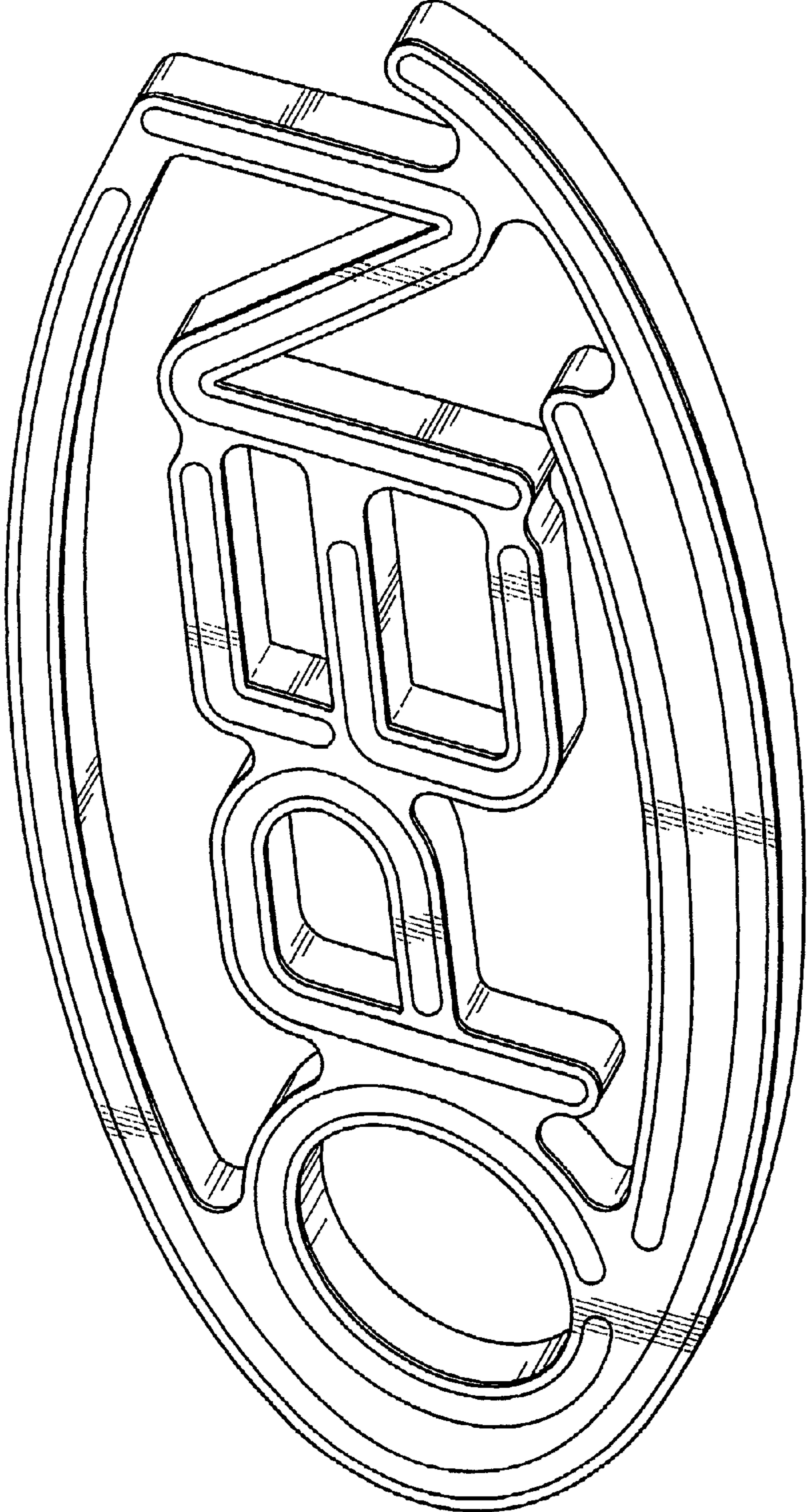

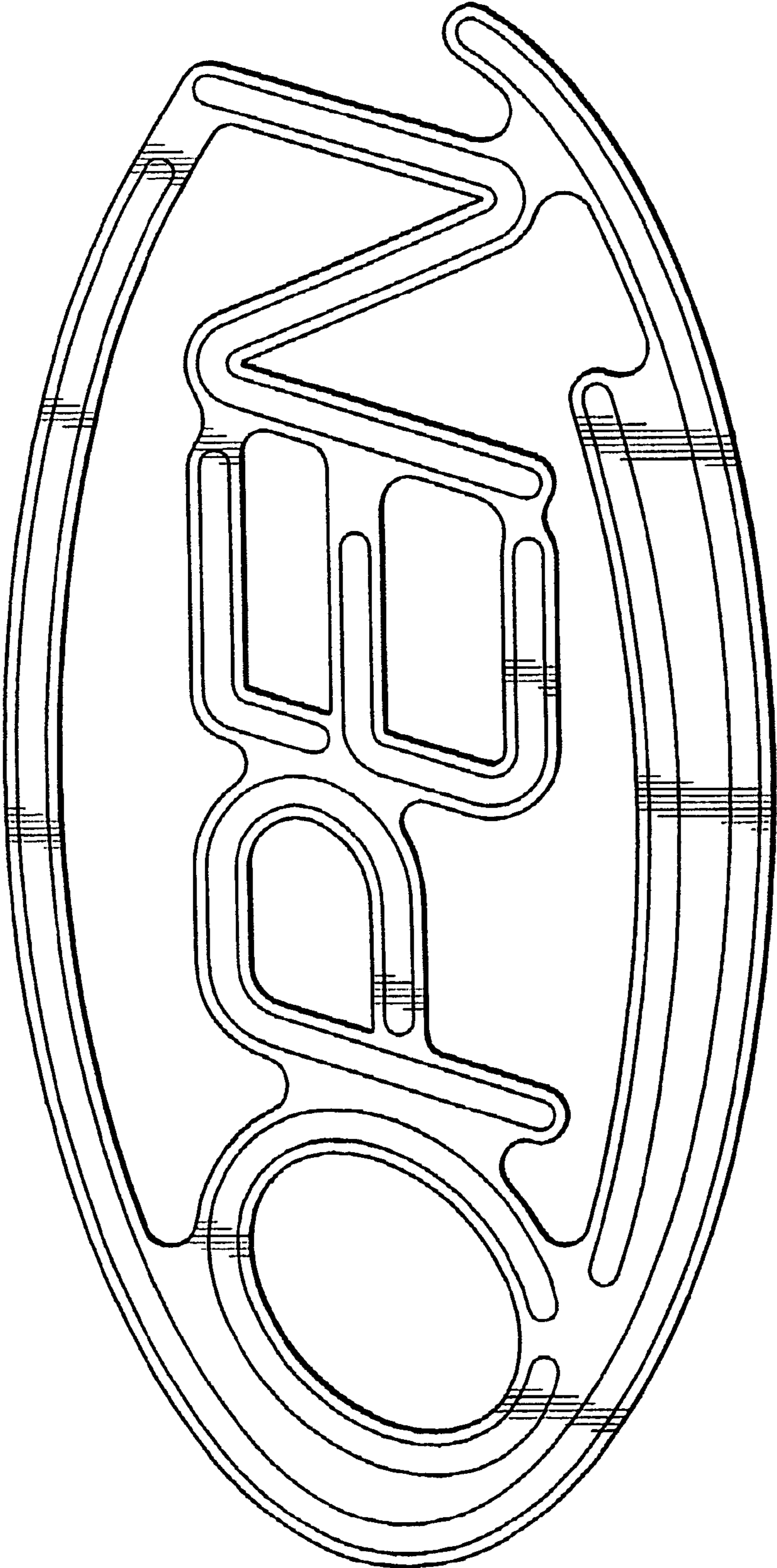

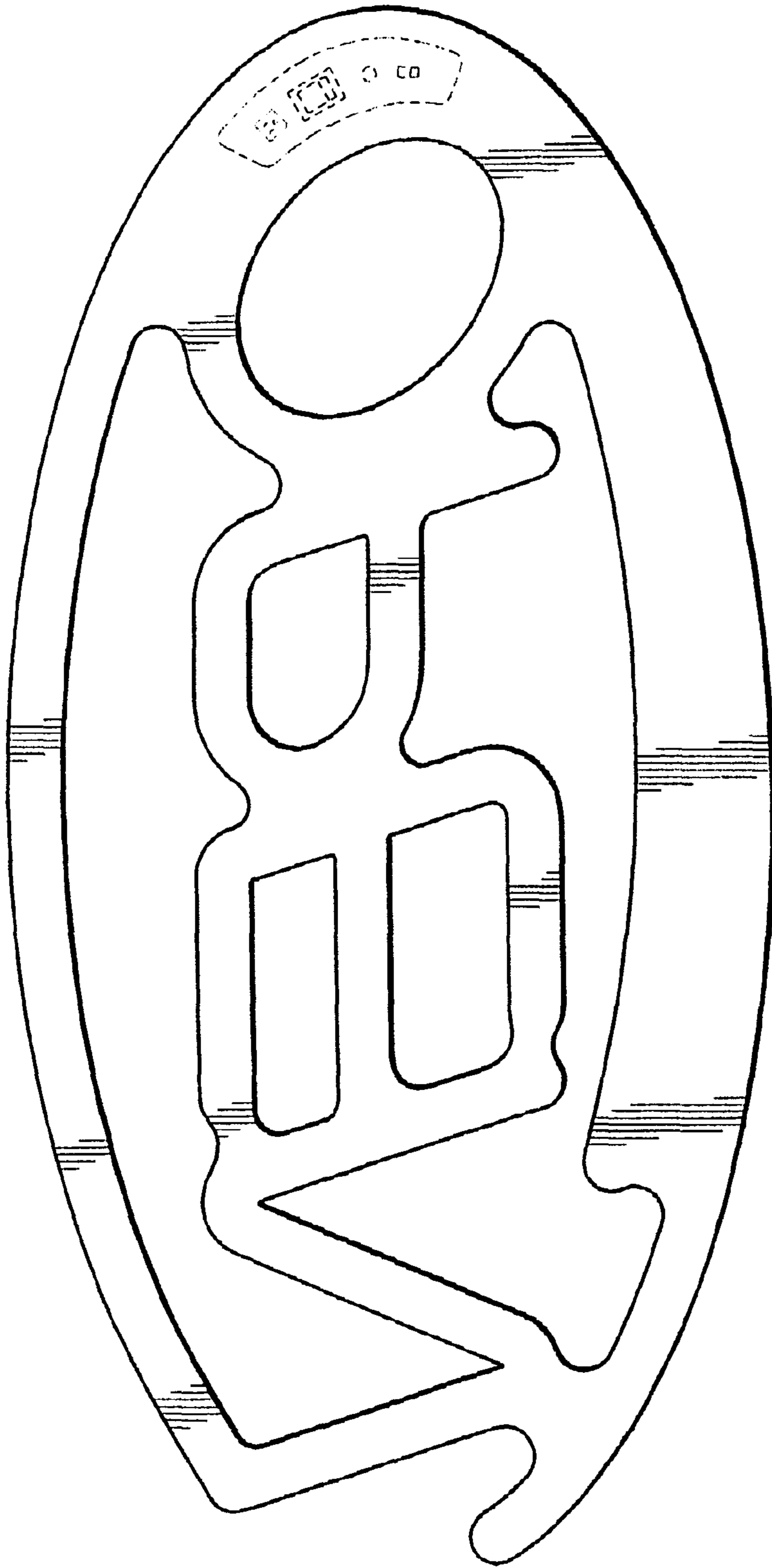

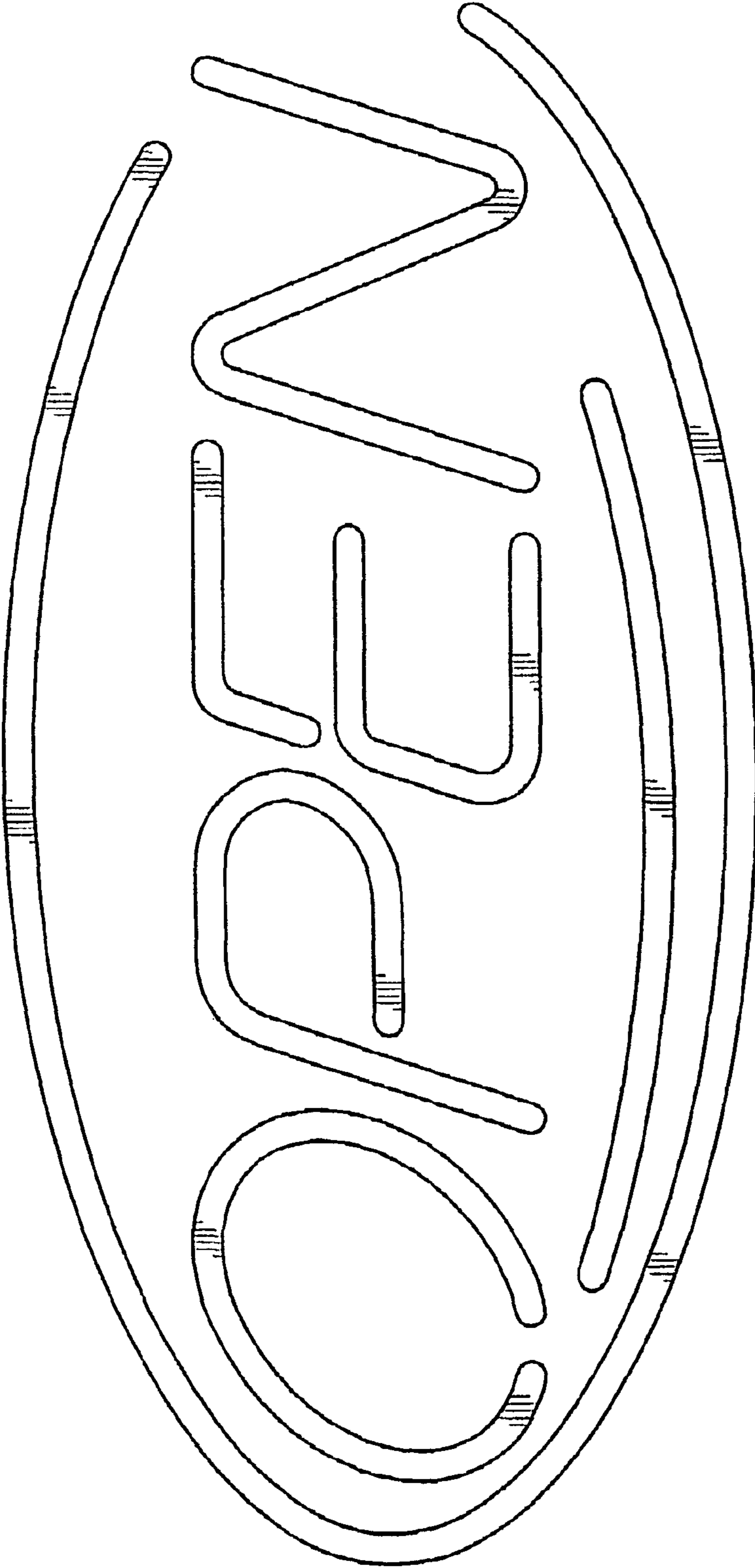
