The ornamental design for a martial art training mat, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a martial art training mat showing our new design;

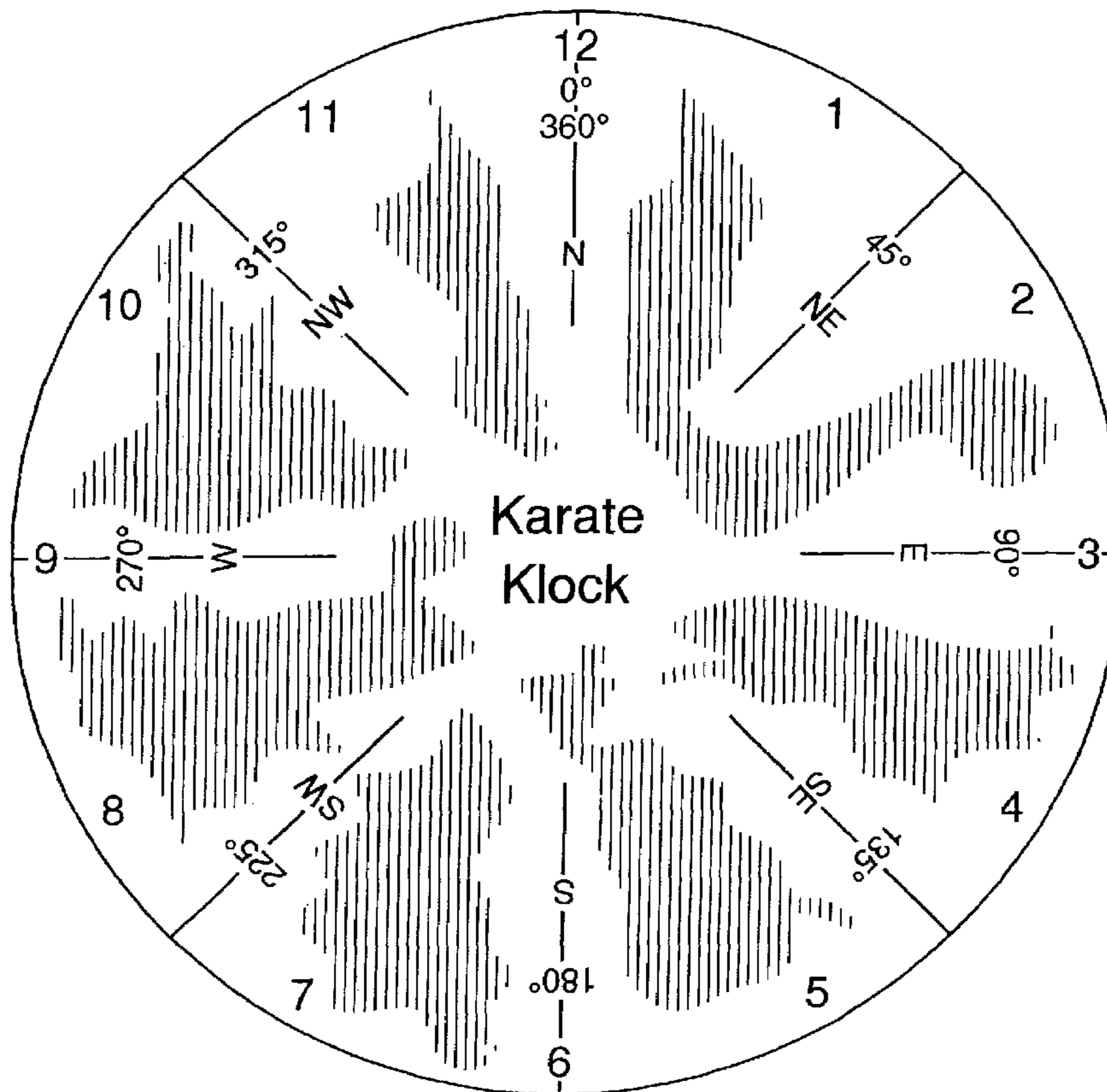
FIG. 2 is a bottom plan view thereof;

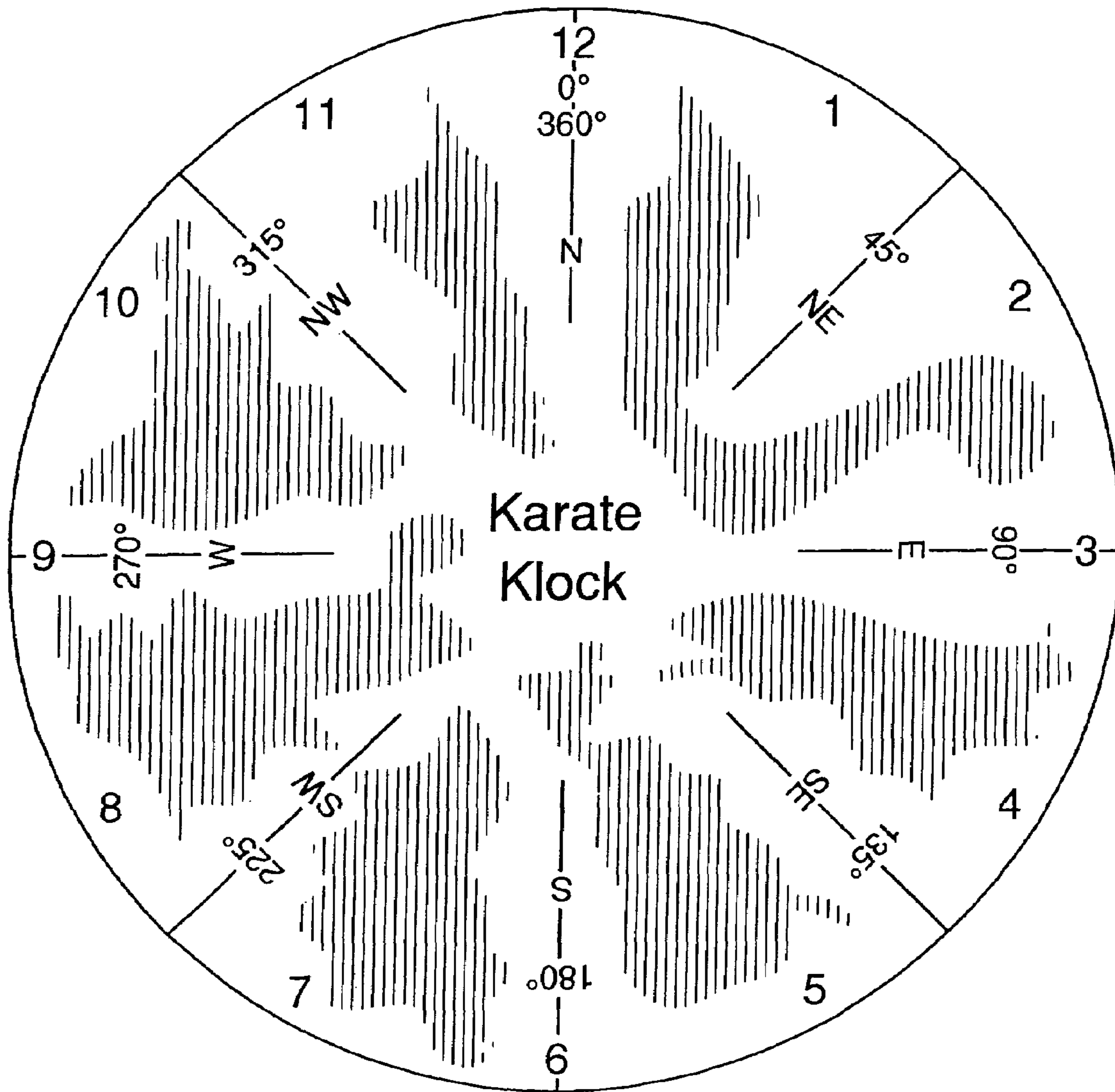

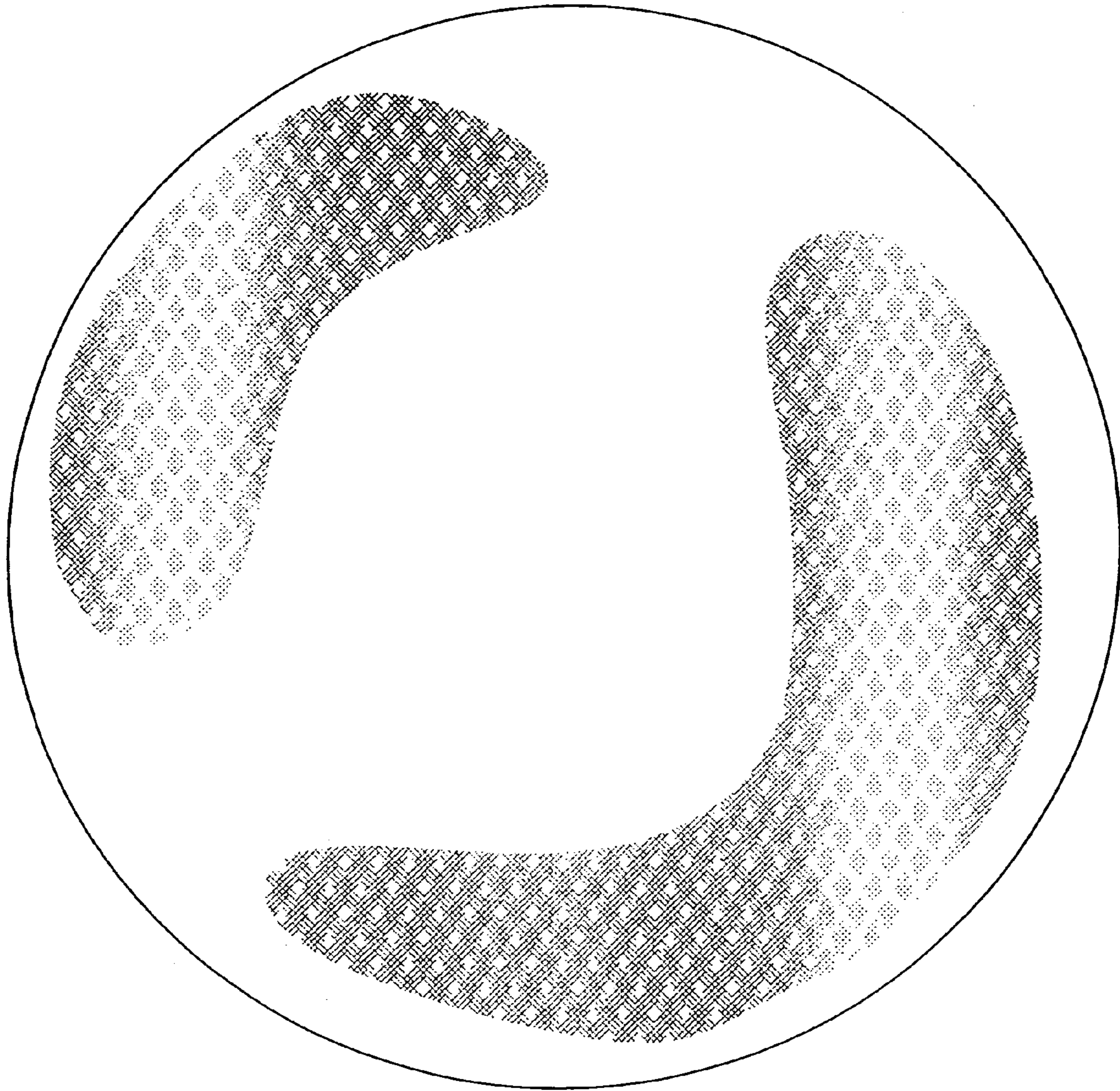

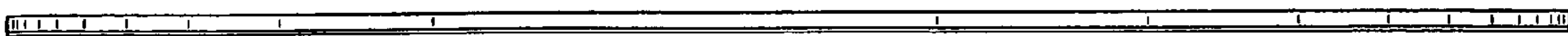

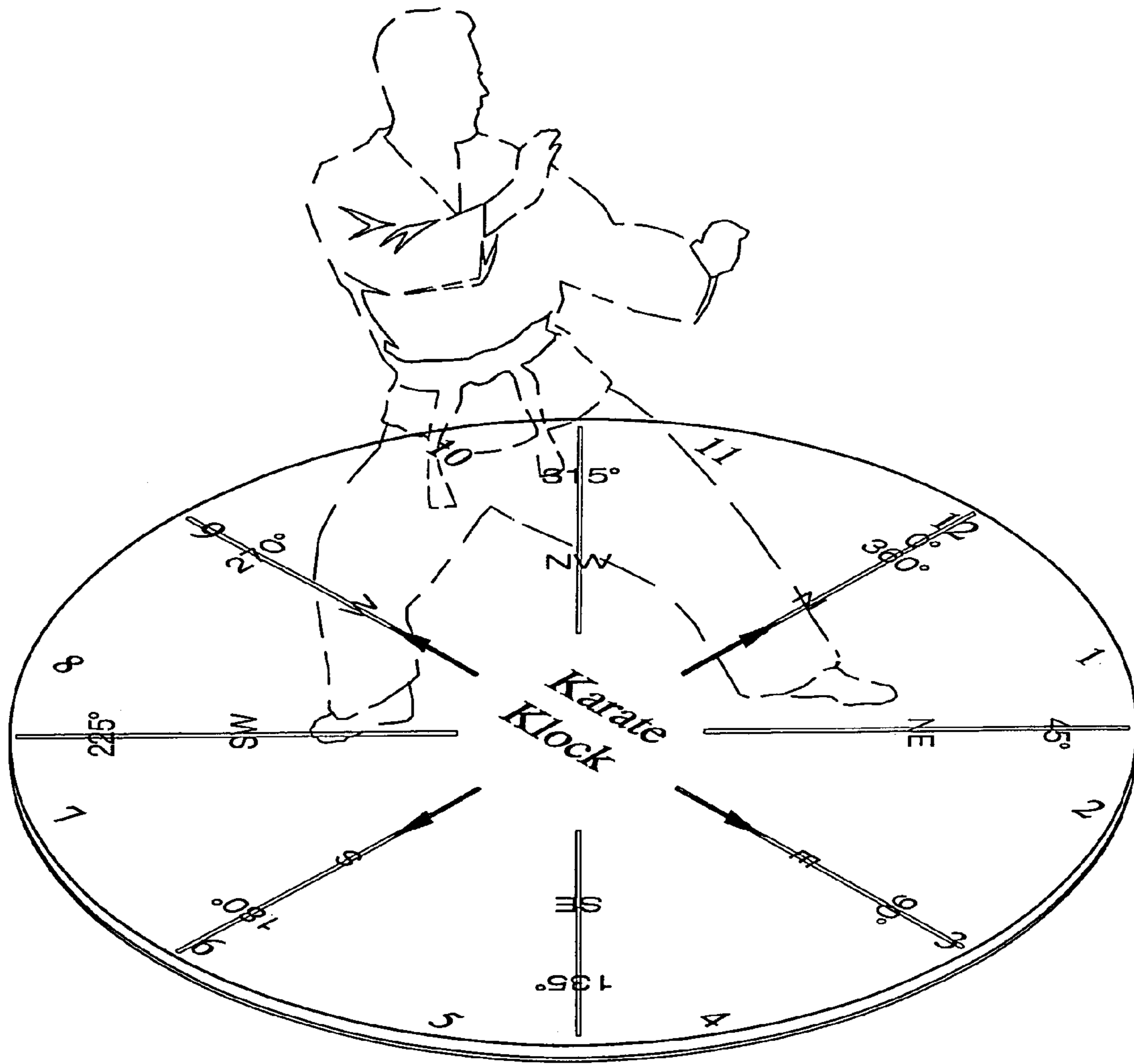
