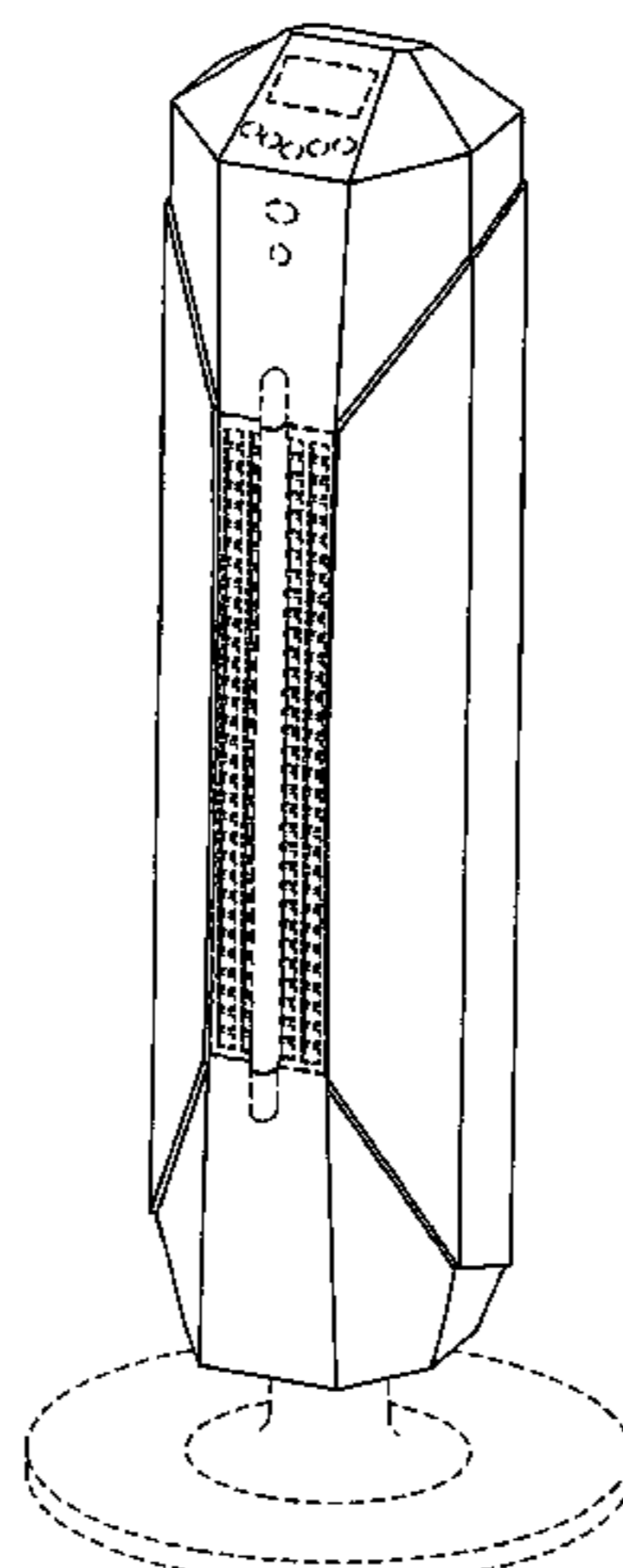
FIG. 7 is a front view of the novel tower heater/fan design of FIG. 1.

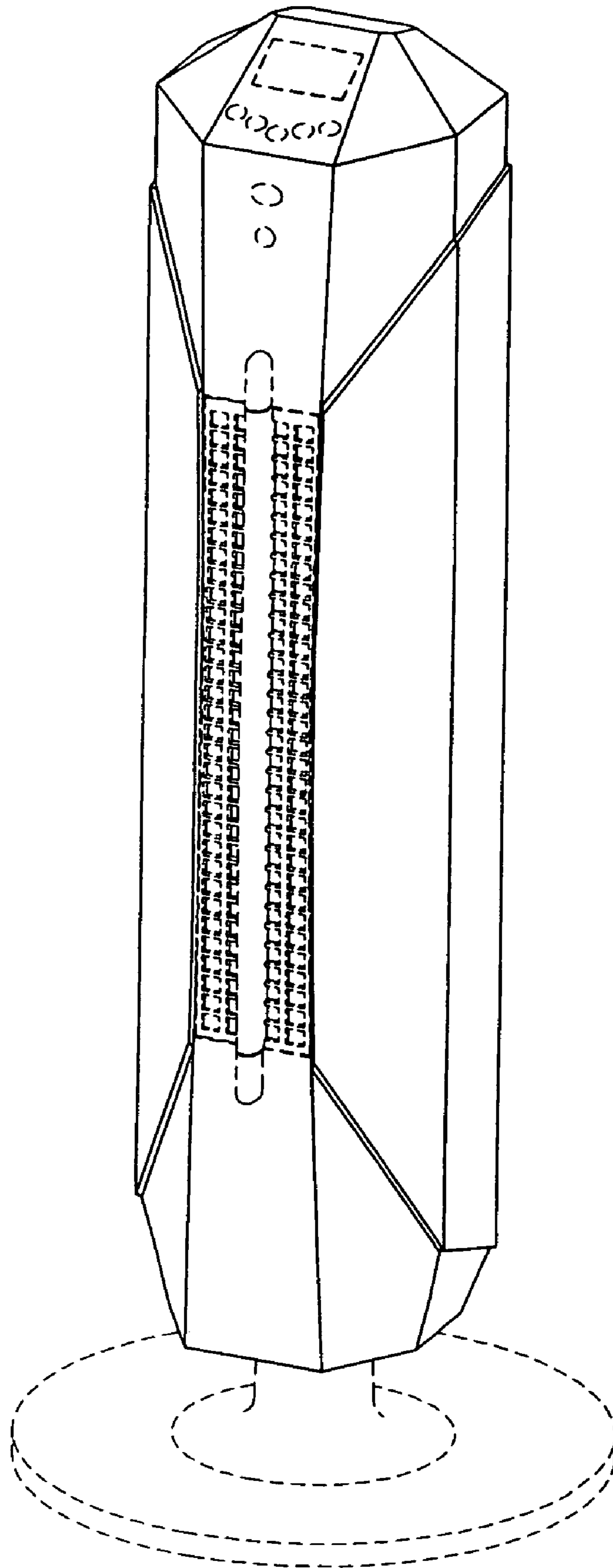

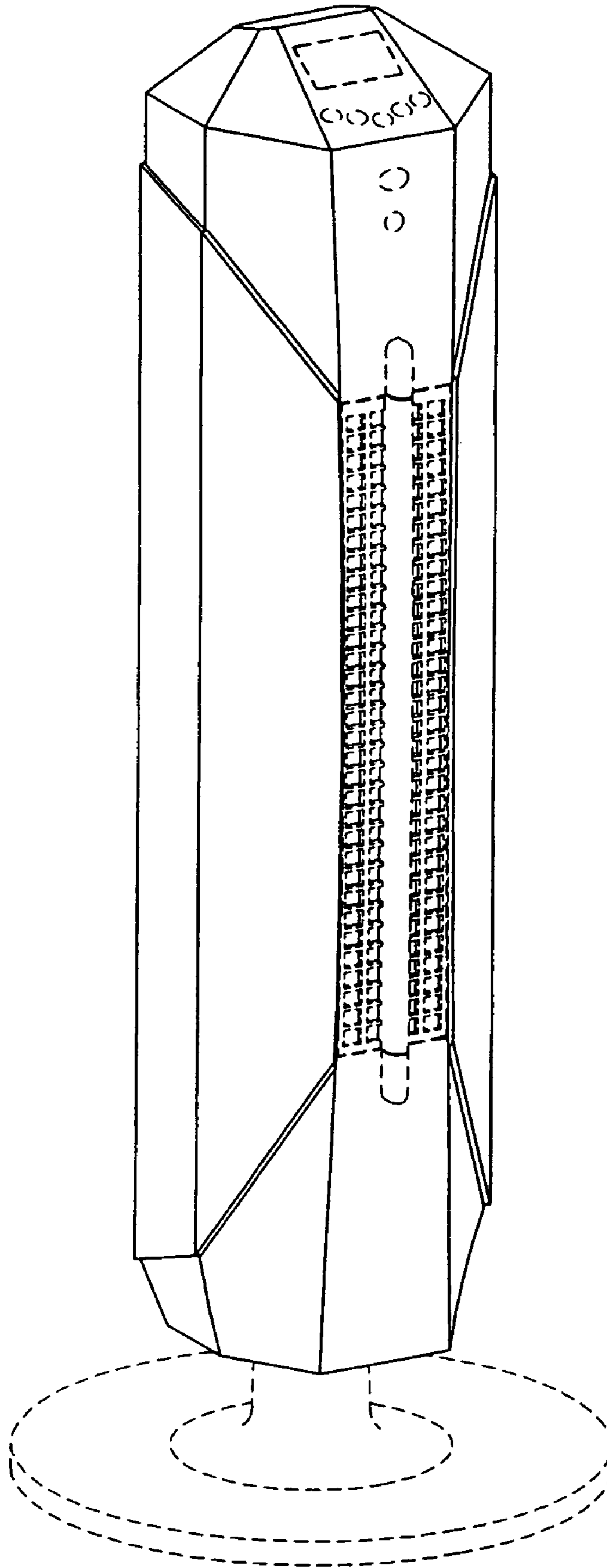

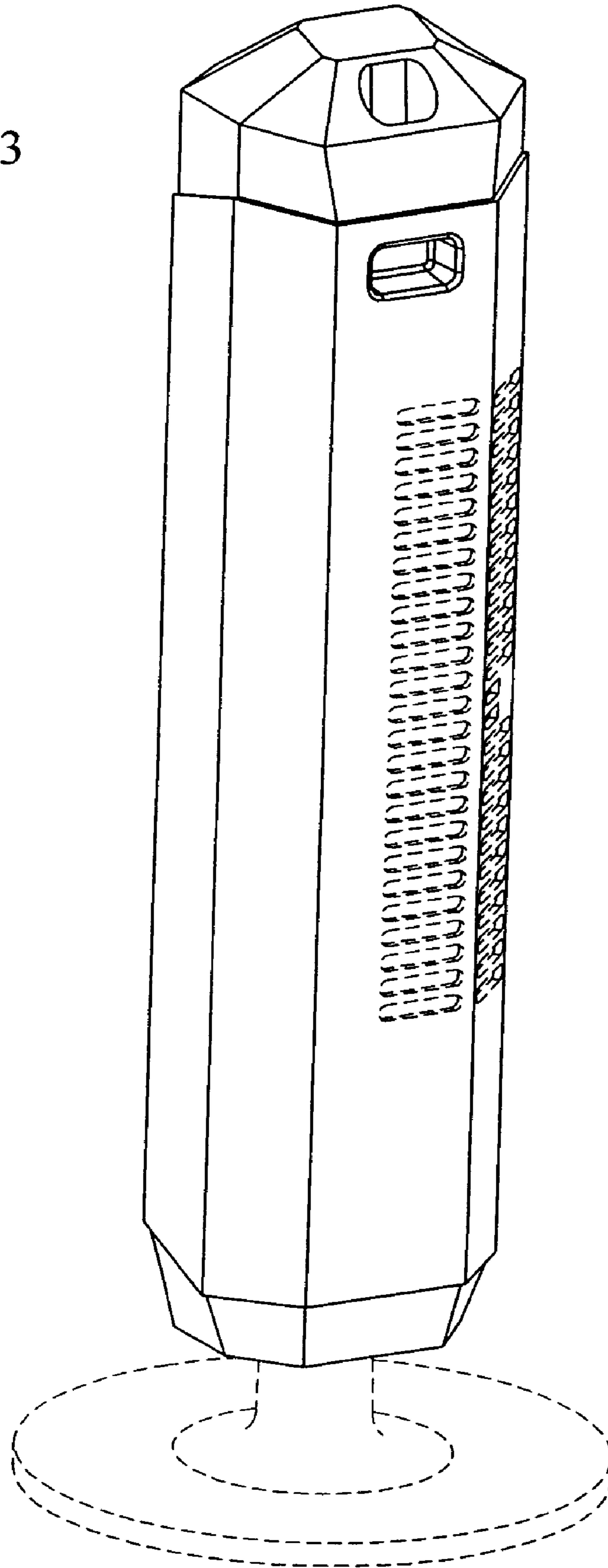

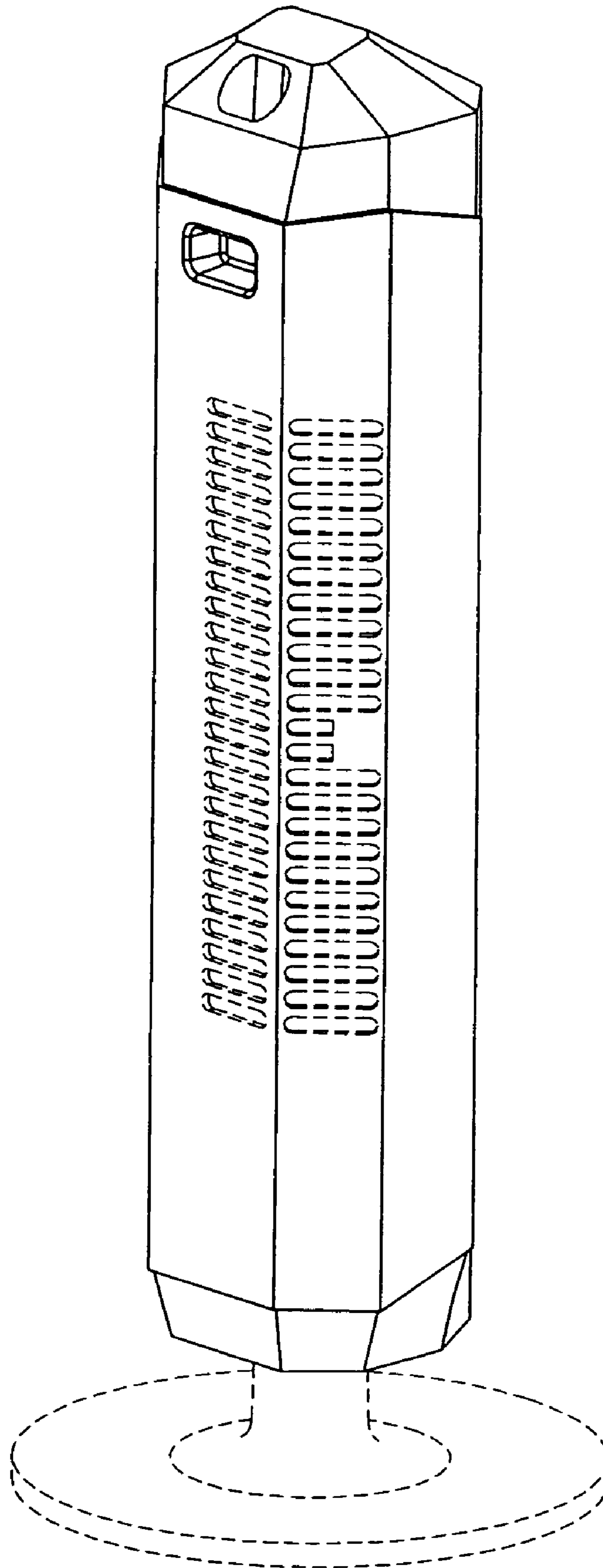

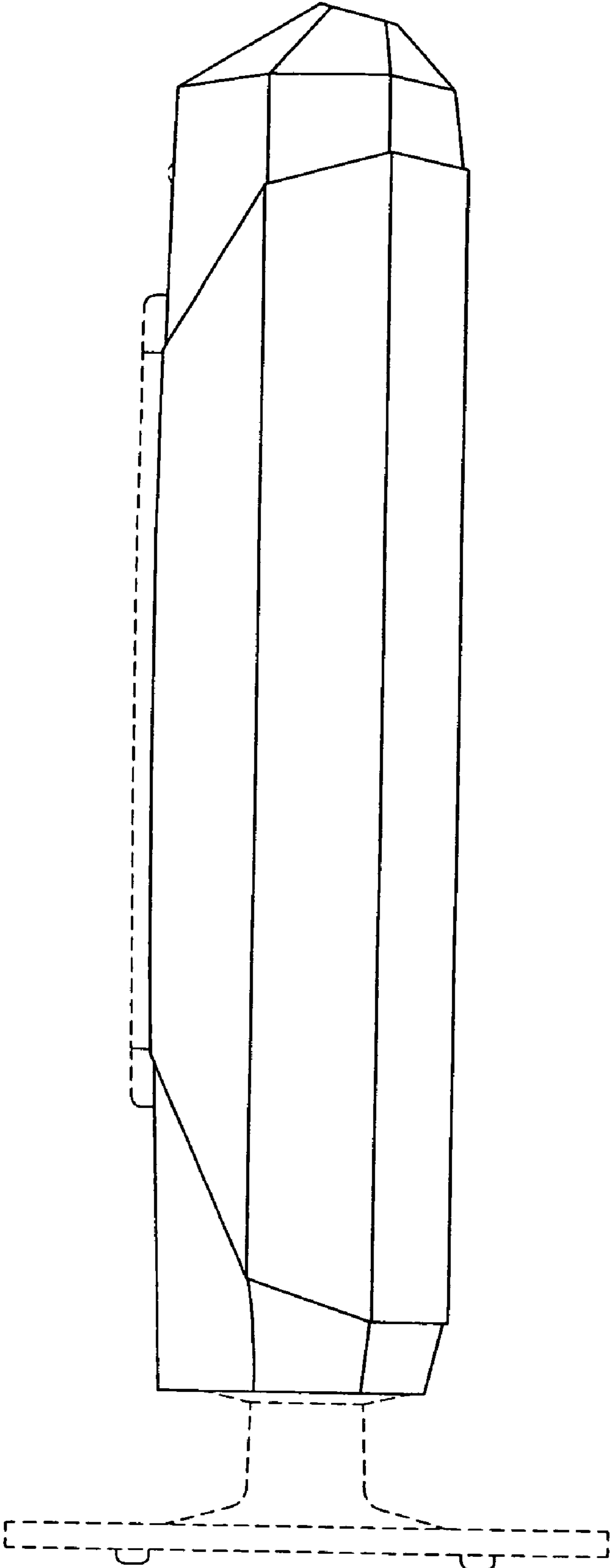

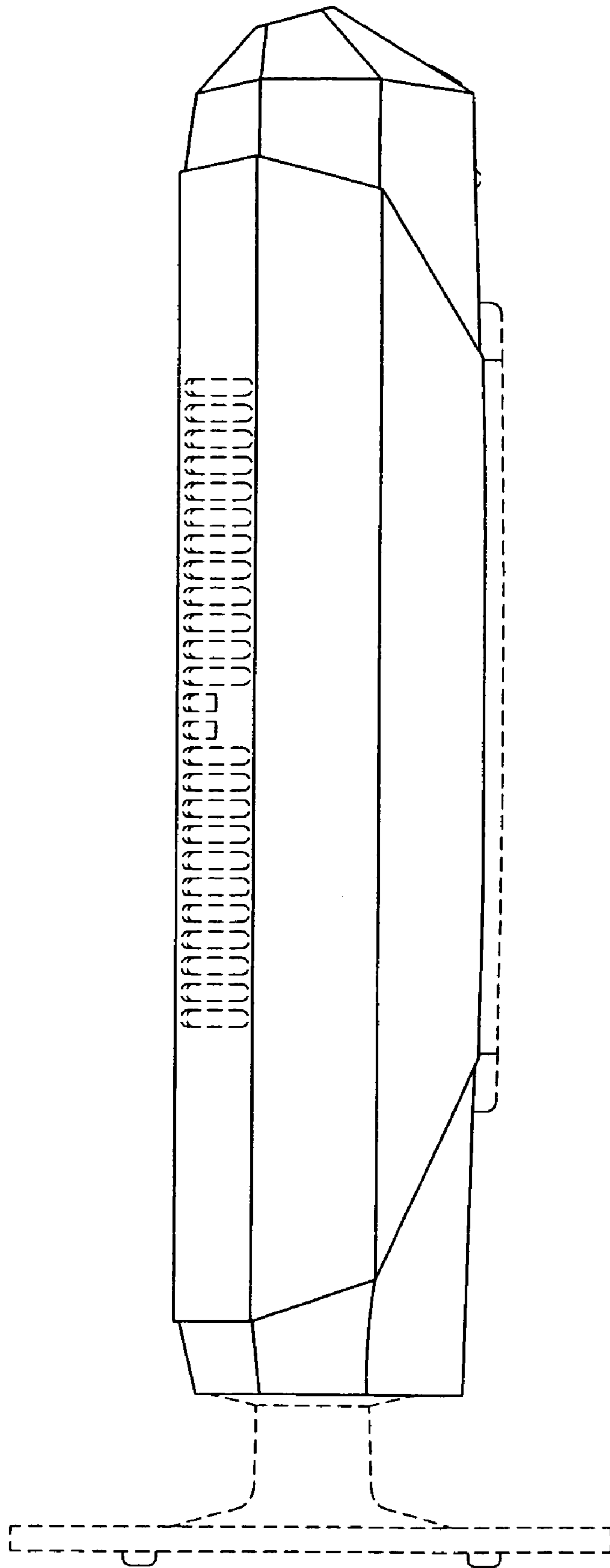

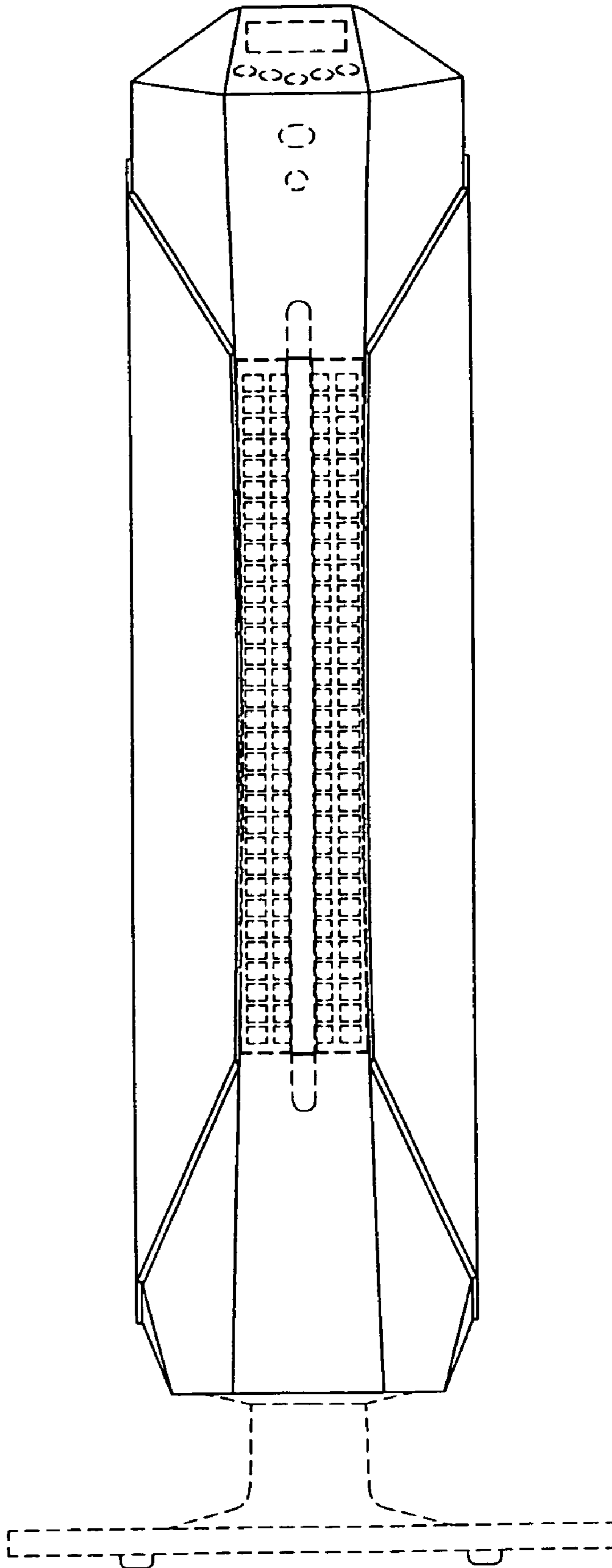

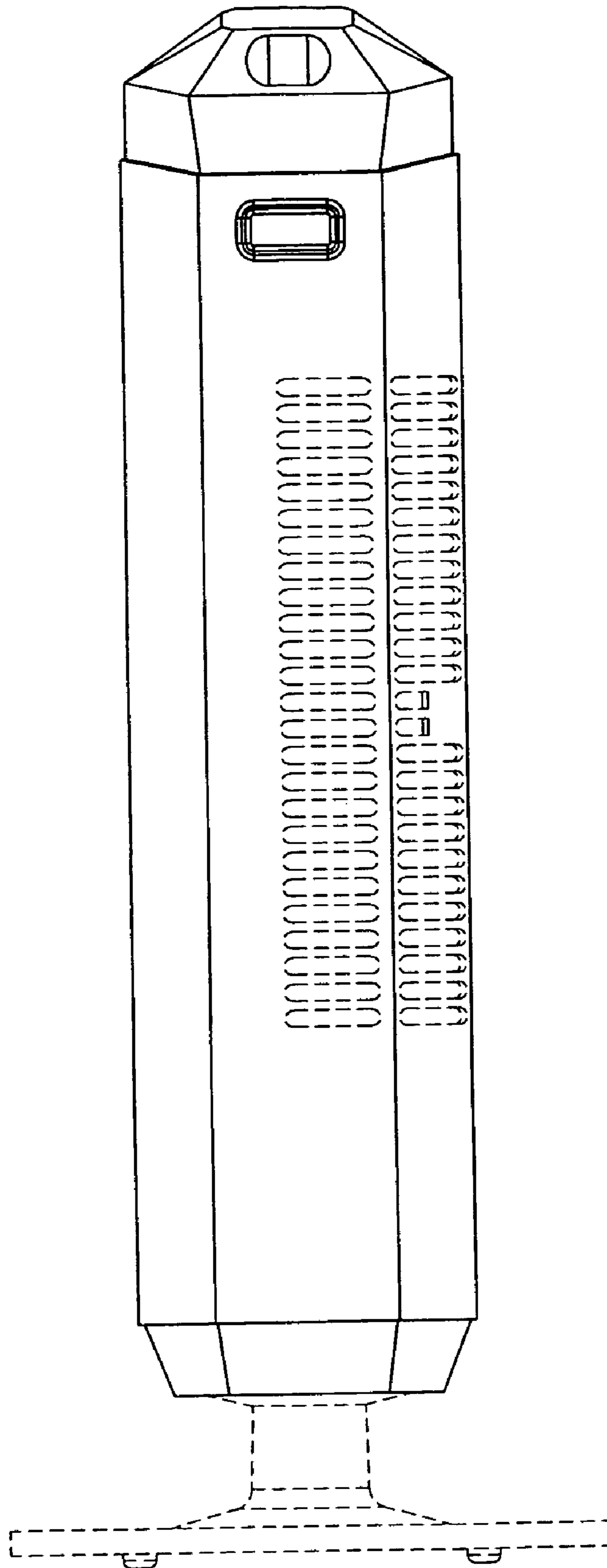
