**DESCRIPTION**

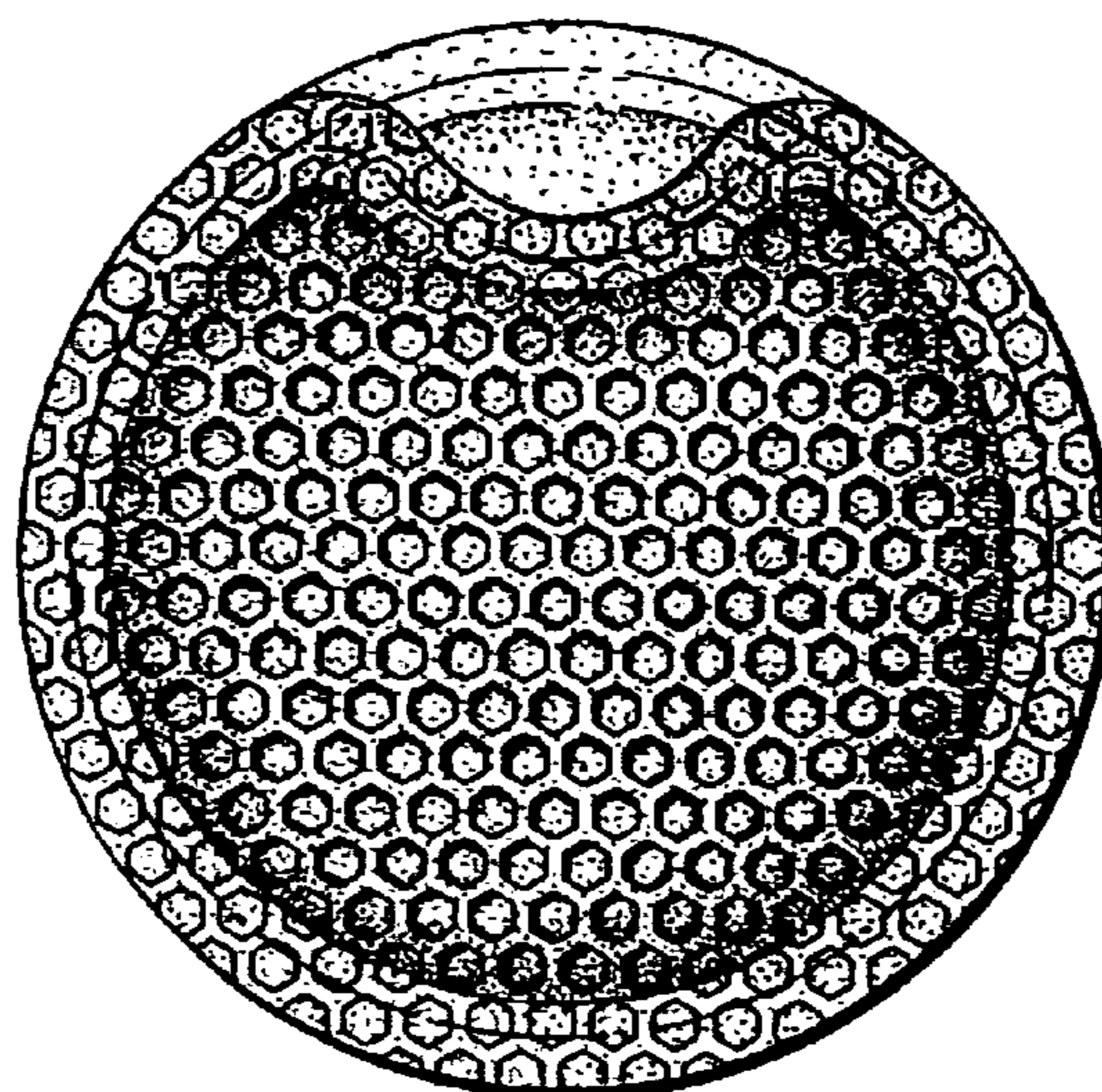
FIG. 1 is a front elevational view of a skin treatment article showing our design.

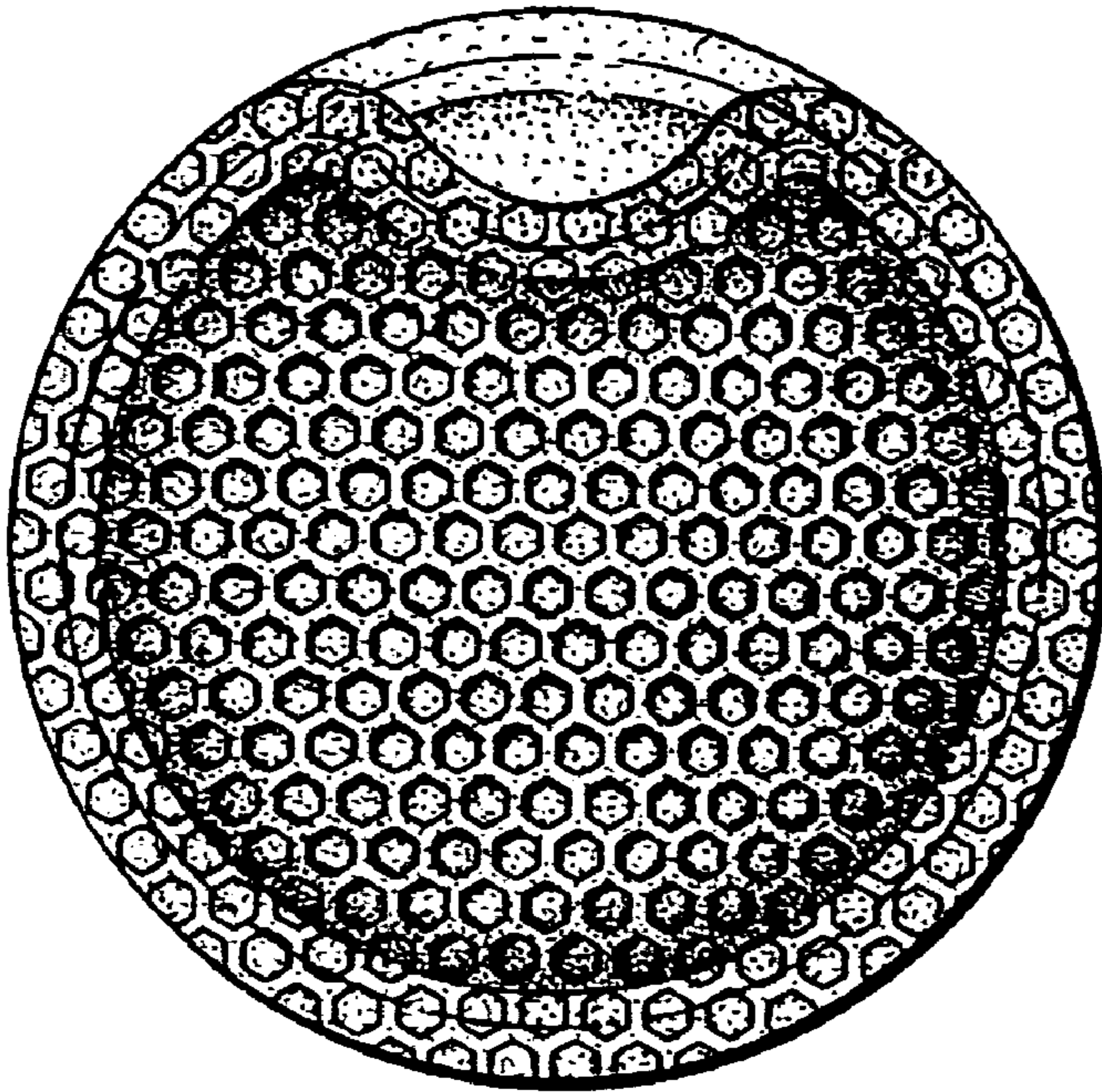
