DESCRIPTION

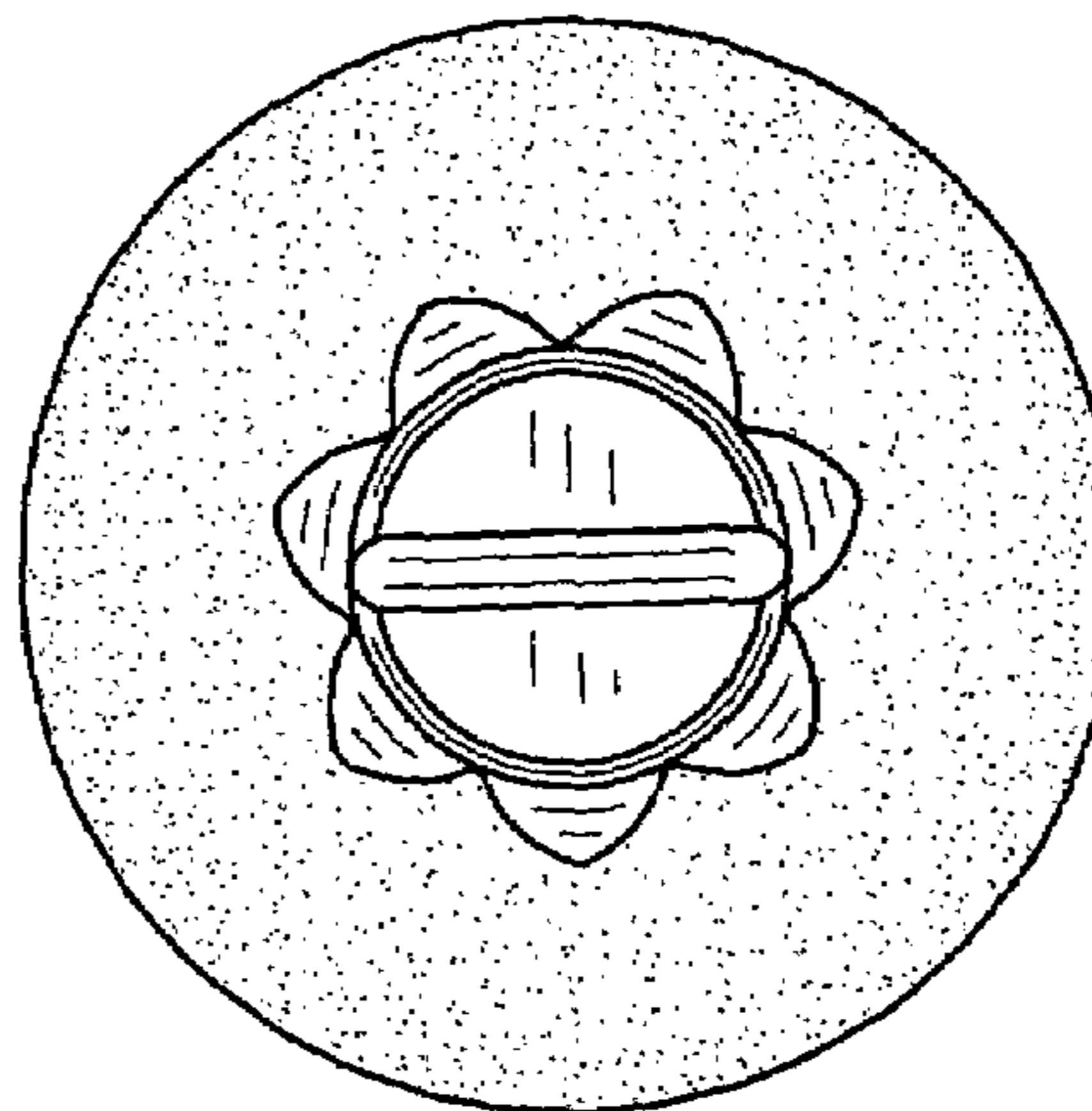
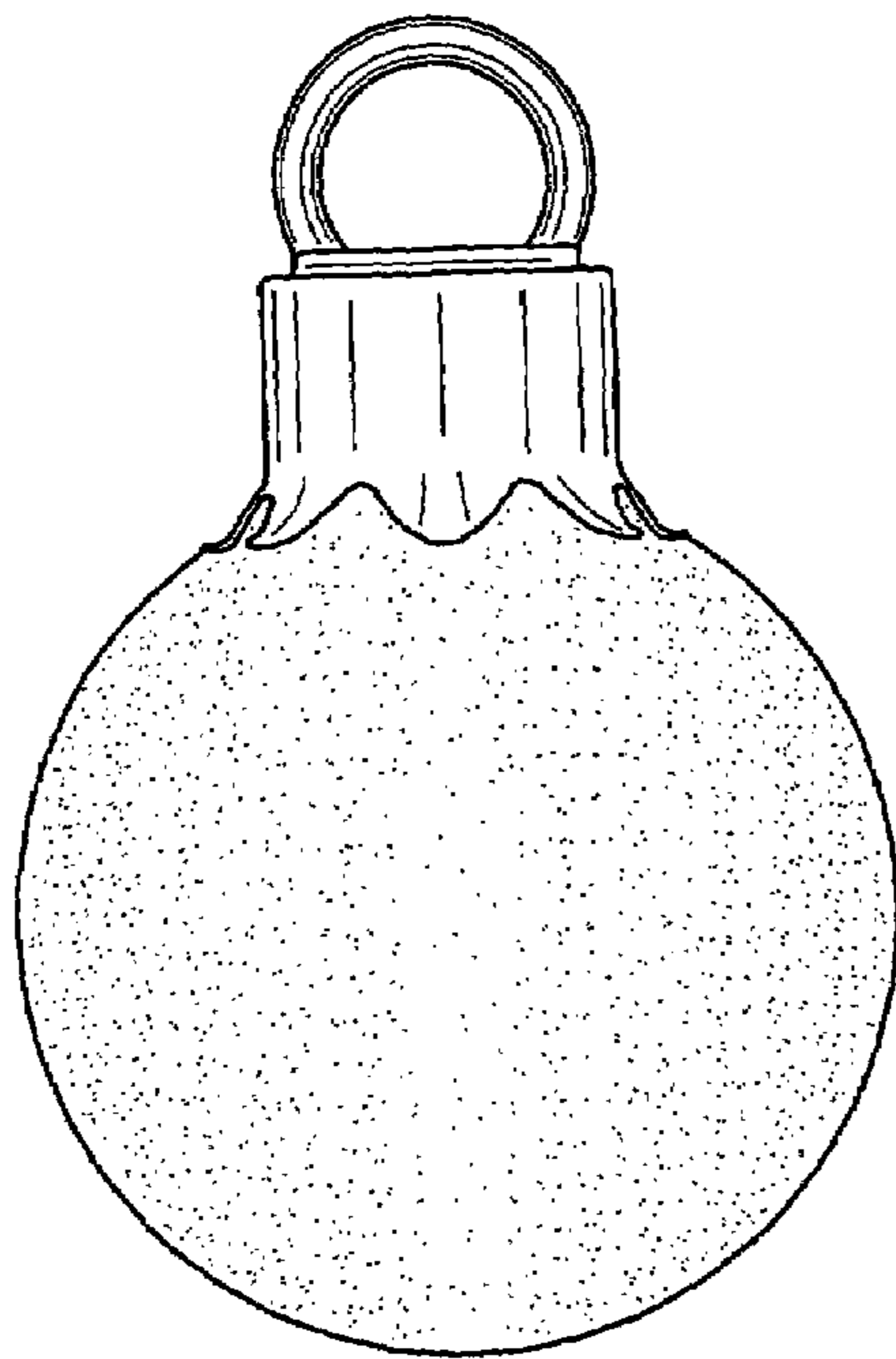
FIG. 1 is a side view of an orange-shaped bath sponge massager, showing my new design.

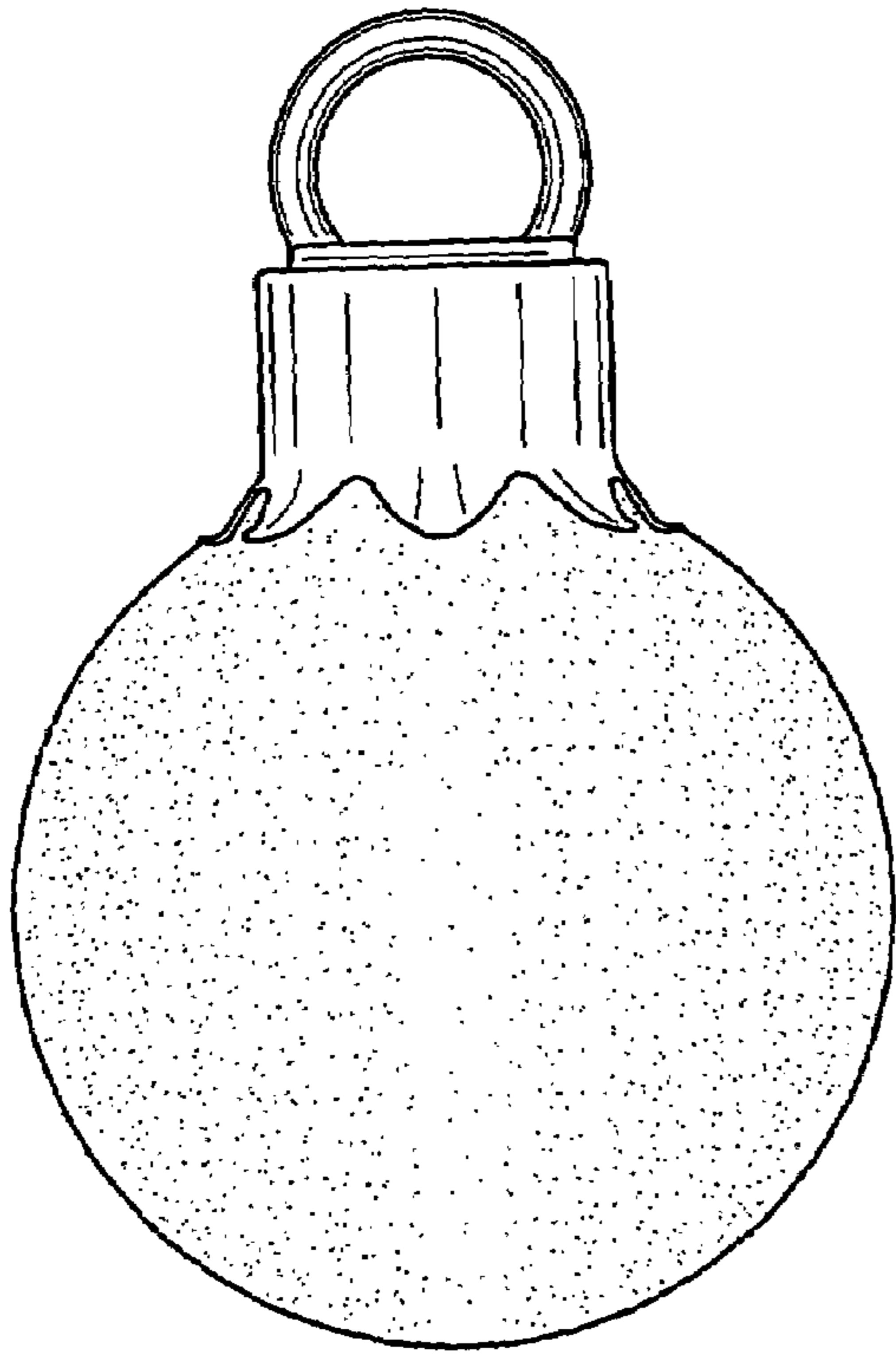

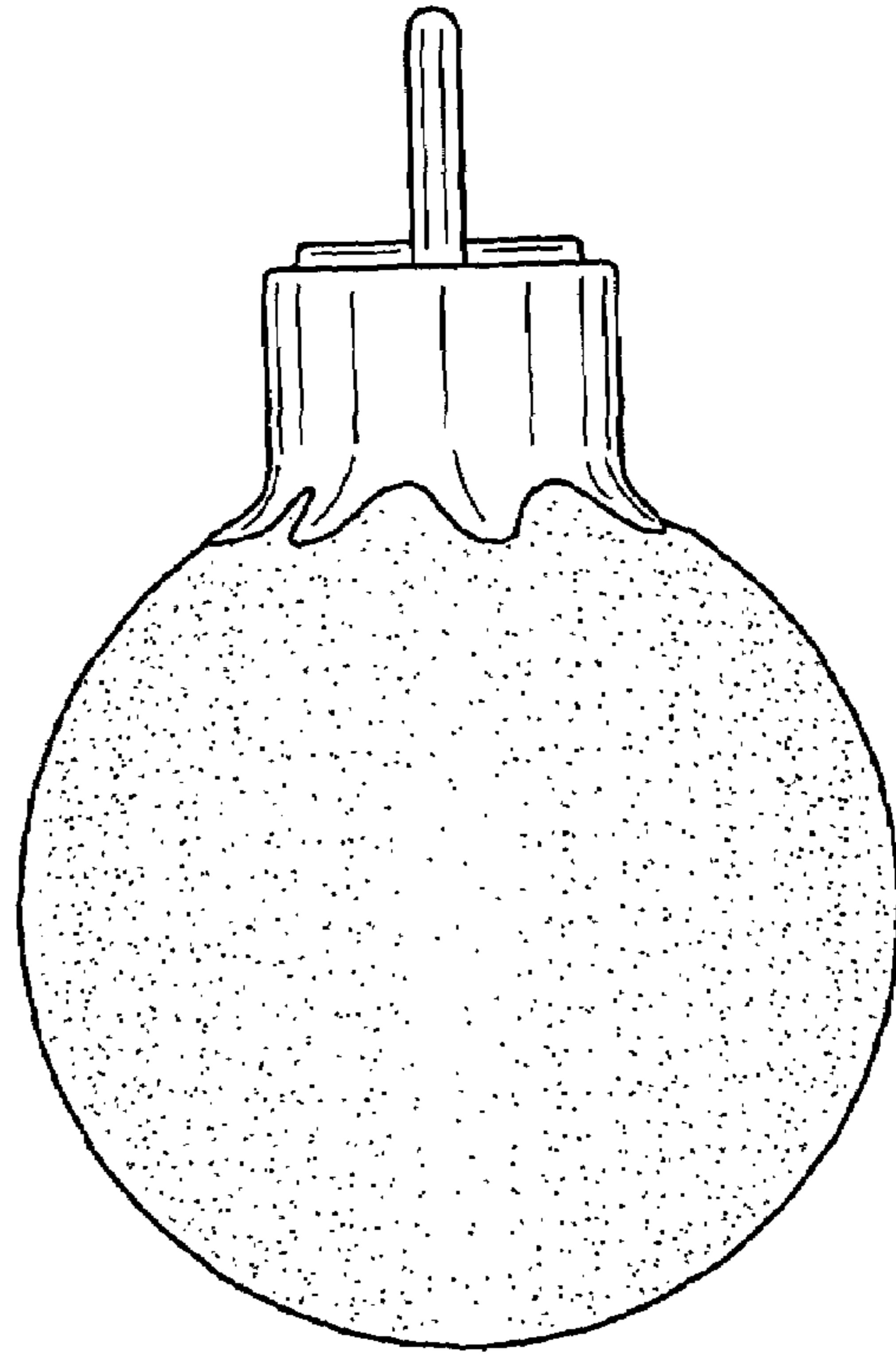

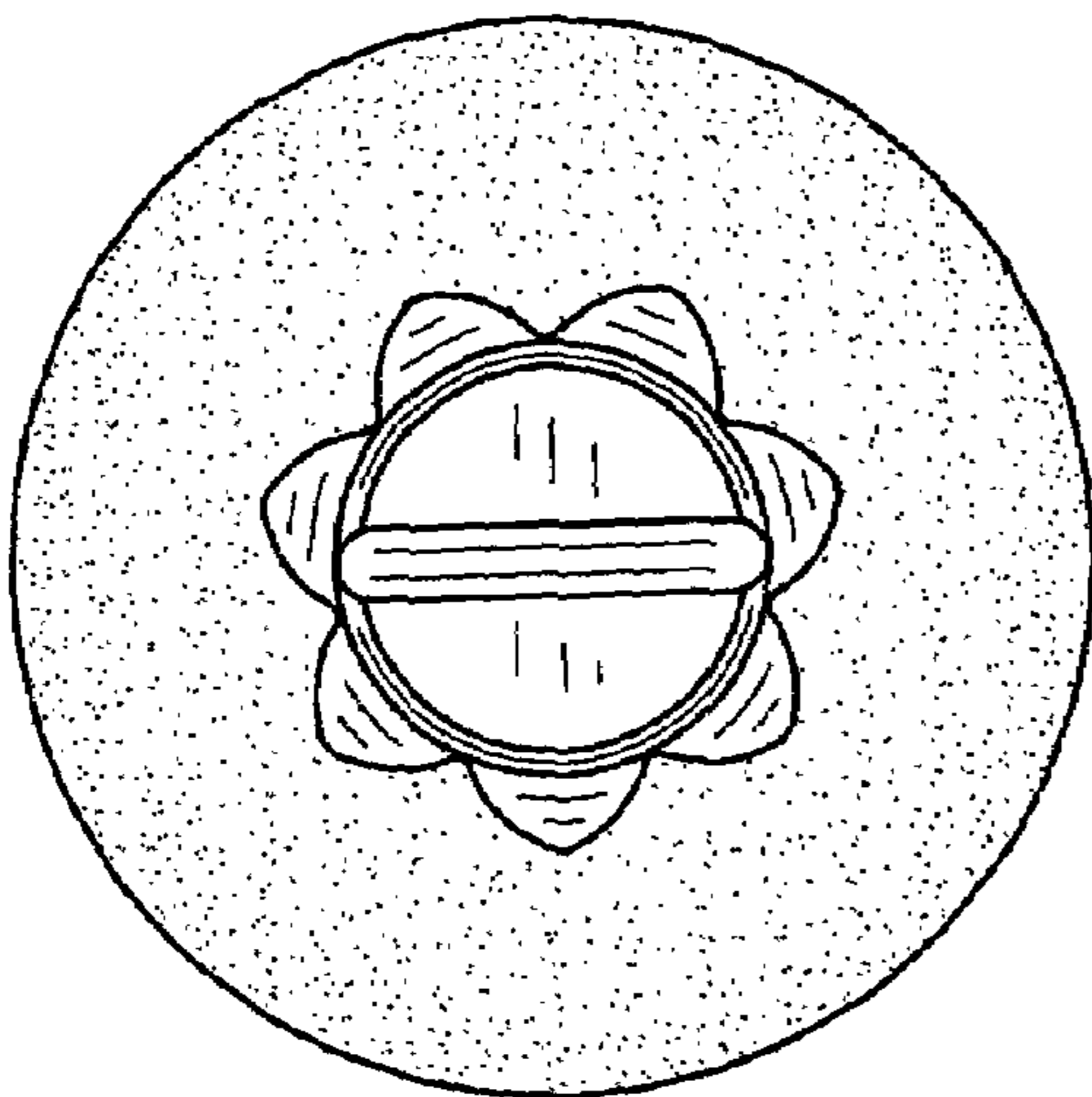

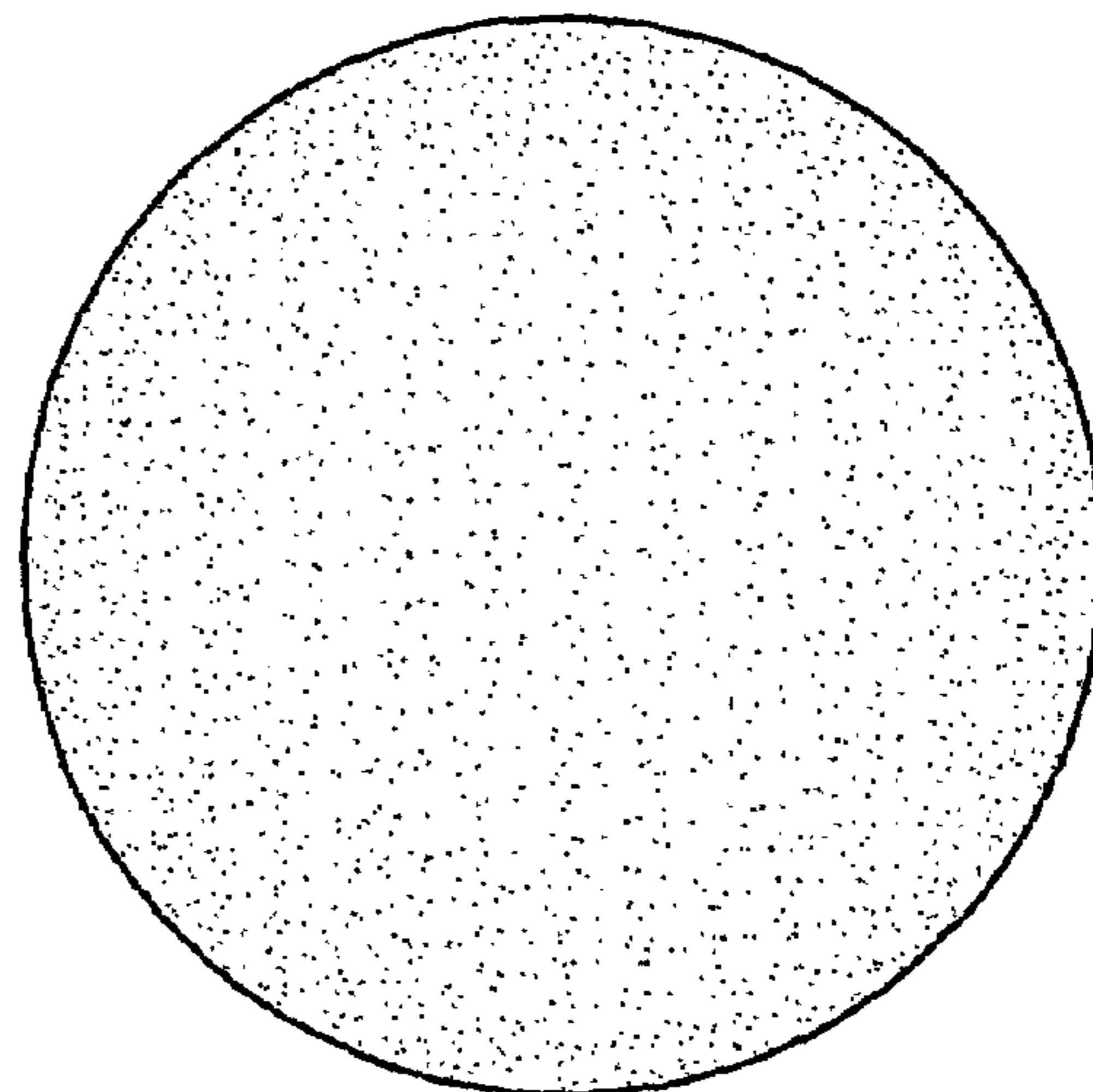
