FIG. 5 is a side elevation view thereof;

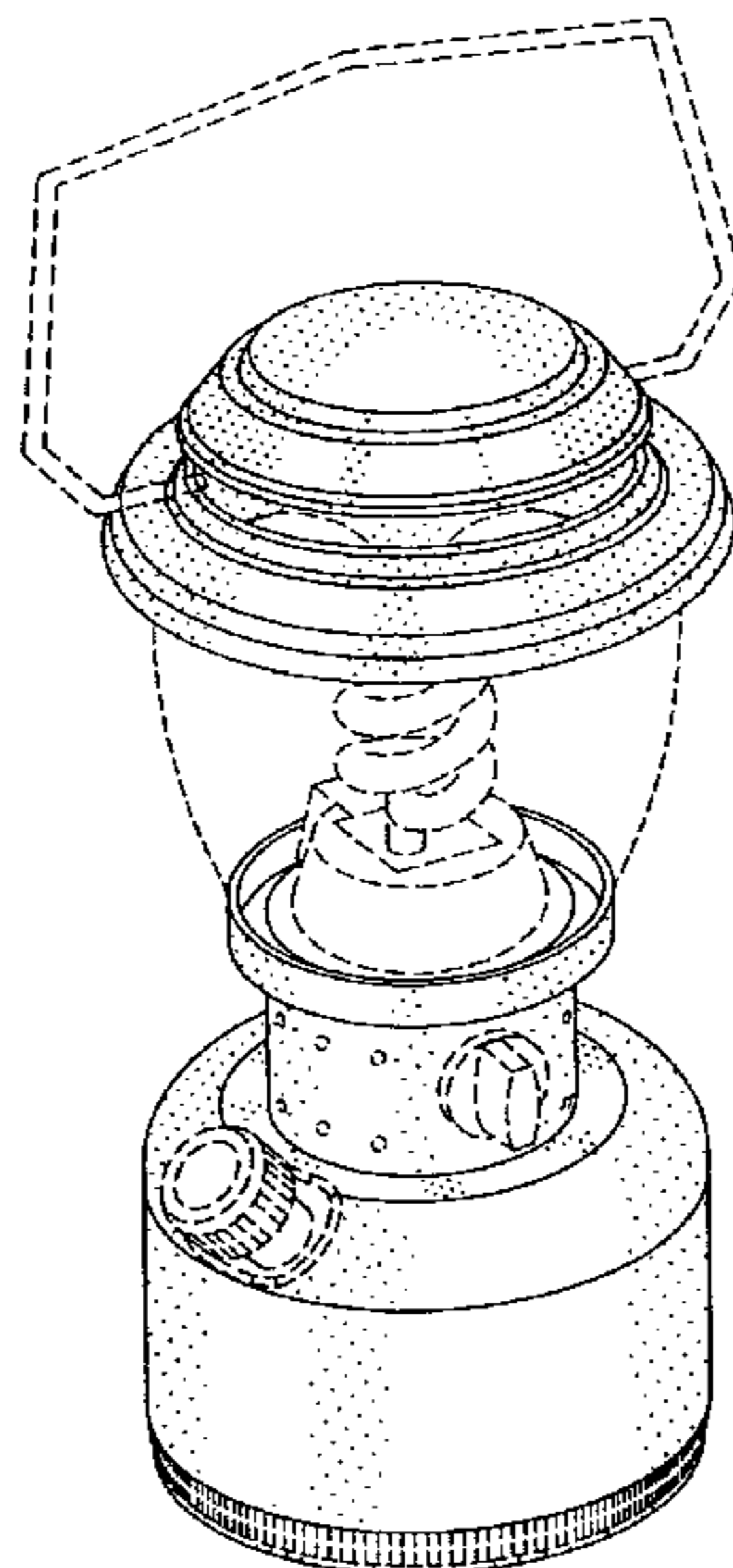
FIG. 6 is a side elevation view thereof, showing the opposite  
side of FIG. 5;

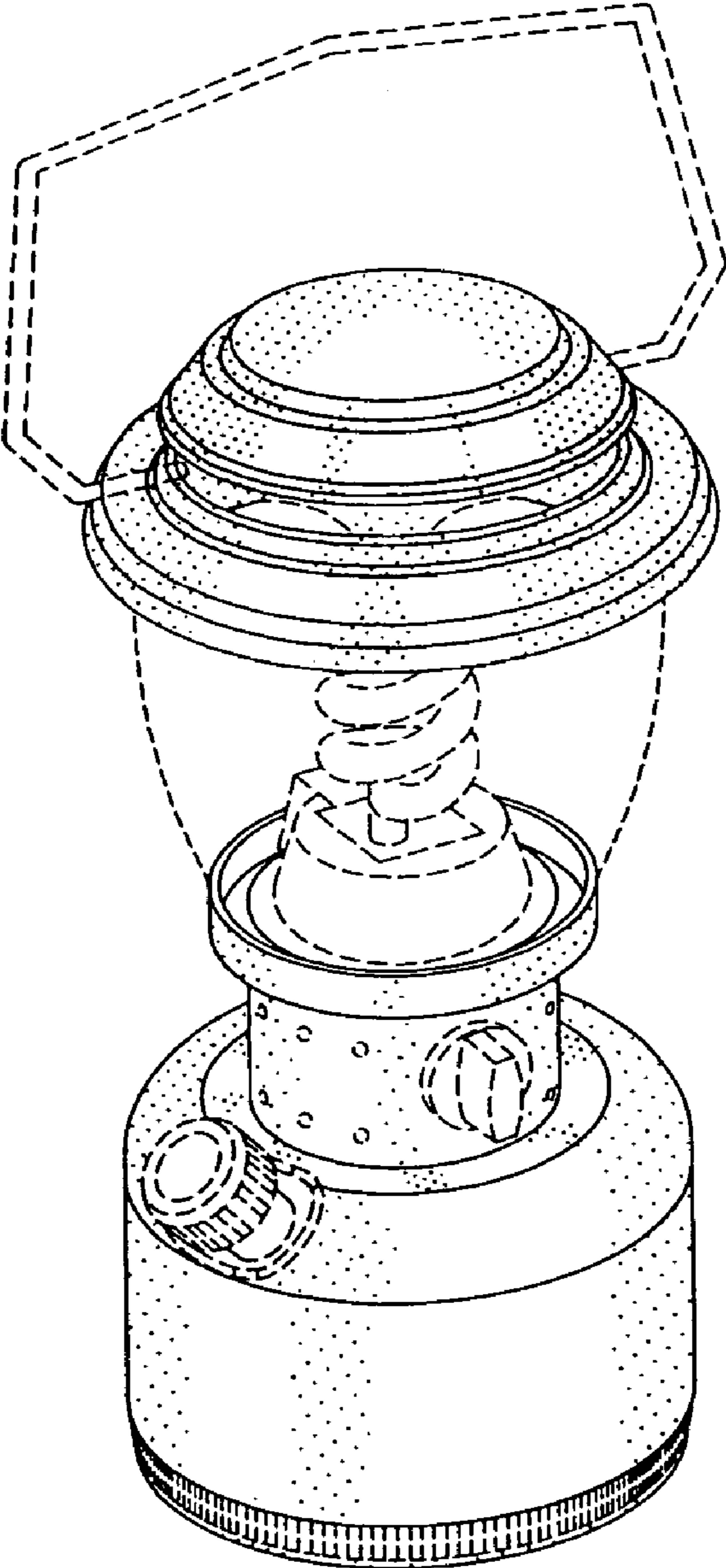
FIG. 7 is a top plan view thereof; and,

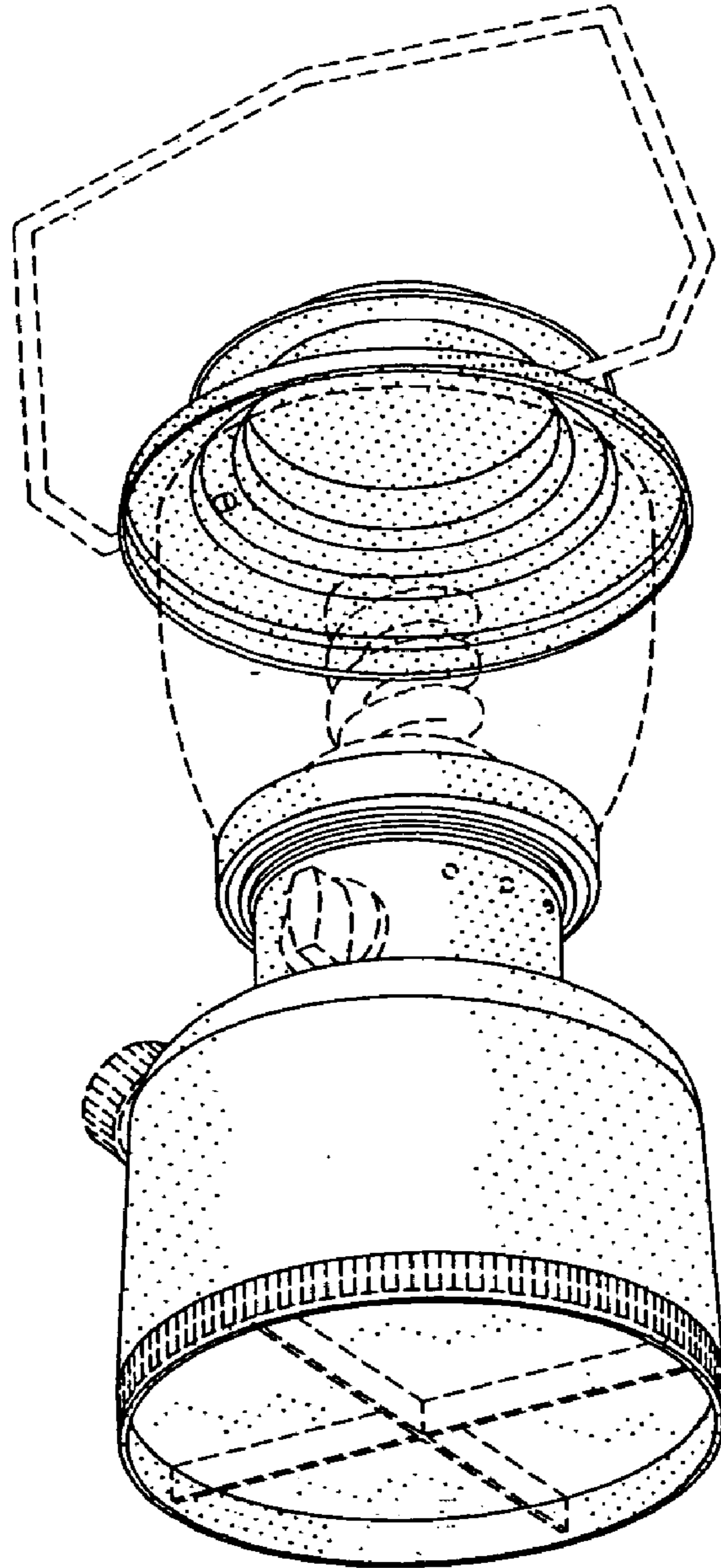

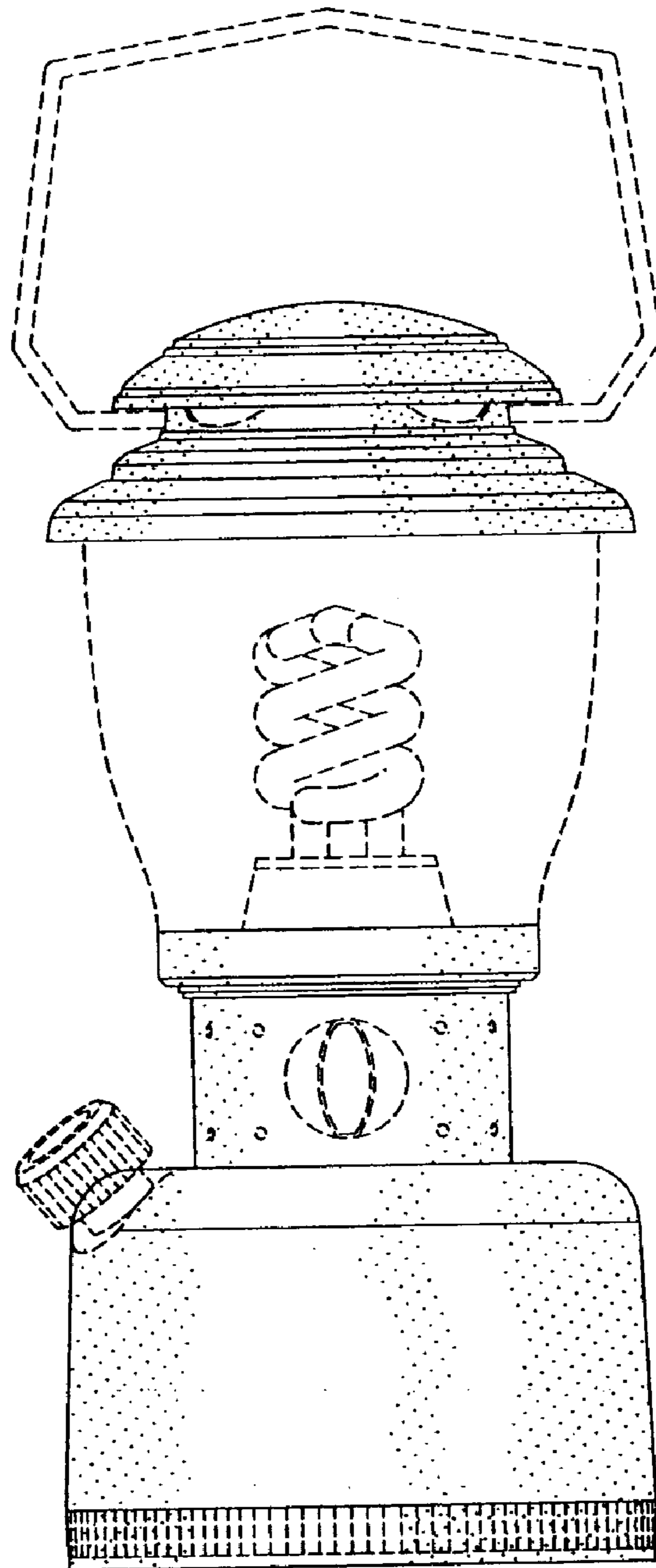

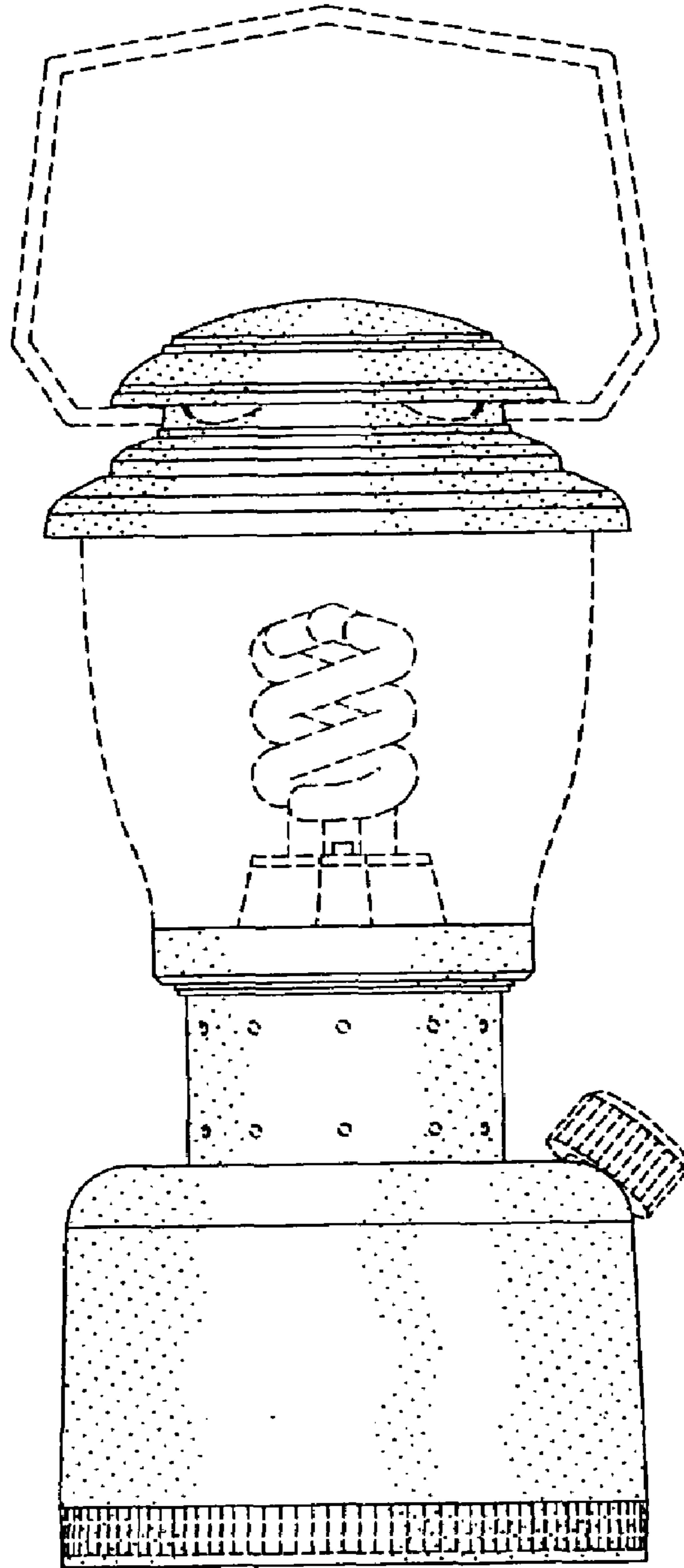
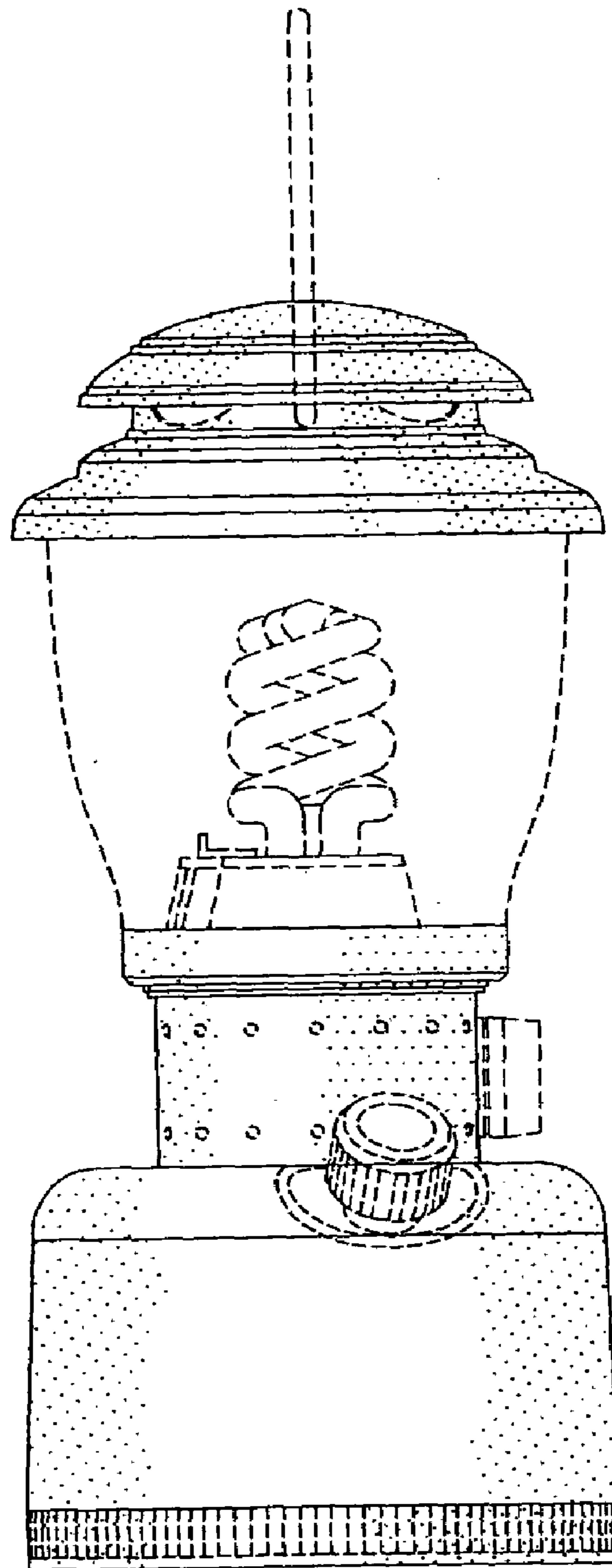
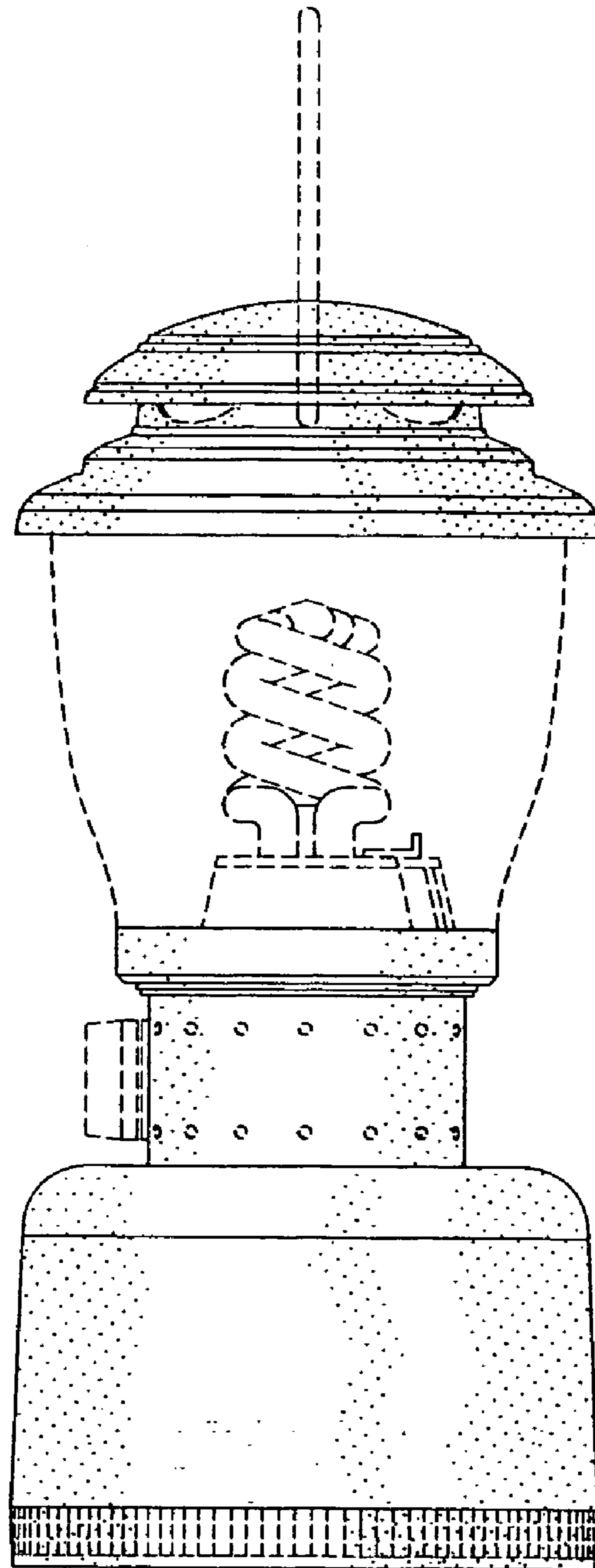


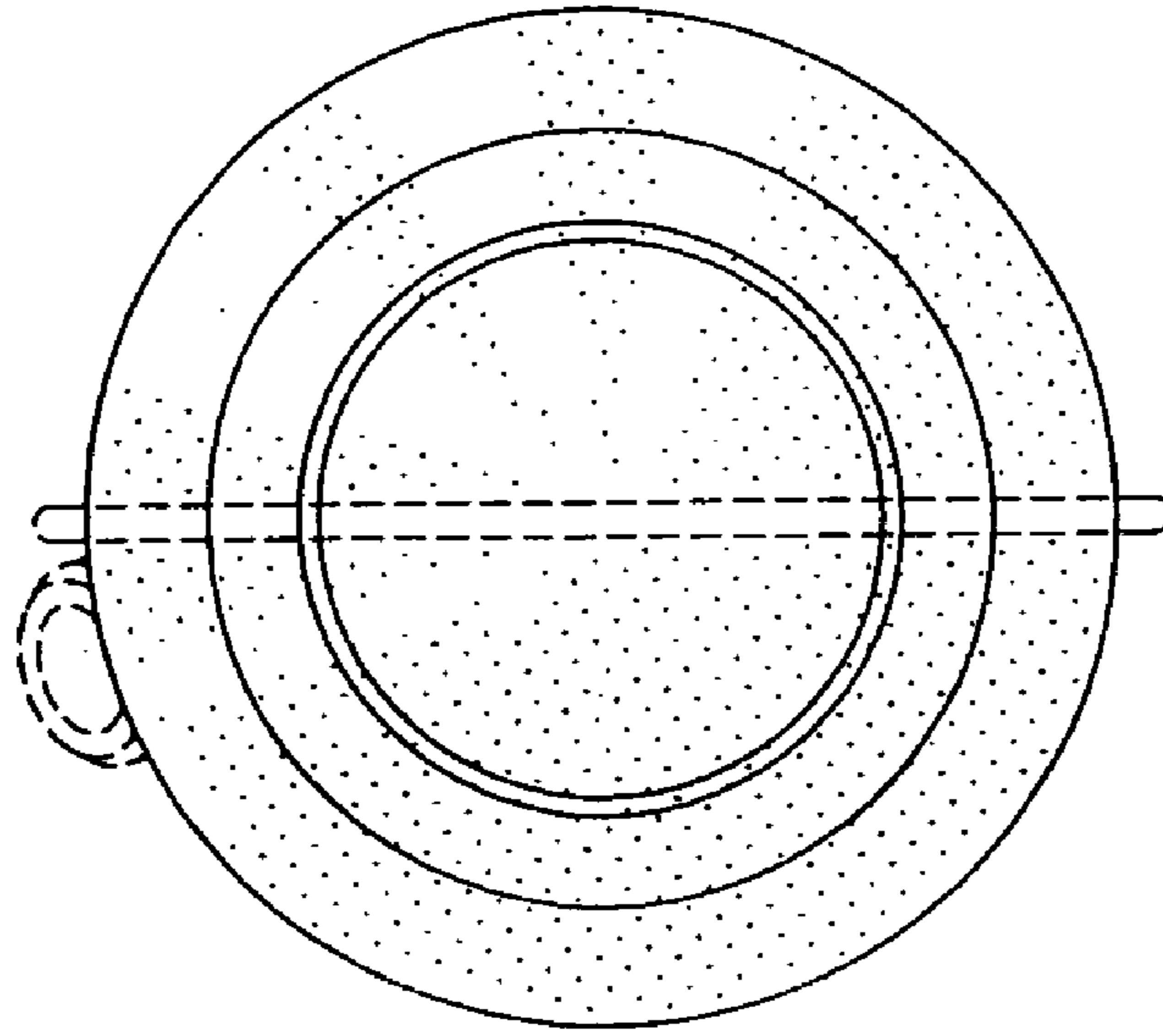

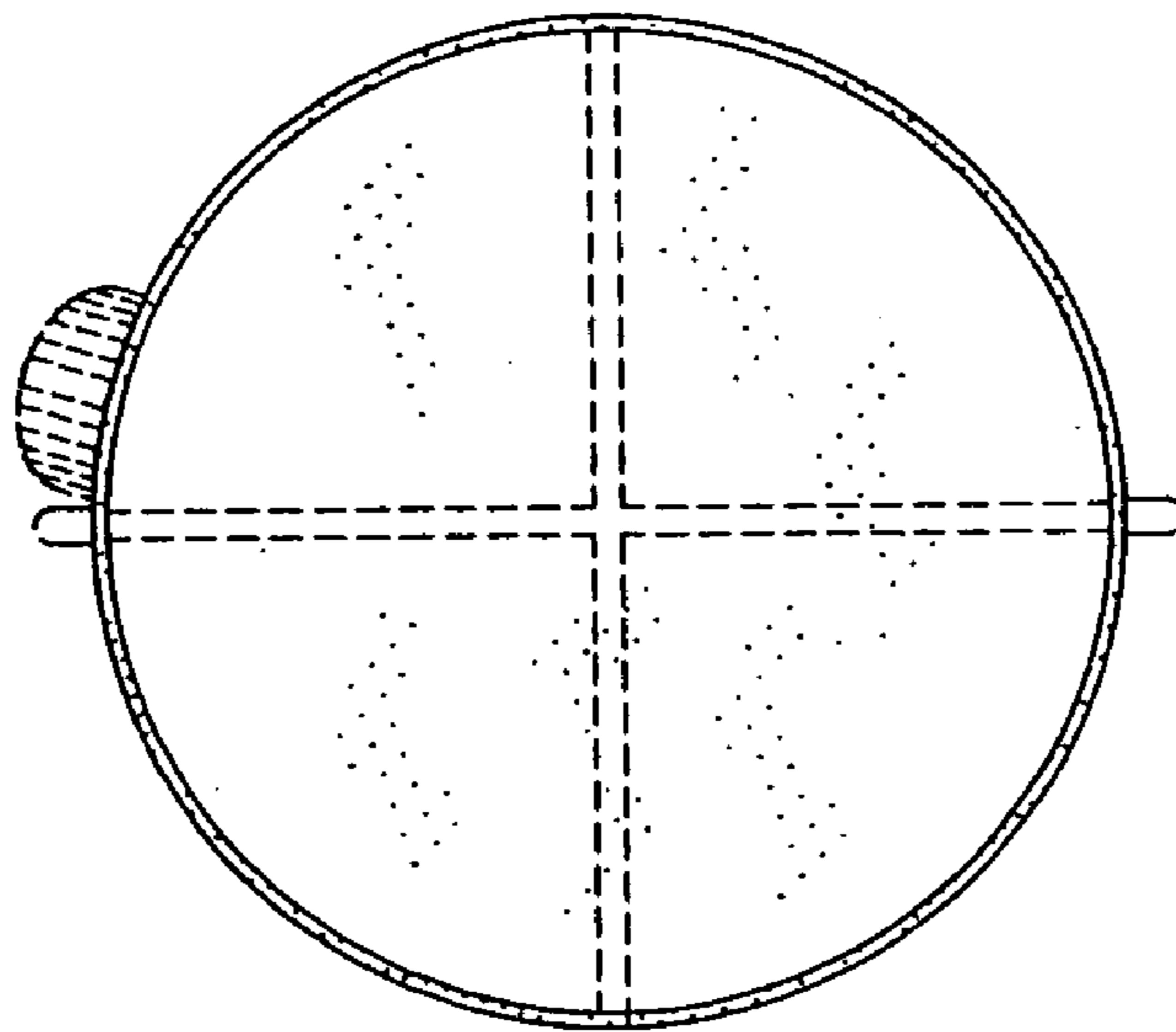
