FIG. 2 is a bottom view of the lamp reflector;

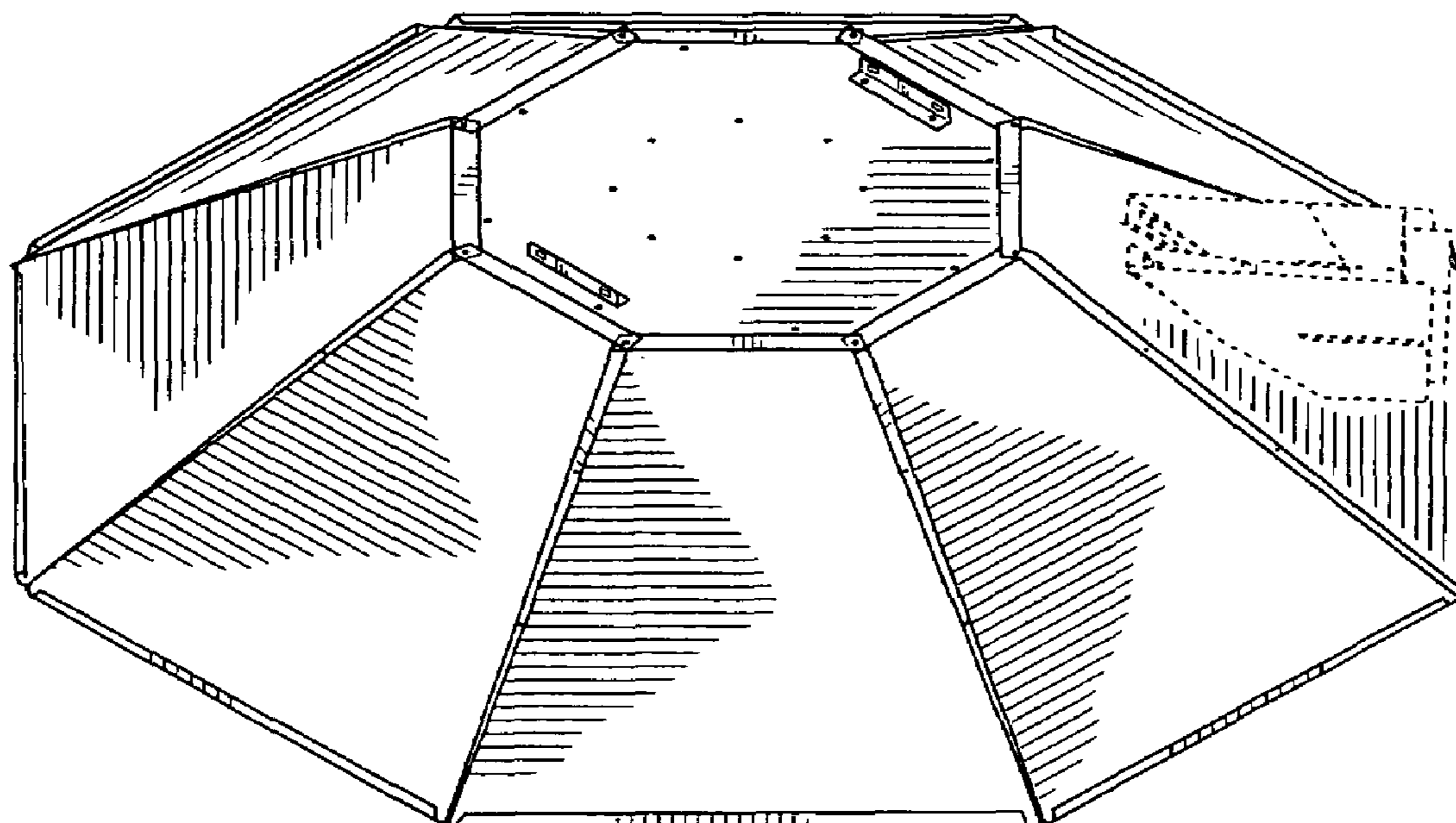
FIG. 3 is a top view of the lamp reflector;

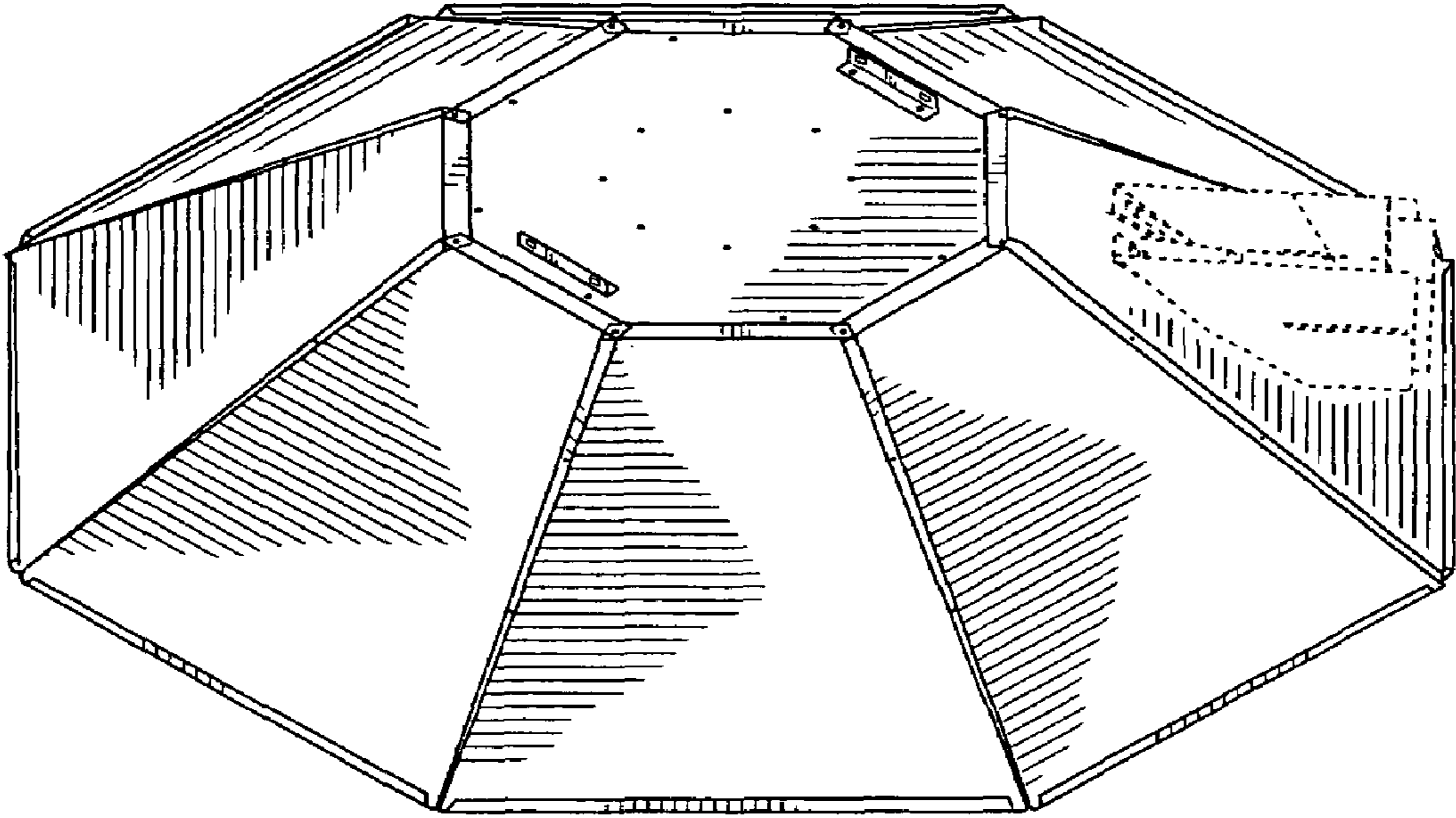

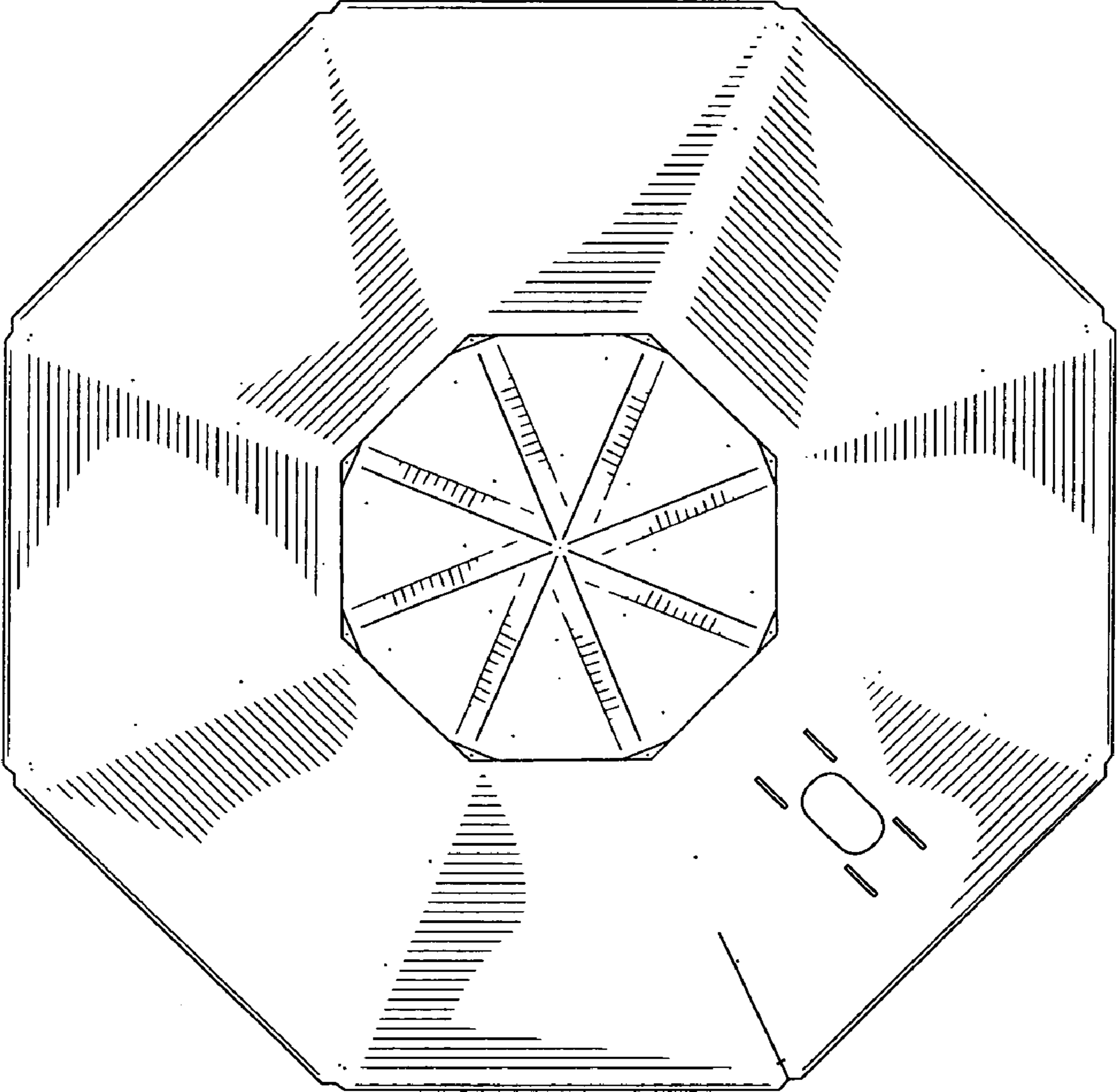

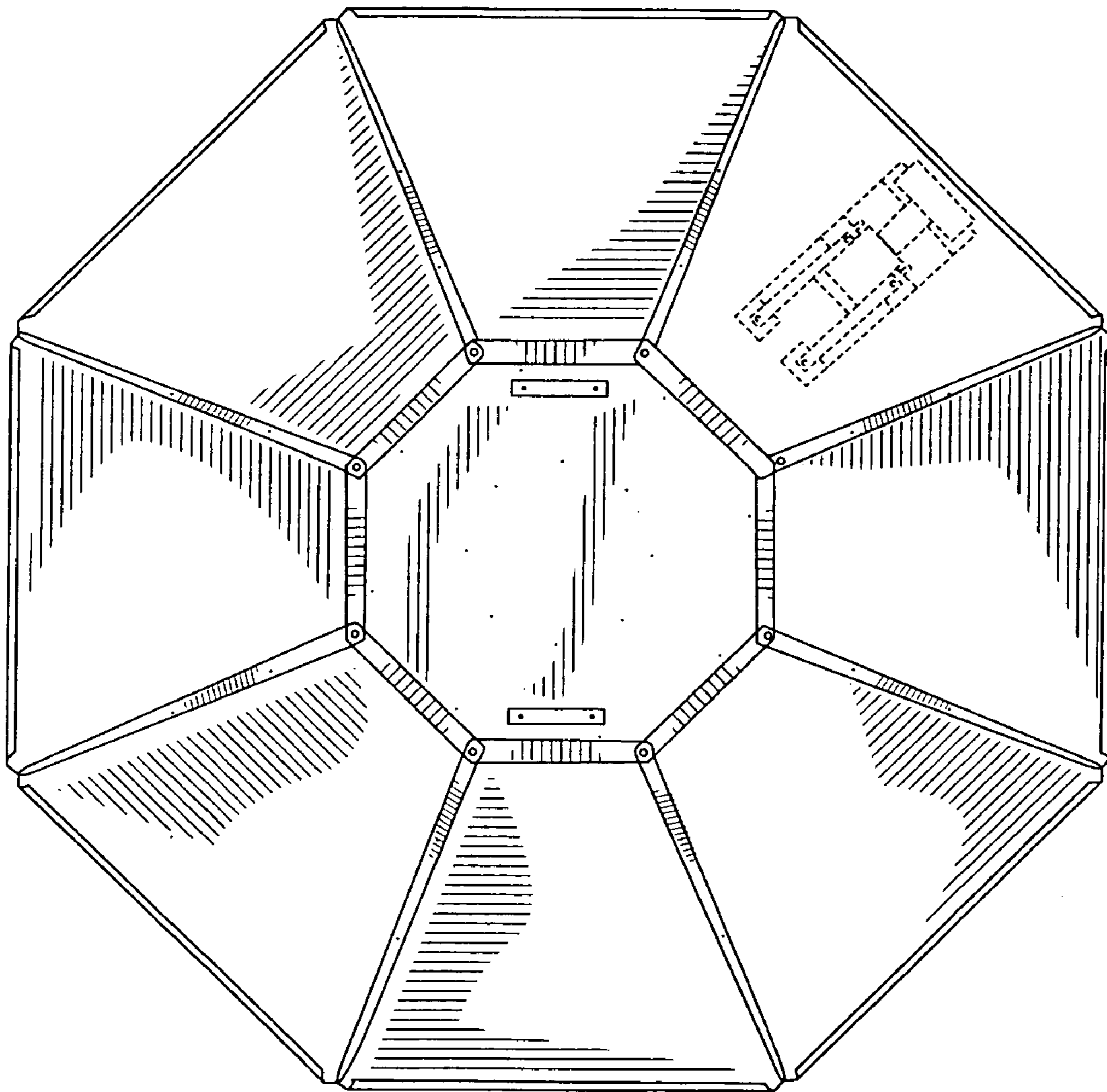

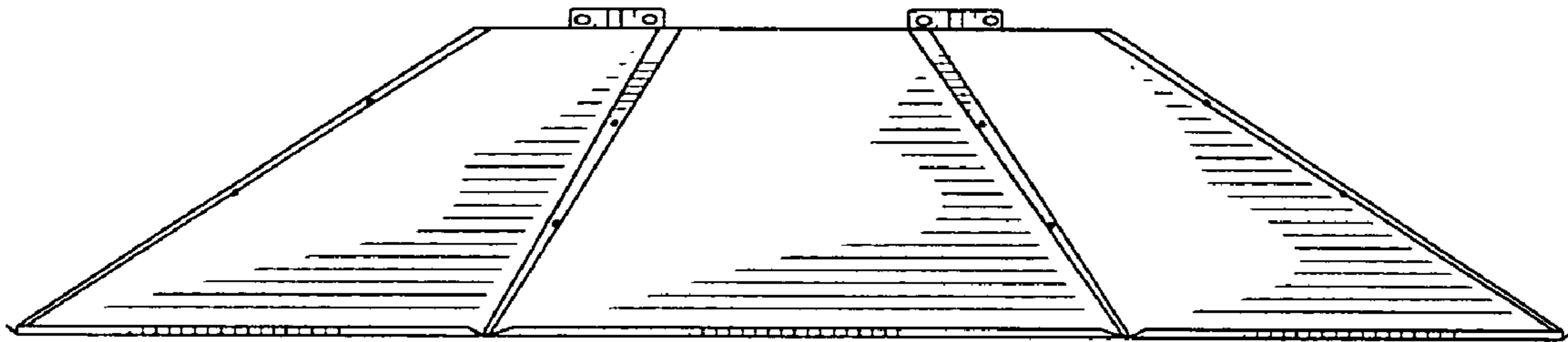

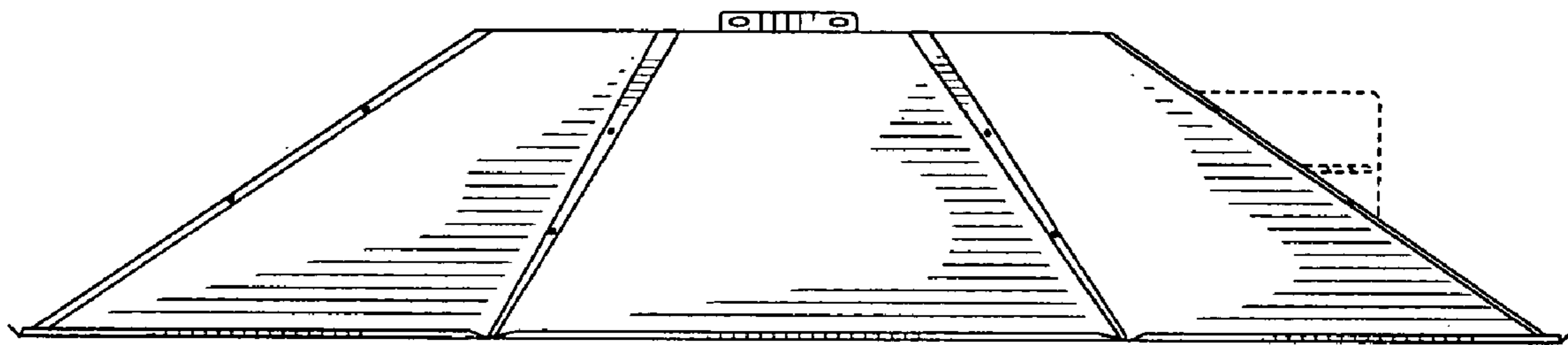

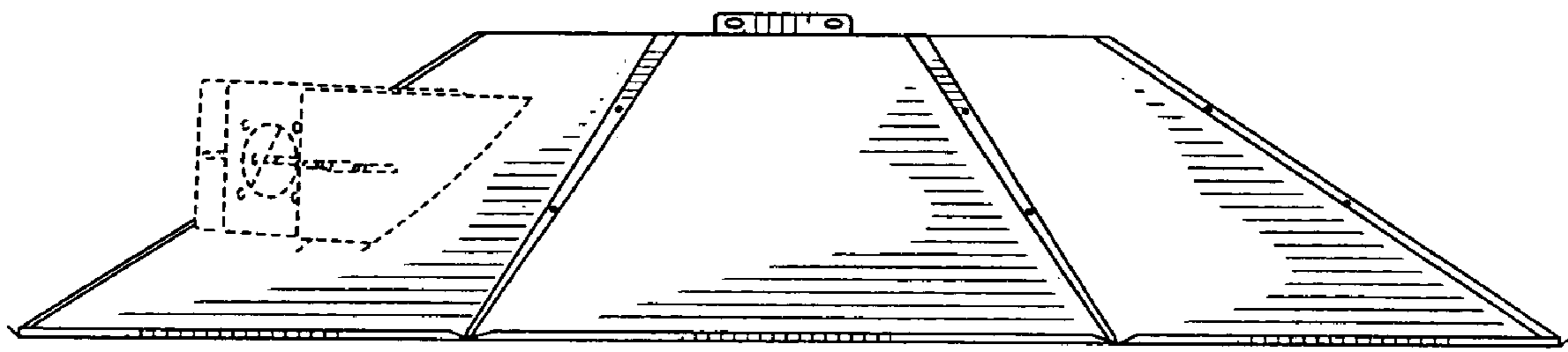
