FIG. 3 is a front side view of the present invention.

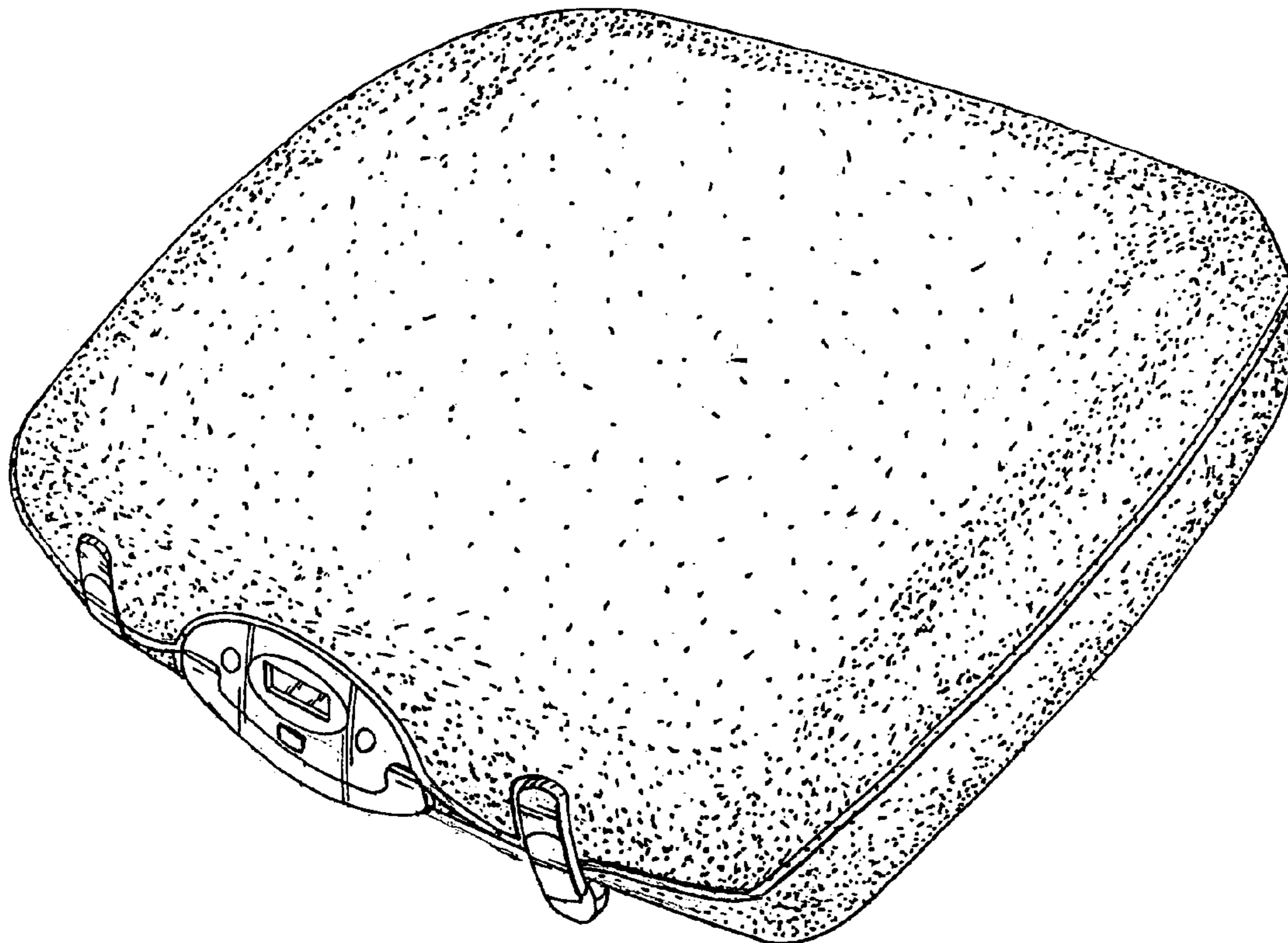
FIG. 4 is bottom plan view of the present invention.

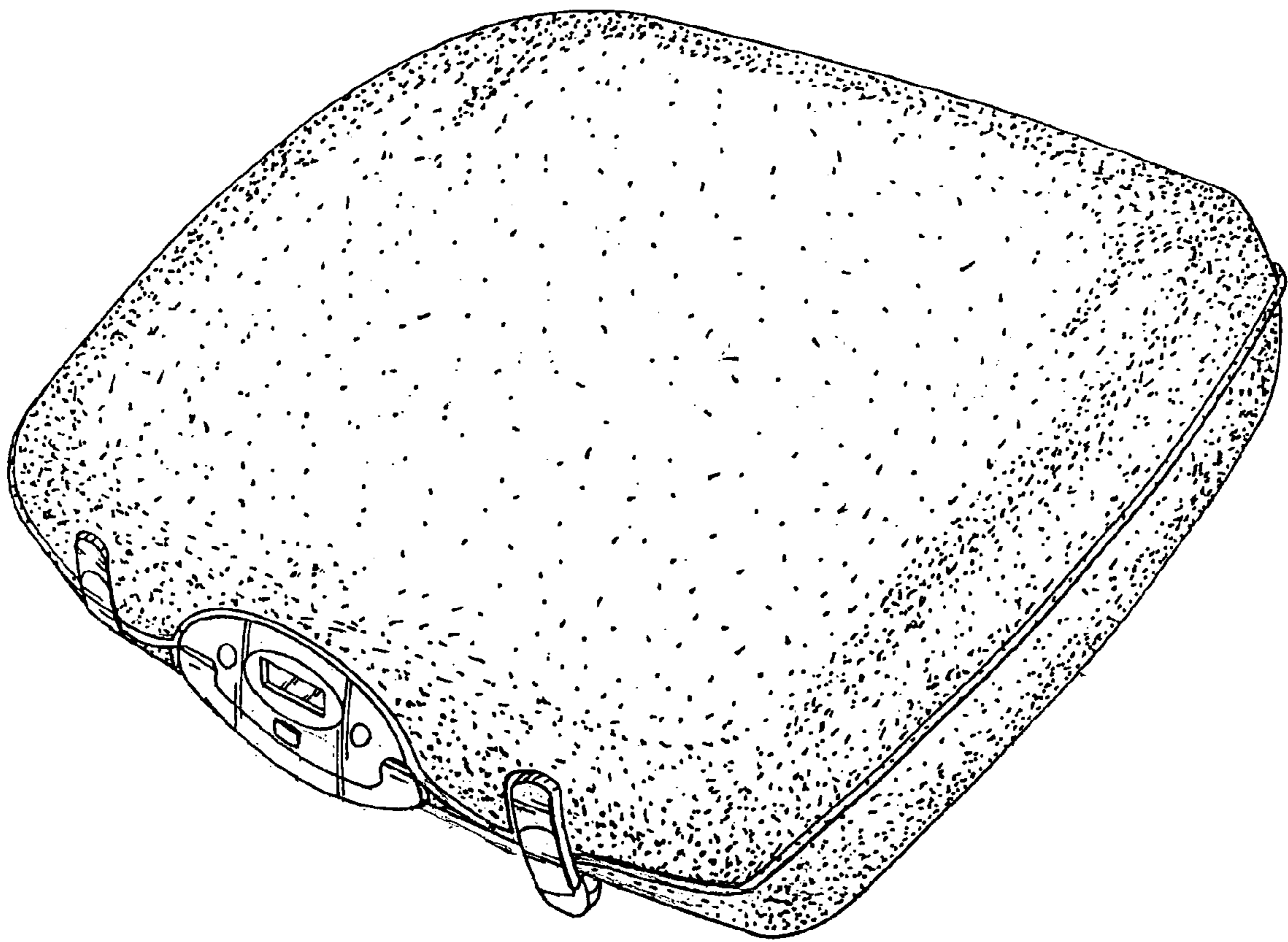

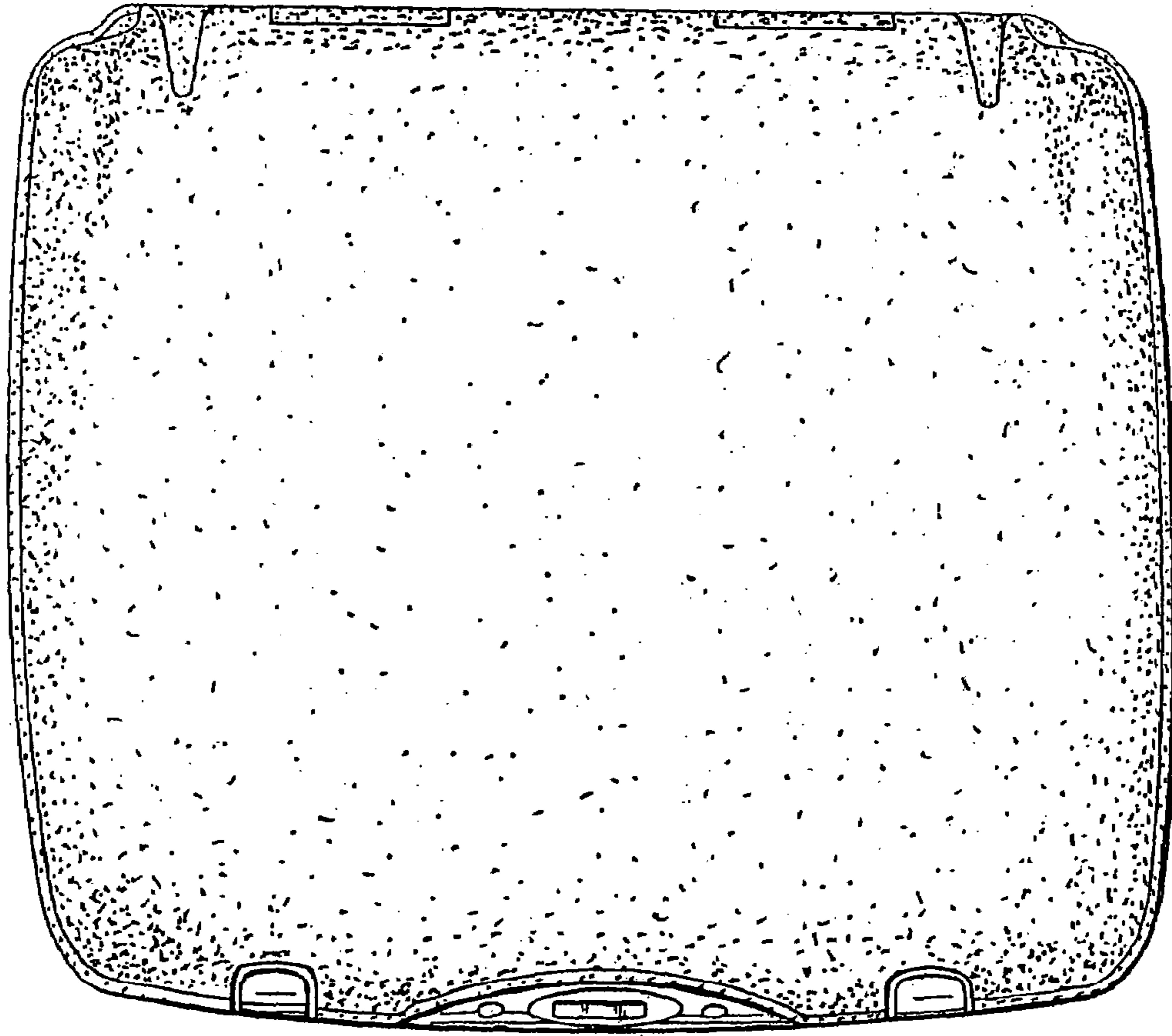

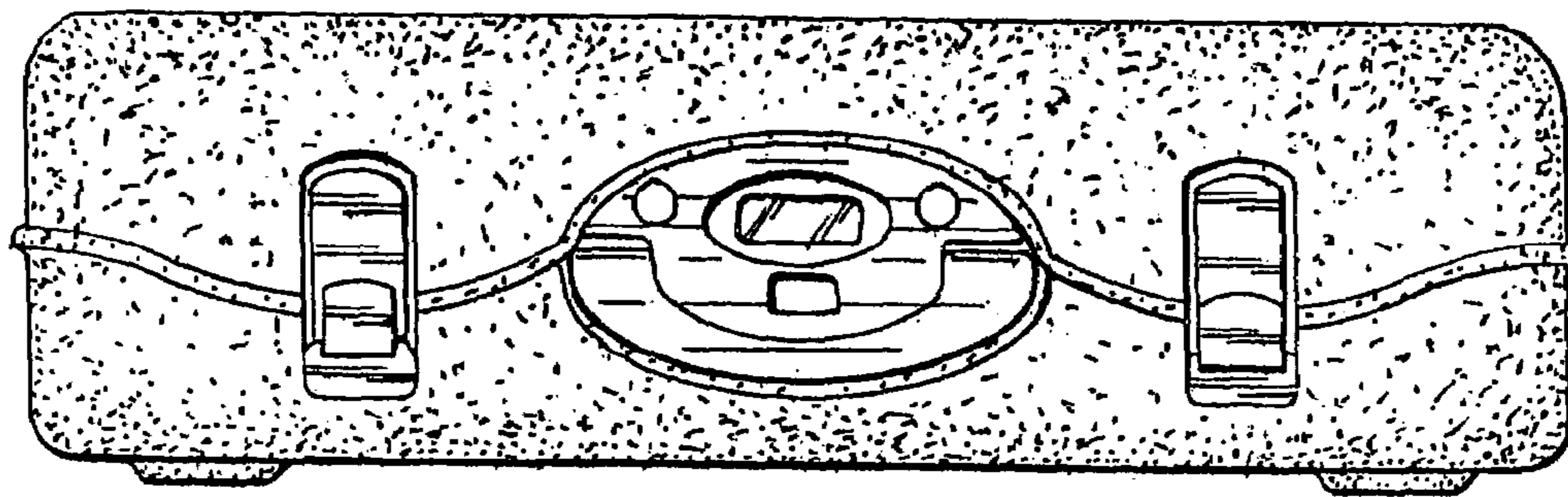

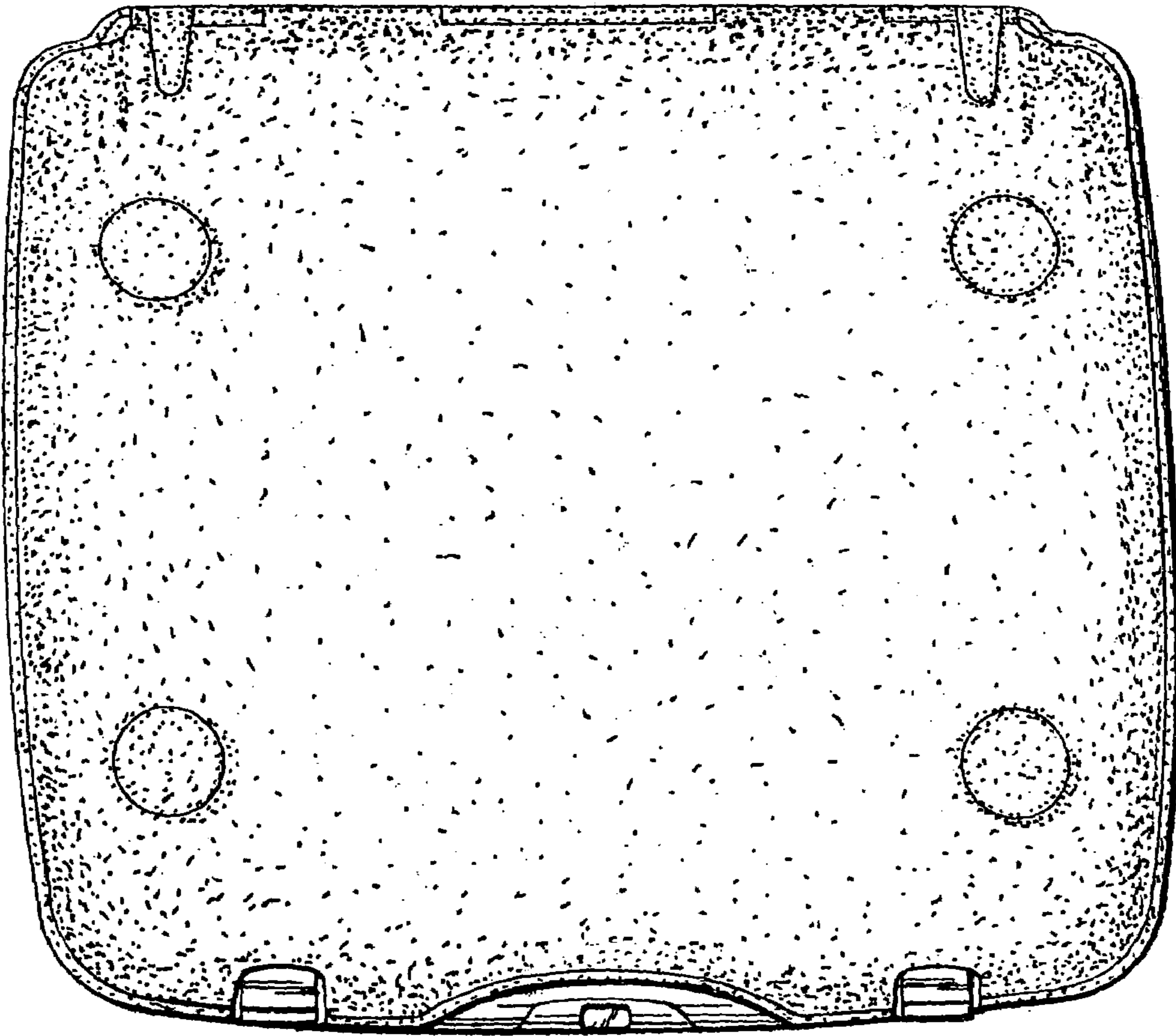

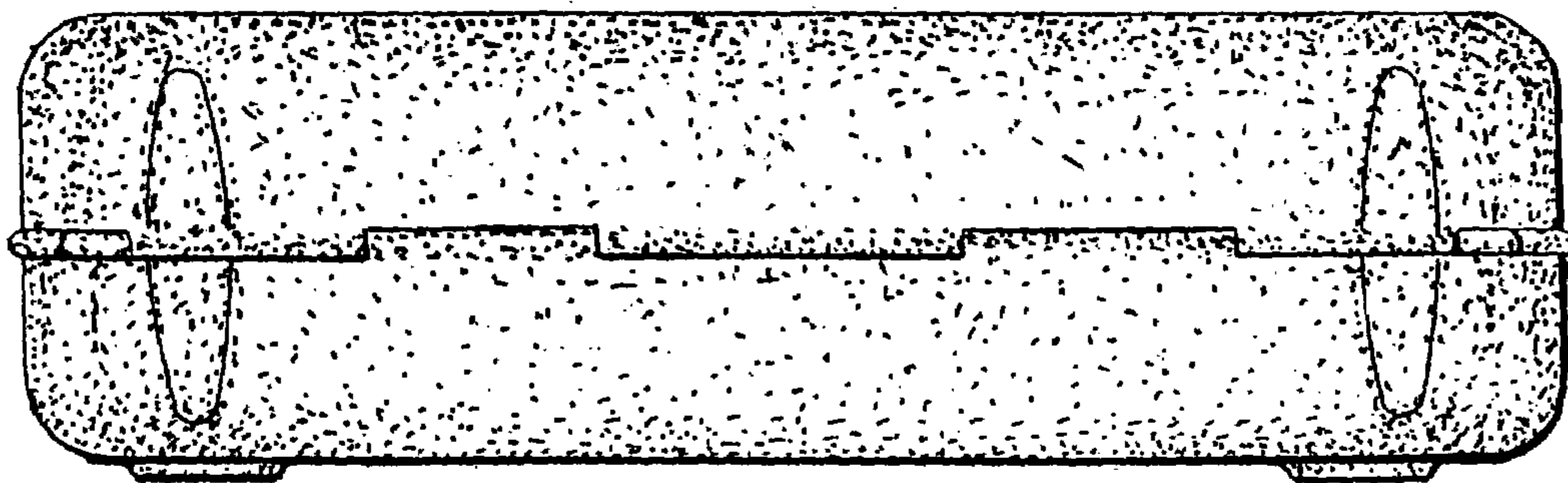

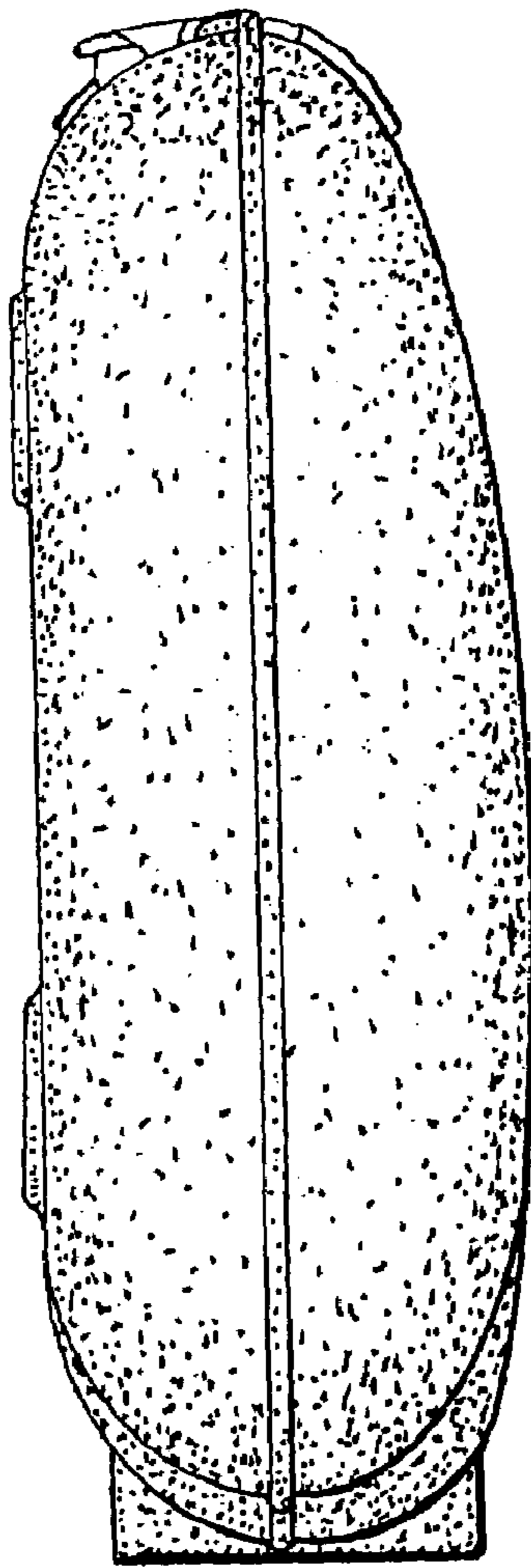

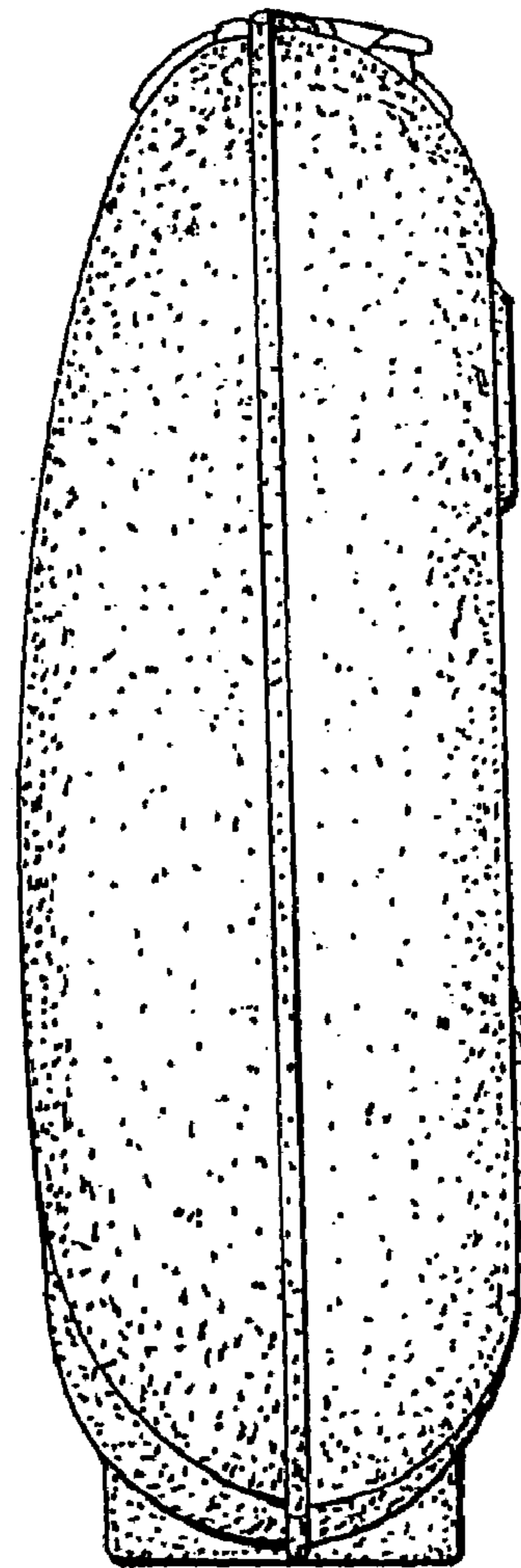
