We claim the ornamental design for a portion of a suction nozzle for a floor care appliance, as shown and described.

**DESCRIPTION**

FIG. 2 is a front view thereof;

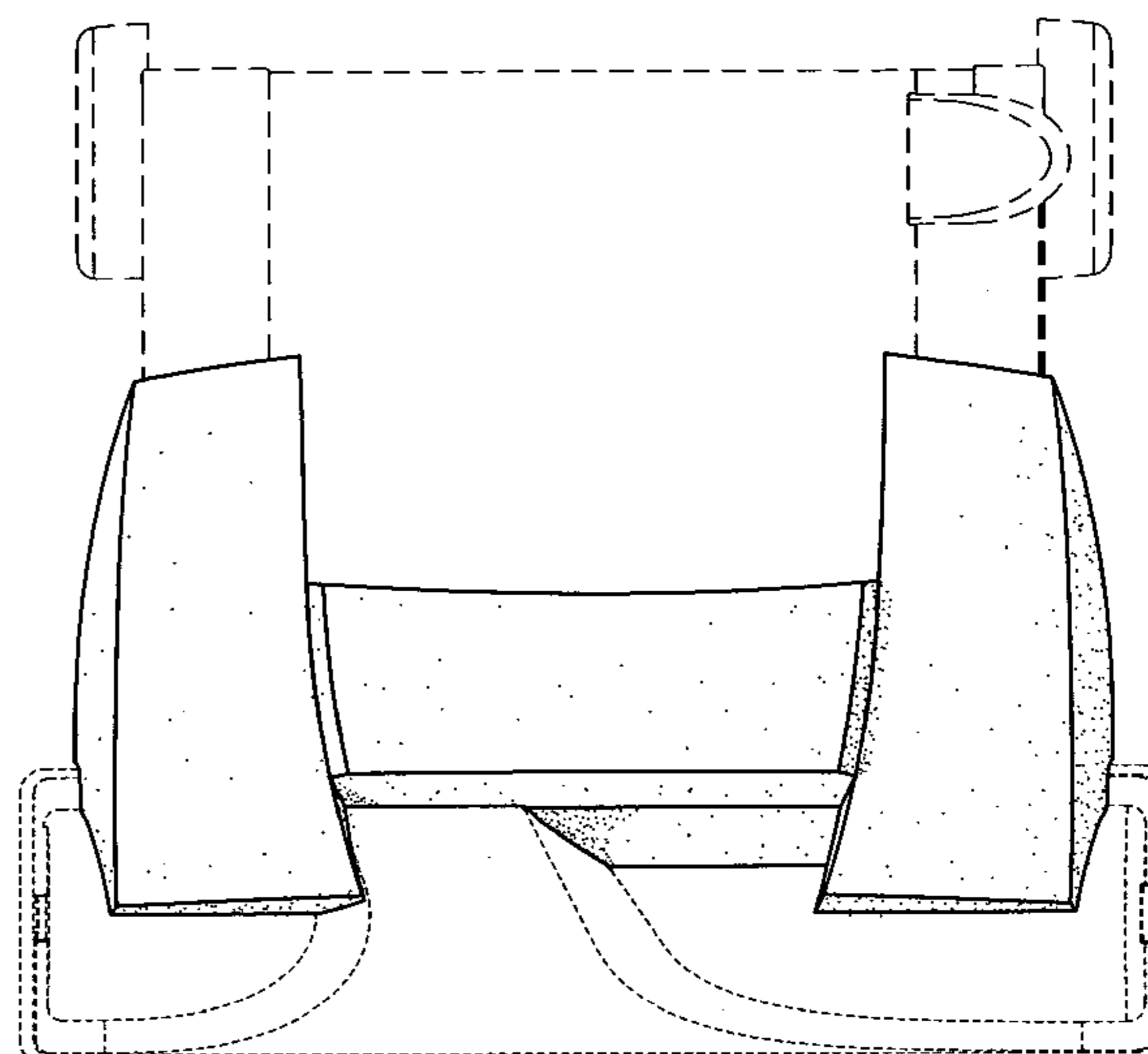
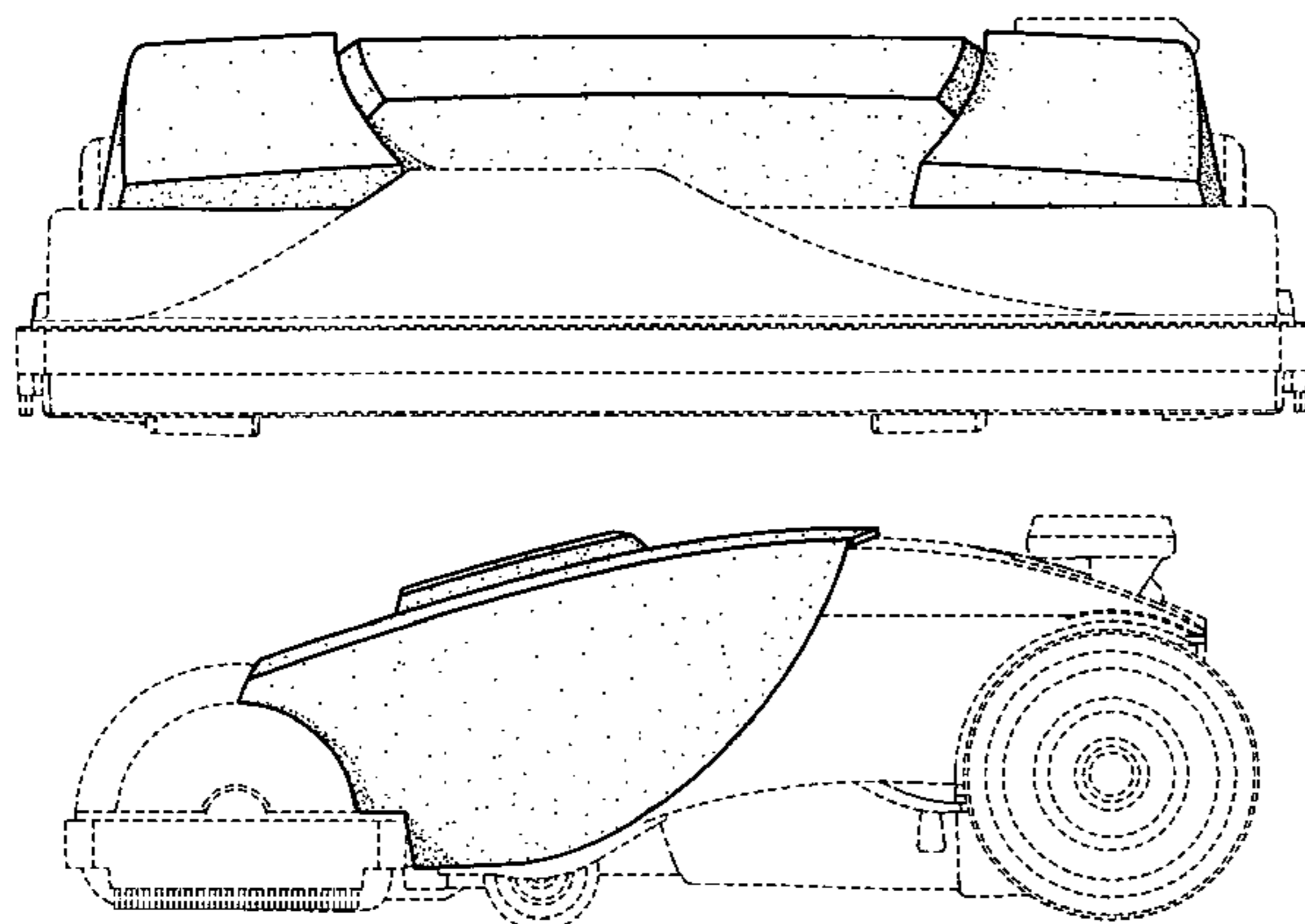
FIG. 3 is a left side view thereof;

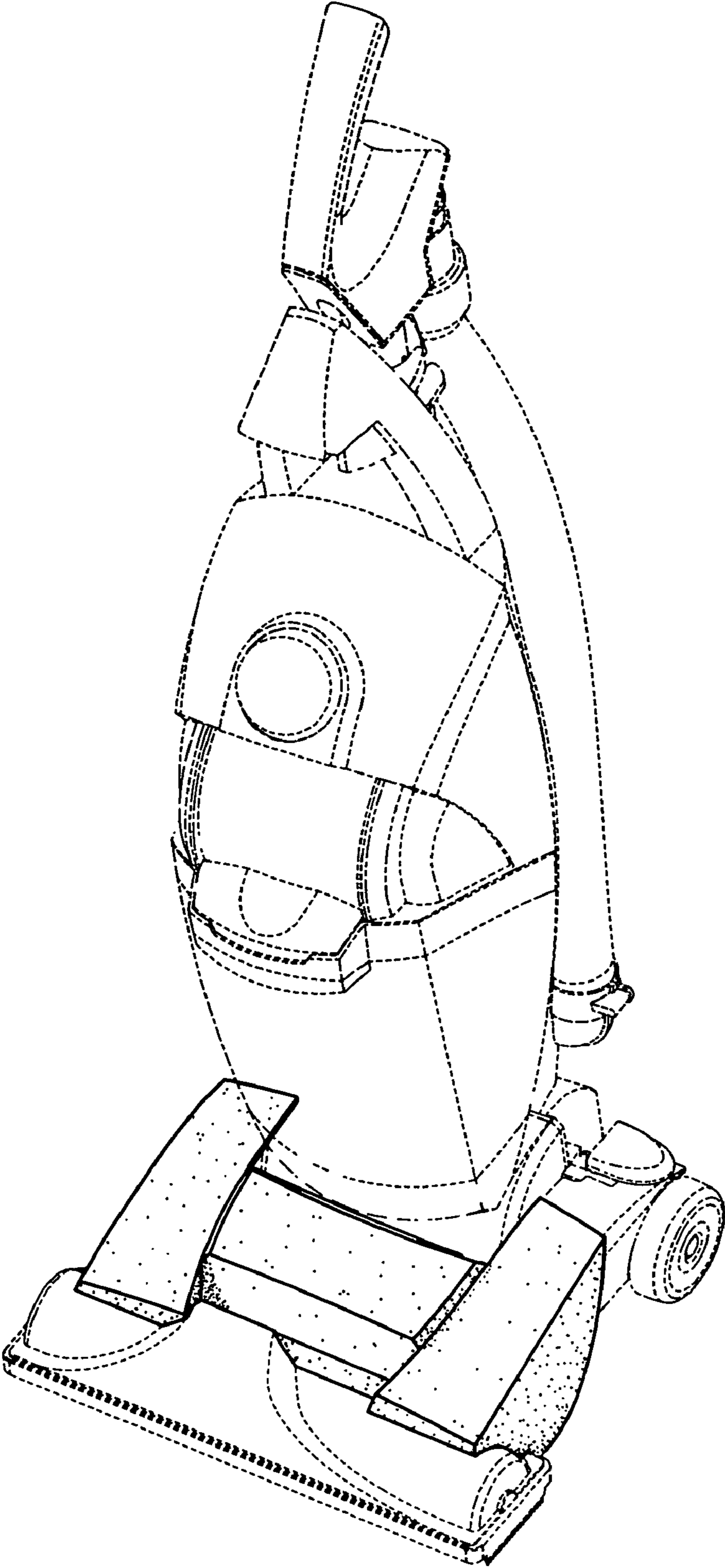

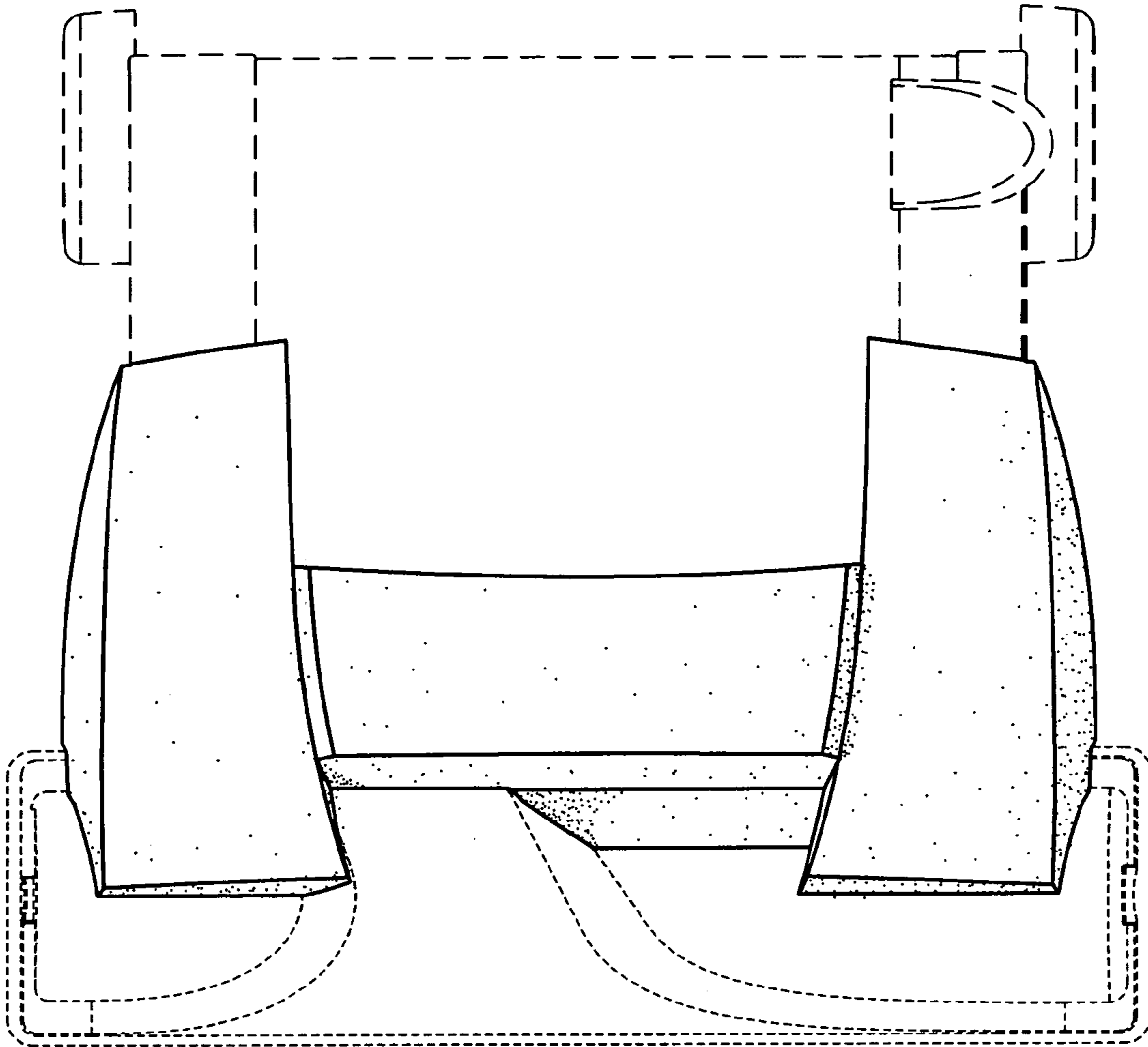

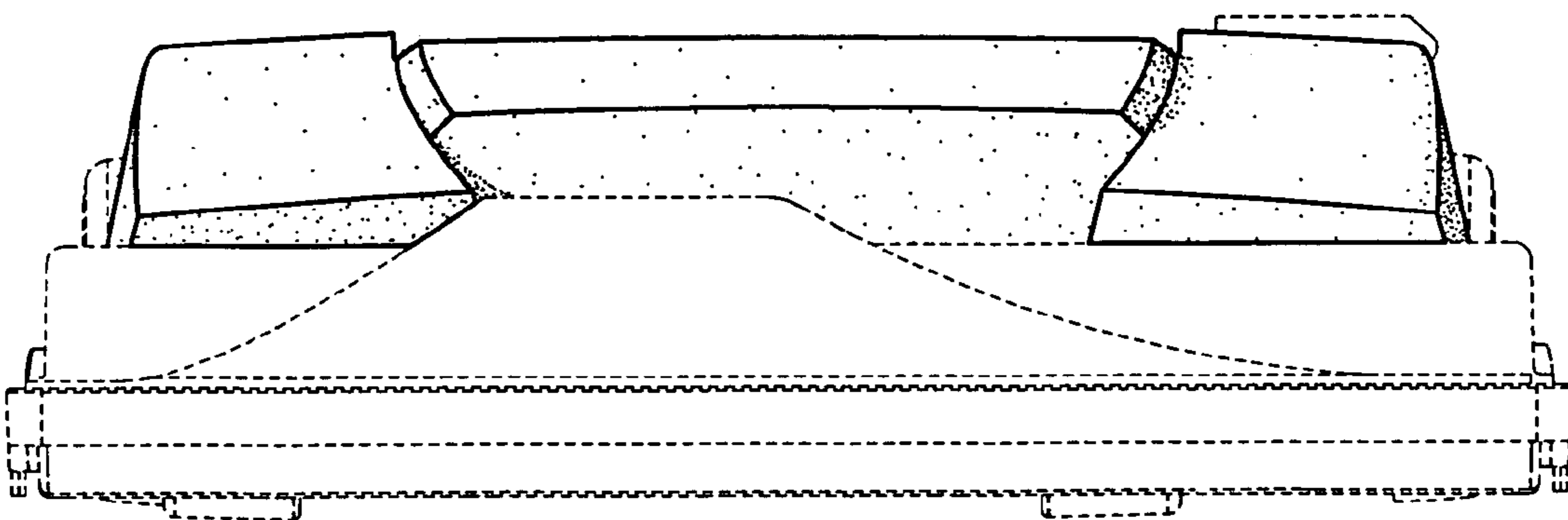

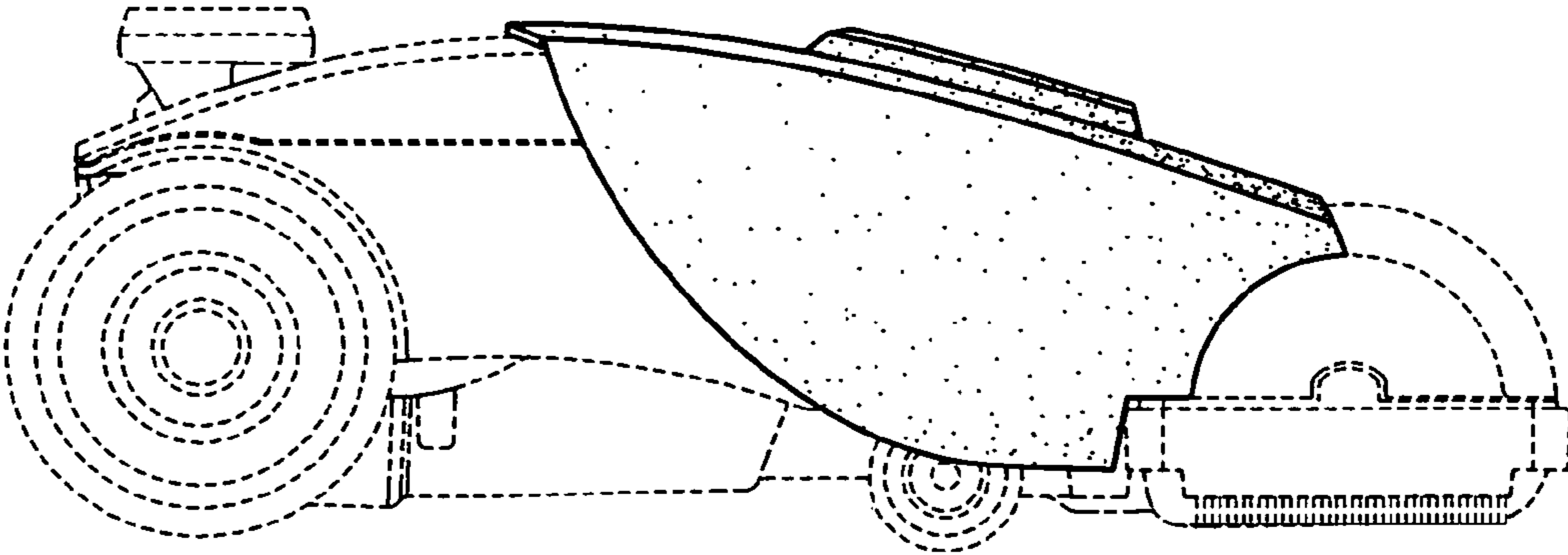

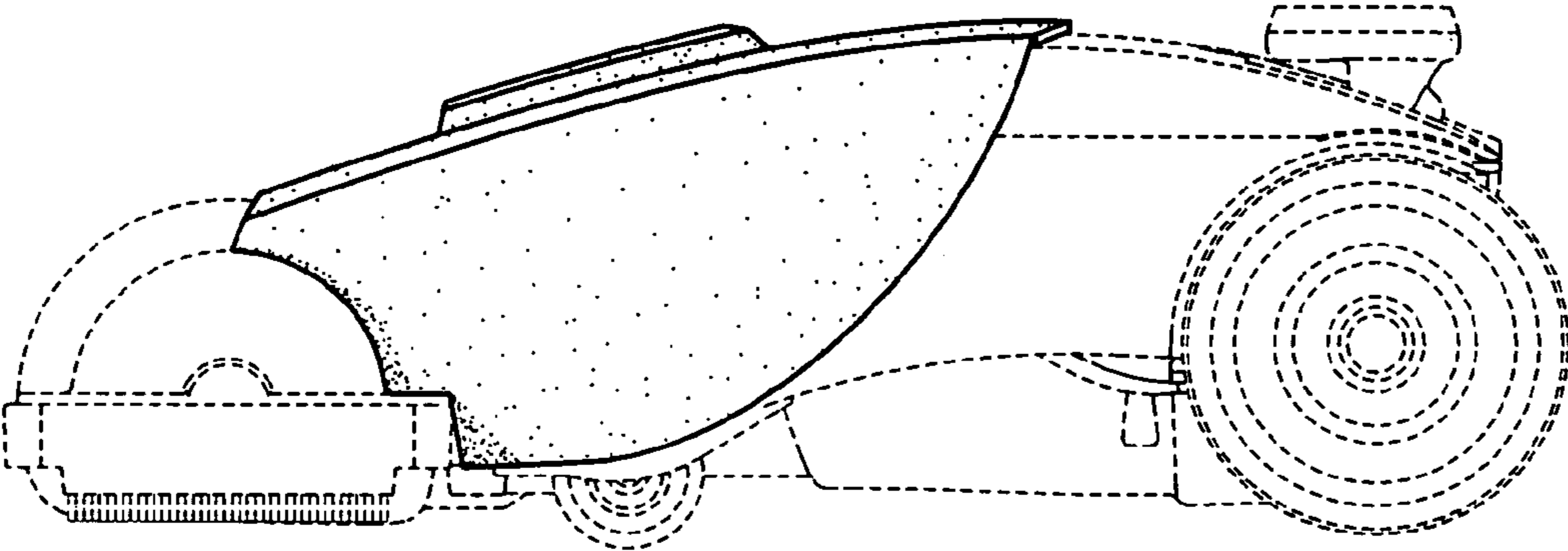
