(57) **CLAIM**

The ornamental design for a slot machine bank, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a slot machine bank in accordance with the present invention;

FIG. 2 is a front plan view of the slot machine bank illustrated in FIG. 1;

FIG. 3 is a first side view of the slot machine bank illustrated in FIG. 1;

FIG. 4 is a top plan view of the slot machine bank illustrated in FIG. 1;

FIG. 5 is a rear elevational view of the slot machine bank illustrated in FIG. 1;

FIG. 6 is a second side view of the slot machine bank illustrated in FIG. 1; and,

FIG. 7 is a bottom plan view of the slot machine bank illustrated in FIG. 1.

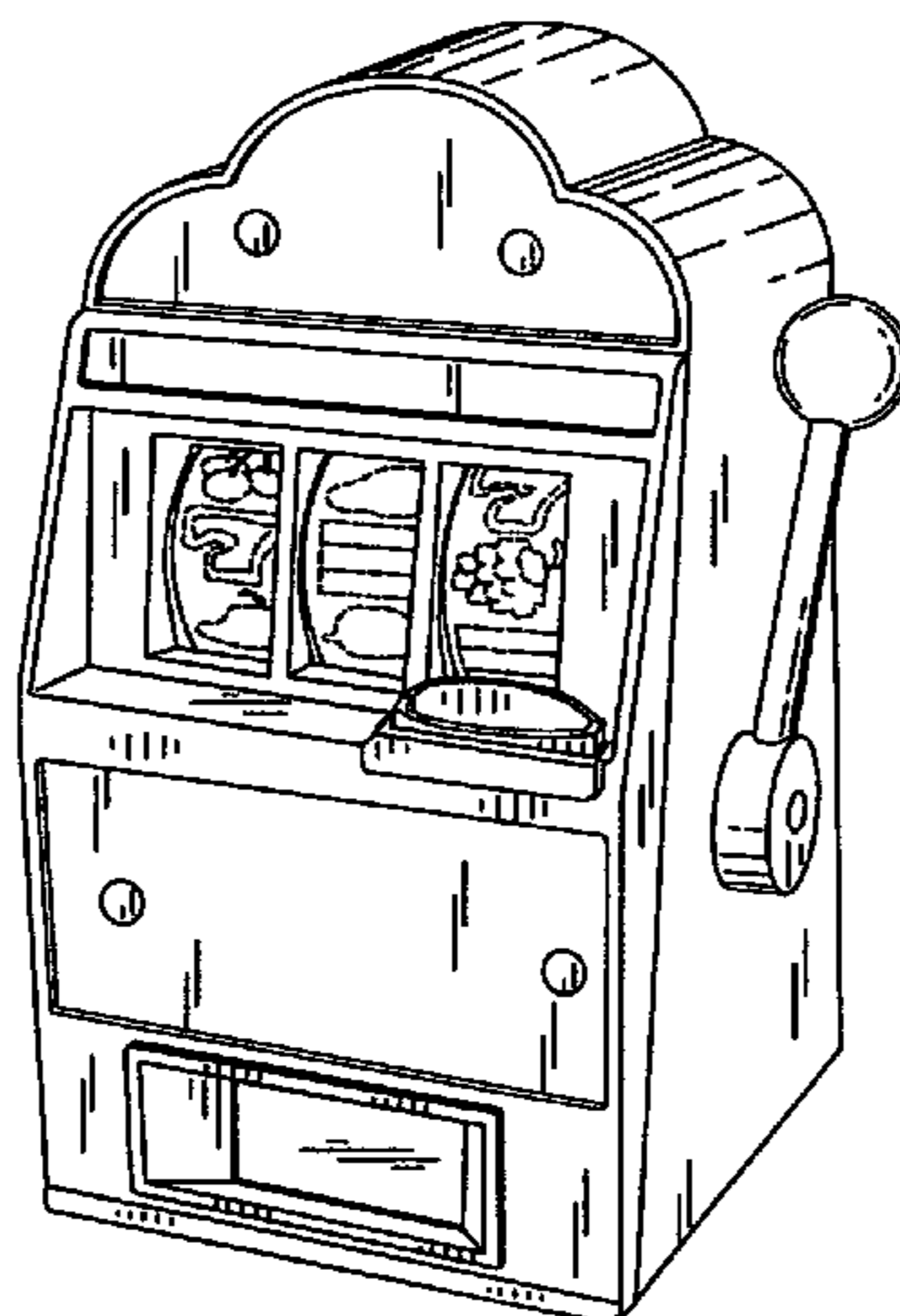

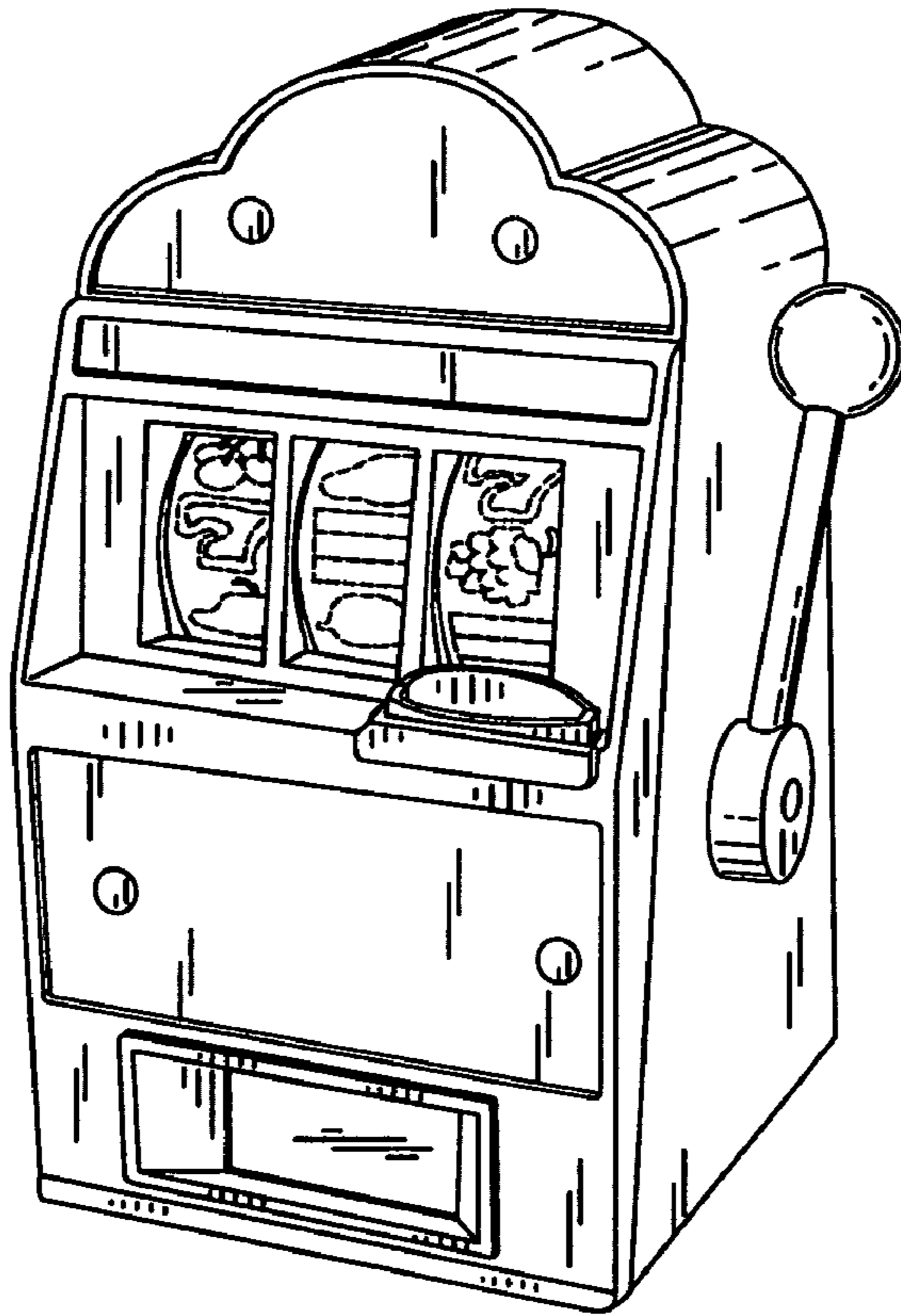

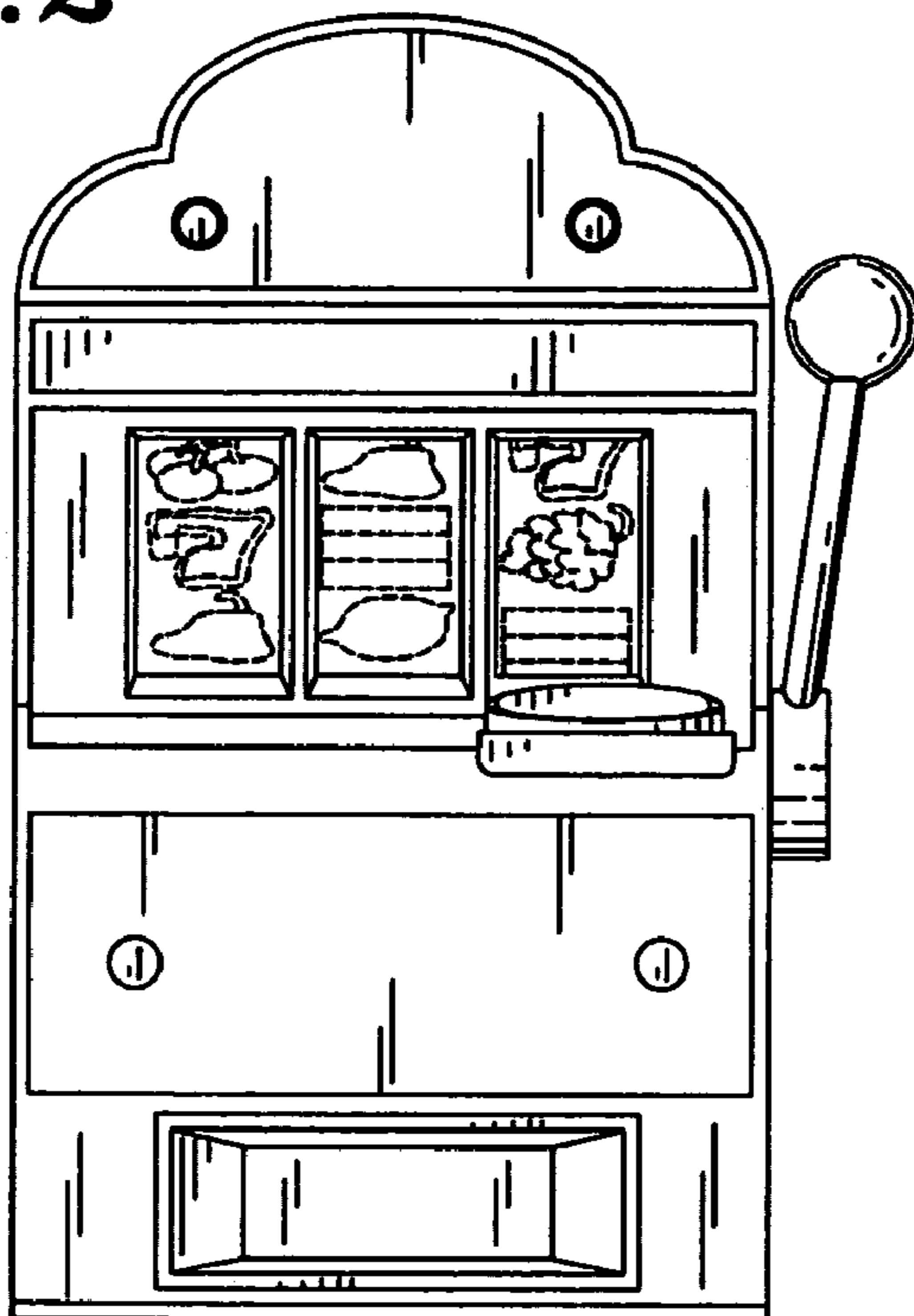
