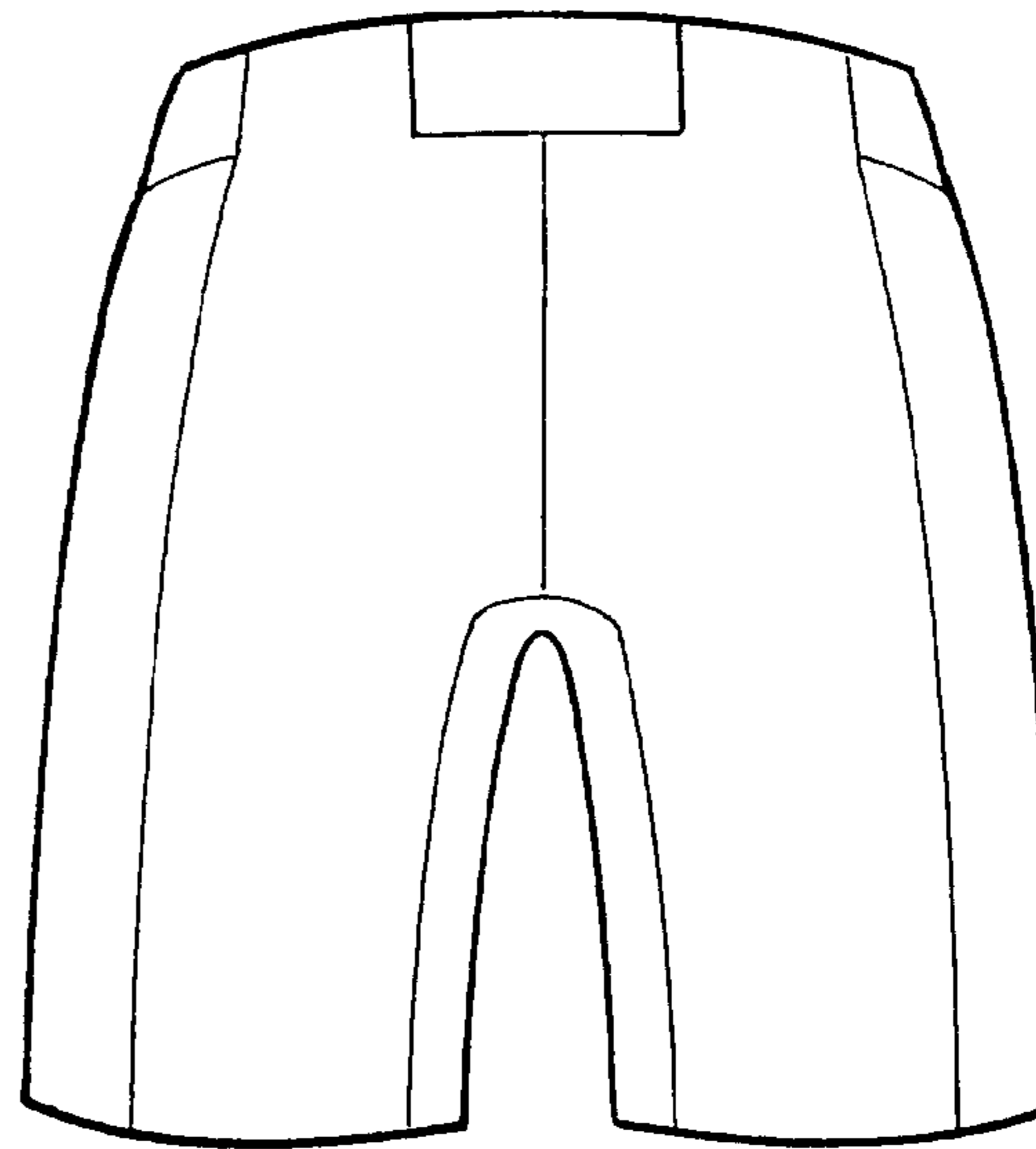
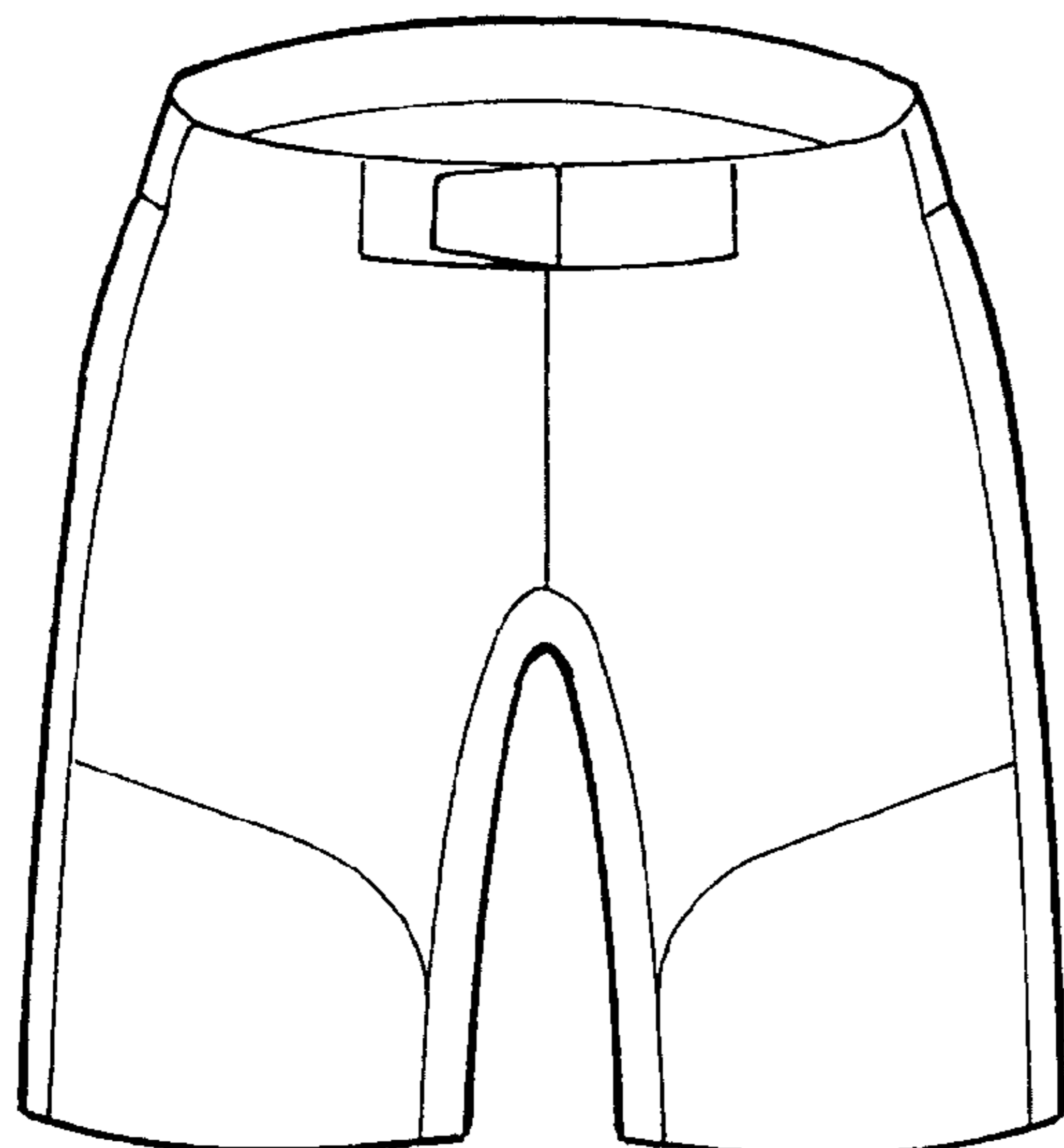
I claim the ornamental design for a garment, as shown and described.

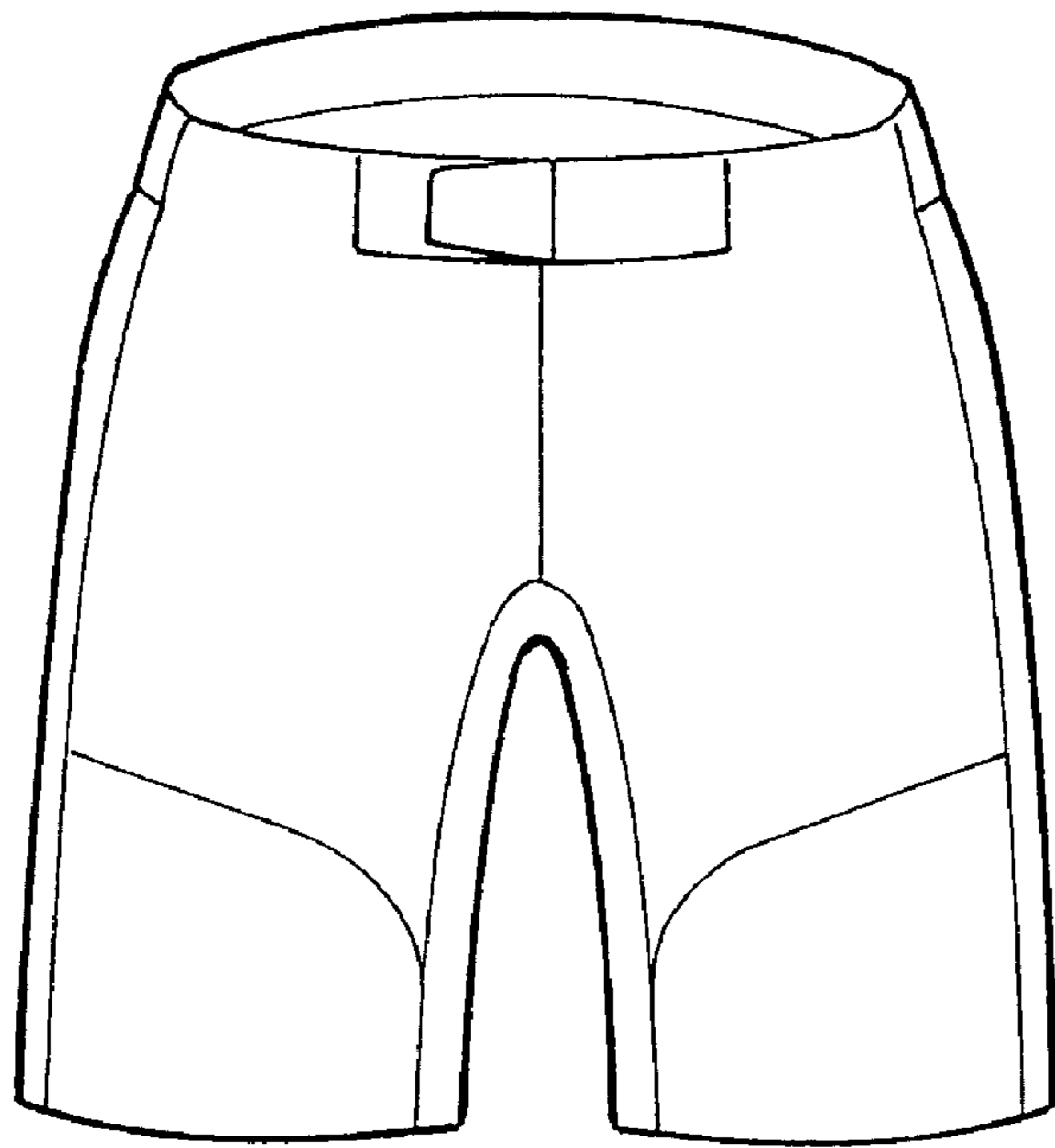

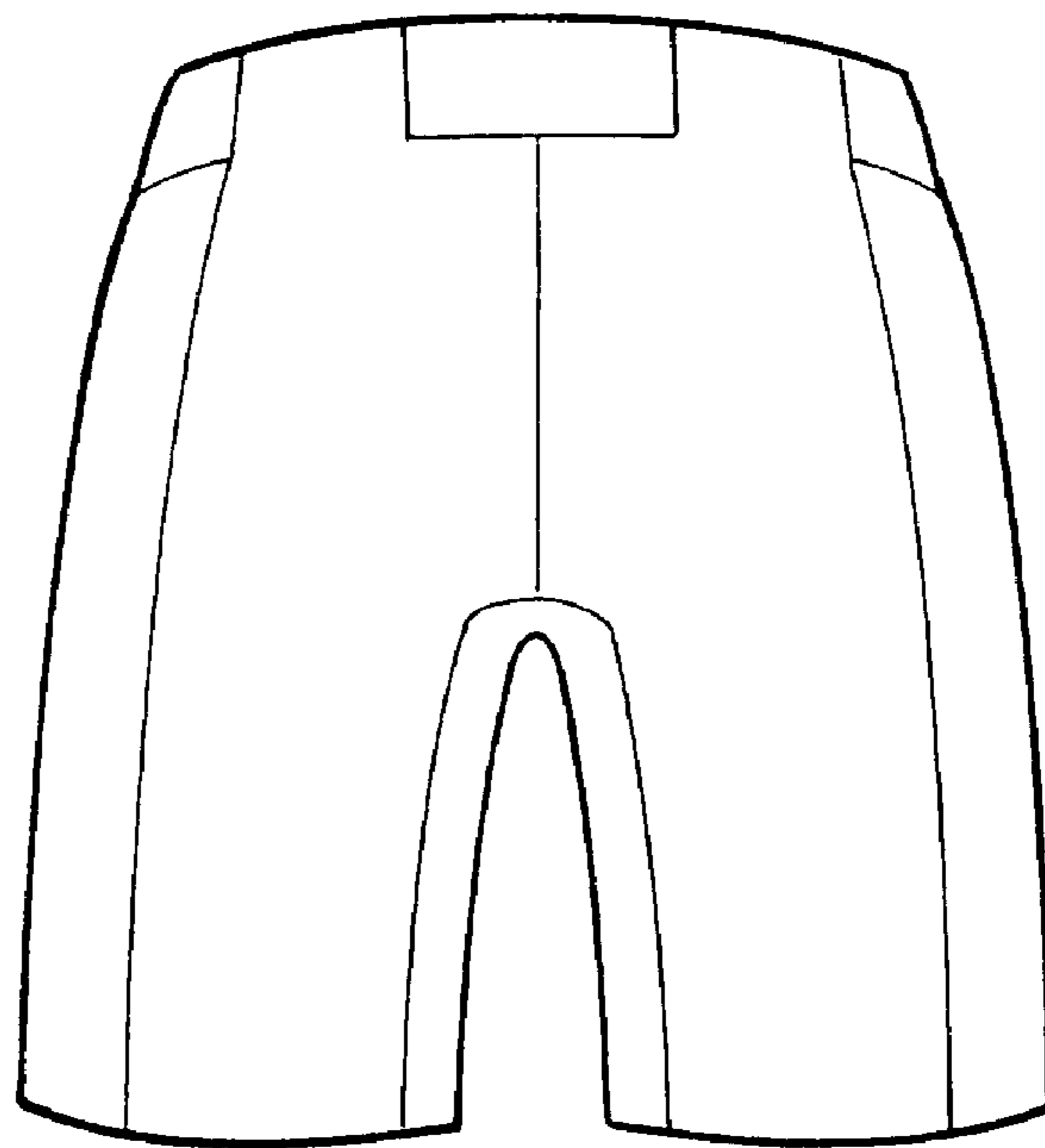
