(57) **CLAIM**

The ornamental design for a cap with adjustable band and hair access opening, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a back elevational view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a top plan view thereof; and,

FIG. 6 is a bottom plan view thereof.

The broken lines are meant to represent stitching.

The pattern shown intermittently across the surfaces of the claimed design is meant to represent fabric, and is intended to be applied to the entire surface of the claimed design.

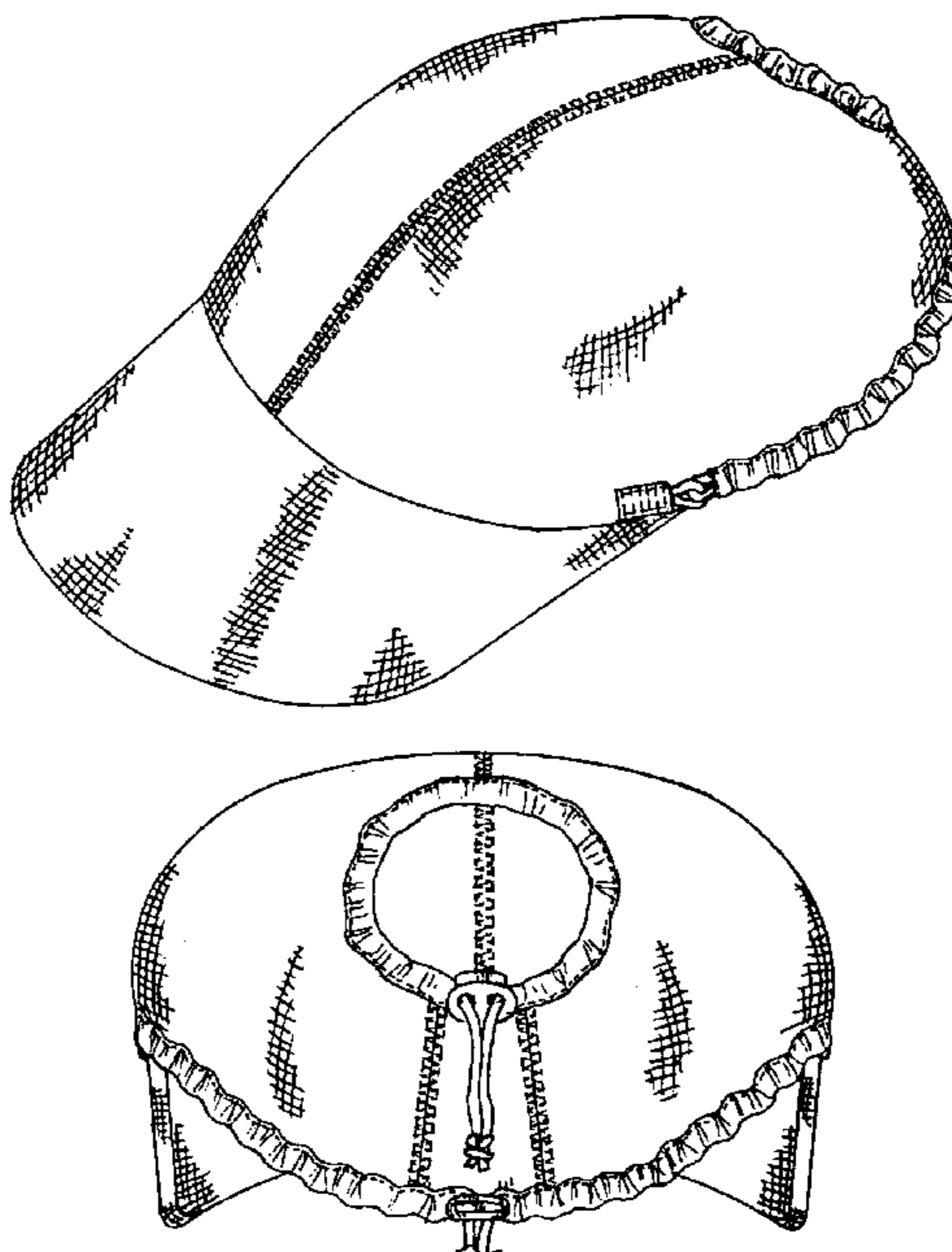

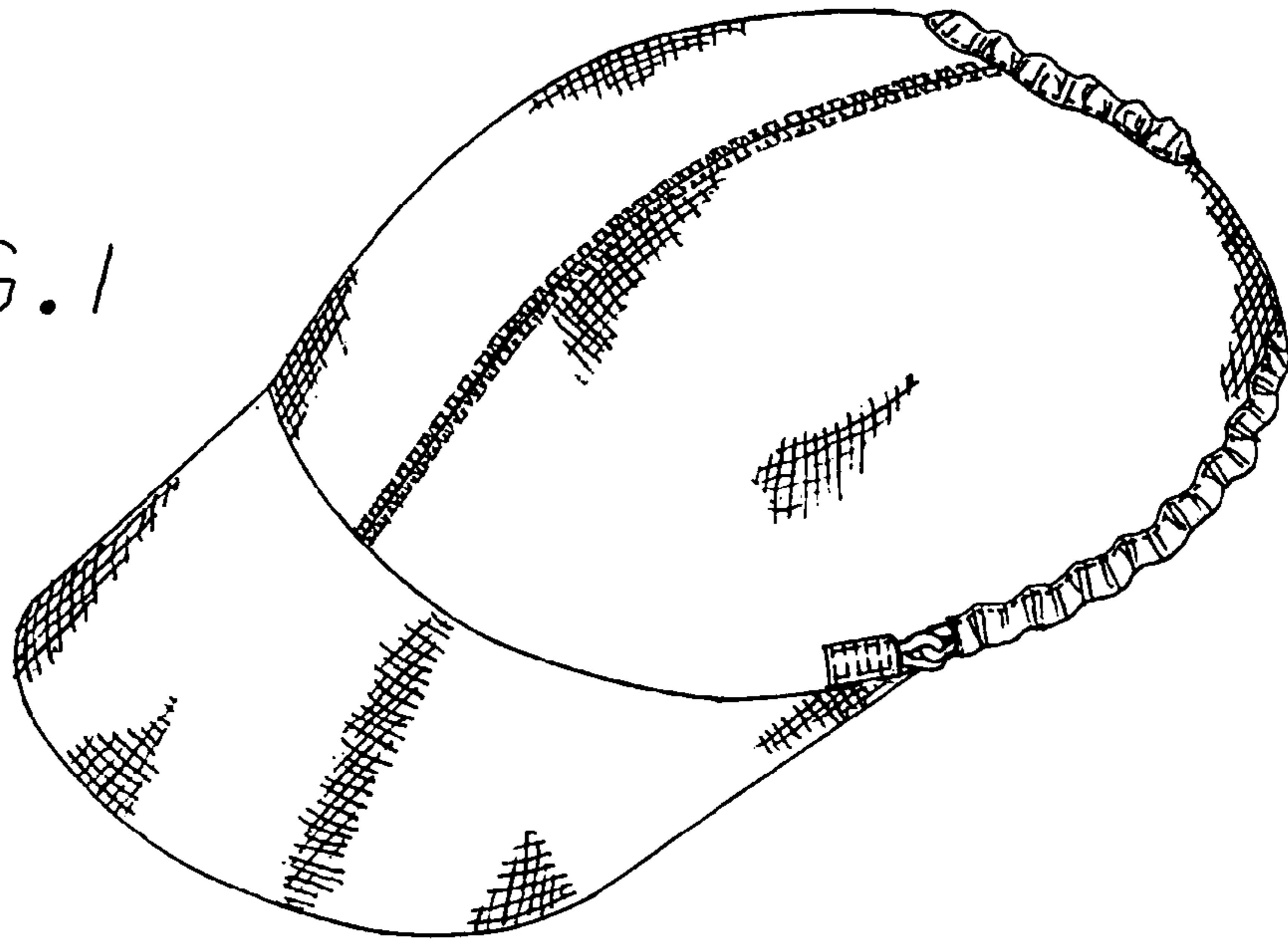

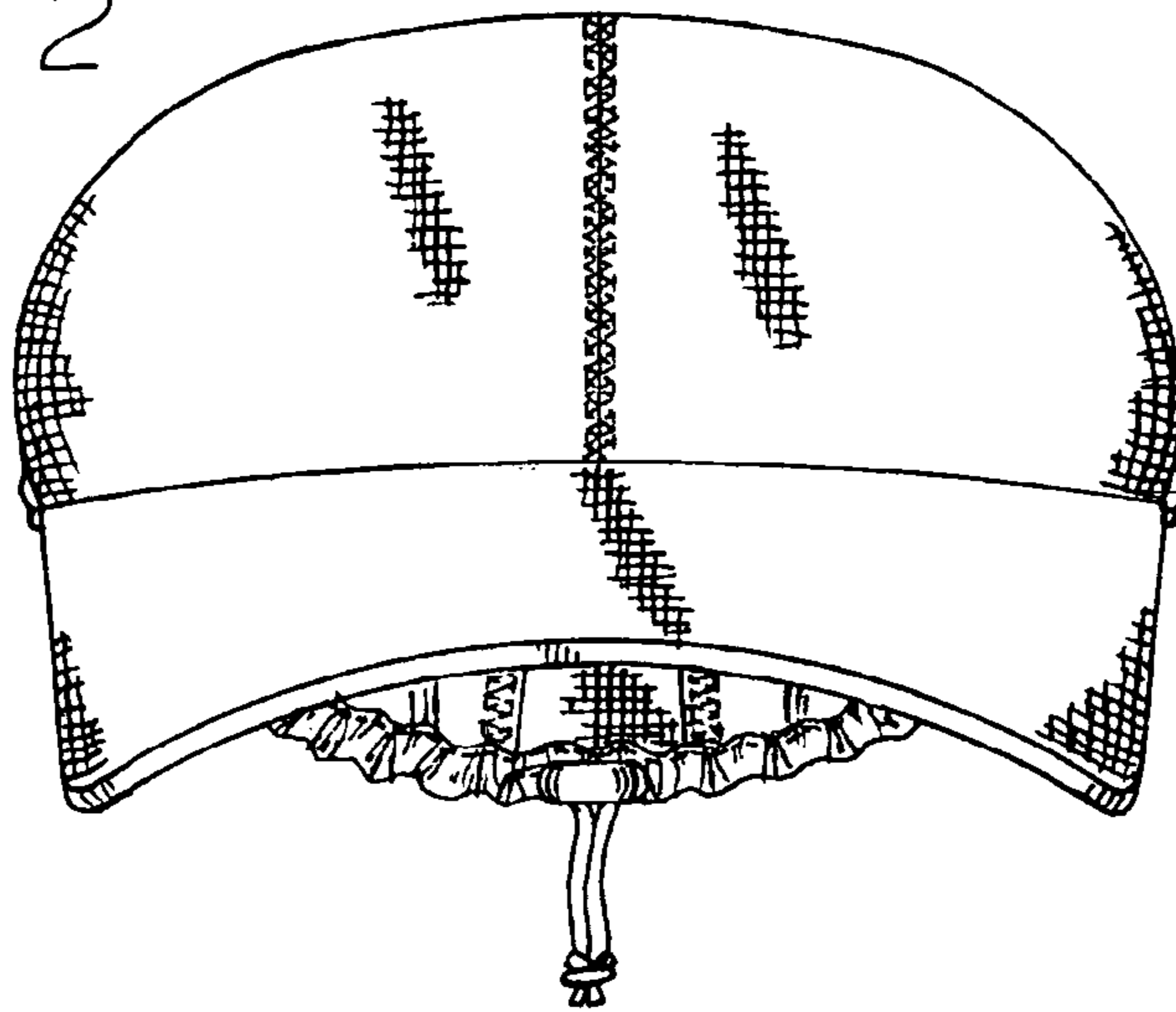

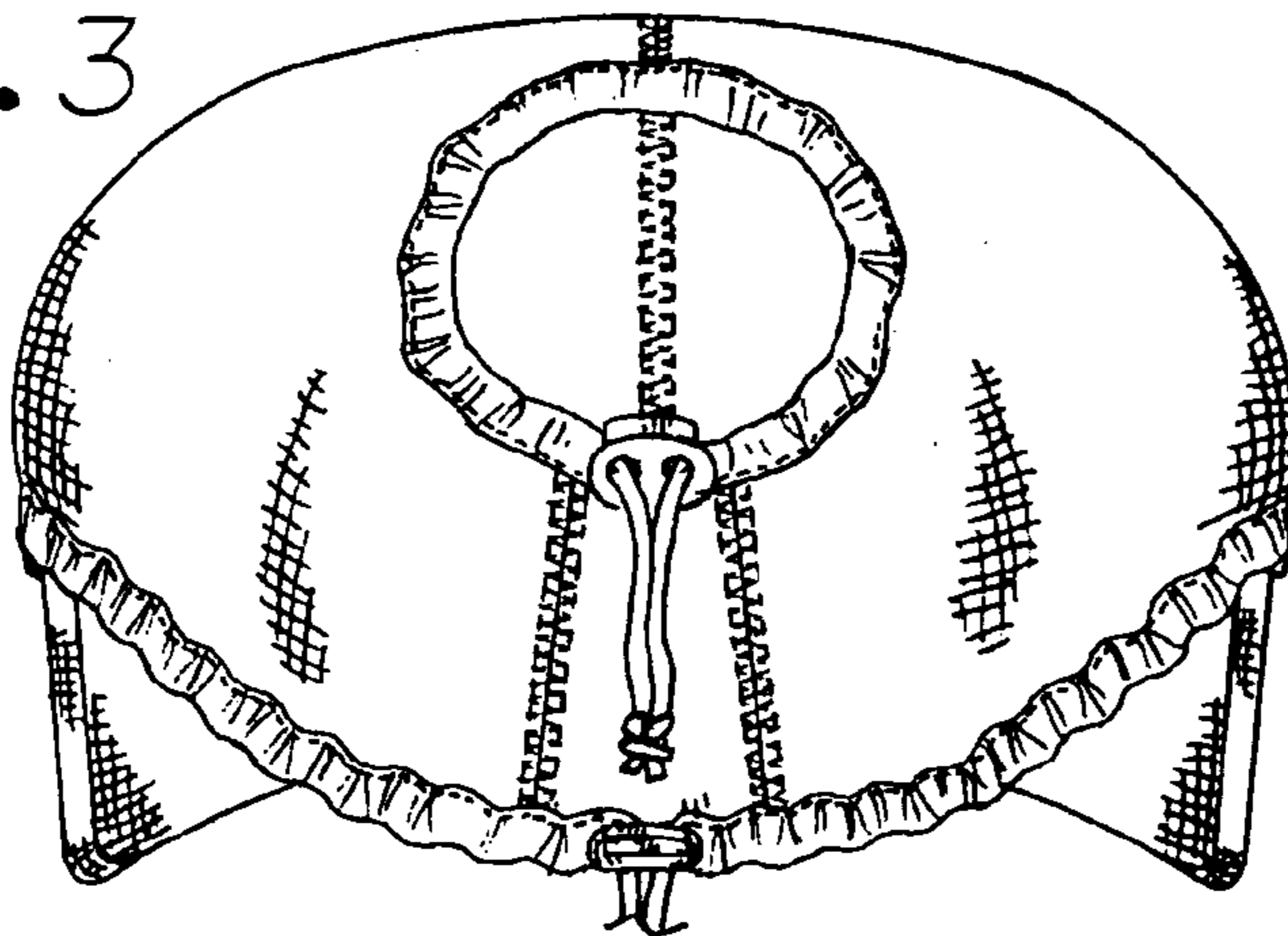

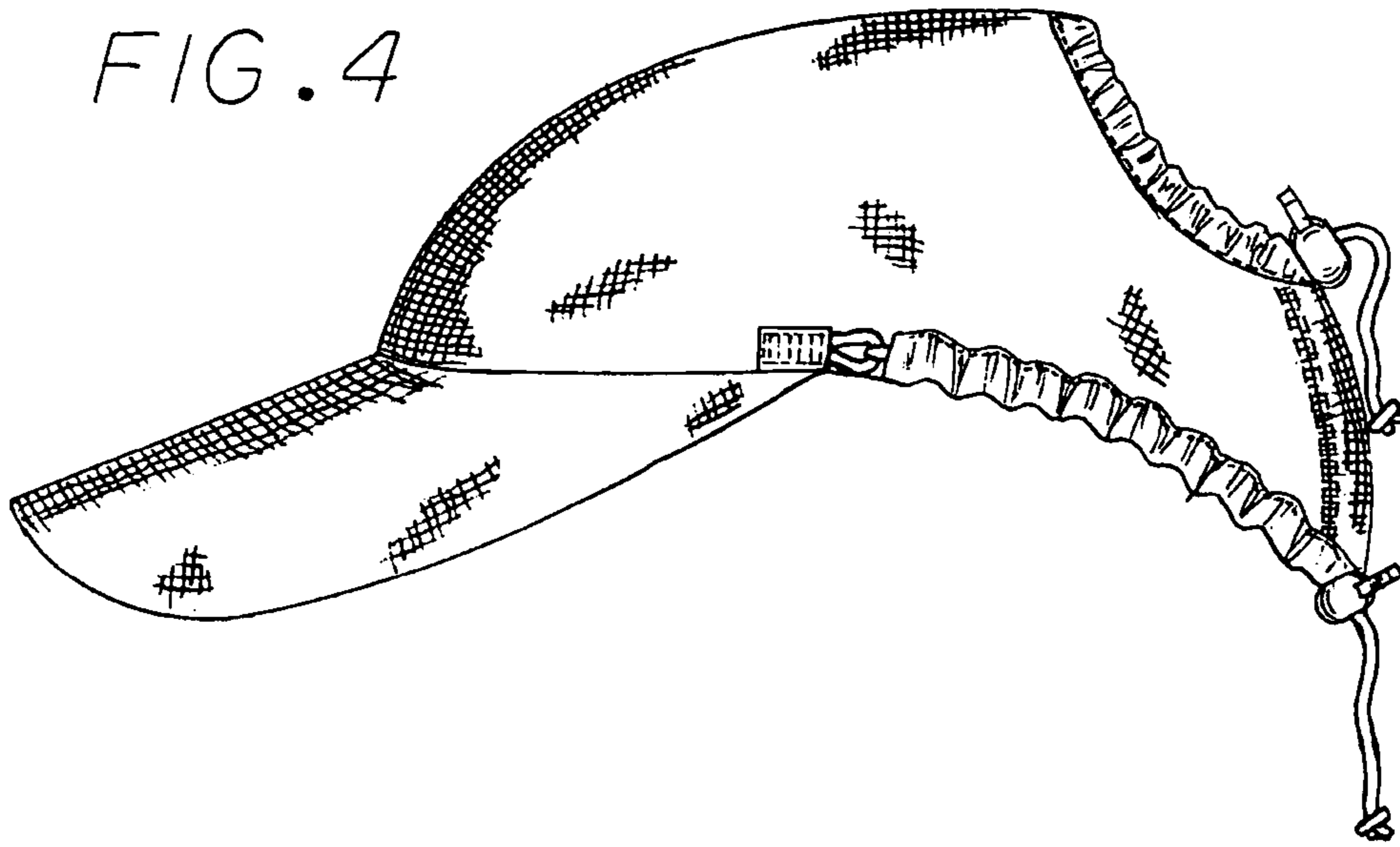

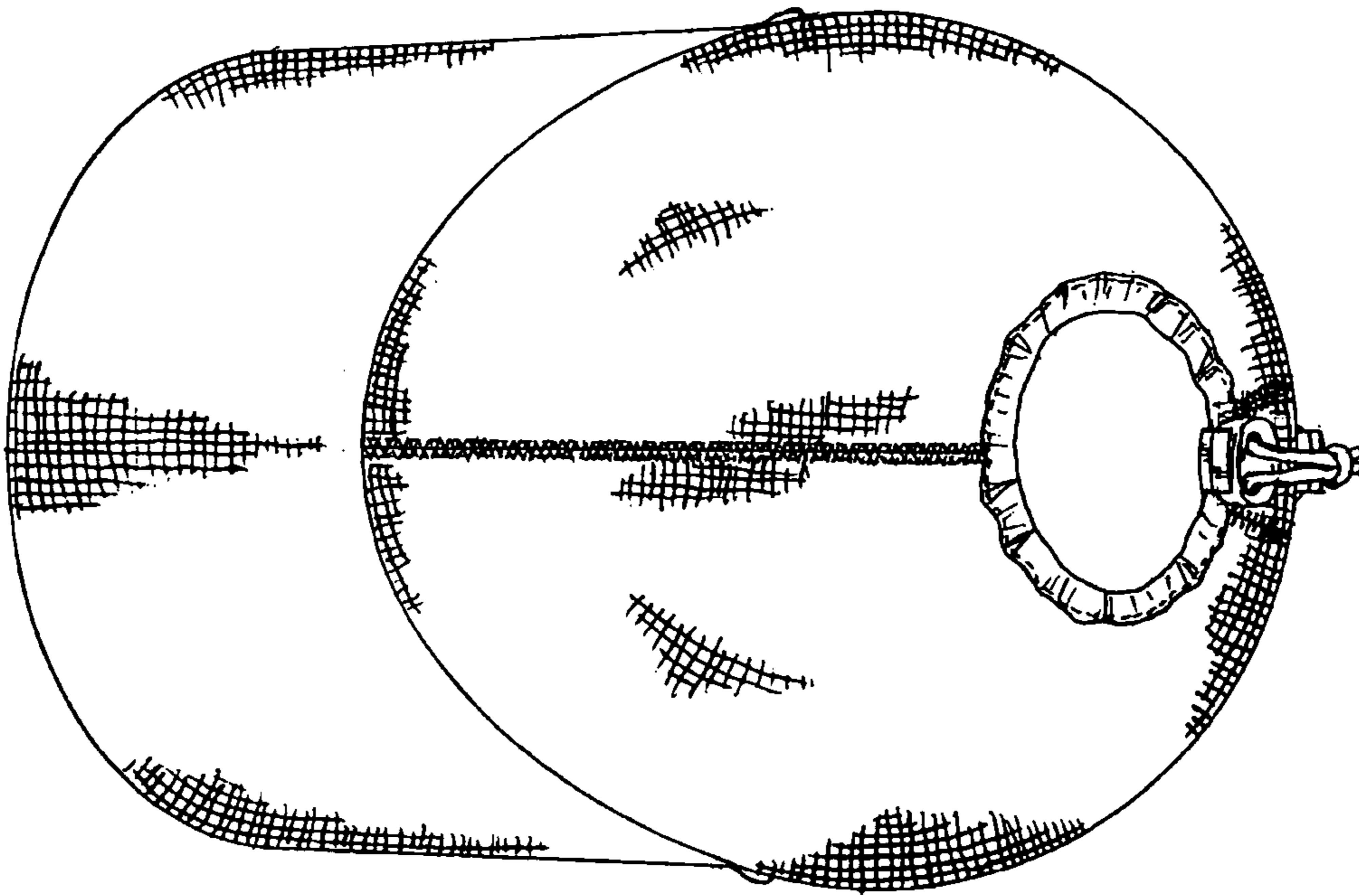
