(57) **CLAIM**

The ornamental design for a handbag, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of my new design, showing the handbag in a non-expanded condition;

FIG. 2 is a right side elevation view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a rear elevation view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view of the design, similar to that of FIG. 1, but showing the handbag in an expanded condition;

FIG. 8 is a right side elevation view thereof;

FIG. 9 is a front elevation view thereof;

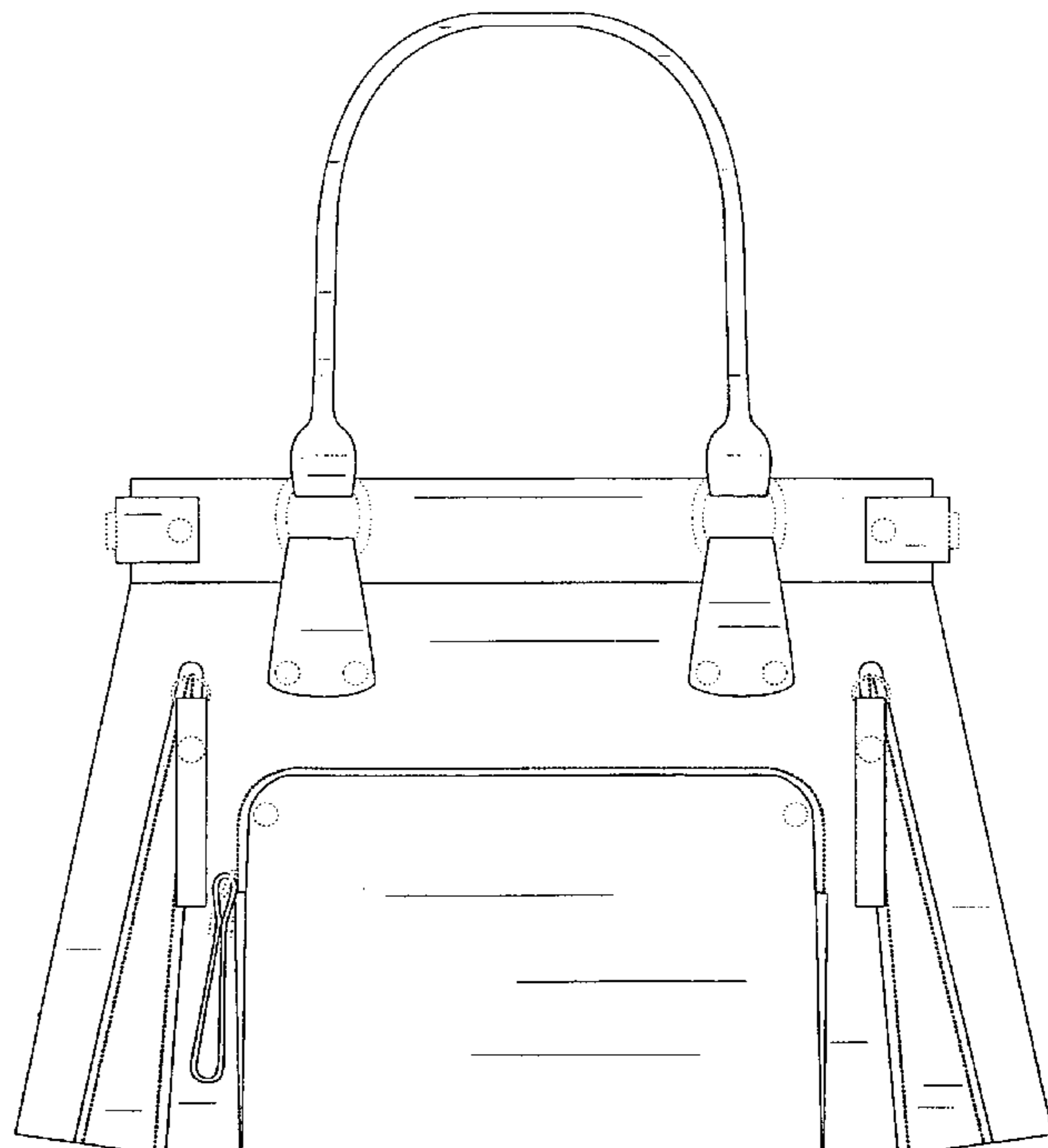
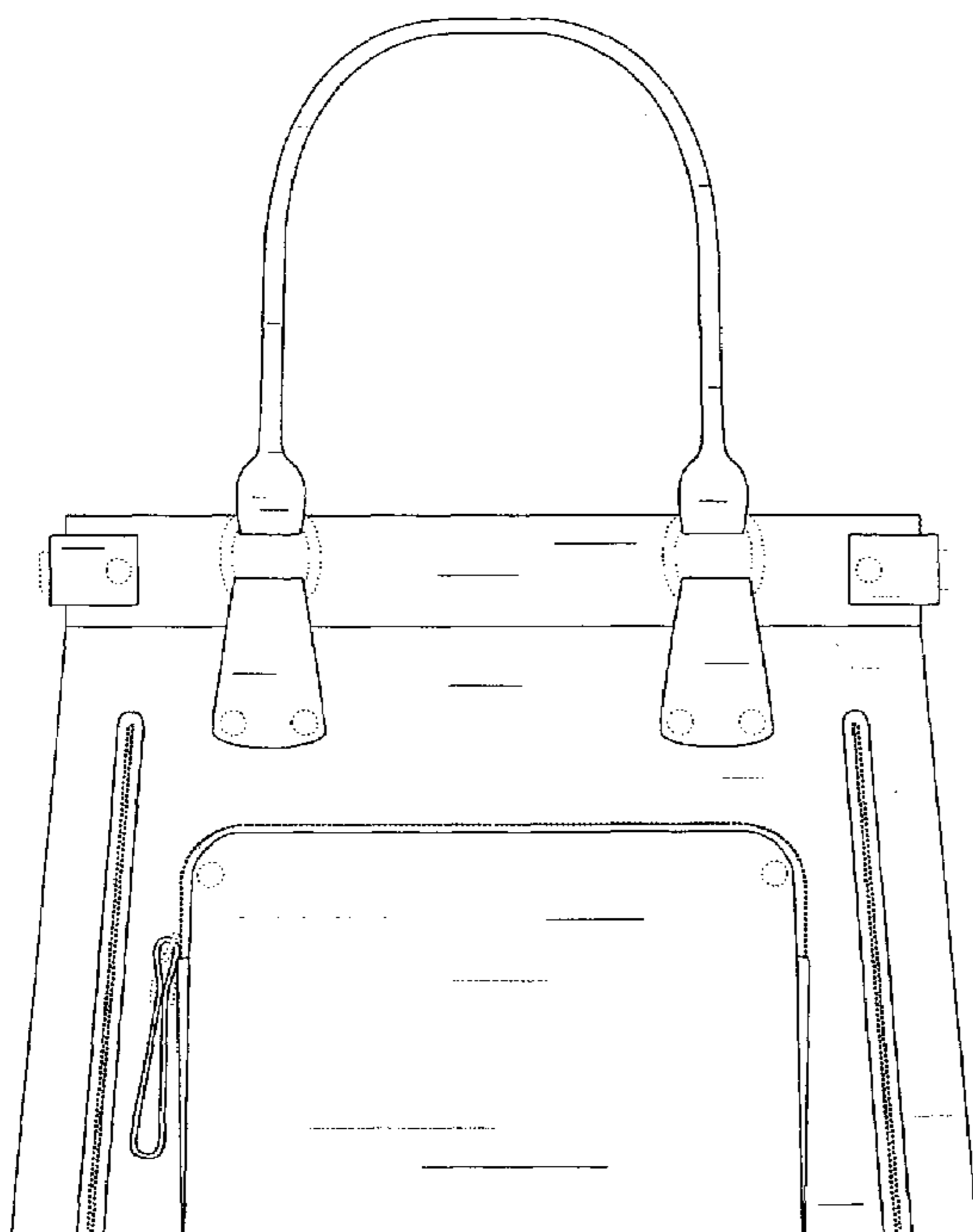
FIG. 10 is a left side elevation view thereof;

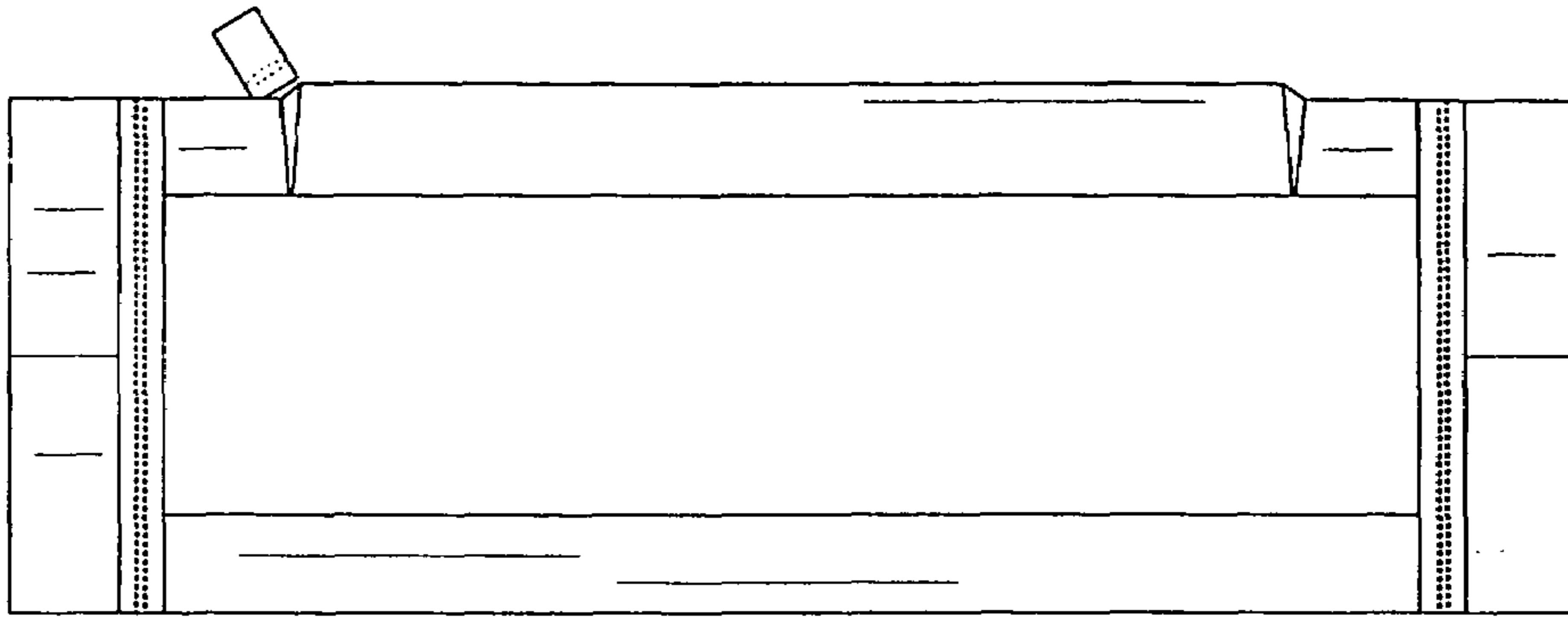

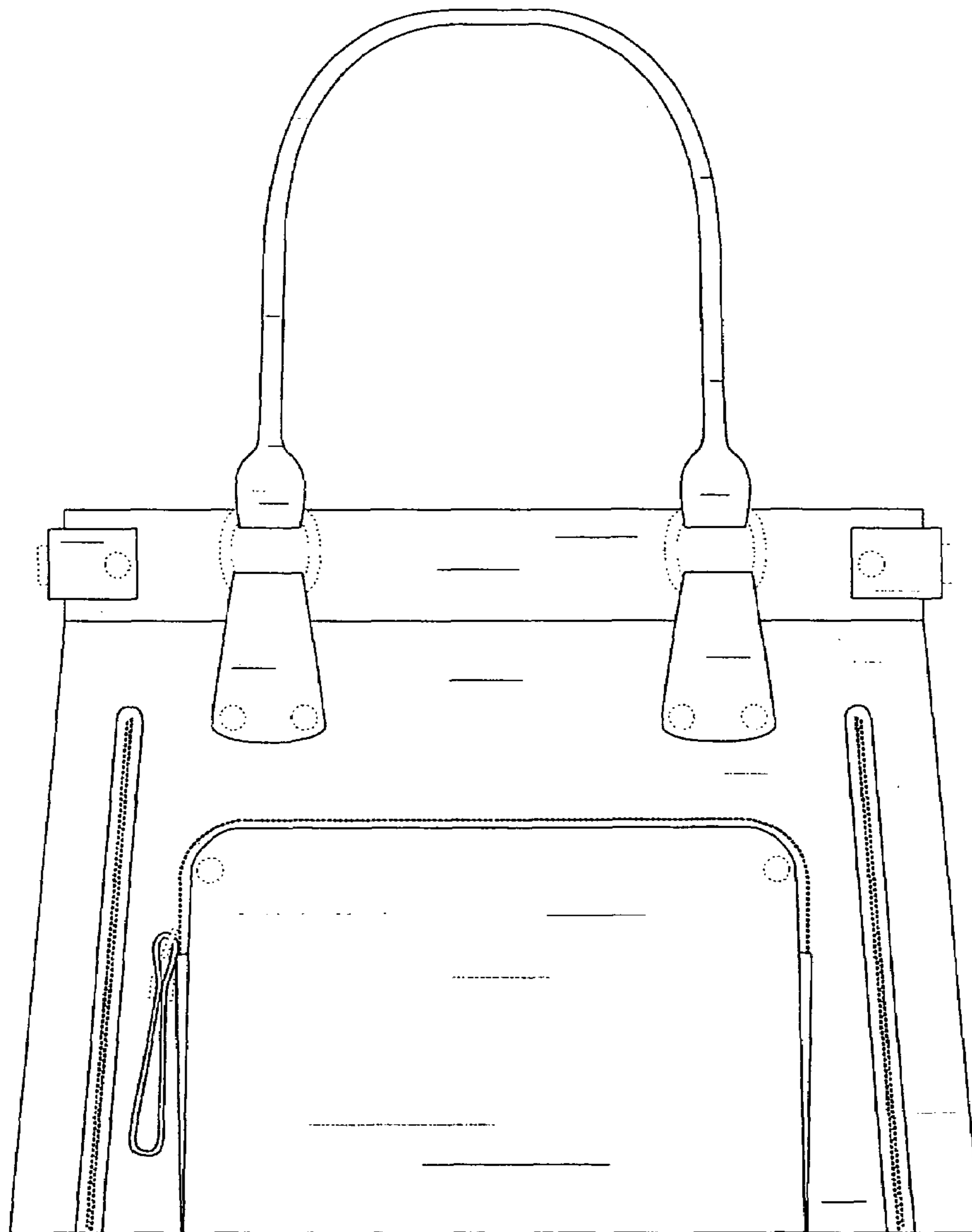

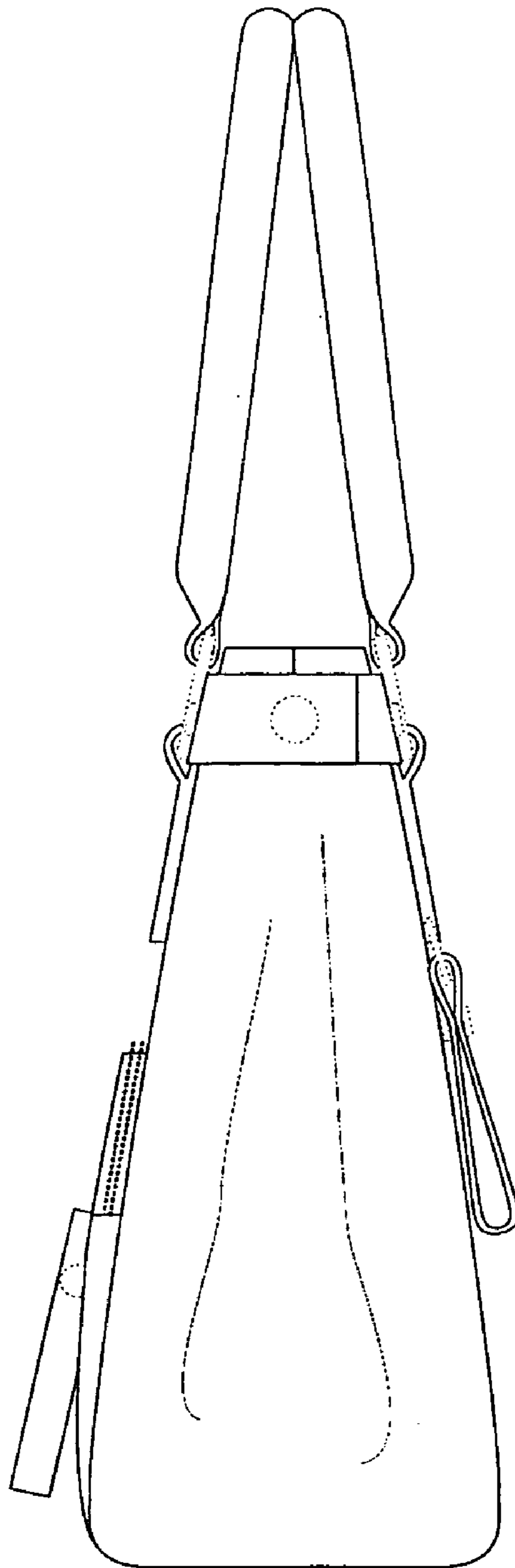

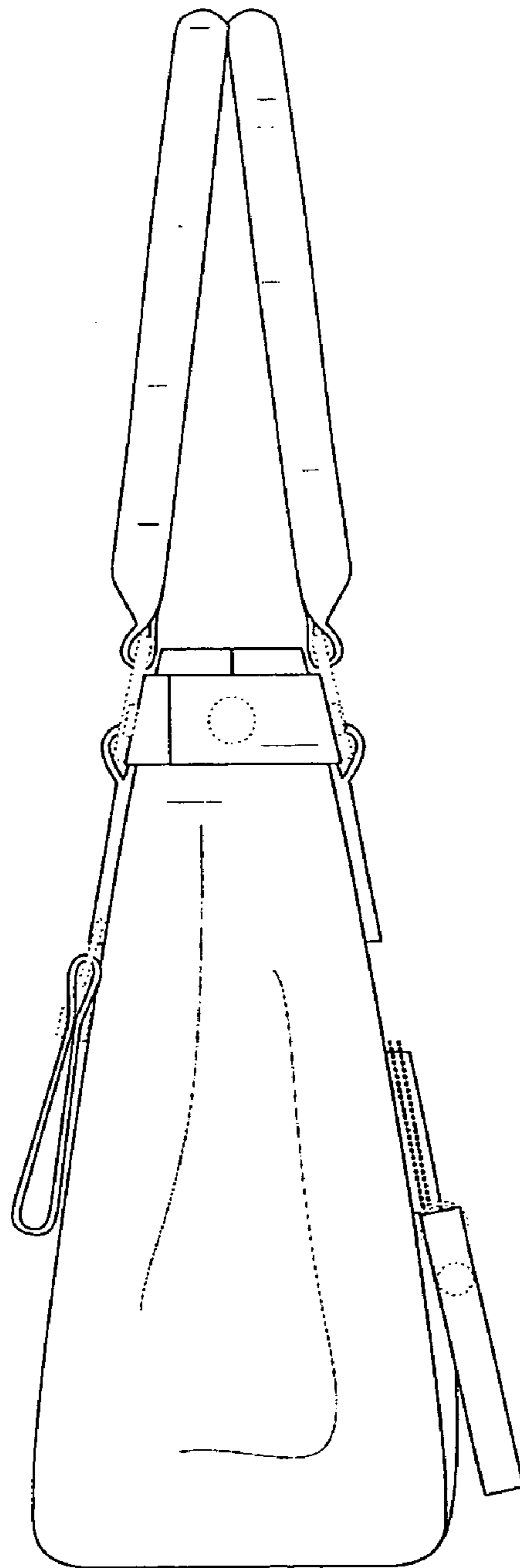

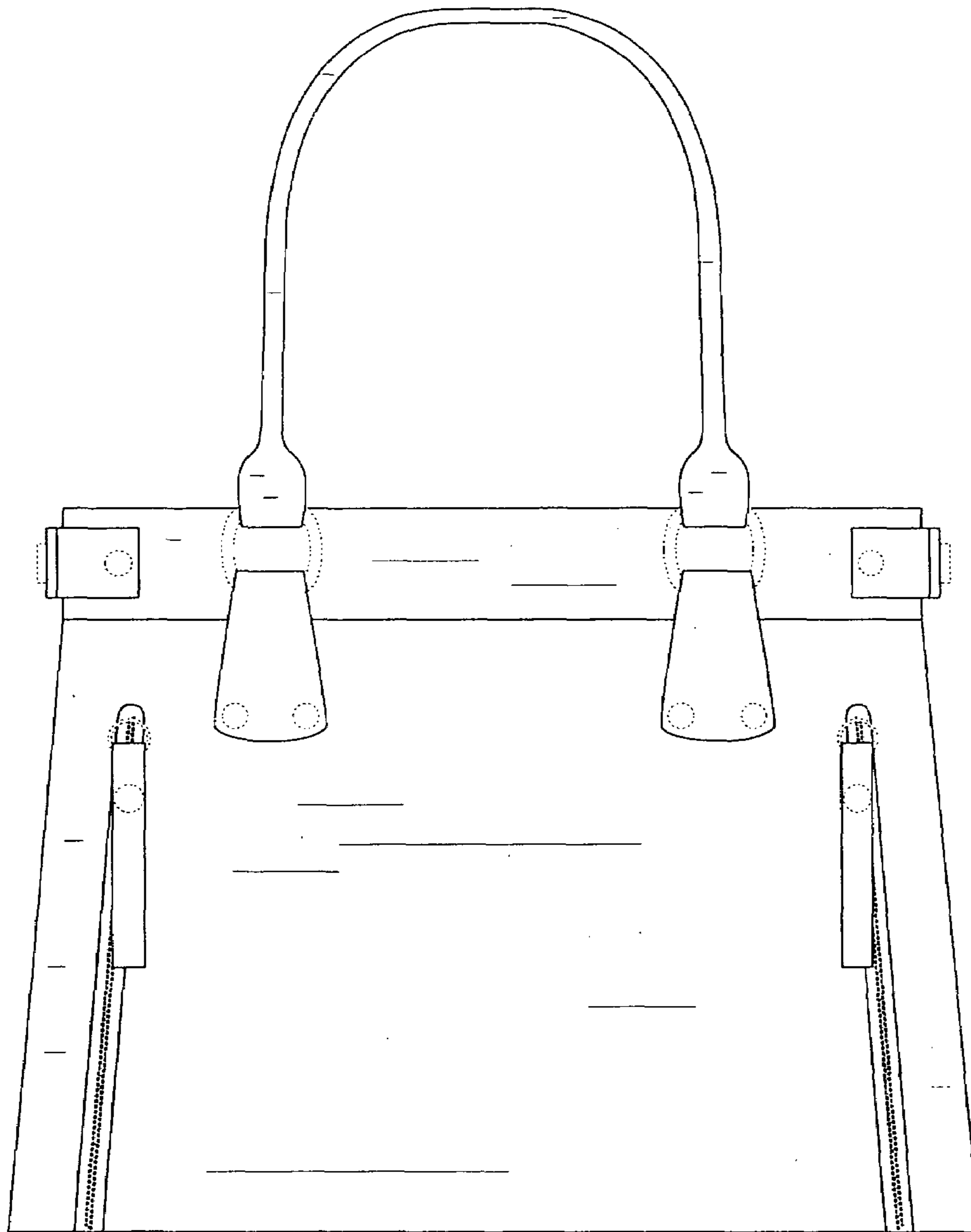

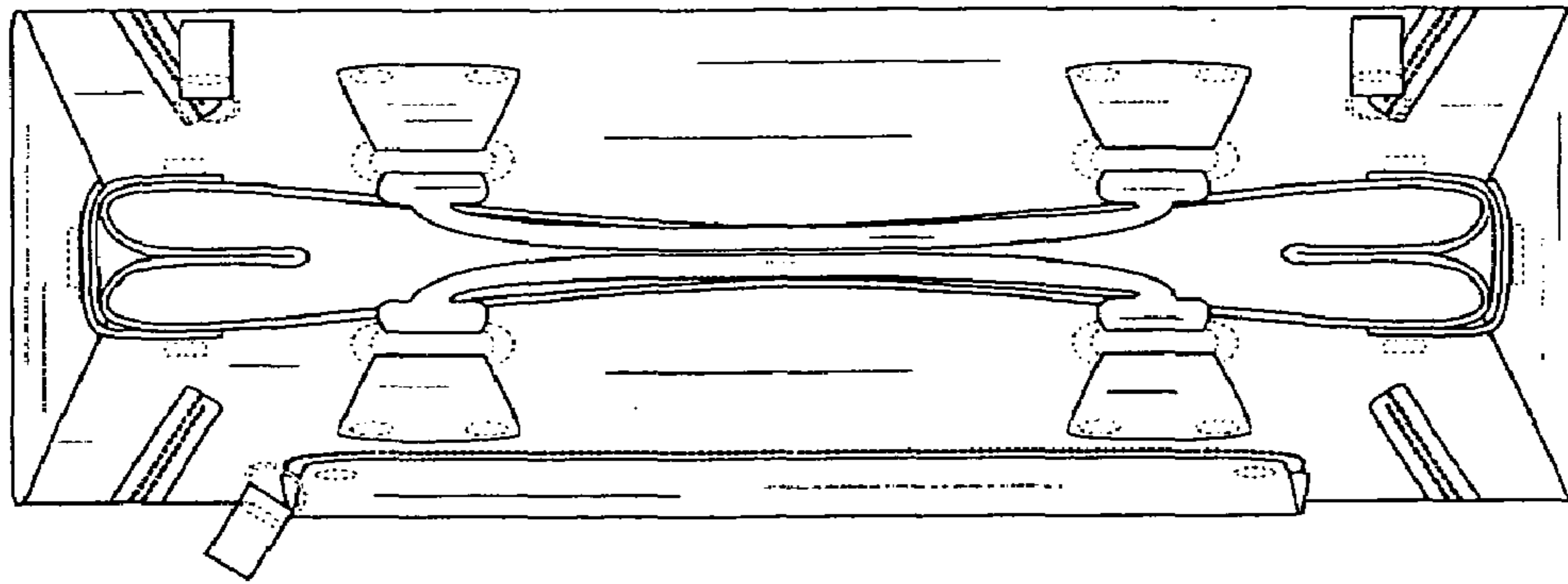

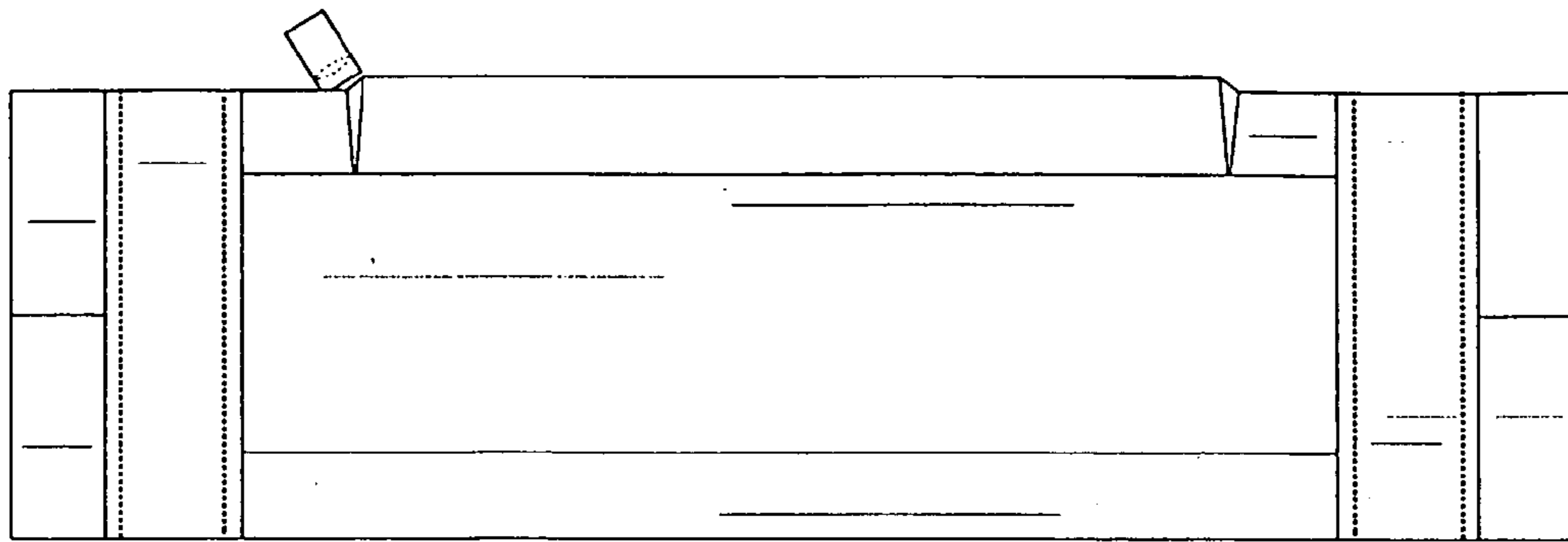

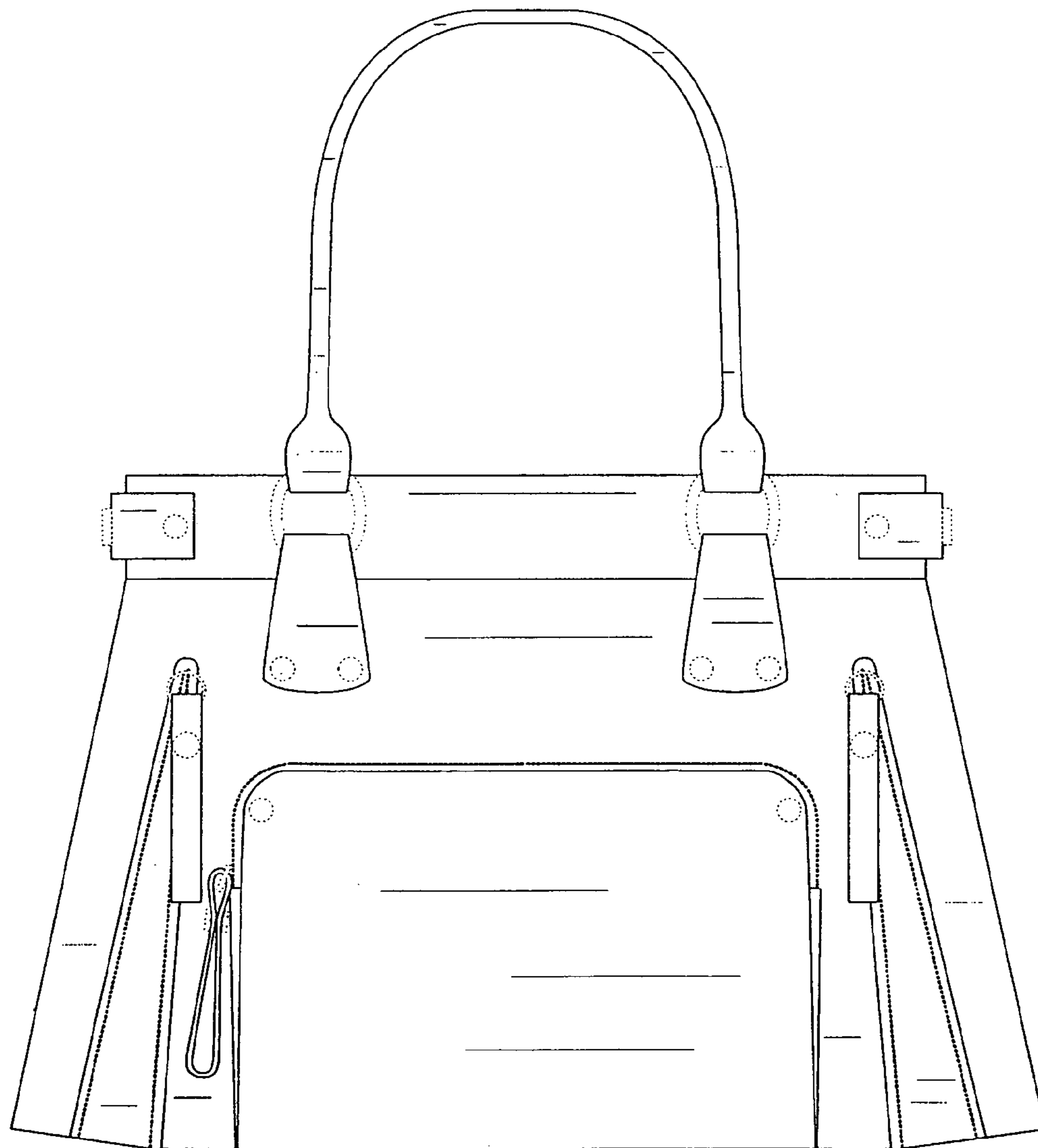

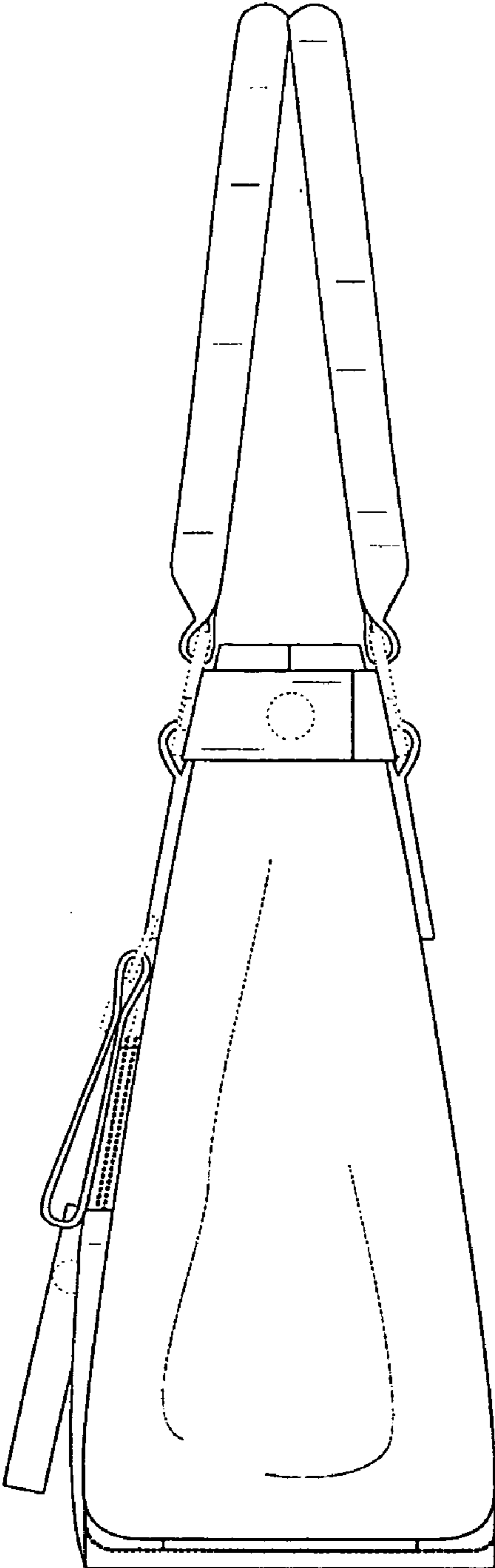

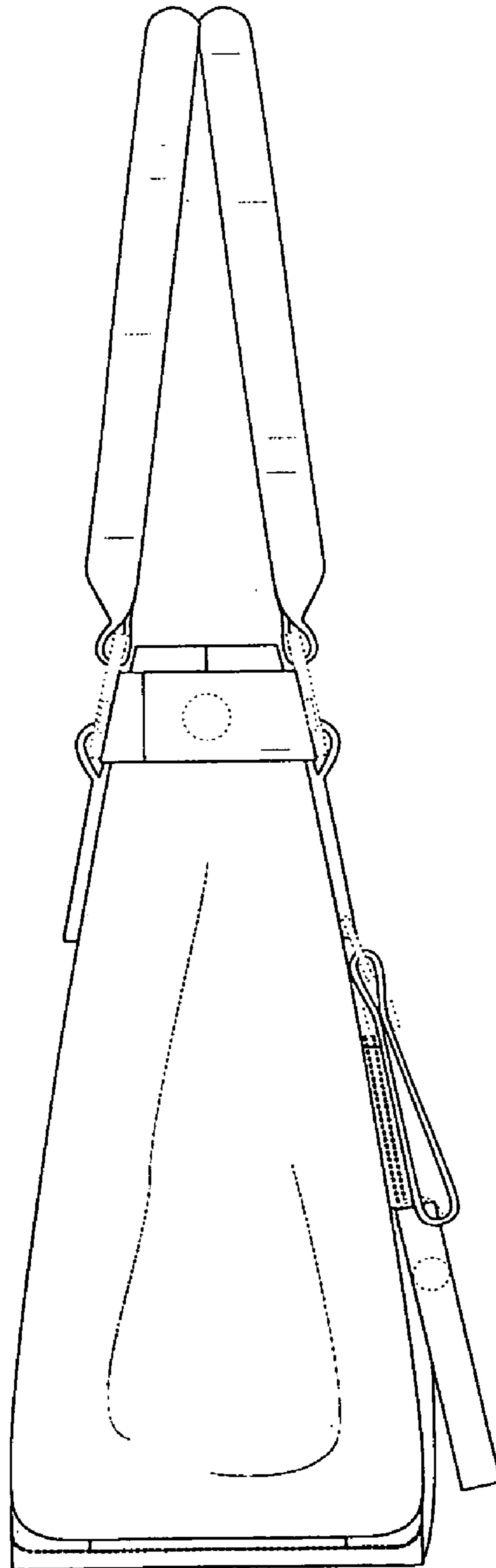

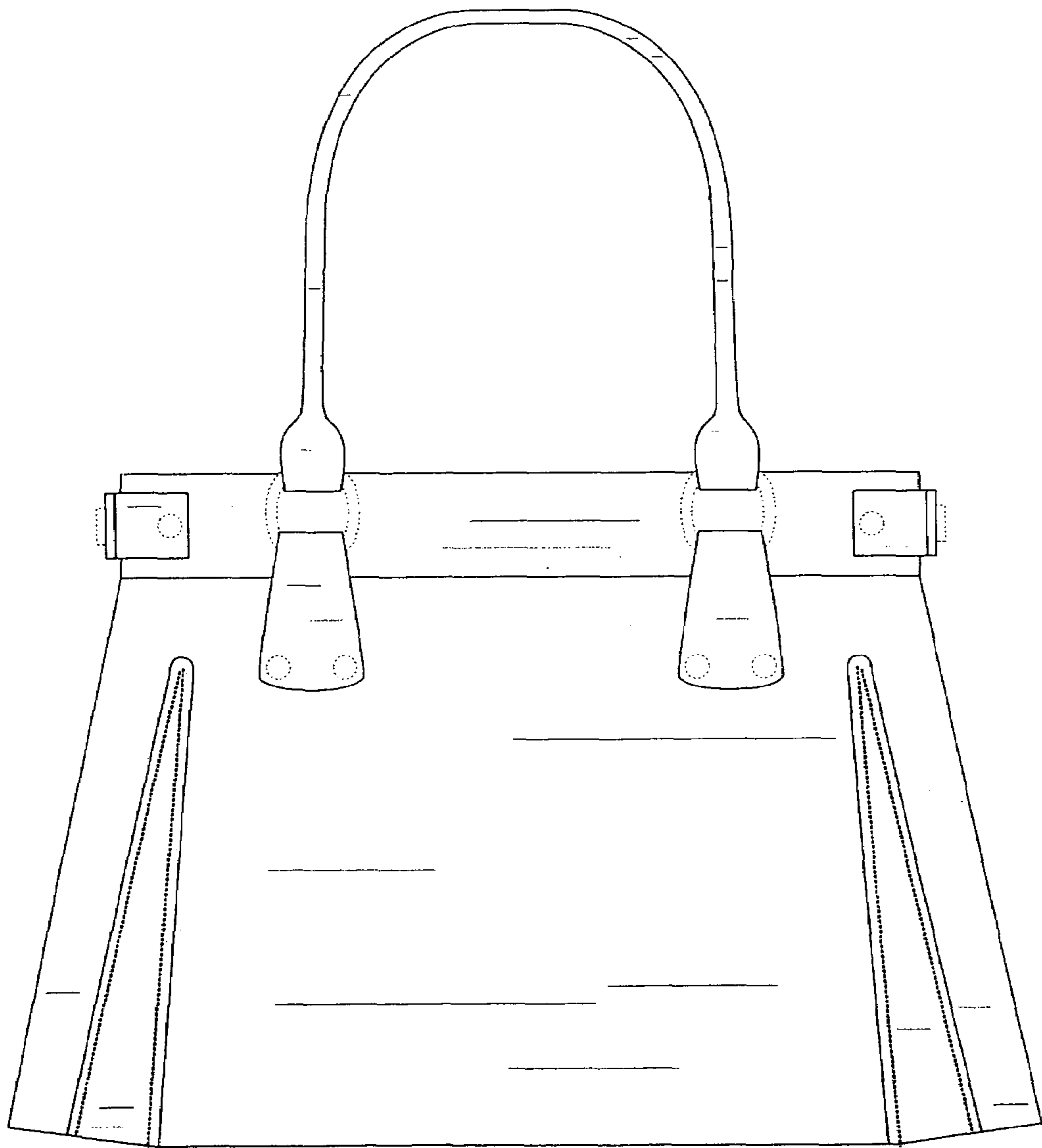

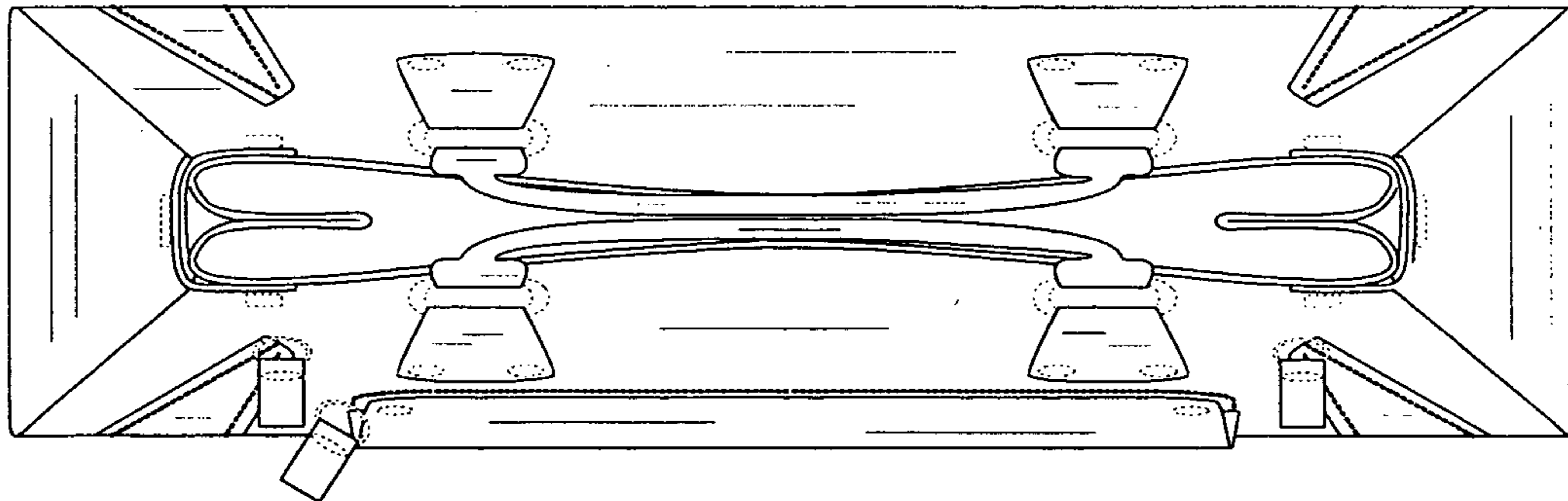
