FIG. 1 is front view of the garment hanger showing my new design;

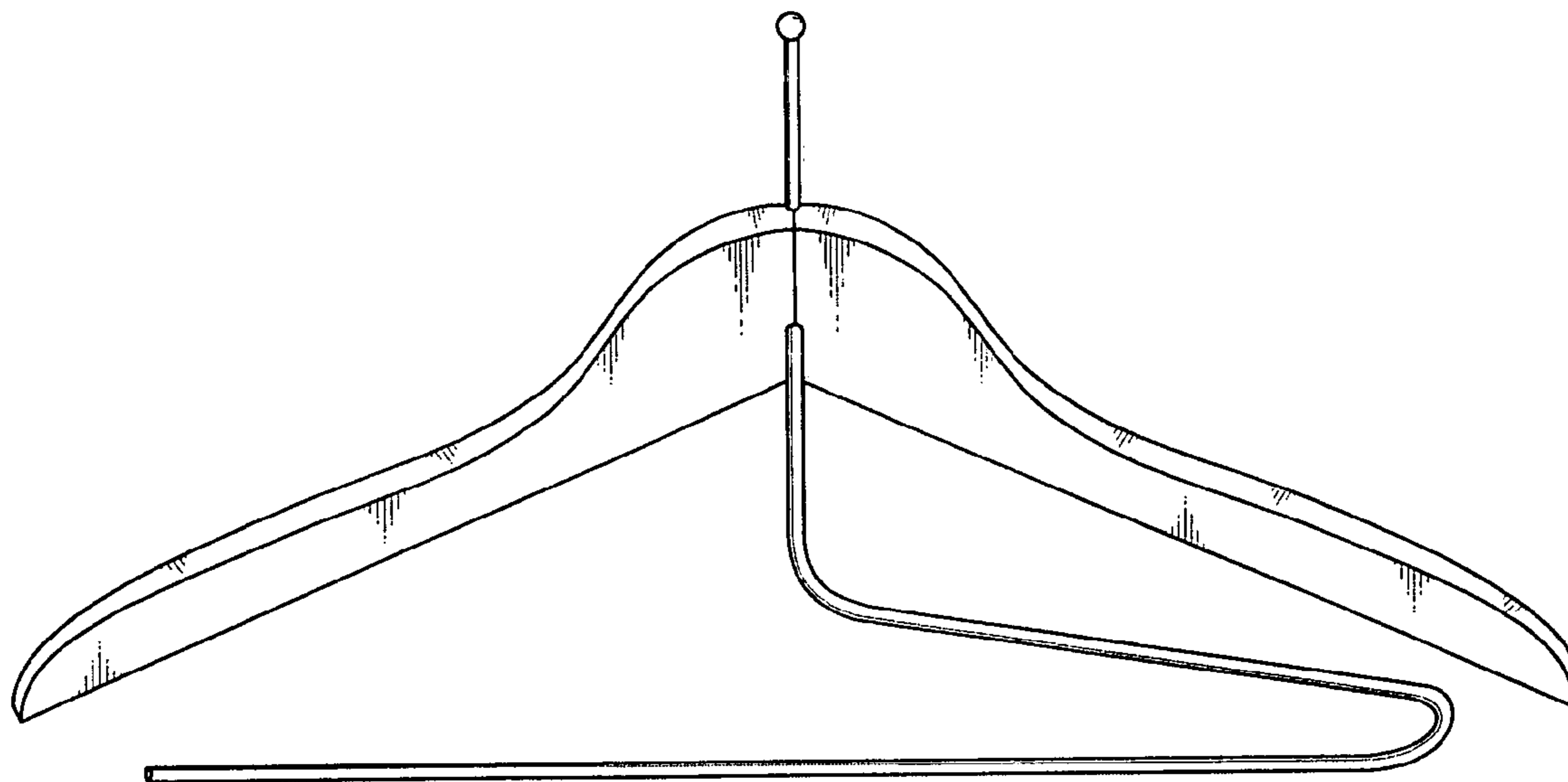
FIG. 2 is a top view thereof;

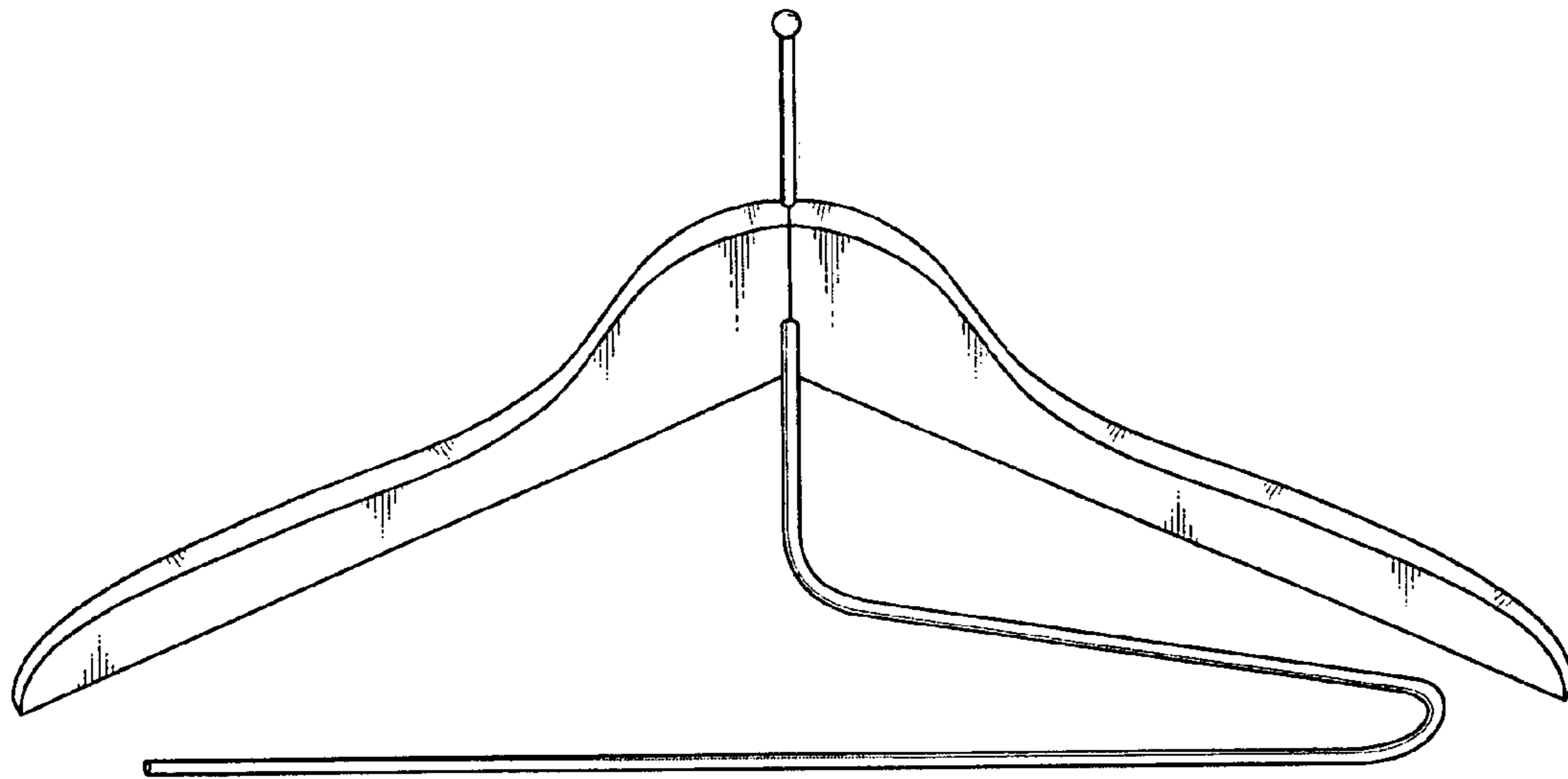

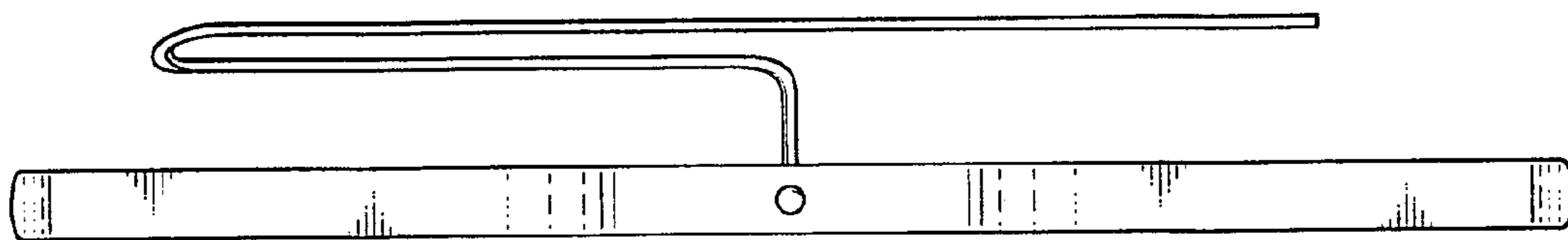

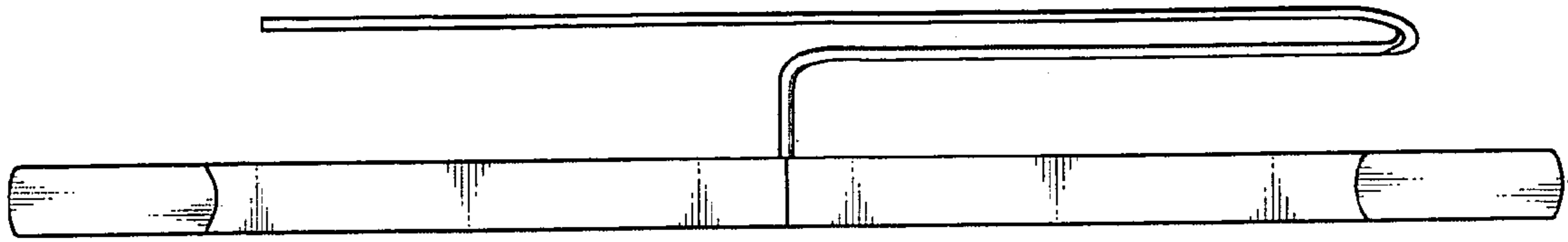

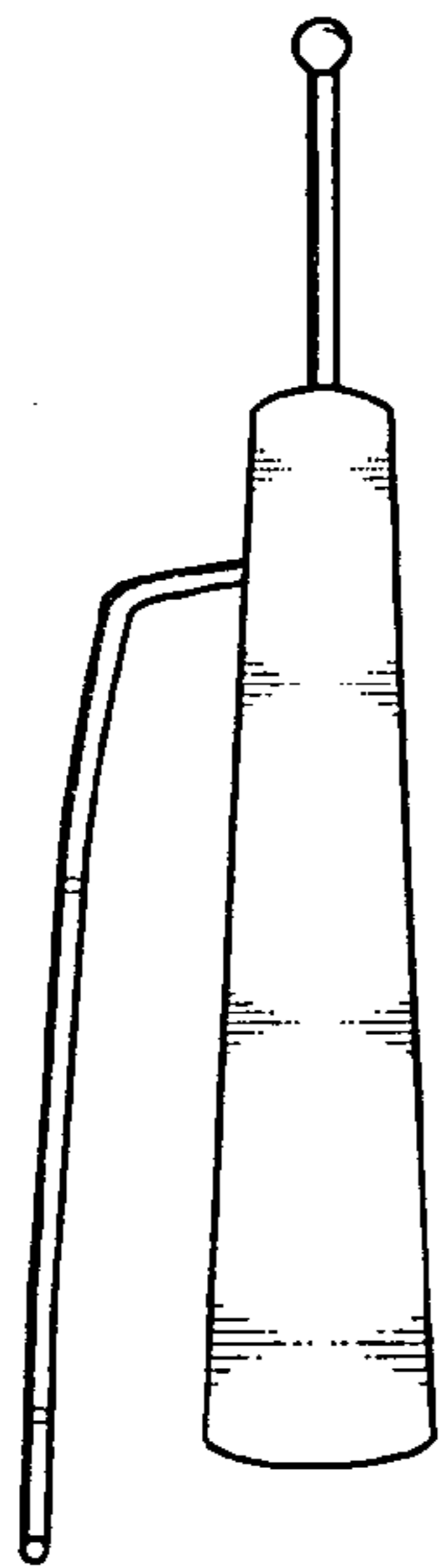

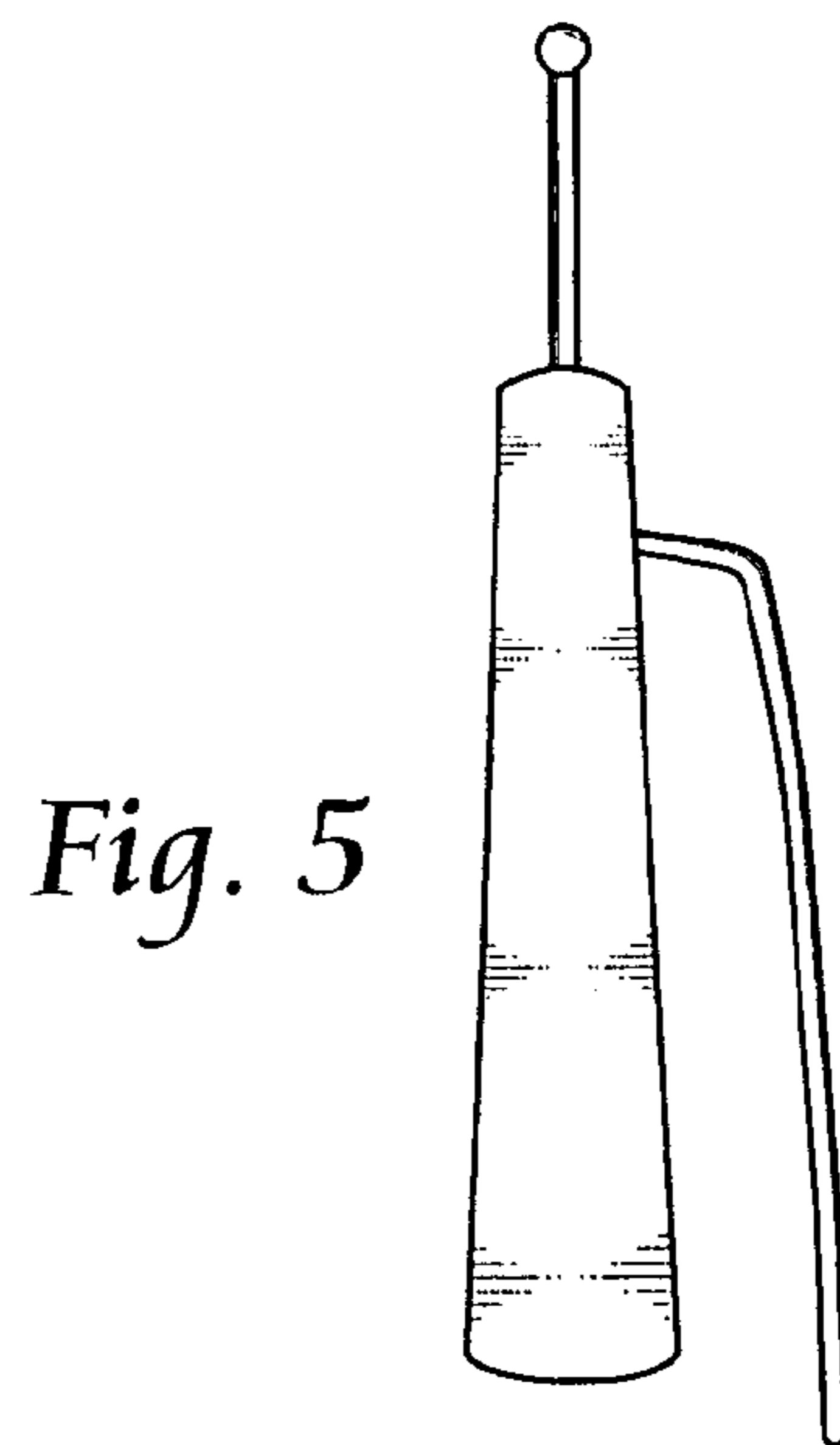
