

(57) **CLAIM**

The ornamental design for a vehicular seat, as shown and described.

DESCRIPTION

FIG. 1 is a left side perspective view of the first embodiment of the vehicular seat of the invention showing a combination of a seat and an expanded periphery/flat center back; FIG. 2 is a front elevational view of the expanded periphery/flat center back portion of the first embodiment of the vehicular seat; FIG. 3 is a top view of the seat portion of the first embodiment of the vehicular seat; FIG. 4 is a left side perspective view of the second embodiment of the vehicular seat of the invention showing a combination of a seat and an expanded periphery/flat center back; FIG. 5 is a front elevational view of the expanded periphery/flat center back portion of the second embodiment of the vehicular seat; FIG. 6 is a top view of the seat portion of the second embodiment of the vehicular seat; FIG. 7 is a left side perspective view of the third embodiment of the vehicular seat of the invention showing a combination of a seat and an expanded periphery/flat center back; FIG. 8 is a front elevational view of the expanded periphery/flat center back portion of the third embodiment of the vehicular seat; FIG. 9 is a top view of the seat portion of the third embodiment of the vehicular seat; FIG. 10 is a left side perspective view of the fourth embodiment of the vehicular seat of the invention showing a combination of a seat and an expanded periphery/flat center back; FIG. 11 is a front elevational view of the expanded periphery/flat center back portion of the fourth embodiment of the vehicular seat; and, FIG. 12 is a top view of the seat portion of the fourth embodiment of the vehicular seat.
























