FIG. 3 is a rear view of the chair of the invention;

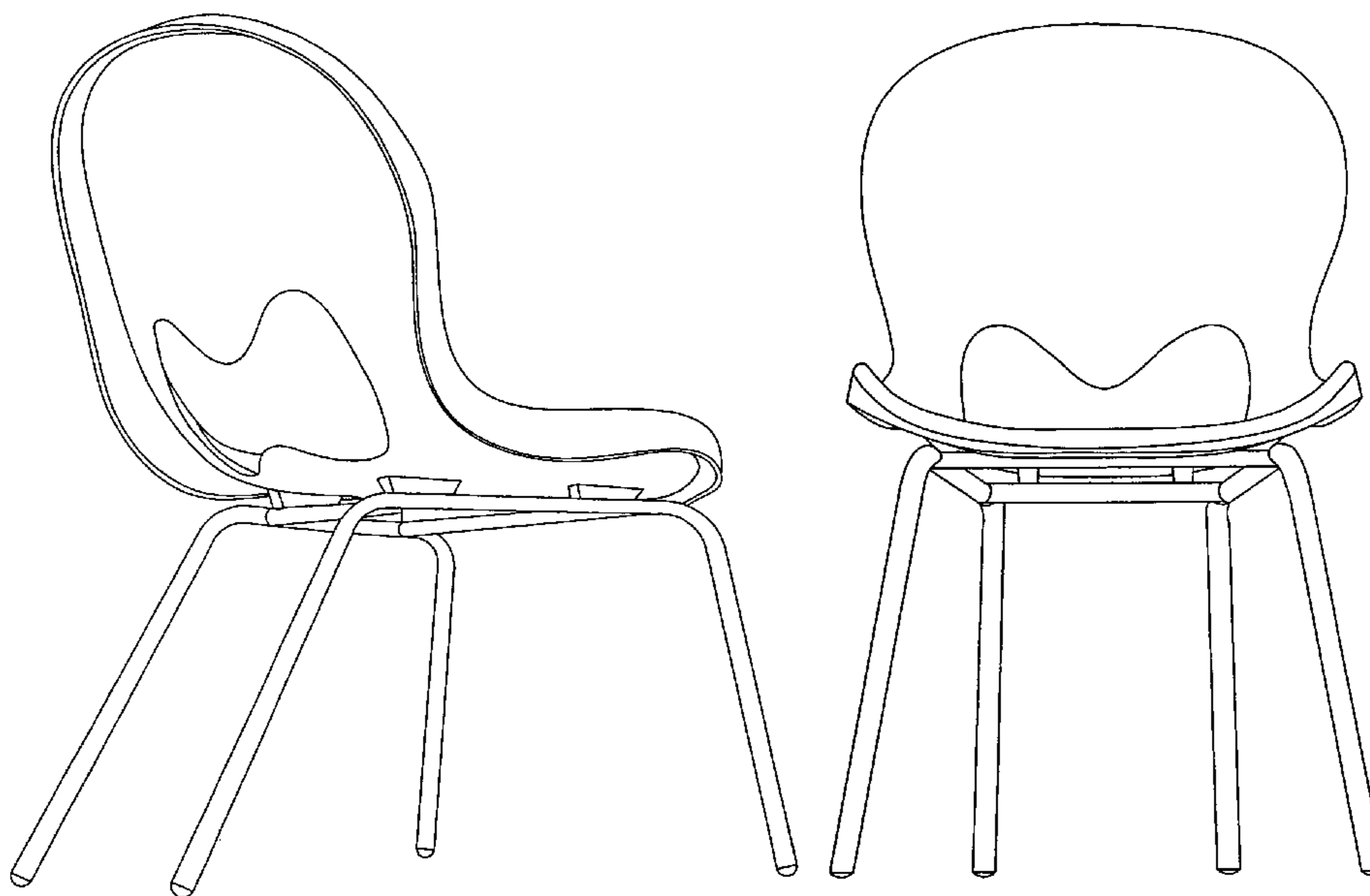
FIG. 4 is a left side view of the chair of the invention;

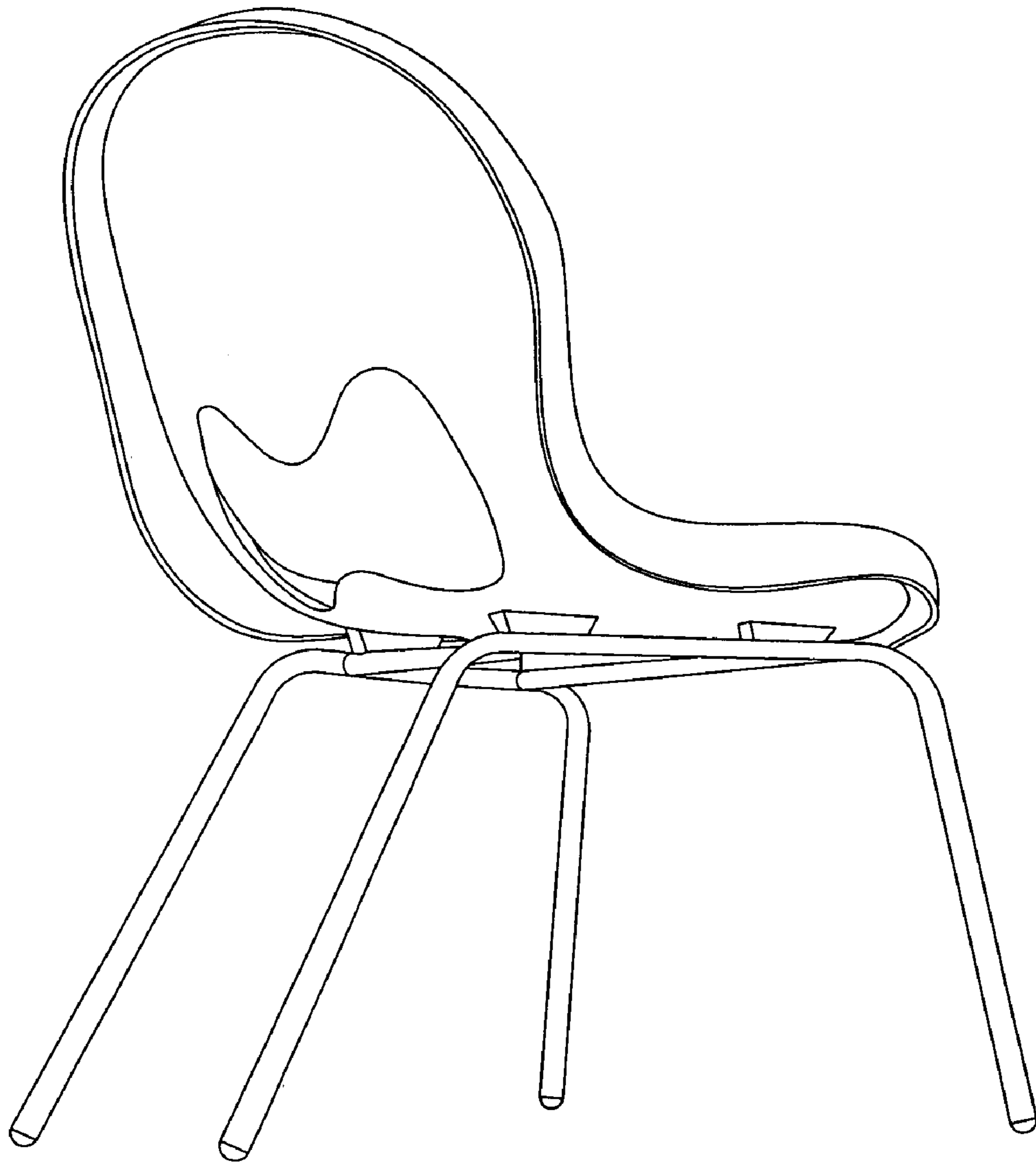

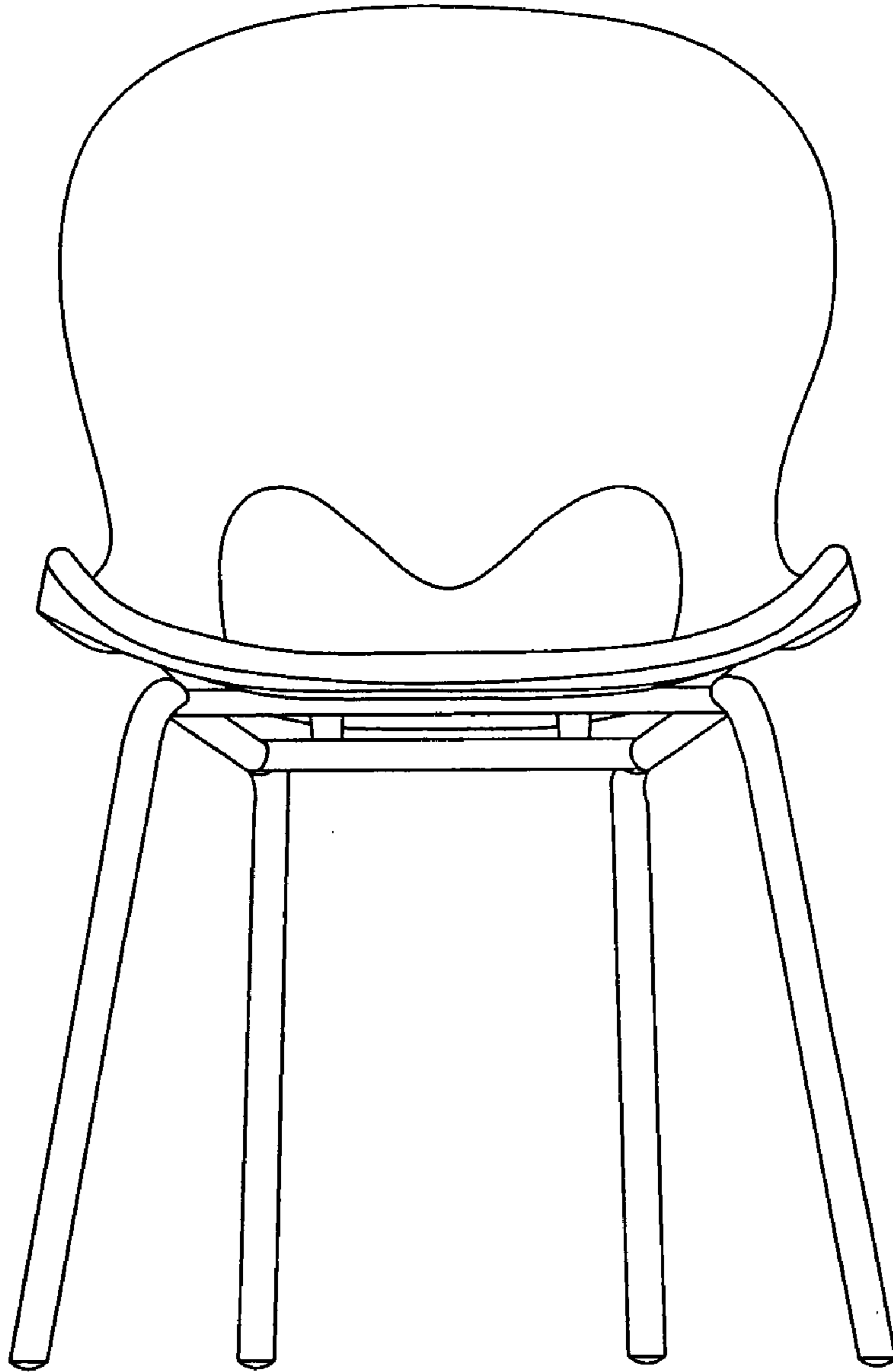

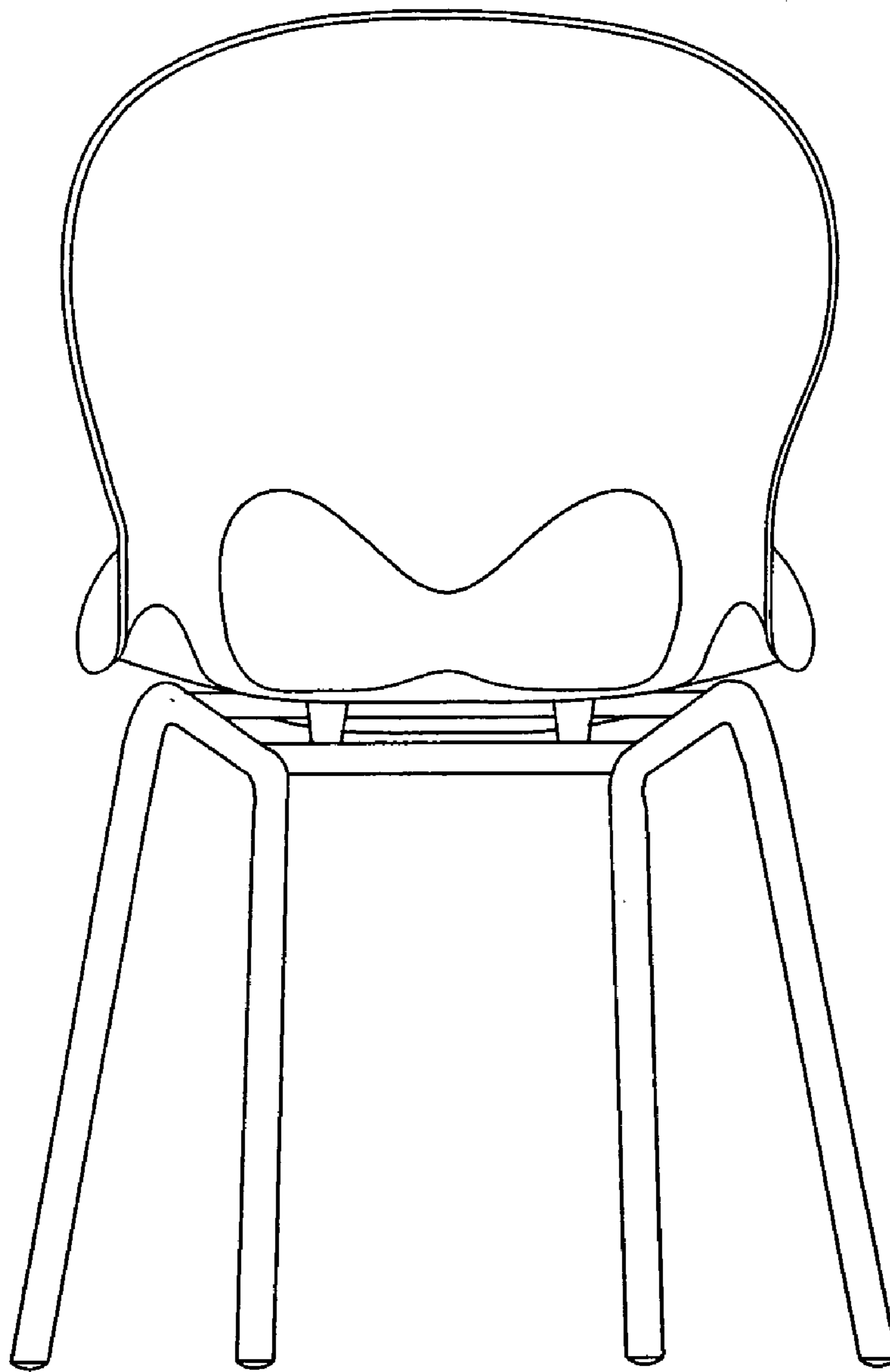

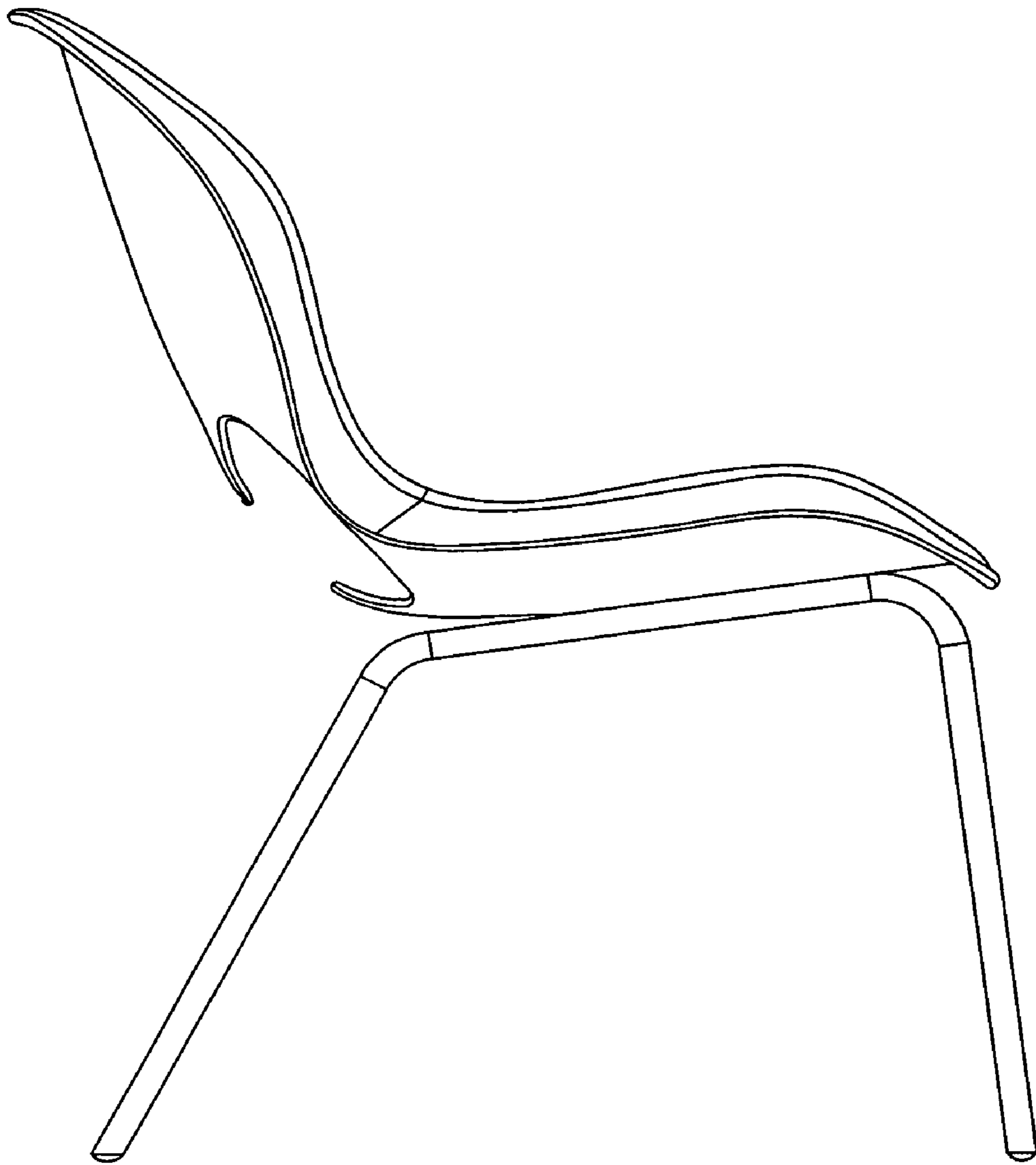

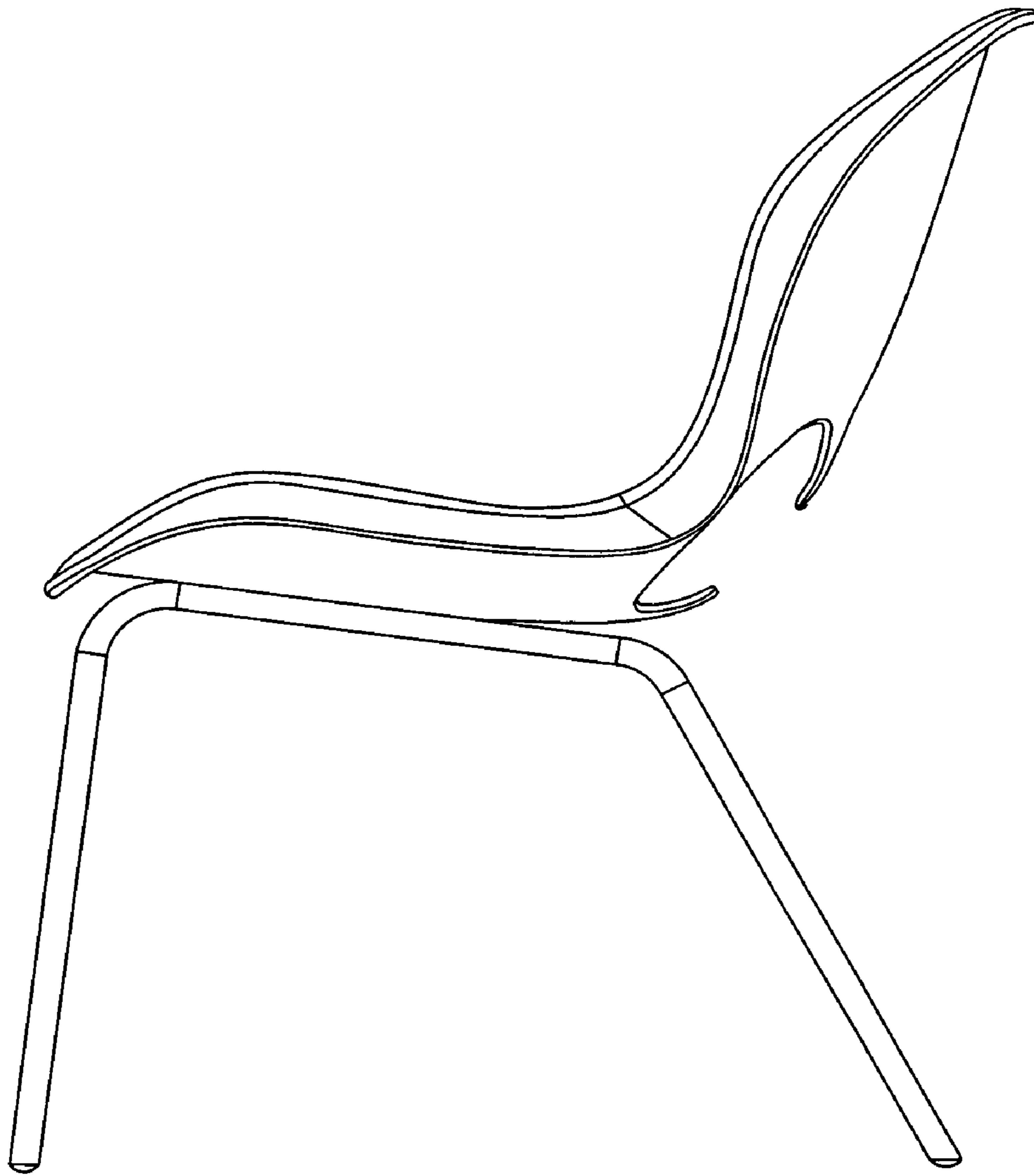

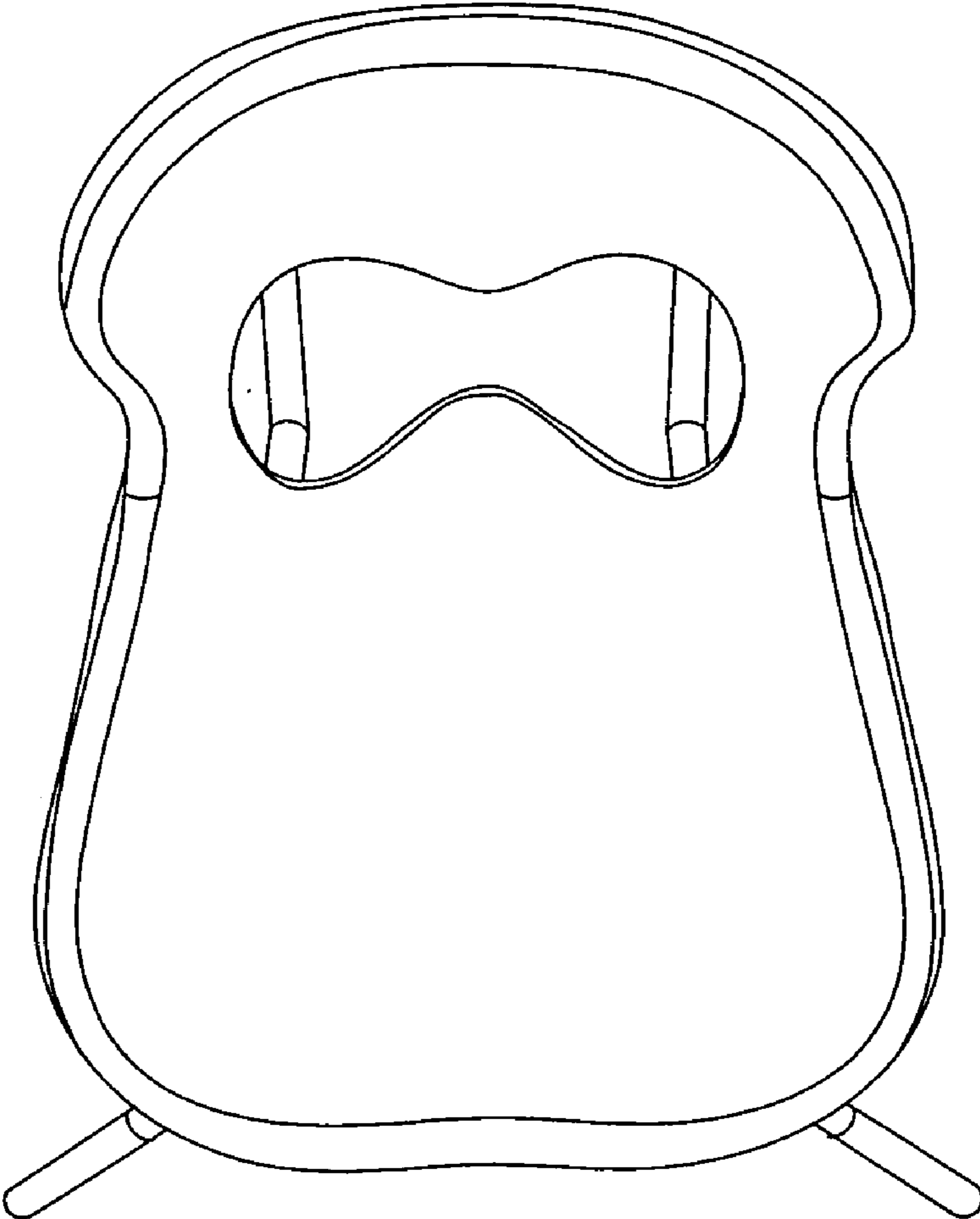

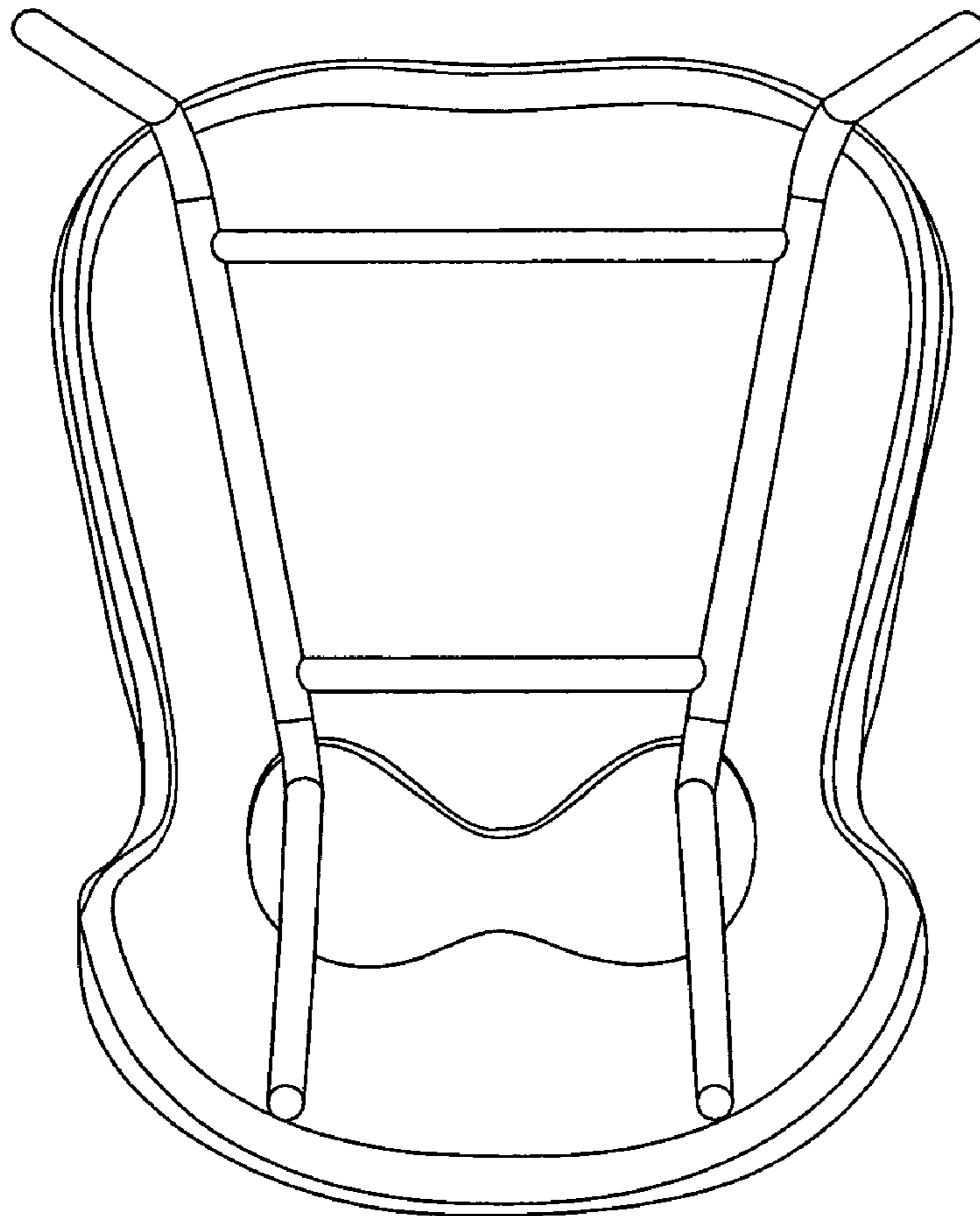
