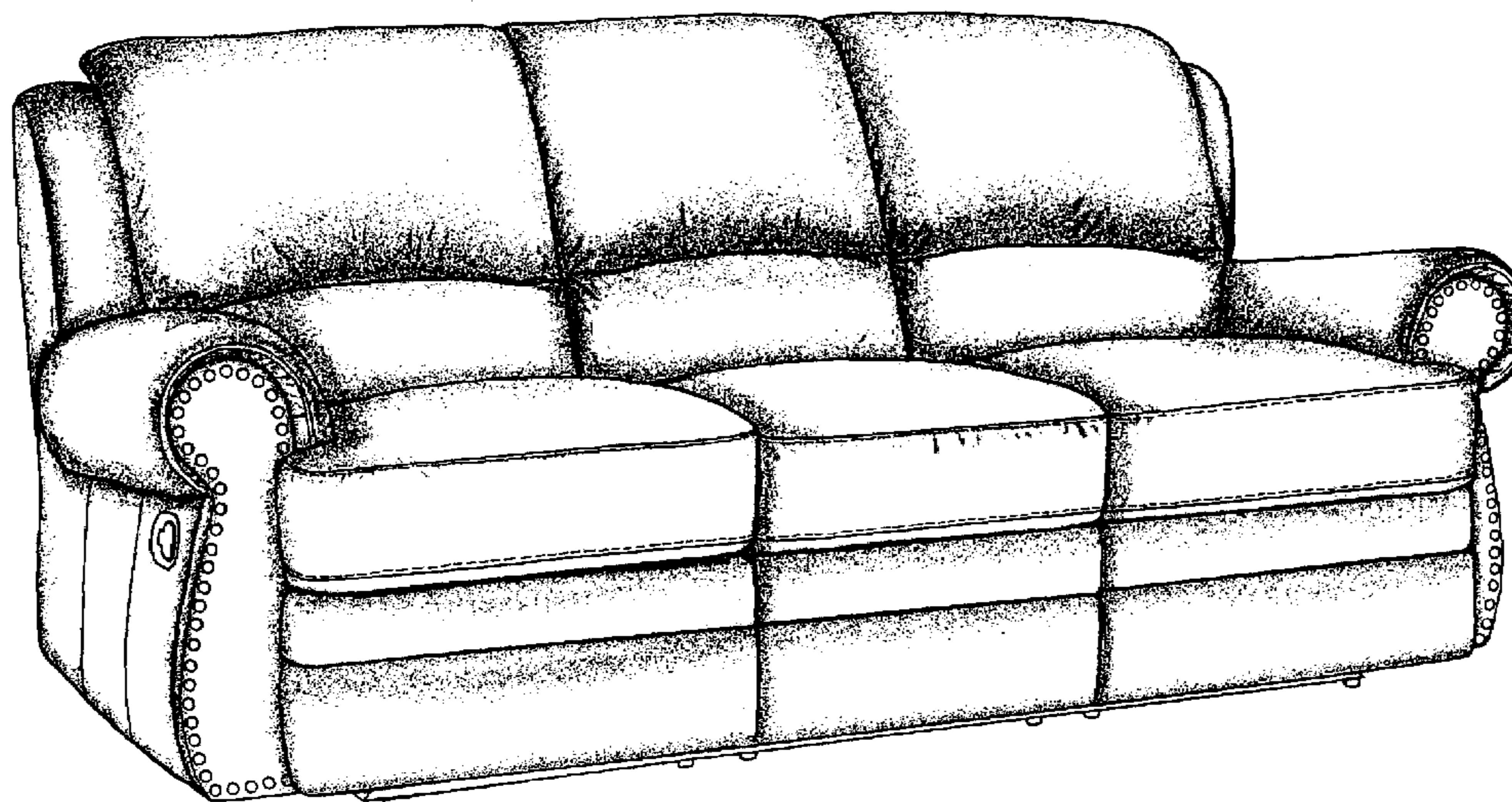
I claim the ornamental design for a sofa, as shown and described.

FIG. 2 is a rear elevation view thereof;  
FIG. 3 is a side elevation view thereof;  
FIG. 4 is a front perspective view thereof;  
FIG. 5 is a front elevation view thereof;  
FIG. 6 is an opposite side elevation view thereof; and,  
FIG. 7 is an additional perspective view of the sofa.  
As shown in the drawings herein broken (dotted) lines are used to indicate stitching.  
The dot-dashed broken lines shown in the drawings are for illustrative purposes only and form no part of the claimed design.

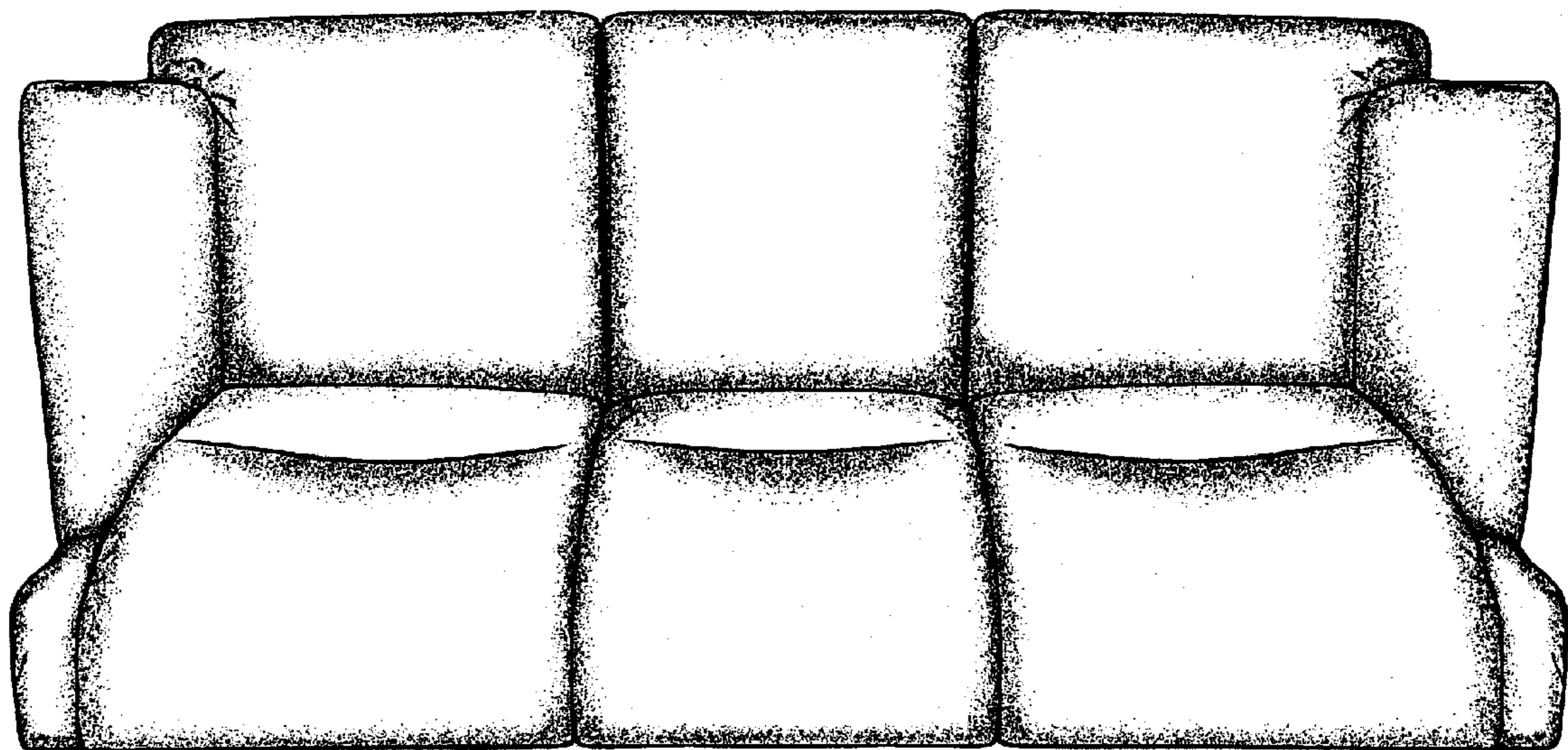

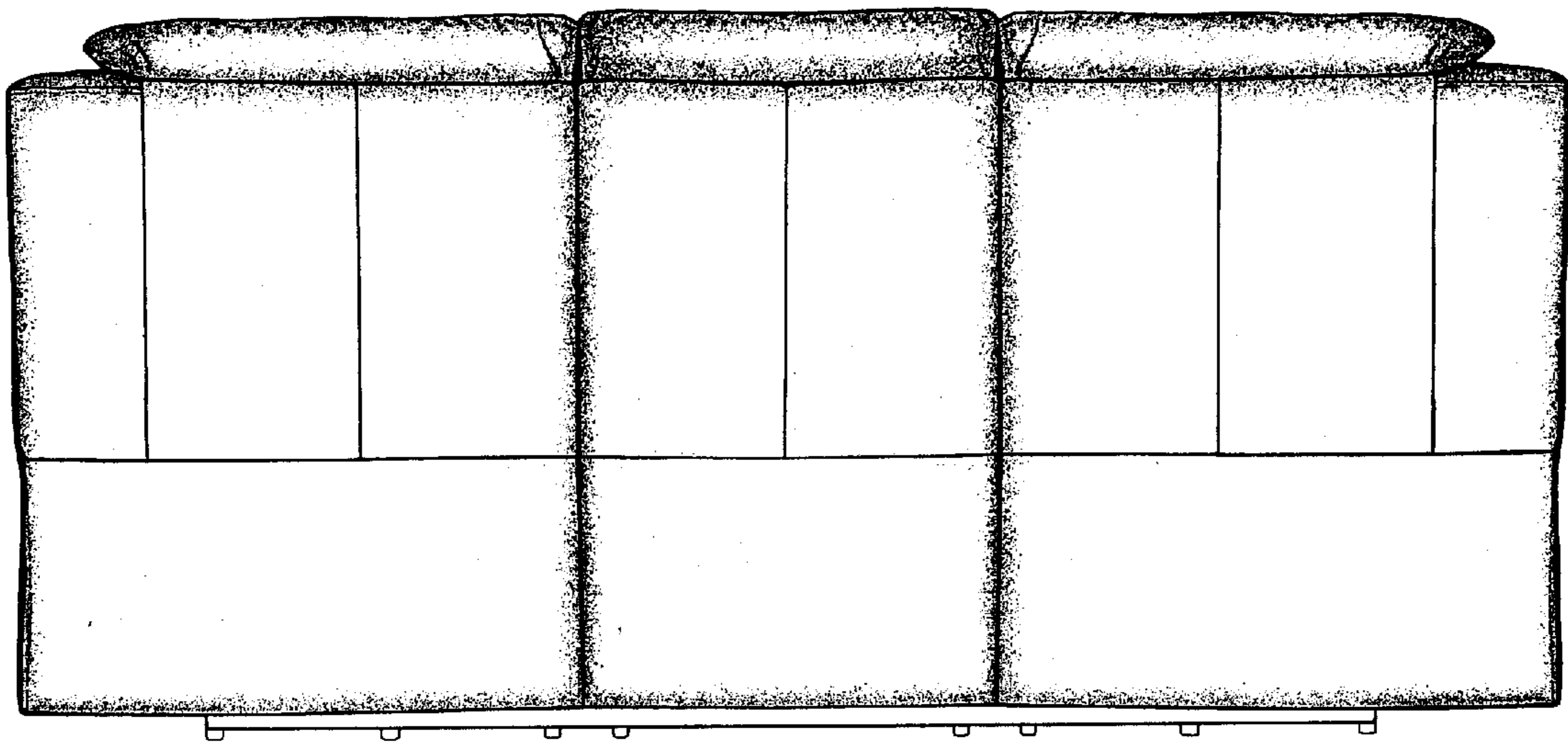

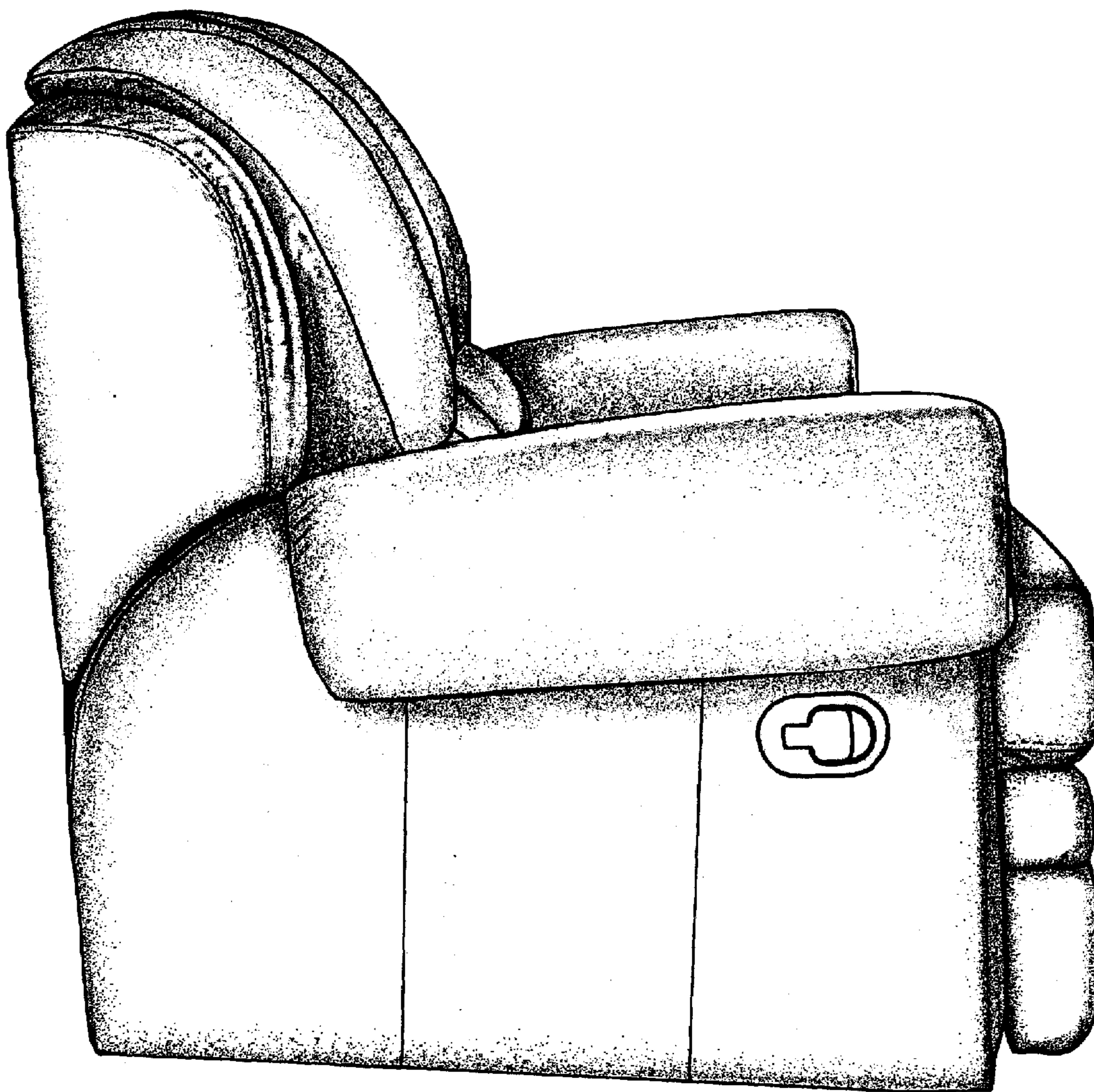

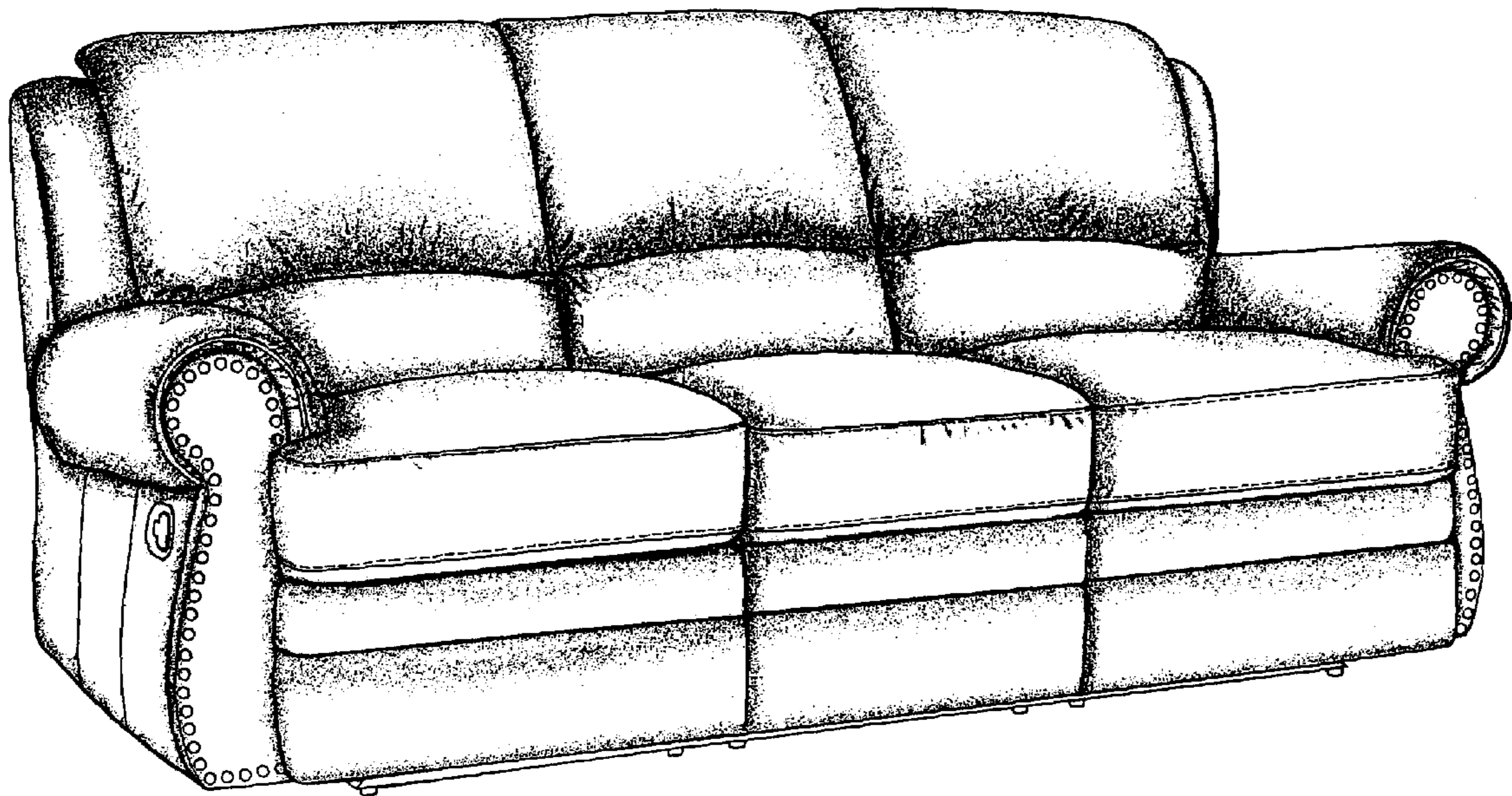

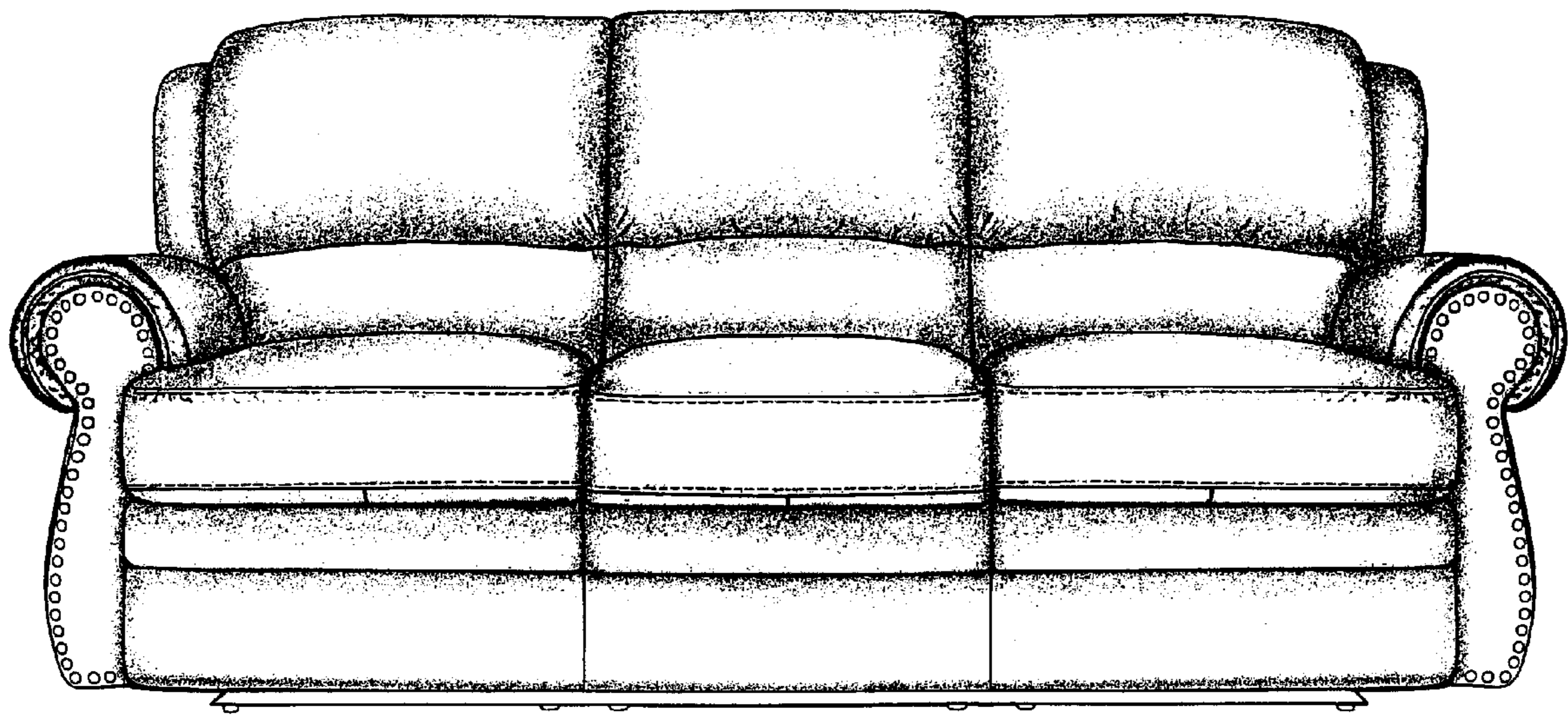

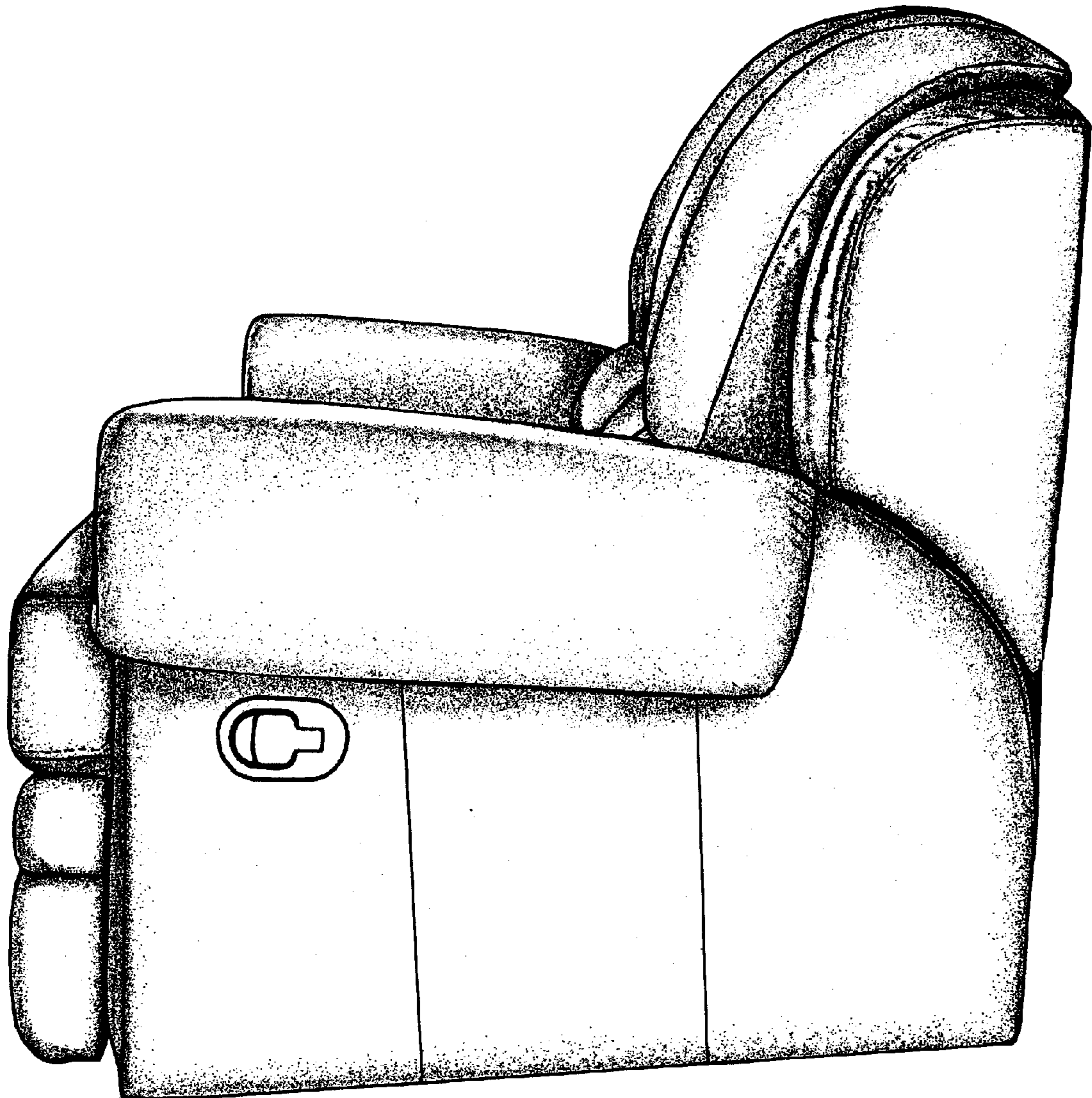

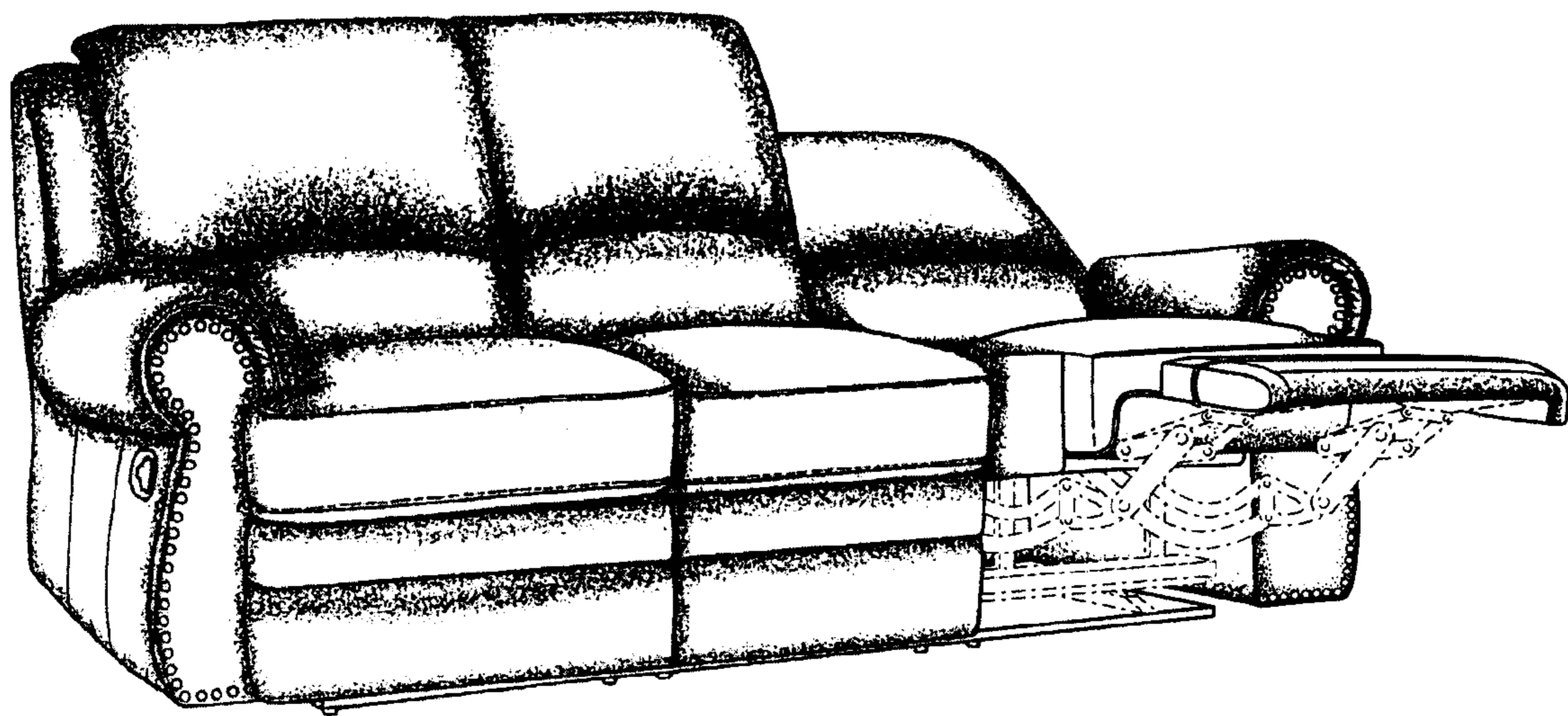
