(57) **CLAIM**

I claim the ornamental design for a pull-out basket, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a pull-out basket of the present invention.

FIG. 2 is a back elevation view of the pull-out basket of FIG. 1.

FIG. 3 is a top plan view of the pull-out basket of FIG. 1.

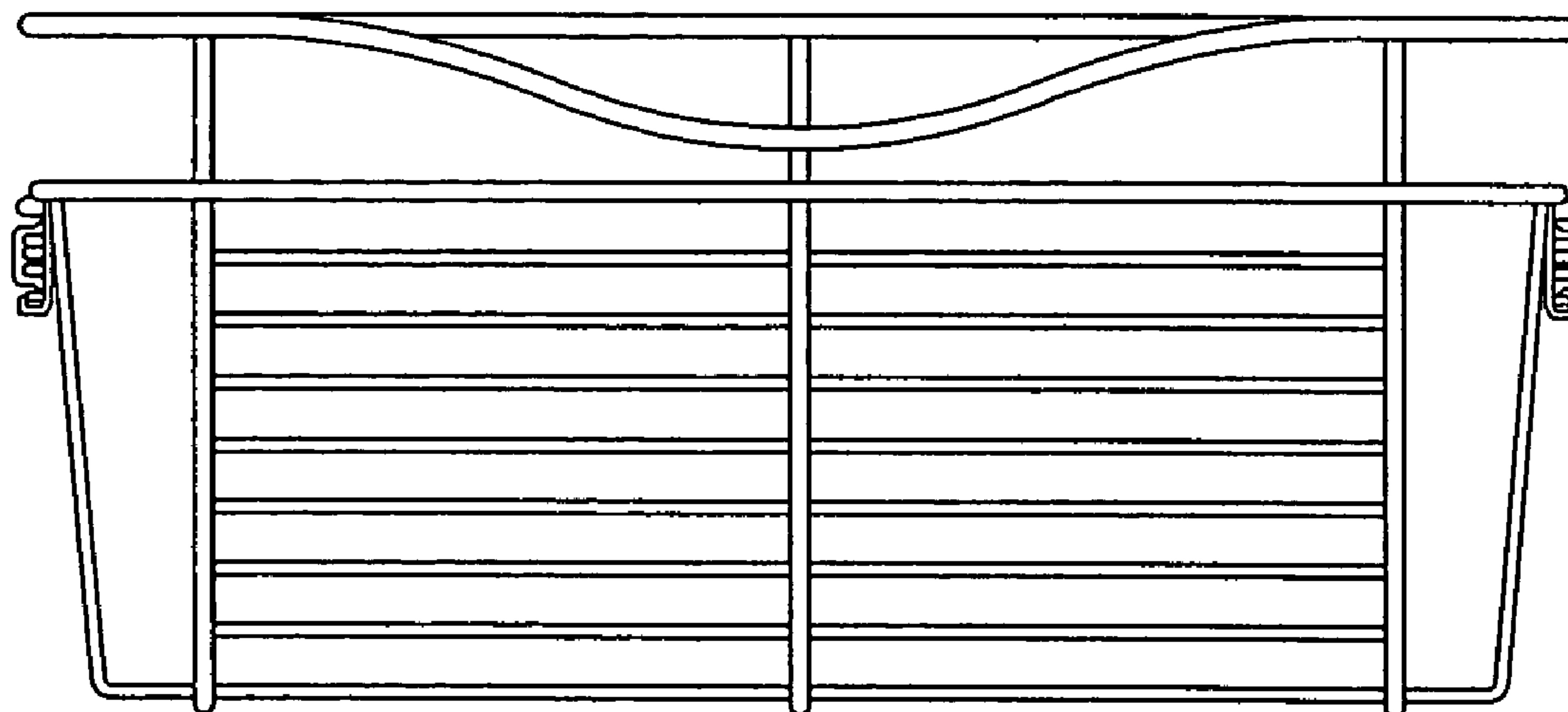
FIG. 4 is a bottom plan view of the pull-out basket of FIG. 1.

FIG. 5 is an elevation view of the left side of the pull-out basket of FIG. 1.

FIG. 6 is an elevation view of the right side of the pull-out basket of FIG. 1; and,

FIG. 7 is a perspective view of the pull-out basket shown in the prior figures taken from the diagonal upper right of FIG. 1.

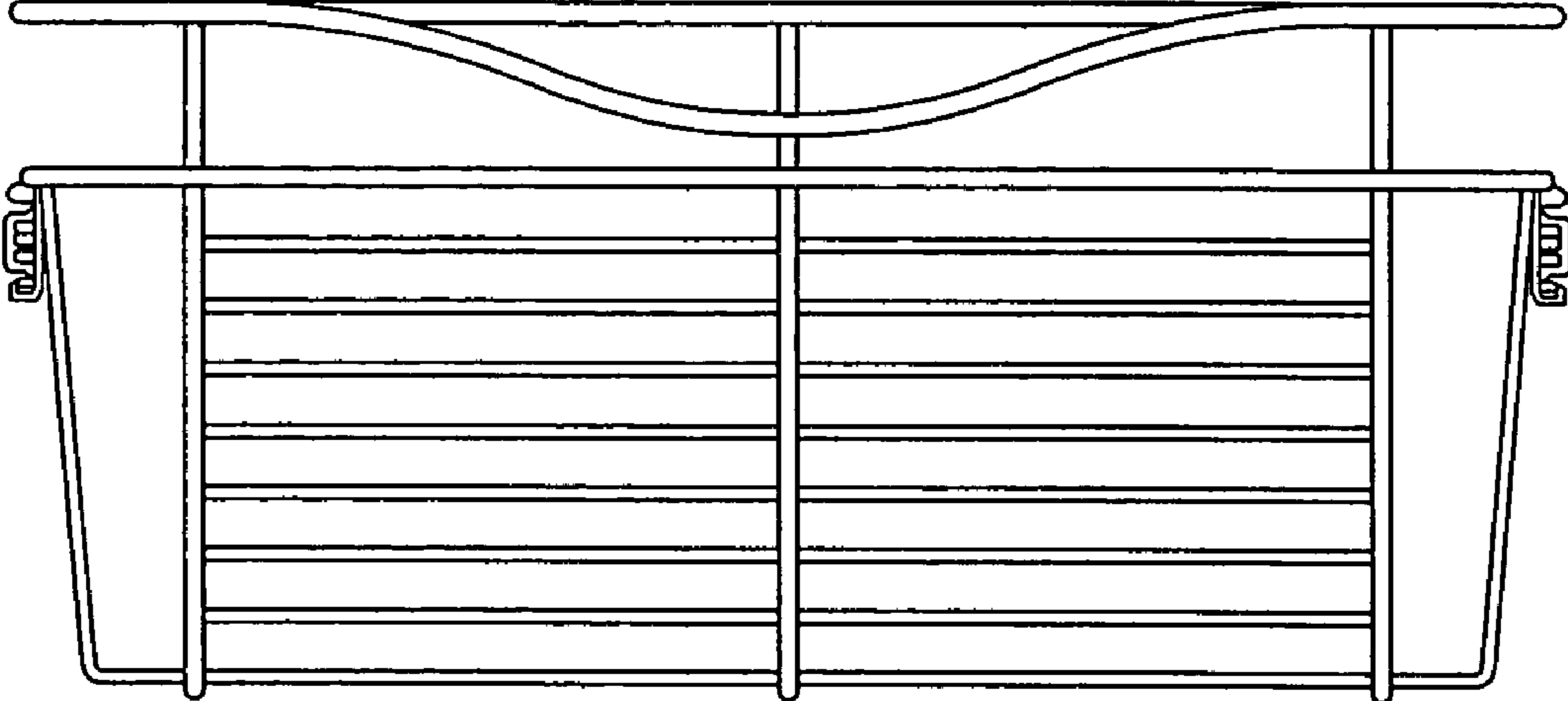

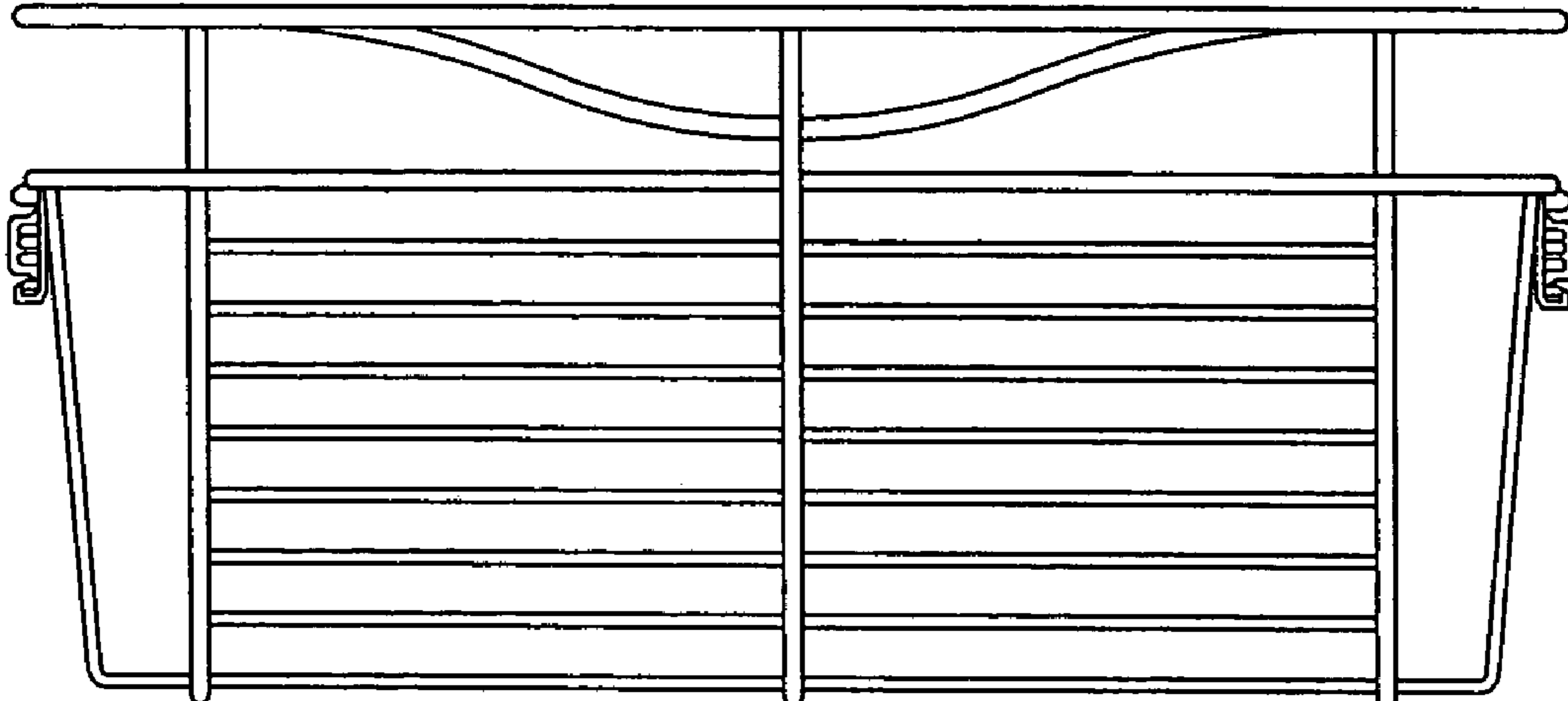

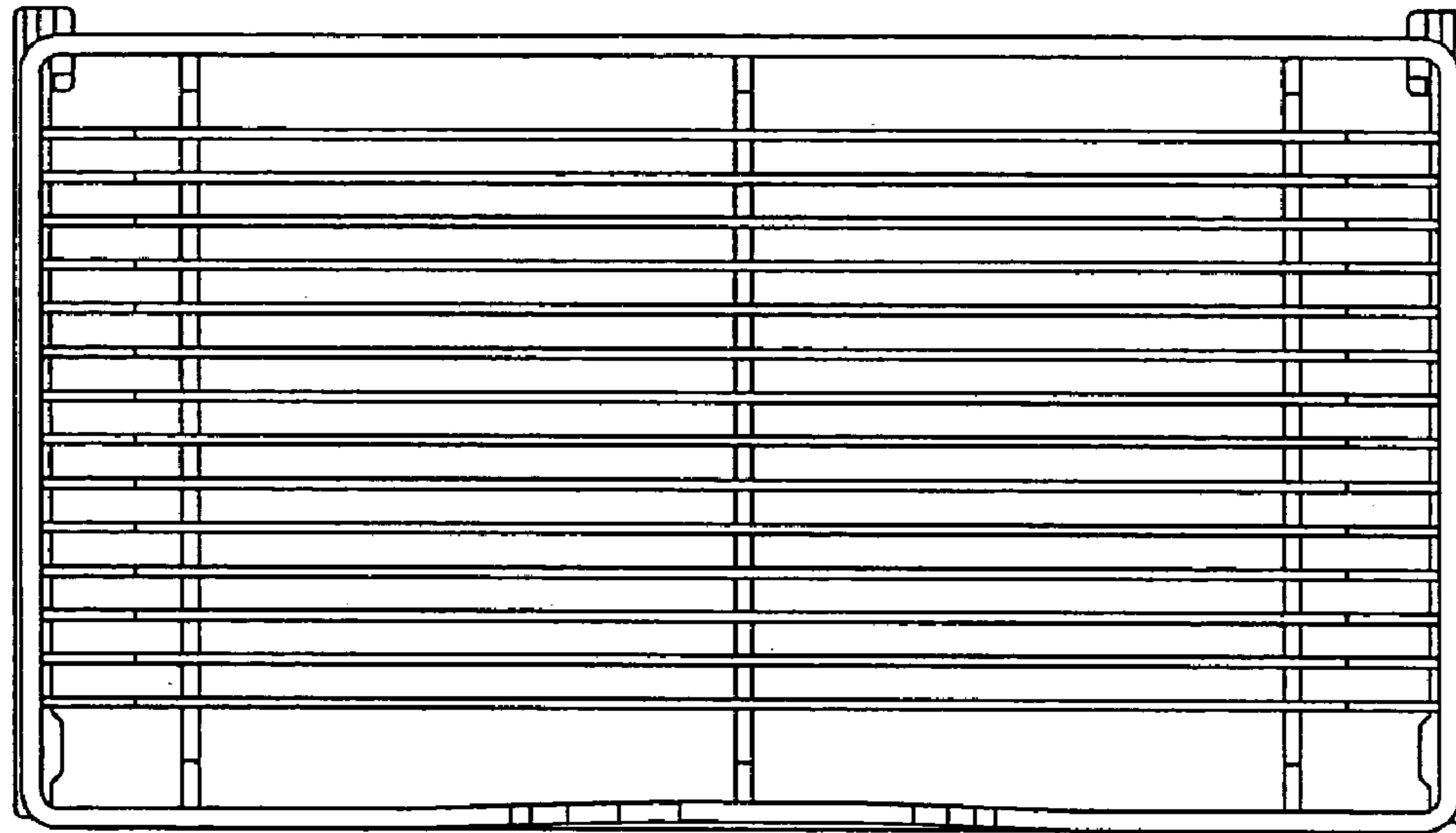

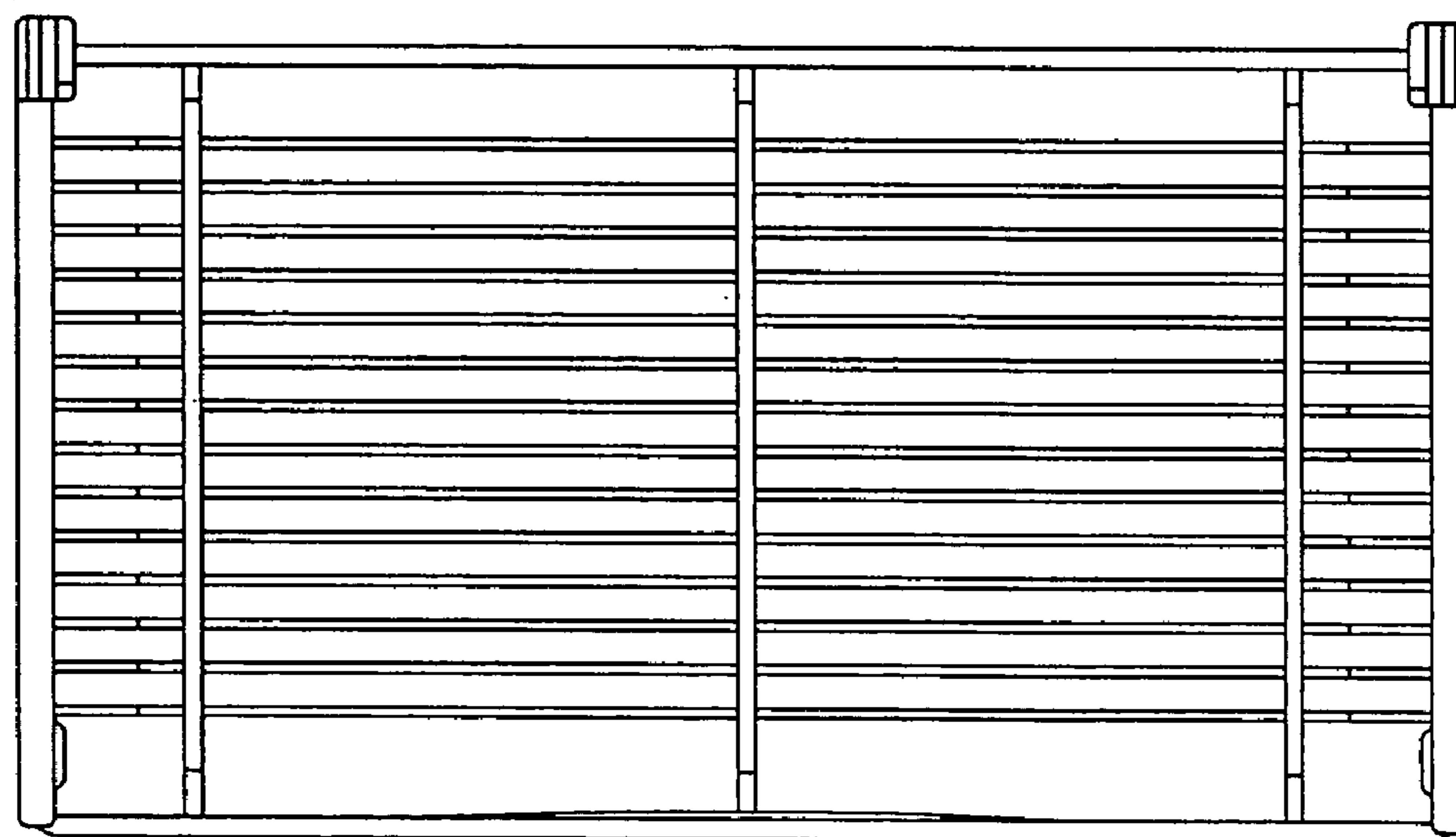

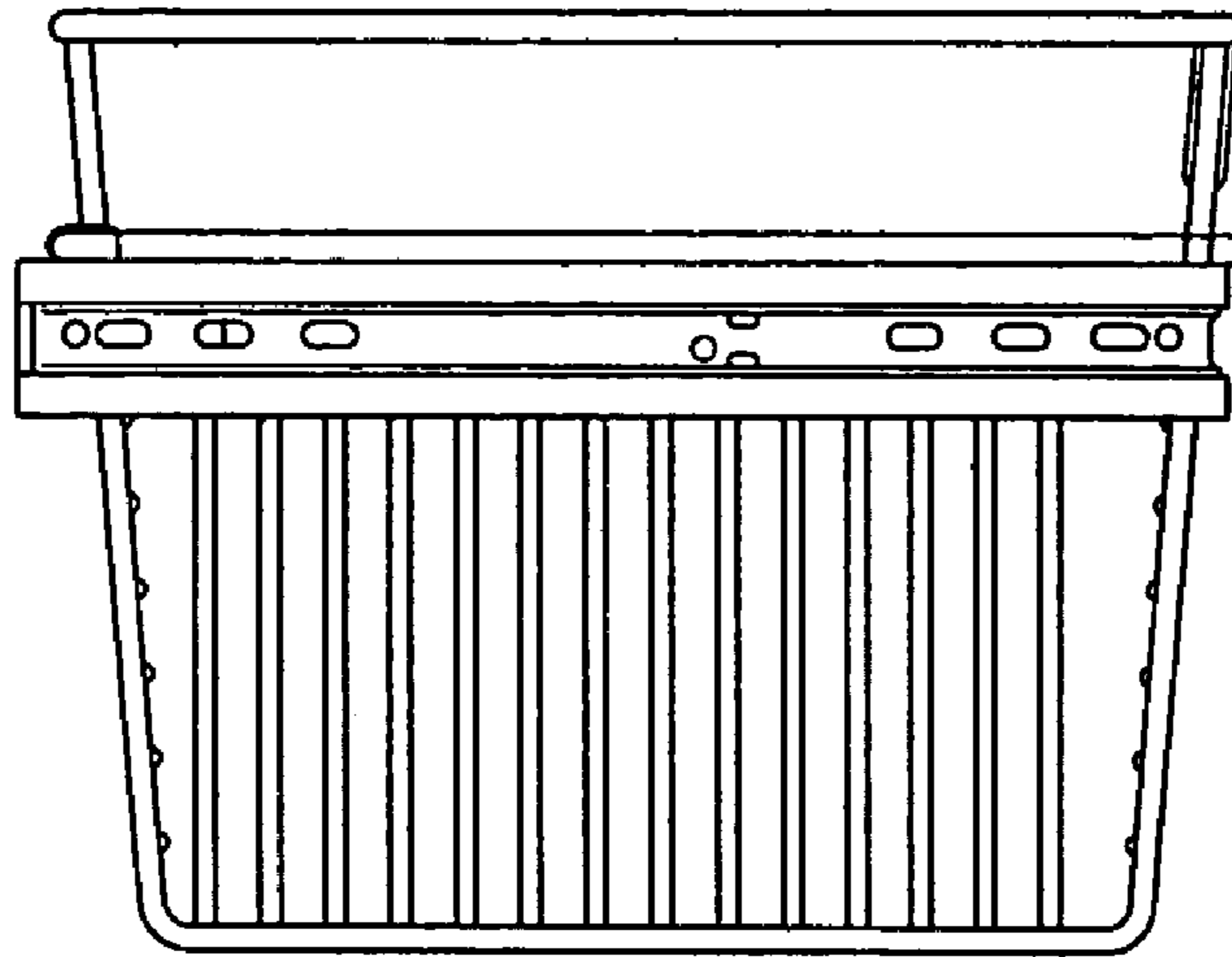

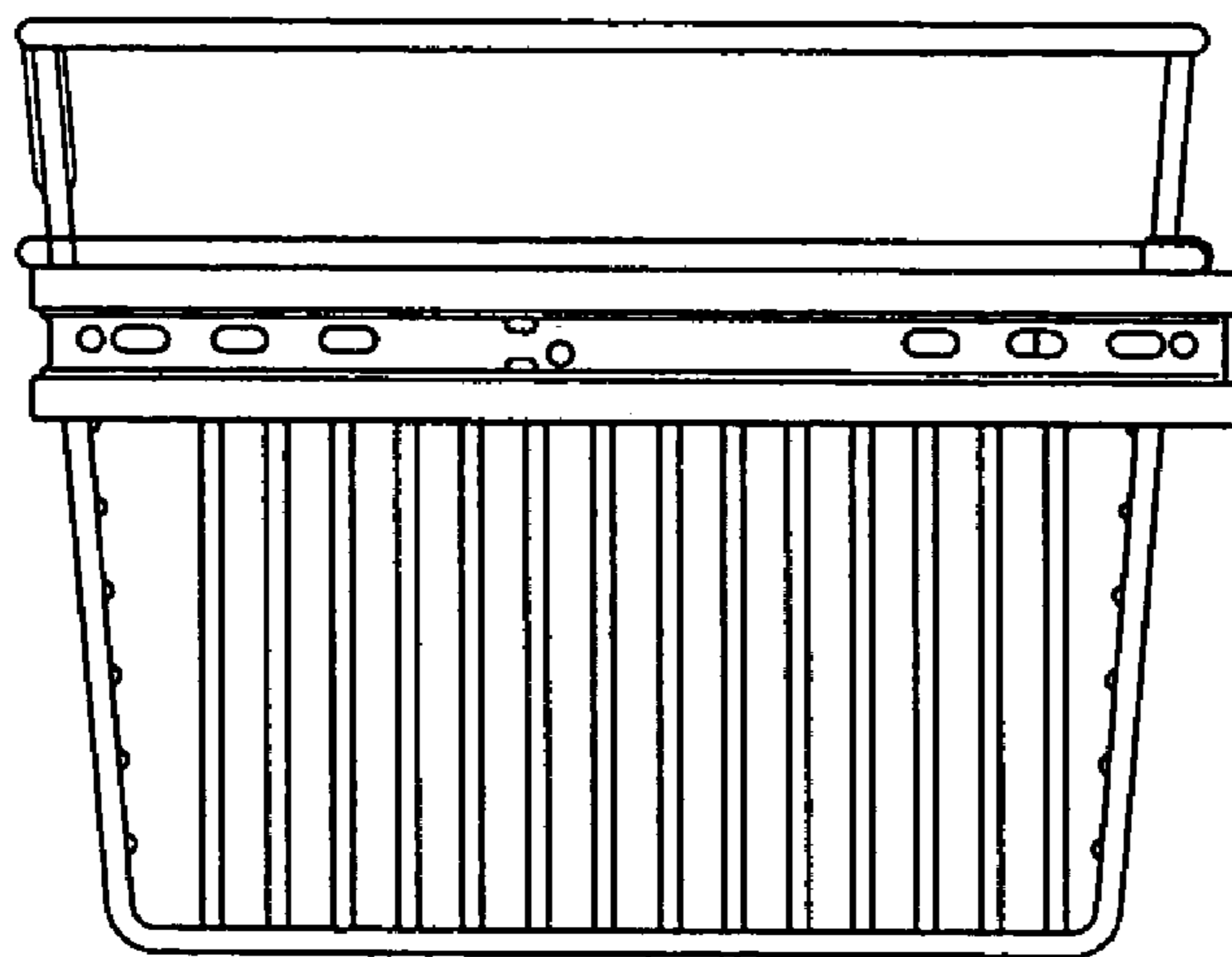

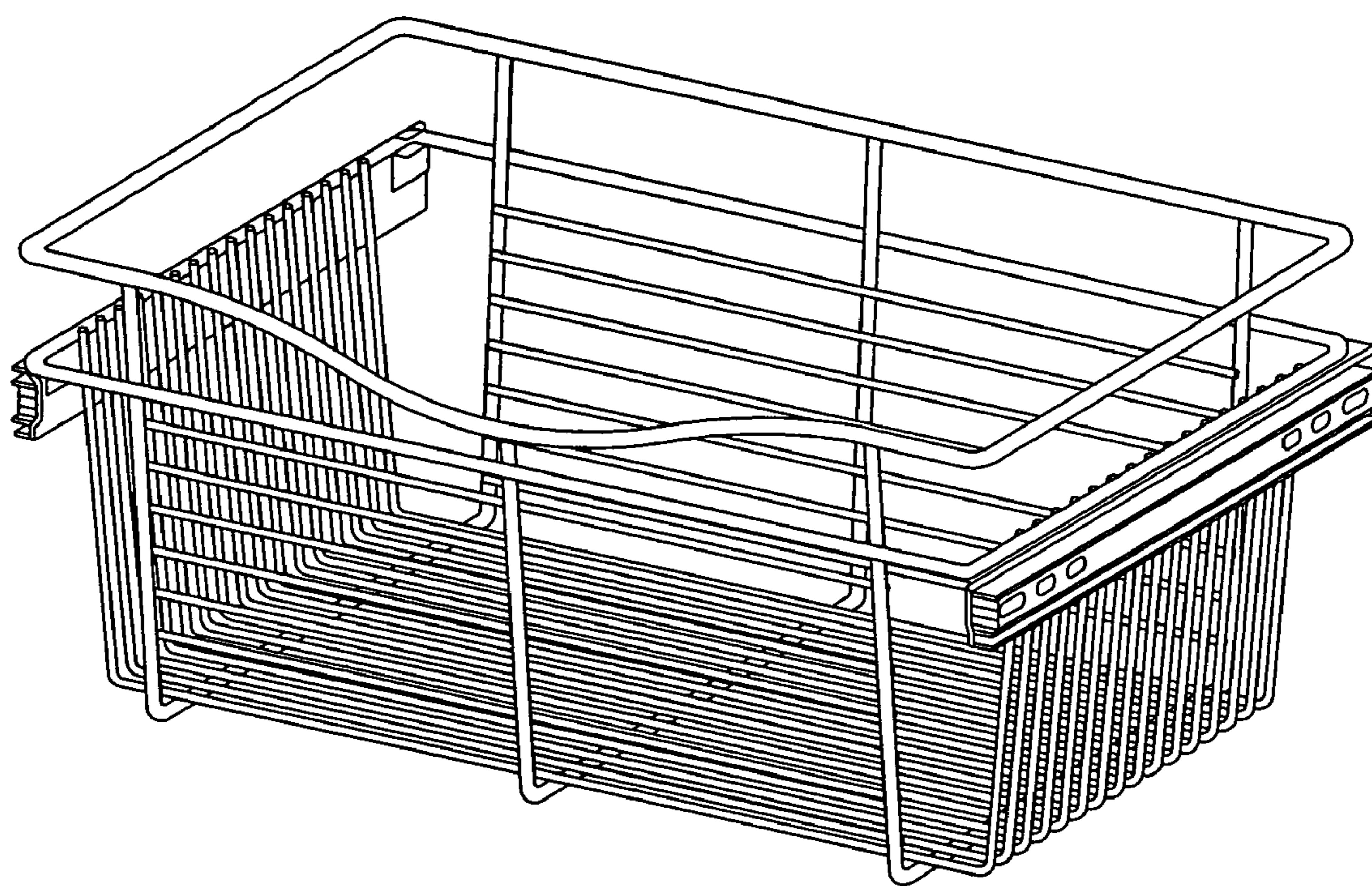
