**DESCRIPTION**

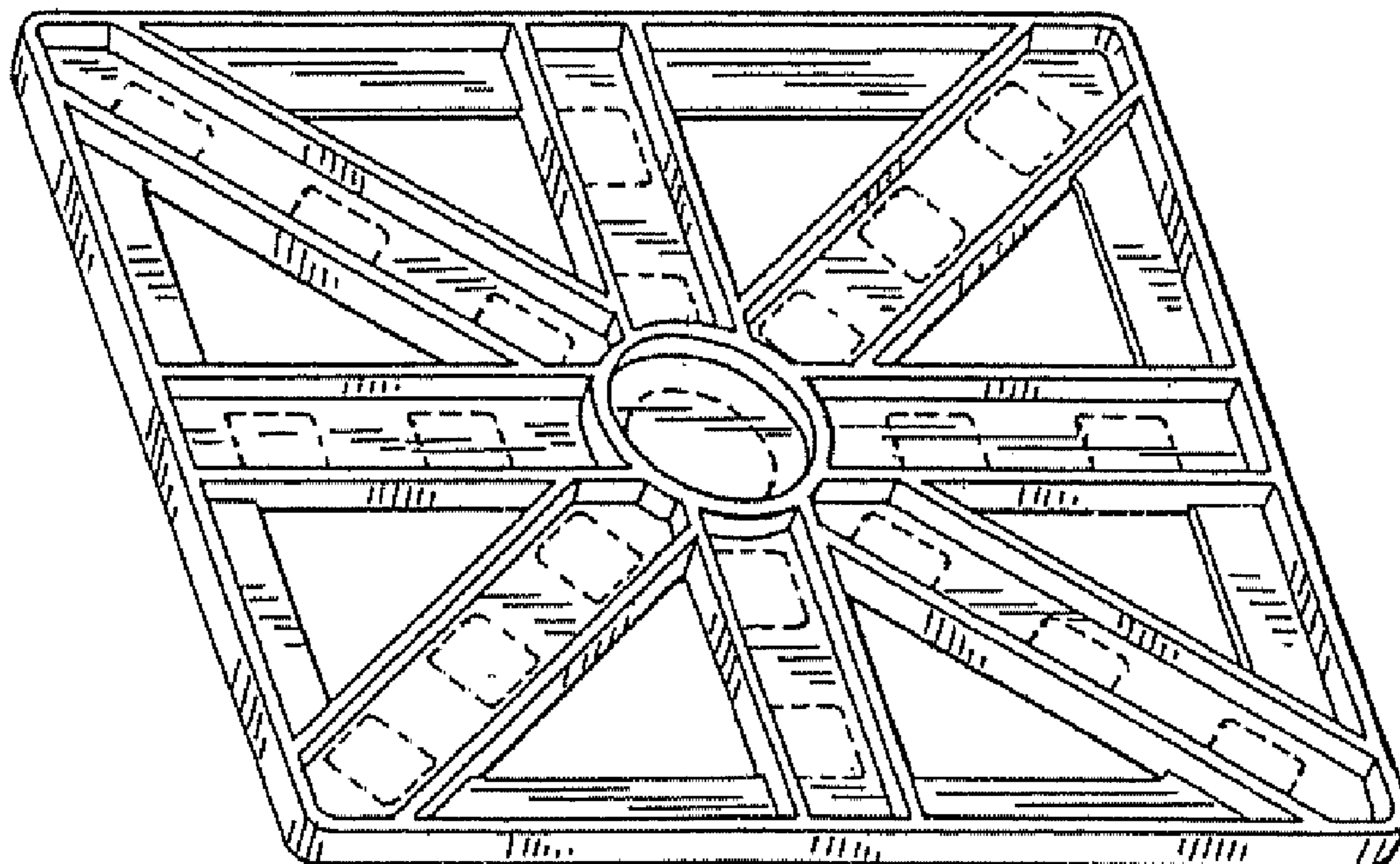
FIG. 1 is a bottom perspective view of a microwave oven pedestal showing my new design;

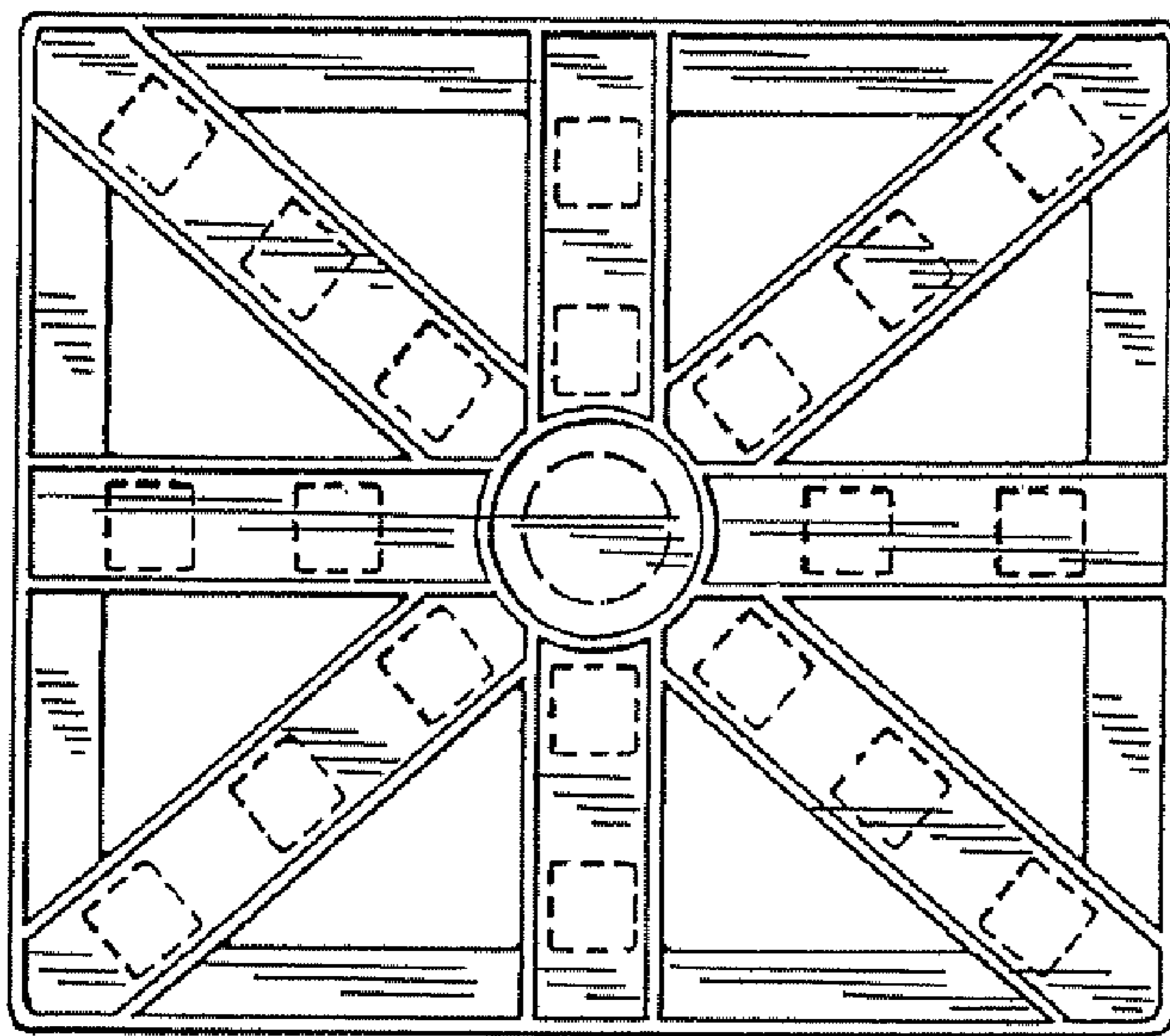
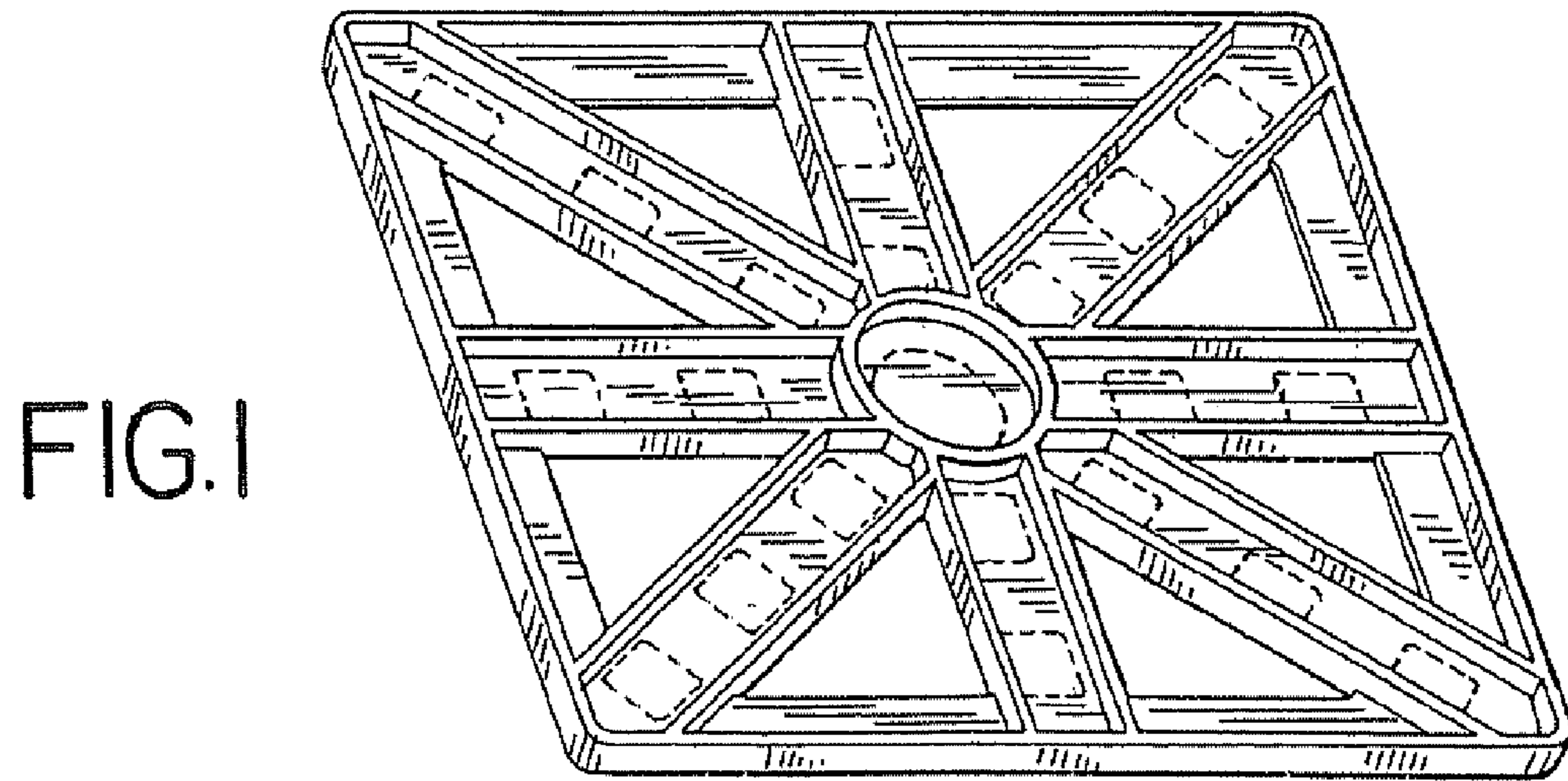
