FIG. 1 is a top front perspective view of a tumbler mug with grips showing my new design;

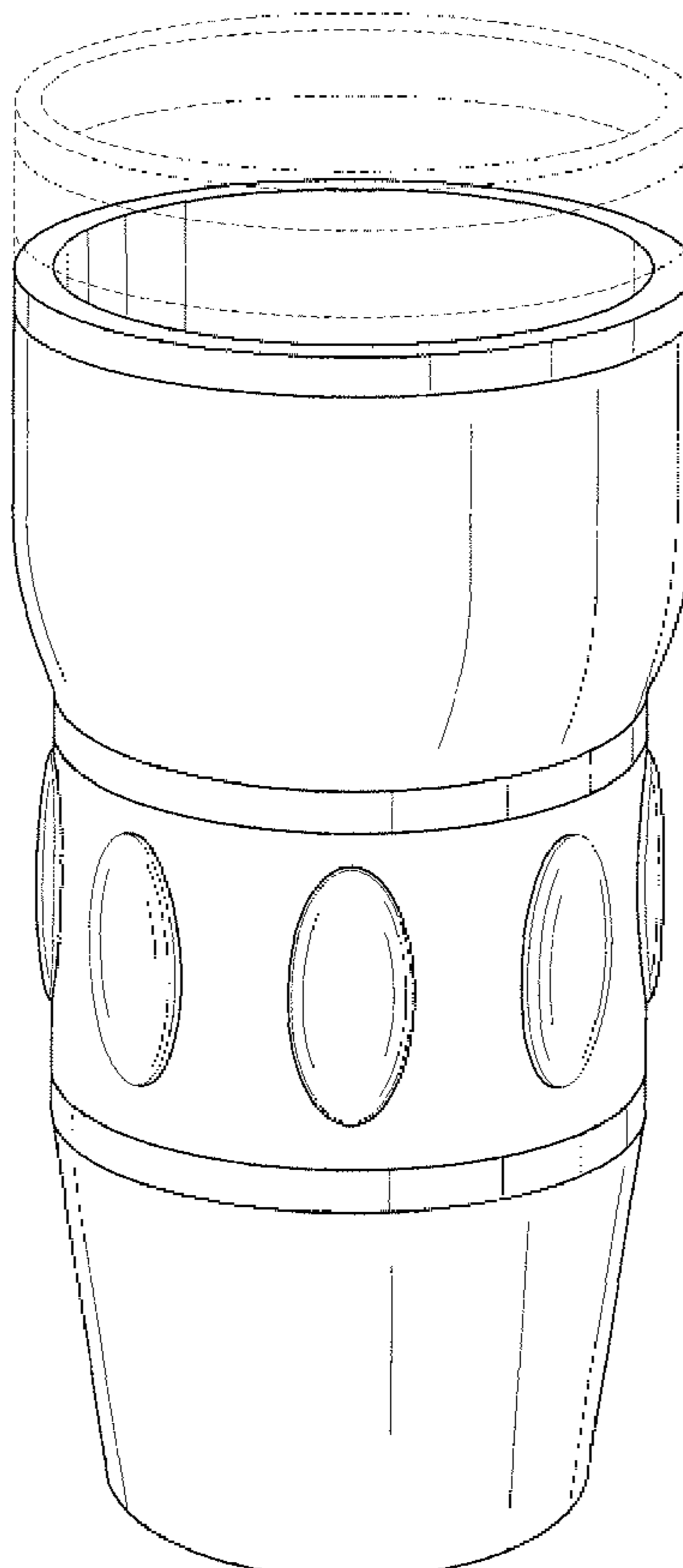
FIG. 2 is a front elevational view thereof, all sides being the same;

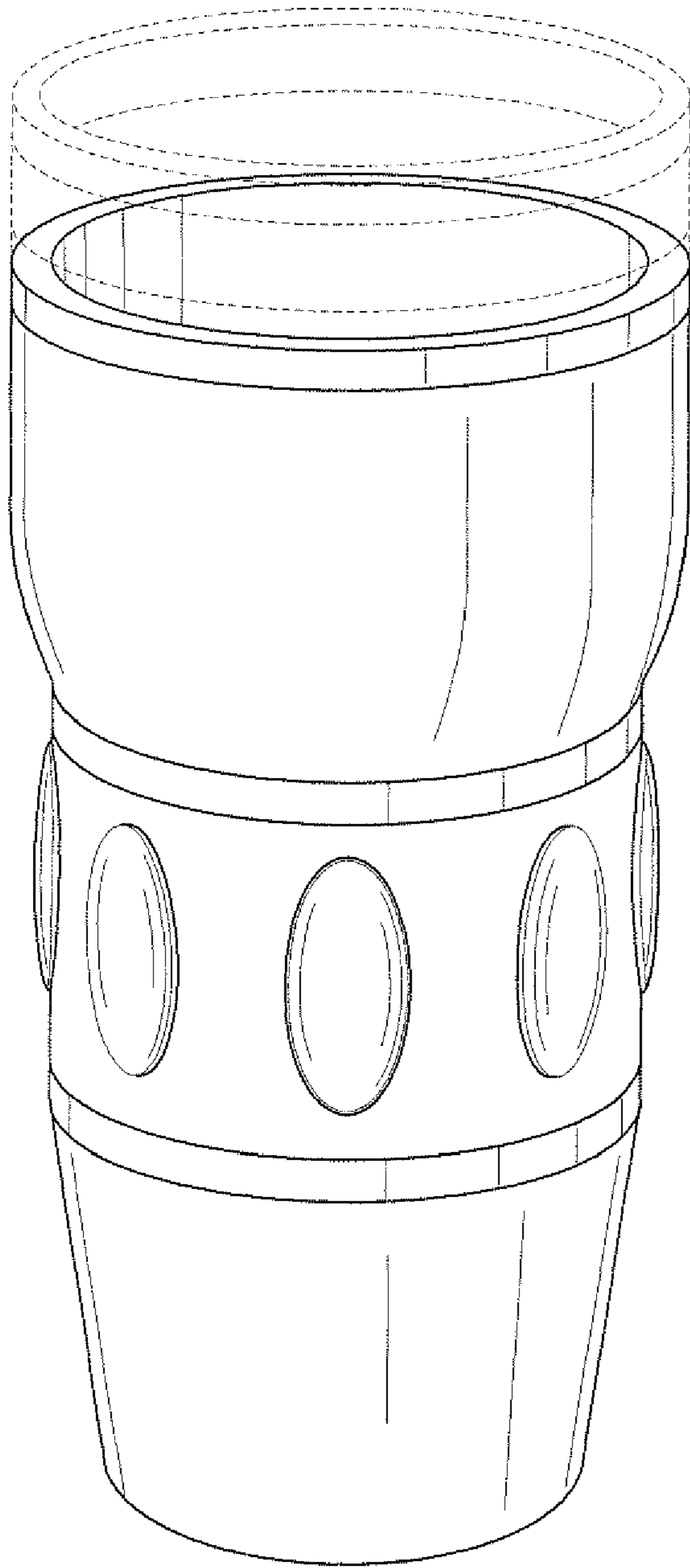
FIG. 3 is a top plan view thereof; and,

FIG. 4 is bottom plan view thereof.

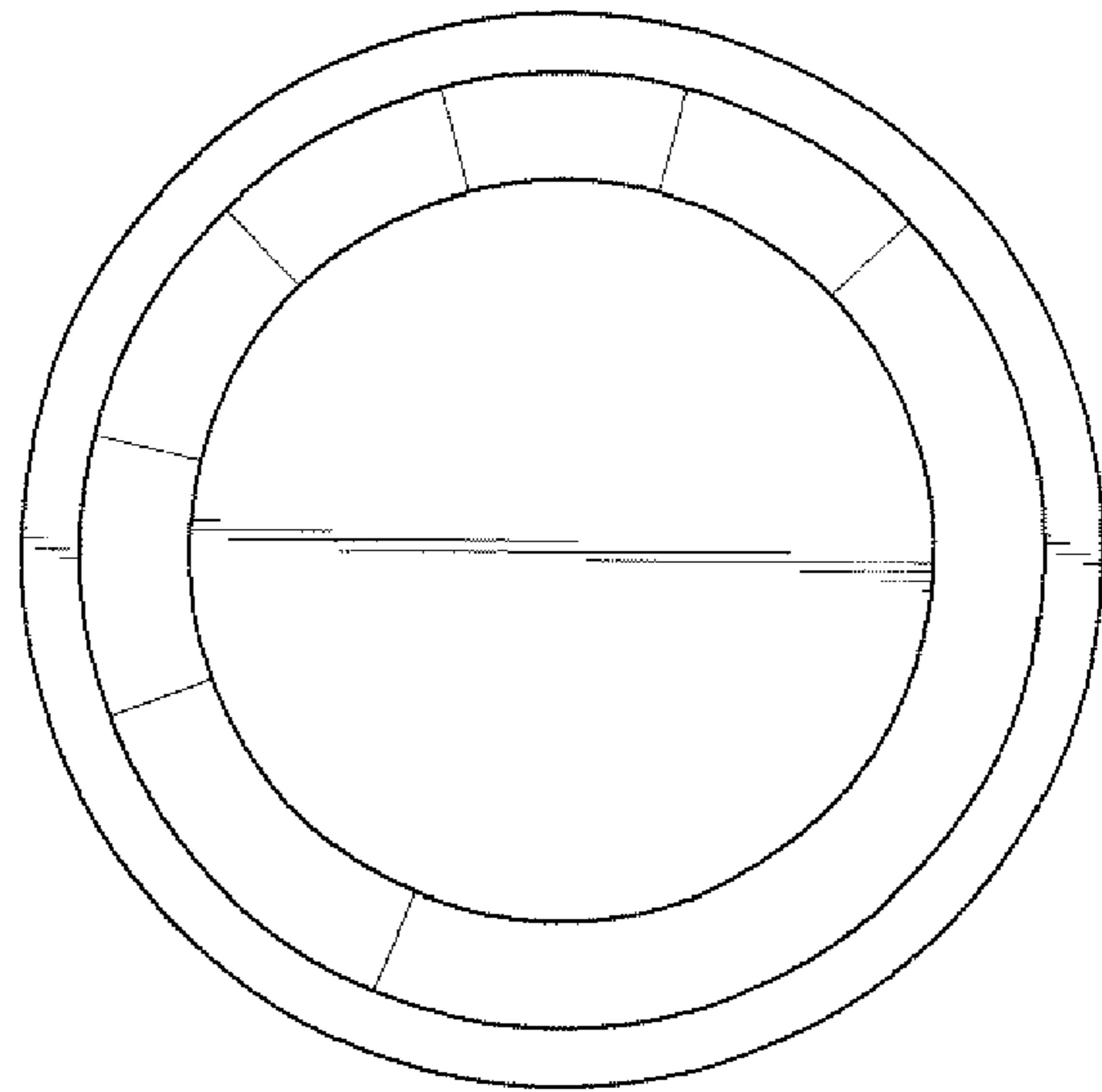

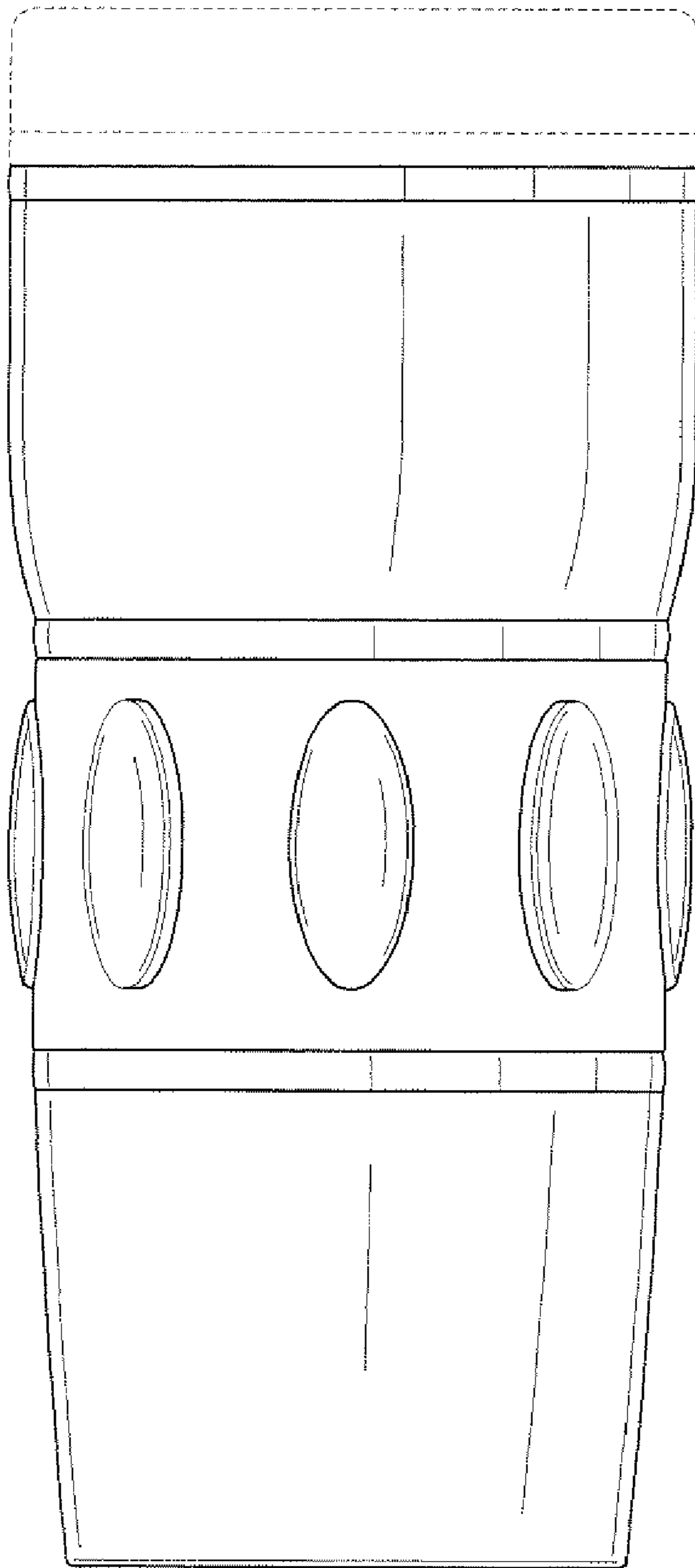




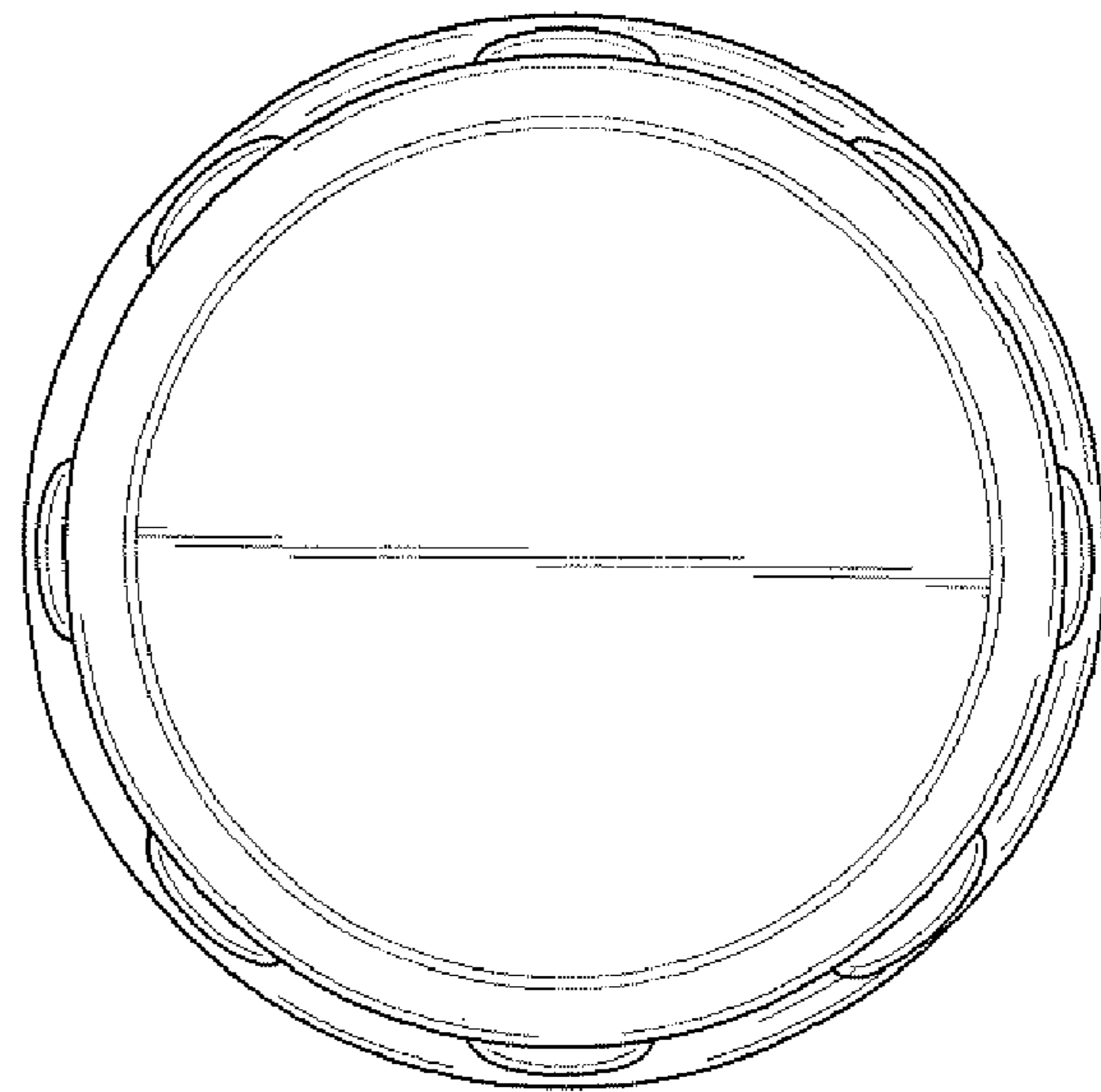
