FIG. 1 is a side elevation view of a bottle showing the present invention, the opposite side being a mirror image thereof.

FIG. 2 is a plan view from the bottom of FIG. 1.

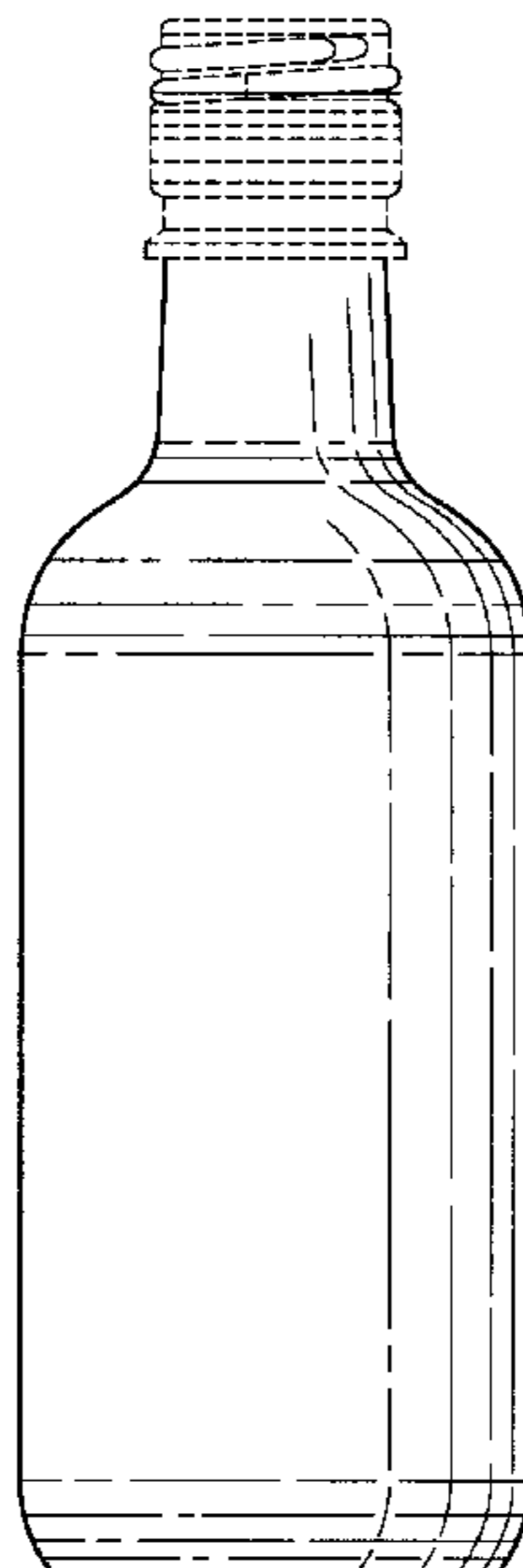
FIG. 3 is a plan view from the top of FIG. 1.

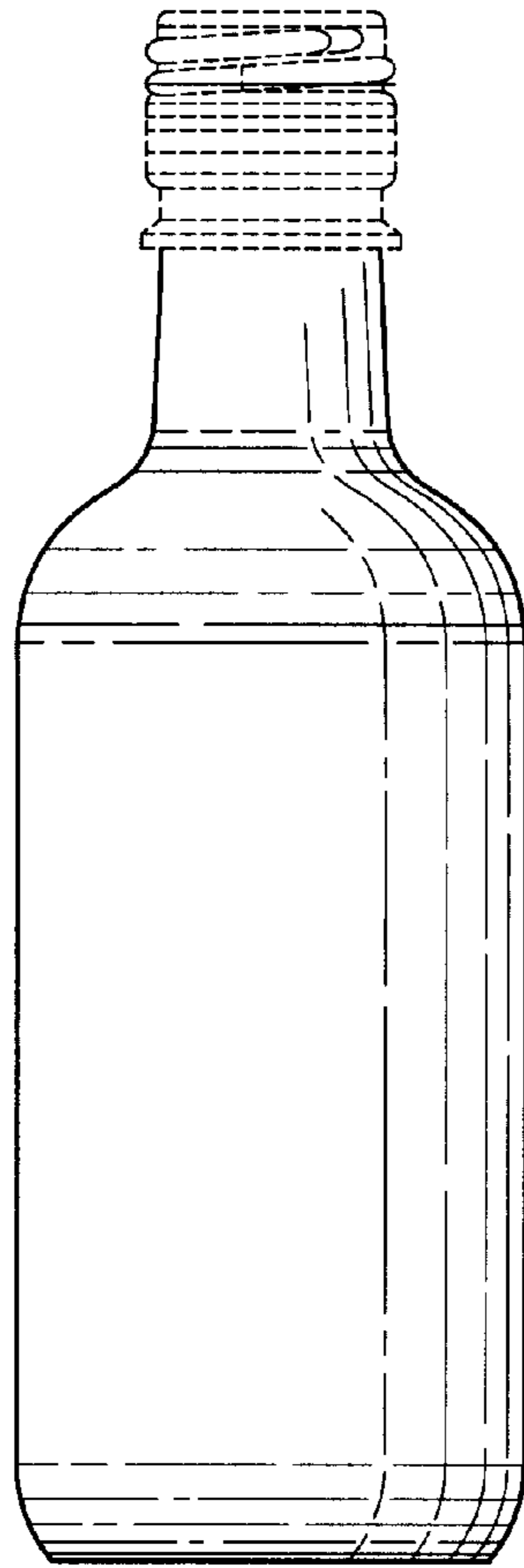

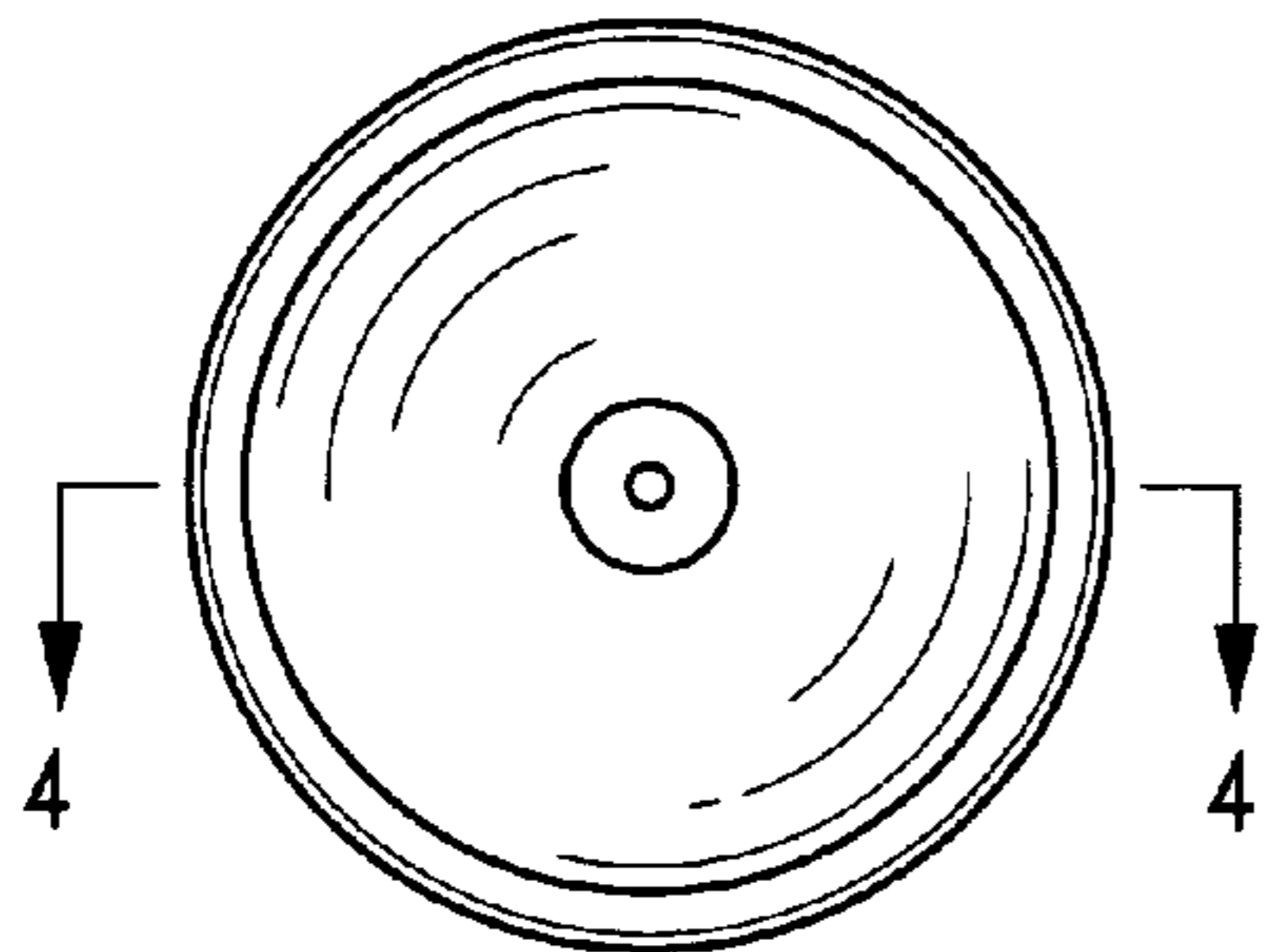

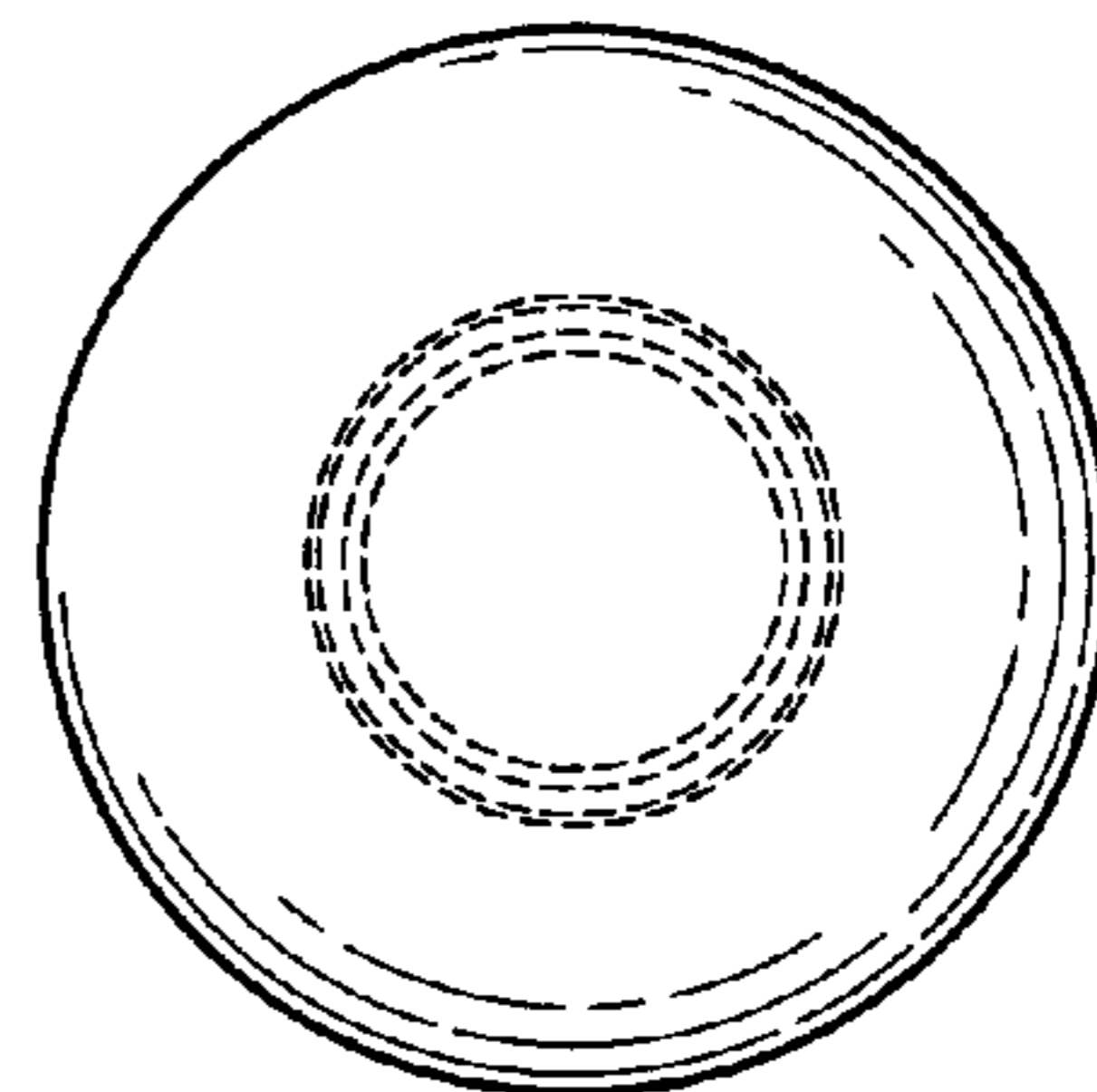

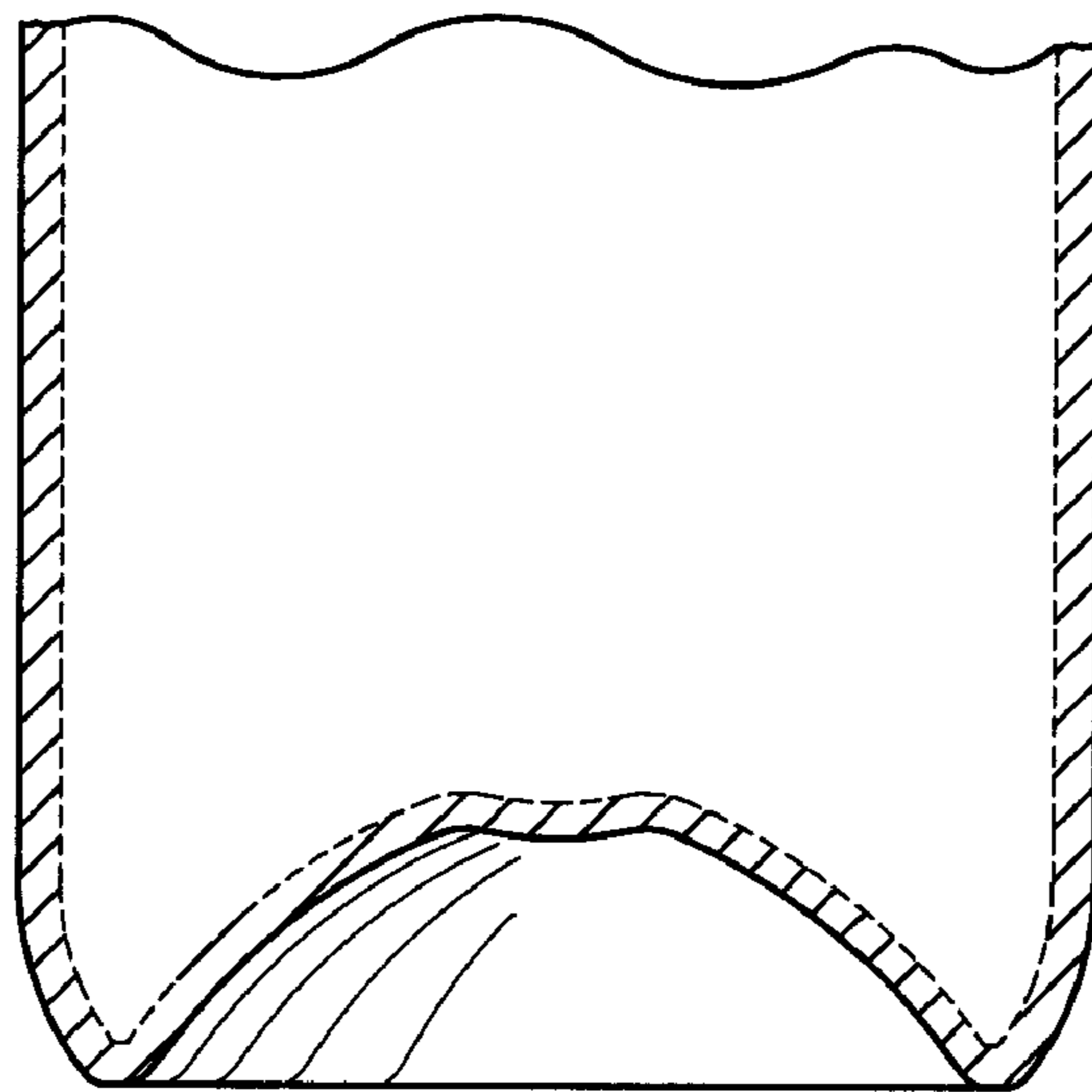

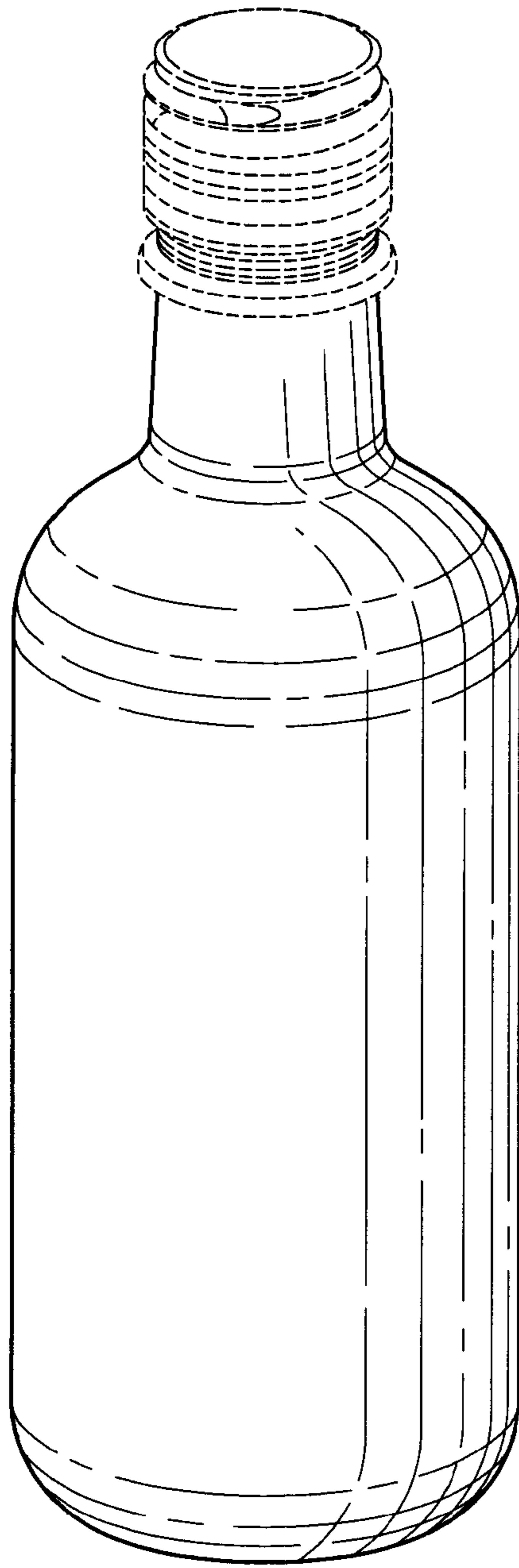
