(57) **CLAIM**

The ornamental design for an electroacoustic transducer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the top, front and left side of an electroacoustic transducer showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof, the rear view being a mirror image;

FIG. 4 is a left side elevational view thereof, the right side being a mirror image; and,

FIG. 5 is a bottom plan view thereof.

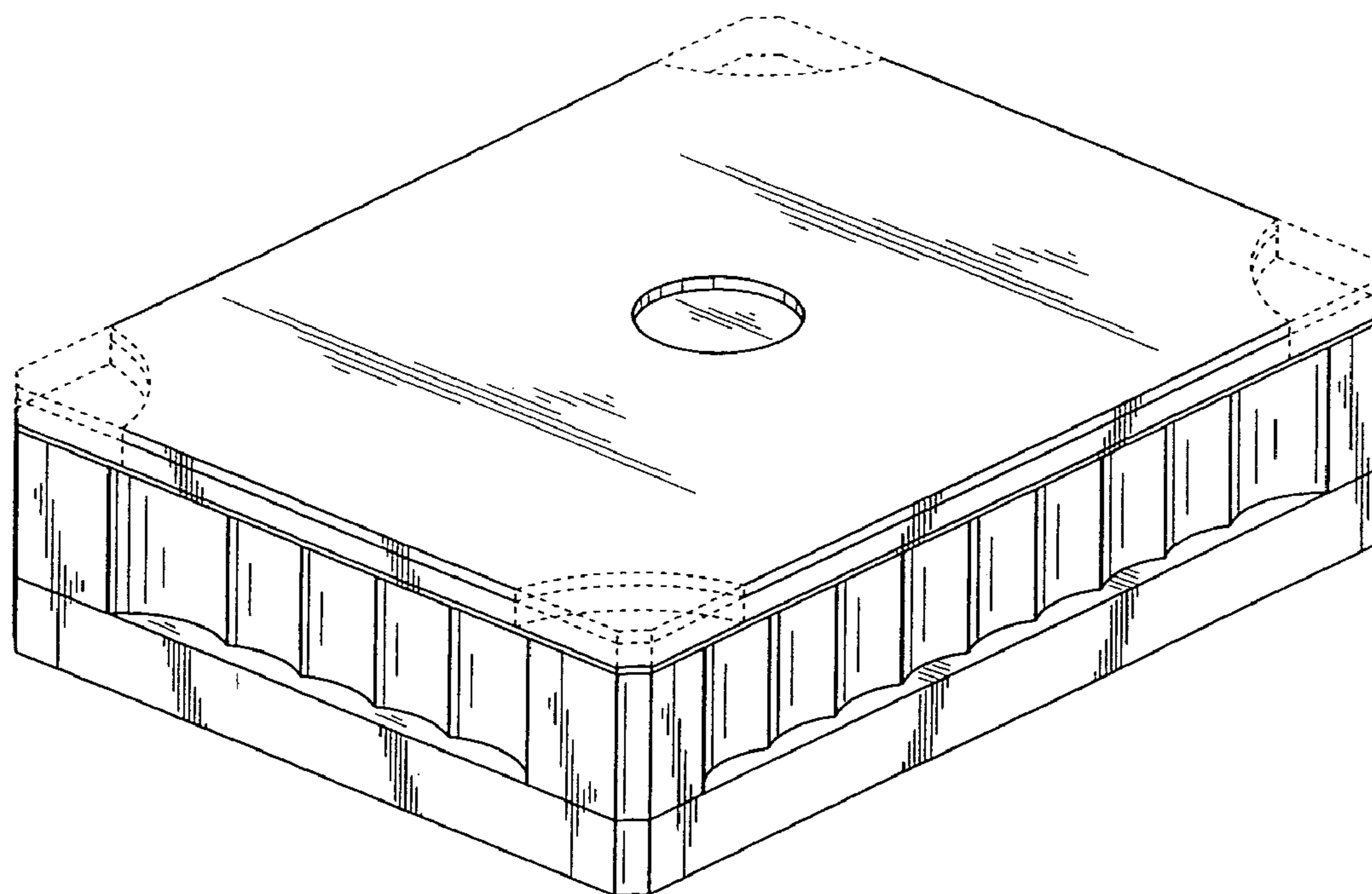

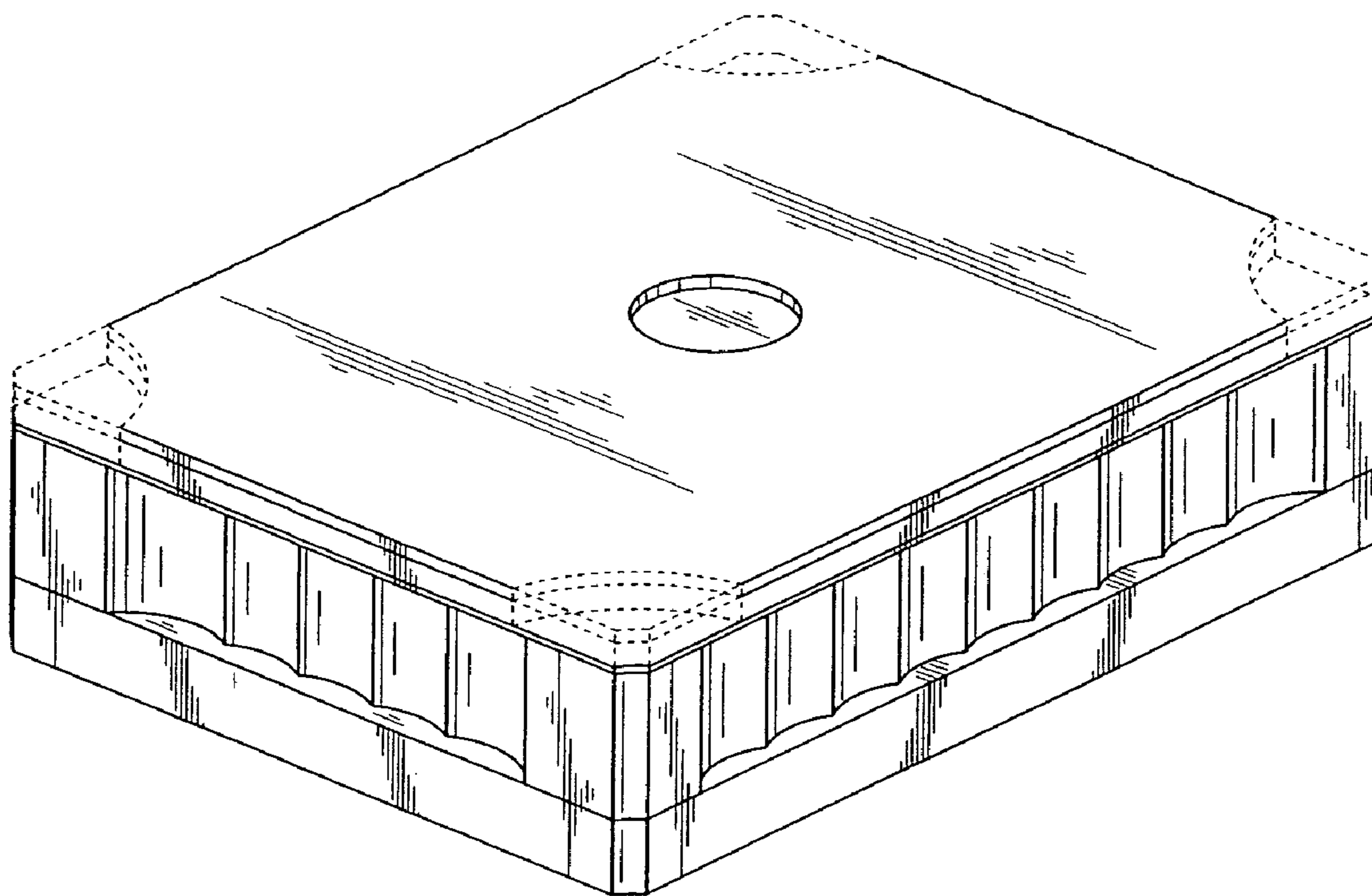

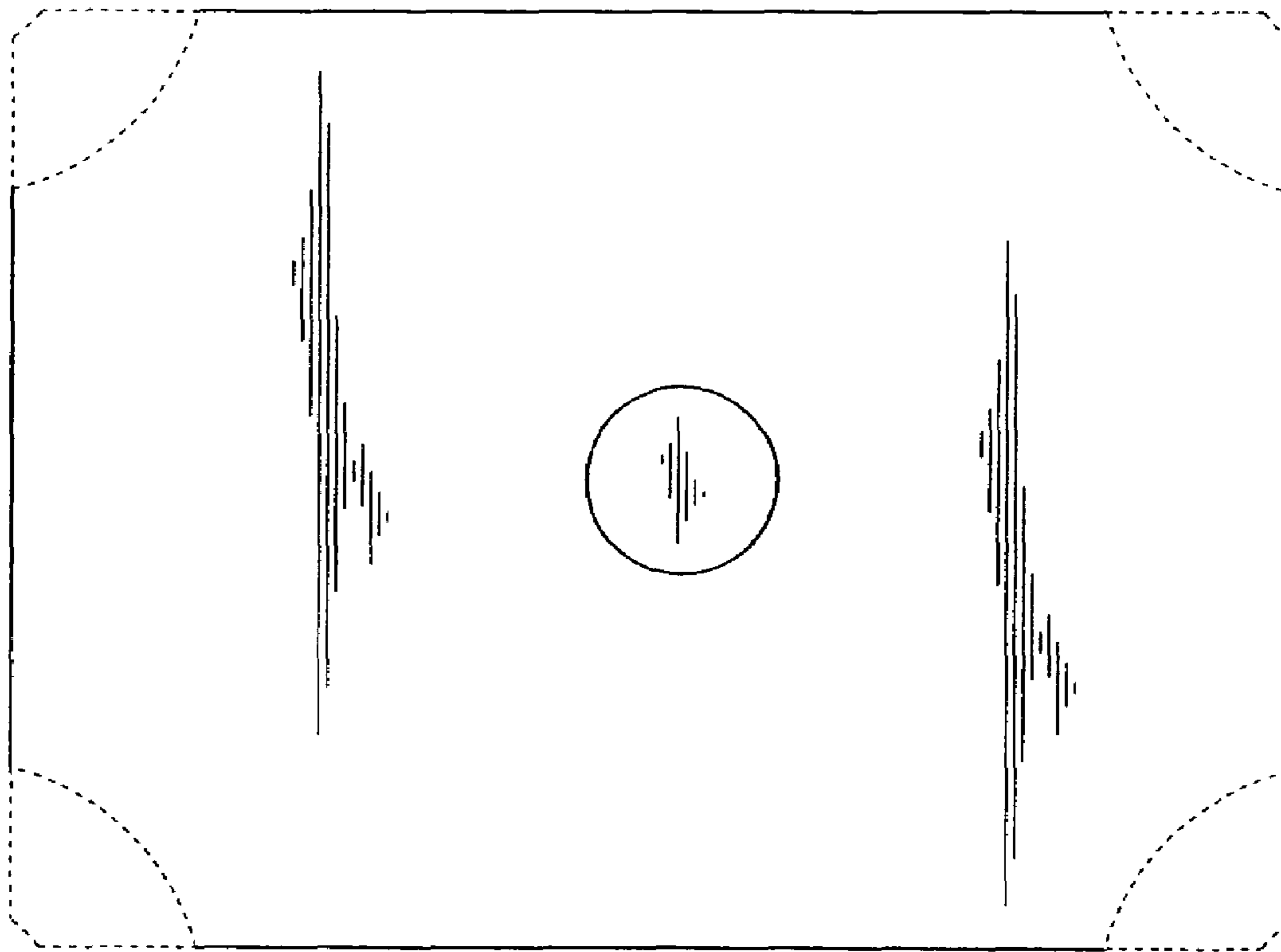

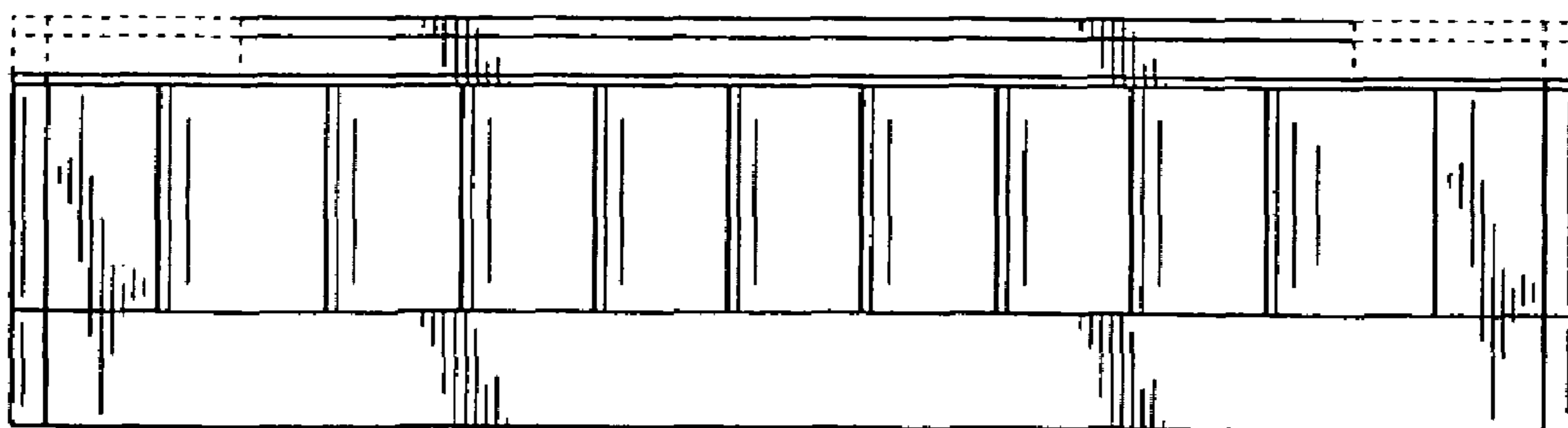

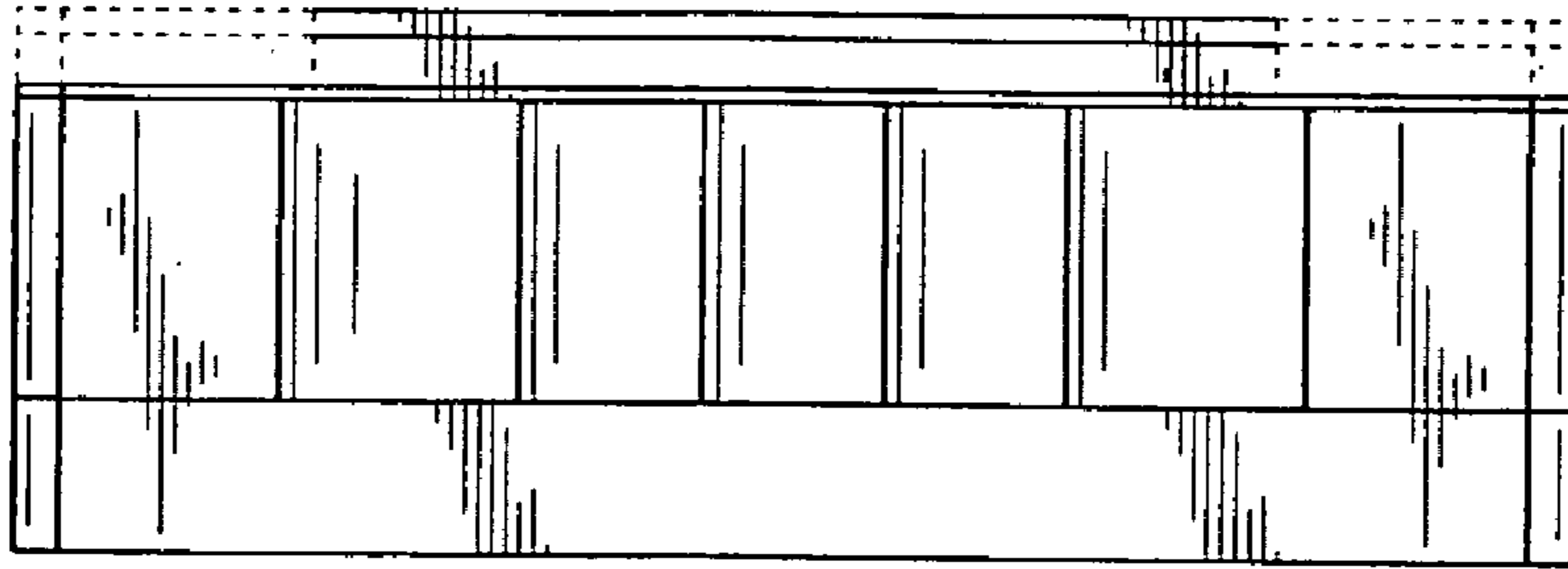
