(57) **CLAIM**

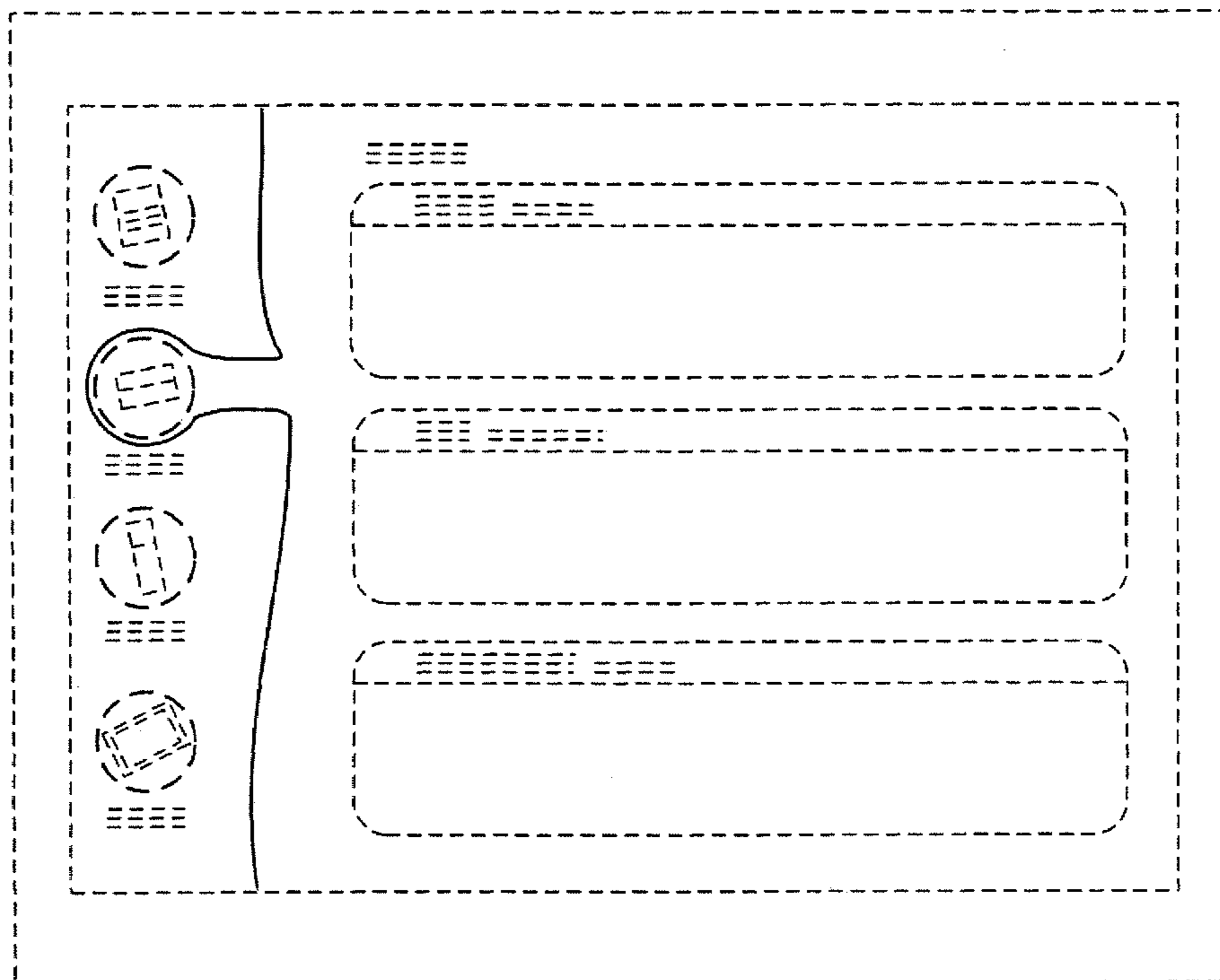
The ornamental design for graphic user interface computer

**DESCRIPTION**

FIG. 1 is a front view of a graphic user interface computer  
icon for a monitor display in accordance with the invention;  
FIG. 2 is a front view of a second embodiment thereof;  
FIG. 3 is a front view of a third embodiment thereof; and,  
FIG. 4 is a front view of a fourth embodiment thereof.

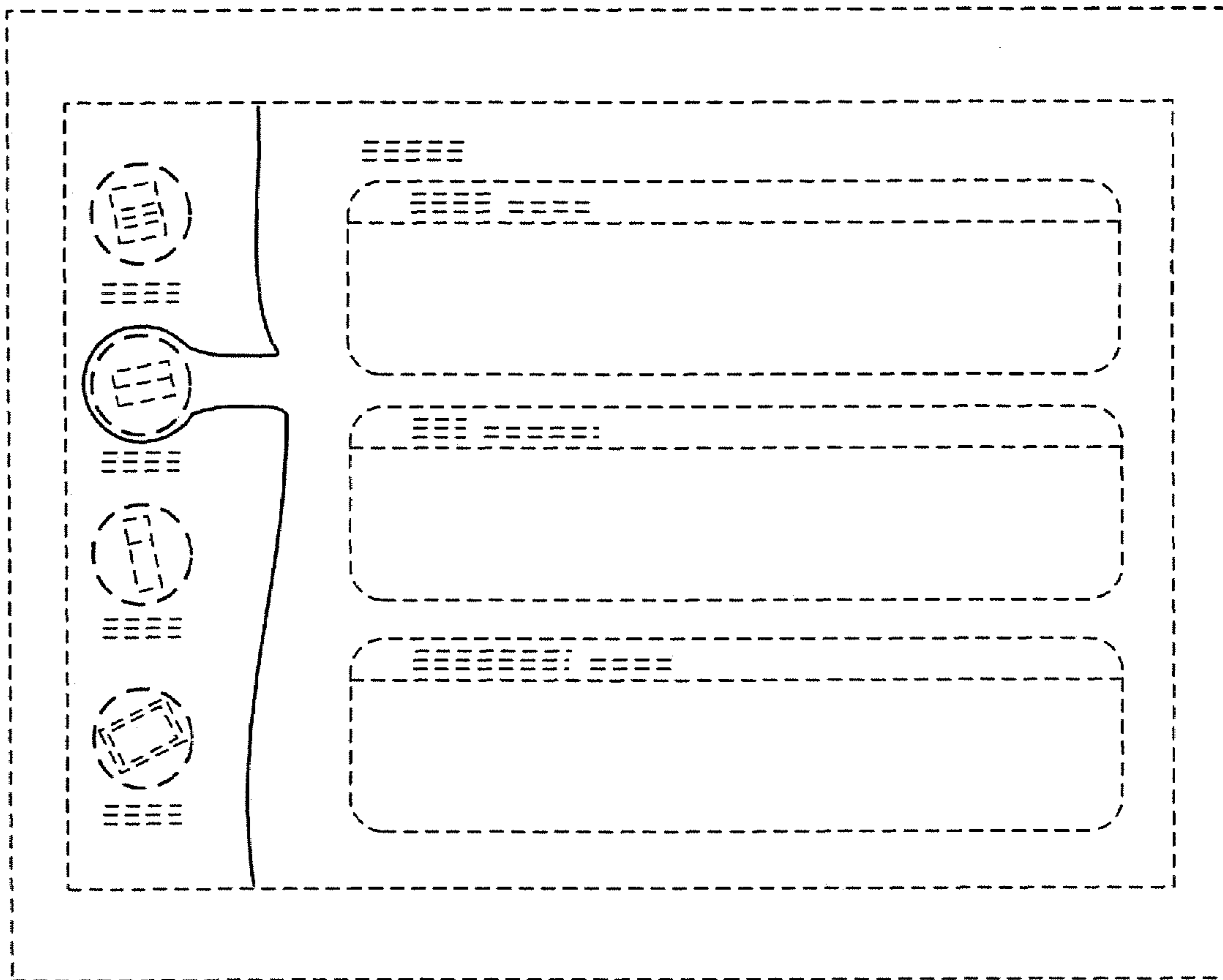

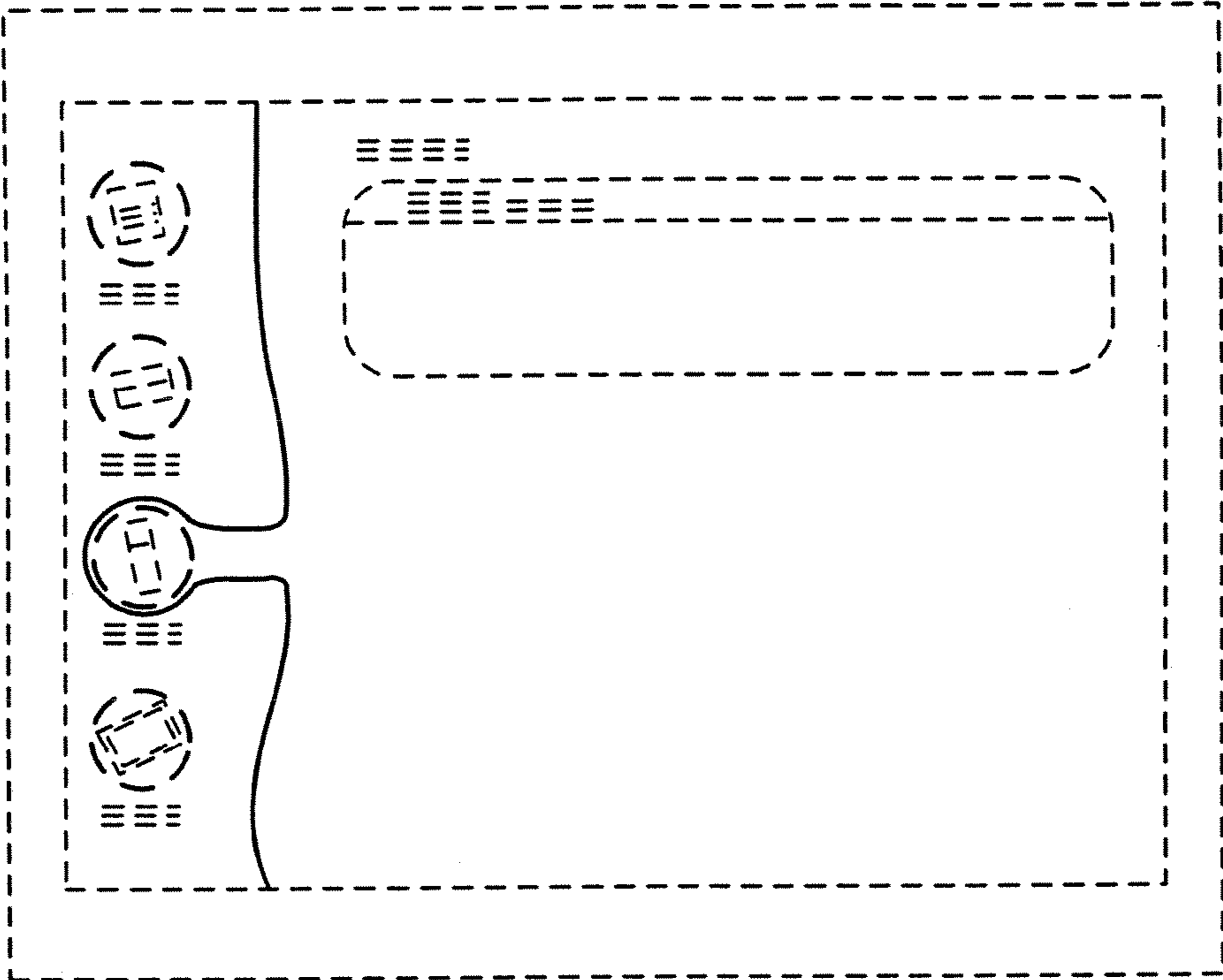

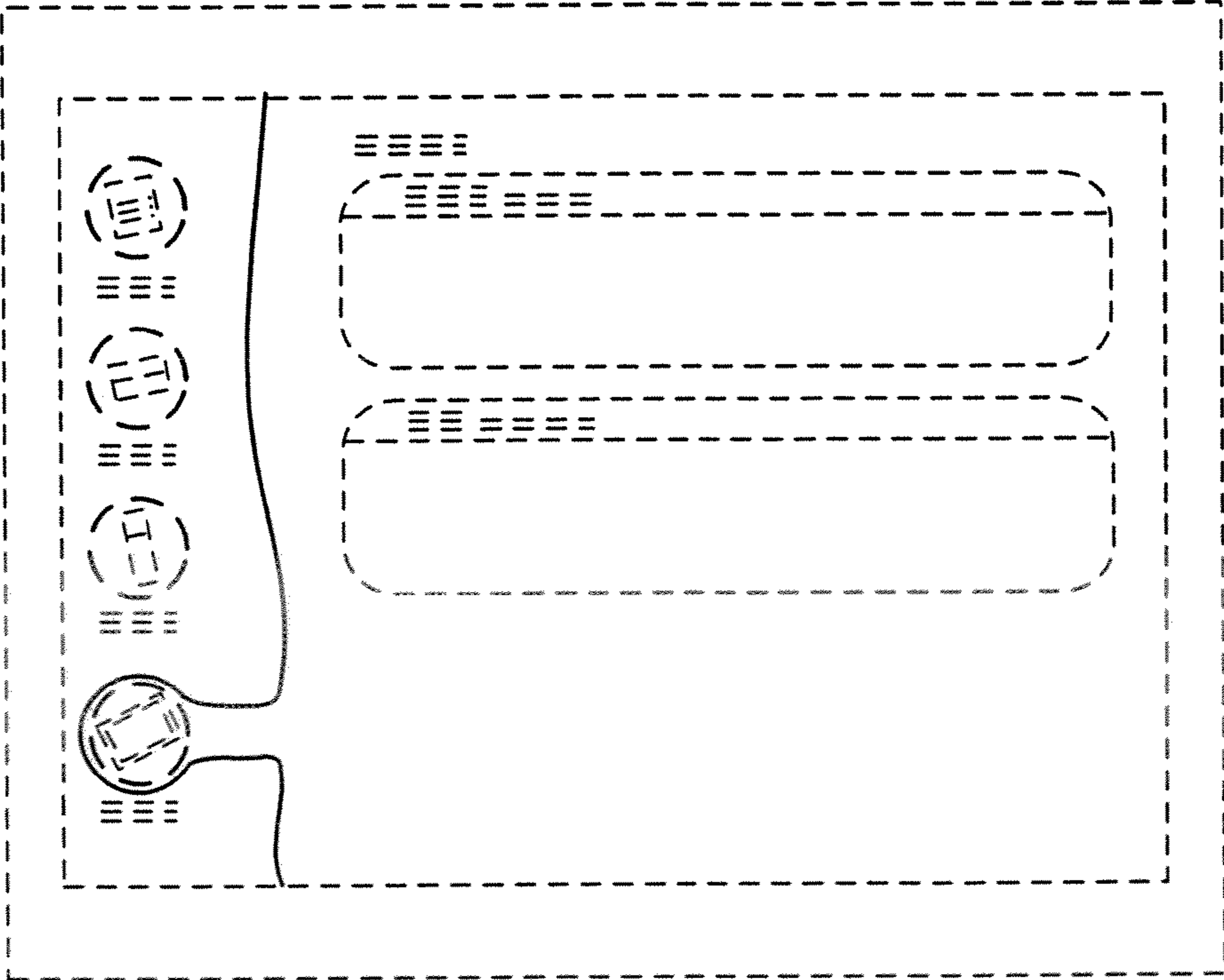

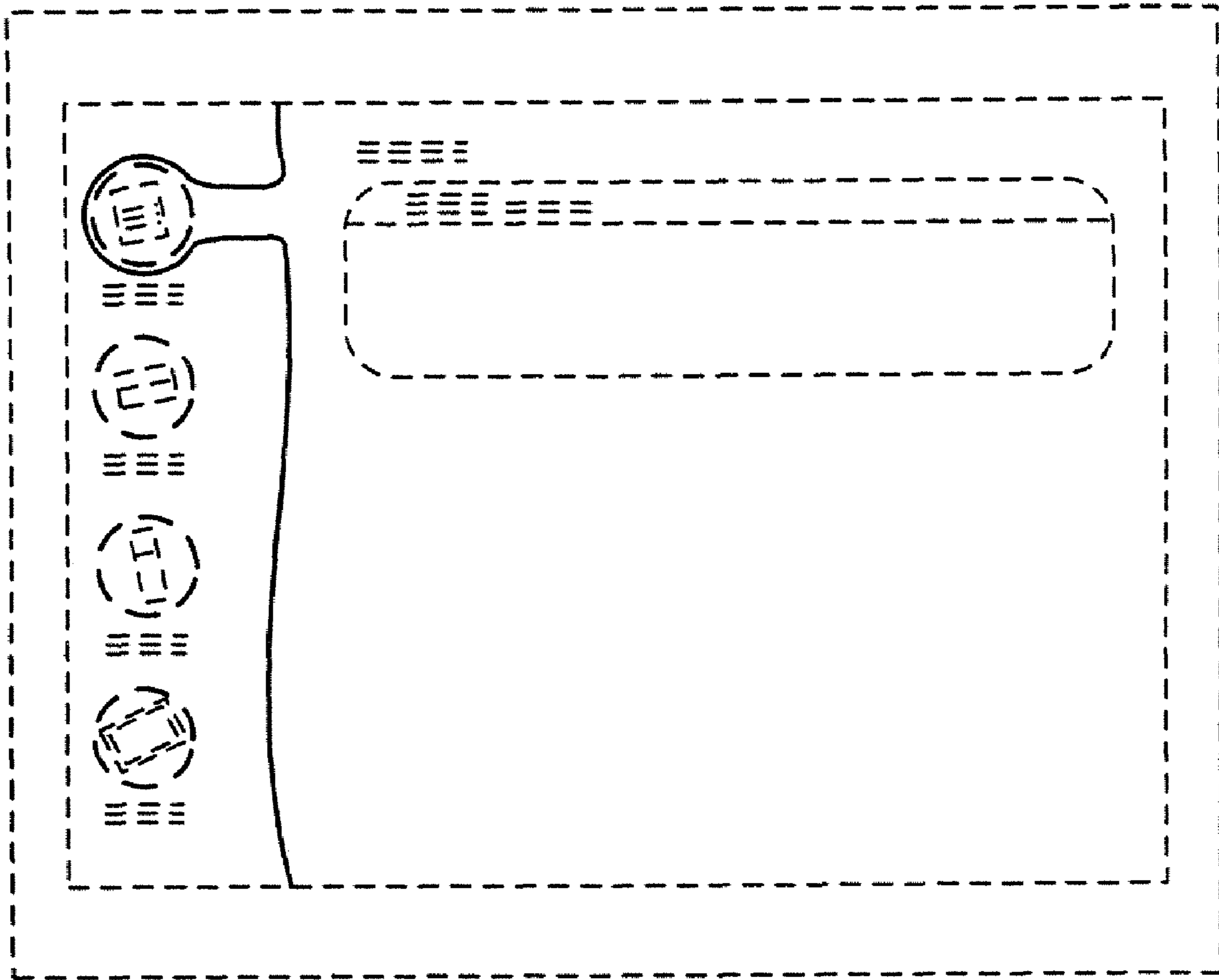
