FIG. 18 is a rear elevational view thereof;

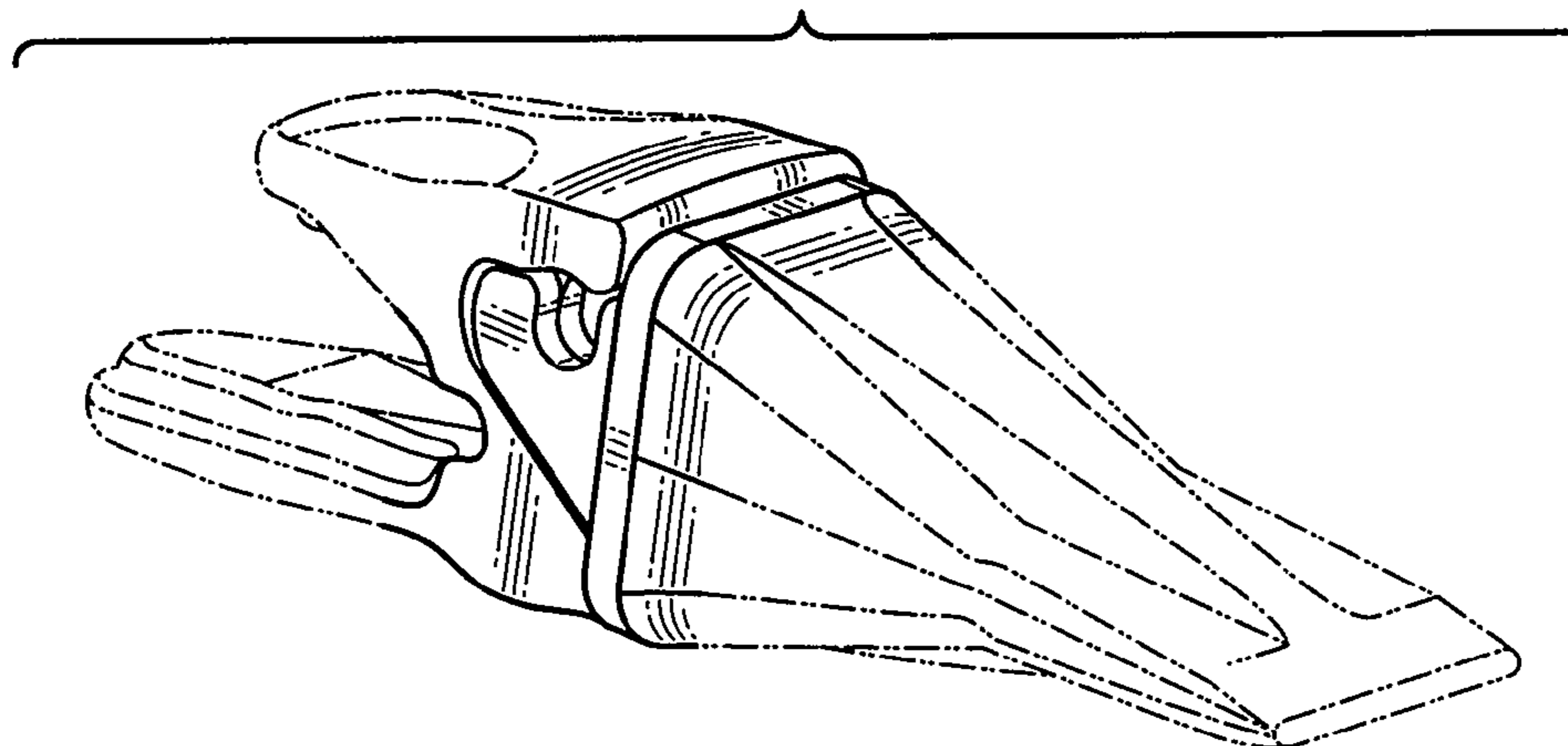
FIG. 19 is a top plan view thereof;

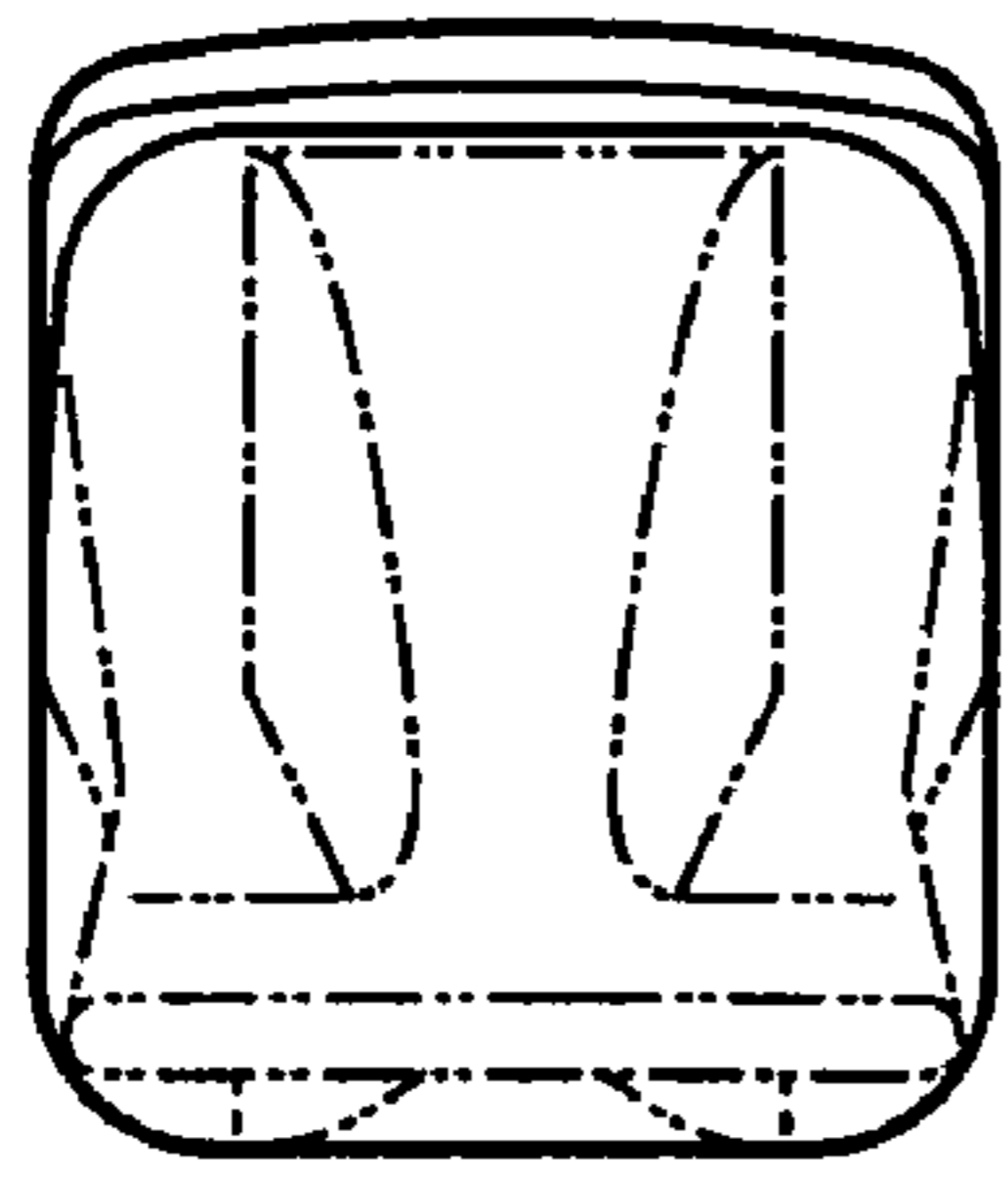

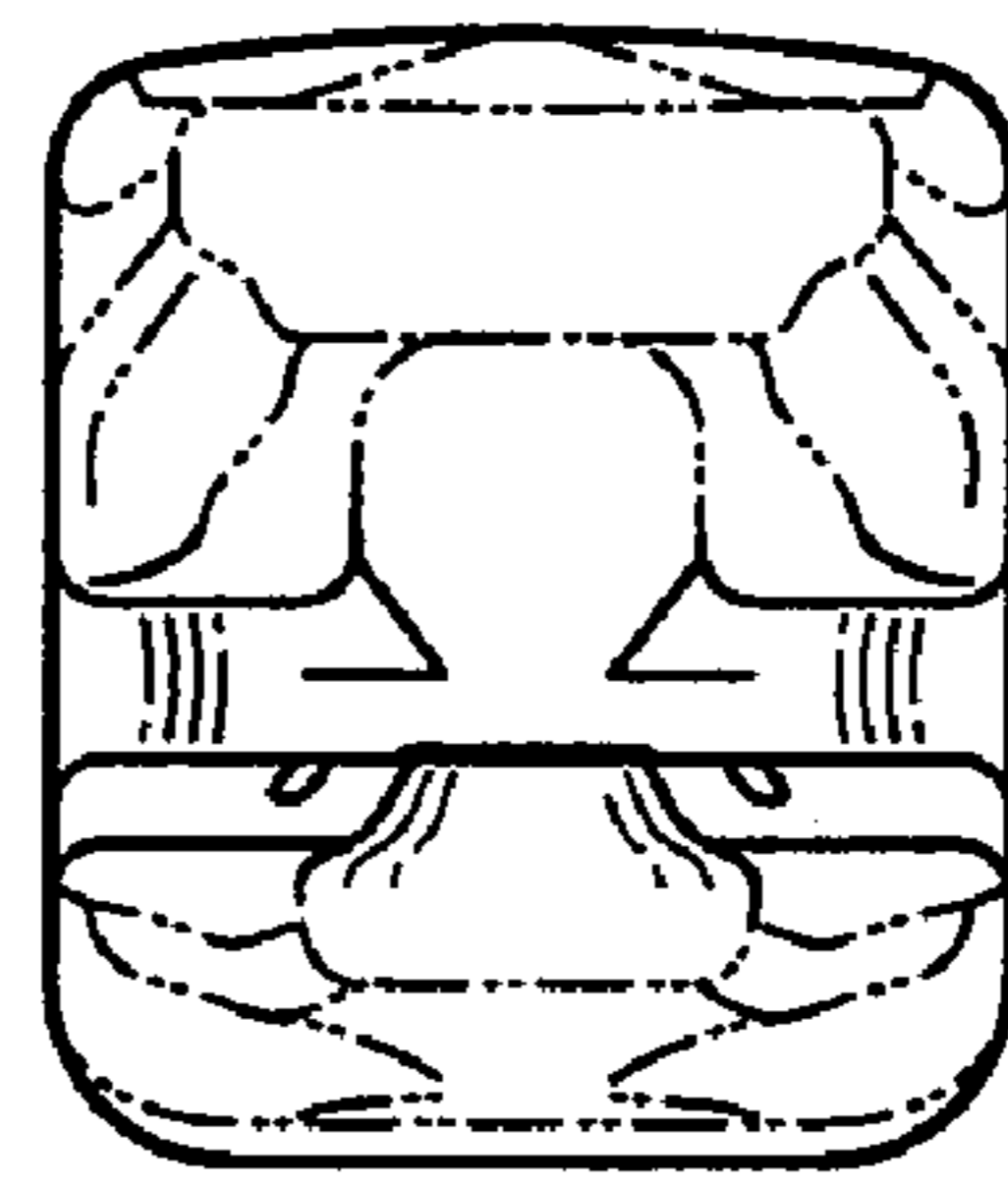

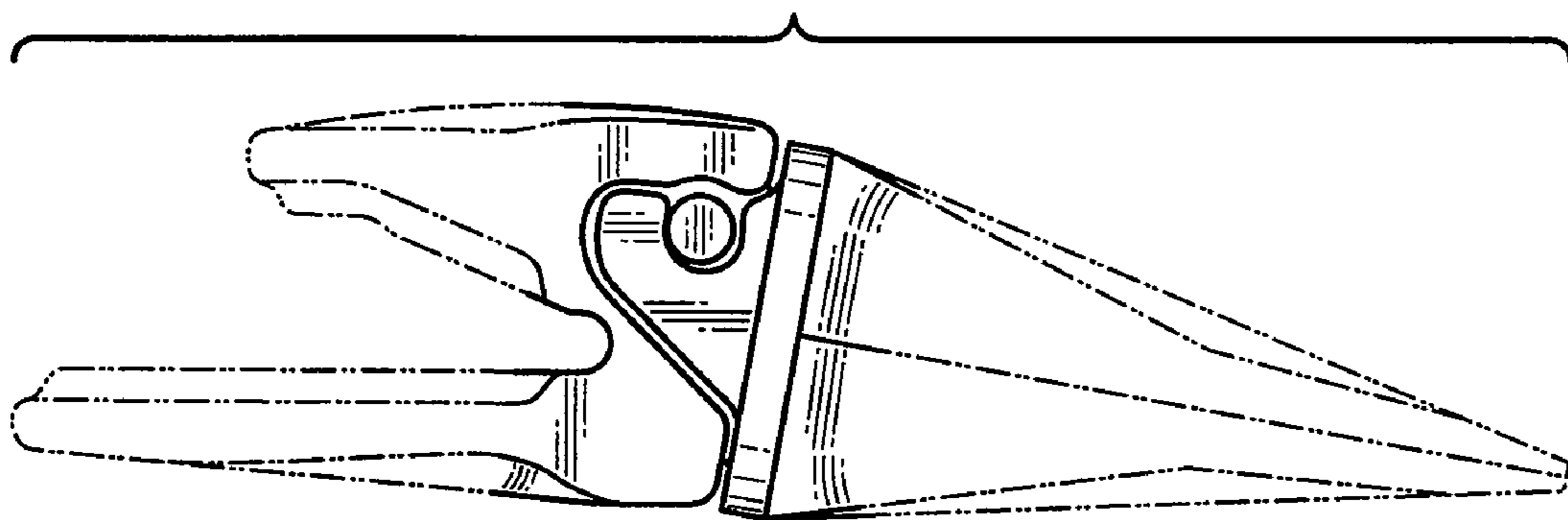

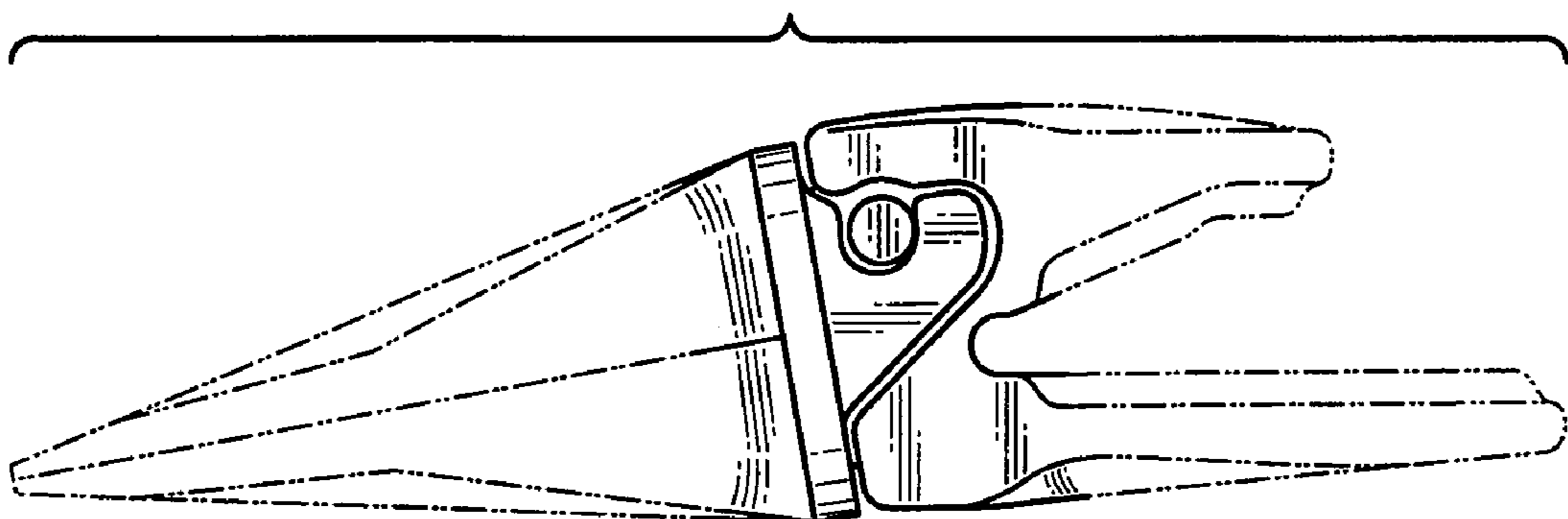

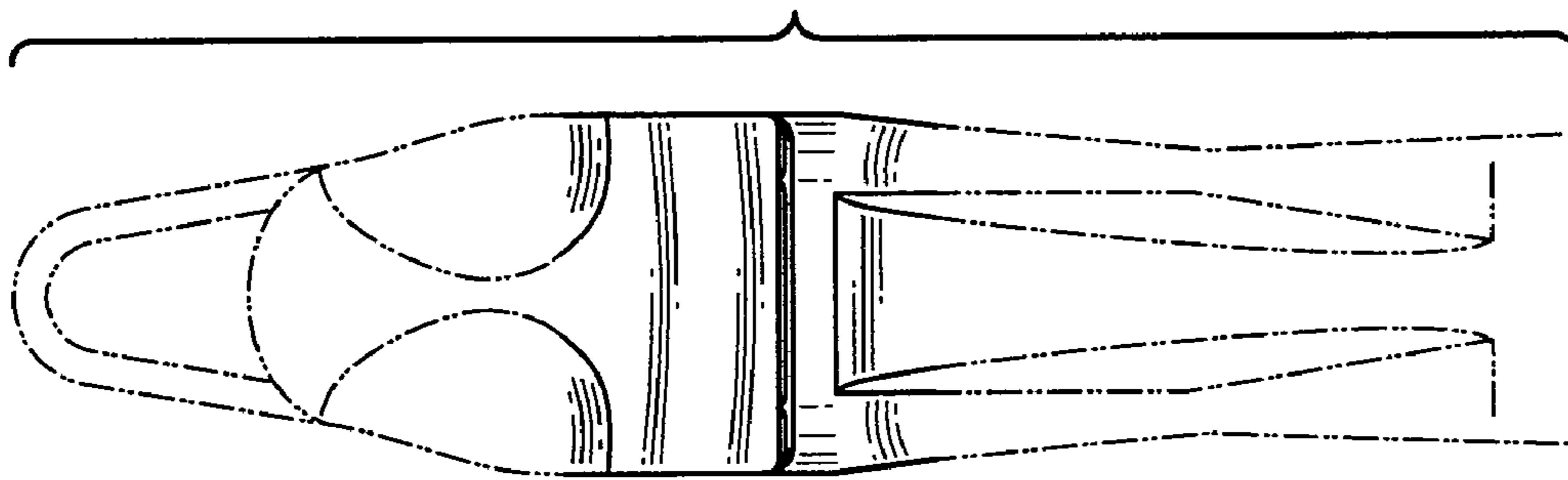

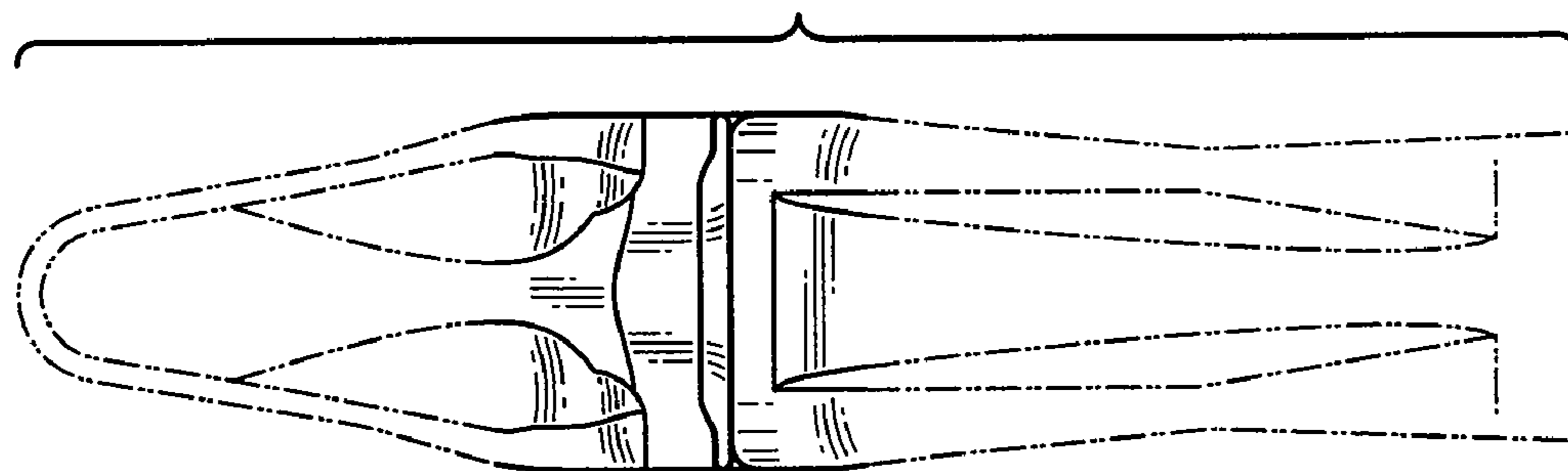

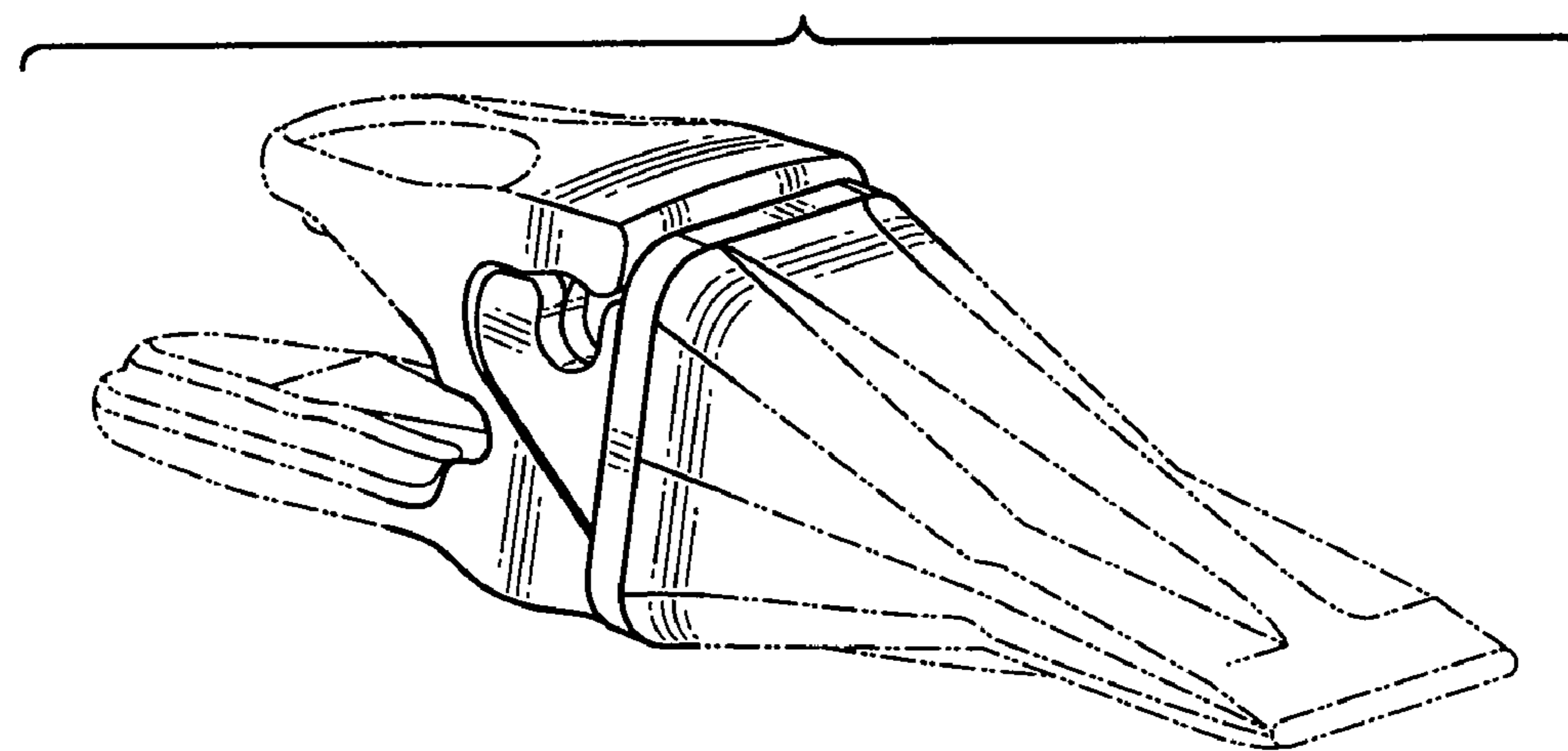

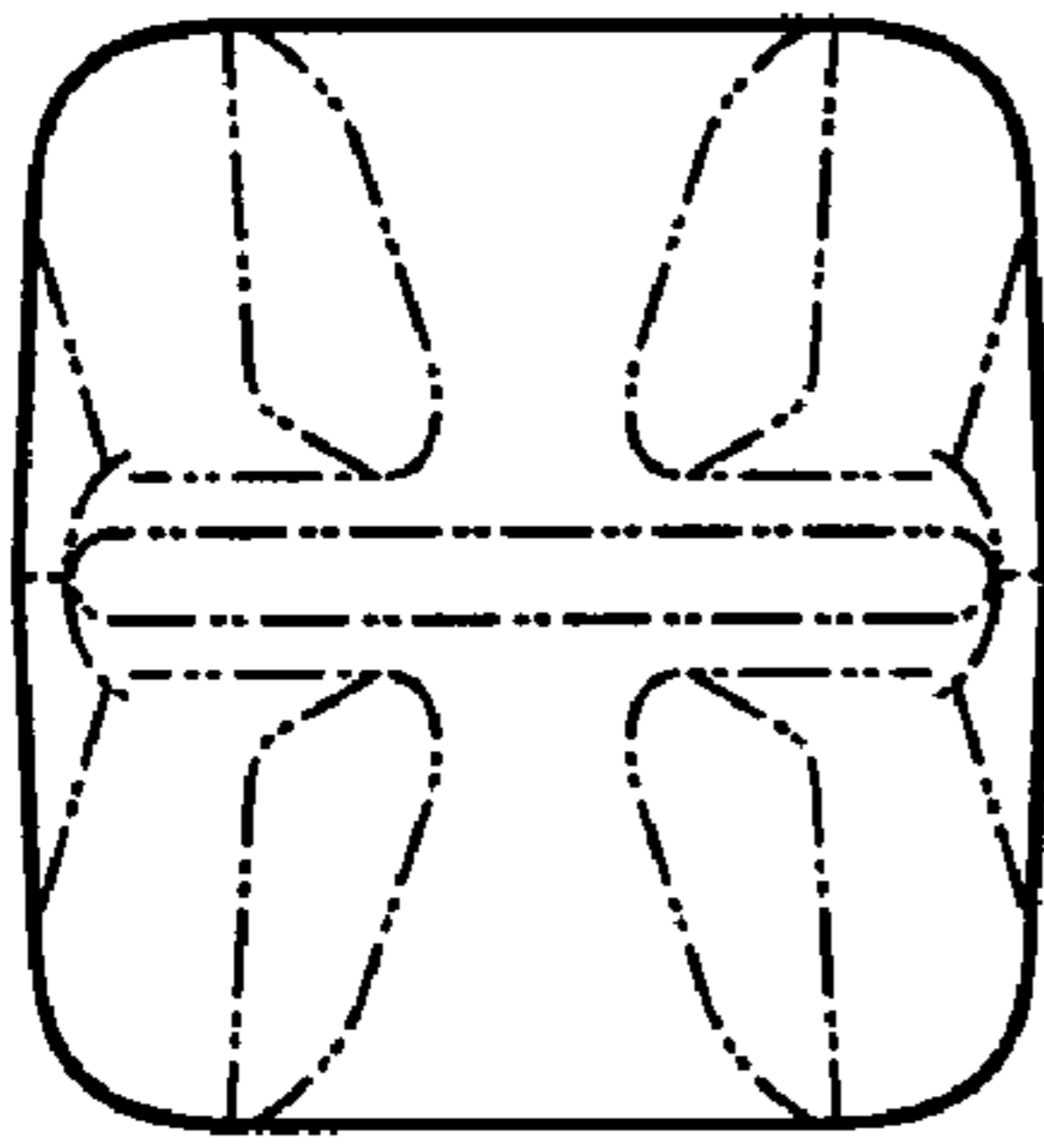

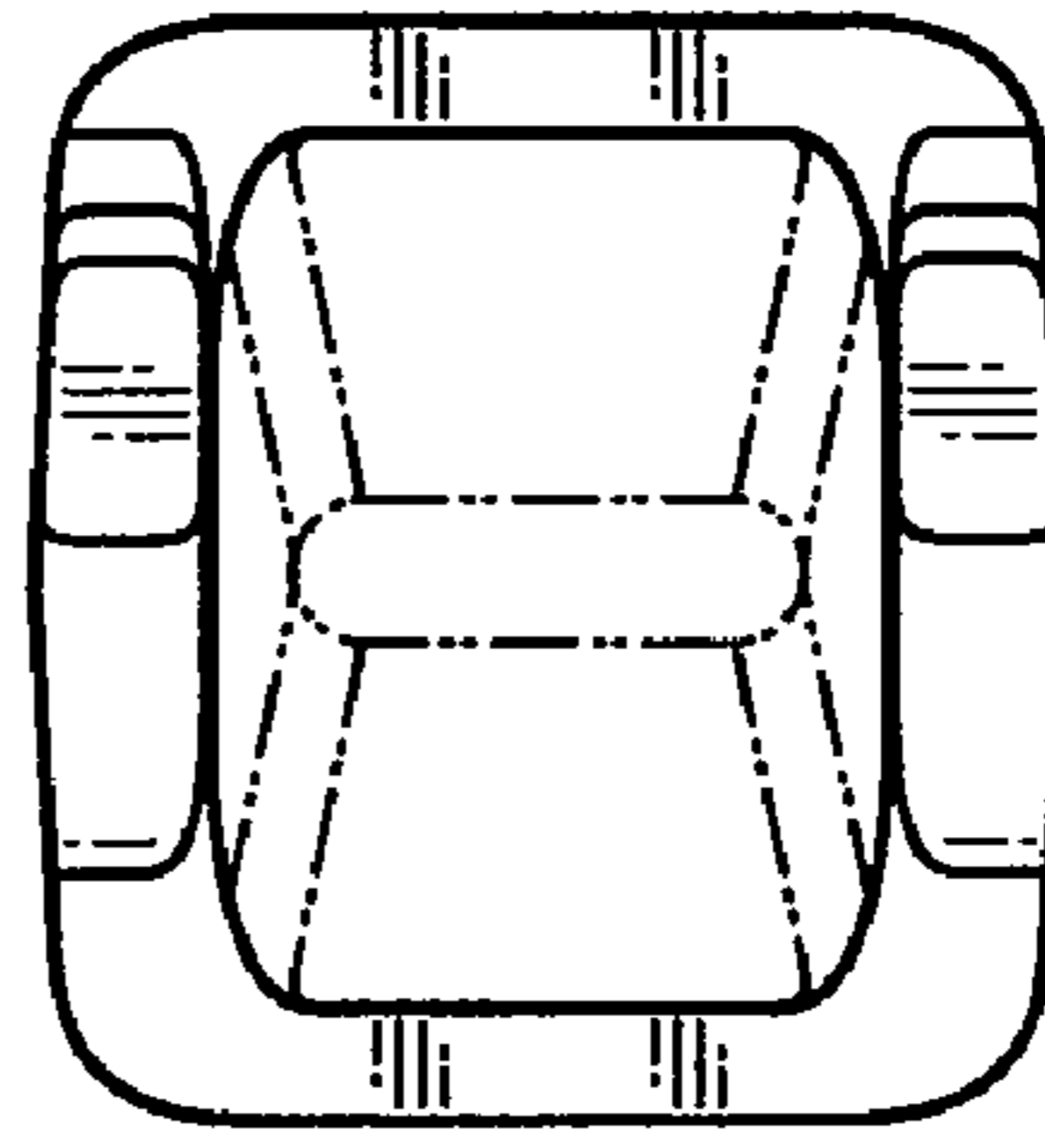

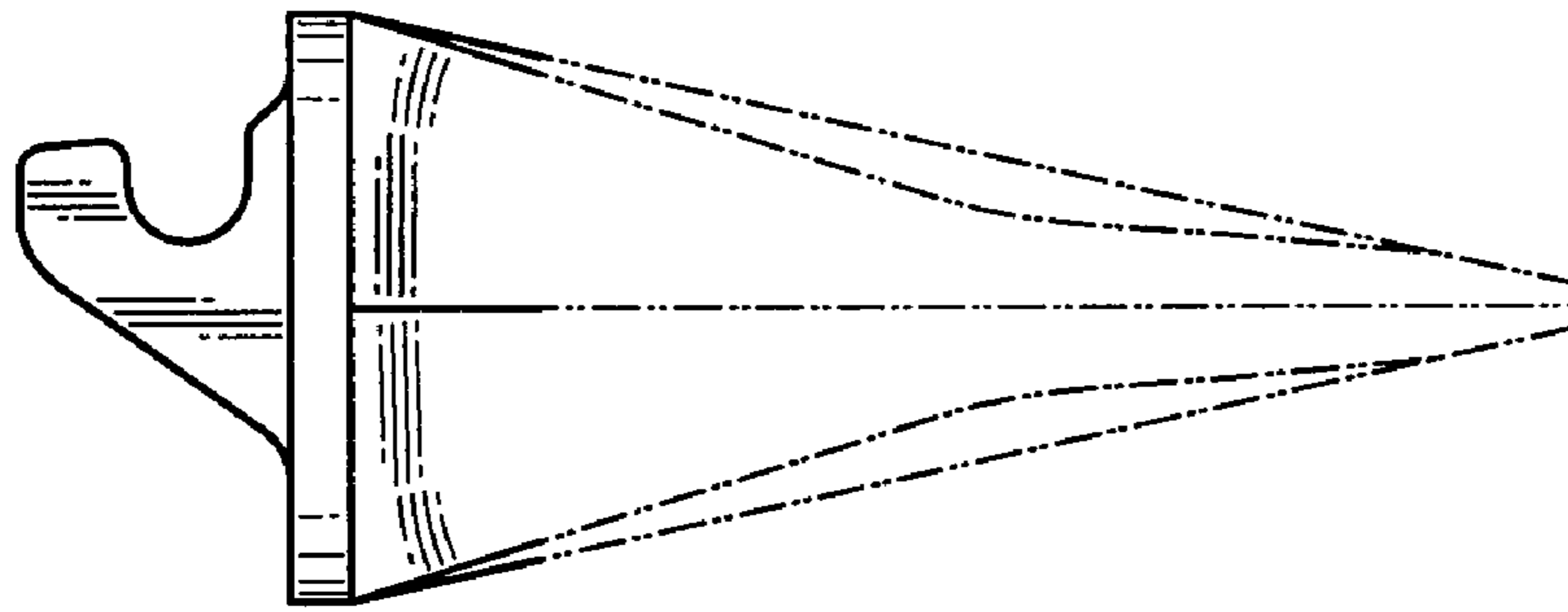

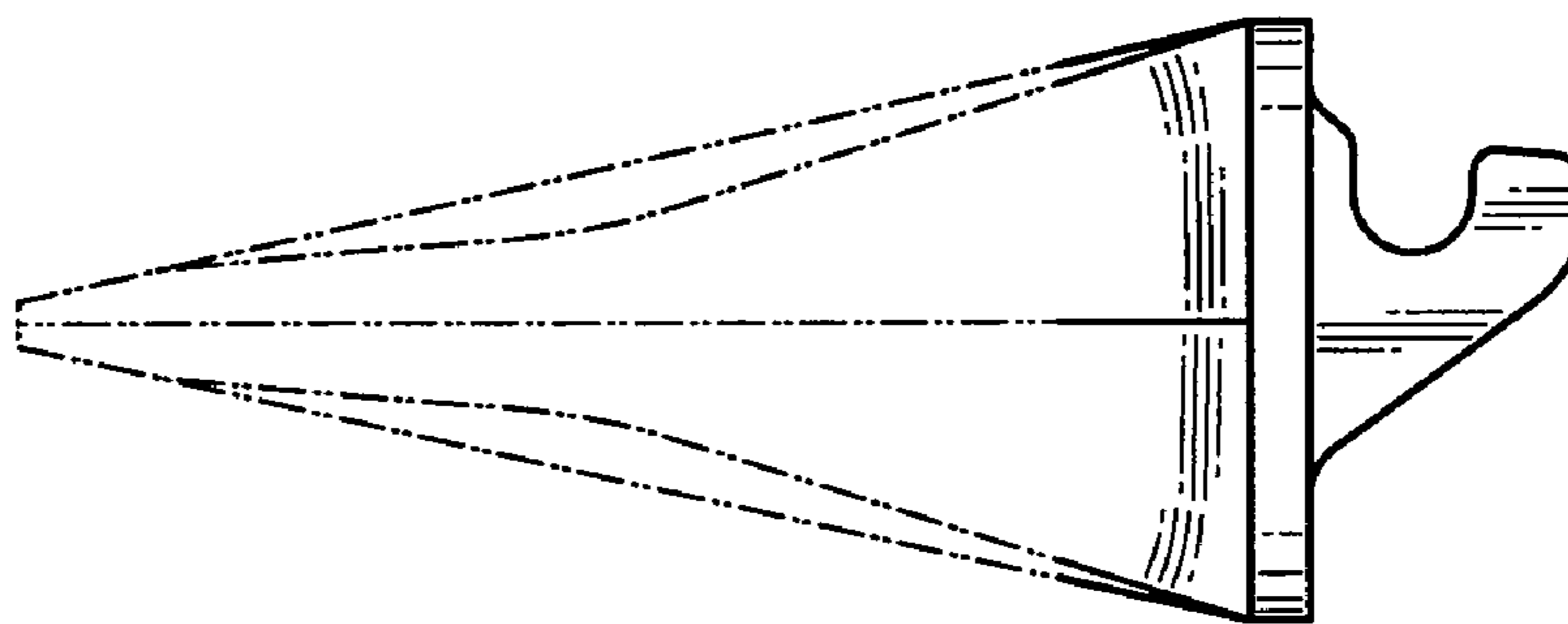

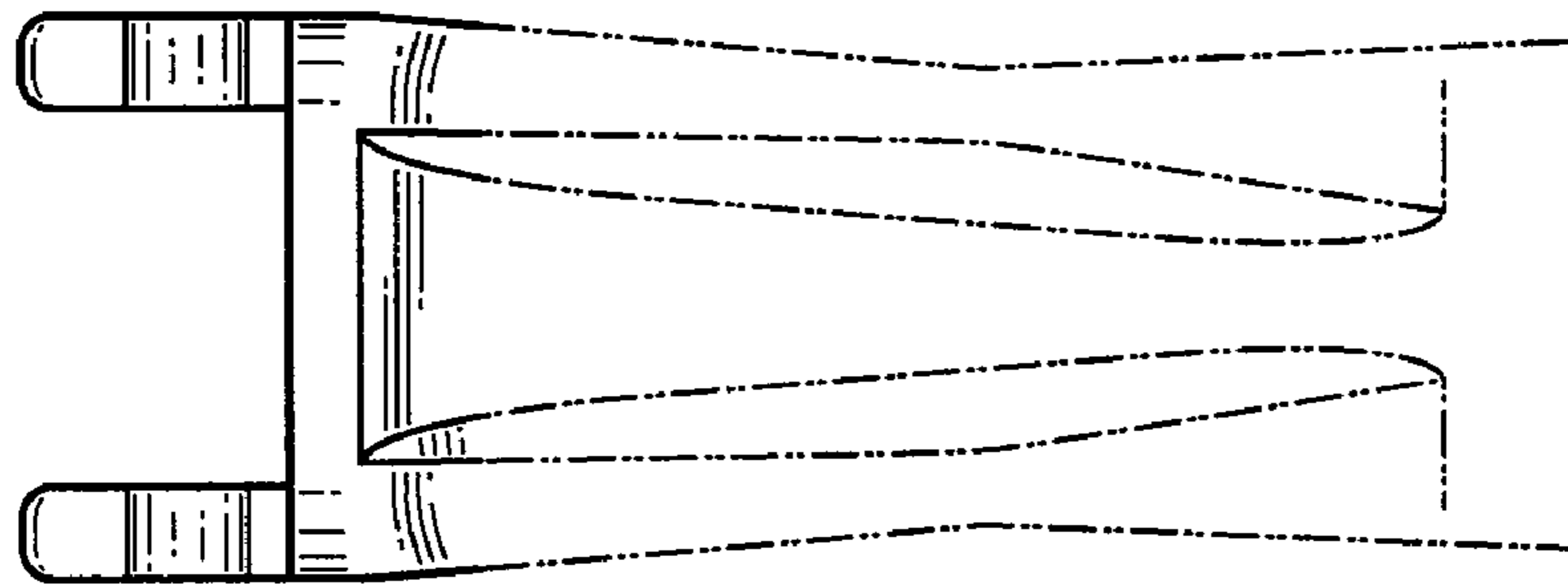

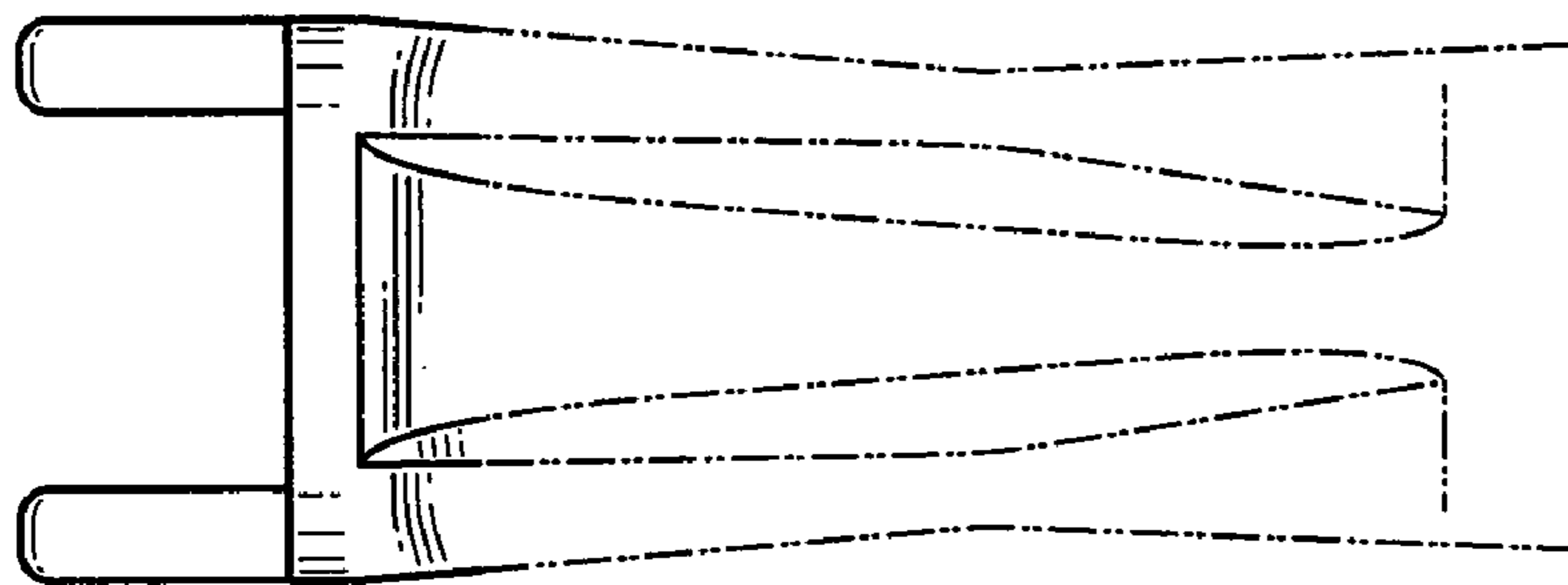

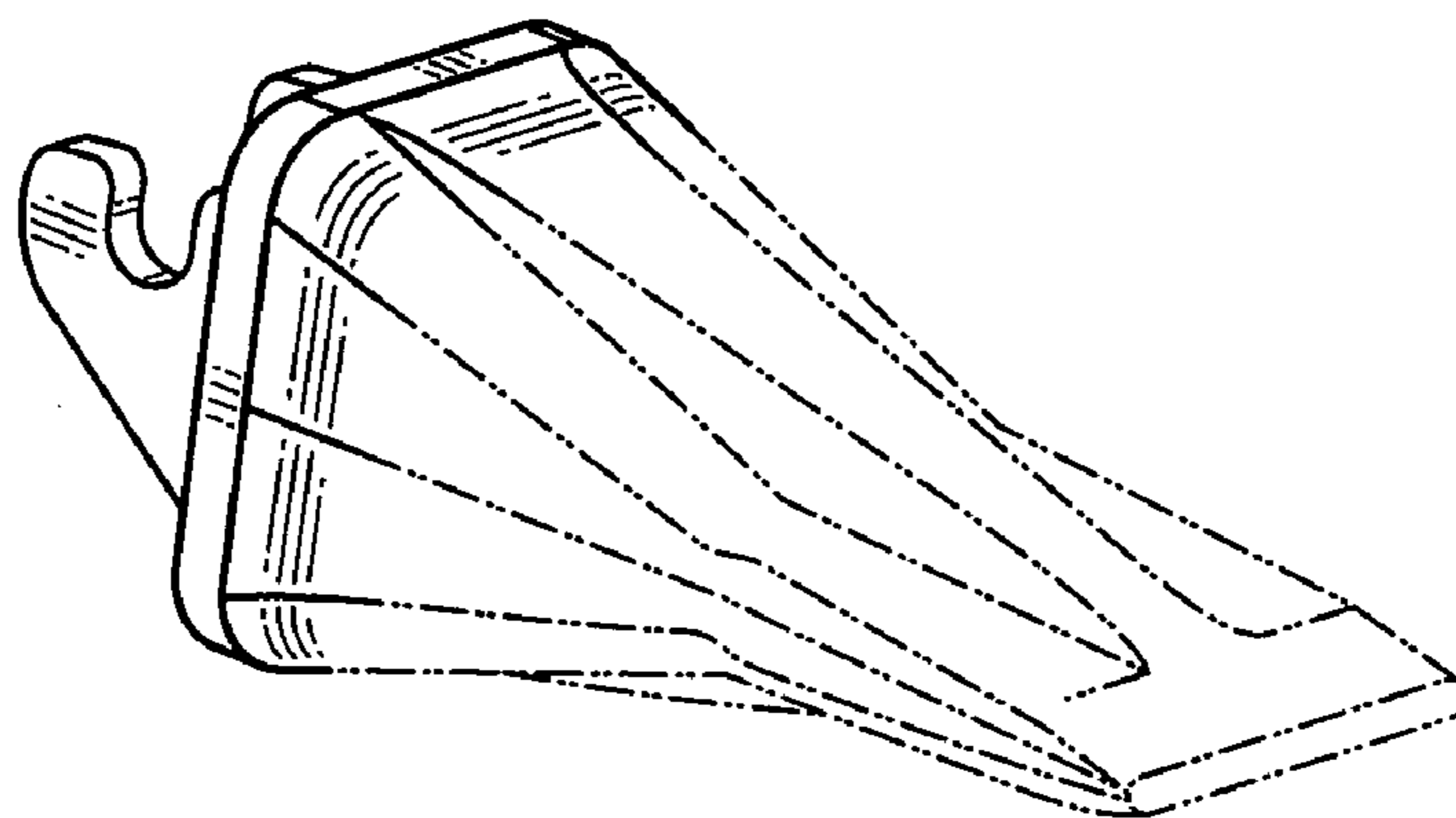

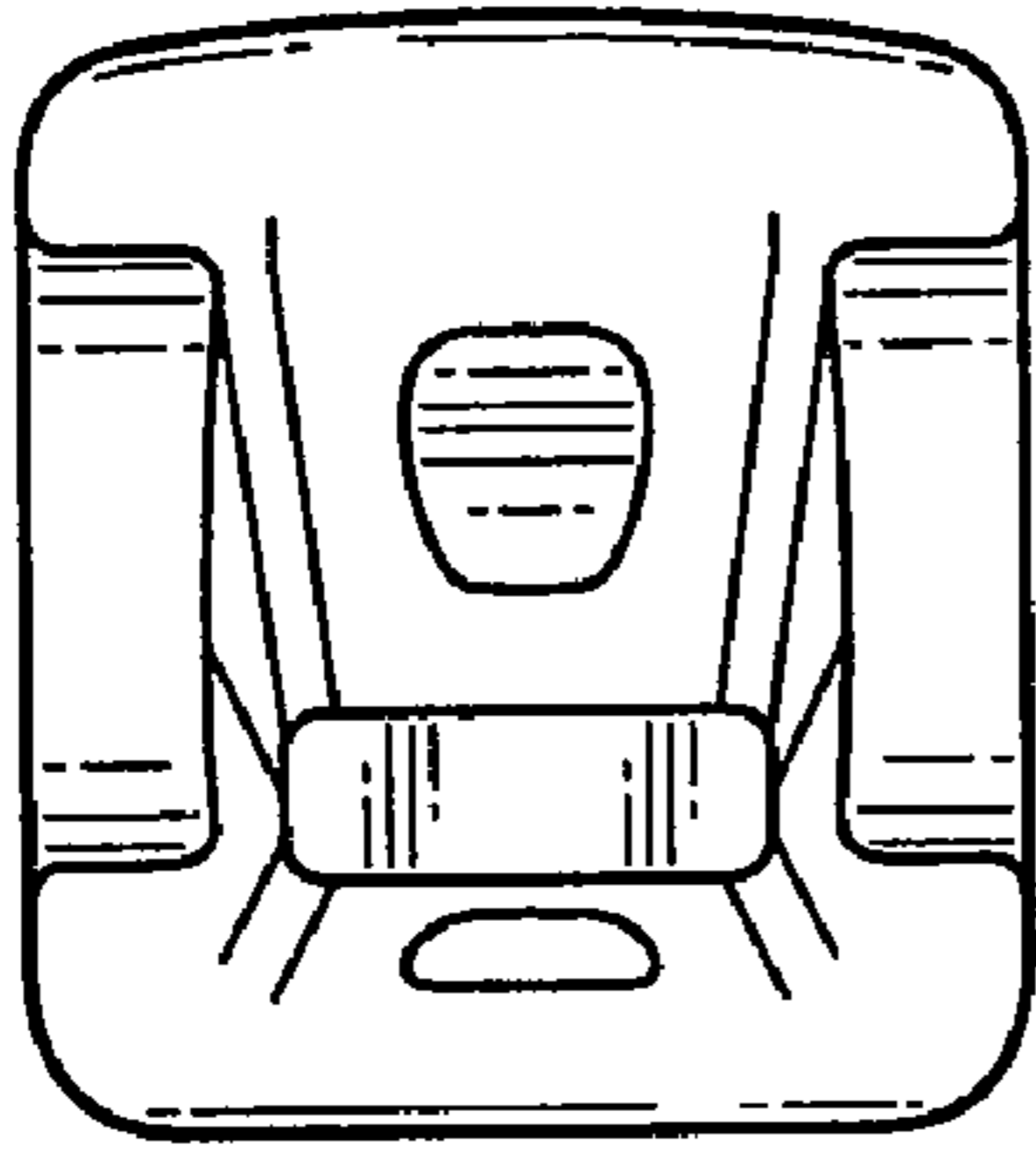

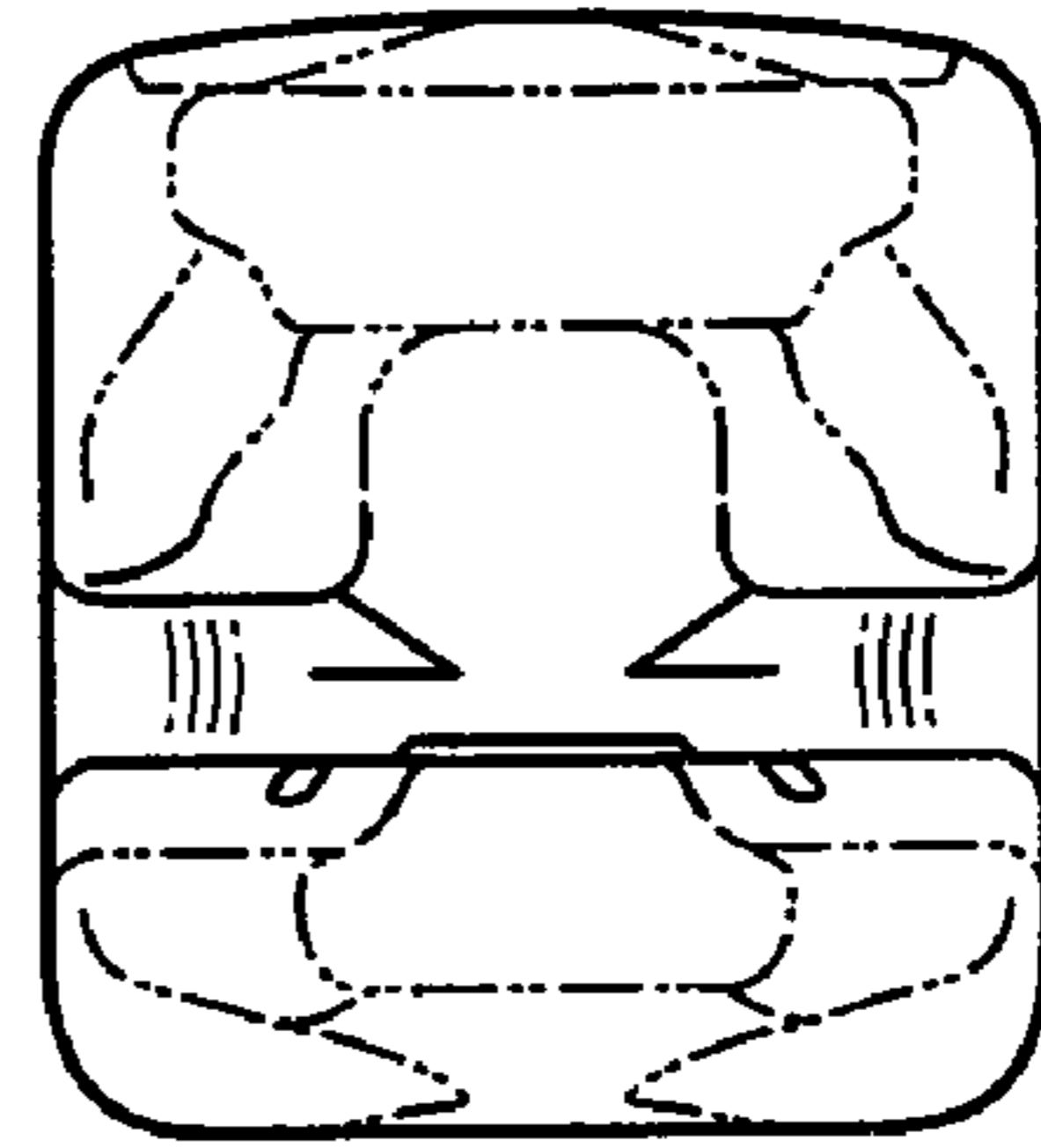

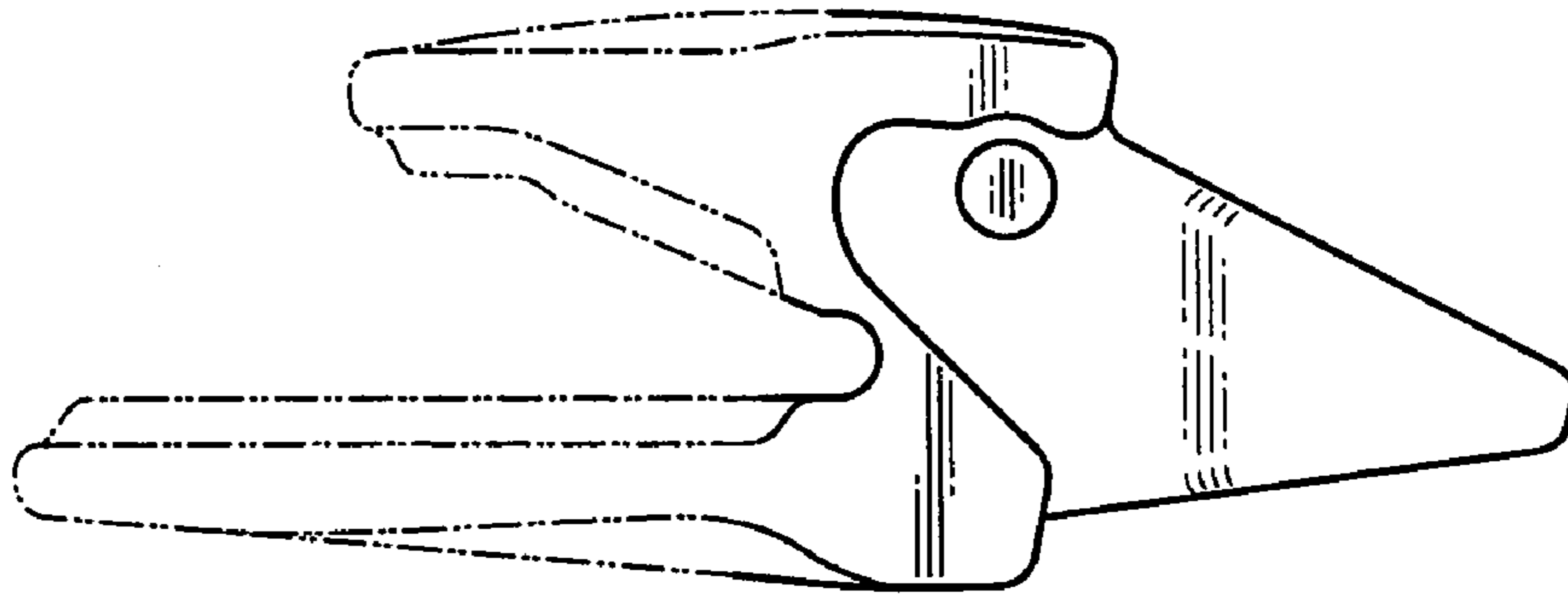

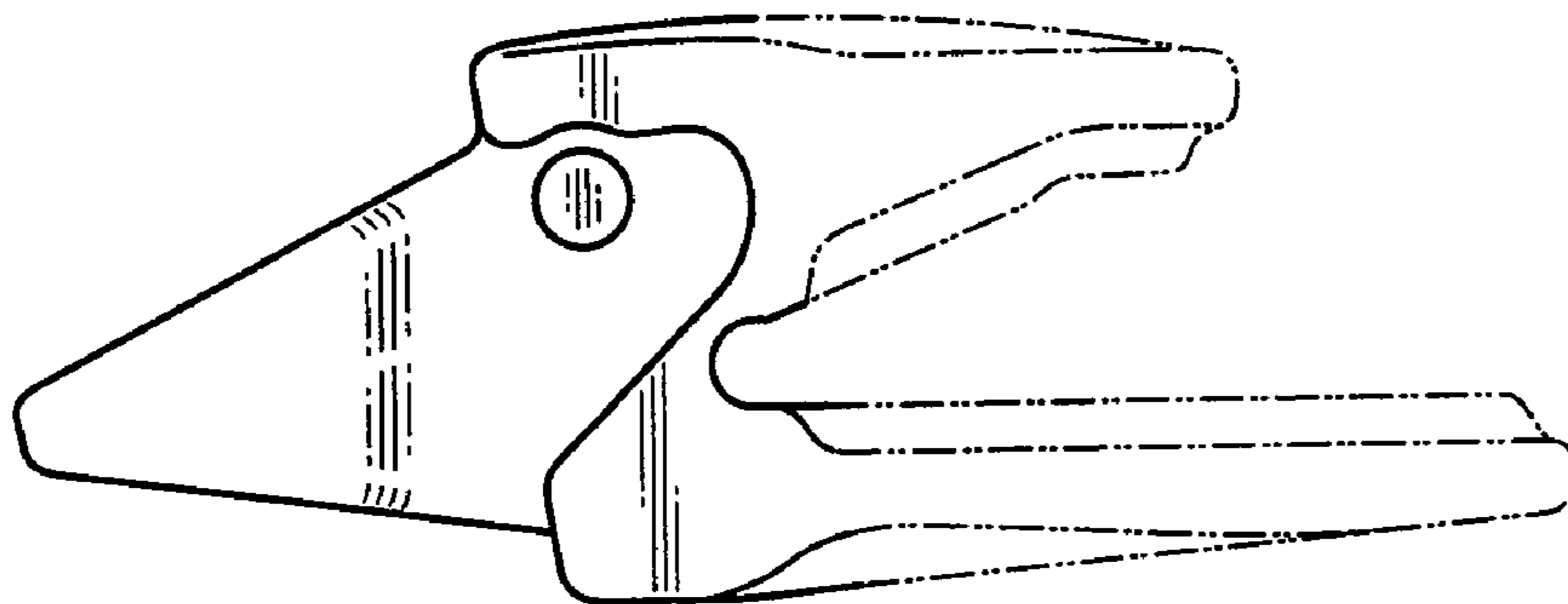

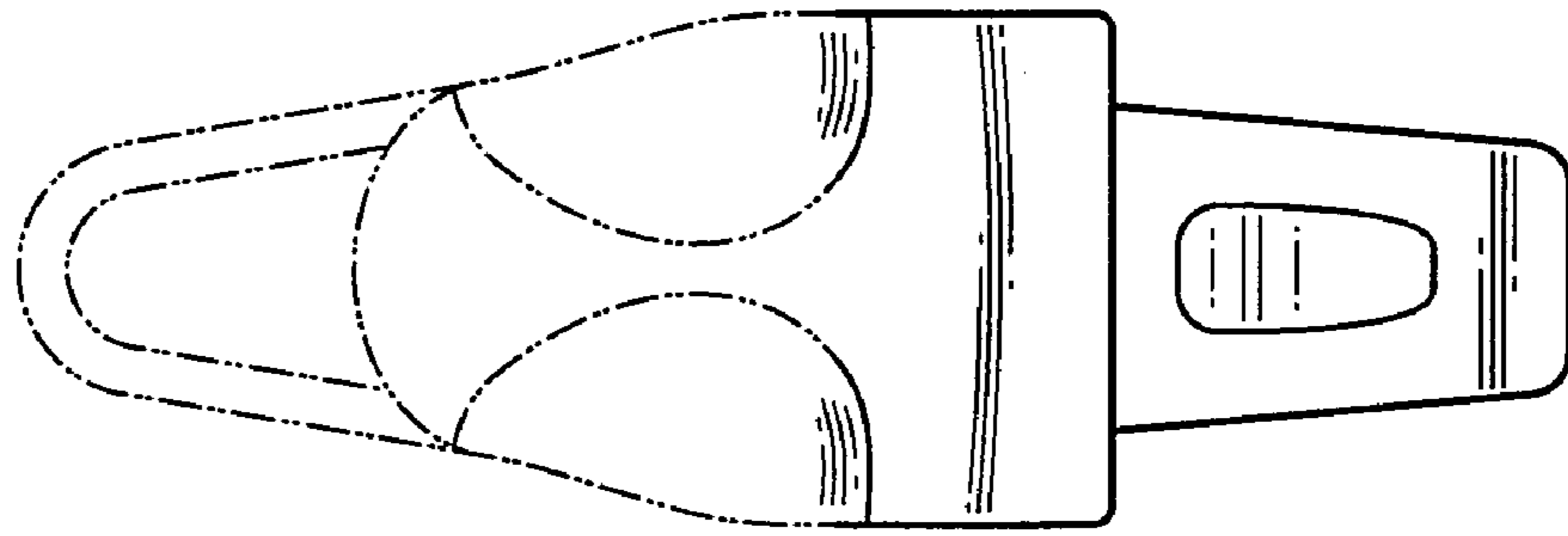

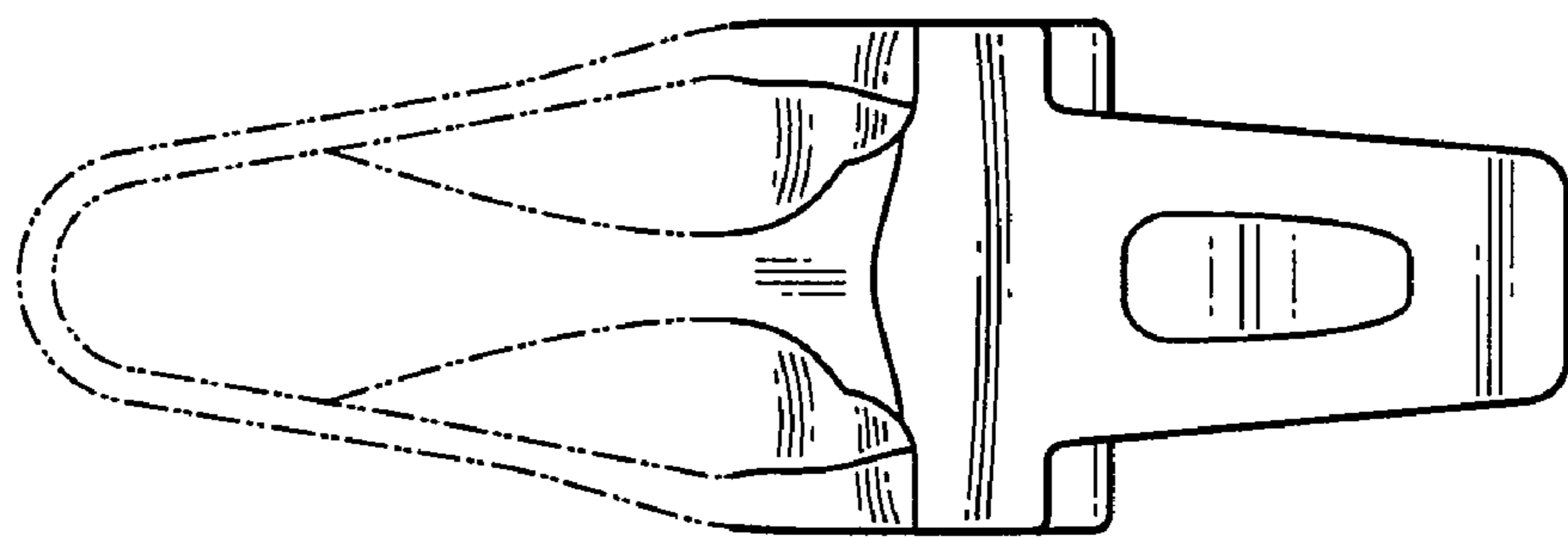

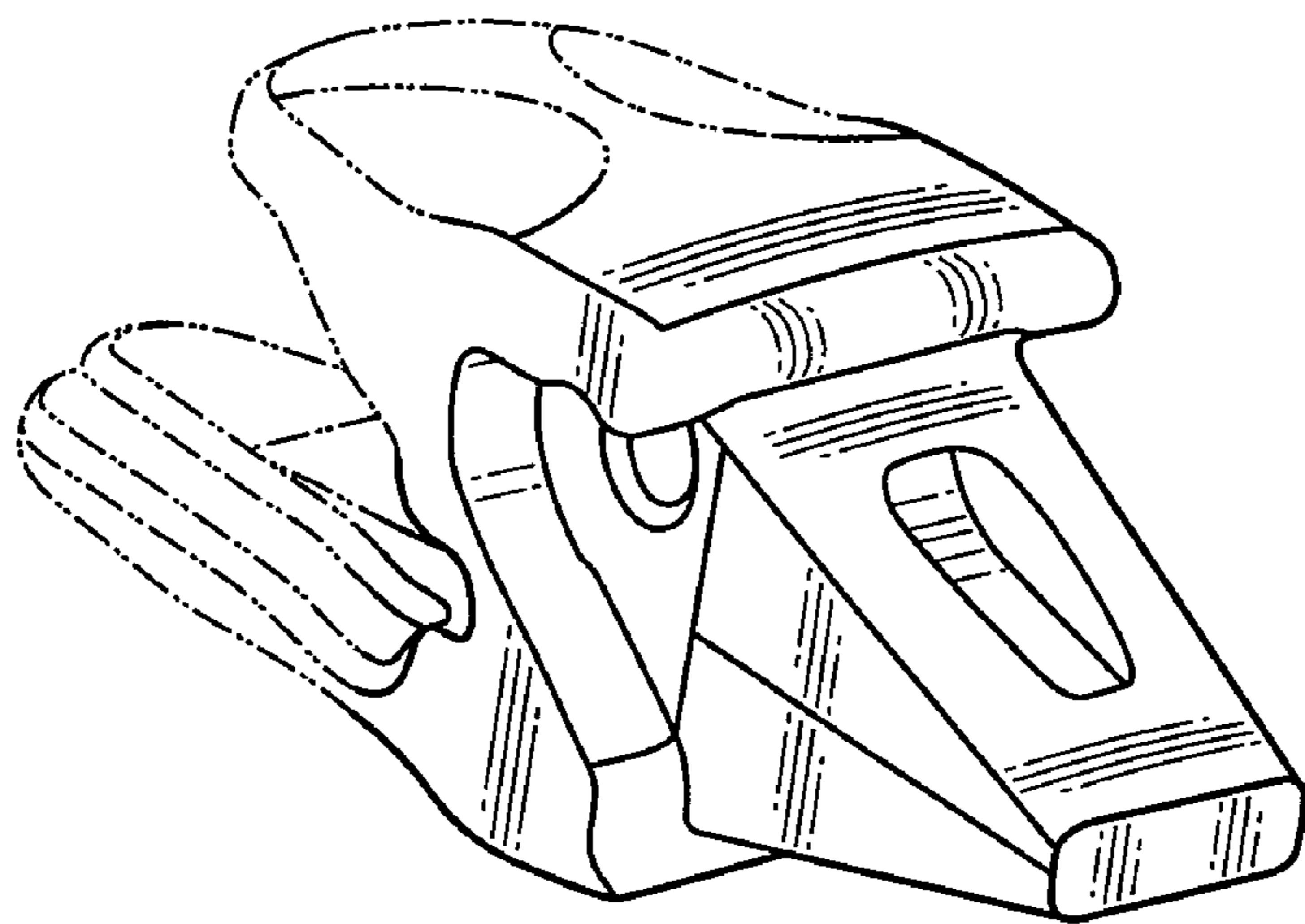
