FIG. 3 is a side view thereof.

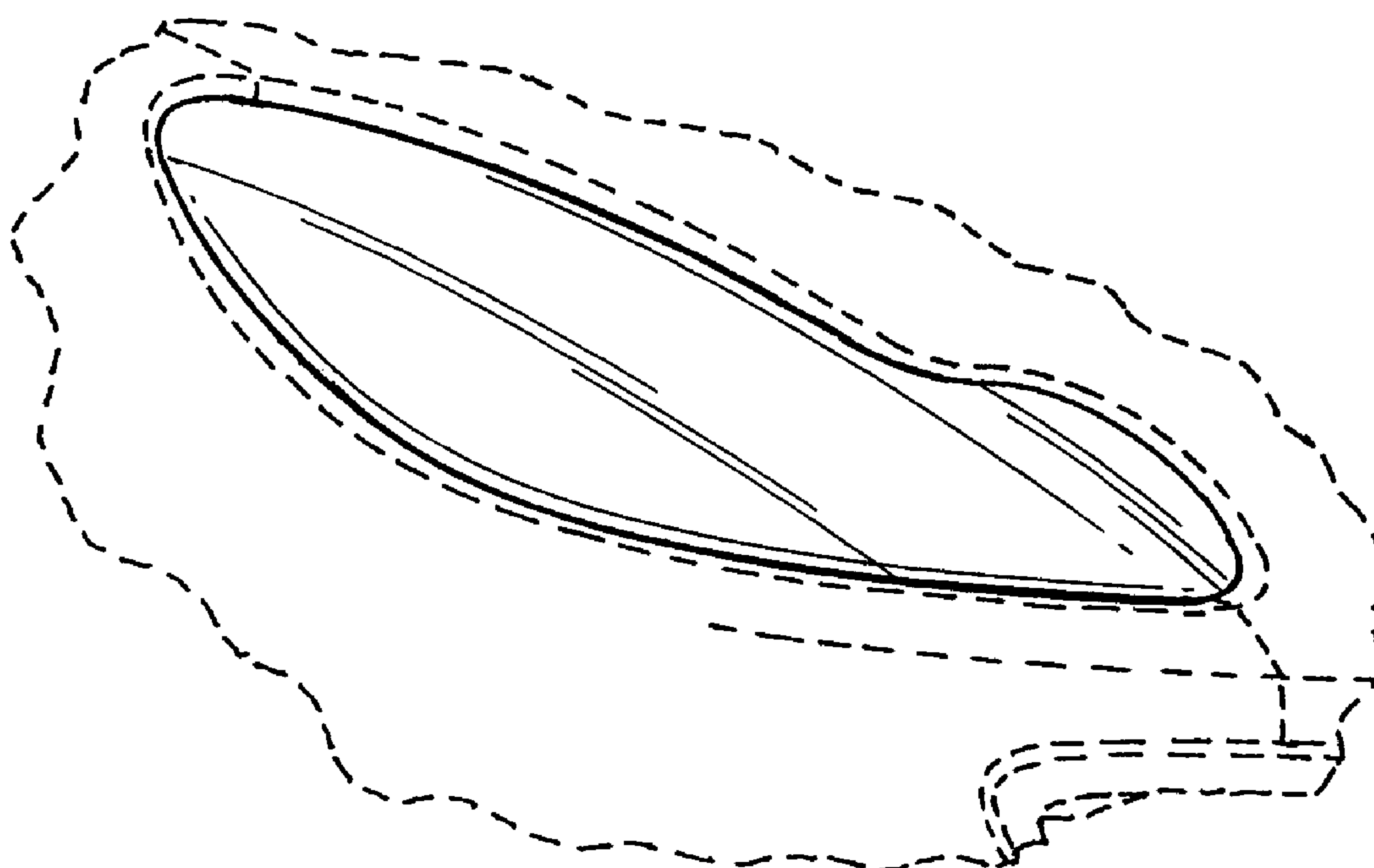
FIG. 4 is a perspective view of a second embodiment of the surface configuration of a headlight for a vehicle according to my novel design;

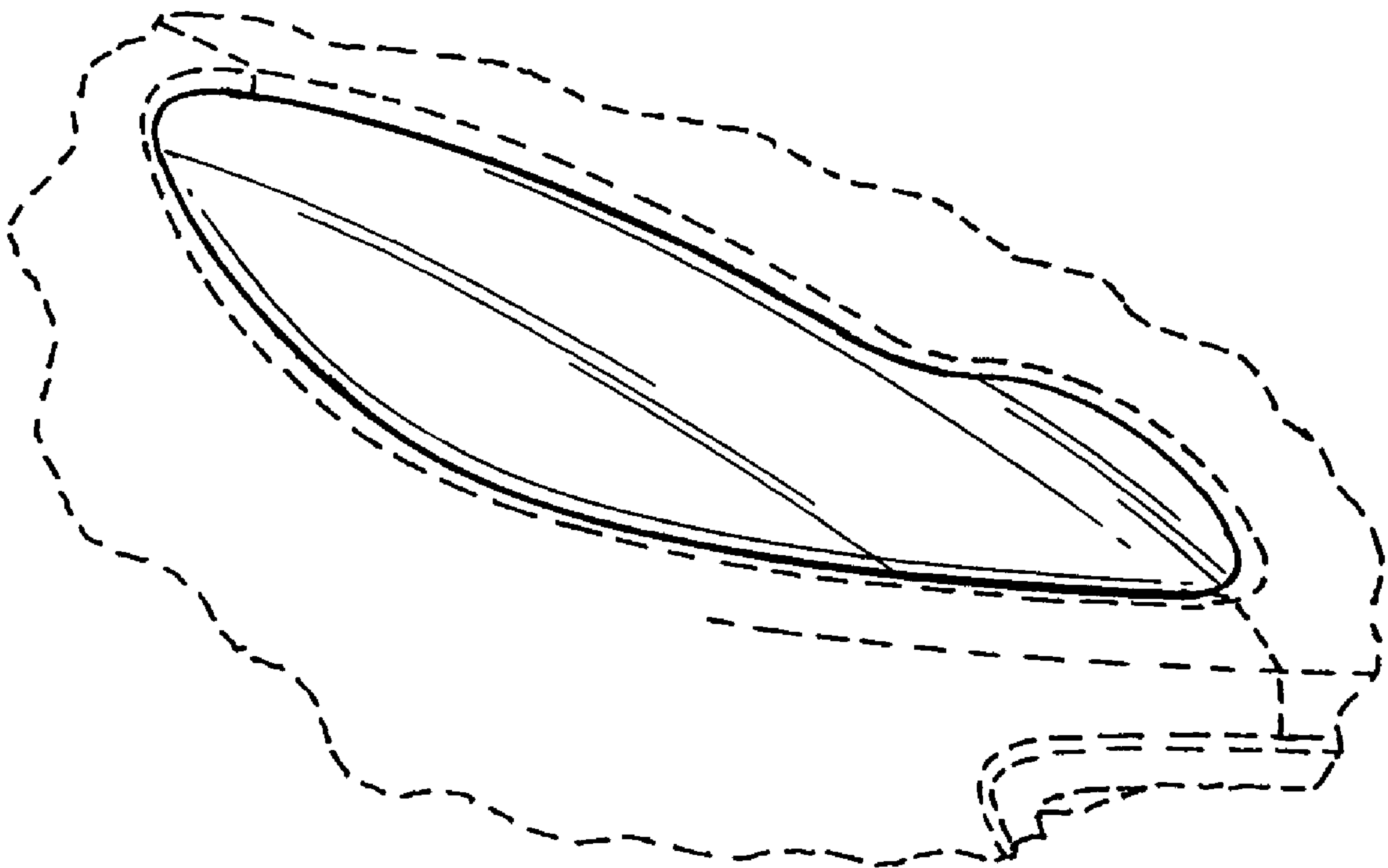

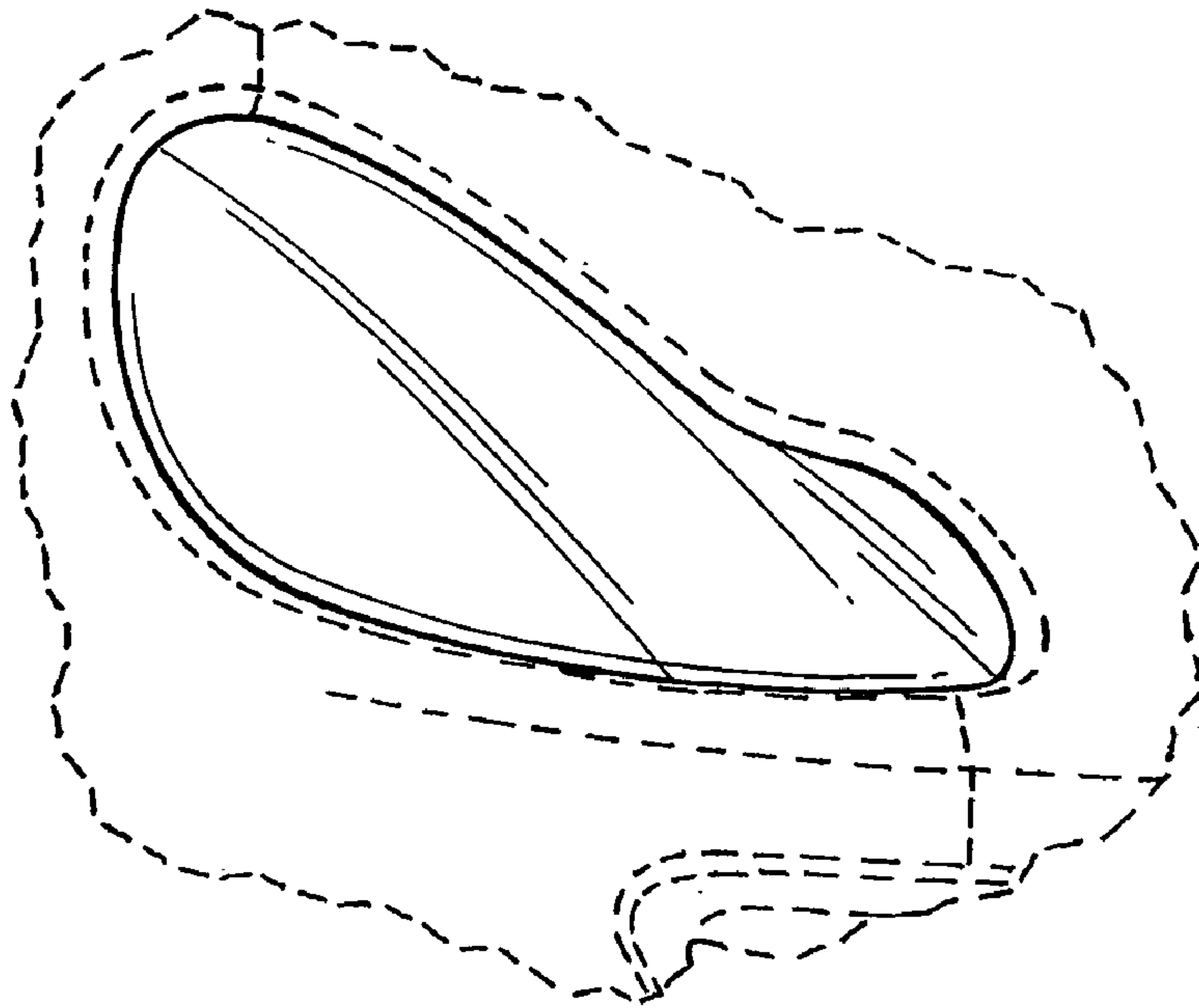

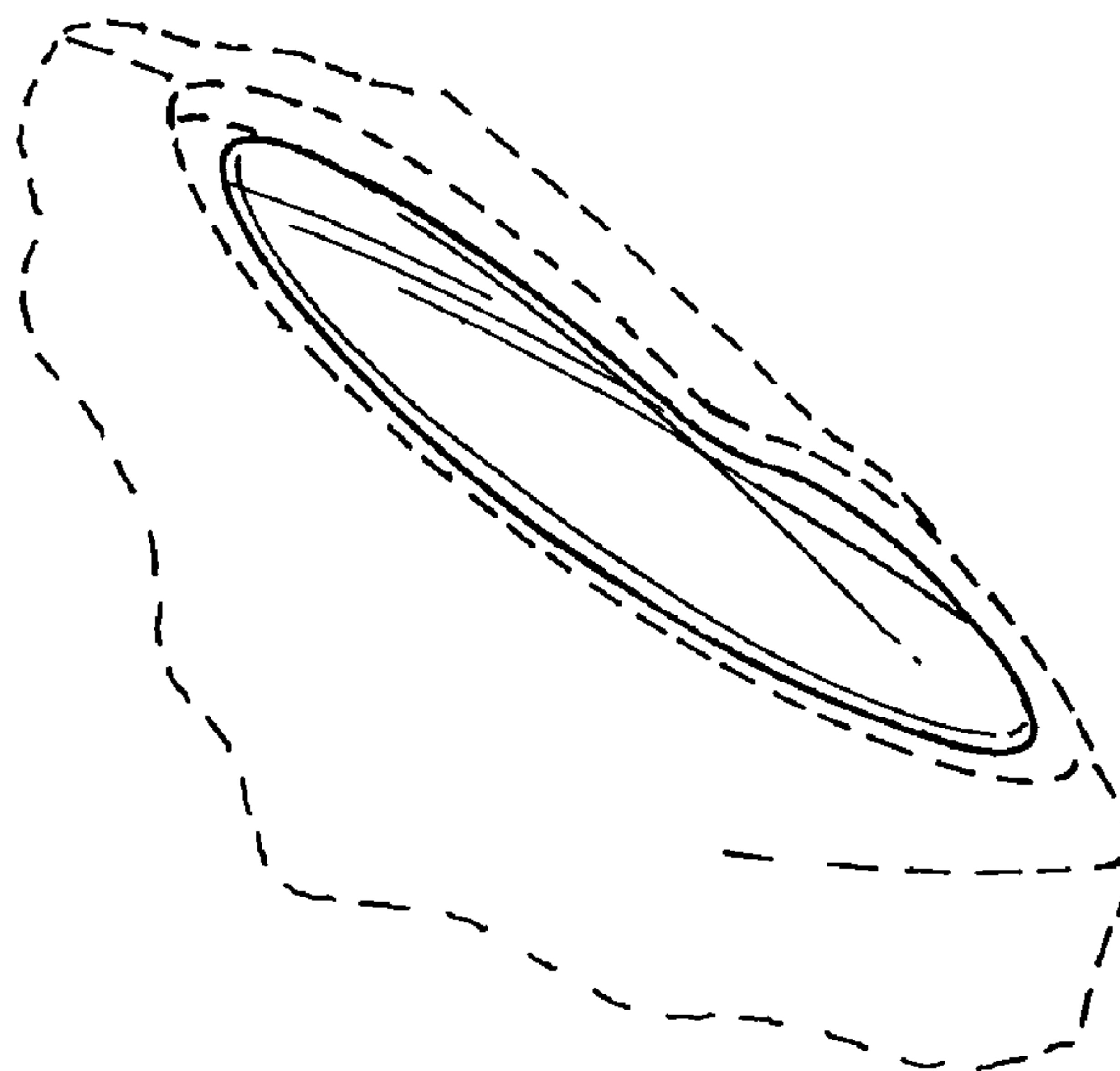

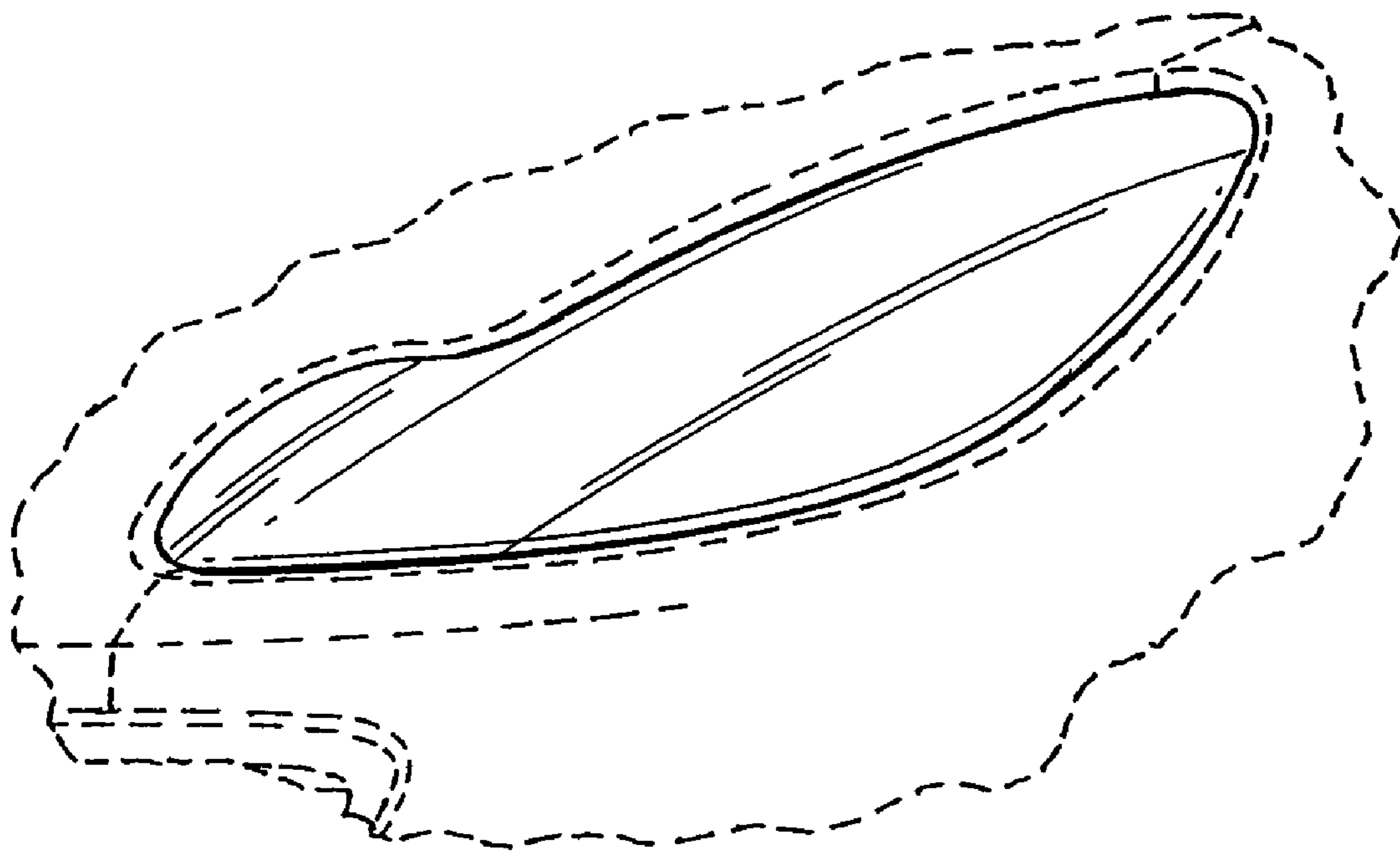

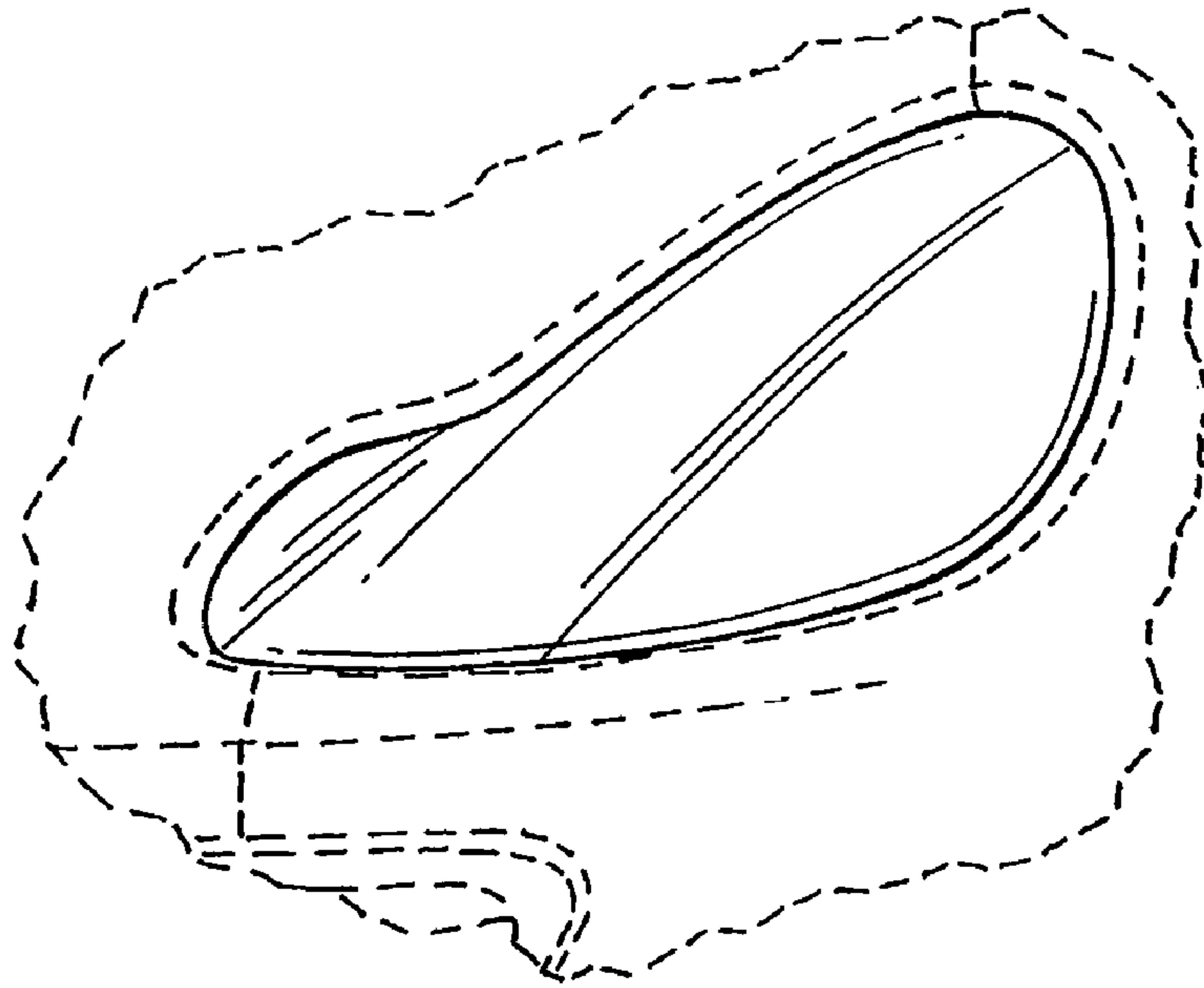

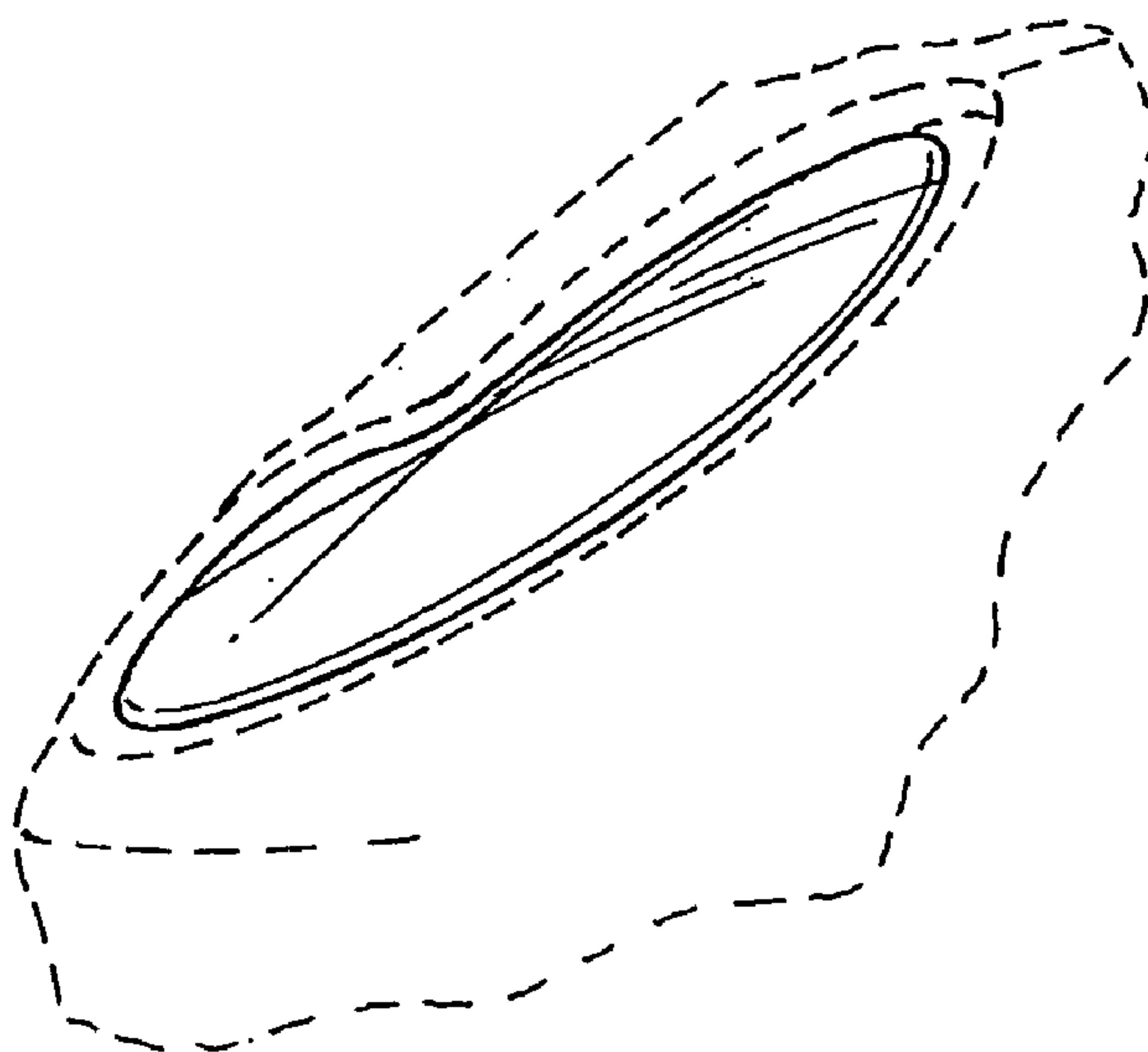
