(57) **CLAIM**

The ornamental design for a bag holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the bag holder shown assembled.

FIG. 2 is a side elevational view of the bag holder shown assembled, the opposing side being a mirror image of the side elevational view shown.

FIG. 3 is an end elevational view of the bag holder shown assembled, the opposing end being a mirror image of the end elevational view shown.

FIG. 4 is a top plan view of the bag holder shown assembled.

FIG. 5 is an exploded view of the bag holder; and,

FIG. 6 is an enlarged detailed view of the section shown in a circle in FIG. 5.

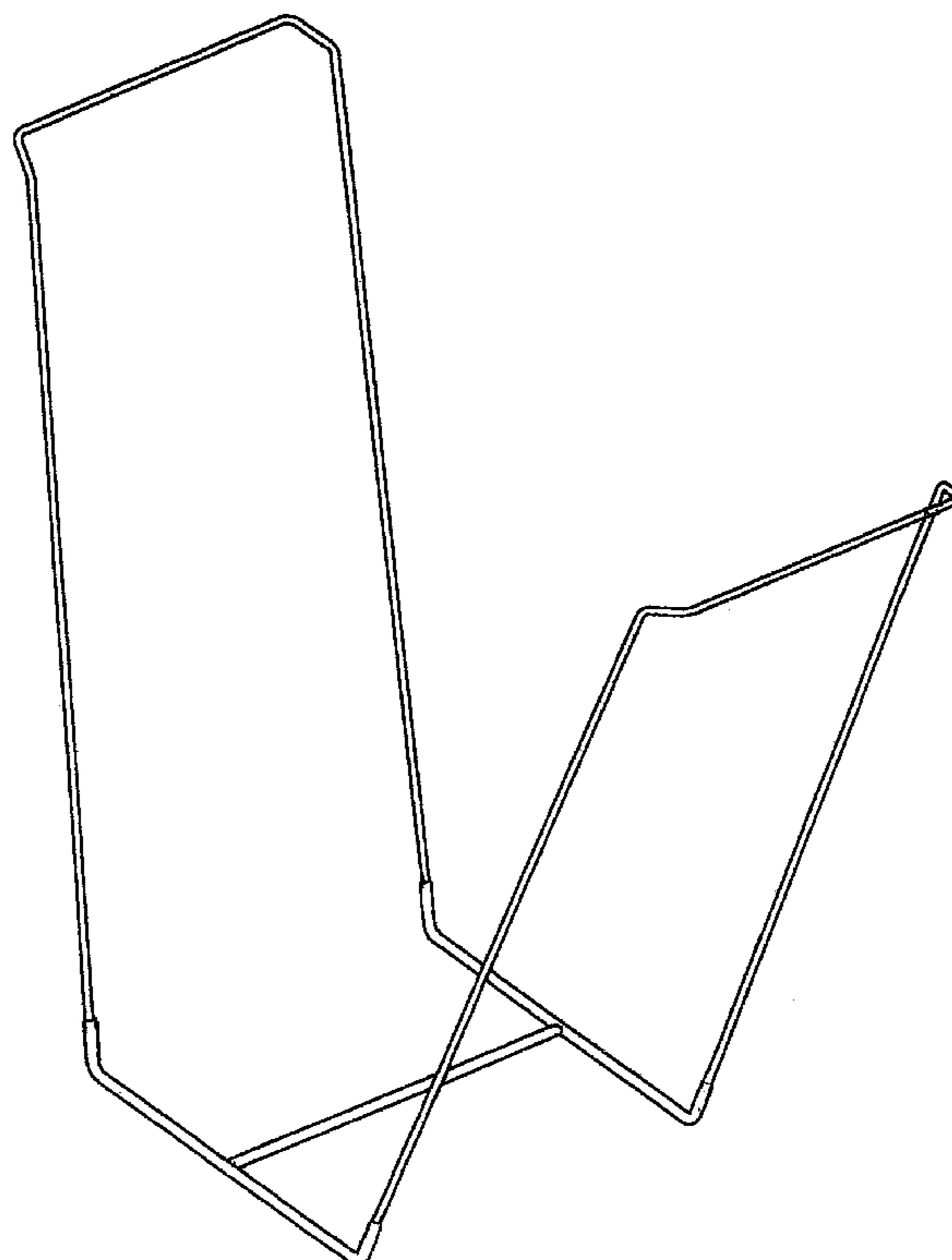

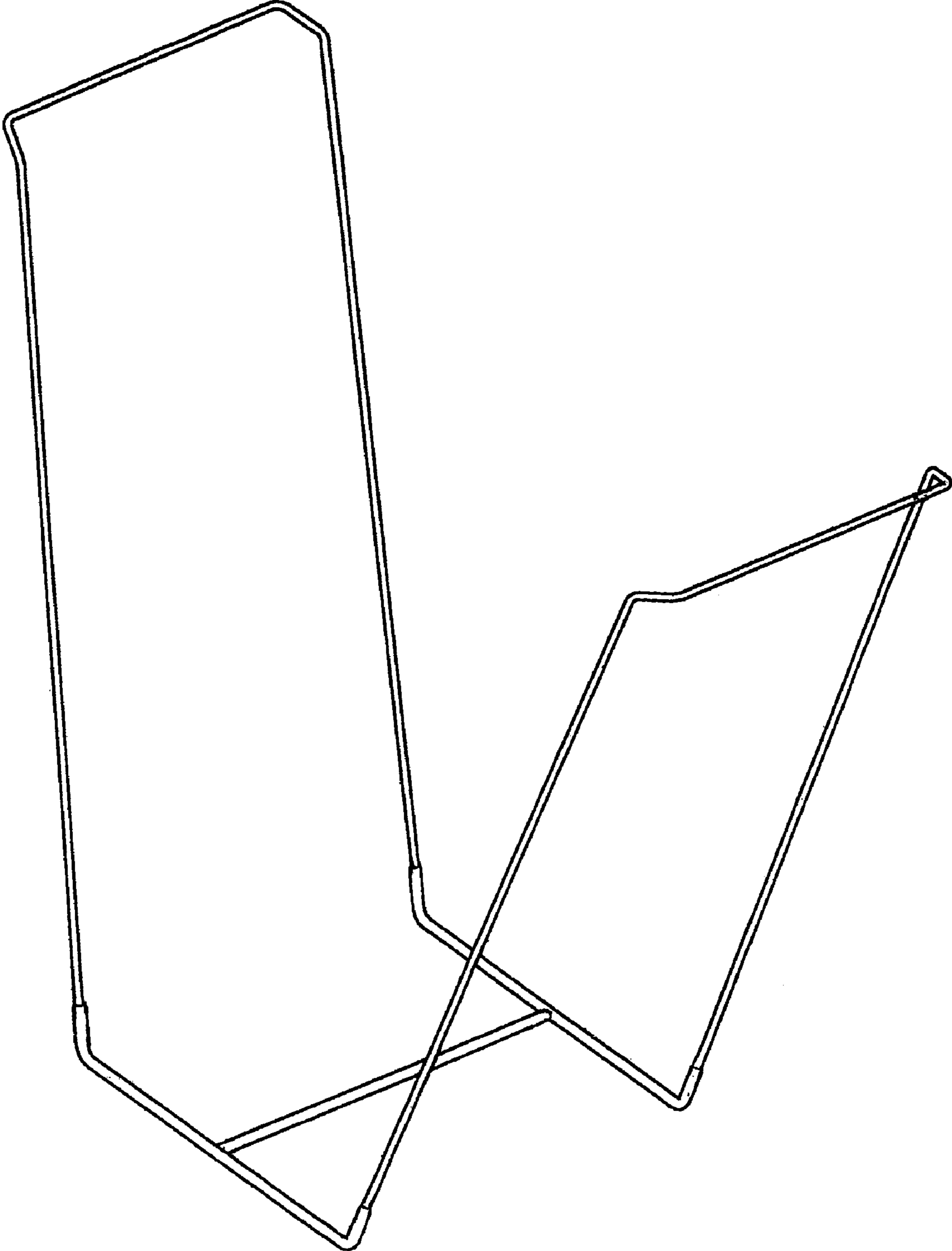

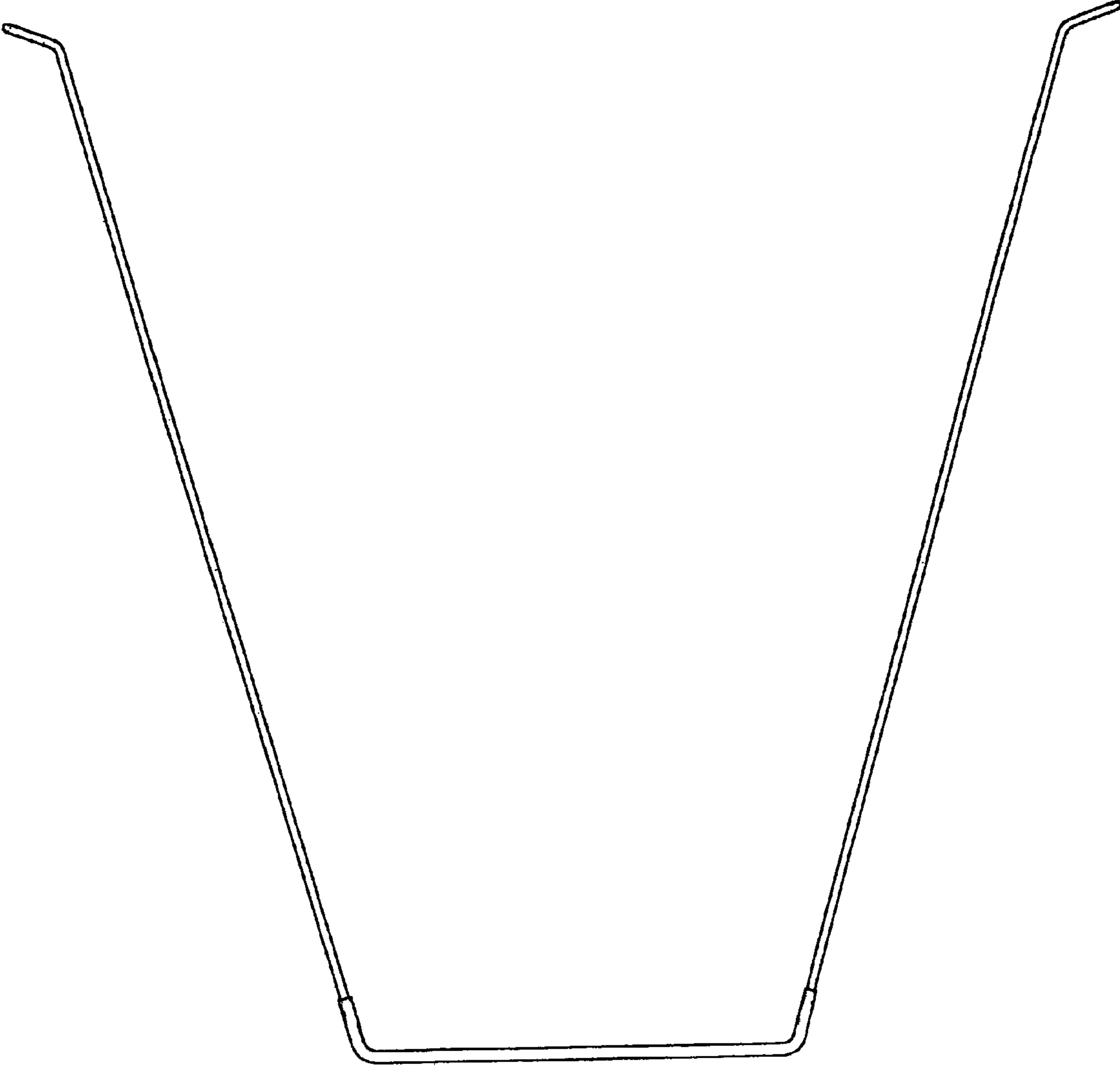
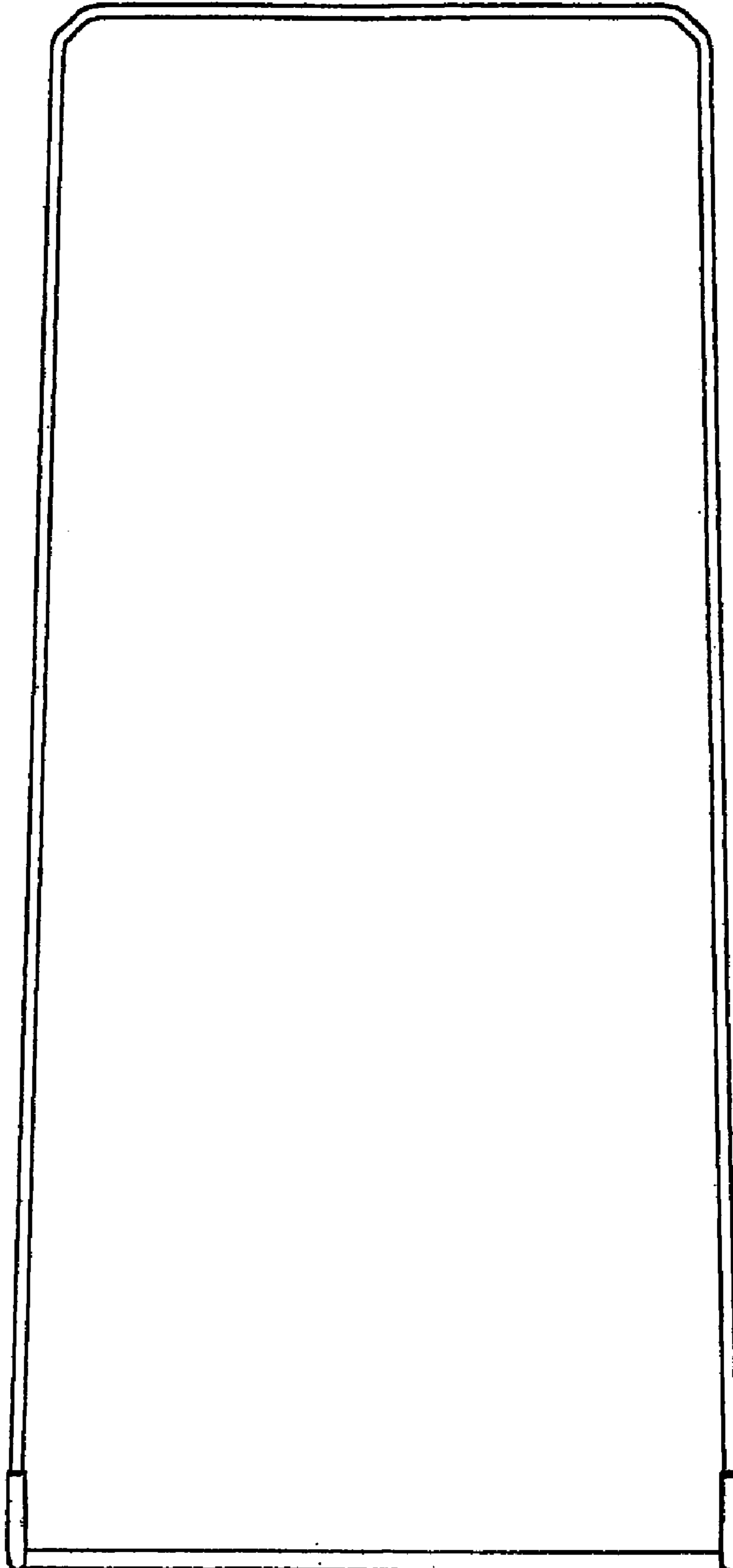

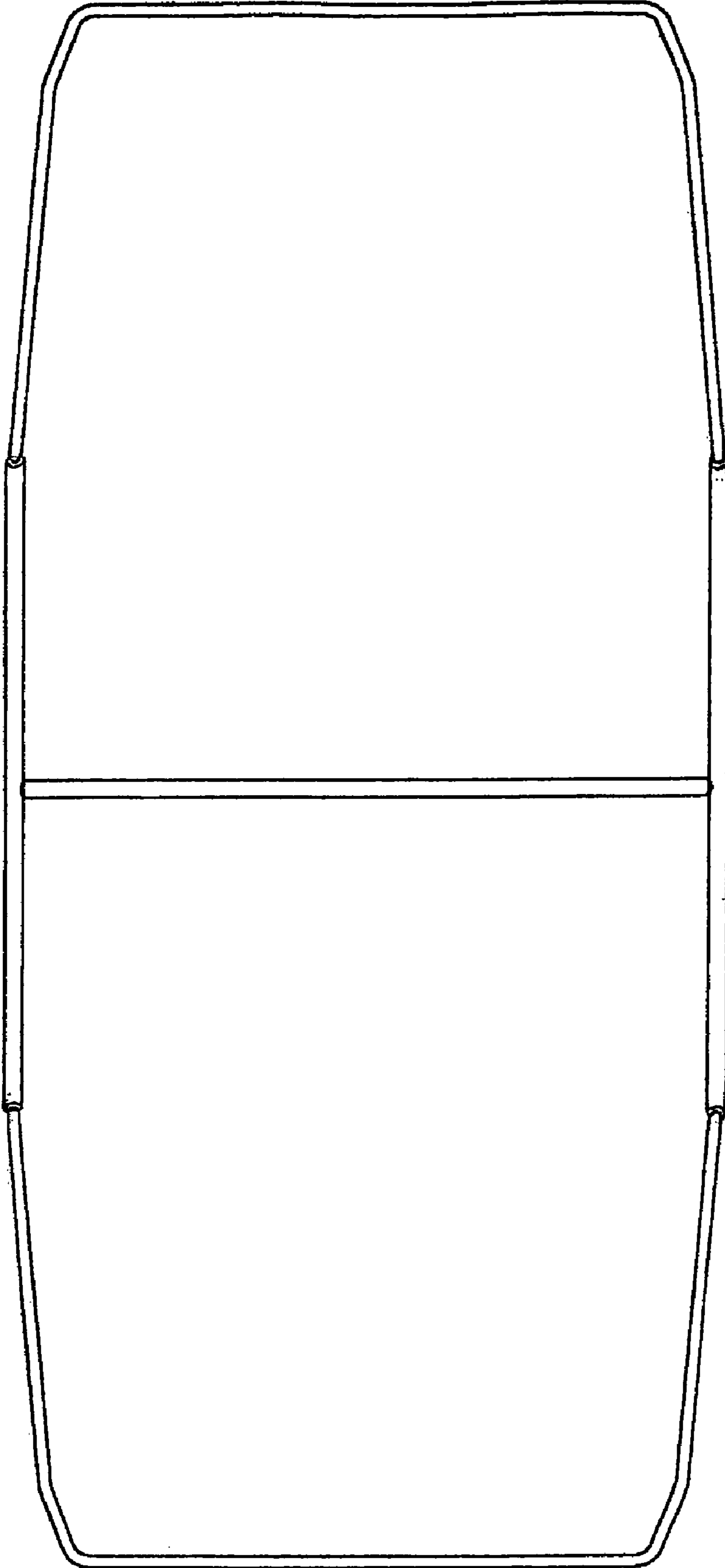
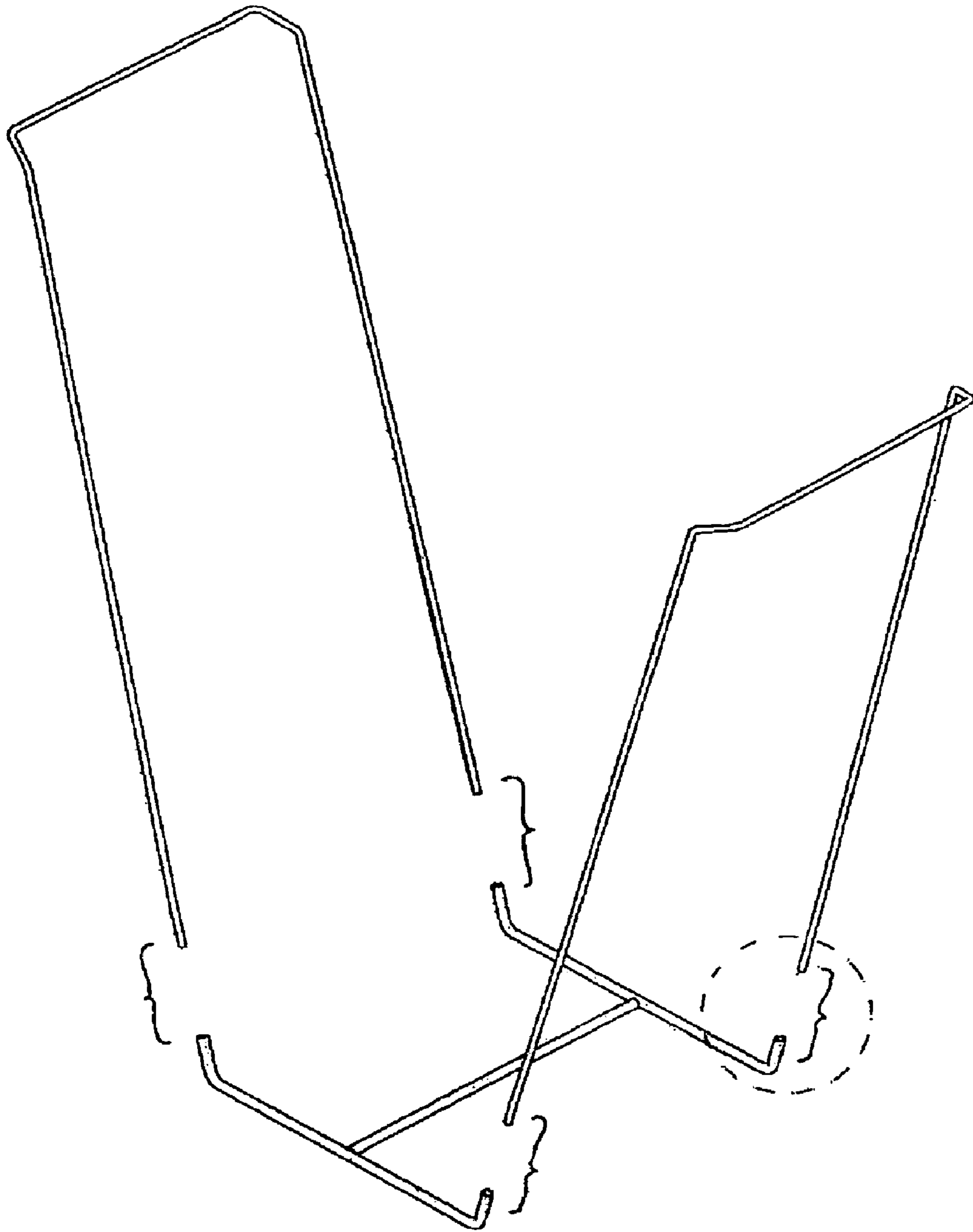
