(57) **CLAIM**

The ornamental design for a holster pouch, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a holster pouch showing my new design;

FIG. 2 is a perspective view showing the flap of the holster pouch in an open configuration thereof;

FIG. 3 is a front view of the holster pouch of FIG. 1 thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a right side view thereof, wherein the left side view is a mirror image of the right side view;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a front view showing the flap of the holster pouch in an open configuration thereof;

FIG. 9 is a rear view showing the flap of the holster pouch in an open configuration thereof;

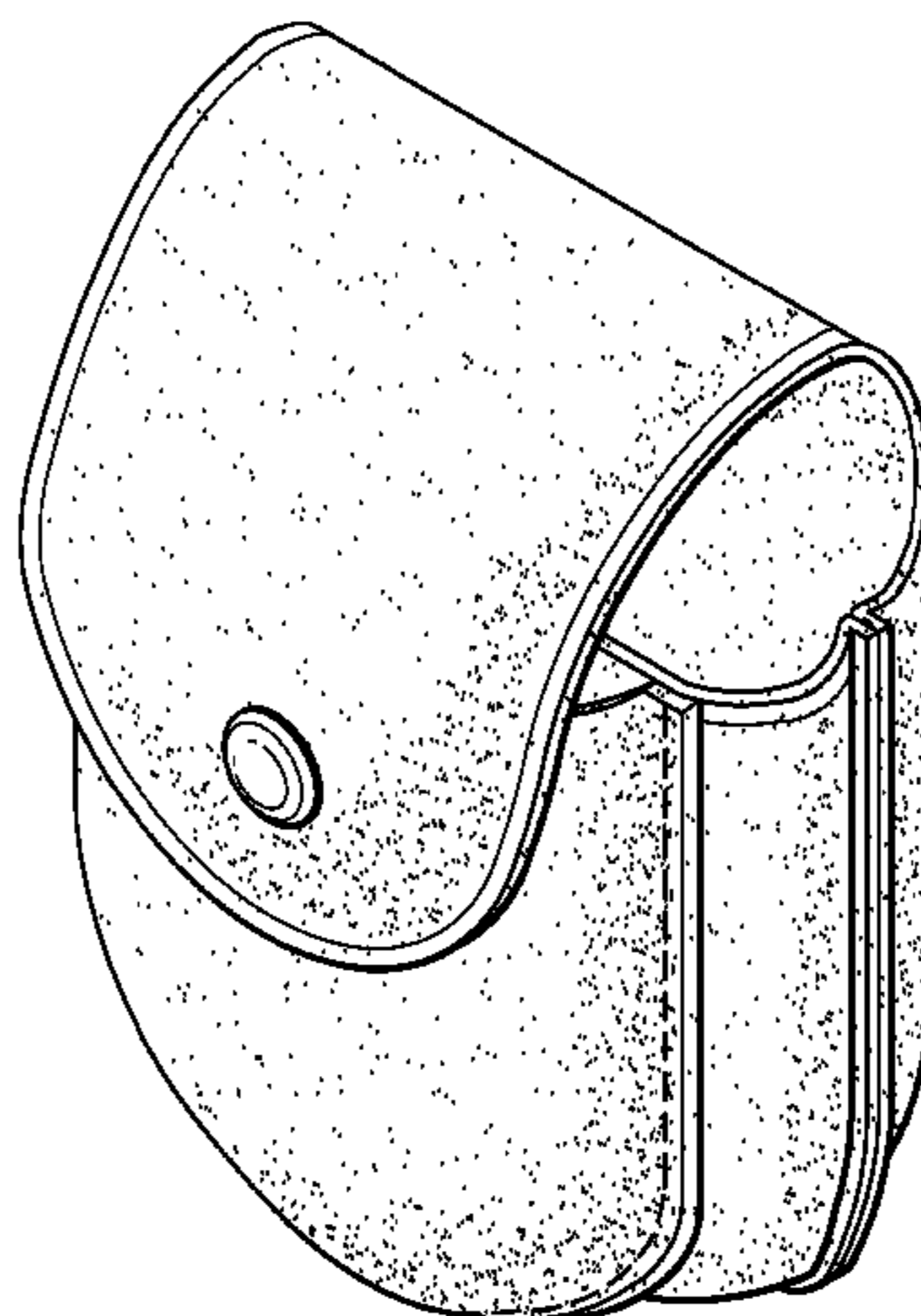
FIG. 10 is a right side view showing the flap of the holster pouch in an open configuration thereof, wherein the left side view is a mirror image of the right side view;

FIG. 11 is a top plan view of the invention with the flap of the holster pouch in an open configuration; and,

FIG. 12 is a environmental perspective view of the invention thereof.

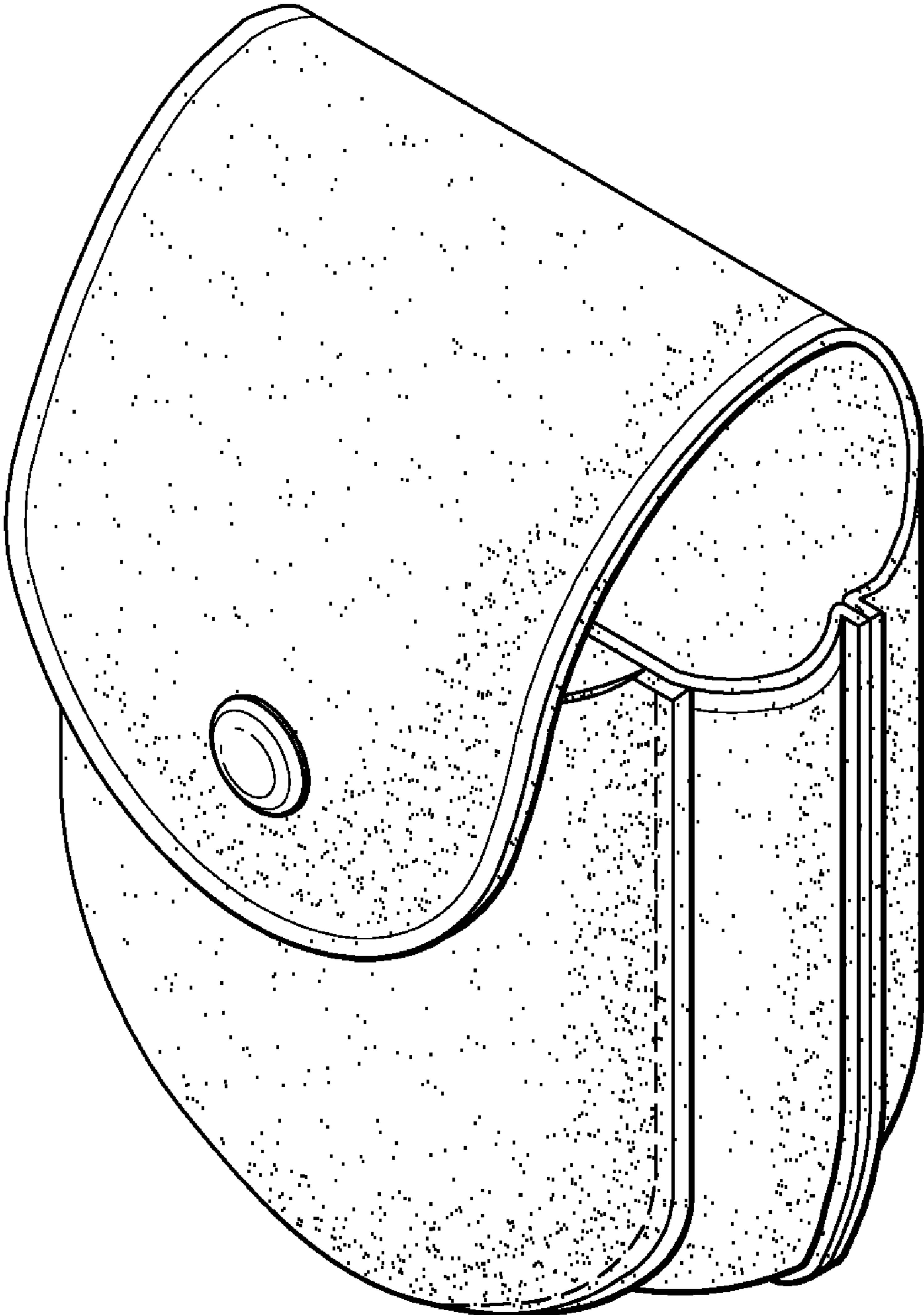

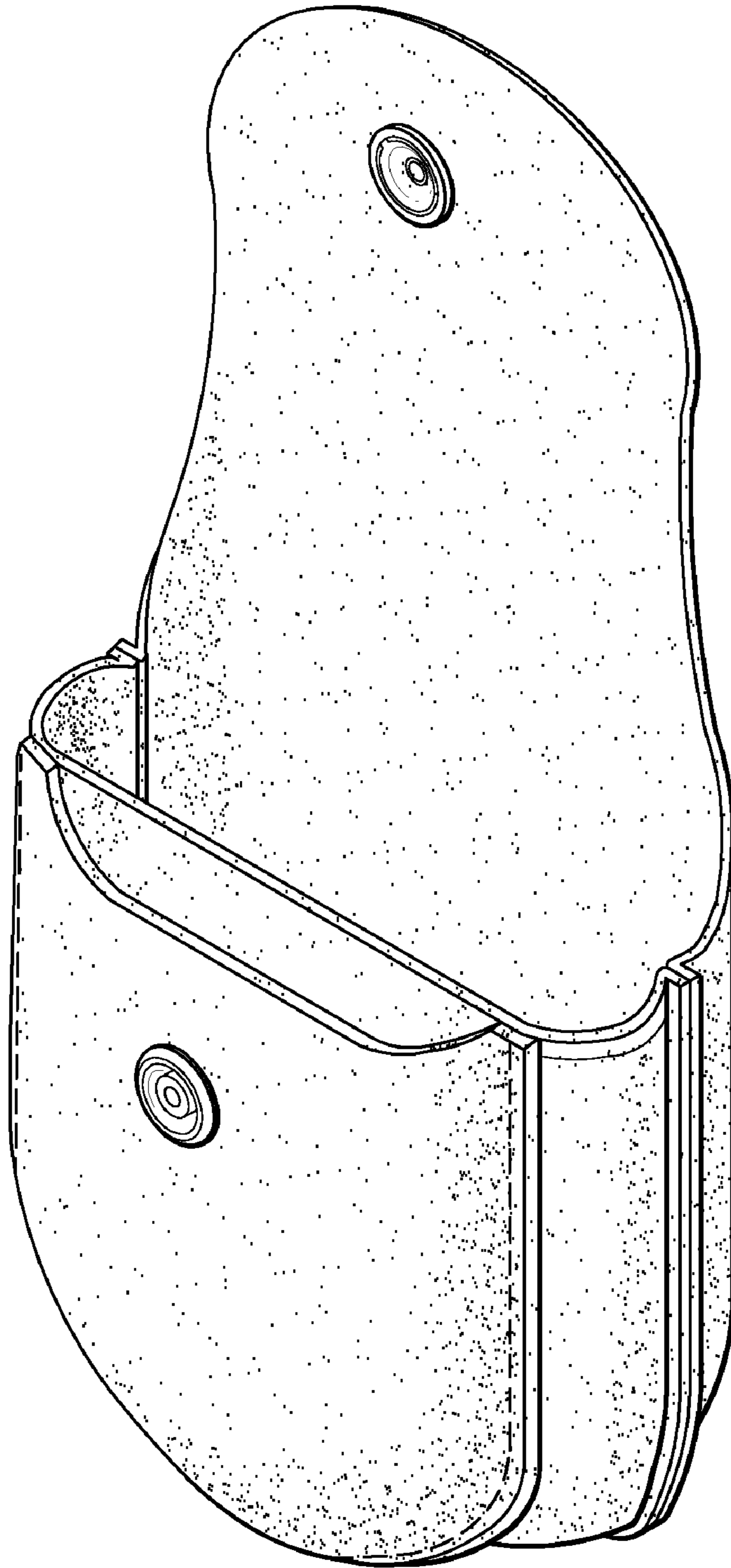

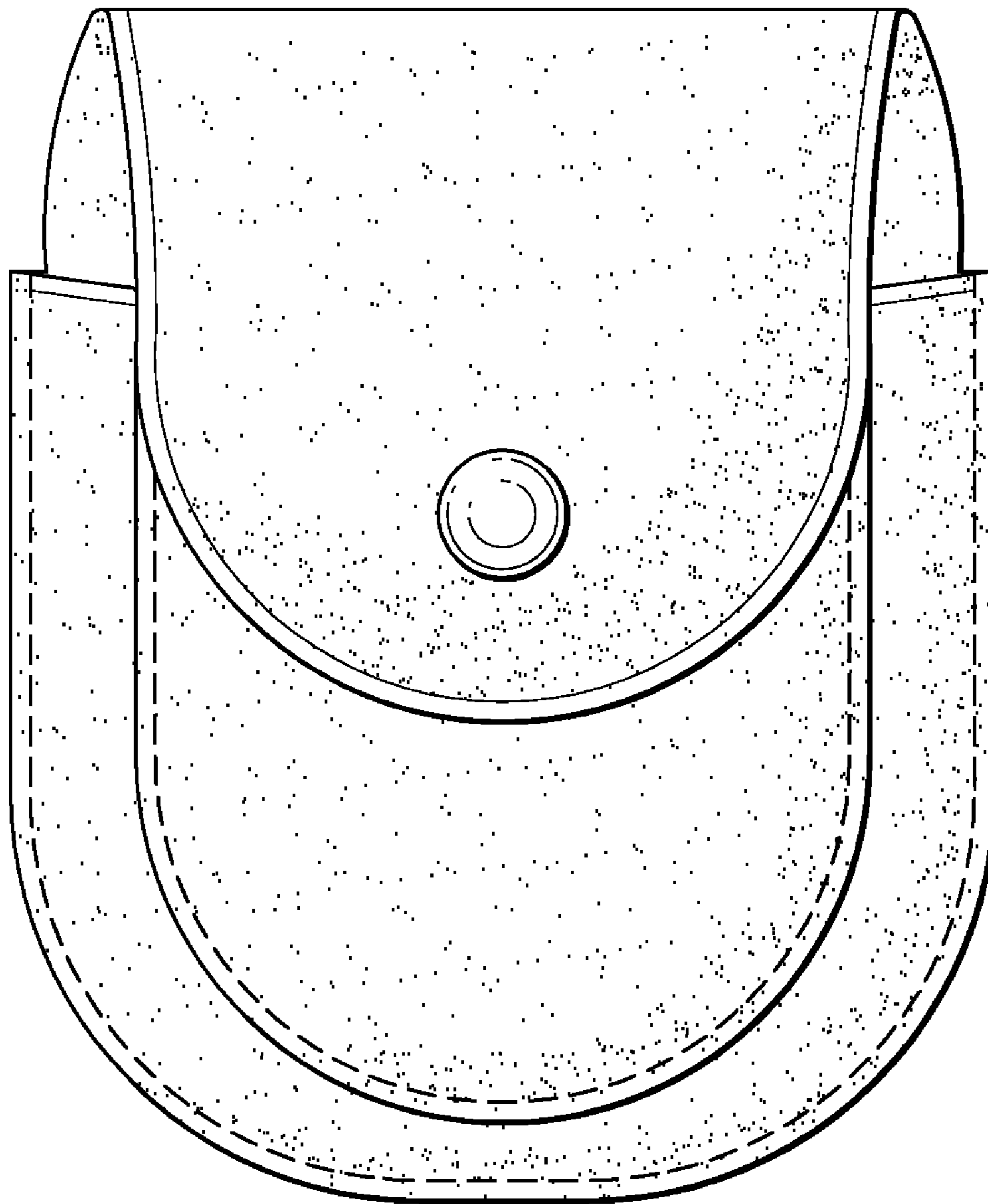

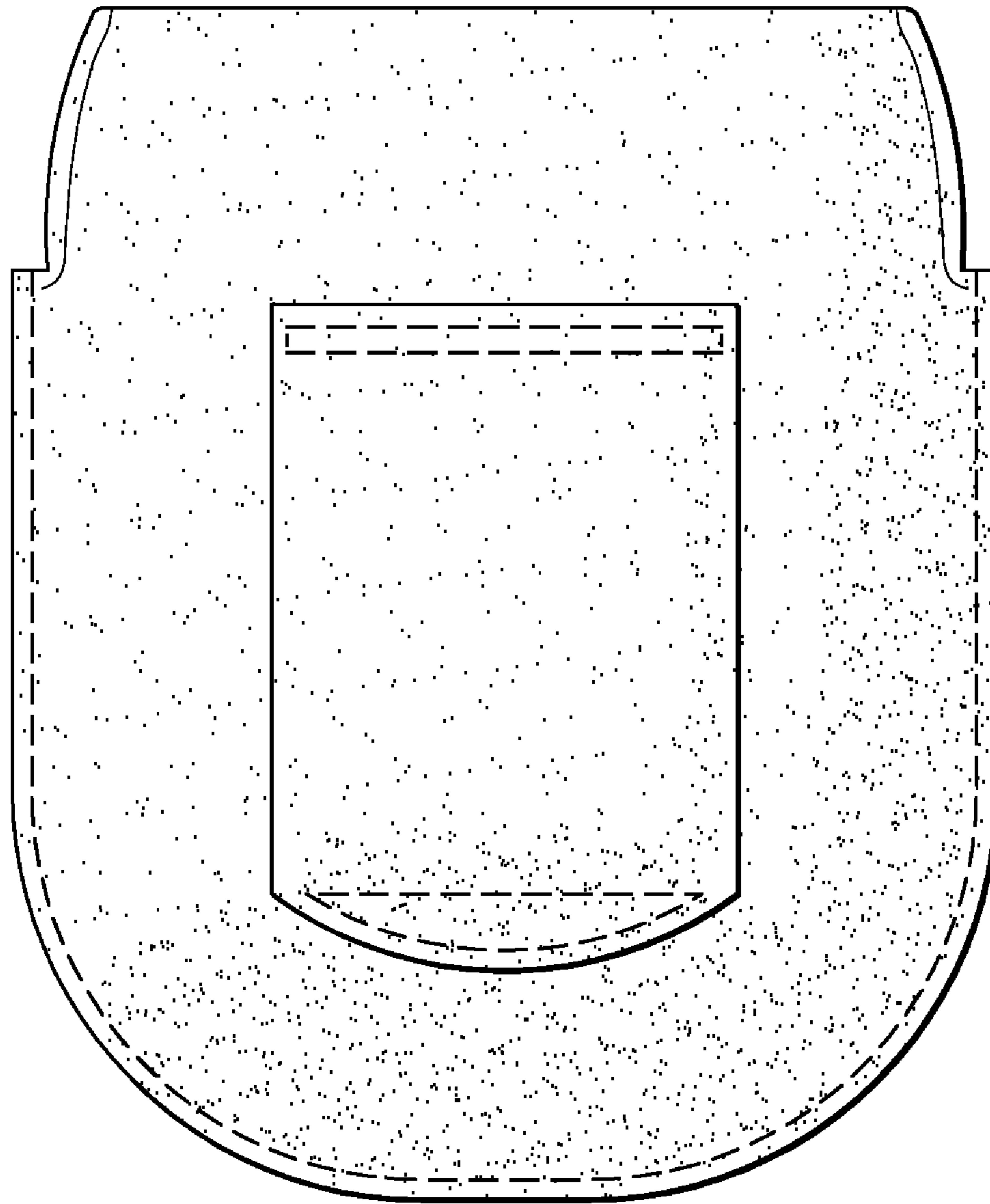

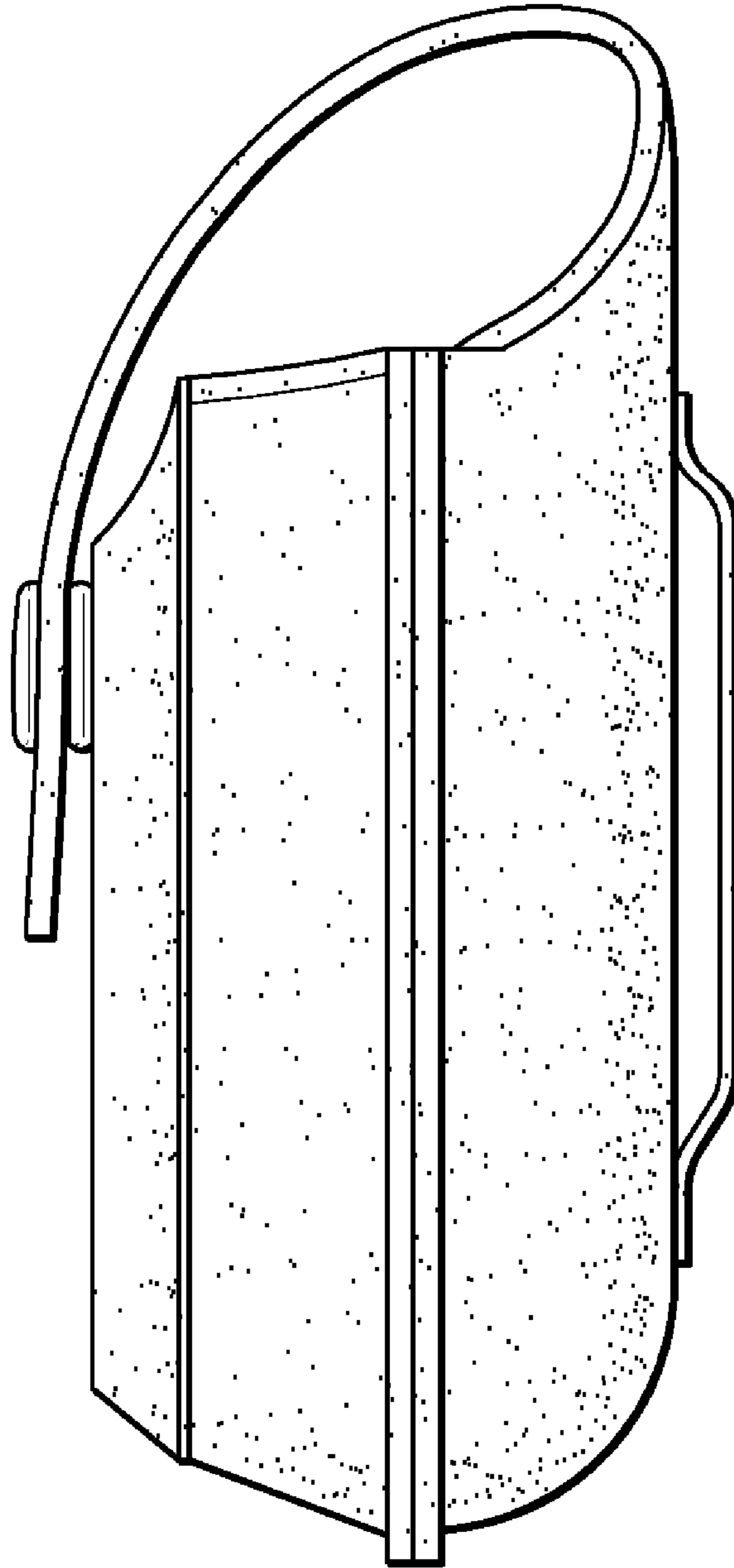

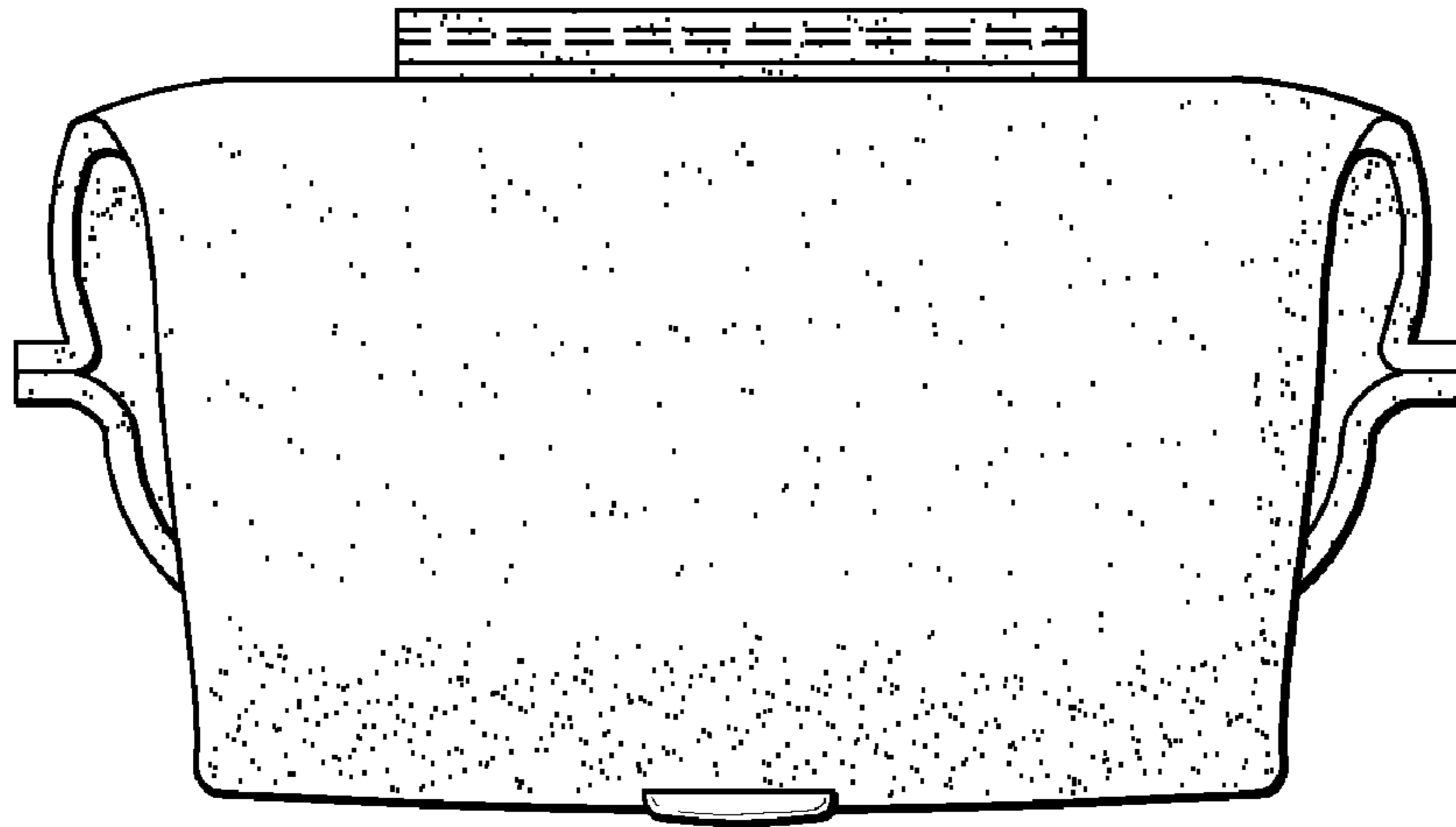

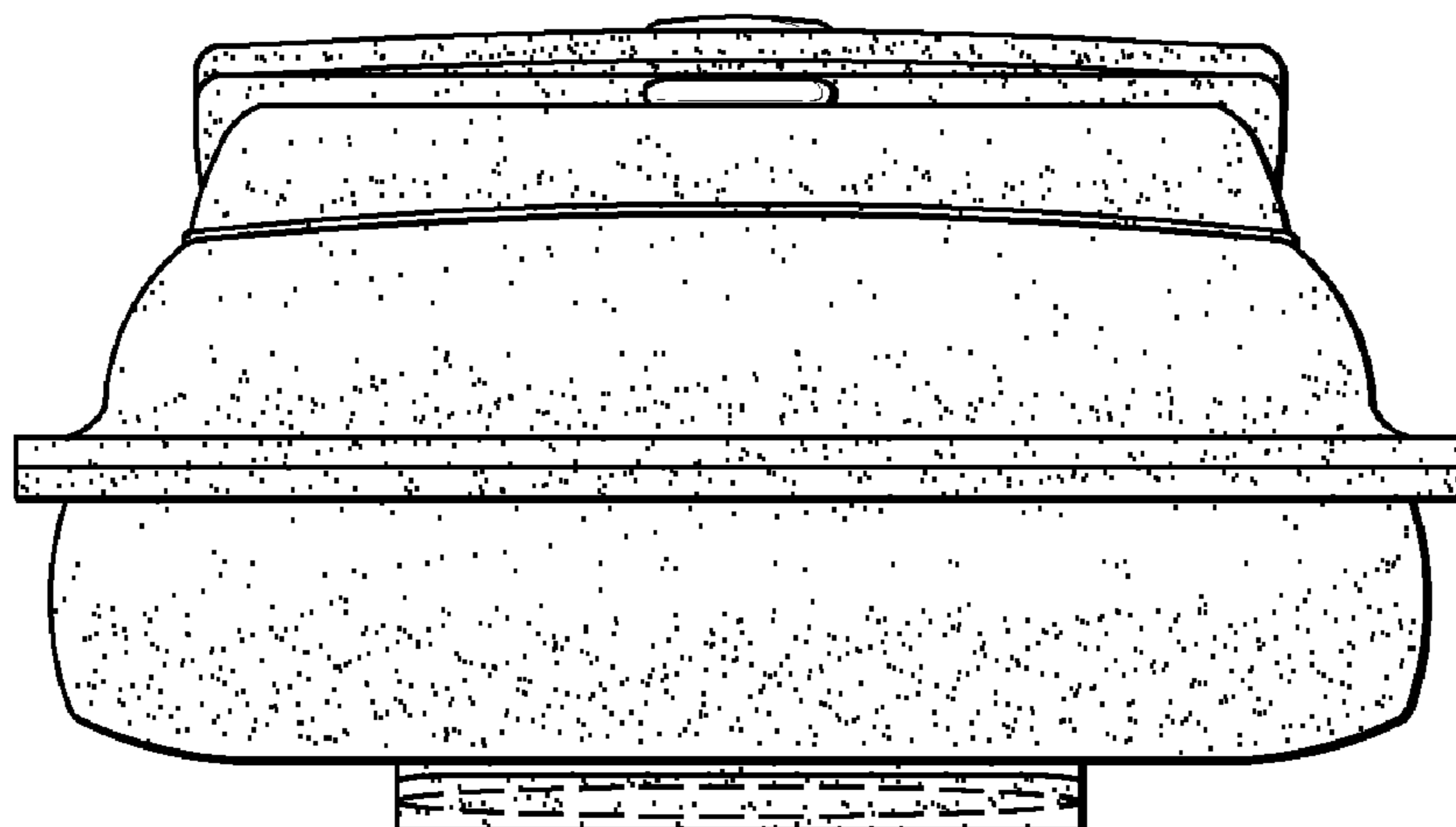

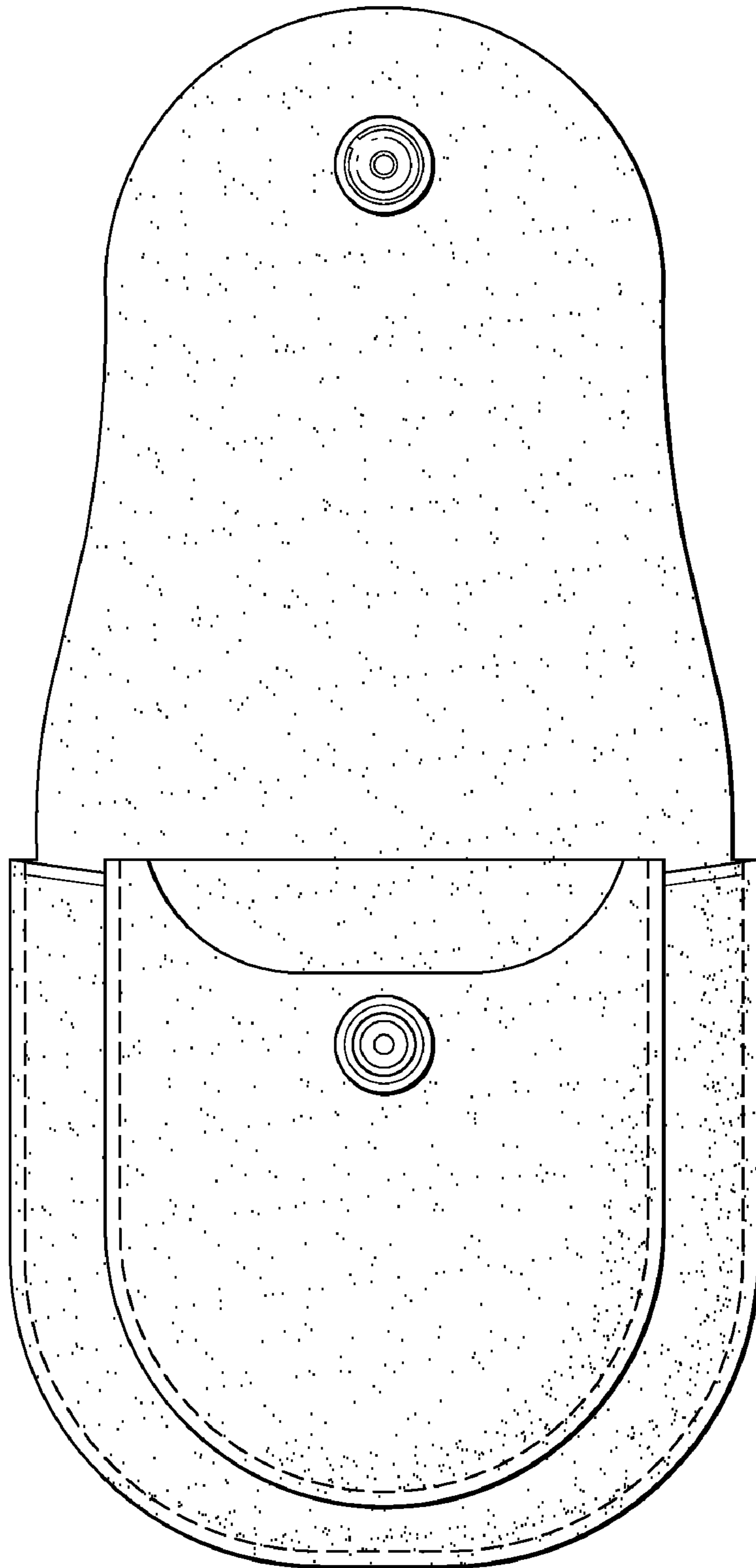

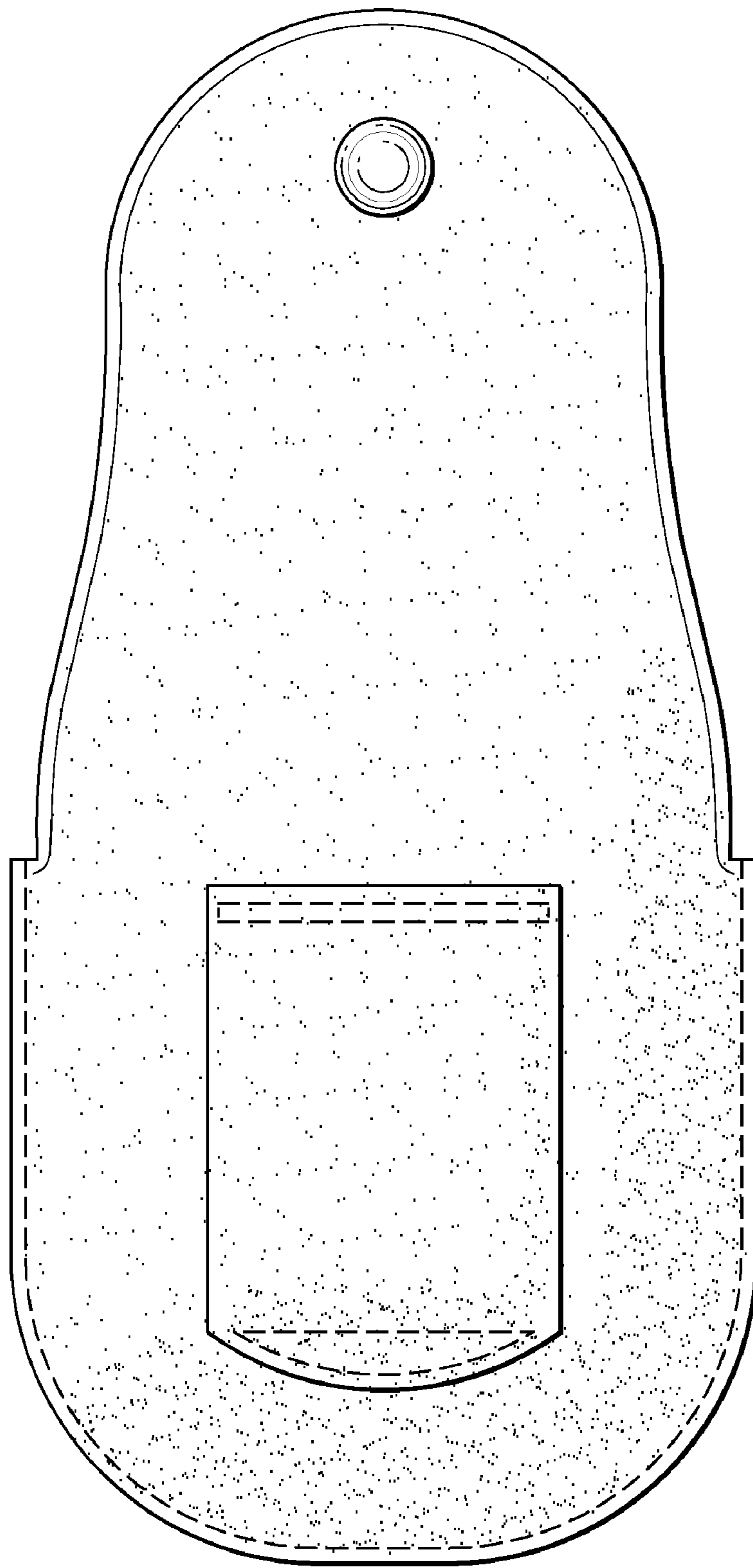

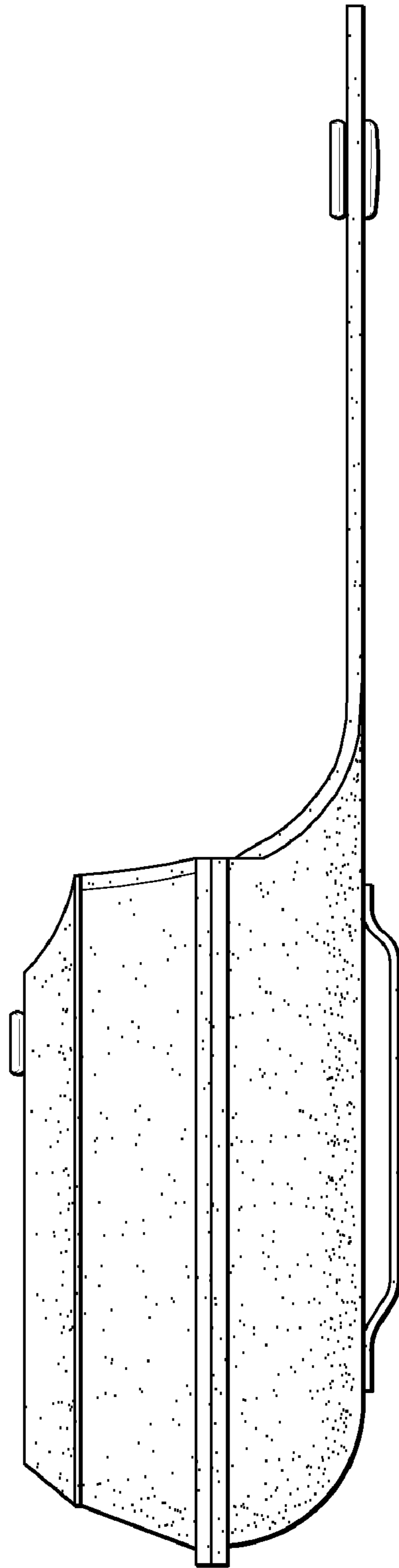

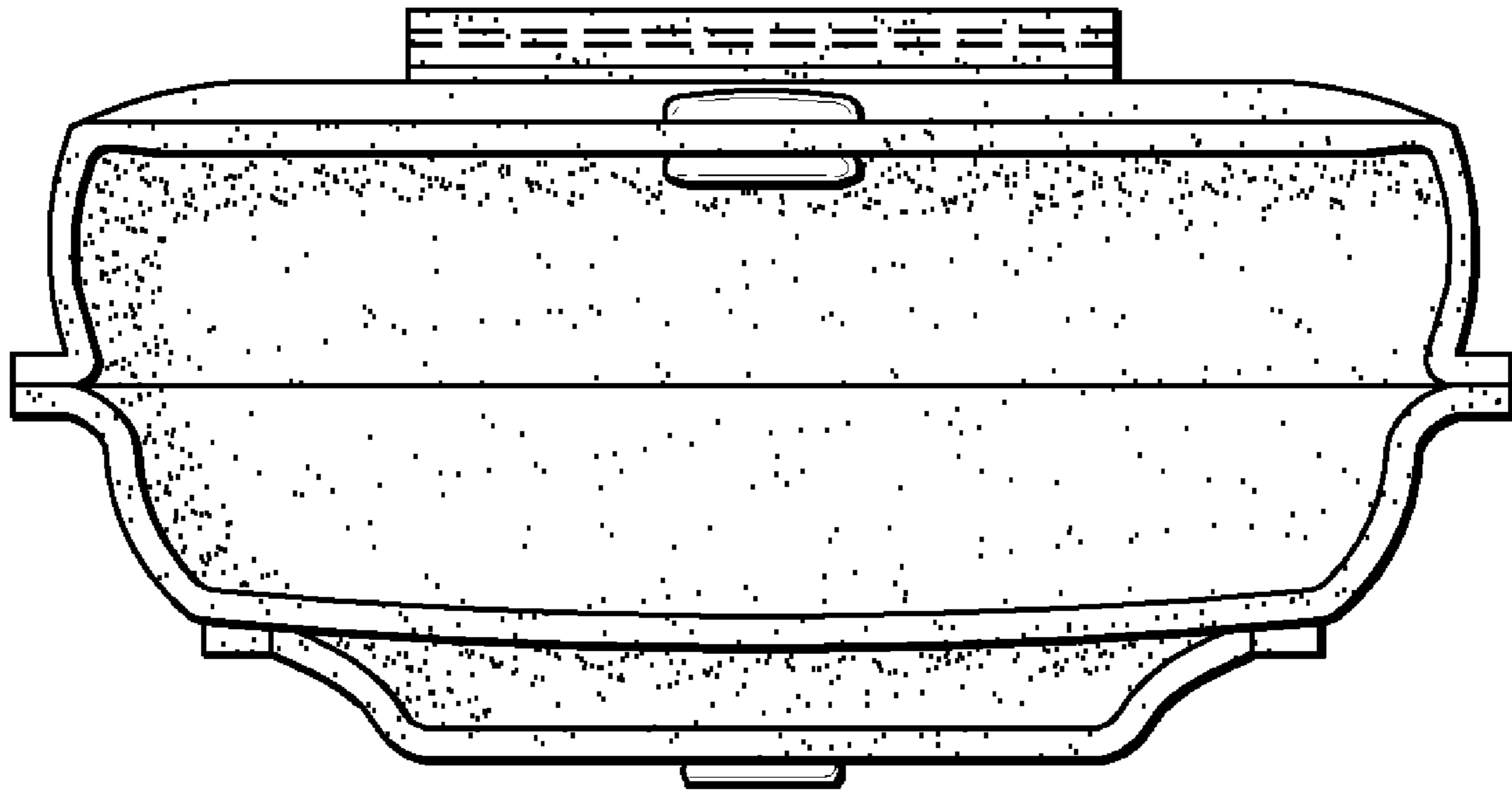

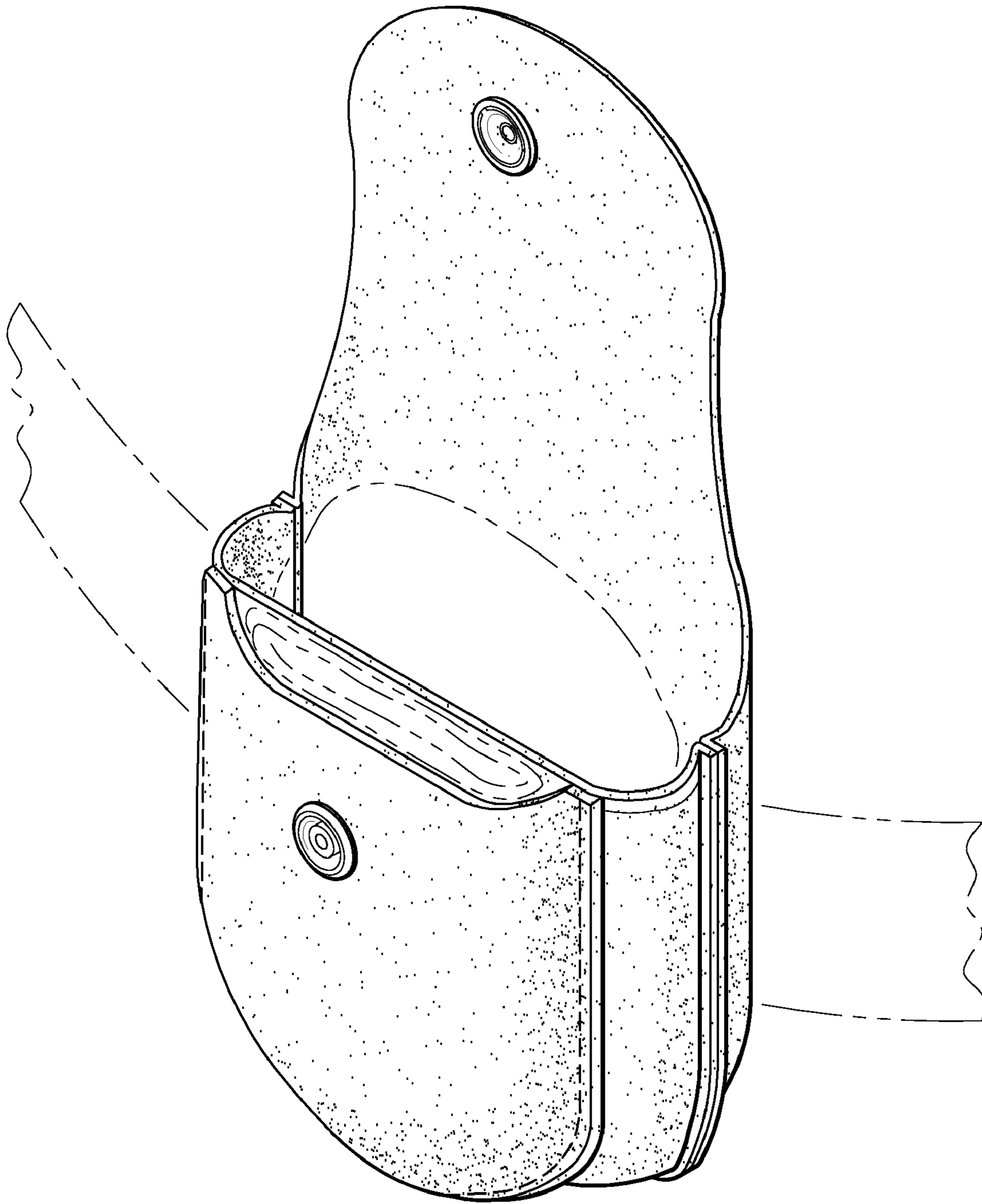
