FIG. 6 is a perspective view embodying the utilization of the rack in which the broken line is for illustrative purposes only and forms no part of the claimed design;

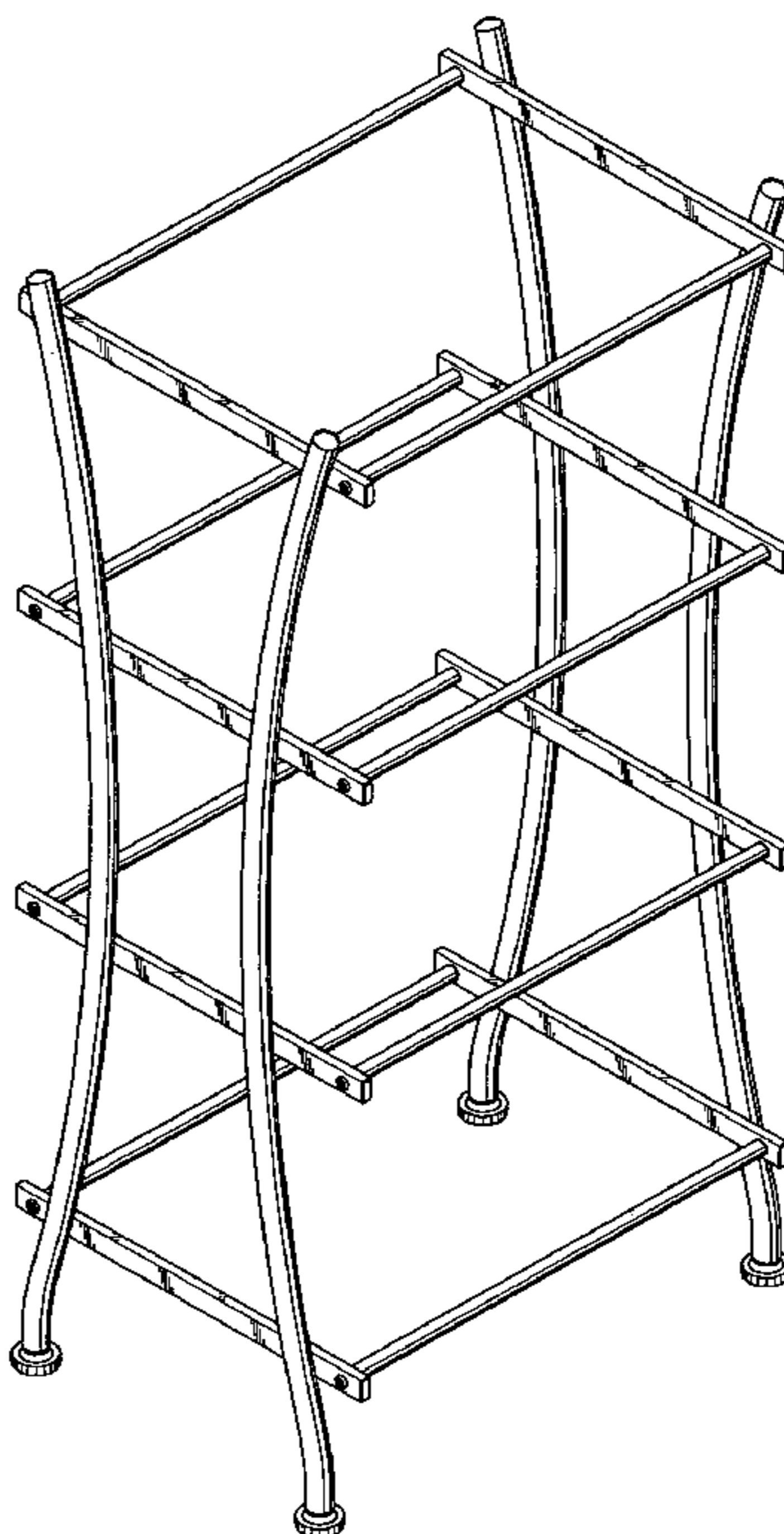
FIG. 7 is a perspective view embodying the utilization of the rack in which the broken line is for illustrative purposes only and forms no part of the claimed design;

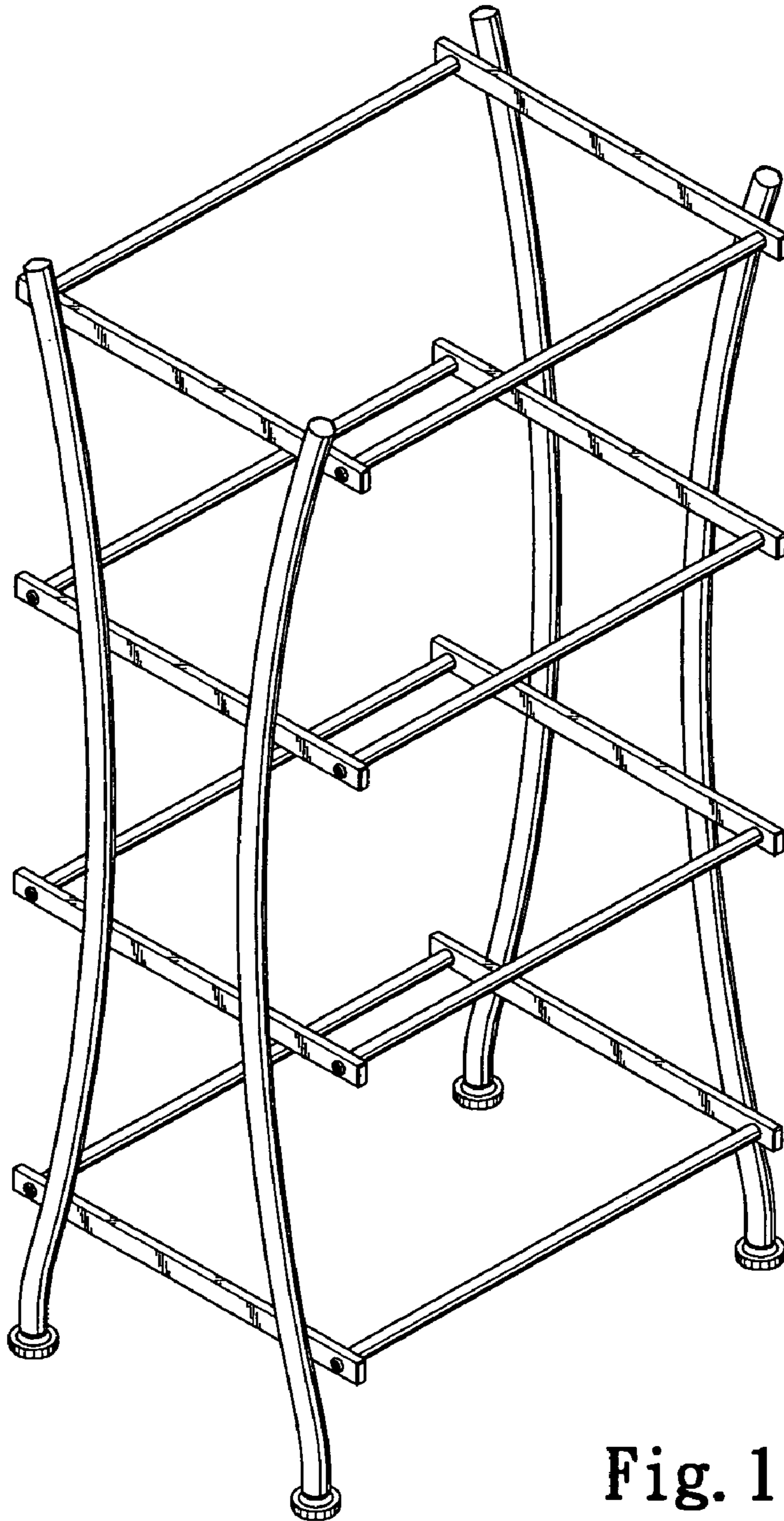

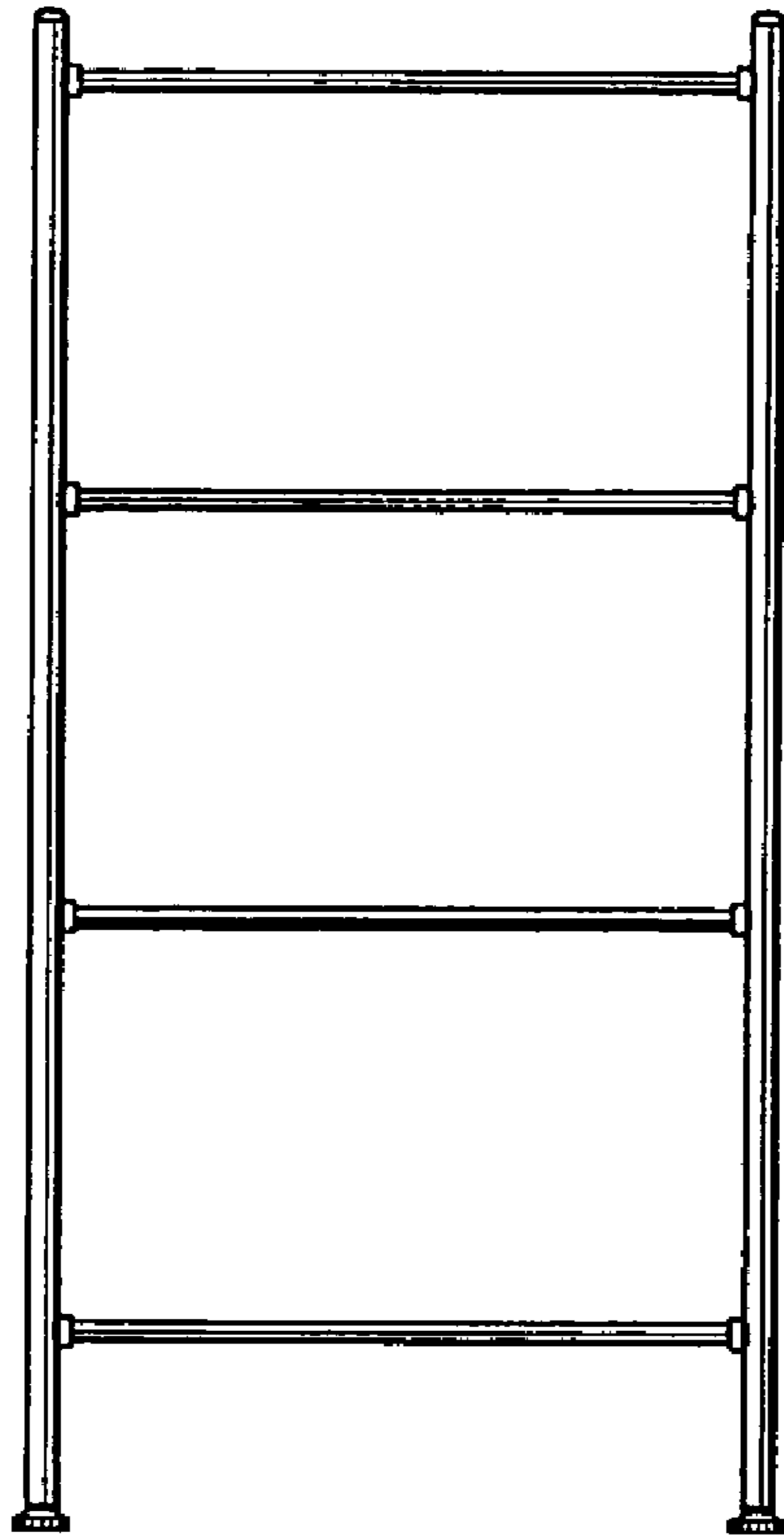

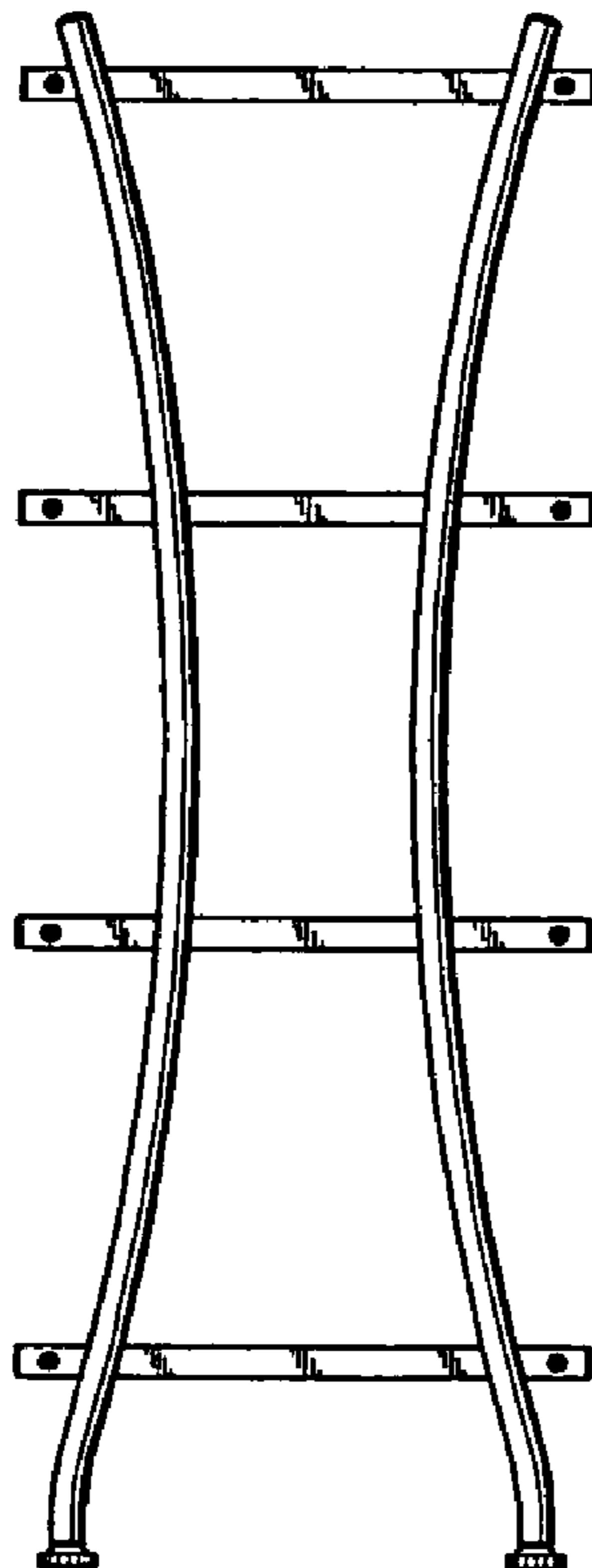

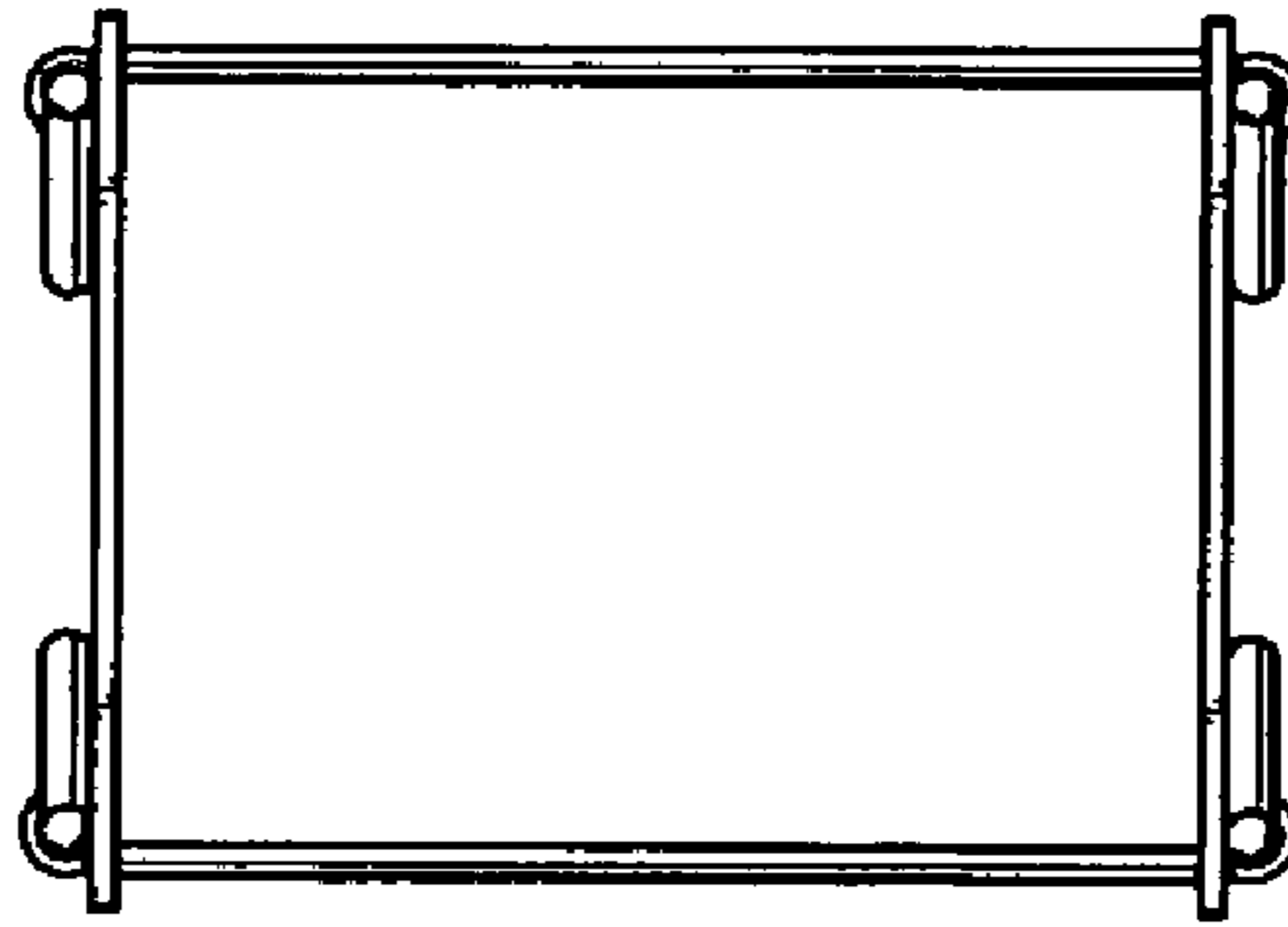

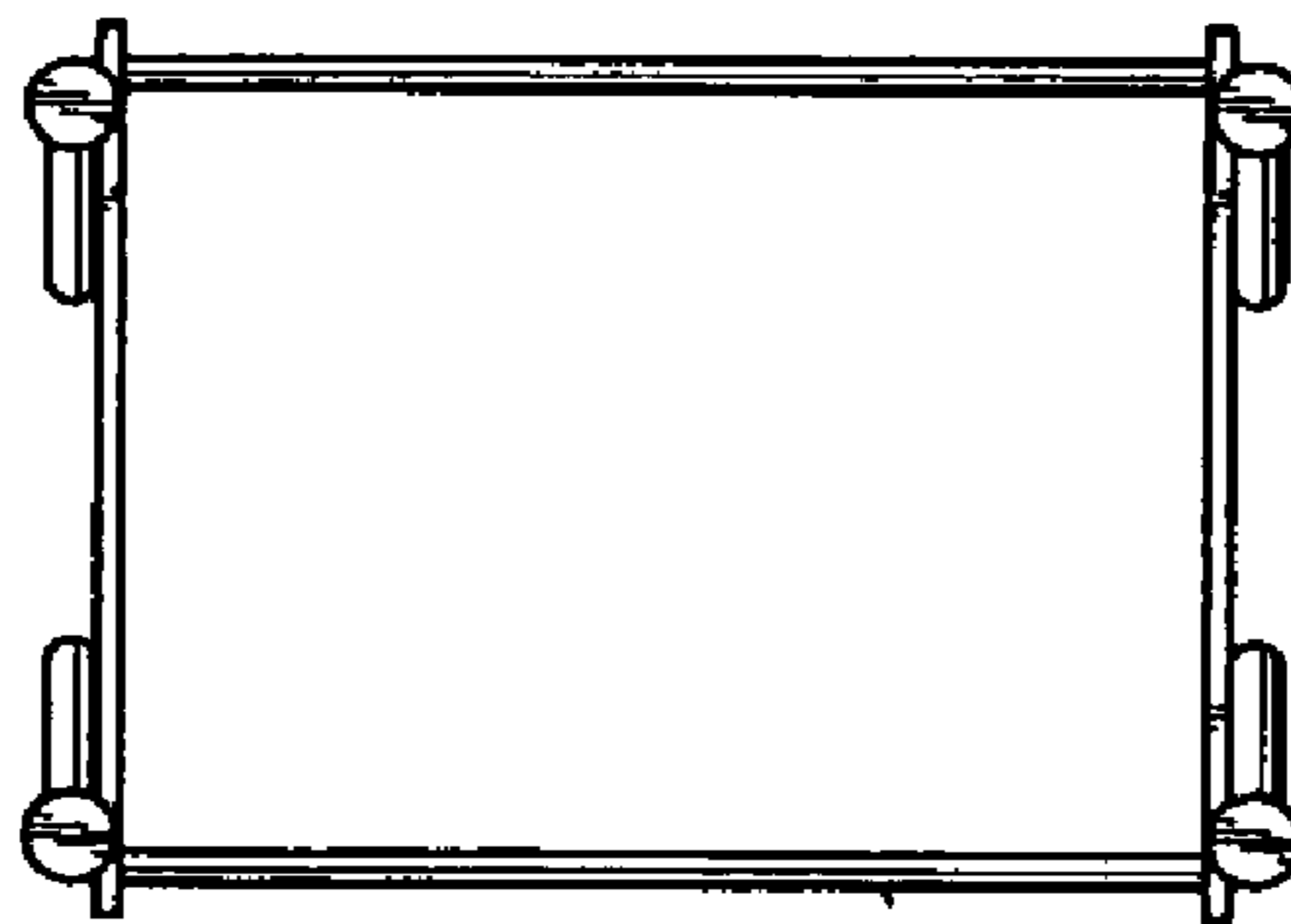

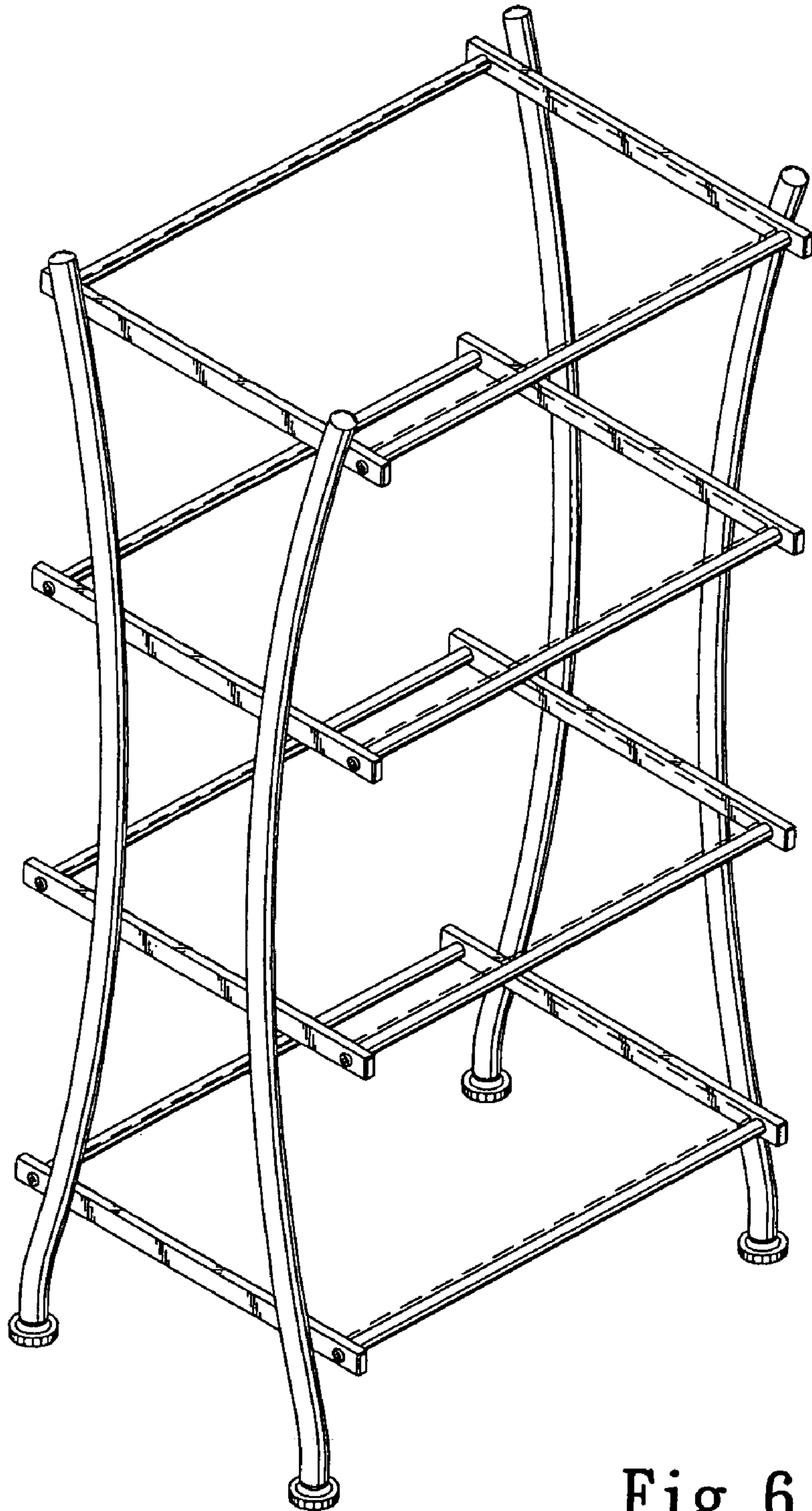

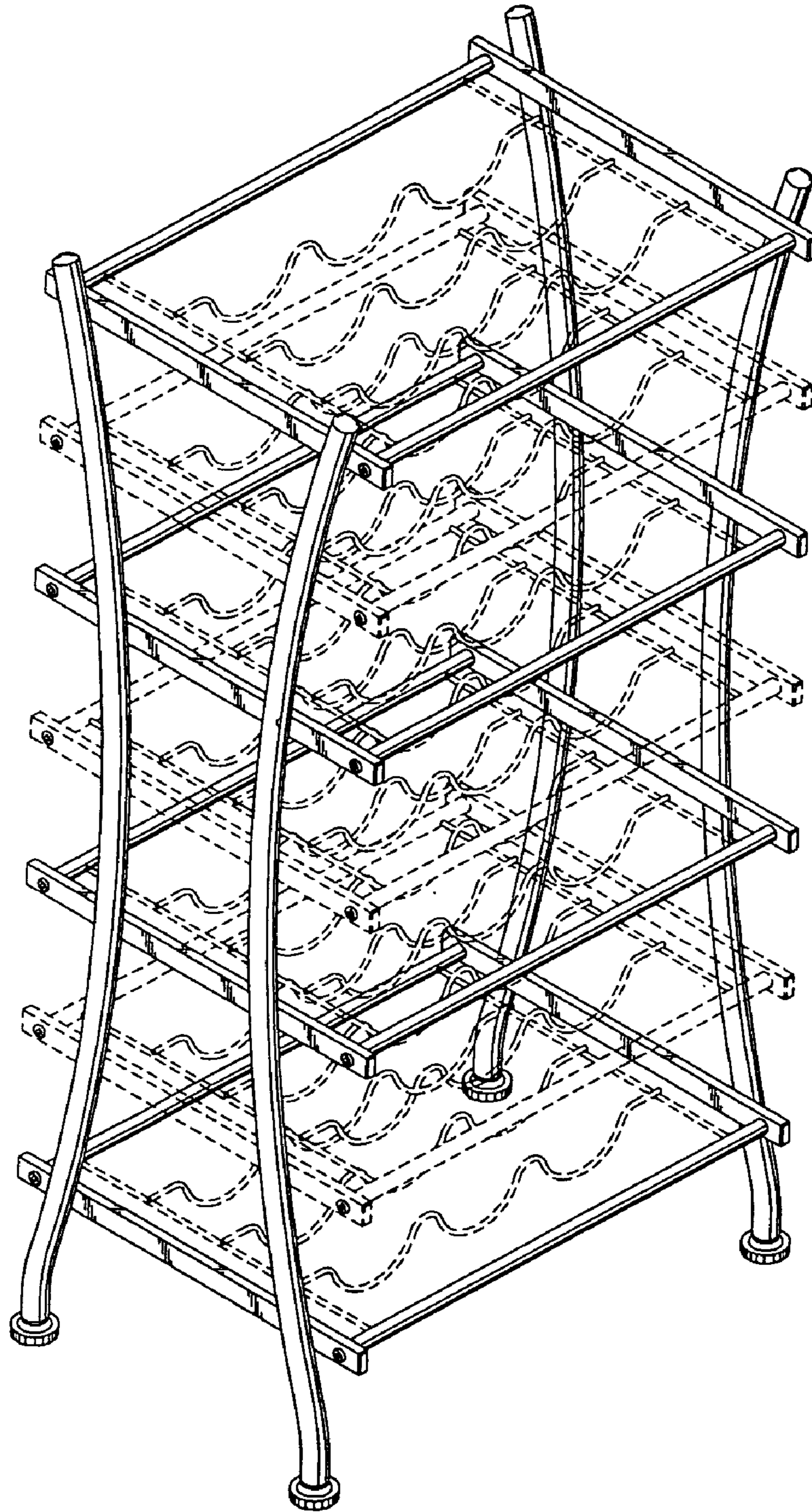

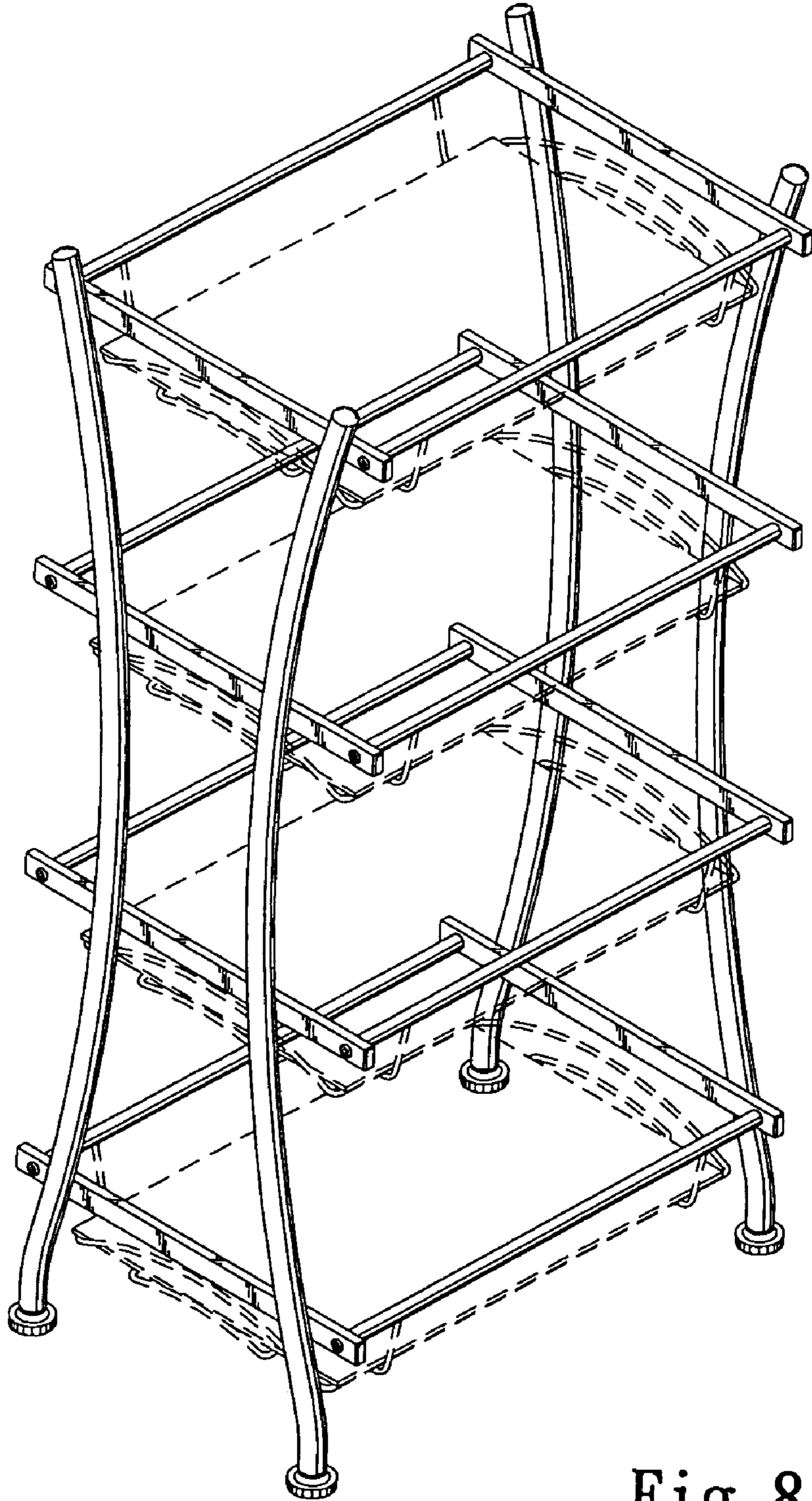

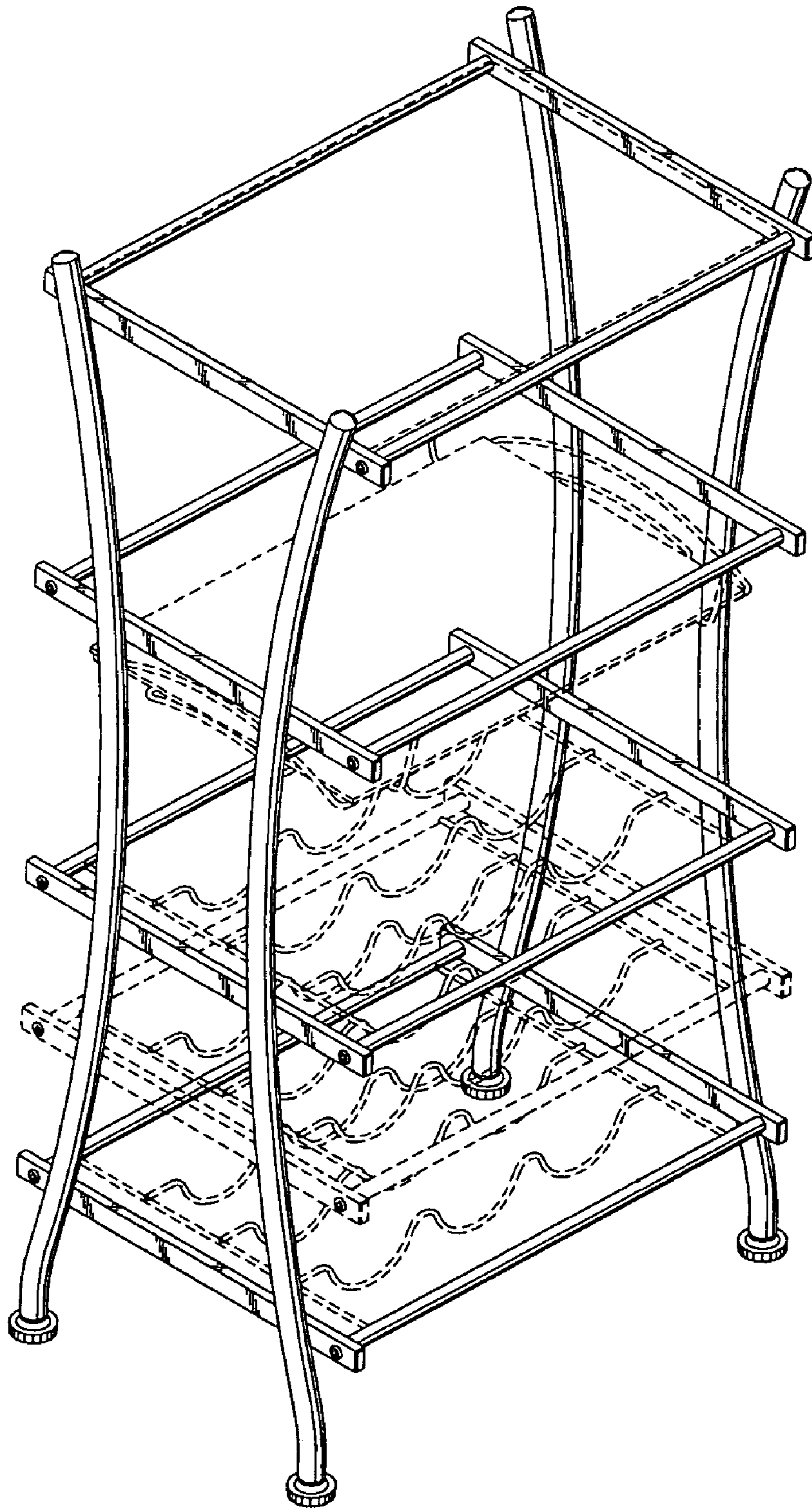

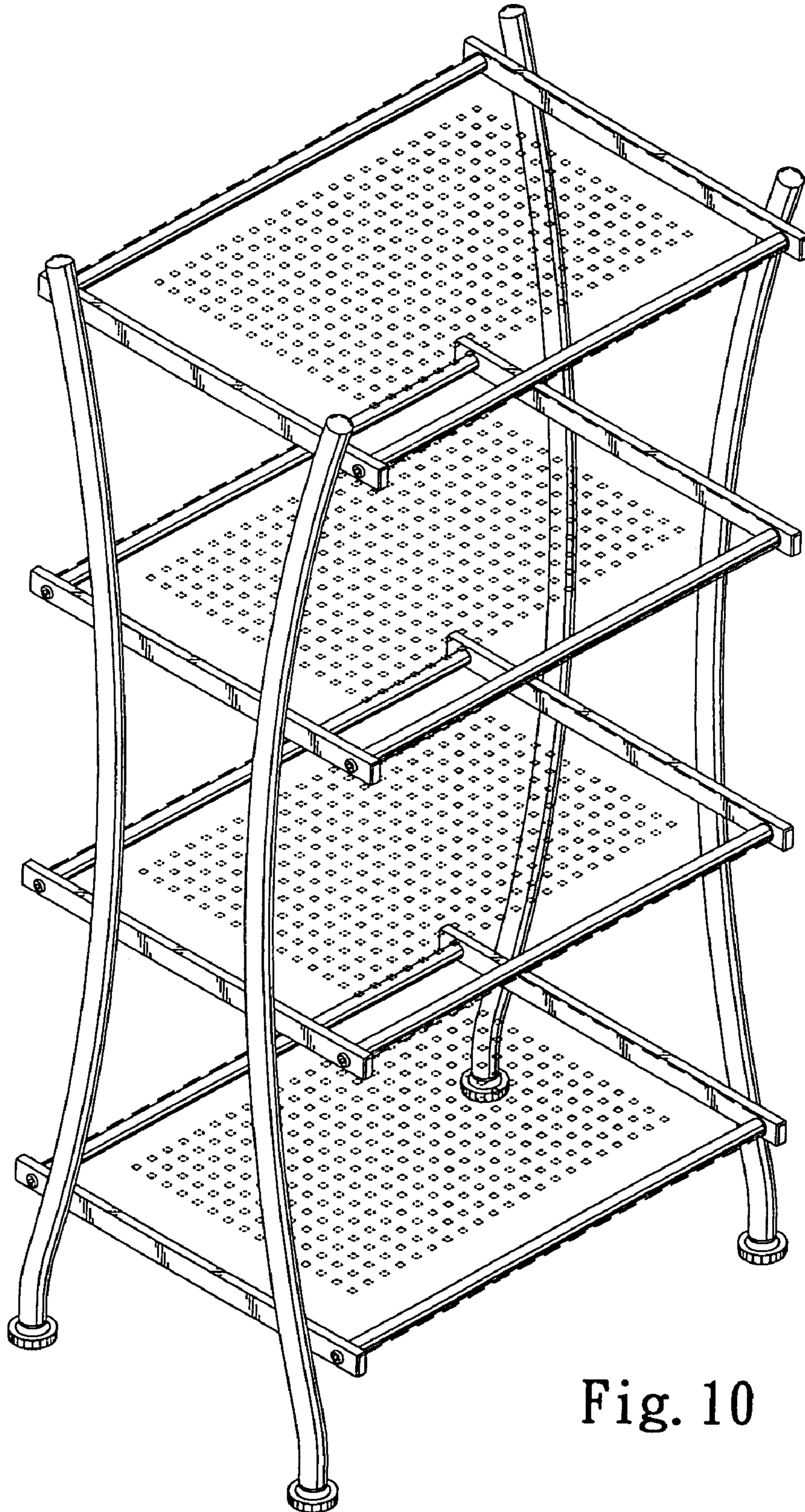
