FIG. 1 is a perspective view of the layer pad showing my new design;

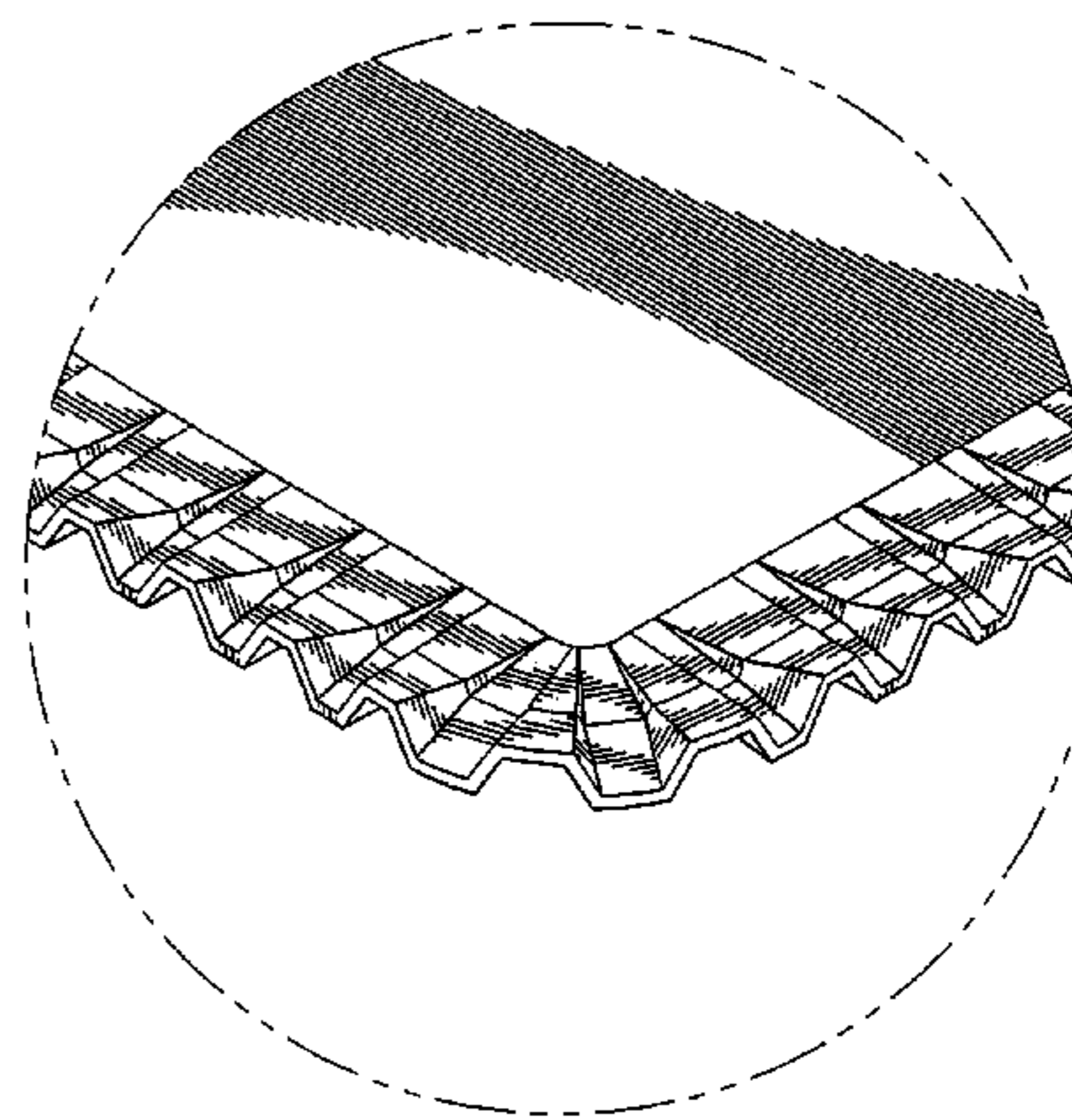
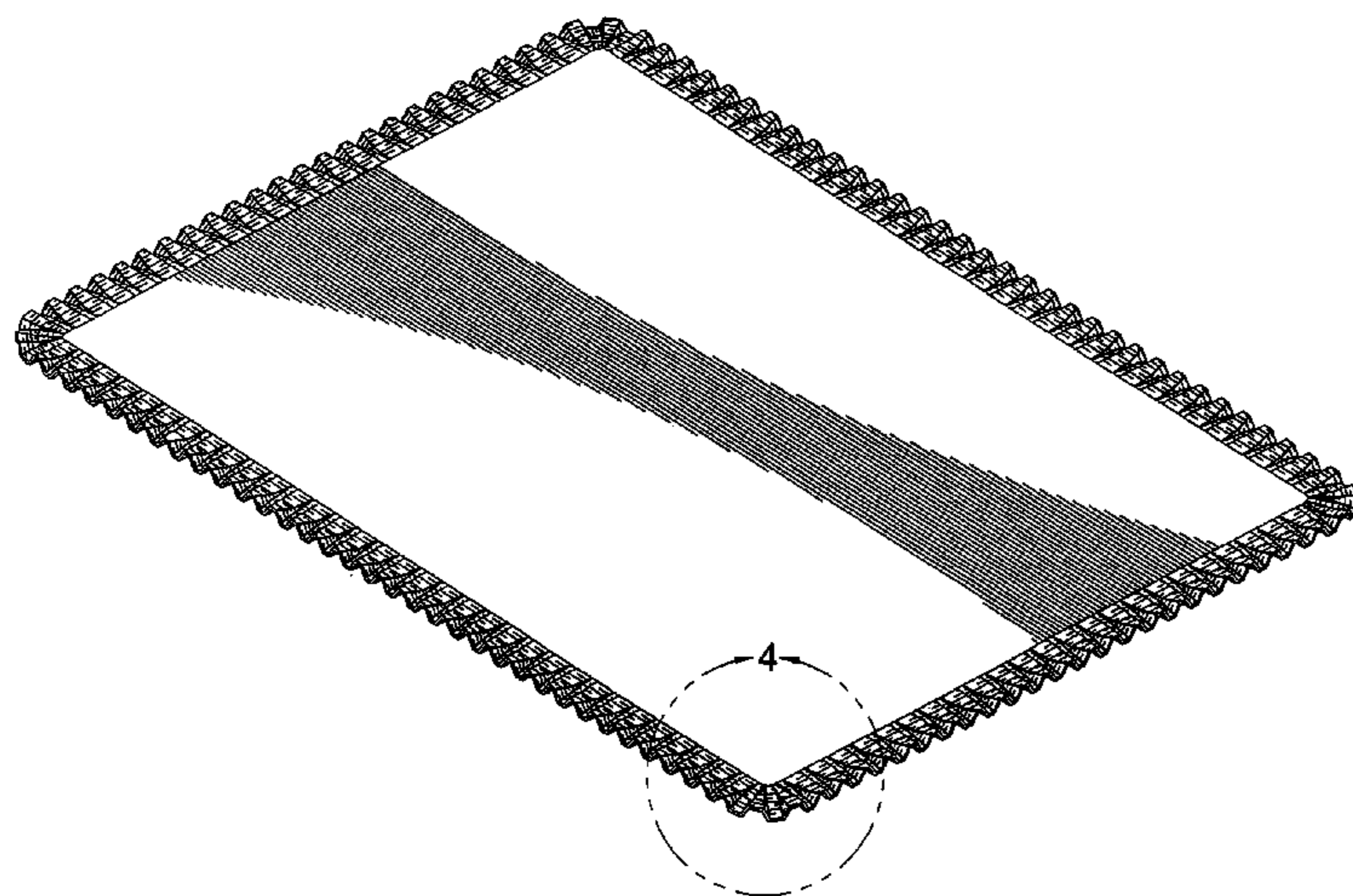
FIG. 2 is a top plan view, the bottom plan view being a mirror image thereof;

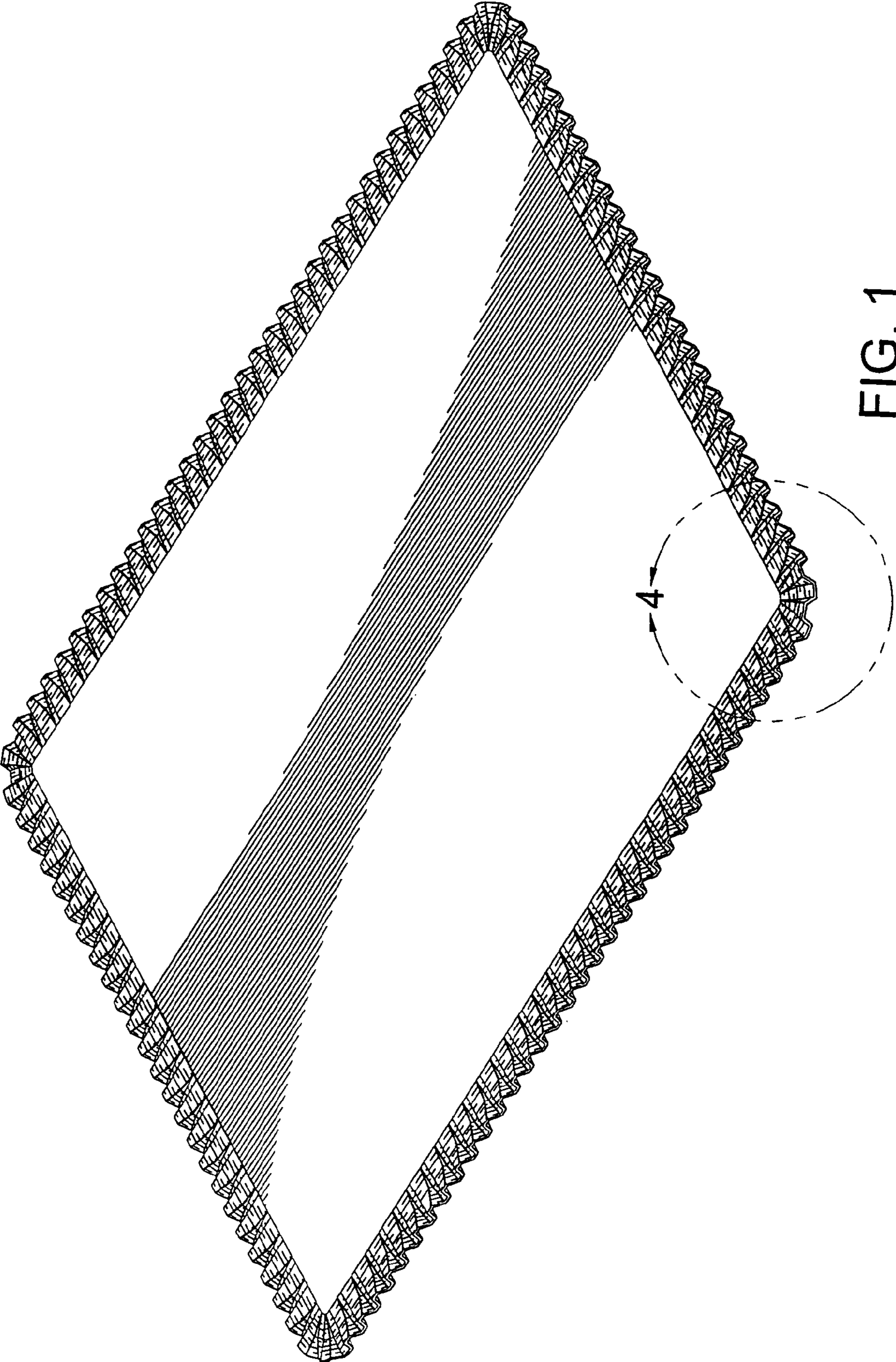

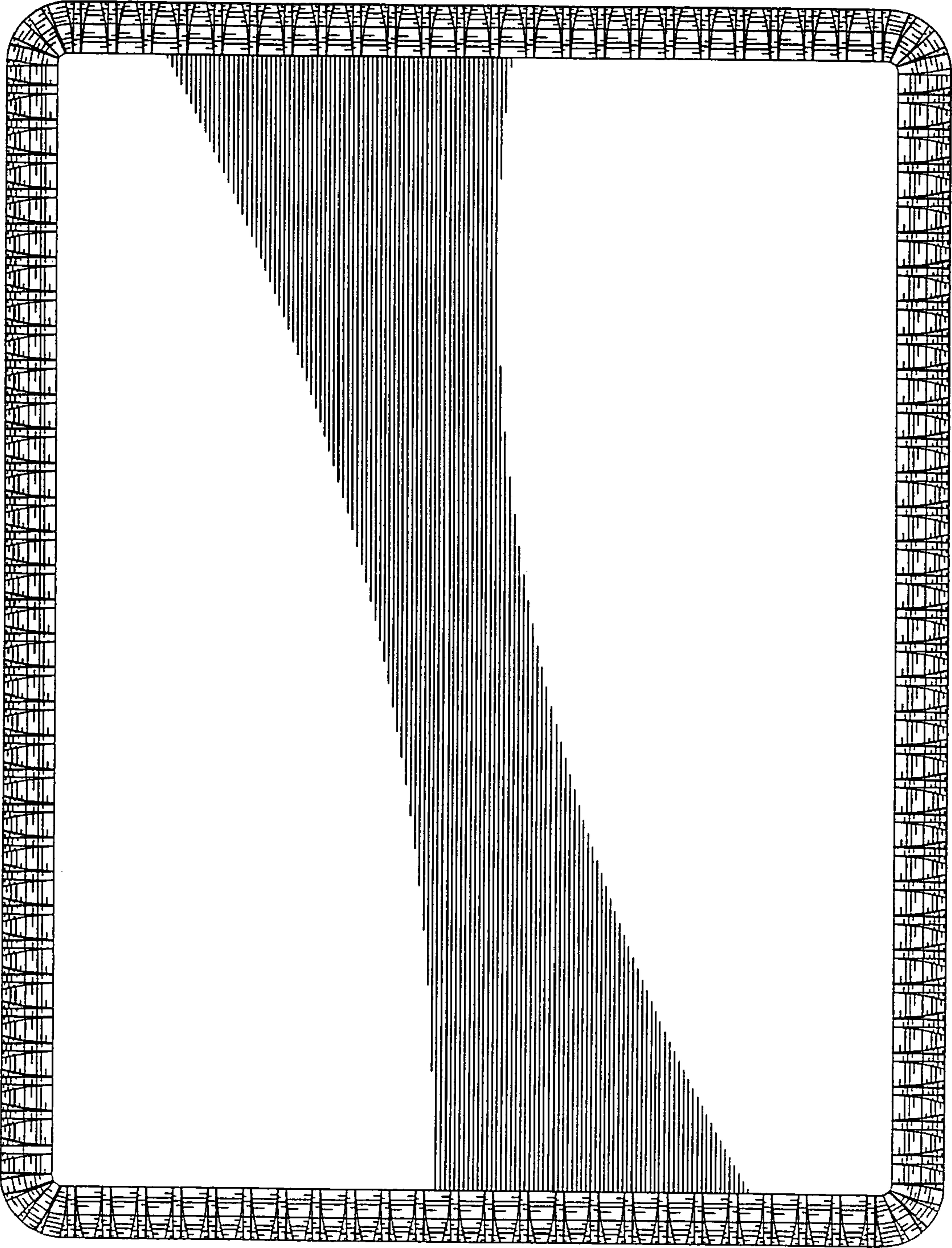

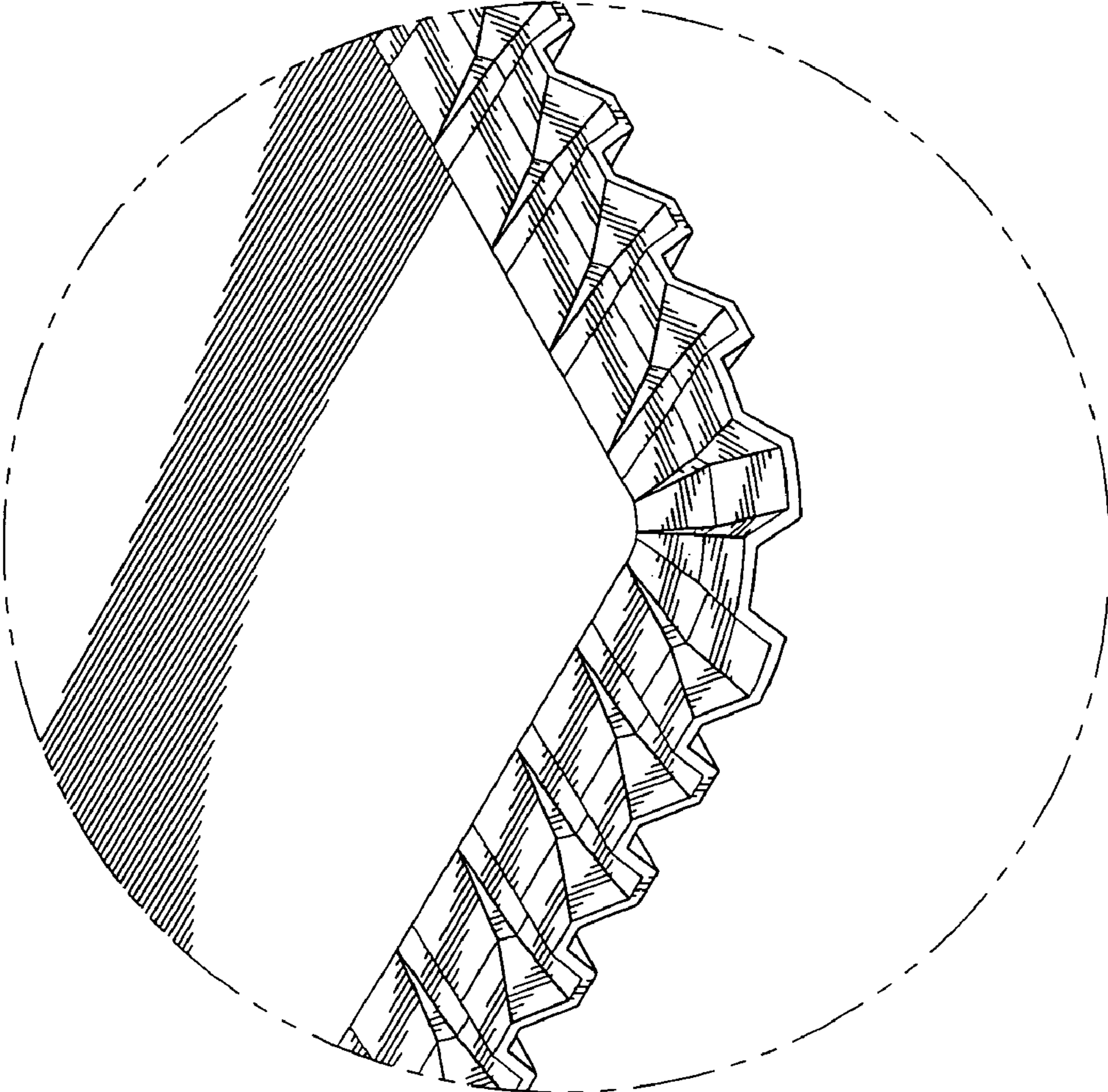
