(57) **CLAIM**

The ornamental design for a barbecue implement with wood laminate handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a barbecue implement with wood laminate handle showing my new design, the rear elevational view being a mirror image thereof;

FIG. 2 is a side elevational view thereof, the opposite sides being mirror images thereof; and,

FIG. 3 is a top plan view thereof, the bottom plan view being a mirror image thereof.

The broken lines are for illustrative purposes only and form no part of the claimed design.

Elements of the handle are shown separately in FIGS. 2 and 3 for clarity of illustration.

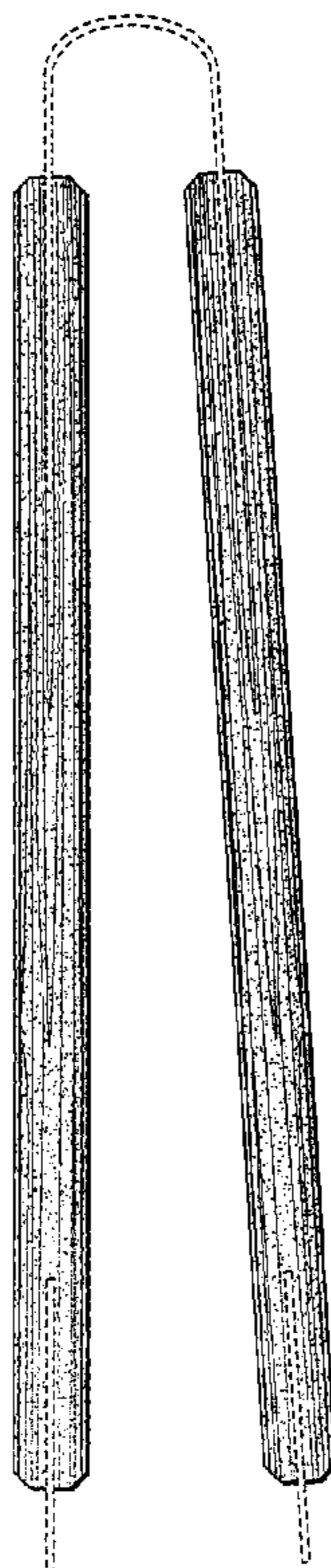

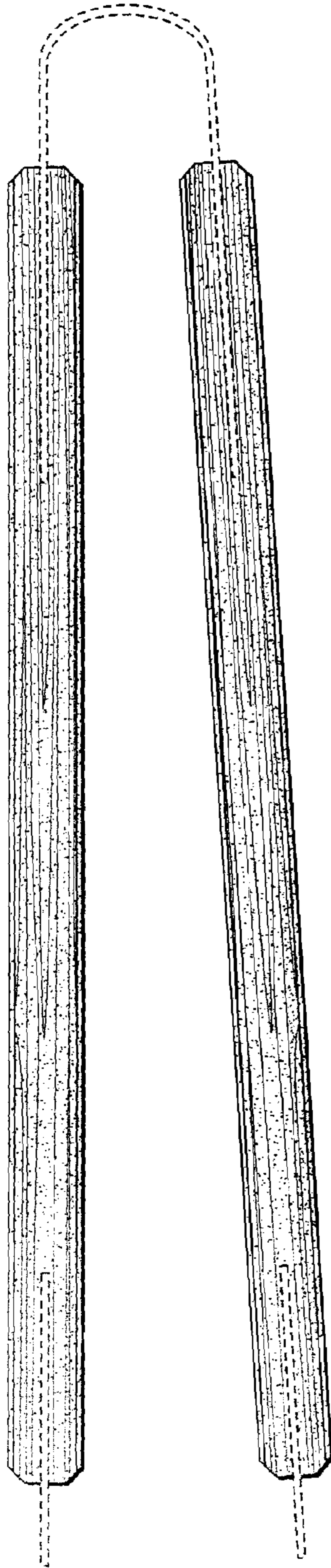
